Three years ago, California leaders passed legislation that promised the most dramatic expansion of mental health and addiction care coverage in decades. As the state's residents struggled with the stress and trauma of a raging pandemic and a record wildfire season, mental health advocates

used words like "groundbreaking" to describe the new law. Finally, they said, California was poised to become a national leader on mental health. Their optimism about that law, Senate Bill 855, has been fraying ever since. Advocates say health plans routinely fail to ensure that enough mental health providers accept their coverage, and often make patients wait too long before

being seen. Case in point: Last week, the Department of Managed Health Care unveiled news of a historic \$200 million settlement with Kaiser Permanente for failing to provide patients with timely mental health appointments, among other issues. Such issues will take center stage Wednesday at a special oversight hearing of the Senate Select

Veteran and Pastor and OPUD Board Member to run for Yuba County Supervisor

OLIVEHURST, CA (MPG) - Retired Air Force veteran, pastor, and Olivehurst Public Utility District (OPUD) board member, John Floe, has announced he will run for Yuba County Board of Supervisors, District 3, representing the Olivehurst area.

"My entire adult life has revolved around service and giving back to this community I love," said Floe. "First through my service in the Air Force, and now for the past 30 years with a focus on preventative resources and care for Yuba County's most vulnerable citizens. Though my work as a local church pastor, non-profit volunteer and in government service, I strive every day to help those in need."

John served in the United States Air Force for 23 years, retiring in 2004 and settling in Olivehurst with his wife of 37 years, Sharon (Royer) of Marysville. They have one son, and two grandsons. Since 1991, John has

served as the Assistant Pastor at Truth Tabernacle Church of Marysville. In 2006, John joined the Sutter-Yuba Behavioral Health Department. He retired in May of this year as their Program Manager of Community Services. For 17 years, he led a team of professionals providing education and training for early intervention programs focused on behavioral health, substance abuse, and homeless services. Since 2010, John has served on the Sutter Yuba Homeless Consortium

Board of Directors. The organization collaborates efforts and resources to best serve the homeless in our area.

John holds a Master's Degree in Organizational Management from the University of Phoenix, and a "Leadership Fellow" from Sierra Health Foundation, University of San Francisco and UC Davis with an emphasis in Health Care Leadership. He holds a classification of California Certified Prevention Specialist with the California Consortium of Addiction Programs and Professionals.

John was elected to the OPUD Board of Director in 2014 and is currently serving his third term in office. OPUD provides water, sewer, park and fire services to approximately 20,000 residents in Olivehurst and Plumas Lake. The board provides leadership and oversight for OPUD's \$5.6 million annual budget and 50 staff.

If elected as Yuba County Supervisor, John will focus on business development and infrastructure improvements

in South Yuba County, including water and sewer line expansions; flood risk reduction projects through the Yuba Water Agency; crime reduction efforts by partnering with the Yuba County Sheriff's Office to increase participation in neighborhood watch groups; and decreasing homeless and transient activity in Olivehurst and West Linda.

"Through decades of good planning and our amazing partnership with the Yuba Water Agency, Yuba County has the opportunity to become the top business, residential and tourism destination in the region," said Floe. "Now, more than ever, it is critical that Yuba County elect leaders with a proven track record of professionalism, building relationships with regional partners, and giving back. I would be honored to continue to serve our community as your next Supervisor."

From Workers United

YUBA CITY, CA (MPG) - Last week, Starbucks workers at the Highway 20 & Tharp store in Yuba City, California, filed a petition with the National Labor Relations Board (NLRB) to unionize with Starbucks Workers United.

Workers sent a letter to Starbucks CEO Laxman Narasimhan to announce their organizing campaign. In the letter, workers explained their decision to unionize: "The partners in this store navigate difficulties every day ranging from understaffed floors for business needs, product shortages, broken equipment, limited hours, to health and safety concerns. Starbucks didn't create all of these issues but they have failed to provide long-term or timely solutions. Despite these shortcomings, baristas manage and continue to make meaningful connections with customers and, not only achieve, but far surpass goals as a top store in our district. However, as partners in this company, we deserve the support and acknowledgment of management in addressing these concerns."

The Yuba City partners (employees) are joining a nationwide movement of over 9,000 baristas organizing for better working conditions, fair wages, and consistent schedules.

"We're so proud of how far our partners have come in making this happen, and we are all really excited to step towards joining baristas across the country in getting a fair deal for all the partners in our store," said J.J. Dizon, six-year store supervisor at the Yuba City location.

Starbucks has launched a ruthless union-busting campaign that includes threatening workers' access to benefits, firing over 230 union leaders across the country, and shuttering union stores. The NLRB has issued over 100 official Complaints against the Company, encompassing over 1,600 violations of federal labor law.

Starbucks Workers United is the union drive that has taken the labor movement by storm. Since December 2021, over 360 Starbucks stores in 41 states and the District of Columbia have successfully unionized — more than any company in the 21st century. ★

Reps. LaMalfa, Thompson Announce IRS Tax Filing Extension

WASHINGTON, D.C. (MPG) - Today, Congressmen Doug LaMalfa (R-CA) and Mike Thompson (D-CA) announced an extension of tax filing and payment deadlines in all California counties that received a disaster declaration from December 2022 to July 2023. As such, tax filings and payments due on October 16, 2023, would be moved to November 16, 2023. This deadline extension gives Congress additional time to pass Congressmen LaMalfa and Thompson's bill, H.R.4970 - Protect Innocent Victims Of Taxation After Fire Act, to exempt all wildfire relief

payments from federal income taxes. The Congressmen previously sent a letter to the IRS urging them to utilize their existing policy that allows for the postponement of deadlines of up to one year from the original deadline. "This tax filing extension

is good news for Fire Victim Trust claimants, as it gives Congress more time to get our bill passed and get necessary financial relief to wildfire survivors. Congressman Thompson and I have been working with House leadership and the Committee on Ways and Means to expedite this bipartisan bill. This is good news for now," said Congressman LaMalfa.

"Our state has been ground zero for significant climate events that have significantly harmed our communities," said Thompson. "The tax deadline extension announced by the IRS is going to provide additional time for California taxpayers to file their taxes." ★

Message from Sheriff Barnes Regarding the Passage of Senate Bill 2

On September 26, 2023, Governor Newsom signed Senate Bill 2 which greatly restricts where concealed carry permit holders can legally carry their firearms. This law would not take effect until January of 2024. The good news for CCW carriers is the Firearms Policy Coalition filed a lawsuit with the support of several other organizations. The matter is scheduled for a hearing in early December of this year.

To provide some context, in June of 2022, the Supreme Court issued a decision in *New York State Rifle & Pistol Association Inc. v. Bruen* case. The decision noted the Second Amendment protects the right to carry a loaded handgun in public for self-defense, and New York's law requiring residents to demonstrate "proper cause" to obtain a CCW, violated the Second Amendment right. SB2 is California's response to the Bruen decision and greatly restricts those

public places where a concealed firearm can be carried.

Within SB2, a new section is added to the penal code that would not allow a CCW carrier to carry in parking lots of government property, airport parking lots, and public transportation like buses or trains that are managed in part by public funds. Also, CCW carriers could not carry at any establishment where alcohol is sold, public parks, or any public permitted event like a parade. Further restrictions require businesses and churches to post signs indicating if concealed carry is allowed

on the premises. These are just some of the restrictions outlined in the law.

What is concerning is SB2 criminalizes routine behavior by good citizens who have lawfully obtained their CCW permit and want nothing more than to protect themselves and their families from harm. Conversely, firearm enhancements for criminals committing violent acts are being ignored in some communities.

For now, there will be no changes to our CCW application process or how we handle and enforce related laws. I, as sheriff, will continue to monitor the situation and work to ensure the Constitutional Rights of our citizens are being protected.

I recommend staying informed and supporting those organizations that are working to preserve our Constitutional Rights through appropriate legal avenues. Some suggested websites are www.firearmspolicy.org/ and crpa.org/ ★

Bottle Collectors Show a Lot of Glass

WILLIAMS, CA (MPG) - For collectors of old bottles and glassware, the Antique Bottle and Collectibles Show in Williams was the place to be last weekend.

While the fourth annual event was free to the public on Saturday, serious collectors paid an admission fee of \$20 just to get first crack at what treasures showed up this year inside the Old Gym at the Sacramento Valley Museum on Friday.

"I came first thing," said Dean Ripley, of Elk Grove. "I'm always looking for something unique to add to my collection. A lot of the time, people who collect antiques and bottles have an eye for the same things."

The bottle show is a

spinoff of the decades-running Williams Antique Show and is held for the same purpose: to raise money to keep the Sacramento Valley Museum operational.

While the primary focus of the show is old and rare bottles, visitors had a large selection of historical photographs, glassware, old coins, and other treasures from the mid 1800s to the early 20th century to choose from.

Joe Gentiliumo, of Rippon, has been a vendor at the bottle show since the Museum revamped the former event into something new and exciting that attracts a lot of collectors.

"I've been collecting since I was a kid," he said.

Gentiliumo had a variety of items for sale, including

old tins and coins, but his passion was in collecting vintage advertising, which he had in abundance.

"I always loved all the different artwork," said Gentiliumo, who sold off a lot of his collection Friday at a discount to other vendors.

Museum President Arno Martini said the annual Bottle Show is a good fit for Williams and the museum because there is always something new for just about every collector.

The Antique Bottle Show was organized by Slim and Christy Edwards, and the museum was open for the duration of the event. Admission to the museum is always free, but donations of any amount are encouraged and accepted. ★

Burn Permit Suspension Lifted

AUBURN, CA (MPG) - Effective Friday, October 13th, 2023, the burn permit suspension in the State

Responsibility Areas of Nevada, Yuba, Placer, and Sierra Counties will be lifted. CAL FIRE Unit Chief Brian Estes is formally canceling the burn permit suspension and advises that those possessing current and valid agriculture and residential burn permits can now resume burning on permissible burn days with a valid permit. CAL FIRE burn permits will be required.

Online Burn Permits are available at <https://burnpermit.fire.ca.gov/>. Agriculture burns must be inspected by

CAL FIRE prior to burning. Inspections may be required for burns other than agriculture burns. This can be verified by contacting your local Air Quality Management District.

While there remains a threat of wildfires, current weather and vegetation conditions are conducive to safely utilize burning to reduce vegetation and create greater resilience to wildfires within communities and rural areas. CAL FIRE facilities will continue to be fully staffed until sufficient rainfall is received, allowing for

the gradual reduction of fire control resources, while also prioritizing the ongoing fuels reduction initiatives. A Burn Suspension may be re-engaged in the event adverse fire weather conditions return.

Property owners and residents are asked to use caution while conducting debris or agriculture burns, follow all guidelines provided, and always maintain control of the fire. Individuals can be held civilly and/or criminally liable for allowing a fire to escape their control and/or burn onto neighboring property.

Residents wishing to burn MUST verify it is a permissible burn day prior to burning. For burn day information, contact your local Air Pollution Control District (APCD) or Air Quality Management District (AQMD).

All burn permits are issued annually and may be obtained online at <https://burnpermit.fire.ca.gov/> or from your local CAL FIRE Station. Permits are issued free of charge.

Pile Burning Requirements; Only dry, vegetative material such as leaves, pine needles and tree trimmings may be

burned; The burning of trash, painted wood or other debris is not allowed; Do NOT burn on windy days; Piles should be no larger than four feet in diameter and in height. You can add to pile as it burns down; Clear 10-foot down to bare soil around your piles; Have a shovel and a water source nearby; An adult is required to be always in attendance of the fire.

Safe residential pile burning of forest residue by landowners is a crucial tool in reducing fire hazards. State, Federal, and Local land management and fire agencies will also be utilizing this same window of opportunity to conduct prescribed burns aimed at improving forest health and resiliency on private and public lands.

Clean California Awards \$115 Million to Transform Neighborhoods and Transit Stations

SACRAMENTO, CA (MPG) - On October 9, 2023, Caltrans awarded nearly \$115 million in Clean California grants to cities and local agencies. The grants are a key part of Governor Gavin Newsom's Clean California initiative, which is a sweeping \$1.2 billion, multiyear commitment led by Caltrans to clean up trash, create thousands of jobs and help communities beautify their public spaces.

With this announcement, Clean California grants have funded nearly 300 projects statewide to revitalize and beautify underserved communities, some of which are already complete and now sources of community pride. The projects will improve public spaces, tribal lands, parks, neighborhoods, transit centers, walking paths, streets, roadsides, recreation fields, community gathering spots, and places of cultural importance or historical interest in underserved communities.

The 42 Clean California local grants announced are in addition to the nearly \$300 million in grants Governor Newsom announced in March 2022 to more than 100 local Clean California projects statewide.

Key projects include:

City of Chico: A grant of \$2.9 million to restore, improve, and beautify public spaces in the underserved community of South Chico to include the restoration and repaving of the Chico-Durham Bike Path and sidewalks to improve public walking and recreation spaces.

City of Colusa: A grant of \$381,200 to provide impactful improvements at four of Colusa's

five city parks. These improvements will address public access to clean water, clean restrooms, and clean spaces.

City of Marysville: A \$2.9 million project

grant projects. The local grants awarded today range from \$88,000 to \$5 million, and all benefit underserved communities. In addition, today's funding announcement includes \$14.5 million to support 18 projects to clean up stations and other areas around public transit systems.

Since launching Clean California in July 2021, Caltrans and local partners have removed an estimated 1.86 million cubic yards of litter from state highways – a trash pile that would be more than 370 times taller than Mount Whitney (14,505 feet, the state's highest peak). The program has created more than 4,000 jobs that have helped Californians overcome barriers to employment, including 357 people experiencing homelessness, and drawn more than 10,000 volunteers to events ranging from community cleanups to large debris collections for appliances, tires and mattresses.

As the Clean California effort moves forward, Caltrans and local communities will continue to draw attention to the negative impact litter has on natural resources, waterways, public safety and public health to create a cultural shift of shared responsibility for clean and vibrant public spaces.

Caltrans is also developing a program in which communities throughout the state can earn a special Clean California Community designation by meeting criteria centered around preventing and cleaning up litter, promoting recycling and greening or beautifying neighborhoods. to add new recreation features, renovate a dilapidated path, and add amenities to enhance the function and beauty of Ellis Lake Park. Six new recreation features will include three play pockets for children, an event island, fishing areas, park and trail signage, and public art and sculptures.

City of Willows: A \$4 million project to upgrade, enhance, and improve access to Sycamore Park by adding sidewalks on the north and east sides of the park and greater access on the west side. The project will also provide new lighting and the installation of solar facilities.

County of Yuba: A \$2.2 million project to transform Friendship Park into a community center by providing local art exhibits, shade structures, playground & recreational equipment, walkways, bike paths, fences, lights, and trash facilities.

Following the positive community response to this first round of grants, Governor Newsom and the state legislature approved \$100 million last year for a second round of local

Committee on Mental Health and Addiction.

Democratic state Sen. Scott Wiener of San Francisco, chair of the committee and author of the California Mental Health Parity Act, says he shares many of the mental health advocates' concerns.

"We know the plans have a long history of finding ways not to cover mental health treatment," he told CalMatters. "The whole purpose of this law is to put an end to that."

Prior to the passage of the 2020 law, the state only required health plans to cover medically necessary treatment of nine serious mental illnesses. For years, mental health advocates had tried and failed to expand that list. With Wiener's law, they were finally triumphant.

Beginning in January 2021, the state has required plans to pay for treatment of a much more extensive array of mental health issues, along with substance use disorder and addiction. This state law is separate from a federal mental health parity law passed in 2008. The concept of "parity" refers to requiring insurers to treat mental and physical health conditions equally.

Health plans say they "have been diligently working in good faith" to comply with these laws while facing industry-wide challenges like workforce shortages. They say they are navigating guidelines that are ambiguous and uneven while waiting for the Department of Managed Health Care to finalize regulations.

"This creates a situation of moving goal posts for plans, providers, and our enrollees," said Mary Ellen Grant, spokesperson for the California Association of Health Plans, in an email.

Mental health advocates have also long criticized the Department of Managed Health Care, which oversees health plans in the state that receive monthly fees to

provide health care for their members. And they, too, are concerned that it's taking so long for the official rules to be decided.

This summer, more than a dozen advocacy groups signed a letter of concern to the department, questioning its commitment to enforcing some aspects of the new state parity law. The organizations want the department to publish and publicize its investigations.

"It's still a relatively secret process," said Lauren Finke, a policy director at The Kennedy Forum, a national organization that cosponsored California's parity legislation.

The Department of Managed Health Care declined to make anyone available to speak with CalMatters until later this fall. In an email, a representative said the department "is committed to ensuring enrollees have appropriate access to behavioral health care when they need it."

In response to advocates' critiques that the department isn't adequately analyzing and publicizing how well plans are complying with state parity law, the department said in a statement that it is evaluating health plans' compliance in other ways; including that analysis in the behavioral health investigations would slow them down too much, the statement said.

Meiram Bendat, a Santa Barbara attorney and psychologist who focuses on mental health parity, says that the three-year-old state law has improved patients' ability to receive mental health care by creating a uniform definition of what is considered "medically necessary."

But when it comes to ensuring that health plans maintain adequate provider networks, he said, the department is "failing miserably." Too often, plans offer their members only outdated lists of providers who then prove to be unavailable, Bendat said. The Department of

Managed Health Care hasn't adequately held plans accountable for this and other problematic practices, he said.

"The historic network inadequacy around the state and the lack of meaningful fines, that's a real failure on the part of the department," he said.

Finke, of The Kennedy Forum, called the Kaiser settlement "long overdue" and "a very important first step in the Department holding plans more accountable for their performance (or lack thereof)." The settlement includes a \$50 million fine and corrective action plan as well as a commitment by Kaiser to invest an additional \$150 million over five years to improve behavioral health services.

But Finke and others also said the settlement itself provides evidence of the department's failures to enforce a previous settlement agreement with Kaiser from 2017.

"Will DMHC do its job going forward? That's the big question," asked Fred Seavey, research director for the National Union of Healthcare Workers, which represents 2,000 Kaiser mental health workers in Northern California who undertook a 10-week strike last year over heavy clinician workloads and long wait times for appointments. He said he wrote complaints to the Department of Managed Health Care earlier this year, saying that Kaiser in Southern California has been illegally restricting the scope of behavioral health services.

Kaiser said, in an emailed statement, that "any accusation that we intentionally limit or restrict needed care is untrue."

Southern California Kaiser members receive a wide range of behavioral health clinical offerings, the statement said. Despite a statewide shortage of clinicians, Kaiser is "doing all that we can" to expand its network of mental health providers. ★

Grant Fuels the CHP's Motorcycle Safety and Awareness Efforts

CHP News Release

SACRAMENTO, CA (MPG) - Motorcycle-involved crashes continue to be a major concern for the California Highway Patrol (CHP). The CHP has implemented a yearlong, federally funded program, Get Educated and Ride Safe VI (GEARS), with the goal of increasing motorcycle safety and awareness throughout the state.



The GEARS VI goals are designed to reduce the number of motorcycle-involved crashes and crash victims. Based on provisional data, there were 7,639 motorcycle-involved crashes, resulting in 381 deaths and 6,969 injuries, within CHP jurisdiction in federal fiscal year 2021-22 – an 8% increase from the previous year.

"Motorcycle riders are statistically more likely to be injured or killed when involved in a crash," said CHP Commissioner Sean Duryee. "The GEARS VI grant will support the Department's efforts to improve safety for motorcycle riders and other

road users through focused education and enforcement."

During the grant period, the CHP will increase motorcycle safety activities in regions with a high number of motorcycle incidents and participate in traffic safety education campaigns such as "National Motorcycle Ride Day" on October 14, 2023.

The campaign will promote the use of U.S. Department of Transportation-compliant helmets for all riders and raise driver awareness of sharing the road with motorcyclists. The CHP will also increase enforcement in areas with a high number of motorcycle-involved crashes, which resulted from speed, improper turns, and driving under the influence of alcohol and/or drugs.

Funding for this program was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★

Gallagher Bills for Fire Survivors and Fund Fire Protection Signed

SACRAMENTO, CA (MPG) - Assembly Republican Leader James Gallagher (Yuba City) is proud to announce that two pieces of legislation he authored have been signed into law by Gov. Newsom. The bills, Assembly Bill 556 and Assembly Bill 570 will address important local priorities for the 3rd Assembly District by providing additional funding for fire protection and helping Camp Fire survivors recover.

In 2018, the Camp Fire killed 85 people and destroyed more than 18,000 structures in and around Paradise, making it the deadliest and most destructive wildfire in California history. Since the fire, more than 2,500 homes have been rebuilt, with roughly 700 homes currently under construction, making Paradise the fastest-growing city in California for the second year in a row.

California allows survivors of disasters such as the Camp Fire to avoid a property tax increase by transferring the assessed value of their previous home when they rebuild or purchase a new property within five years. The scale of the destruction and uncertainty surrounding

how survivors would be compensated made it difficult for many to rebuild within the five-year time frame. AB 556 addresses that problem by providing survivors an additional three years to retain their home's base value as they work to recover.

"The passage of AB 556 is a major milestone in recovery for the residents of Paradise," said Paradise Mayor Greg Bolin. "We appreciate the work of Assemblyman Gallagher in moving this important legislation forward for our community."

"California is committed to helping Camp Fire survivors rebuild their homes, lives and community," said Gallagher. "The resilience of the people of Paradise is an inspiration to people around the state, and we will do everything possible to help them continue to recover."

AB 570 will make County Service Areas that provide fire protection services, such as the Sutter County Fire Department, eligible for grant funding from the Special District Fire Response Fund. In November 2020, voters approved Proposition 19, which will generate additional revenue for fire protection in the state's most underfunded areas. Despite the fact that they provide the same services and face the same

budgetary challenges as the fire districts that would receive Prop. 19 grants, County Service Areas were excluded from that funding. AB 570 fixes that difference, recognizing that all Californians deserve well-funded, professional fire protection services.

"Sutter County appreciates Assemblyman Gallagher's successful effort to ensure Sutter County Community Service Area F is treated like every other professional fire district in the state when it comes to competing for state grant funds for rural fire departments from the Office of Emergency Management," said Karm Bains, Chairman of the Sutter County Board of Supervisors. "Fire suppression and medical response in rural California are critical and expensive public safety services."

"Firefighters go above and beyond to protect our communities, and this bill will give them equal access to the resources they need to get the job done," said Gallagher. "The grants opened up by AB 570 will help our firefighters with improved training, modern equipment and high-quality facilities."

AB 556 will take effect immediately, while AB 570 will take effect January 1, 2024.

How Liberal California Compares to Florida, Texas on Social Media Regulation

The dichotomy between blue and red states – in essence California vs. Florida and Texas – has played out in many arenas on many specific issues, including immigration and abortion.

The whole nation will get a full dose of the running conflict next month when California Gov. Gavin Newsom, a Democrat who's obsessed with building a national image, debates Florida Gov. Ron DeSantis, a declared 2024 Republican candidate for president, on national television.

Meanwhile, an ironic twist to the rivalry has developed over how the competing states seek to force social media companies, such as X (formerly Twitter) and Facebook, to toe the official line on content that runs afoul of their very different ideological outlooks.

When it reconvened this month, the U.S. Supreme Court agreed to examine laws in Florida and Texas that would prohibit social media outlets from barring controversial political speech. The laws were enacted after both Facebook and Twitter suspended former President Donald Trump's account.

The Texas law, now on hold, would classify social media companies as

common carriers such as public utilities and require them to disclose their "moderation standards" affecting what they allow to be posted, and declare why they remove certain content.

The Florida law – similar in thrust – would prohibit banning certain users, such as journalists or politicians, and require social media companies to explain the rationale for each instance of content moderation.

In both cases, the social media companies say Florida and Texas are attempting to control how they edit their platforms in violation of the Constitution's right to freedom of speech.

"At bottom, government 'may not ... tell Twitter or YouTube what videos to post; or tell Facebook or Google what content to favor,'" Scott Keller, an attorney for internet trade groups, told the court in a petition.

The issues before the Supreme Court are remarkably similar to a lawsuit filed in federal court this month by X Corp. against California, alleging that a 2022 law violates its free speech right as well.

The law, Assembly Bill 587, also bores into the standards that social media use to moderate content, requiring them to make extensive disclosures to the state Department of Justice. The measure was sponsored by the Anti-Defamation League and is aimed at pressuring the social media companies to remove what the sponsor deems to be hate speech.

"The line between providing an open forum for productive discourse and permitting the proliferation of hate speech and

misinformation is a fine one, and depends largely on the structure and practices of the platform," Assemblyman Jesse Gabriel, a Woodland Hills Democrat, said in a statement as his bill was being considered.

X Corp. claims that Gabriel's law violates the First Amendment because it interferes with social media companies' constitutionally protected editorial judgments, requires them to post terms "dictated by the government," and pressures them to remove content the state "deems undesirable or harmful."

Fundamentally, then, while Texas and Florida accuse social media of being too eager to censor inflammatory content, the California law implies that they are not eager enough.

California, meanwhile, has rolled back another censorship law passed last year.

Assembly Bill 2098 threatened doctors with losing their licenses for "unprofessional conduct" if they openly disagreed with officialdom on the nature of COVID-19 or the vaccines used to battle the pandemic.

This year, a few words that repealed the law were slipped into an omnibus medical licensing measure, Senate Bill 815, that Newsom quietly signed. The repeal short-circuited what could have been another legal battle over censorship and the First Amendment and is a lesson about legislating without considering effects on constitutional rights.

The New Weight Loss Drugs

The Novo Nordisk's products use a compound called semaglutide while Eli Lilly's Mounjaro uses a drug called tirzepatide.

Where drugs for weight loss were mostly stimulant types which ramped up metabolism and may have had "speed" like side effects and not been very effective, these new drugs were developed to manage blood sugar levels for diabetics and are approved for that specific use.

What then occurred is after widespread use, people started reporting weight loss in significant amounts over a sustained period of usage. What is different about this class of drug is that it reduces cravings by simulating what your body does naturally when you eat. It gives you the feeling of satiation without stuffing oneself with food. They apparently work so effectively that Lilly and Nov Nordisk cannot make enough of them and sales are off the charts.

Recall that Wegovy, Ozempic and Mounjaro are not yet approved for weight loss but are already out there for diabetes and have been for quite some time. Wegovy has been out since 2014, Ozempic since 2017 and Mounjaro since May of last year.

Nov Nordisk and Eli Lilly are seemingly way ahead of the pack as to production, approvals and actual usage, and with a plethora of information already known about the drugs and new information about their effect on weight loss seemingly coming in daily, the other drug companies are scrambling to catch up.

With the three drugs in successful use already approved for diabetes, both companies are engaged in the final stage of trials and have already submitted the applications for the approval of the drugs for weight loss.

Doctors may not be waiting for the approval as sales are skyrocketing and likely not every prescription may be for a diabetic. My assumption here of course but it aint rocket science.

Some analysts argue the three drugs may be the best selling drugs of all time, and may even have the capacity to alter human lifespan, throwing longevity actuaries into historical revision territory. Others agree and go further to suggest these drugs may be the most important drugs ever developed. They may also help reduce cardiovascular disease,

heart attack and stroke in certain instances. If that wasn't enough to scare the food industry and give a new sense of hope to the rest of us, an increasing number of people who use these injections to help control their food cravings say other cravings disappear as well—including ones for nicotine, alcohol, gambling, skin picking and other compulsive behaviors

Holy Cow Batman.

No wonder the food stocks got hammered.

Now before you rush out to get your prescription or buy the stocks, there are both health and investor risks from the medications and the companies that make them and this is definitely not a recommendation to buy or sell any security nor consume any drug. The stocks themselves have already had an incredible run.

In my 50 years of adult coherency and observation, I have seen many of the "latest and greatest" ideas, theories, stocks, miracle drugs and the like flop horribly. Side effects of the drugs can make themselves known years later and kill the drugs marketability. Think of the drug Thalidomide that caused horrible mutations in humans. Any number of approval setbacks can knock a pharmaceutical companies stock down many fold, and in certain cases obliterate the company altogether. I am not suggesting Novo Nordisk or Eli Lilly could go under. They are both huge conglomerates with billions of dollars in capitalization. But many investors have had their portfolios severely damaged by a drug stock gone bad.

In conclusion, that fact that the major food company stock sell-off in the past few weeks has been at least partially attributed to the rise of this new class of weight loss drug, apparently somebody is taking it seriously. And should these new drugs actually accomplish some of what the scientists are hoping and seriously help with obesity, cardiovascular disease and even other addictions, a rising portfolio balance is the least of our benefits. Mankind, our lifespan and indeed our quality of life in general could be lifted to new heights, and won't that be good news for all of us.

Huskies Lose to Rhinos in Thriller, Focused on Week 10 Finale

SUTTER, CA (MPG) - Wayne Gadberry Field at Sutter Union High School had all of the eyes from the CIF Sac-Joaquin Section on it as one of the premier matchups of the week and it didn't disappoint as the Twelve Bridges Raging Rhinos beat the Sutter Huskies 19-14 on Thursday, October 12.

The crazy media presence for this game brought a movie-like atmosphere between two competitive programs that are "newer" to the SJS as Sutter and Twelve Bridges are in their second year of competition.

The Dispatch spoke with Sutter head coach Ryan Reynolds in the morning of the big matchup and he expressed the matchup felt like a potential section final game in the regular season.

The Rhinos began the game with the ball and that didn't last long as Huskies junior linebacker Mason Cartwright intercepted his first of two Twelve Bridges senior quarterback Whit Kruse passes on the night.

The first quarter ended scoreless as the defense's weren't giving up an inch to the opposing offenses.

Rhinos senior running back Nathan Crawford put Twelve Bridges up 6-0 with 6 minutes, 15 seconds left in the second quarter. Sutter commuted a penalty before the point-after touchdown (PAT) attempt, so the Rhinos went for a two-point conversion and were unsuccessful.

Kruse extended the Twelve Bridges lead 12-0 after a 1-yard touchdown rush with 5.9 seconds in the first half.

possessions, they punted the ball twice, turned it over on downs and had the clock run out at the end of the first half on them.

Although it was rare for the Huskies to trail at the half, it didn't stop them from having their leaders take charge in the locker room.

Cartwright expressed to the Dispatch that at the half, he told his defense there was no room for mistakes in this type of game.

"We were able to build on that and do it," Cartwright said.

jolted down the right sideline and put the Huskies on the board with a 49-yard touchdown rush and cut the Rhinos deficit 12-7.

Meras rushed the ball 18 times for 140 yards on the ground and two touchdowns.

The relentless Sutter defense kept the charge going as Cartwright snagged his second interception on the night after it was tipped at the line of scrimmage from senior lineman and California State University, Fresno commit Auckland Asiata.

Cartwright had a game-high 16 tackles and one tackle for loss as Asiata contributed six tackles and three hurries on Kruse.

Kruse extended the Rhinos' lead when he found senior wide receiver Anthony Gallagher for a 34-yard touchdown pass to give Twelve Bridges a 19-7 lead.

Meras punched in a 2-yard touchdown rush to dwindle the Rhinos lead 19-14 for the final score of the game.

The Huskies and Twelve Bridges each had the ball three times in the fourth quarter and the defenses locked it all down.

Reynolds told the Dispatch postgame they had their chances to win but just didn't capitalize at certain moments.

Sutter senior quarterback Jagger Beck continued his pin-point accuracy as he went 9-for-12 for 152 passing yards in the game.

Beck did throw one of his incompletions in the fourth quarter as an interception as he tried to get the ball to senior wide receiver Jordan Lee in double coverage.

The Huskies defense forced a punt with a few seconds under a minute to go in the game and Beck completed a pass to Meras and Meras fumbled the ball and Twelve

Bridges recovered and was able to kneel the ball down for victory.

Although the Huskies didn't come out with the win, they aren't focused on the PVL title. Reynolds expressed to the Dispatch that a league title is nice, but their goals as a team are still intact and the kids are a self motivated group.

"Let's face it, we want to win a Section Championship and a State Championship," Reynolds said. "This game will make us better in that regard."

Beck said to the Dispatch postgame that they know this game isn't their last of the season and they know when they get into the postseason, they are going to get through the adversity.

A lot of people had this game pinpointed as the PVL title game, but there is still a way the Huskies could share the league title, but are going to need a lot of help.

Twelve Bridges travels to Colfax tonight and hosts Marysville next Friday. If the Rhinos lose one and Sutter beats Wheatland next Friday, they will share.

The main focus for the Huskies now is getting healthy and playing their final regular season game on Friday, October 27 at Wheatland.

In the latest playoff projections from MaxPreps on Sunday, October 15, the Huskies remained atop the Division VI projections with the loss against Twelve Bridges.

Sutter's rating by MaxPreps remained higher than Sonora and the Huskies also had a greater strength of schedule, which gave them the higher nod at staying at the top spot of projections for the CIF SJS Division VI bracket. ★

MARYSVILLE, CA (MPG) - The Marysville Indians became playoff eligible on Friday, October 13 after a late pass secured a win over the Wheatland Pirates in a 22-18 victory.

According to the latest MaxPreps projections that were released on Sunday, October 15, the win over Wheatland secured a designated spot for Marysville in the CIF Sac-Joaquin Section Division VI playoffs.

Wheatland got on the scoreboard in the final minute of the first quarter when the Pirates scored on a 2-yard touchdown rush to take a 6-0 lead.

Marysville's Israel Stewart intercepted a Wheatland pass about halfway into the second quarter and the Indians put a great drive together for junior running back Dennis Syders to finish it off with an 11-yard touchdown rush to remain tied after a missed point after touchdown (PAT).

Syders would be a big component of this game in the later stages that would eventually lift Marysville (4-4, 1-3 Pioneer Valley League) into the win

column.

Indians junior running back Josiah Smith-Brown opened the second half with a bang as he took the opening kickoff of the second half to the house for a 69-yard touchdown return and put Marysville up 14-6.

Wheatland was able to March down on the following possession and score the ball from eight yards out of the end zone to stay in the game with a 14-12 deficit after they failed on a two-point conversion.

Walnut Growers are Upbeat about Harvest, Prices

After a late-season heat wave pummeled their 2022 crop, California walnut growers are much more upbeat about their harvest this year. Favorable growing conditions and increased rainfall have allowed them to produce higher yields and quality nuts that marketers say will be easier to sell. A top concern now is whether buyers who may have gotten used to discounted walnuts are willing to pay more for this year's crop. Don Barton, a San Joaquin County walnut grower and marketer, said pricing at the start of the current marketing year is already 40% higher than where it ended last year.

Quarantine Established in Ventura County Amid Threat to Citrus

A new quarantine has been established in Ventura County, a key commercial citrus-growing region, after two residential citrus trees in the city of Santa Paula tested positive for the fatal citrus disease huanglongbing, or citrus greening. The quarantine, which covers a minimum 5-mile radius around where the diseased trees were found, is mandated by law to restrict movement of citrus fruit, trees and related plant material, so as not to artificially spread the disease. State officials said they may expand the quarantine area if more infected trees are found.

Use of Drones in Agriculture Gets Boost from New Legislation

Farmers will soon face fewer obstacles in getting approved to use drones for aerial applications thanks to a bill, signed into law Saturday by Gov. Gavin Newsom, that will modernize the California Department of Pesticide's certification process. Growers of various commodities have touted the technology's ability to improve worker safety, lower labor costs and boost crop yields. However, farmers say an outdated regulatory process has made it difficult for them and their employees to get licensed to use drones to spray pesticides and biological treatments.

Forecast of another El Niño Raises Water Hopes, Flooding Fears

California has seen dramatic increases in reservoir levels and surface-water supplies as a result of an El Niño weather pattern this year that brought drenching atmospheric river storms. It followed a La Niña pattern that delivered three years of searing drought. But with farmers and ranchers suddenly blessed with ample water supplies, state and federal officials said last week they expect to release water from reservoirs to create more water-storage space. That is because of fears of potential severe flooding from a predicted second consecutive El Niño year. ★
