Halloween Fun

A Pair of Trick-or-Treat Events in Galt

GALT, CA (MPG) - All the spooky denizens of Galt came out to play last weekend with two entertaining trick-or-treat events: the Spookishly Fun Movie Night at Veterans Soccer Field and Old Town Galt Trick or Treat on Fourth Street.

The main event for the movie night on Oct. 27 was a screening of "The Nightmare Before

Christmas," but the fun began well beforehand as children visited booths set up by community organizations to get their fill of candy and games.

Jack Skellington and Sally, the main characters of "Nightmare," walked around the city-organized event to greet kids, and they told the story of how Jack, the "Pumpkin king" of Halloween Town, discovers Christmas and inadvertently mixes the two

Isleton Man Arrested for Child Sexual Abuse Images

ISLETON, CA (MPG) - California Highway Patrol (CHP) announced the arrest of an Isleton man on charges of possessing and distributing child sexual abuse material. James Stanley Skaggs, 60, was arrested on Oct. 23 following a two-month investigation by CHP's Computer Crimes Investigation Unit, the agency said in an Oct. 26 release.

He was first booked into the Sacramento County Jail and held on \$1 million bail, according to the release. He was arraigned on Oct. 25. As of Oct. 31, jail records said he was being held in Rio Cosumnes Correctional Center and was ineligible for bail.

"Every arrest that safeguards our children from harm is a resounding declaration that we will not tolerate the exploitation of innocence," CHP Commissioner Sean Duryee said in a statement. "As law enforcement officers, we are committed to protecting the safety of the most vulnerable among us."

The investigation began in August when a computer crimes investigator identified a device in Isleton suspected of "downloading and distributing a significant quantity of" child sexual abuse material.

CHP arrested Skaggs at a residence on Fourth Avenue in Isleton, where it found a device that contained "several gigabytes" of sexually explicit pictures and videos of children aged 3 to 13.

The computer crimes unit was aided by the California Department of Corrections and Rehabilitation and by the Sacramento County Sheriff's Office Hi-Tech Crimes Task Force. ★

Supervisor Hume Hosts Forum on Behavioral Health

GALT, CA (MPG) - Sacramento County officials shared information on the county's behavioral health services during a community meeting hosted on Oct. 26 by Supervisor Pat Hume.

The presenters represented the county's services for mental health, and substance use prevention and treatment, as well child and adult protective services.

They explained the services that each division provides, often describing a "continuum of care" that ranges from less-disruptive actions aimed at prevention, up to more intense actions like acute care for mental illness.

Rexanne Irizarry, who manages the behavioral health peer specialist program, spoke about her own experience with county services, which she said have greatly improved since she was a child growing up in a family marked by abuse and untreated mental illness.

Irizarry said that, during her childhood, a family member sexually abused her and she felt unable to tell the adults in her life. Her mother had been called the "bad child" of the family and dismissed because of her

chronic drug use; however, she was eventually revealed to have severe schizophrenia and to have been abused by the same relative who targeted Irizarry.

The silence around these issues and others was partly due to cultural influences, said Irizarry, who is of Hispanic and Native American descent.

In the two cultures, Irizarry explained, "we survive through things; we don't dwell on them. And most of the time, we are not to even talk about them. ... Alcohol, substance abuse, suicide and guns are normalized. They

holidays together.

The following day, Oct. 28, crowds visited Fourth Street for the Old Town Galt Trick or Treat. are accepted as our life. Mental health, though, is not to be spoken of.”

Medical providers proved to be of little help, Irizarry said, creating a hostile environment for her.

The quality of behavioral health care in Sacramento County has markedly improved since then, Irizarry said.

“Once I did return to public health services as an adult, I was treated differently,” she noted. She said the range of mental health treatments had expanded to include family partners, art therapy and self care. “There was no more questioning me of why I was the way I was and no more asking what had happened to me.”

Irizarry said she feels “safer using Sacramento County public health services.” She noted that her job with the county allows her to use her experiences to help others.

“So the stigma of mental health, substance use and violence is not so much of a taboo anymore. There is still much more work to be done, but it’s happening,” Irizarry said.

All five members of Galt City Council attended the meeting. Council Member Shawn Farmer asked what is being done to address mentally ill people who are repeatedly arrested and released.

Director of Health Services Tim Lutz said the county encourages law enforcement to take people having mental health crises to urgent care rather than jail, with the goal of breaking the cycle with treatment.

Mayor Jay Vandenburg asked about the county’s ability to work with homeless people who live in the area around Dry Creek, which is partly in San Joaquin County. The officials said there are complex jurisdictional issues in the area.

The county officials who presented encouraged attendees to spread information about county behavioral health resources. See below for a selection of contact information and resource lists for various topics.

SACRAMENTO COUNTY, CA (MPG) - This is a good time to make sure residents know what to do in case we have a repeat of last January’s storms. It is important for you to know the flood risk to your home or business. After years of drought, the floods of 2023 were a stark reminder about the County’s location in a floodplain. The County’s Department of Water Resources has information to help residents understand the threat flooding may pose to property. Go to www.stormready.org and click Flood Zone Information to learn more about your flood risk.

If you live in a flood zone, you can reduce the potential for damage to your property by being proactive.

Before the rain falls, remember to clear storm drains of leaves and debris to ensure the water freely flows away from your home. Clogs can cause localized flooding to streets that could eventually back up to your doorway.

If you come across street flooding, call 3-1-1 to have County crews come out and clear the clogs.

Don’t drive through flooded streets. Turn around, don’t drown!

If you see items dumped into nearby creeks, call 3-1-1 and report it. It’s important to clear those areas before the rain to avoid problems.

Even in non-disaster years, nearly 20 percent of flood insurance claims in Sacramento County come from moderate to low-risk areas. Residents can obtain flood insurance if their homes

or businesses are not in the mapped floodplain. If unchecked, localized flooding can cause a lot of damage. If you live in an area prone to flooding, consider talking to a qualified insurance agent about flood insurance. It takes 30 days for flood insurance to take effect, so don’t wait.

Did you know that Sacramento County takes part in a special Federal Emergency Management Agency (FEMA) program that helps reduce the cost of flood insurance? Through FEMA, residents living in a designated Special Flood Hazard Area can save about \$446.00 per year on the full cost of a standard flood insurance policy.

Take the time to develop an evacuation plan for you and your family. This plan will be useful for any potential disasters, including fires. It’s not too early to decide where you will go and what you should take.

What do you take if you need to leave? Remember the “five Ps” you should have ready to go if you need to evacuate:

- People and pets
- Papers (important documents)
- Prescriptions (medication, eyeglasses, hearing aids)
- Pictures (Irreplaceable memories)
- Personal computer

Also, have a designated meeting place in case your family is separated. Visit Stormready.org to view evacuation maps as well as the region’s flooding history.

Need sandbags? On November 1, Sacramento County will open two sandbag locations for residents in the unincorporated area. For those who live in a flood prone area, this will offer up the chance to grab sandbags prior to the rainy season. The County supplies the sand and bags, but bring a shovel. There is a 20-bag limit per visit.

Do you live near a creek or stream? Follow the rise of nearby streams with the Water Resources Rainfall and Stream Level Information System at www.sacfflood.org. This system monitors 47 different waterways in the County. If you live by one, it’s one way to keep an eye on how high the water is rising.

You can also receive evacuation notices during flood threats by signing up to Sacramento Alert. This Countywide system, run by the Office of Emergency Services, will keep you informed about potential flooding or other emergencies threatening your neighborhood. Be Aware. Be Prepared. Make yourself Storm Ready. ★

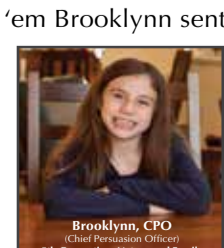

Spiritual Care

In my new book, "Tell it To the Chaplain," I describe the yearlong post-graduate residency I took in 1991 to become a chaplain. The program was called Clinical Pastoral Education and was the hospital-based internship required to begin a career in healthcare chaplaincy. Each morning, the interns went onto the wards to support patients in need of spiritual care. In the afternoon, we'd critique our patient visits with our supervisor and fellow students. Dr. Timothy Little was our supervisor. He was an old hand at teaching his charges how to walk with patients through sickness and pain. He was blind, yet quite Yoda-like with his limitless wisdom. He often used a critique tool called a "verbatim," which was our written verbatim of a visit in a word-for-word description. One afternoon I went onto the hospital wards determined to find a patient who would portray me in a favorable light to my supervisor. As I walked past the nurses' station, a nurse called me aside to tell me of a patient requesting a chaplain visit. The man he described was in his fifties and had just received a terminal diagnosis of stomach cancer. However, before the nurse could explain more, an urgent phone call pulled him back to the desk. Never mind, I thought, waiving a dismissive hand.

Pregnant With Truth

I pushed out of the station like I was Chaplain America looking for a patient to save. I found the room and opened the door. As I neared his bed, my game face shattered. The male patient appeared every bit pregnant. Fortunately, I think his bulging gut blocked him from seeing the shock on my face as I composed my introduction. The man responded well. He took an immediate liking to me and freely shared the doctor's prognosis. "Would you pray with me?" he asked. "I feel God in me and know He wants to heal me." "Certainly," I said, smiling inwardly. This was someone I just might "save." I prayed a strong prayer from my Baptist tradition, full of words like, "If it be your will, God," and "In Jesus's name we ask." In retrospect, it was more like I was casting a theological incantation rather than trying to understand the man's soul. Still, he offered a satisfied smile. I was sure my patient would be the stunning star of my upcoming verbatim. Just as I was about to dismiss myself, the man placed his hand on his belly. "Sometimes I can feel him move," he said. "Pardon me. Who do you feel move?" "Jesus!" he proclaimed. "Jesus is returning through me. I'm carrying God's son." Along about then, the nurse appeared at the door and motioned me outside.

"Chaplain, I was trying to tell you that our patient is also psychotic." I shot the nurse my best "no-duh" look. "I was trying to tell you that when my phone rang," he added. A few days later I humbly presented the verbatim as a "how-not-to." I admitted that I'd not waited for the nurse's guidance or tried to hear the patient's pain. Dr. Little tapped his white cane on the floor. "Well, well, well," he said, "I think we might have the beginnings of a chaplain." Years later, I reprised that verbatim, this time before a peer committee as I sought professional certification as a chaplain. "What did you learn?" asked one committee member. "I learned that I can't be the hero of someone else's story. When someone invites me into their story, I can't morph into the Great Explainer or shine as the Truth Holder. I must honor the way God intersects their story without injecting myself into it." They all voted to endorse me as a new chaplain - and gratefully, I acknowledged that their commendation demonstrated yet another way in which God intersects my story. 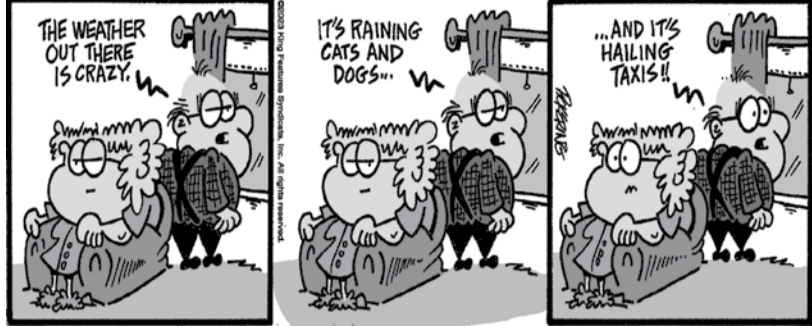

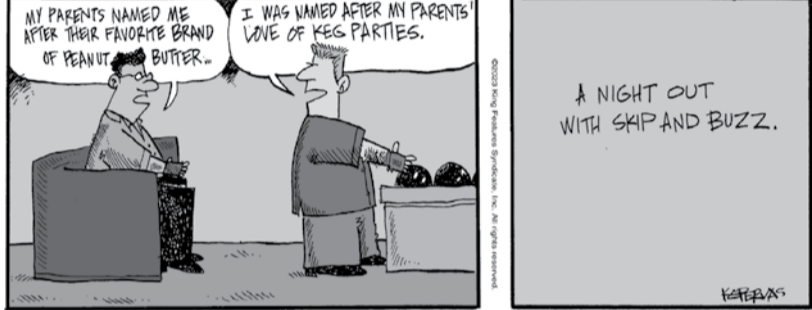

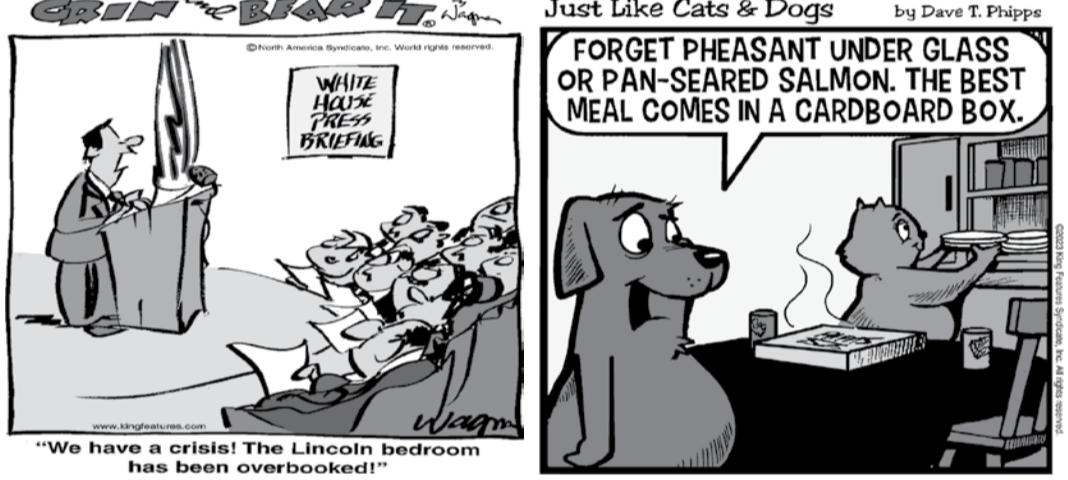

Hawks Continue Dairy Bowl Winning Streak

GALT, CA (MPG) - The 14th Annual Dairy Bowl took place on Friday, October 27th, at Warrior Stadium, where the Warriors held a special ceremony to honor their senior football players, cheerleaders, band members, cross country runners, and golf team before the game. Despite being ranked last in the league, the Warriors put up a tough fight against the third-ranked Hawks.

The Warrior defense held off the Liberty offense impressively, allowing them to score only with 50 seconds remaining in the first quarter. The final score favored Liberty, with a 42-13 victory.

Consistent with the rest of the season, this game seemed to have yellow flying in abundance. The Warriors received the ball and had an immediate holding penalty called on them. They were soon forced to punt and Liberty took the ball over on their 40.

However, Liberty's momentum waned as they encountered a false start penalty followed by a fumble on the next play, which was recovered by Warrior Brendon Lane.

A false start penalty was then called on the Warriors, but they managed to secure a first down. Hawk George Adrian soon sacked Warrior quarterback Roman Tapia, and the Warriors faced more adversity with another false start penalty, making it 3rd and 30. Sean O'Brien then sacked Tapia once again, leading to a Warriors' punt. Finally, with only 50 seconds left in the first quarter, Hawk running back Joseph Brown found the end zone, scoring for Liberty.

The Warriors struggled to gain momentum after receiving the ball and eventually turned it over on downs. On the second play, a personal foul penalty was called against the Warriors with 10:05 remaining in the first half.

Soon after, Hawk quarterback Wyatt Blevins pitched to Brown, who advanced the ball to the 20-yard line. A personal foul penalty was then called on both Liberty and Galt, with a subsequent unsportsmanlike conduct penalty on Liberty. Brown swiftly scored his second touchdown of the night, though he received a penalty for taunting. The score stood at 14-0 with 6:33 remaining

in the first half. The Warriors fought hard, but penalties continued to impede their progress. Another personal foul penalty was called on them, followed by a personal foul on the Hawks, allowing the Warriors to regain the 15 yards lost in their previous penalty. Galt's Tapia attempted a throw for a score but was sacked, resulting in a turnover on downs with 2:08 left in the half.

In the dying seconds of the first half, Liberty's Oscar Romero caught a 23-yard reception with his fingertips, securing a touchdown and bringing the score to 21-0 at halftime.

Liberty Ranch maintained their momentum after halftime, as senior Shaye Setter ran into the end zone with 9:24 left in the third quarter. Galt attempted a throw, but Liberty's Joseph Brown intercepted the ball. Brandon Cathey swiftly advanced the ball to the 2-yard line, and with 7:24 left in the third, the Hawks scored another touchdown.

Galt fumbled on the kick-off, and the Hawks recovered the ball on the Warrior 18-yard line. Cathey capitalized on the opportunity, scoring once again, bringing the score to 42-0 with 5:48 remaining in the third quarter.

Despite the challenges, the Warriors made a remarkable play when Kayson Jones caught a pass from Tapia and ran for an 80-yard touchdown, breaking four tackles and delivering two stiff arms. The score now stood at 42-7.

Galt attempted an onside kick, but Liberty gained possession at midfield. Liberty couldn't convert, resulting in a punt, and Galt took over on their own 19-yard line. Penalties plagued the game again, with defensive holding called against Liberty, followed by a false start penalty on Galt. With the ball on the 29-yard line, Galt's punt handed possession back to the Hawks with 9:18 left in the game.

Liberty momentarily lost control of the ball, allowing Galt to regain possession. Tapia was sacked one more time, but he managed to find an opening, pointing out a block for Jones, managed to squeeze into the end zone. Galt then attempted an unsuccessful 2-point conversion, leading to a final score of 42-13.

Liberty Ranch wasn't without their adversity this season. "We are proud of our
