For those of you faithful sports fans, and in particular Sacramento Kings fans who still find eating breakfast on a Sunday morning with a paper in your hand a salubrious experience, I welcome you one and

Can it be just seven short years since the Kings were rescued from the Siberia called Seattle, and placed inexorably in the fabulous confines of technical wonder, Golden 1 Center?

True, we suffered through several losing seasons and more than one questionable draft choice, but memories of past bad experiences fade quickly when your team transforms into a kaleidoscope of positivity.

Last season's 48 wins did more than just get our attention. It ignited an energy that has awakened the base and brought with it new fans that had only an anemic interest in the past.

Recent years brought new faces and crowd favorites such as De'Aaron Fox, Malik Monk, Keegan Murray, and the acquisition of All-Star Domantas Sabonis was the missing piece the Kings have been looking for, for years. Trading fan favorite Tyrese Haliburton for Domantas Sabonis was controversial, and at the time shocking for many Kings fans, but leading the NBA in rebounds and double-double's convinced many that the organization had finally made a trade that would elevate the Kings to the next level.

Whether your favorite player is Domantas Sabonis, De'Aaron Fox, or Sasha Vezenkov, or Davion Mitchell, there is plenty to be happy about with the team we have

In years gone by, we would be jumping for joy with a 9-6 record, but Kings fans know with a little luck it could easily be 12-3. Losing backto-back games in both Houston and New Orleans wasn't on anyone's radar, and if Clay Thompson hadn't hit a last second bucket our Kings record would be the envy of the league.

I remember as a young Kings fan in 1989 feeling lucky just to get a ticket. Those hopeful of becoming a season ticket holder could expect to wait 3-5 years before such an opportunity would arise.

For the past 20 years season tickets have been in abundance, but no more. The number of wins accumulated this year will no doubt correlate with the depth of the waiting list for season tickets, and many believe the Kings could surpass the 50-win mark for the first time in over 20 years.

Yes, Kings fans, it's fun again to take your family or sweetheart to a game, and with the advent of the hightempo, high-scoring game the Kings play today, it's by far the hottest ticket in

Mike Brown in his first full season of coaching with the Kings brought a winning style of basketball, and by season's end the Kings had amassed the highest point total in the entire NBA.

Sending not one, but two All-Stars to the All-Star game was a highlight of last year's season, and it wouldn't surprise anyone if De'Aaron Fox and Domantas Sabonis did it again.

There remains question marks though, and we will sort them out as the season progresses.

Mike Brown's use of his bench has had many scratching their heads, as crowd favorite Davion Mitchell rode the pine for more than one game before finding himself in the rotation again. Davion, while a streaky scorer, is perhaps the most dependable defensive player on the team, and without a doubt stirs the crowd whenever he enters the game.

Keegan Murray has struggled at times this season to find a consistent 3-point shot, but coach Brown remains committed to Keegan, and it appears to have had a positive effect on his defensive play as well.

De'Aaron Fox may go down as the greatest first-round draft choice in the history of the Kings before his playing days are over, but for the moment we will just be consistently amazed at his lightning speed and acrobatic shot making! Truly a gem, De'Aaron has become an All-Star right before our eyes, and many fans believed his All-Star appearance last season was overdue.

Gear up Kings fans! This is going to be a wild ride, and supplanting the Golden State Warriors as the Northern California #1 team is the first test we will have to face.

"At Women's Empowerment, we believe there is dignity in giving," Culp said. "So often unhoused women and children do not have the resources to give gifts to their loved ones. We are grateful that this community helps us ensure they have that joyful and proud experience of giving."

Women's Empowerment provides a two-month employment-readiness and empowerment program, paid job training, childcare and support services so women and their children can break the generational cycle of homelessness. Women's Empowerment offers the most comprehensive job-readiness program in the Sacramento

area designed specifically for women experiencing homelessness and their children. Last year, 121 graduates secured employment or enrolled in paid training or education. 

"We have been providing academic support to foster families in the San Juan Unified School District this year, and we are thrilled to offer this holiday market so the families we have worked with can choose gifts and other items that will best prepare their foster youth for success in school and later in life. United Way's Foster Youth Support program with San Juan Unified School District provides academic intervention and supportive services to district foster youth in kindergarten through eighth grade. Primarily funded through a grant from the Sacramento County Department of Child, Family and Adult Services, program staff works with each student and their team of caregivers, family, teachers and counselors to connect youth and caregivers to school and community resources, including transportation support, academic assistance, health services, behavioral health support, housing, food, clothing and more. 

This is the time of year that many of us consider our charitable-donation budget. But as we decide how much to give, perhaps we also ought to calculate why we give.

In his list called "Eight Degrees of Charity," the 13th century Rabbi Moses Maimonides offers wise council for weighing our motives.

I've mentioned his list a few times in this column, but like Dicken's "Christmas Carol," the list inspires me each time I revisit it. The unabridged catalogue can be found on my website, but since it has many nuances, allow me this paraphrased summary.

Maimonides describes his list as a ladder, so let's begin at the bottom rung, the lowest form of charity.

8. Sometimes we give only because we are uncomfortable with our wealth. This sentiment is aptly described by Tibetan Buddhist Trungpa Rinpoche as "Idiot compassion." You can see it in the actions of retirees like me who did this during the pandemic. As our savings bulged with stimulus checks and investment returns, we started giving to the local foodbank. No judgment here. I think Maimonides would say that most charity is good charity. Still, it's hard to sort our good motives from our lesser ones. That's why the rabbi encouraged us to work our way up the ladder.

7. Let us give cheerfully but not too much. We do this by dropping a few bucks in the Salvation Army kettle or the church offering. We smile generously, but we know it's woefully inadequate.

6. Just ask me and I'll donate. Generous, yes. But why must we be asked first? In Honduras, as in many Latin countries, people of all income levels will carry charity money to give to those who ask. The San Francisco company GoFundMe began with the premise of giving to those who ask. The tragic drama

in many requests inspires us to give. In 2021 they generated \$22.6M in revenue.

5. Let's give without being asked. This sounds like a clean motive but it's low on the ladder because the giver may be doing it to gain attention. On one hand, it's the kind of giving we might do when we say we pick up the dinner check. On the positive side, it's the kind of giving we do when a neighbor needs our assistance.

4. We should give to those we don't know, but they should know who we are. A lot of us achieve this when we give to the homeless woman at the intersection. It's a kind act, but there's no way to avoid making the recipient feel less-than.

3. I like to give anonymously but I need to know who's getting it. This may seem like a high form of giving, but not quite. Maimonides cautions that since "subconsciously, the giver might gain a pleasure and a sense of power over the recipient, this detracts from his act."

2. I like to give anonymously and don't want anyone to know This one is tricky, but the best modern-day example is the Salvation Army Kettle. Your donation helps the poor, but you will never know who they are, and they will never know who you are. You have no say in where the money goes and cannot take it back. And the highest degree of charity motive on Maimonides list is...

1.Let's form a business partnership with the poor. "What?" you ask. "Business is not charity!" The rabbi considered this the highest charitable form because it "strengthens the hand of the poor through either a gift or an interest-free loan." Surprisingly, Maimonides considered the loan better than an outright gift "since the poor are not shamed."

This charity is best illustrated in the saying, "Give a person a fish and he will eat for a day. Teach him to fish and he eats for a lifetime."

It's this charitable approach that has inspired me to proudly promote Chispa Project in this column for the past eight years.

Chispa establishes libraries in Honduran elementary schools with the help of Honduran teachers, parents and students who will organize, plan and monitor the libraries.

Each Honduran community is asked to raise a symbolic portion of the costs (less than 4% of the total project). In this way Maimonides highest principle is applied and the schools establish ownership, pride, and better sustainability of the library.

"Pure" charity is about improving the lives of others, not our own. Yet still I think even Maimonides would have to admit that sometimes we need to do something to feel better. Regardless of our motive, someone is helped.

In any case none of us have a pure heart, so thankfully most charities are able to help those in need regardless of our motive to give.

FBI Warns of Charity Scams in Israel, HAMAS Conflict

SACRAMENTO, CA (MPG) - The Federal Bureau of Investigation (FBI) Sacramento Field Office is warning the public that criminals are soliciting donations during the Israel-HAMAS conflict. These charity scams victimize both well-meaning, local communities, and the vulnerable populations impacted by life-changing catastrophes.

Scams are especially prevalent during times of increased conflict such as war, natural disasters, or epidemics. Criminals often use these crises as opportunities to exploit individuals seeking to support humanitarian efforts. Perpetrators claim to be associated with established charities or creators of new charities associated with emergent conflicts.

Local communities may be targeted by individuals claiming to collect funds for victimized families while using the donations for their own personal gain or in support of domestic or international criminal enterprises.

Foreign terrorist organizations often establish fake charities using social media platforms to misdirect unwitting donors to subsidize their operations. Solicitations are then coordinated via social media posts, e-mail, cold calls, or crowdfunding website requests.

To avoid becoming a victim: Approach all unsolicited co

Approach all unsolicited communication including direct messages, calls, and e-mails with suspicion;

Visit the official website of a charitable entity directly to obtain contact information rather than clicking on links in e-mails or assuming the unsolicited call is from an official source;

Thoroughly research new charities online



and verify phone numbers or e-mail addresses before donating. Be sure the named charity is not associated with scams and uses funds as they claim:

Ensure that you are using the official website of a well-known charity. Criminals may create look-alike, "spoofed" websites with URLs similar in appearance to those of known organizations;

Visit the California Attorney General's Charitable Registry Search tool to ensure a charity is registered in the State of California;

Visit the IRS Tax Exempt Organization Search to see if a charity donation to the organization is tax deductible;

Never pay by cash, gift card, wire transfer, or cryptocurrency. Each of these forms of payment are difficult or impossible to track and reverse.

The FBI urges the public to report these fraudulent or suspicious activities to the FBI Internet Crime Complaint Center at IC3.gov. The public may also call their local FBI field office or resident agency. ★



Canvassers Needed for the 2024 Point-in-Time Count

SACRAMENTO COUNTY, CA (MPG) - Sacramento Steps Forward (SSF) announced on Monday, December 4, 2023, that the evenings of Wednesday, January 24 and Thursday, January 25 have been selected for Sacramento's 2024 Point in Time Count (PIT). SSF is seeking hundreds of volunteers to help with what will be the most wide-ranging community effort to date to determine the number of people experiencing homelessness in the Sacramento

The event is intended to provide a comprehensive estimate of the total number of individuals and families living outdoors and in places not intended for human habitation on a single night. SSF will release the results in a report in spring 2024. PIT data enables community leaders to better understand homelessness, design more effective policies and programs, and measure progress toward reducing and ending homelessness.

The PIT is part of a nationwide effort. The U.S. Department of Housing and Urban Development (HUD) requires communities to do a census to qualify for annual federal homelessness response dollars. In 2022, the Sacramento community received \$30.5 million

in HUD Continuum of Care funding, \$29 million of which was dedicated to maintaining permanent housing programs and directly served 1,271 households.

More than 500 volunteers participated in the last PIT count in February 2022. It concluded that an estimated 9,278 individuals experienced homelessness on a single night. Find the full report on Sacramento Steps Forward website.

"The PIT is a huge community-wide

effort that gives people a chance to make a meaningful contribution toward better understanding where we are and is a great way to contribute toward addressing and ultimately ending homelessness," said Lisa Bates, Chief Executive Officer of SSF.

The PIT's main deployment center will be at Sacramento State's Harper Alumni Center. Several other satellite locations will operate in the region. Canvassers will fan out to predetermined census tracts across the Sacramento region. The 2024 PIT will also include more intensive coverage

of known homelessness locations along the American River Parkway.

Volunteer canvassers will be able to utilize a new "Counting Us" mobile application, a HUD approved method of counting used in many cities and counties across the U.S. The application replaces previously used apps and paper-based data collection methods. The app, developed by Simtech Solutions, Inc. - which is joining forces with SSF this year as the researcher selected for the PIT Count - will support efficient canvassing by volunteers.

To canvass, a volunteer must be at least 18 years old, be willing to travel by foot or car to predetermined locations, and be willing to use their personal smartphone and flashlight. Additional volunteers are also needed for a variety of support functions at the deployment centers. Volunteers are required to complete a volunteer training session. Two live training sessions will be offered via Zoom, on Wednesday, January 10 and Wednesday, January 17, both from 5 to 6:30 PM. For those unable to attend a live session, there is a new recorded training option with a short quiz to assure accountability and comprehension. The live training is highly recommended for new PIT volunteers.

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Coroner's Office is seeking the public's assistance in identifying an unidentified man.



Creating Families Through Adoption

SACRAMENTO COUNTY, CA (MPG) - It took a little effort, but 4-year-old Elias signed his own name on his adoption papers. During the short and cheerful proceeding, the judge defined adoption as a choice to be a family, a lifelong agreement to treat them as your own natural-born child. Finding the adoption to be in Elias' best interest, the court declared him and his grandmother, Kimberly McCloskey, as a parent and child under the law.

"Today is a great day," McCloskey said.

Adoption Day

Court is not usually a place for young children, let alone a courthouse full of them. But on Saturday, November 4, 29 families finalized the adoptions of 34 children at the William R. Ridgeway Family Relation Courthouse. Volunteers—including

nonprofits and government agencies, judges and court staff – made the day fun, colorful and memorable for children and their new official families with balloons, sweets, toys and books, a police car and firetruck.

Family, foster care and adoption

The adoption process started for McCloskey a year ago when her daughter wasn't able to care for Elias and he ended up in foster care. Wanting to provide a stable home and keep him with their family, she stepped up and asked to adopt her grandson, who she describes as smart and loving.

"I just wanted him to stay in the family, I wasn't sure if [his foster family] was going to allow for me to continue to see him, and I didn't want him out of my life," she says. "I came forward and said that I wanted to adopt him."

While McCloskey admits that it can be tough dealing with and advocating for yourself in the court system, she did get support from social workers who helped guide her through the process, which included becoming a certified foster parent, home interviews, fingerprinting and foster parenting classes.

"The goal of permanency is to provide a child the opportunity to develop secure attachments which can promote more positive educational and social outcomes, and promote a child's optimal physical and emotional growth and health overall," says Melissa Lloyd, Sacramento County's Deputy Director of Child Protective Services. "All children deserve to have a family and strong connections for life."

Supporting children and families

While National Adoption Day is officially November 18, Sacramento County celebrated Adoption Day early so new families can enjoy

their first official November holidays together. Several community organizations also took part to make the day special, including:

Sacramento Department; Sacramento County Library; Sacramento Sheriff Department Youth Services; Department of Child and Family Adult Services; Court Appointed Special Advocates of Sacramento; Wayfinders Family Services; Zeta Phi **Beta Sorority**

"Adoption Day brings national attention to the significant number of children and youth who remain in foster care awaiting their forever home," Sacramento Superior Court's Juvenile Court Presiding Judge Dena Coggins said in a statement. "Our last National Adoption Day event occurred in 2019 and was extremely successful. We are excited to bring this wonderful event back to Sacramento County."


