**GALT, CA (MPG)** - For a second year, the Galt-Arno Cemetery District took part in the national Wreaths Across America observance, an event honoring the country's service members. In simultaneous ceremonies

across the United States on Dec. 16, wreaths are laid at the graves of military members in recognition of their sacrifices.

The Galt-Arno district made significant progress toward a goal of funding enough wreaths to adorn the graves of every veteran buried in its cemeteries. Community donations funded 380 wreaths this year, District Manager Belinda Ellis told the Herald. That was compared to 254 wreaths last year, when the district first participated. To place wreaths at every veteran grave, the district will need to collect more than 700. Ellis said organizations that contributed included A-Z Foundation, Seventhday Adventist Veterans Group, Cremations Only, Shepherd of the Valley Lutheran Church and Michael's Miracle Foundation.

## 2 Arrested in Twin Cities Drive-by Shooting

**GALT, CA (MPG)** - Galt Police Department has made two arrests in connection to a shooting that injured two boys near Liberty Ranch High School nine months ago.

The department made the announcement in a social media post on Dec. 15, saying that on Dec. 9, Galt and Lodi police arrested Juan Blanco, 18, of Lodi, as well as an unidentified juvenile.

"The arrest was made possible through diligent investigative work and the unwavering commitment of our officers, detectives, and partnering agencies," the Galt PD post read. "Blanco is currently being held without bail pending formal charges related to attempted homicide and shooting into an inhabited dwelling/vehicle." The juvenile was arrested on suspicion of being an accessory in the shooting. The drive-by shooting took place in the late afternoon on March 15 at the intersection of Marengo and Twin Cities roads. According to police. the people involved were traveling east on Twin Cities. In a vehicle at the scene, officers found a 17-year-old boy and a 15-year-old boy who had both been shot multiple times; a 17-year-old in the car with them was uninjured. Liberty Ranch High School and Galt Adult School were evacuated, while class at all Galt Joint Union High School District campuses were sent home for the day. Galt police leaders later told the Herald that they doubted that there was a connection to Liberty Ranch, but they believed that there was a connection between the perpetrators and those injured. While one of the boys who was shot was soon released from the hospital, the other was in critical condition nearly a week later.

Continued from Page 1 honor those that serve and their families, and teach the next generation the value of freedom," Ellis said before the ceremony opened with the pledge of allegiance and the national anthem. She later expressed gratitude for the service of veterans and active military members.

Shepherd of the Valley pastor Michael Dubé gave the invocation, describing the event's theme.

"The 2023 theme is 'serve and succeed,' simply because there are so many ways we can serve our families, our communities and our country. We succeed together when we serve the needs of others and grow together," Dubé said before calling for a moment of silence and leading attendees in a prayer.

Individual wreaths were displayed in honor of members of each of the six U.S. military branches, as well as the U.S. Merchant Marine, first responders, and service members who are missing in action or prisoners of war.

Ellis encouraged attendees placing wreaths to say the name of the veteran aloud and take a moment to reflect on their service.

"It's a small act that goes a long way towards keeping the memory of our veterans alive," Ellis said. "Remember: We are not here to decorate graves; we are here to remember not their deaths but their lives. Each wreath is a gift of appreciation from a grateful America." ★


*Continued from Page 1* the "Memorial Tree" to remember loved ones.

**GALT, CA (MPG)** - The annual spelling bee at Marengo Ranch Elementary School was anything but "nondescript," but that was the word that won the day for the first-place speller, Levi Peterson.

The spelling bee began with 12 of the school's

best spellers, ranging from fourth to sixth grade. The words gradually increased in difficulty from simpler terms like "blank" and "mile" to words that tripped up some of the competitors, like "clearly" and "oddity." But they also made quick work of tough words like "stitchery," "deliberately" and "bamboozled." When the final two students were left, they gave correct spellings for three rounds, until one of them misspelled "sentinel." That gave Levi, a sixth grader in teacher Dave Moore's class, a chance to win. He spelled "sprocket" correctly and then "nondescript," clinching the victory.

#### Sacramento County Sheriff's Office News Release

SACRAMENTO COUNTY, CA (MPG) - During our recent retail theft Operation Bad Elf, detectives observed an individual, later identified as Ningning Sun, acting suspiciously near the gift cards in the payment aisles in a Sacramento Target store. Detectives observed him placing all the gift cards on a rack inside his jacket, then replacing the gift cards with another set of seemingly identical ones. After Sun was stopped trying to exit the store with the stolen gift cards, detectives discovered over 5000 gift cards from Target and Apple in his possession.

Their investigation revealed Sun was part of a scam that tampered with gift cards, scanned

money from the gift card as money was loaded on them. Victims are completely unaware it is happening, and the money is often siphoned to an off-shore account within seconds. Their investigation revealed that the operation spanned across California and several regions nationwide.

The Sacramento County Sheriff's Office urges residents to be cautious when purchasing physical gift cards from any retailer. Be observant of any signs of tampering, especially scuff marks or scratches near the bar code on the back of the card. These operations are very sophisticated, and modifications to the gift cards are often virtually undetectable, even to the trained eye. Detectives suspect Sun has done this at many stores and

are requesting the public's help to potentially link him to other crimes.

This investigation is still ongoing, and detectives are asking anyone with information about this incident to contact the Sheriff's Office at (916) 874-5115 or Sacramento Valley Crime Stoppers at (916) 443-HELP (4357). Tips leading to additional charges are eligible for a CASH reward of up to \$1000, and tipsters remain anonymous. Tips are paid in cash, and you are never asked for identification.
