Solving an Impossible Problem

Supreme Court will hear case about homeless encampments, with huge implications for California

The U.S. Supreme Court will weigh in on whether cities can legally ban or limit unhoused people camping in public spaces — a case that could grant California officials more power to sweep homeless

The case, originating from the Oregon city overturn or narrow a fiveyear-old precedent from a federal appeals court that limited how much cities in Western states could criminalize those who sleep on the streets when

there aren't enough shelter spaces available.

In the older case — Martin v. Boise — the Ninth Circuit Court of Appeals ruled in 2018 that it's cruel and unusual punishment to criminalize camping on public property when the people in question have nowhere else they can legally sleep. The ruling was binding on West Coast cities, where rising rates of unsheltered home lessness that later spiked during the pandemic were driving local politicians to pass public camping prohibitions. In 2019 the Supreme Court declined to

hear an appeal of that case.

Since then, California cities have often been subject to federal lawsuits after passing restrictions on when and where the unhoused can set up camps. Relying on the ruling in the Boise case, judges have delayed or outright halted camping bans from being enforced in cities including San Francisco, Sacramento, Chico and San Rafael, finding that the cities had failed to provide adequate alternate shelter options for the residents they were about to sweep from their encampments.

The situation has led city officials —and Gov.

Gavin Newsom — to complain that the Boise ruling has tied their hands from addressing the state's sprawling encampments, arguing they need to sweep camps both for health and safety reasons and for the well-being of encampment residents. It's led liberal state and local officials, including Newsom, to join conservatives in asking the court for more power to penalize the homeless for sleeping outside. The high court has a 6-3 conservative majority.

In a high-profile case that has particularly drawn Newsom's ire, the Ninth

SAFE Accepting Grant Applications for Financial Literacy Programs

FOLSOM, CA. – (MPG) - In its drive to improve financial literacy in the Greater Sacramento region, SAFE Credit Union will grant \$20,000 to a nonprofit organization providing financial literacy and financial stability programs in underserved communities.

SAFE is accepting applications for the grant until Friday, Feb. 9, through its online application, or at https://www.safecu. org/community/community-impact/funding/ community-sustainability-grant-application-1.

"Equipping people with the skills they need to take charge of their finances is one of our main motivations here at SAFE," says Vice President of Community Relations and Financial Education Rebecca Delmundo, adding only 27 percent of California's students attend schools that offer personal finance

"It's essential for people to understand how to put aside savings, how interest rates and loans work, and how to handle debt for them to succeed in life. With so few students receiving formal financial literacy training, financial cooperatives like SAFE Credit Union and our nonprofit partners are stepping in to provide this much-needed education," she continues.

Only 1 percent of California students are required to complete personal financial education courses to graduate from high school, according to state Department of Education statistics. There have been some political efforts to change that, with the Legislature recently considering proposals, and a 2024 ballot initiative in the works. However, the grant, says Delmundo, represents how SAFE and others in the region dedicated to providing financial education services are stepping in to fill the need

Delmundo says that young people especially can benefit from financial education programs since mistakes they may make early in life can affect them long into adulthood.

"It just takes one missed payment to harm a credit score," she says. "I've seen a lot of young people get buried in credit card debt while also tackling paying off student loans. I'm a strong proponent of helping people learn how to handle the finances they have now so they can achieve their future financial goals."

SAFE offers its own financial education services through free webinars available to the public as well as workshops to employers and organizations. It also offers its no-cost Budget Cents interactive simulations to high schools in the region, where students get a first-hand look at the real-life expenses they'll face as adults. SAFE's high school branch program works closely with three area high schools to house a branch at each and provide supportive financial education for the students who staff the branches and their fellow students.

"There are a lot of us working to fill the financial education gap," says Delmundo. "And we are all keenly aware of how many people truly want this information. This grant helps us help others providing this service."

SAFE conducts four grant cycles each year as part of its overall philanthropic program that also includes direct giving, scholarships, sponsorships, and volunteerism.

Circuit Court of Appeals this month backed a judge's 2022 ruling restricting San Francisco's enforcement of certain bans on sleeping on sidewalks and in parks, because the city hadn't shown there were other locations that were "realistically available" to unhoused residents before a city sweep.

"California's elected officials who seek in good faith to improve what often appears to be an intractable crisis have found themselves without options, forced to abandon efforts to make the spaces occupied by unhoused people safer for those within and near them," Newsom's administration wrote to the Supreme Court in September.

An attorney for the homeless Grants Pass residents said in a statement today that politicians were wrong to blame judges for the homelessness crisis. He said cities have always been allowed to regulate encampments, even under the recent rulings.

"The issue before the Court is whether cities can punish homeless residents simply for existing without access to shelter," said Ed Johnson, director of litigation at the Oregon Law Center.

The case is being closely watched by officials across California and could widely affect how they respond to encampments. Newsom's statement was part of an amicus curiae brief the administration filed in the case. Amicus briefs are legal briefs submitted by parties not directly involved in a given case, but who typically take one side or the other in a case. The majority of the amicus briefs filed in the case were from California entities and, though more than a dozen mostly-Republican-led state governments also filed a brief, Newsom was the only governor to weigh in.

In addition to Newsom's, other filings include the California State Association of Counties, the California State Sheriffs' Association, district attorneys for Sacramento and San Diego counties, the cities of Los Angeles and San Francisco, the Los Angeles Area Chamber of Commerce, the Bay Area Council, and even the Brentwood Community Council.

But advocates for the unhoused say the Boise ruling is clear. They point out that most cities have hardly enough shelter beds to accommodate their homeless populations and that shelters are often near-full on any given night, and say banning public camping or restricting it does more harm than good by pushing homeless people from location to location.

"All you need to do to be compliant with (the Boise case) is stop using our criminal system as the stick here to solve this problem," said Will Knight, decriminalization director at the National Homelessness Law Center, last year.

In particular, the court rulings have led to a patchwork of interpretations across the state on what qualifies as the "adequate shelter" cities must provide before sweeping homeless camps. The Oregon case that the Supreme Court agreed to hear could provide some clarity — or so California officials hope.

While the Boise ruling said the government can't broadly ban any public camping without giving people alternative places to stay, Newsom and city officials across California said in briefs filed before the Supreme Court that they want to know whether they can set restrictions on times or locations where camping is allowed.

Other questions include whether cities can criminalize public camping for those whom they call "voluntarily" homeless — people who refuse offers of shelter. And California cities have asked the court to rule on whether, in order to ban camping, they need to have a suitable shelter space available for every individual unhoused person no matter their circumstances, or simply have general shelter beds open the day they sweep a camp.

But U.C. Berkeley law professor Jeffrey Selbin, who has studied statewide responses to homelessness, said claims from both sides are overblown.

Selbin said the existing cases neither fully tie cities' hands, as some politicians say, nor provide a broad right to sleep outside, as some advocates say. He defended the status quo in which cities sometimes must seek guidance from federal judges to know whether their local rules are constitutional under the Boise decision.

In Chico, for example, a federal district judge in 2021 ruled that sending unhoused residents to camp on an unshaded airport tarmac on the outskirts of town was not "adequate" enough shelter to justify banning encampments in town. In response, the city settled the case by setting up a site of tiny homes where it can offer encampment residents a room before proceeding to sweep their camp.


That case, Selbin said, provided direction to other cities, showing that the court cases have "required local jurisdictions to take seriously what it means to provide basic shelter and options."

The Supreme Court is unlikely to provide that kind of "micromanaging," Selbin said, predicting instead that the justices will simply overturn the 2018 precedent set by the Boise case and allow cities to broadly criminalize encampments.

"It's just going to return California to the whack-a-mole of prioritizing punishment over services," he said.









Social Security Matters

How Can I Get Details about My Social Security Payment?

Dear Rusty: How do I find the actual breakdown of the Medicare insurance that I have auto deducted and my actual Social Security payment? I was just looking at a video which explained the 3% Cost of Living Adjustment we will be receiving this year, and it compared the current payout to the new payout. There seems to be a big difference in what I am getting and what they said in the video. Currently my Social Security payments are \$1,431. My Medicare insurance is supposed to be \$165, which means my total Social Security is about \$1,596. On the video it said all retired workers are getting \$1,848 with the new increase to take it to \$1,938.00. There are a couple hundred dollars there that I seem to be missing out on. Can you help me understand that difference? Signed: Confused Senior

Dear Confused Senior: What you're asking for is an itemized breakout of your gross Social Security benefit, any deductions being taken therefrom (e.g., your Medicare Part B premium), the amount of your COLA increase, and your net Social Security payment for 2024. If that is the case, the best way to get this detail is in your personal "my Social Security" online account, which provides all the information mentioned. You can access your online account at www.ssa.gov/myaccount, and if you don't already have that online account set up, you'll need to first establish your online access credentials (instructions for how to do that will be at that website).

I'm not sure which video you watched, but "all retired workers" do not get \$1,848 (or \$1,938). Everyone's Social Security benefit is different, based on their lifetime earnings record and the age at which they claimed benefits. The numbers you heard in the video were likely average Social Security payments, not the actual amount you should personally be receiving. Here's how it works:

· Your personal benefit is based on your Primary Insurance Amount (PIA) which is the amount you get if you claim for your benefits to start at your full retirement age (FRA), which is somewhere between 66 and 67 depending on the year you were born. Claim before your FRA your benefit is permanently reduced; claim after your FRA it is higher. Your personal maximum benefit is achieved if you claim at age

• The Medicare Part B premium (for outpatient healthcare services) is automatically deducted from your Social Security payment. Although the standard 2023 Part B premium was \$164.90, the standard 2024 Part B premium is \$174.70. You may also have other things (e.g., income tax) withheld from your monthly Social Security

• The annual Cost of Living Adjustment (COLA) for 2024 is 3.2%. That means your gross Social Security benefit goes up by that percentage starting in 2024. But there was also a \$9.80 increase in your Medicare Part B premium starting in 2024, which means that you won't see all of the COLA increase in your Social Security payment. Since your Medicare premium is deducted from your Social Security, that Medicare increase will also be taken from your SS payment, so you won't see the full 3.2% COLA increase in your 2024 Social Security payment. To see all of this detail

for you personally, I suggest you access your online "my Social Security" account as described above. As an alternative, you can also call Social Security at 1.800.772.1213 and request a Benefit Verification Letter which will include all the information you seek about your Social Security payment.

Outsiders Love Bashing California But Residents Are Souring On The State, Too

As Republican presidential candidates were slogging through Iowa and talking to voters prior to this week's caucuses, California-bashing was common.

Los Angeles Times reporter Seema Mehta picked up on the phenomenon, writing that "the Golden State, its elected leaders and its policies were a constant target."

"Bashing California, one of the most liberal states in the nation, is a grand tradition in the GOP," Mehta observed. "But Republican presidential candidates may be targeting the state and its politicians more this cycle because they are a better target than President Biden."

"Biden isn't as motivating a villain as other Democrats might be. So the Republican candidates are essentially running a negative campaign against California," California politics scholar Dan Schnur told Mehta. "The very worst thing Ron DeSantis could think of to say about Nikki Haley during the debate was that she might be more liberal than (Gov.) Gavin Newsom. For an Iowa Republican - or any

California may be the state that many in the rest of the nation loves to hate, but a new poll of Californians indicates that they aren't very sanguine

about the state, either. The UC Berkeley Institute of Governmental Studies found that just 33% of California voters believe the state is headed in the right direction while 57% say it's on a negative

"This is a somewhat more negative assessment than voters have given in similar measures conducted over the past 11 years," poll director Mark DiCamillo said.

The sour attitudes extend to Newsom, the poll found. Asked about his job performance, 47% of voters surveyed disapprove and 46% approve. That's a very slight improvement from the 49% to 46% ratio that pollsters found in October.

"However, similar to the October survey, twice as many voters say they strongly disapprove of the governor's performance (33%) as strongly approve (17%)," DiCamillo noted.

The poll introduced a new topic - the whopping budget deficit that Newsom and the Legislature must address this year – and discovered that nearly 90% of voters consider it a serious issue and there's almost no support (13%) for raising taxes to deal with it. Instead, voters prefer that Newsom and legislators

cut spending (51%) or tap

into state reserves (35%)

to cover the deficit, which

- that's an absolutely terri- Newsom pegs at \$38 billion but the Legislature's budget analyst estimates to be \$68 billion.

> Newsom also has shunned raising taxes, but progressive legislators, with support from groups dependent upon the state budget, such as public employee unions, have continued to press for higher personal and corporate income taxes and/or a new tax on wealth.

> It appears that by cutting or postponing some spending, using reserves, borrowing from special funds and implementing some accounting gimmicks, the governor and the Legislature could fashion a 2024-25 budget without new taxes.

> However, Newsom's budget advisors and those of the Legislature also agree that California faces continued multibillion-dollar deficits for the next several years, at least, which means the debate over spending cuts and taxes will continue for the remainder of Newsom's governorship.

> "The survey suggests little appetite for tax increases to address the deficit, but a challenge for Governor Newsom and the Legislature is that while spending cuts, in principle, are relatively popular, that support would likely dissipate when it comes time to making cuts to specific programs and services," the co-director of the poll, Eric Schickler said

Dear Dave,

My husband and I have run our own small business for nearly 10 years. Our largest client, who is also a friend, is almost three months behind on the bill. He has always been good in the past about paying on time, but we work on a 30-day payment period. Can you give us any advice on how we should handle this?

Dear Melissa,

In my mind, there's no reason to level accusations or make threats in a situation like this. There are personal dynamics involved, and my guess is he's probably not trying to outright cheat you.

If it were me, I'd go to his office or ask him out to lunch, and then have a friendly sit-down talk. Listen to what he has to

say about being so far behind with his bill, but at the same time you need to let him know that you can't function as his bank. You're a small business, and you need your money. Some kind of understanding and agreement have to be reached.

For starters, a fair

request would be asking him to help things along by trying as best he can to get current on his bill as soon as possible. At the very least, he needs to do something to reduce the amount owed within 10 days. You've provided services for him, and you're owed money that's long past due, so there's nothing wrong with this. I'd also establish an understanding that once he's caught up on the past due amount that all payments for services going forward will be due within 14 days after delivery.

Now, he may not like this. If he pushes back too hard, you may have to switch to a cash-only

basis with payment due on delivery. If it were me, and he didn't like any of these options, I'd politely suggest he take his business elsewhere.

Like I said, he's probably not a bad guy, just another small business person who's disorganized. That's not an uncommon thing. But you definitely need to correct this behavior before it gets any further out of hand. You've got a business and a livelihood to think about, too!

Women Business Owners are Optimistic and Confident

SACRAMENTO REGION, CA (MPG) - Women and men who own small and mid-sized businesses are typically more aligned than they are different in their viewpoints about the economy. Now – more than ever - this is especially true as it relates to their optimism about running their businesses, according to PNC's latest Economic Outlook Survey.

Survey results show that 69% of women and 73% of men are highly optimistic about their business prospects. But women appear to have the edge when it comes to confidence – 69% say they are confident about running their businesses compared to 57% of men. This trend is consistent with last year's survey responses. In 2022, 8 in 10 women business owners reported feeling very confident in their business success and nearly half credited their confidence to their own hard work and drive.

"It stands to reason that those sentiments, together with a few key resources professional networks, improved access to credit and the agility to navigate the economic landscape – all contribute to a level of confidence that is driving continued optimism this year," says Beth Marcello, director of PNC Women's Business Development.

ENGAGING IN NETWORKS

According to the survey, women-owned businesses are more likely to be engaged with the Small Business Administration, chambers of commerce and other professional groups. In fact, 83% of women business owners participate in business development organizations compared to 64% of men.

"Women often credit the benefits of a strong network to winning new business and finding new and better ways of doing business, and we're supporting that network-building through our relationships with organizations such as global nonprofit Coralus and the Women Presidents Organization," says Marcello.

DECISIONS FOR THE ECONOMIC LANDSCAPE

The optimism of women business owners comes through in the survey in specific areas of their enterprises, as 64% expect to see an increase in demand, 65% anticipate an increase in sales, and 56% predict an increase in profits in the next six months. While 57% also have plans to moderately increase prices.

"These are just a few indicators of how women are thinking as they make business decisions heading into 2024," Marcello says. "While some of their optimism may be tested by continued high inflation and a potential recession, there is strong evidence that they are prepared."

SEEKING CREDIT

When PNC began surveying women business owners in 2014, men were more likely to seek credit in the near term. The 2022 survey showed for the first time, women overtaking men when considering a new loan or line of credit to support business growth. This trend continued in 2023, with 26% of women saying they are likely to seek a near-term business loan or line of credit compared to 23% of men.

"While this data could simply reflect changes in the way women are conducting business, it's evidence that fewer women are intimidated by the traditional process of gaining access to credit for their businesses," Marcello says. "This is really encouraging."

Dedicated efforts to make more resources available to women entrepreneurs are paying off, says Marcello. At PNC, for example, women can lean on the expertise of 5.000 PNC-Certified Women's Business Advocates who have a passion for working with women financial decision makers. Through Coralus, entrepreneurs have access to a global support network and a no-interest loan program.

"Providing support to entrepreneurs and making access to credit more attainable are important steps toward their ongoing success as well as economic growth overall,"

California Farm Bureau-Sponsored Bill Targets Impacts of Statewide Wildfire Smoke

California Farm Bureau News Release

SACRAMENTO, CA (MPG) -Over the past five years, California has experienced unprecedented wildfire activity that has devastated nearly ten million acres across the state. Wildfire smoke has poured in from hundreds of miles away, severely impacting air quality around regions unaffected by the wildfire itself.

This is a direct result of years of mismanaged forest and wildland strategies that have created a new reality for California - one in which wildfires burn faster and hotter than ever before, presenting grave dangers to the environment and residents. As a result, many people suffered from health and economic impacts as they have been forced to shelter in place, with businesses and schools shutting down, and other daily operations coming to a halt.

Senator Marie Alvarado Gil's Senate Bill 945 (The Wildfire Smoke and Health Outcomes Data Act) would allow state agencies to track and monitor air pollution, population exposure, and cases of adverse health outcomes due to wildfire smoke. Using the compiled data, the appropriate agencies would be able to facilitate future research efforts to better understand the negative impacts of wildfire smoke on the environment and California's population. Currently, there is insufficient data by the state and medical community on these health impacts. "Ensuring the well-be-

ing of our communities means understanding the true impact of wildfire smoke. Our bill aims to unveil the impacts on our population, emphasizing the urgent need to address forest health for a resilient and healthier California," Senator Marie Alvarado-Gil stated. The California Council

of Science and Technology recently published a report stating that improving the health of California's forests not only reduces the risk of wildfire, it can also benefit people's health.

Shannon Douglass, President of the California Farm Bureau, weighed in on the significance of the bill saying, "Farming and ranching communities have been hit directly by wildfire smoke. At a time when state and federal

governments, including private landowners, are making substantial investments to mitigate wildfire hazards in our forests and woodlands, it is imperative that policy makers understand how neglecting to invest in our wildfire-prone communities can impact health outcomes -- from bringing on respiratory illnesses to pregnancy complications -- across the state's population." It is essential that we

work with our environmental partners to create and maintain a resilient California, where informed research guides our actions, and a commitment to forest health becomes the foundation for a safer, cleaner, and brighter future for all. Senator Alvarado-Gil

Matsui and Frost Introduce Legislation to Lower the Cost of EpiPens

Office of Congresswoman Doris Matsui News Release

WASHINGTON, D.C. (MPG) - Congresswoman Doris Matsui (CA-07) and Congressman Maxwell Alejandro Frost (FL-10) introduced the Epinephrine's Pharma Inflated Price Ends Now Act (EPIPEN Act), legislation that would cap the out-of-pocket costs of epinephrine auto-injectors at just \$60 per pack of two. Epinephrine auto-injectors, like EpiPens, are used to treat severe allergic reactions. This cap would apply to individuals with private health insurance.

The EPIPEN Act comes as the prices of auto-injectors have skyrocketed, with even generics becoming prohibitively expensive. EpiPen's manufacturer increased the price of the life-saving device from under \$100 to over \$600 in the past decade squeezing working-class Americans and families.

As costs have exploded, several states have acted to cap prices, but federal legislation is still needed to lower costs nationwide. The EPIPEN Act can save families over 90% on the cost of the device, and for those paying more than \$650 per year, \$13,000 in savings from the time a child is old enough to use the device to the time they transition off their parents' insurance at 26 years old.

"Families with children with allergies should not have to choose between ensuring their children's safety and paying for rent and groceries," said Congresswoman Matsui.

"Parents should be able to rest assured knowing their children have access to lifesaving epinephrine no matter where they are—and this access starts with affordability. That's why I'm pleased to introduce the EPIPEN Act with Congressman Frost. This crucial legislation would save people money and increase the number of those with allergies who can afford to carry epinephrine auto-injectors. Both Congressman Frost and I know how severe allergies can impact our lives and families, and this important bill would help patients and families throughout the country to prioritize their children's

safety."

"As someone who has suffered a life-threatening allergic reaction, I know first-hand just how critical it is to have access to an EpiPen or an auto-injector when your body needs it most. But right now, we have a problem in America where people who need EpiPens aren't carrying them simply because of the cost," said Congressman Frost. "Our office has heard from countless working folks who either carry expired auto-injectors or simply don't carry one despite their severe allergies because they can't afford it. It's time the federal government looked out for working families and capped these prices. Our EPIPEN Act can save some parents \$13,000 over the course of a child's life. This bill would make all the difference in ensuring that the decision to carry the medicine we need to stay alive isn't a difficult


The legislation has been endorsed by leading allergy organizations including Allergy and Asthma Network, Allergy Strong, American College of Allergy Asthma and Immunology, Doctors for America, and Food Allergy Research and Education (FARE); as well as organizations impacted by the rising costs of auto-injectors including the American Federation of Teachers, Association of Flight Attendants – CWA, and MomsRising.

"The American College of Allergy, Asthma and Immunology applauds the intent of this bill in requiring health plans to cover self-administered epinephrine for anaphylaxis while protecting patients from overly burdensome cost-sharing for their life-saving medication," said Todd Mahr, MD, Executive Medical Director, American College of Allergy, Asthma & Immunology.

"On behalf of the more than 33 million Americans with potentially life-threatening food allergies who rely on epinephrine auto-injectors to stay alive, FARE is grateful for Representative Frost and Representative Matsui's leadership in introducing legislation that would cap the costs our community pays for their epinephrine auto-injectors," said Sung Poblete, PhD, RN, CEO of FARE. "We proudly endorse this bill, will support it on Capitol Hill, and encourage other U.S. House members to cosponsor this critical legislation."
