Yuba Water Agency Supports Student Engineering

MARYSVILLE, CA (MPG) - Yuba Water Agency engineers are meeting with approximately 60 Yuba County middle schoolers this week as part of a new pathway program to expand engineering education opportunities for Marysville Joint Unified School District students.

“We already have many of these courses, like robotics and

coding, at some sites and we have started expanding these across the TK-12 system,” said Marysville Joint Unified School District Superintendent Fal Asrani. “Our new engineering pathway program is an example of a more formal and accessible option that is aligned to university standards so that students are better prepared to pursue a four-year degree, if they choose.”

Asrani spoke about the engineering pathway program during an update

to Yuba Water Agency’s board of directors on Tuesday. The new pilot program includes three years of integrated math and four elective courses in coding, robotics and artificial intelligence.

Yuba Water Agency is providing in-kind support of the program by connecting its engineers with incoming and current Lindhurst High School students to talk more about their career paths and what it’s like

Agency on Aging Area 4 to Fund Five Agencies to Improve Lives for Older Adults

YUBA AND SUTTER COUNTIES (MPG) - Agency on Aging Area 4 is one of six grantees awarded a total of \$1.1 million in California Department of Aging funding during round two of the Local Aging & Disability Action Planning Grant Program. The planning and capacity-building grant will support agency efforts in planning for and addressing the needs of older adults, people with disabilities, and professional and family caregivers in Yuba and Sutter counties.

Agency on Aging Area 4 will fund a consultant to work in partnership with five local organizations that will organize and conduct listening sessions/focus groups to inform the development of a plan(s) for Yuba and Sutter counties. The local age- and disability-friendly plans to be developed are to

improve a community's livability for residents of all ages centered on equity, cultural competency, community engagement, and disability inclusion principles and practices, according to the Agency on Aging Area 4.

"Real, meaningful change happens when community members are empowered to participate in the process," said Pam Miller, Agency on Aging Area 4 executive director. "We're honored to join the nearly 100 communities across California who have already embarked upon age- and disability-friendly action planning and implementation, especially in rural and underserved communities."

Organizations serving Yuba and Sutter counties that are interested in applying are encouraged to visit www.agencyonaging4.org/rfp. Questions about this opportunity should be directed to rfp@agencyonaging4.org. Proposals are

due Feb. 26 by noon for service beginning April 1 through March 31, 2025.

The Local Aging & Disability Action Planning (LADAP) Grant Program focuses on supporting communities and populations that have been historically under-resourced and under-served. That includes rural and frontier communities, Tribal communities, people with disabilities, people living with Alzheimer's disease and other dementias, LGBTQ+ persons, veterans, professional and family caregivers, populations of lower incomes, and communities of immigrant and/or refugee status.

Agency on Aging Area 4 (AAA4) is one of 33 agencies on aging in California designated by the State to develop, coordinate and fund programs designed to help older adults and people with disabilities maintain their health and independence. For more information, visit agencyonaging4.org ★

MARYSVILLE, CA (MPG) - Yuba Sutter Arts & Culture is pleased to announce that registration is now open for the Spring 2024 season of the Yuba Sutter Youth Choir. The new set of classes gets underway with rehearsals on Thursday, March 7. The theme for this session is the "Retro Groovy 70s."

The Yuba Sutter Youth Choir is one of Yuba Sutter Arts & Culture's Arts in Education programs. During COVID, the popular program had to be suspended. Classes will again be held at the Burrows Theater at 630 E St. in Marysville. Instruction is offered for students from 7-14 years of age. Weekly classes will be held on Thursdays starting on March 7th through May 23rd. A grand finale performance will be held on May 24th at 7 p.m. Prior choir experience is not required. Come learn from the best. The choir is open to

children 7-14 years of age. The rehearsal schedule for 7-9-year-olds is from 4-5 p.m. and for 10-14-year-olds from 5-6:30 p.m. Both sessions will be held on Thursdays beginning March 7th.

The cost for the spring session is \$20 per student which includes the students' music portfolio and a Youth Choir T-shirt. Full scholarships are available for qualifying students. The choir will learn songs from the 70s including "Rocket Man," "Honky Cat," and "Crocodile Rock" as part of an Elton John medley along with "Lean on Me," "Dancing Queen," and other great songs.

Once again, the Youth Choir will be directed by the incomparable Gay Galvin. Gay has been singing and playing piano since she was six years old. Trained in classical and jazz styles, she has worked in big bands, musicals, jazz trios, and various classical ensembles. She is an accomplished vocalist and

has taught choir at all age levels. Gay is a founder of the Yuba Sutter Big Band. Originally from Ohio, Gay has a master's degree in music. She teaches piano in her studio in Marysville. She plays most musical genres and has even played in rock bands. Gay also leads her own jazz trio.

"I'm so privileged to lead the Youth Choir again this year," said Gay. "And what better way to engage young singers than with the universally loved songs from the 70s," she added.

"We are pleased to be able to restart our Youth Choir program and especially now that we can continue to offer it to students at a significantly reduced rate thanks to additional grant funding we've received," said David Read, Yuba Sutter Arts & Culture executive director.

working as an engineer at the agency. The meetings will be at active work sites and agency facilities such as New Bullards Bar Dam and Reservoir to help students connect classroom learning with real-world jobs and projects.

“As someone who grew up in the Yuba-Sutter area, left to pursue engineering and came back to work as an engineer for Yuba Water, to see more opportunities for young people to explore engineering and to be able to give kids the exposure to this career field is just so exciting,” said Yuba Water Flood Risk Reduction Manager Sami Nall.

Update on partnership with the Center for Information Technology Research in the Interest of Society and new levee monitoring pilot

During Tuesday’s Yuba Water Agency meeting, agency staff also shared an update on plans to improve levee monitoring

throughout Yuba County in partnership with the Center for Information Technology Research in the Interest of Society and the Banatao Institute (CITRIS), part of the University of California.

“Today happens to be the anniversary of the 1986 levee break on the Yuba River that impacted thousands of people, homes and businesses in Linda and Olivehurst,” said Yuba Water Director of Water Resources and Flood Risk Reduction Ryan McNally. “I can’t think of a better way to leverage our partnership with CITRIS than to explore the best and latest technologies to further reduce the likelihood of an event of that magnitude from happening again.”

Yuba Water Agency will commit up to \$360,000 over two years for the project, which will deploy advanced sensing technologies at eight levee sites to investigate more efficient monitoring methods. The research’s goal is to enhance monitoring

capabilities and, in the long term, predict and manage the life expectancy of this critical infrastructure, further reducing the risk of catastrophic flooding in Yuba County.

Last year, Yuba Water, the city of Wheatland and the Center for Information Technology Research in the Interest of Society and the Banatao Institute signed a memorandum of understanding to outline plans for mutually beneficial research that will connect technological solutions to local and regional issues, build more resilient communities and protect Yuba County’s natural resources. Center for Information Technology Research in the Interest of Society and the Banatao Institute is a University of California research center focused on creating information technology solutions that generate societal and economic benefits for everyone. ★

Another Farm Show in the Books



The 2024 Colusa Farm Show, a playground for those in the agriculture industry, opened for its three-day run under clear skies on Tuesday, and wrapped up on Thursday after just one day of rain.

COLUSA, CA (MPG) - Another Colusa Farm Show is in the books after the 2024 exposition saw a mix of clear skies and rain.

Despite an atmospheric river blowing through Northern California just days before the Colusa Farm Show, the sun came out Feb. 6, as if on cue.

On the second day, it rained.

“It would not be a Colusa Farm Show without at least one day of rain,” said Casey Ryan, standards officer for the Colusa County Air Pollution Control District, at an informational booth hosted by the Agriculture Department.

Billed as the “granddaddy” of farm trade shows on the West Coast, the Colusa Farm Show brought the usual flood of visitors through the gates of the Colusa County Fairgrounds to learn about the latest in farm equipment and agriculture-related services.

“I could say I came to win a Yeti,” joked Jake Robinson, of Oroville. “But I actually came hoping to get a good deal on an orchard shredder.”

Robinson said he was greeted well at the Colusa Farm Show by manufacturers and retailers of all kinds of farm equipment but was most impressed with Orchard Machinery Corporation’s new E-limb-inator.

“And E does not stand for electric,” Robinson said, noting the unique design of a machine built to chew through large limbs and carries with it 140 gallons of diesel fuel,

15 gallons of diesel emissions fluid, and 160 gallons of hydraulic oil. “I just don’t think we are there yet with electric farm equipment. Maybe someday.”

The three-day run of the Colusa Farm Show provided one-stop shopping for all farm equipment and services.

Combines, tractors, shakers, scrapers, tillers, mowers, risers, along with farm and sport vehicles were just some of the equipment on display outdoors. Farm credit and banking services, nursery and seed suppliers, water, soil and conservation experts, insurance agencies, utility building manufacturers, and other service providers filled all four exhibit buildings.

While many people came to the show for specific services, quite a few came for the camaraderie of seeing old friends, neighbors, and others in the agriculture industry.

Many came for the handouts, fundraisers, and “Fair-Food,” such as popcorn and corndogs, which has become a staple at the Colusa Farm Show.

For a \$5 donation to Friends of the Colusa County Animal Shelter, Napa Auto Parts handed out 5-gallon buckets and hats.

It was the second year Napa has held the fundraiser for FOCCAS and it was going well just hours into the first day, said Napa Representative Pedro Palacios.

And because the Farm Show is about showcasing products, Palacios worked alongside Josh Mendoza, a representative for Milwaukee products, a company that, a century

ago, invented the “hole punch,” the predecessor of the modern-day drill, and became the first tool manufacturer to use modern lithium-ion technology.

“We started with our corded power tools, but we are now known for battery-power,” Mendoza said. “We actually hold the patent on lithium and batteries for power tools. We can get the same amount of power from 18 volts where most are going to 40 or 60, simply because we have been doing it for so long.”

The Farm Show was also an educational stomping ground for children and youth.

“We came to get more experience in agriculture,” said Cheyenne Smith, 16, a member of Lower Lake High School FFA, one of many schools that attended the show during its three-day run. “We’re seeing a lot of farm equipment for newer generations. It’s a community coming together with a lot of businesses, who are here to talk about what they are here for and what they do.”

Emily Allard, 16, also of Lower Lake FFA, said the Colusa Farm Show is a reflection on the endurance of the agriculture industry.

“We’ve seen a lot of future potential for agriculture and what future generations will have to face and learn about,” Allard said.

The Farm Show wrapped up Thursday, Feb. 8, again to clear skies.

Vendors, who came from as far away as Saskatchewan, Canada, said the show was once again a success and they would be looking forward to returning next year. ★



The Biggest Government in History

For those of you who are fans of big government, congratulations are in order. The United States of America has the largest government in the history of the world.

To give you an idea of just how big we have become, the federal government spent 6.13 trillion dollars in 2023. Putting that in perspective, it took since our nation's founding in 1776 to the year 1981 to hit a trillion dollar deficit. Now we spend and borrow way more than that every year. A mere 43 years later after hitting the one trillion mark, which is today by the way, we have 34 trillion in debt. And that's not the all of it. There is something called *unfunded liabilities* (debt that isn't quite due yet but will be) and that is so astronomically high no one really can put an accurate figure on it. Best guess is it's about 80 trillion.

The 6.13 trillion we doled out in 2023 is nominally larger (in actual total dollars) than the GDP of almost every nation on the planet. GDP means every dime, dollar and nickel spent in a year. The percentage of GDP that our government requires to take from its citizens to run it currently stands at 36%. In other words, all the bureaus, agencies and departments of the government devour that much of what the entire nation makes by selling whatever it is you all sell and service whatever it is you all service. Simply put, all the money changing hands between every one of us ends up leaking about a third of it into the government's hungry mouth.

Percentage wise, Vladimir Putin's vaulted Russia is tied with us. China is close at about 33%. But as I said, in nominal dollars, which is basically how many trillions are consumed, we are the largest.

Ukraine's government consumes a whopping 66% of its people's money. No wonder they're broke. But in actually dollars compared to us, is chicken feed.

An interesting side note: I normally wouldn't think of Iran as a well-run place, but its government comparatively is on a diet at 12% of GDP.

And what state in Uncle Sam's empire has the largest unfunded liabilities?

Look down at the ground if you live where I live, and I live in the Golden State of California.

So we have to ask, what do we get for all that debt?

Many would argue not nearly our money's worth while others would claim we get one hell of a deal. For that matter, why not give them more of what we make?

Uh, no, please don't.

How did we get in such a debt laden mess?

Like anyone else who gets stuffed to the gills in debt, we spend more than we make, that's how.

Governments who can *print* money can basically spend as much as they please. And most all governments can print their

own versions.

Here in the U.S., our lofty government conjures up U.S. dollars from the printing press, nicknamed the greenback.

Over in Switzerland they manufacture Swiss Francs and in Japan, the mighty Yen is the meal of the day.

And so on and so forth throughout the Earth-land.

And nary a restriction constrains any of them from doing so.

But it wasn't always so.

Decades ago, and through much of time, the currencies of the civilized world were backed by gold.

If you printed up a million dollars, you had to have a million dollars in gold. In that way, you avoided the *Mexican Peso* moment. That's my nickname for unbridled printing of colored paper with dead presidents on them, until you print so many of them, no one accepts them anymore.

There are more technical terms for it, the simplest one being inflation. But since many people know the word but really don't understand what inflation is besides rising prices, the words Mexican Peso seems to instantly educate people on what is so bad about inflation and printing up money.

As modern day governments go, they can't stop spending.

But that dang gold always seemed to get in the way.

And in man's creative imagination, the mother of invention spawned a novel but simplistic remedy to unbridling the purse strings: Say the hell with backing the money with gold.

It makes no sense anyway. At least to the spenders. And in one swift edict, followed by many swift edicts, one by one, the nations of the world said the heck with this gold thing.

Gold wasn't tossed out the window mind you, but the relationship between it and colored paper with dead presidents on them was eliminated.

And that is why the debt is so high all over the world.

Because we, they, us and them, can print as many dollars, Francs, Yen, Euros, Rupees and whatever else there is, simply because we want to.

MARYSVILLE, CA (MPG) - Pacific Gas and Electric Company (PG&E) will start work on Feb. 26 to improve the safety and reliability of the local natural gas distribution system in Marysville.

PG&E crews are installing all-new pipes, and in some cases upgrading gas meters.

The project is expected to continue until May, with crews working weekdays between 7 a.m. and 4:30 p.m. Crews will bore and trench to replace more than 3,800 feet of gas lines serving 56 business and residential customers.

Work will occur along Ninth Street

between F and G streets and between H and I streets; along H Street between Eighth and 10th streets; along I street between Eighth and Ninth streets; along J Street between Sixth and Eighth streets; and along Sixth Street between J and Olive streets.

During the work, streets are expected to remain open except for periods when work needs to occur in the center of the street. Traffic controls will be in effect when needed for safety.

Crews will work in phases to minimize impacts to parking spaces. PG&E has notified customers in the neighborhoods by automated phone calls and letters. ★





Navy SEALs Train with Beale Defenders During Exercise Dragon Trident

BEALE AIR FORCE BASE, CA (MPG) - Forty Airmen from the 9th Security Forces Squadron (SFS), 9th Medical Group (MDG) and 9th Operations Support Squadron (OSS) from Beale Air Force Base, California, teamed up with East Coast-based Naval Special Warfare Operators (SEALs) for joint Exercise Dragon Trident from Jan. 29 to Jan. 31. This three-day training exercise involved base defense operations, weapons training and re-capture operations.

The exercise kicked off with 9th SFS Airmen establishing air base ground defense with command and control, mobile security patrols and defensive fighting positions at the forward operating site (FOS). Beale's defenders were on guard with ultimate training munitions (UTM) to defend themselves from a series of unknown maneuvers from SEAL team operators infiltrating the FOS. Under the cover of darkness, the SEALs conducted a free-fall enabled nighttime raid supported by fixed wing and rotary wing assets.

"After getting set up, we knew an attack was coming, but we didn't know where it would come from," said U.S. Air Force Senior Airman Aaisha Banks, 9th Security Forces Squadron cyber security liaison. "This is new training for most of us, and it helps us prepare for real world encounters by showing where our deficiencies are and where we can improve."

Alongside the 9th SFS Airmen were the 9th OSS Airmen, including airfield management, air traffic control, radar airfield and weather systems, who assisted in drop zone setup and integrated with SFS for multi-capable Airman training.

On the second day of training, Beale Airmen went to the firing range to train on the M-249 light machine gun, M-240 machine gun, M-4 carbine and P320-M18 pistol. They also utilized the Common Remotely Operated Weapon Station (CROWS) system inside Mine Resistant Ambush Protected All-Terrain Vehicle (M-ATV) firing the .50 caliber machine gun and MK-19 grenade launcher. The SEALs

provided tips and techniques to enhance 9 SFS efficiency and lethality with various weapons systems.

"The most memorable experience was using the CROWS system in the M-ATV since it gives us a safe position to strike our targets," said Airman 1st Class Jaylin Charles, 9th SFS protection level 1 entry controller. "[The SEALs] also gave us great hands-on training on grip and stance for firing our handguns and rifles, as well as better squad tactics for machine gun firing."

The roles reversed on the third day of training as Beale Airmen executed re-capture operations alongside SEAL teammates. Using UTMs, the joint unit infiltrated the forward operating site, utilizing squad tactics to raid and secure the site. This exercise was beneficial for the Airmen and the SEALs, as it allowed them to see how the other side functions and how to operate as one cohesive unit.

"When we look at strategic competition

and future conflict, we need to establish the relationships in our joint community to ensure success on the battlefield," said Chief Master Sgt. Christopher Ricks, 9th SFS senior enlisted leader.

Training between Air Force security forces and Navy SEALs is not common, but a collaboration of senior leaders made it possible.

"In November of 2022, and I were classmates at the Joint Special Operations Forces Senior Enlisted Academy (JSOFSEA) and had numerous conversations about the importance of joint operations and bringing our units together to train," said Ricks.

Throughout 2023, the conversations turned into actions that brought this unique training opportunity to life. Within 14 months of the initial idea, Exercise Dragon Trident 1 kicked off.

"It's always easy to say 'no' but it takes a lot of effort to say 'yes' and follow through on your promises and put forward the effort

to make this type of training happen," said the SEAL senior enlisted leader. "We wanted a near-peer adversary to present a difficult target set for our final end of cycle training exercise before going downrange. The planning during the exercise was very in depth and detailed. Upon assessing the base defense that was established, it forced the assault team to change the game plan on the fly, presenting a whole different level of complexity, which provided outstanding training value."

After three adrenaline-filled training days, both sides wrapped it up with in-depth feedback, pointing out areas for improvement for everyone involved. Those improvements are hoped to be implemented in the near future, as the 9th SFS and SEALs are expecting this to be the first of many joint exercises. This new training environment sharpened both the 9th SFS and SEALs skills, keeping them primed and ready for real-world wartime operations. ★

Five Area Basketball Teams Eliminated from SJS Playoffs, Faith Christian's Girls Move On

YUBA/SUTTER REGION, CA (MPG) - The CIF Sac-Joaquin Section girls and boys basketball playoffs began on Tuesday, February 13 and the local region had six teams that made it into the postseason, this is how they fared.

The Faith Christian boys' basketball team lost their first-round matchup for the second consecutive season as they fell 62-55 to Vacaville Christian on Feb. 13.

The Lions lose their top-three scorers and six players to graduation this spring as head coach Rick Daugherty will attempt to make it into the SJS playoffs for a 13th year in his tenure at Faith Christian.

The Marysville boys' basketball team was beaten in a 63-53 loss to Escalon in the opening round of the playoffs on Feb. 13. The Indians trailed by 15 at the end of the first half and had a strong second half, but couldn't overcome the deficit as their season ended.

Marysville will lose three key players to graduation off of this season's roster that includes senior guard Bradford Pietz and forwards Anthony Walker and Josiah Arrington. The Indians have a ton of 2025 players that will return to the roster next season, including 2025 guard Dennis Syders and forward Elias Delozier.

This was Marysville's fifth consecutive season of a .500 winning percentage under head coach Stan Easter and ninth playoff appearance in his 11 years at the helm of the program.

After a 63-60 first-round victory over Casa Roble on Feb. 13, the Sutter Union boys' basketball season ended on Thursday, February 15 after they lost 83-50 to Natomas.

The Huskies started the game great in the first few minutes against Natomas as they came out with a high intensity and had the game tied at 10 early on. Natomas was able to build a lead and continuously make shots as nothing wanted to fall for Sutter.

The playoff victory against Casa Roble was the first for the Huskies basketball program since the 2016-17 season, but the first in the SJS since they transferred over last season.

Sutter head coach Nabeel Bhatti told the Dispatch that the six departing seniors (Naseem Bhatti, Jagger Beck, Gannon Deal, Jordan Lee, Daniel Ward and Diego Belmont) have been together the last six years and were a huge reason the Huskies had the most wins (19) in the program since the 2008-09 season.

The Sutter Lady Huskies basketball program had their season end on the road for the second consecutive year as they lost in the first round of the playoffs in a 77-39 defeat to Riverbank on Feb. 13.

Sutter junior forward Torrence Harter had a

quadruple-double in the game, which included 11 points, 10 rebounds, 10 steals and 12 blocks. Harter ended her junior season with leading the Pioneer Valley League in five categories (rebounds, free throws made, steals, blocks and double doubles), according to the latest statistics on MaxPreps as of Sunday, February 18.

The Lady Huskies returners along with Harter, include 2025 guards Sydney Meagher, Grace Ketterling, and the experience level that 2027 forwards Mia Bautista and Sissy Luttrell gained this season at the varsity level give Sutter an experienced roster next season.

The Marysville Lady Indians had their season shortened in the second round as they fell 40-39 to West Campus on Feb. 15. Marysville head coach Ike Prince told the Dispatch defensively, they played gritty tough "Marysville" basketball.

Prince added they missed a lot of shots in close proximity to the basket throughout the game and West Campus was able to make their shots count.

The Lady Indians' guards were given a lot of fouls throughout the night, but Prince expressed to the Dispatch he is proud of his team for accomplishing the first league title in program history in a long time and wants his returners to keep working.

Marysville loses a great group of senior players including senior forwards Krystal Briggs, Maya McNeal, Taliyah Edwards, Michelle Smith and guard Kaliyah Henry.

Prince has 2025 guard Demi Boykin and 2026 guard Abigail Pietz returning next year as the leaders of the team and aim to keep the continuous success of the program alive.

The only basketball team remaining in the local area in the postseason is the Faith Christian girls basketball team as they won their second-round playoff game over Vacaville Christian 76-26.

The Lady Lions were led by sophomore guard Lauren Harris as she scored 41 points, 12 rebounds and eight assists. It was Harris' fourth 40-point game of the season.

Faith Christian head coach Geoff Harris kept his team humbled as he told them the night prior at practice on Wednesday, February 14 that anyone can beat anybody. He used the example of how Liberty Ranch was upset in the first round of the CIF SJS D-IV bracket on February 13.
