ELK GROVE, CA (MPG) -With a ceremony on April 4, Cosumnes Fire Department opened its first new fire station in more than two decades in southern Elk Grove. Officials said the station would shorten response times in a fast-growing area of Elk Grove and support fire services in Galt. Located at 8350 Poppy Ridge Road, Fire Station 77 will serve an area with multiple housing developments, as well as a Cosumnes River College facility, Sky River

Casino and the potential Sacramento Zoo's future location.

The station will host a fire engine and an ambulance, as well as a grass rig to respond to grass fires. Three staff members will operate the engine and two will staff the ambulance.

Cosumnes Fire operates as part of Cosumnes Community Services District (CSD), providing

State Offers Campaign To Prevent Suicide

SACRAMENTO REGION (**MPG**) - Suicide was the second leading cause of death among youth ages 10 to 25 years in California between 2018 and 2022, with youth ages 10 to 18 experiencing a more than 20% increase in suicide rates from 2019 to 2020 according to the California Department of Public Health.

"Young Californians are facing a mental health crisis like never before," said California Department of Public Health Director and State Public Health Officer, Dr. Tomás J. Aragón. "While this crisis has been growing for years, the pandemic put a spotlight on the issue, especially those in marginalized and underserved communities. This ("Never a Bother") campaign directly addresses this crisis with education, tools and resources informed and co-created by diverse young people across the state."

Health stresses that suicide prevention can only be effective when everyone is part of the solution. That includes learning how to support yourself, a friend or a youth in your care before, during and after a crisis; telling a friend or youth in your care that they are never a bother; and encouraging them to reach out for help when needed. The California

The California Department of Public Health (CDPH) recently launched the "Never a Bother" campaign, a youth suicide-prevention public awareness and outreach campaign for youth, young adults, parents, caregivers and allies.

The campaign to address youth suicide incorporates input from more than 400 Californian youth, and 34 youth-serving community-based organizations and tribal entities with oversight by the state Department of Public Health's Office of Suicide Prevention.

California is investing \$4.7 billion so every California up to 25 years old has increased access to mental health and substance use supports. The Never a Bother youth suicide-prevention campaign is a major component of this investment in California's youth, according to the public health department.

While suicide is a risk within every population, according to the

Zoo Concepts Move From Planning to Council

ELK GROVE, CA (MPG) -The Elk Grove Planning Commission hosted a public hearing April 4 to consider recommending to the City Council Rezoning as an Amendment to the Bicycle, Pedestrian and Trails Master Plan, for construction of a new zoological park. It will contain facilities and activities on an approximately 103-acre site to be developed in four phases.

The project site is located at 8663, 8665 and 8675 Kammerer Road. The main facility would be on about 65 acres and designed to support an average annual attendance between 1.1 and 1.6 million visitors. The facility would be organized into four primary zones: Green Corridor (the main pathway), Africa, California and Australasia.

The initial plan presented to each of the commissioners in books of more than 900 pages designs the zoo projects to be consistent with the General Plan for

inclusion in the Capital Improvement Project. If approved by City Council, it will take about five years to build out.

The recommendation, which the Commission adopted, was that the City Council certify the Environmental Impact Report, make Findings of Fact and adopt a Statement of Overriding Considerations and Mitigation Monitoring; adopt the Zoological Park Special Planning Area and rezone the project site to the Zoological Park Special Planning Area. It also recommends amending the Bicycle, Pedestrian, and Trails Master Plan; and approving a Conditional Use Permit; Tentative Subdivision Map with Subdivision Design Review; District Development Plan and Level 1 Design Review; and the Art Plan.

Christopher Jordan, director of Strategic Planning & Innovation, and other designers and planners participated in the presentation, which included a graphics show of designs of the site space displaying the zoo design plan, restaurants, parking, drive lanes and accommodations to the neighborhood.

Emphasis was made that the circular roadway around the zoo would take visitors up in order to have an overview of certain spaces, including the African Savannah, from restaurants and cafes and a children's play area.

WEST SACRAMENTO, CA (MPG) - The Oakland Athletics have changed their dugout location and it's at 400 Ballpark Drive, West Sacramento.

Known as the A's, the Major League Baseball team will call Sutter Health Park home for the next three seasons in West Sacramento before moving into a new stadium on the Las Vegas Strip in 2028. The A's are moving, following failed negotiations with the City of Oakland about a new lease for the coliseum there.

"The A's look forward to making Sutter Health Park their home for the next three years through the move to Las Vegas," an Oakland Athletics spokesperson told the West Sacramento News Ledger on April 5.

The home of the West Sacramento River Cats will become the interim venue for the A's, beginning with the 2025 Major League Baseball season. Mayor and Chair of the Financing Authority Martha Guerrero shared her excitement over the partnership.

"We're delighted to welcome the Oakland A's and Major League Baseball to West Sacramento," said Mayor Guerrero. "This is a great honor, and we're looking forward to hosting visiting MLB teams and fans from throughout the region at our beautiful ballpark along the Sacramento River."

As a former affiliate of the A's, "there are many shared connections with the River Cats, its players and the wonderful fan base in West Sacramento," according to the Oakland Athletics spokesperson, who added, "The A's extend their appreciation to the Kings and the City of West Sacramento for hosting the A's."

West Sacramento City Manager Aaron Laurel said West Sacramento is ready for the professional baseball team, noting that Sutter Health Park's location offers stunning views of Tower Bridge and downtown Sacramento.

"As the City of West Sacramento prepares to welcome the A's, excitement is building among residents and businesses alike," Laurel said.

According to Laurel, the beer garden Drake's BARN and the French-inspired wine bar Franquette across the street from the stadium are two businesses that will benefit from the A's new location.

"There are also several other restaurants along West Sacramento's Third Street corridor within walking distance of the ballpark," Laurel said. "Together, with our neighbors across the river in Sacramento, there will be no shortage of amenities available to A's fans and those from visiting teams."

Yolo County Supervisor Oscar Villegas,

who governs the Sutter Health Park region and serves with Mayor Guerrero on the Financing Authority board, said he is proud to support the temporary relocation of "this fantastic franchise" to West Sacramento.

"Hosting the Athletics in Yolo County represents a significant opportunity for economic growth and community enrichment," Villegas said. "I am confident that this will foster a profound sense of community among our residents."

Residents now have two mascots to be proud of, with A's mascot, Stomper, joining Dinger and Sacramento River Cat's mascot. The A's have captured nine World Series titles, including four since moving to Oakland in 1968.

"We're prepared to accommodate the A's and the River Cats to ensure a seamless transition for both teams and their fans," Laurel said. ★

Continued from page 1 move because they want to feel safe, where someone will be at their front door within six minutes after pushing three digits on their phone."

Rodriguez also pointed to the strength of the collaboration between Community Services District, the cities of Elk Grove and Galt, and Sacramento County.

The fire chief noted that, while various stations have been upgraded or moved over the years, the most recent station to be added was Fire Station 76 on Sheldon Road in 2001. Station 77 is the first new station since Cosumnes Fire formed in 2006 from the merger of the Elk Grove and Galt fire departments. Rodriguez said the agency anticipates adding more stations as neighborhoods continue to fill in.

The ceremony included a "hose-uncoupling," the fire station equivalent of a ribbon-cutting. Rodriguez said uncoupling a firehose after a call is the first step in preparing it to return to service.

Wilton Rancheria officials performed a blessing of the fire station, whose service area includes the

said.

tribe's Sky River Casino.

"Our blessing songs are us asking our creator to come down here and bless this ground and bless these people and allow them to do the job that they have to do for our community," Rancheria Chair Jesus Tarango said.

Jim Luttrell, the Community Services District board president, said the fire station would "serve the emergency needs of the rapidly expanding part of our community.'

Luttrell noted that he lives just north of the station.

"The fire station with an engine and ambulance will greatly enhance the response times to our community and the communities near us," Luttrell

The station opening was the "big news" in Elk Grove that day, Elk Grove Mayor Bobbie Singh-Allen told attendees.

"As the proud mayor of Elk Grove, I'm so appreciative of the partnership that we have with the city, the CSD and our amazing fire department," Singh-Allen said. "Our firefighters, our police department, they are on the front lines, keeping Elk Grove safe, and that partnership has gotten stronger every year."

Singh-Allen cited Elk Grove's Measure E sales tax, which supports Community Services District operations.

"This is all about the public safety, the safety of our community and

our residents. Just look all around you outside. This city is growing, and this station will enhance the public safety of all of our residents. so today is a great day for the city of Elk Grove."

Galt Vice-Mayor Rich Lozano told the Citizen that Fire Station 77 would help relieve pressure in Galt when a call comes in when both of the city's local stations are handling other calls. He commended the station's "state-of-theart" features.

Paul Mewton, who will soon retire as Cosumnes Community Services District's chief of planning, design and construction, said the station has "the latest in fire station design," including a separated area for cleaning firefighting gear to keep hazardous chemicals out of the station's residential space.

After the ceremony, Rodriguez commented on overseeing the department's opening of the first new fire station in 23 years.

"This is really exciting as the fire chief here to have this accomplishment from our own personnel being able to do this together with our district personnel and our

California Spends More on Schools with The Neediest Kids *Here's How It's Succeeded and Failed*

A decade after California revolutionized the way it funds schools, nearly everyone agrees the initiative has done what it was meant to do: improved math and reading scores and brought more resources to students who struggle the most.

And nearly everyone also agrees that the Local Control Funding Formula, as it's known, could use a tune-up. Black and Latino students' test scores have improved but still lag behind their white and Asian peers, and schools in affluent areas still spend far more per student than schools in poorer neighborhoods.

But overall, researchers and superintendents say, the system introduced under Gov. Jerry Brown has remade California's schools for the better.

"Gov. Brown had a good idea," said Adam Clark, superintendent of Mt. Diablo Unified in Concord. "(The funding formula) has given school districts the tools and resources to really address the needs of students. And it gives parents and the community a voice."

Jaime Green, superintendent of Trinity Alps Unified in Trinity County, put it more succinctly: "Without LCFF, our district would not be open."

Under the Local Control Funding Formula, the state gives school districts a base amount of money calculated by attendance, but funnels extra funds for low-income students, English learners and foster youth. Districts have freedom to spend the money on whatever programs they think will help their students, with guidance and accountability through a public local planning process.

Prior to the funding formula, California schools were financed through local property taxes, a system that had been in place for 40 years. Districts with lower tax revenues got extra money from the state, up to a certain limit, and the state doled out dozens of grants for specific programs.

Districts like Trinity Unified, located in California's poorest

big changes in California education: passage of Proposition 30, a sales tax which raised about \$6 billion annually for schools; introduction of the Common Core reading and math curriculum; and the Smarter Balanced standardized testing system.

Within a few years, the improvements were obvious in California classrooms. By 2019, before the pandemic, reading and math scores in all grades had improved, graduation rates rose, suspensions and expulsions fell, and more students met college admission requirements for the state's public universities. A report by the Learning Policy

Overall School Spending is Still Unequal

Another problem is the overall amount of school spending generally, some said. Even though low-income schools now have much more money than they did a decade ago, it's not enough to address the needs of students facing complex challenges. And schools in affluent areas still spend far more per student, thanks to parent donations and local bonds and taxes.

Jack O'Connell, who was State Superintendent of Public Instruction prior to the Local Control Funding Formula, agreed. While he considers the who meet more than one of the formula categories should be counted twice, not once. Schools should receive extra money for English learners who are also low-income, for example.

Basing School Funding on Enrollment, Not Attendance

In Trinity Alps Unified, in the mountains of Trinity County in Northern California, the funding formula has made a world of difference — not just for students but for the entire community, said superintendent Green. Prior to the funding formula, the district received less than \$12,000 per student from all sources; now it's closer to \$20,000.



violate Proposition 209, the affirmative action ban that prevents the state from linking money to students' race or ethnicity.

Gov. Gavin Newsom last year introduced a tweak to the funding formula that directs extra funding to specific schools based on high rates of student turnover, low-income students or students whose parents didn't graduate from high school. The equity multiplier, as it's known, is intended to reach students who have the highest needs.

'Deep inequities' in California

But that's not enough, said Natalie Wheatfall-Lum, director of TK-12 education policy at Ed Trust-West, an education research and advocacy organization. California should repeal or scale back Proposition 209.

"We still have deep inequities across the board," Wheatfall-Lum said. "But by fixing LCFF we have a huge opportunity to support racial equity. ... The stakes are very high. How we fund schools is the foundation of our education system." Ed Trust-West also recommends that the state hold districts accountable for the academic performance of specific student groups, such as Black and Latino students, and pay more attention to the progress of English learners, whose test scores have barely budged since the finding formula was introduced. But money isn't always the answer, Brown noted at a conference in December. Bumps in school funding, while helpful, can't be expected to solve problems as deeply embedded as poverty, racism and inequality, he said. Factors beyond school play a huge role in students' outcomes.

county, barely stayed afloat under that system because the extra money was not enough to cover expenses, especially considering the large number of students living in poverty.

The overall amount of spending was low due in part to Proposition 13, the 1978 ballot initiative that capped property taxes and resulted in deep cuts to state spending. By the mid-2000s, California was near the bottom of states nationally in school spending, student test scores and nearly every other educational measurement. Linda Darling Hammond, president of the State Board of Education, described it as "a broken system."

Simplifying and Decentralizing School Funding

Brown, who was elected to his second stint as governor in 2010, said he got the inspiration to overhaul school funding from Mike Kirst, who served as president of the State Board of Education during both of Brown's stints as governor. Kirst and his colleagues had proposed the idea of a weighted formula a few years earlier, but it was shelved when the economy crashed in 2008.

Gathering support from legislators, teachers unions, parent groups and school boards, Brown, Kirst and their allies helped get the funding formula enacted in 2013.

The simplicity, along with shifting power away from the state, appealed to Brown.

"I liked the idea of reducing complexity, of giving money where it was most needed," Brown said in December at a conference on the impact of the funding formula. "You need goals, you need standards, but you have to let local people do their thing."

It coincided with a trio of other

Institute found that an increase of \$1,000 in per-pupil spending over three consecutive years resulted in a full grade level improvement in math and reading.

California now ranks near the national average in school spending, as well as in math and reading scores. Although scores fell in the wake of the pandemic, they didn't fall as far as they did in other states and are slowly beginning to creep upward.

But challenges persist. One common gripe among superintendents is the annual plan required to chart goals and priorities. The Local Control Accountability Plan is a key part of the funding formula's accountability and parent involvement components, but it can be a headache, superintendents said. It entails community meetings, surveys, data analysis and detailed explanations of spending for the public, county and state to review.

The plans are often so dense with jargon that even though they're posted online, reviewed at school board meetings and shared with parents, few people wade through them — thereby not providing the accountability they're intended to. funding formula a landmark in California education, he thinks the state needs to increase the base amount of money it gives schools. Currently, that amount ranges from \$11,000 to \$12,300 per student, which poses a challenge for middle-class districts without large numbers of low-income students or wealthy parents willing to donate thousands.

"There's no question things are better off now," O'Connell said. "But increasing the base grant might be the best way to help all students."

Kirst said he was confident the funding formula would work, but he's surprised at its political staying power and how entrenched it's become in the education landscape.

He'd like to see the formula adjusted to take into account regional costs of living, so districts in expensive areas get more money. And he'd like to see the poverty measurement change. Currently it's based on how many students meet the federal standards for a free or reduced price meals. But with so many districts now offering free lunch to all students, he said, the state should consider using other criteria.

He also thinks that students

That money goes a long way in Trinity County, funding everything from art classes to after-school programs to special education.

"We feel very blessed to have this formula," Green said. "LCFF allows us to stay open and serve our children at a high level."

An improvement Green and other superintendents would like to see is funding based on enrollment, not attendance. Currently, the state disperses money to districts based on average daily attendance. But chronic absenteeism soared during the pandemic, resulting in lower revenues. While enrollment is also declining in many areas, absenteeism is the bigger challenge, Green said.

Going forward, some advocates are calling on the state to tie extra funding directly to students' race. The impact of systemic racism, they say, is too profound to ignore. They argue that Black and Latino students often fall through the cracks, especially if they attend affluent schools, or if they attend low-income schools in affluent districts. The state has shied away from such a policy for fear it would

'More Than Money' to Help High-Needs Students

At College Park High in Pleasant Hill, the district used funding formula money to open a wellness center two years ago. Furnished with couches, comfy chairs, student-created artwork and private enclaves for one-onone meetings with counselors, the wellness center is a popular place for students to relax and socialize. In addition to mental health services like peer counseling and therapy dogs, the center offers yoga, meditation, games and a quiet place to do homework. A social worker is always present.

Stephanie Perez, a senior at College Park, said the wellness center has been a lifesaver — literally. It's given her a reason to stay in school and motivation to stay healthy.

"If this place wasn't here, I'd be out drinking, smoking, ditching school, getting bad habits," Perez said. "They really care about you, listen to you, give you a shoulder to cry on. I come here to ease my mind."



I know the odds are terribly impossible, but maybe Chaplain Norris' winning numbers can help you win that jackpot.

That's right. Today I will reveal my divinely inspired numbers.

Well, the "divine" claim is probably an overreach, but I do know that if you pick numbers above 31, you're likely to be the sole winner. That's because most people choose their birth dates.

So with that in mind, can I get a drum roll?

Chaplain Norris's winning numbers are 35-40-45-50-55-60. Bonus number 65.

Yup, I know choosing numbers in multiples of five may seem whacky, but statistics suggest that the odds never change no matter how many times you play or what numbers you choose. Your

winning odds are similar to getting struck by lightning on your birthday two years in a row.

Truthfully, you really shouldn't take gambling advice from a chaplain. Unless it's "Don't gamble!"

But the whole lotto game provides some analogy for the way folks choose the right kind of faith.

Why is it that we sometimes think faith is all about luck?

We seek out the nearest weeping statue and drive hundreds of miles to light a candle. We say a prayer and hope a god in a good mood hears it.

Sometimes we search for faith like we are playing scratch cards. We scratch at the deep questions of faith, hoping to come up with a win.

Still others rely on some lucky combination that their grandfather passed along to them. "My granddaddy prayed for my grandmother inside that church, and she was healed, so I guess it's a winner."

Yet, still others rely on the big-spin approach and take the one they land on. Others see faith like picking the right card out of a newly shuffled deck.

And some play faith the way they play a bluffing poker hand, refusing to let anyone see the cards of doubt they hold. The problem with these approaches is they produce a routine of losing, much like those who return each night to the same casino only to lose again.

The faith choice made with these methods usually ends up discarded, much like a Lotto ticket on a gas-station driveway.

Faith has little to do with winning or losing. Faith is too important to treat with the same glibness we use to choose our winning numbers. Perhaps it's more about investing in who we are, not about gambling on what we never had.

Maybe faith comes about when we invest in the search. We find it inspired by the conversations, the discussions, the questions, and the

debates that we have with others. In fact, I believe God prefers honest "searchers" or "questioners," even when they challenge him directly, even when they are unflattering.

Jesus suggested faith might well be something compared to a mustard seed. A mustard seed is the tiniest of seeds, yet in ratio, it grows into one of the biggest plants. Faith starts from the smallest beginnings in the hearts of people and produces not a personal profit, but a powerful and personal transformation.

Well, all this talk about winning the lottery made me wonder what might hap-

pen if I actually bought a ticket. I mean, if I ever bought just one, what might happen?

I may never know.

But if you do happen to win with my divine numbers, please remember my favorite charity – Chispa Project. I think it's fair to say that any gift can be an investment in faith.



Homeless Outreach and Safe Stay Report 2023

Sacramento County **News Release**

SACRAMENTO COUNTY, CA (MPG) - The Board of Supervisors, at its March 26 meeting, received a report on outreach and engagement efforts to address homelessness in the unincorporated County and Regional Parkway System. In its March 12 meeting, the Board received an update about the Homeless Services Partnership Agreement between the County and the City of Sacramento.

The County оf Sacramento (County) is the primary entity responsible for providing homeless outreach services to unincorporated areas and the Parkway System. The County's approach to outreach services is multifaceted with teams dedicated to:

• Proactive outreach to County-identified priority encampments

• Response driven needs from Sheriff, Rangers, and other County partners

• Maintaining consistent outreach 'office hours' distributed throughout suburban areas and the Parkway system

County funded outreach teams employ a 'case carrying' approach in which they provide on-going engagement focused on resolving a person's experience of unsheltered homelessness. The case carrying approach may result in dozens of interactions with one person over the course of several months to ensure they are receiving the services they need. Services outreach teams' offerings include (not limited to):

• Shelter and Permanent Supportive Housing through Coordinated Access System (CAS)

• Referrals and linkages to community resources

• Securing vital documents

• Transportation support • Access to basic needs supplies

The case-carrying method may result in less people served over the course of the year, but with a higher rate of positive outcomes. With the goal of ending homelessness for each person served, this method has proven to be more effective than volume alone.

The outreach team also created "Drop-In hours" that are held at the same location, on the same day and time in each geographic region to ensure that individuals can access services when they're ready. Community Health Workers hold these 2-hour sessions in easily accessible community locations to let any community refer someone so that individuals in crisis have consistent access to navigation services.

• 16 consistent drop-in locations

• 1,284 unduplicated individuals enrolled into County programs

Those factors include vouth who are American Indian/Alaskan Native, Hispanic/Latinx and African-American/Black; live in rural communities: experience mental health

challenges; and/or are impacted by the foster care system.

The "Never a Bother" campaign resonates with youth, according to the Department of Public Health, as it validates their feelings of not wanting to be a burden to others. It speaks to their need to know that they are never a bother, that no problem is too small and that it is important to check in with one another before, during and after a crisis.

According to the "Never a Bother" campaign: "If you are experiencing thoughts of suicide, you are not alone. Call or text 988 to reach the Suicide & Crisis Lifeline. Trained professionals can reconnect you with your reasons to keep going and show you ways to cope with difficult days."

Support resources are at NeveraBother.org.





MELLO-ROOS TAX REDUCTION NOTICE

SENIOR CITIZENS / DISABLED PERSONS LIVING IN THE ELK GROVE UNIFIED SCHOOL DISTRICT

In 1987 and 1998, voters in Flk Grove Unified School District approved bond measures to help finance school facilities. By approving these measures, the voters authorized District administrators to sell bonds and agreed to a Mello-Roos special property tax assessment for repayment of the bond debt. Residents who are at least 65 years old or fully disabled may receive a 70% reduction to the Mello-Roos tax on their residence.

TO QUALIFY FOR THE REDUCTION

Eligible persons may apply for a Senior Citizen/Disabled Person Tax Reduction, which would reduce the Mello-Roos school tax by 70% if:

- The applicant provides evidence that he/she is at least 65 years of age (by June 30th) or fully disabled as defined by the State Controller's Office.
- · No school-age children lived in the residence during the previous 24 months.

The reduction is allowed only for the applicant's residence; all other properties are subject to the full tax.

If the applicant rents his or her home or resides in a mobile home park, the landlord/owner must certify that the amount of the tax reduction will be passed along to the applicant.

Galt Vice-Mayor Lozano to Run for CSD Seat

GALT. CA (MPG) - Galt Vice-Mayor Rich Lozano announced on April 6 that he is running for the Division 1 seat on the Cosumnes Community Services District (CSD) board of directors. Lozano said he wants to provide a voice representing Galt on the board.

Cosumnes Community Services District's Division 1 seat, which includes Galt and eastern Elk Grove, is up for election this year. Lozano said Director Gil Albiani, the current District 1 representative, plans to retire after 20 years on the board.

If Lozano is elected, he would be returning to the Cosumnes Community Services District. He served for eight years before winning a Galt City Council seat in 2018.

Since his departure, Lozano said, no directors have been Galt residents. With the introduction of by-division elections in 2022, in which only residents of a given division vote for that division's representative, the Division 1 election is the only one in which Galt residents have a say at the ballot box.

"I really think it's important that that board

have representation from the Galt community and I've always believed that," Lozano said in an April 8 interview.

Lozano pointed to a broad range of support, including endorsements from Albiani, Cosumnes Community Services District Director Angela Spease and CSD Board President Jim Luttrell, as well as from Galt City Councilmember Kevin Papineau, Sacramento County Supervisor Pat Hume, the three most

recently retired Cosumnes fire chiefs and Sacramento Area Firefighters Local 522.

Choosing to run for the Cosumnes Community Services District board "wasn't an easy decision for me because I absolutely love being on the council," Lozano told the Citizen. "I love the city and doing what I can for city services for residents here."

The vice-mayor listed public-safety measures among his accomplishments on City Council, particularly body-worn cameras, a new drone program and license plate readers for Galt Police Department. He also cited transparency improvements in the city's finances.

Lozano said he conditioned his candidacy on the support of his wife and children and on Albiani's blessing.

"He has fully endorsed my campaign," Lozano said of Albiani. Through the Cosumnes

couple things? Maybe." Fire Department, Cosumnes Community ume is "at a good level" at Galt's fire stations and that he wants to maintain that level as residential areas in the city build out.

Additionally, Lozano said he wanted to look at options for addressing concerns about service west of the Union Pacific railroad tracks in Galt. Some residents have voiced worries that passing trains might delay emergency responses.

Lozano said he would bring knowledge he gained in his time on City Council, especially an understanding of police department operations and of the funding options available for cities, to Cosumnes Community Services District. He also highlighted the importance of gathering constituent feedback.

Lozano spoke about the responses he has received in the days after his announcement.

"The amount of support that I've received in terms of people willing to get behind my campaign has been tremendous," Lozano said.

The formal candidate filing period for the November General Election opens July 15. Prospective candidates will have until Aug. 9 to file with Sacramento County.


for 10 innings," Cherry said.

Hoffstot thanked many

As a native of the Washington D.C. area, Hoffstot said that he thought his local league was special until he moved to Elk Grove and realized "baseball is life" here. Many players started in baseball through Elk Grove Youth Baseball.
