## City Explains 1% Tax Proposal

**YUBA CITY, CA (MPG)** - A one-cent tax could generate 17.5 million dollars if passed in November.

Yuba City City Manager Diana Langley presented Mayor Shon Harris and the Yuba City Council with a detailed explanation of the proposal on May 7, beginning with the website dedicated to the tax.

"Our website is a wealth of information and I don't think people are very familiar with it," Langley said, adding the link information is at [www.yubacity.net/city\\_hall/2024\\_revenue\\_measure](http://www.yubacity.net/city_hall/2024_revenue_measure).

The website page, Langley said, "immediately goes into some basics about the potential revenue measure of 1% that would allow local control over local funds."

"I think what has been most interesting as we have gone out and done two presentations so far is that people are shocked by the 7.25% sales tax rate in Yuba City; the city only receives 1%," Langley said. "A lot of people think that the entire 7.25% comes back to the city."

The remainder "largely goes to the state and then a portion to the county," according to Langley.

The city manager pointed out the basic facts on the website, including the \$17.5 million it could yield annually. Part of the tax would be paid by non-resident shoppers. No funds can be taken by the state and must stay for local services and programs. Additionally, essential purchases such as groceries and prescriptions are exempt from the proposed revenue.

Langley pointed out the website's six subsections for roads, fire, homelessness, budget, Walton/Happy Park and FAQ (frequently asked questions).

"There are presentations related to it," Langley said, adding roads, for instance, have both a grand jury report and a budget presentation. "It talks about the pavement condition index and there are maps. That is just the road piece."

The joint City Council-Board of Supervisor meeting from last December is available on the website. If you click on community feedback, "this is where you can submit information for us to contact you and provide you feedback," Langley said.

The website also provides a media link for the public to read about or listen to in local newspapers and on the radio.

## Calling All Volunteer Police

**YUBA CITY, CA (MPG)** - If you ever wanted to be a police officer, now is the time.

Yuba City's Volunteer in Policing Program (VIP) wants you to become one of their own. The Volunteer Policing Program (VIP) began in 1997 with 14 members to attract citizens into the organization through increased service.

"When beginning our VIP Program, our agency utilized the volunteer hours from the program to provide relief to various members of our agency and allow work to be completed more efficiently, timely

and consistently," Police Chief Brian Baker said.

Throughout the years, the Yuba City Police Department recognized a need for additional police-related services that would benefit the vulnerable members of the community, thus creating two programs: At-Risk Citizen (ARC) and Volunteer Outreach for Independent Citizens and Elderly (VOICE).

"ARC is designed for families who have a family member, of any age, who suffers from a disability or illness that would make them considered 'at-risk' if they were to go missing," Baker said. "VOICE is designed for adults with disabilities

or those who are elderly and live alone with no regular contact with family or friends."

According to the chief, members regularly contact At-Risk Citizen and Volunteer Outreach for Independent Citizens and Elderly individuals up to three times a week.

"It allows citizens to feel confident in our police department staff and become more educated in policing," Baker said. "By having volunteers engage as an integral part of our organization, we can increase our level of service by reducing the workload of many department divisions and provide our community with additional

**MARYSVILLE, CA (MPG)** - What are some of your favorite songs about famous historic events in U.S. History? A childhood favorite was the "Battle of New Orleans" written by Jimmy Driftwood and made popular by Johnny Horton. There's "Which Side Are You On?" written in 1931 by union activist Florence Reece. "The Night They Drove Old Dixie Down" is a song written by Robbie Robertson about a poor white Southerner during the last year of the American Civil

War. Maybe the best known of all is the "Star-Spangled Banner" by Francis Scott Key. Now the public is invited to attend a free concert about local history unique to Yuba-Sutter and the surrounding region. Tom Galvin, a Yuba County-based singer songwriter and his band will perform a show titled "Heroes & Victims" on Saturday, June 15, 2 p.m., in the main gallery at the Sutter County History Museum, 1333 Butte House Road in Yuba City. The album and performance are made possible thanks to a generous grant from the Upstate CA

Creative Corps, a part of the CA Arts Council. The program was designed to serve vulnerable communities and those identified by the CA Healthy Places Index. It was designed to increase ways in which artists are engaged with public work through various art forms to create awareness about subjects including water and energy conservation, social justice, and public health. This is the concert premier of Tom's remarkable new song cycle about the colorful history of Yuba-Sutter and environs. As a transplant from the Midwest, Tom has been

fascinated to learn about all that has occurred in the area from the frontier and early gold rush days to modern day including disputes over water rights and the mistreatment of indigenous people and Japanese Americans during WWII. Specific songs cover topics including the Yuba Water Accord, explorer James Beckwourth, the Arboga Assembly Center, and the Japanese American WWII experience, the native American Ishi, the Sutter Buttes, the perils the Mormon's experienced on their journey west, and other relevant themes. In other words, be prepared to get the whole story about the good, the bad and the ugly about our local history.

Singer/songwriter, Tom Galvin, is a lifelong musician who "troubadoured" around the country for many years while also training to become a psychotherapist. He has written songs for touring bands from the American Midwest to the American far west. Tom and his musician wife, Gay, have both appeared in numerous concerts at the Burrows Theater and the Sutter Theater Center for the Arts and other local venues with various ensembles playing a variety of styles and genres of music.

In addition to Tom on guitar and vocals, the *Heroes & Victims* band includes Rich Celio on drums, Dylan McConnell on bass, Rick Kirkpatrick on lead guitar and Gay Galvin on keyboard and vocals. police-related services that would otherwise not be feasible.”

Since its founding, membership has nearly doubled in the program, which has various duties ranging from patrol duties to department mail and court runs. When not on traffic control or handing out parking and handicapped tickets, Volunteer in Policing Program members assist in the property evidence room or conduct business or residential security checks.

Carol Boyer has been a Volunteer in Policing Program member for more than two decades and has 6743.5 hours of experience.

“There is no end to learning, teaching and working with so many people in various duties and jobs,” Boyer said. “I have been fortunate to have worked within the department offices, outside events, other agencies, businesses and personnel throughout the city and county.”

Boyer is the best example, according to Baker, who said she and other Volunteer in Policing Program members are “important for our agency because it allows for additional relationships to be made within our community, allows us to continue our transparency and provide an upstanding level of service to Yuba City.”

Volunteer in Policing Program members must be at least 21 years old, pass a background check, attend a 12-week Citizen Police Academy and commit to a minimum of 16 hours of service per month. According to Boyer, it is all worth it.

“It makes me more aware of many things, such as the history of our city and surrounding communities, the diversity of nationalities, faiths, languages, traditions and how it can all work together if we help it,” Boyer said. “Knowledge is never-ending and I want to be a part of it every day.”

Boyer said all Volunteer in Policing Program members “can grow at their own pace while working with good people.”

That is precisely the point, according to Baker, who said the program is open to members of all ages since many have different physical abilities, life experiences, training or passions that interest them.

“With this in mind, we allow our volunteers to serve in many ways and can accommodate most individuals with a duty they feel passionate about,” Baker said. “Our volunteers can assist with our Records Unit, patrol officers, Traffic Unit, Community Outreach and more.”

Baker said his department greatly values the Volunteer in Policing Program.

“Every year, our volunteers dedicate thousands of hours keeping our department efficient and providing Yuba City with excellent service,” Baker said. “We appreciate every single one of them and cannot thank them enough.”

“Find a few hours a month to help and you will be rewarded many times over,” Boyer said. ★

“This area will build over time as we put more articles out and radio interviews and PSAs (public service announcements),” Langley said.

The website also notes upcoming informational meetings over the summer, with the June schedule including one on the 4th at the Soroptimist International of Sutter-Yuba and the 11th at Early Risers Kiwanis.

“We are happy to do more; if you would like to have a neighborhood meeting and have us come out, we will meet with a small group or a large group,” Langley said, adding that it is only informational. “We are not here to advocate or convince.”

A flier that breaks down the current sales tax complements the website and is available at Yuba City Hall, 1201 Civic Center Blvd., Yuba City.

Vice-Mayor Dave Shaw said he has “had the privilege of being at both of the first two presentations.”

“It has been very clear and well received,” Shaw

said. “Thank you for a clear, concise message because that is the way we have to be with the public.”

Councilmember Marc Boomgaarden brought the citizen oversight committee to the public’s attention, saying it would not be a group of “all those in favor” but rather an unbiased group.

“I encourage anyone out there: we are taking signups as it stands right now,” Boomgaarden said.

Langley said the committee will review any proposed expenditures.

“They would also look back to see how the funds were actually spent and if that aligns with the intent of how the funds were supposed to be spent,” Langley said.

Along with the website, the city is advertising the 1% revenue tax proposal with a QR code that leads to information on the ballot measure. ★

When an inspection shows that mosquitoes are breeding in a pool, treatment is simple, quick and free. Application of a thin film of a coconut based oil quickly kills the immature mosquitoes living in the water. For a long term solution, mosquitofish are introduced. No unrelated data is collected or shared regarding any property. There is no charge, penalty or fee for an inspection or treatment to a pool. You can still get your pool ready for swimming later.



### Are You Growing Mosquitoes?

It only takes a tiny amount of water that sits for just a few days to breed hundreds or thousands of new mosquitoes. It’s an excellent idea to check through your yard regularly through the season for standing water. Places that hold rainwater or catch irrigation water make perfect breeding sites. Regularly dump and drain plant pottery and saucers, birdbaths, wheelbarrows, tarps, uncovered boats, lawn sculptures/ornaments, tires and other miscellaneous containers.



Can’t maintain your pool this year? You can self report your green pool or anonymously report a neighbor’s. An easy inspection and treatment, at no cost provides season long mosquito control.

# Extravagant Spending Undermines Character

may have reached the point of no return.

However, it wasn't always this way.

President Calvin Coolidge in his inaugural address March 4, 1925, said, "I favor the policy of economy, not because I wish to save money, but because I wish to save people. The men and women of this country who toil are the ones who bear the cost of Government. Every dollar that we carelessly waste means that their life will be so much more meager. Every dollar that we prudently save means that their life will be so much the more abundant. Economy is idealism in its most practical form."

Coolidge assumed the presidency upon the death of President Warren Harding. Coolidge delivered upon his idea of fiscal responsibility. Federal expenditures in 1920 when Harding-Coolidge won the election were \$6.4 billion. Upon Harding's death in 1923 spending was cut in half, at \$3.2 billion. Then, after more than 5 years of the Coolidge presidency the outgo was just under \$3 billion.

Tax rates in the 1920s were decreased dramatically while federal revenues rose. Nearly half of the national debt was erased. The budget had a surplus every year.

Sadly, nothing approaching this fiscal record has been witnessed since. Now both parties practice massive deficit spending, financially burying future generations long after the miscreants have enriched themselves and died.

Coolidge was a Republican, but Republicans today are but trash-talkers that vote bigger government and debt-ceiling increases. But what about Democrats and fiscal responsibility?

The last Democratic president of the 19th century, Grover Cleveland, vetoed more bills than all of the previous presidents combined. Cleveland, an advocate of fiscal responsibility, was elected in 1884 on a platform of restraining both federal spending and corruption.

Seeking a second term,

Cleveland won the popular vote in 1888 but lost to Republican Benjamin Harrison in the Electoral College. Cleveland then came out of retirement in 1892 to run against the reckless spending of the Harrison administration. He defeated Harrison thereby being the only President to serve two nonconsecutive terms (1885-1889 and 1893-1897.)

In 1901, the federal government spent in today's dollars about \$12 billion. Today, Washington spends that in less than half a day. However, a retired Cleveland was harsh toward 1901 spending extravagance in his Saturday Evening Post article that year:

"Probably no one will have the hardihood to deny that the cost of our Government is excessive and wasteful, and that for this condition, the heedless neglect and indifference of our people are in some degree responsible....If the aggregate mass of our people are at all blame-worthy on account of the present advanced stage of public prodigality, it is largely because they overlooked and tolerated its small beginnings, when at all times they should have been vigilant and uncompromising. A self-ruling people...should constantly remember that nothing multiplies itself more abundantly than national extravagance, and that neither an individual nor a popular government can easily correct or check habits of waste."

Cleveland scolded not only politicians but noted that many Americans welcomed reckless spending. They were bought and paid for, being guilty of "accepting the bribes of selfish and personal advantage, which public waste and extravagance offer."

Cleveland was adamant that no society that allowed itself to be bribed by its politicians ever survived such legal larceny.

# California's Lagging Economy Hinders Efforts to Close State Budget Deficit

As Gov. Gavin Newsom and state legislators spend the next few weeks fashioning a state budget that's plagued by a multibillion-dollar deficit, they can't count on a booming economy to make their task easier.

California's recovery from the devastating economic impacts of the COVID-19 pandemic has been sluggish at best, trailing what's happening in the nation as a whole and in the state's archrivals, such as Texas and Florida.

According to Employment Development Department data, there are 200,000 fewer Californians in the labor force — those employed or seeking employment — than there were in February 2020, just before the pandemic exploded. There are 500,000 fewer employed, and 200,000 more unemployed.

While California's unemployment rate of 5.3% in March was just a third of what it was at the height of the pandemic-induced recession, it was still the highest of any state, markedly higher than the national rate of 3.9% and nearly two percentage points higher than it was before the pandemic.

By the federal government's more nuanced measure of employment called U-6, which counts not only the unemployed, but workers who are "marginally attached" to

the labor force and those who are involuntarily working part time, the state's 9.5% rate of underemployment is also the nation's highest.

Those numbers imply an economy that's not even operating at cruising speed, much less accelerating. Even the state's technology sector, centered in the San Francisco Bay Area, has cooled off as its once high-flying corporations announce layoffs virtually every day.

"California's civilian employment growth has been essentially flat since the second half of 2022 while the U.S. has remained relatively healthy, resulting in the state's unemployment rate rising faster than the nation," the revised budget Newsom unveiled last week acknowledges.

The pandemic erased about 3 million jobs in California as Newsom shut down large segments of the state's economy. Countless employers, particularly small businesses, never reopened after the health crisis eased and those that did survive have had to contend with inflationary costs, tighter loan conditions and changed consumer habits.

The budget blames stubborn inflation and the high interest rates imposed by the Federal Reserve System to tame inflation for California's slowdown, but economies of other states have experienced the same factors and prospered despite them.

However, they don't contend with factors unique to California, such as extremely high costs for housing, utilities and labor that make job creation more difficult here. Until recently, California has been losing population, thanks to outward migration to other states. The state has

also seen employment shifts, particularly in technology.

Those conditions underscore the sluggish recovery that sets California apart from other states. For instance, Texas' unemployment rate, 3.9%, is identical to the national rate while Florida's 3.2% is even lower.

So, one might ask, where is California's once-booming economy headed?

Newsom's Department of Finance says it "has not modeled a recession scenario. However, if inflation takes longer to cool and interest rates remain high for longer than projected in the May Revision baseline forecast, continued tight credit conditions could further discourage economic activity."

A few days before he released his revised budget, Newsom stood at the top of a Golden Gate Bridge tower to record a video celebrating the tourism industry's recovery.

Visitors to California spent \$150.4 billion last year, he said, surpassing the previous record of \$144.9 billion in 2019.

That's good news, even though an adjustment for inflation would probably reduce the recovery's relative impact. But while it's a high-profile economic sector, tourism is scarcely 3% of the state's overall economy. It's the other 97% we should be nurturing.

On another note, Mike Brown is reportedly asking for a salary extension, with one year remaining on his current contract. This after what many fans would describe as a sub-par season in which his Sacramento Kings had the lowest free-throw percentage in the NBA, and coach

Brown resided in the bottom of the league with regards to coach's challenges.

At the end of the day, last year's coach of the year did not take his team to the playoffs.

Fans will make up their own minds, but coaches that actually made the playoffs are already finding themselves out of a job.

On the positive side, the Kings improved in defense from 24th in the league just a year ago, to 14th in the league this season.

That is perhaps coach Brown's crowning achievement since the vaunted Kings offense that was rated #1 a year ago overall, slipped to #13 this season.

I believe coach Brown will likely receive the contract extension he is looking for, and the Kings will make more than one trade in the off season.

Smart fans need to turn their attention to the draft, in which the Kings still maintain the 13th pick in the first round, as a result of their final game loss to the Pelicans. Had the Kings won that game and ventured into the playoffs for the second straight year, they would have lost their first-round pick entirely.

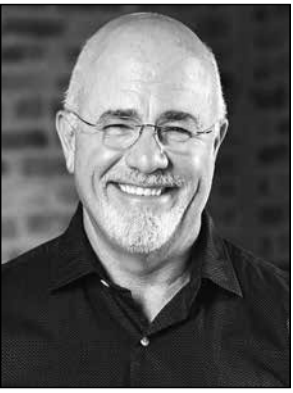

ute. How often does Dave Ramsey tell people to borrow money? Almost never. Why am I doing it now, in this situation? Because the IRS is the worst creditor on the planet. They have almost unlimited power, which they use and abuse, and they have ridiculously high penalties and interest rates. With a personal loan from a local bank or credit union, you'll at least have more input and flexibility in deciding the terms of the agreement.

Now, I don't know about you, but if the person doing my taxes screwed things up to the tune of \$18,000, I'd find someone else in a heartbeat. I understand you want to work with someone nice, and free is usually a great price. But in this case, free was not so free after all.

Just go to your local bank or credit union, explain the situation and see what you can work out. I always recommend small banks or credit unions over any of the mega banks. Places like Bank of America and Fifth Third

just have no soul or empathy whatsoever. And the customer service at a credit union or small bank is a hundred times better than what you'll find at a big bank. Sure, they're still bankers, but there's a human element in there. You're not just a number to them like you are to the mega banks.

I hate debt, Laura, and I'm sorry you guys are in this situation. But 100% of the time, I'd rather have personal loan debt than IRS debt. In my mind, it's the lesser of two evils.

## Start a Business Mentors

With 9 out of 10 new businesses failing in the first 18 months of inception, it's tantamount that people considering opening a business get some sort of guidance. First off, avoid those that talk a good game but basically have seldom if ever done what you are about to try and accomplish.

Truth be told, those that really understand how to start a new business and want to help you will know that new business owners will need all the money they can muster so they shouldn't be taking some of it from you right at the time you need it most.

In a nutshell, the qualities you want to look for in a business mentor are people that have **started and probably OWN more than ONE business** and that those businesses are **still** in existence and thriving.

On the flip side you may want to avoid those that claim they have "had many businesses" but now their only business is taking your money.

Some resumes' might show many businesses to sound impressive but these businesses are actually kaput, faked, embellished or supposedly sold. Especially be wary of resumes that list previously owned businesses that are

unrelated and hodgepodge in their theme. The same goes with employment history. A mish-mash history of employment moves and businesses on ones resume' demonstrate this person may tried his or her hand at everything they could, only to fail and move on to the next thing.

The bottom line is Investigate their claims before you pony up your hard earned money.

On the flip side, look for people that get up early, work late, answer phone calls and texts promptly, and know the value of a buck and the hour it takes to earn it.

An easy test is call them at 8:00 am and see if they answer. Any business person worth his salt is well on his way at 8:00 am and the really good ones are up and at 'em at 6:00.

It sounds odd but if possible investigate their personal net worth.

Successful business owners are at least comfortable and the better ones usually have a higher net worth. I once had a guy try and sell me on financial mentoring but he was in debt up too his eyeballs.

And now for the good part. The best mentors just want to help. Usually their on the older side of things as well. After all, you're probably going to learn more from a 65 year old retired businessman or woman than some 35 year old trying to sell you a start-up program whose instructors are part time handyman or people with mile long resumes who nap till noon and spend half their time hiking in the Himalayans.

The good news is you may not have to spend money on some sort of school or class on how to start a business. You can find real business mentors at SCORE, MICROMENTOR or DIGITAL BOOST. Google 'em up. They are experienced, have been there and FREE at the above entities.

Which means they're not trying to charge you up the wazoo in exchange for advice from a room full of part timers, job hoppers and wheel spinners who pretend to know what they're doing.

Trust me, they probably don't.

## Food & Farm NEWS

### California Rice Farmers Expected to Plant Full Acreage this Season

After a storm dumped more than an inch of water on parts of Northern California earlier this month, effectively halting fieldwork, rice farmers have since been going full throttle. Throughout the Sacramento Valley, aerial applicators can be seen crisscrossing the skies raining rice seed onto flooded fields while tractors prepare neighboring plots for planting. With the region receiving full water allocations, most rice farmers say they intend to plant all their acreage, weather permitting. Before the storm, California growers were projected to sow 497,000 acres of rice this year.

### Technology Lags Behind as Zero-Emission Trucking Mandates Begin

California fleet owners are scrambling to comply with new rules to limit emissions from diesel-powered big rigs and other heavy-duty vehicles. But as new standards go into effect, operators report the technology and infrastructure they need for compliance is not yet available—and could still be years away. The Mahrt family, which owns the Petaluma Egg Farm, uses 10 diesel-powered trucks to haul organic eggs. They need to replace two with zero-emission vehicles or install battery-powered refrigerating units. "The problem is they do not exist," said manager Jordan Mahrt.

### Ventura County Cabbage Growers, Researchers Target Diamondback Moth Threat

Despite having wings, a diamondback moth isn't much of a flier. That hasn't stopped it from spreading across Ventura County, where cabbage is in the ground much of the year. California is the nation's top producer of cabbage, with Ventura and Santa Barbara counties leading the state. The region is also ground zero for the diamondback, which is attracted to leafy plants in the brassica family. With an uptick in crop damage, researchers are now studying new integrated pest management approaches to deal with the pest, which is becoming resistant to common insecticides.

### California Delegation Advocates in Nation's Capital on Behalf of 2024 Farm Bill

The California Farm Bureau board of directors, members of this year's Leadership Farm Bureau class and the organization's federal policy team were in Washington, D.C., early this month, meeting with lawmakers and staff to advocate on issues including passing the 2024 Farm Bill. The House Committee on Agriculture is expected to release final language this week and consider amendments during a bill markup set for May 23. The omnibus legislation supports farmers and ranchers through a variety of safety-net, farm-loan, conservation and disaster-assistance programs. ★

on Oak Street, west on Butte Avenue, south on Acacia Avenue, west on Griffith Lane, south on Perry, and west on South Butte Road to its intersection with West Butte Road.

The fire department reminds homeowners and ranchers to maintain their residences and other structures clear of dry vegetation.

As always, after May 24, persons within the burn ban area may receive a special burn permit from the local fire department. The fire department will inspect the site and may approve a special burn if, in their opinion, it is safe to do so. No burning without an approval inspection by the fire department will be allowed during the ban on fires. ★

# Fatal Crash Occurs on SR-99

**YUBA-SUTTER, CA (MPG)** - On May 20, at approximately 2:07 a.m., CHP Chico Communication Center advised CHP Yuba-Sutter units of a solo vehicle roll over crash on SR-99 south of Richland Road. Emergency personnel arrived on scene and located the driver, who was ejected during the crash. The driver was unresponsive and was declared deceased at 2:15 a.m.

Preliminary investigation indicated the silver 2011 Acura RDX was driving north on SR-99. According to witnesses, the Acura was weaving heavily, unable to maintain its lane. North of the intersection of Lincoln Road, the Acura entered the paved center divide and sharply turned to the right. The Acura drove onto the right shoulder, turned sharply to the

left again and overturned. The driver was unrestrained and was ejected through the windshield during the rollover. The Acura came to rest in the traffic lanes. Multiple witnesses stopped to assist until first responders arrived on scene. The passengers were transported to the hospital to assess their injuries. SR-99 was closed between Lincoln Road and Richland Road for approximately two hours.

Drugs are suspected as a factor in this crash.

The Sutter County Sheriff Coroner will release the name of the deceased once proper notifications have been made.

# Progress Made on Yuba Water's New Power Systems Facilities

## Yuba Water Agency News Release

**MARYSVILLE, CA (MPG)** - Construction of Yuba Water Agency's new Power Systems facilities on Marysville Road in Oregon House is on schedule, with completion expected later next year. To accommodate a recent change in the project's construction schedule, Yuba Water's board of directors

approved on May 21 moving \$6 million from the budget for the fiscal year starting July 1 to the current budget year to ensure work continues.

"This adjustment does not add to the total project budget at all," explained Ryan McNally, Yuba Water's interim director of power systems. "We're still on track to stay within the originally approved budget of \$39.5 million."

Yuba Water broke ground on

the two-year project at 8897 Marysville Road last summer, with Yuba City-based Hilbers, Inc. leading construction. The new property spans 16 acres and includes a 14,000-square-foot administration building, a warehouse and mechanics shop, 150,000-gallon fire suppression water tank, parking and more. The agency is also updating a school bus stop on Marysville Road adjacent to the property to

ensure families can safely pick up and drop off students.

Yuba Water also heard an update on how its financial support of First 5 Yuba County's Growing Up Wild program is helping foster a deeper understanding and appreciation of the outdoors among Yuba County youth.

"90 percent of a child's brain is developed by the age of 5," said Ericka Summers, executive director of First 5 Yuba

County. "We have such a wonderful natural landscape here in Yuba County, and this curriculum is a great way to encourage children to learn, interact with nature and foster an early interest in science."

The free program trains local early educators and caregivers to teach children ages 3-7 about the environment and natural resources with a goal of fostering a love and appreciation for the outdoors. Using a nearly \$19,000 grant from Yuba Water, the Growing Up Wild program has already trained 44 early education providers, potentially reaching hundreds of children.

Lastly, the board heard an update on a planned water and wastewater infrastructure improvement project that will help safeguard groundwater quality in South Yuba County and create a modernized water and sewer system for Olivehurst and Wheatland. Yuba County, Olivehurst Public Utility District and the City of Wheatland are leading the project with support from Yuba Water and are working on securing additional funding to move the project forward.

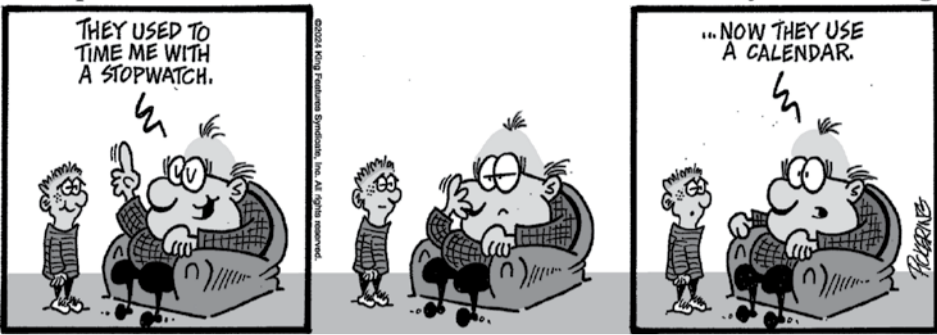

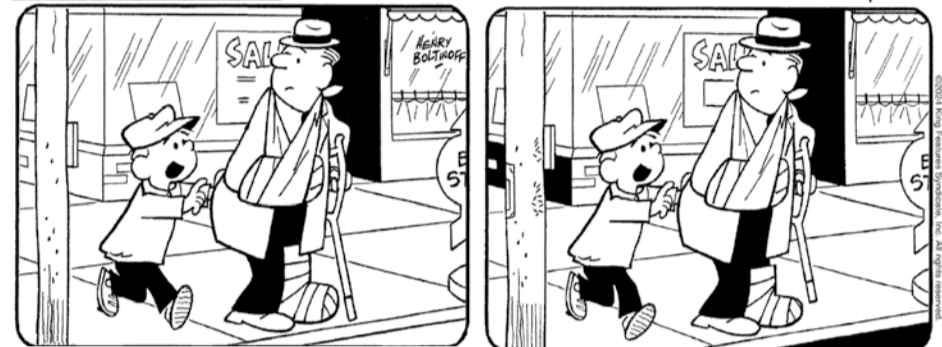

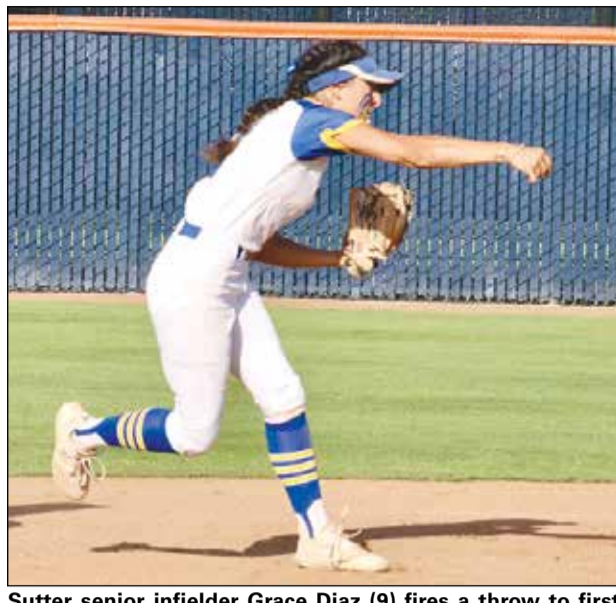

**SUTTER, CA (MPG)** - The Sutter Huskies baseball team punched their opportunity to win a second consecutive CIF Sac-Joaquin Section Division V championship as they swept the Hughson Huskies in a best-of-three series for the second-straight year last week with 10-2 and 6-5 victories.

Sutter chipped away in game one on Monday, May 13, at Hughson as they scored in the first couple innings and led 3-2 after four.

Sutter senior pitcher/outfielder Rylan Giovannoni pitched five strong innings on the mound where he gave up four hits, two runs and struck out five.

After stringing together three hits with two outs in the top of the fifth, Sutter extended their lead 5-2. In the top of the sixth they added five more runs, including three extra-base hits before senior pitcher Kasey Combo relieved Giovannoni for 1.2 innings of shutout ball to help secure the game one of the series.

In game two of the series at Sutter on Wednesday, May 15, Hughson got on

the board early in the first inning as they put three runs across the plate in a hurry before the first out of the game was recorded.

Hughson was effective in raising the pitch count off of Sutter senior pitcher/Hawaii signee Jagger Beck as they added a run in the third and fourth inning to take a 5-0 lead.

Beck pitched four innings where he gave up five runs, four hits and walked five hitters on the afternoon and had his pitch count in the mid-90s.

Sutter head coach Stewart Peterson brought in junior outfielder/pitcher Carson Bishop to pitch the top of the fifth.

Like Giovannoni, Bishop is a left-handed pitcher who made the Hughson hitters struggle at the plate as he pitched three-shutout innings.

"I came in confident with the mindset that if I come in and throw strikes, I would be able to shut them down and be successful," Bishop said.

Sutter got their first run on the board in the bottom of the sixth when junior outfielder Jonny Munger brought senior

infielder Logan Yacavace in on a fielder's choice.

A key component that is instilled in the Sutter baseball program is they do not give up and never feel they are out of a game.

The Dispatch can count multiple times throughout the last couple seasons where Sutter has shown grit and that "never give up" attitude.

Hughson junior pitcher Max Mankins had kept his pitch count low through the first few innings against Sutter, but he threw around 45 pitches between the fifth and sixth inning to get his pitch count into the high 90s where he was taken out after throwing six shutout innings, surrendered only three hits and walked three.

Hughson brought in senior pitcher Paul Wagner to get the final three outs and send the series back to Hughson for a series rubber match with a trip to the SJS D-V final.

The Sutter hitting lineup flustered Wagner as they had two singles in the innings and drew three walks to cut the deficit to 5-3.

Wagner was replaced with the bases loaded and one out. Sutter junior third

baseman Ezra Hilleary took a 2-1 pitch with a base hit to left field to tie the game at five.

Hilleary told the Dispatch that he had the mindset of doing whatever he had to do to get the ball in play and move the runners.

Munger ended the game a couple pitches later as he hit the ball to the right side of the infield with runners on second and third to send Sutter back to the SJS D-V final.

Peterson told the Dispatch the belief in this team of never giving up even when they are down.

"We know if we kept chipping away that we would give ourselves a shot if we had an at-bat left," Peterson said.

Sutter had a rematch of the 2023 SJS Division V final this past Wednesday, May 22, against Bradshaw Christian (Elk Grove) at Islanders Field in Lathrop.

The result of this game was past the Dispatch's print deadline.

The winner of this game would move onto the CIF NorCal baseball tournament as brackets will be released this weekend following the conclusion of all section final games this week. ★
