West Sacramento and Habitat for Humanity have your back, or backyard for that matter, at the 2024 Rock the Block on Oct. 11 and 12. But don't let the far-off date fool you; applications for upgrades must be in by June 3 and is the third year of the five-year commitment made at Bryte Broderick. While West Sacramento vowed \$250,000 over five years at \$50,000 a year, Habitat's investment this round is \$200,000.

24 home repairs and 15 community projects, totaling more than \$365,000 in investment.

The city and nonprofit organization have partnered again for the third year, bringing in more than 400 volunteers who are ready to give 2,800 hours of service, according to West Sacramento Economic Development manager Meaghan Stiles.

"The City Council and the city manager wanted to make sure residents in that area and the community

know money was specifically allocated to them," Stiles said. "So the money in this contract

for Habitat for Humanity is not going to be used anywhere else in the city besides Bryte Broderick." Some community projects com-

pleted in the last few years include

refreshing paint, bark and planter boxes at the YCCA, weed abatement at Elkhorn Park, limestone paths and Continued on page 3

Big Day of Giving Big Deal

SACRAMENTO REGION, CA (MPG) -Local nonprofit organizations were big winners in the May 7 Big Day of Giving. Many achieved support that surpassed their

hopes. Choreographed by the Sacramento Region Community Foundation, the 24-hour give-a-thon this year helped 826 organizations and raised record donations. Gifts totaled more than \$13.25 million. Since the 2013 inception of this annual appeal, public philanthropy has helped Sacramento, Yolo, El Dorado and Placer County charities to the tune of \$100

Administered by the American River Natural History Association, Effic Yeaw Nature Center is funded solely by public support. Big Day of Giving boosted donations by \$65,000.

"We had matching funds from two of our strongest supporters," said staffer Kalee Christensen. "It was an exciting day for us watching our computers and seeing funds

come in. They'll help us enormously."

Carmichael Library Friends gained a share of almost \$98,000 donated to Sacramento Public Library's Friends organization. Summer reading programs and a scheme that gives free books to hundreds of Carmichael children will be funded.

"We're so grateful for community generosity," said local Friends President Barbara Safford. "The lifetimes of many wonderful children will be enriched by reading."

Carmichael Kiwanis raised \$12,500.

Its bottom line also benefited from a \$500 booster prize for most donations between 5 and 6 a.m. A random prize from Big Day of Giving organizers brought in another \$100.

"I'm always impressed by the generosity of our club members and our community,' said Kiwanian Mike Koerner. "We're all about helping kids. These donations go a long way toward that aim."

2024-25 **School Calendar Year Proposed**

WEST SACRAMENTO, CA (MPG) - If you don't like something, change it.

Washington Unified School District (WUSD) proposes to do just that with the 2025-26 calendar year. However, some say it should stay the same.

At the last school board meeting on May 7, Interim Superintendent of Human Resources Farah Ubaidullah presented the school board trustees and Superintendent Edith Hildreth with two choices.

Option A has a twoweek winter and spring break with 180 school days beginning Aug. 6 and ending June 4, equating to 88 days in the first semester and 92 in the second semester.

Option B entails a threeweek winter break and one-week spring break, including the same amount of school days, start and end dates, and semester length. Staying the same, which includes a two-week winter break and one-week spring break, is not an option.

Ubaidullah pointed out

that both A and B options meet the Californiamandated Physical Educational (PE) minute requirement for both semesters. Additionally, priorities that the committee considered were part of creating both options. Priorities included meet state instructional minute requirements, align to state and federal holidays, meet Civil Service Employee Association and West Sacramento Teachers Association contractual requirements, ensure River City High and Yolo High School's finals are before winter break, align transitional kindergarten to fifth-grade parent conferences to the first-trimester grading window and develop October break with an extended four-day weekend.

According to Ubaidullah, start and end dates were important but not a priority. The "diverse committee" shared concerns about not having enough working days in June.

"All those concerns are valid and important, so we wanted to ensure that we Continued on page 3

Alice Astafan Shares Her Story

Retired Major General Highlights Achievements (and Challenges) in New Memoir

SACRAMENTO, CA (MPG) - Being the first female two-star general in the Air Force Reserves is only one of 85-year-old trailblazer Alice Astafan's many accomplishments. She was also a CEO, worked at the Pentagon, was personally appointed by former Gov. Arnold Schwarzenegger and is now a published author.

But that's merely scratching the surface. Astafan's memoir, working various jobs on campus. There she studied biology and chemistry. "Roll Tide!" she said at one point of the newspaper interview, alluding to the Alabama slang.

Astafan was first inspired to serve her country when she attended a movie theater at age 19. She saw a cutout of a woman dressed in an Air Force uniform, advertising women's enrollment in Officer Training School. This piqued her interest, so she joined

"Lady Leader Leaves Lasting Legacy," takes the reader through a detailed journey of her extraordinary life, leaving inspiration and courage along the way.

Messenger Publishing Group had a recent conversation with Astafan at her Carmichael home. Tucked away in a peaceful neighborhood, the Astafan house is warm and inviting. Astafan is quick-witted, energetic and wildly interesting. "Why do newspaper people care so much about my age?" she laughed when asked.

A longtime Carmichael resident, Astafan hails from a farm in rural Alabama, which is obvious when her honey-sweet Southern accent comes out. Born Nora Alice Davidson, she spent her childhood among eight other siblings (seven also served in the military), helping with farmwork and living off the land.

Dreaming of a bigger life, she later put herself through the University of Alabama by the Air Force in 1960, where she would become very successful. Little did she know that she would go on to make history as the first female two-star general in the Air Force Reserves. To clarify, a two-star general is nominated by the president and confirmed by the Senate.

Being one of the only women among thousands of men in the Air Force, it would be safe to assume there was some disadvantage due to the time period. However, Astafan was sure to point out, she didn't face much sexism or prejudice in the military, and if anything, the men she worked with were protective and supportive of her. Astafan reminisced that they recognized her work ethic and loyalty and gave her the promotions she deserved.

"Throughout my career, I had 42 male supervisors and they all treated me with great respect," she said.

Astafan's military career lasted 38 years, taking her throughout

the world. Her duties included developing and finalizing logistics plans, inventorying war readiness material, coordinating and planning support for aircraft and hundreds of personnel, and much more.

From Thailand to Austria to England to Africa, she traveled near and far, eventually landing at Tinker Air Force Base in Oklahoma City in 1965, where she met her future husband, Peter Astafan, a civilian employee. The pair married in a small ceremony in 1968.

"He was perfect," Astafan said.


"He didn't have a jealous bone in his body."

When Peter was assigned to Fort McClellan in 1973, he and Astafan moved to Carmichael. Shortly after their move, the Astafans welcomed a baby boy named Patrick. He would be their only child. To juggle motherhood and her booming career, Astafan stepped down from her 13-year stint of active duty and joined the Air Force Reserves. This gave her more ability to care for Patrick and still do the job she loved. Impressing all her supervisors, it was only a few years later in 1988 when she was named a general and received her first star.

What made Astafan so successful? She said it was all about following the Air Force mission, being a team player and working to the best of her ability. Her grit and determination were recognized and she proved herself capable every single time she was promoted.

While continuing her successful career, the unimaginable happened when Patrick was diagnosed with leukemia in 1992. While Patrick was fighting leukemia, Astafan somehow kept rising up the military ladder, traveling and working in logistics at the Pentagon, officially receiving her second star in 1993, while also supporting her son.

Unfortunately, Patrick lost his hard-fought battle in 1994 at age

20, which turned Astafan's world upside down.

"He was a jewel, he really was," Astafan said. Patrick's legacy has since been honored with a scholarship fund in his name at both Oklahoma Christian University and California State University, Sacramento (CSUS), which has helped fund nearly 200 students' education.

Then in 2021, Peter died from retrograde amnesia, which was another unimaginable loss.

"We had been married for 53 years, four months, and nine days. My life will never be the same," Astafan wrote in her memoir.

When asked how she kept going after losing both her husband and son, Astafan points to sky, referring to God. She honors both Patrick and Peter in her memoir's Chapter 15, "My Soulmate and My Angel – Love is the Greatest Blessing of All".

After retiring from the Air Force in 1998, Astafan immediately dove into a new role as the CEO of the Federal Technology Center, which works with state, federal, and local government contracts. She stayed in that role for 10 years. In addition, she was appointed by former Gov. Schwarzenegger to serve as the chairperson on the California Veterans Board. She served on 20 boards of directors with no

compensation, wrote and gave 100 speeches across the country, was the grand marshal of the Sacramento and Elk Grove Veteran's Day parades, and even got her master's in both early childhood education and international affairs from California State University at Sacramento.

Astafan hopes her passion for this country will inspire American youth to serve their country, chase their dreams and believe in themselves.

"Quite frankly, the country needs women to serve," Astafan said. "We need good honest people to serve our nation so our way of life can forever be safe and in place. Why do so many people want to come to America? Think about it."

She provides words of wisdom to young people: "You do not have to be born with a silver spoon in your mouth. You can dream big, set goals, work honestly and diligently, and become most anything in America. Also, it is not what happens to you along the way, it is how you handle those things. Life is short; it is like a drop of dew on a blade of grass; in the morning it is there but it is soon over. Make your time on this Earth count for something!"

There is so much more to her story. Astafan has lived what can only be described as a remarkable life and has changed the lives of others, as well. Devoted to every role she has had, whether cotton on her childhood farm, being a wife and mother, a mentor, a CEO or a two-star general, Astafan has lived a life full of hard work, selflessness, patriotism and integrity.

Leaving no stone unturned, Astafan's book is filled to the brim with her past speeches, every article written about her and a vast array of photos. It is now available to purchase on her website (aliceastafan.com) or on Amazon.

Continued from page 1 landscaping at Shores of Hope, and new fencing and gutters at Holy Cross Paris.

"We like to say, 'it takes a community to build a community,' and that could not be truer for the Rock the Block Bryte Broderick," said Habitat for Humanity of Greater Sacramento chief advancement and marketing officer Kimberly Cole.

"This life-changing work wouldn't be possible without the advocacy of people like Mayor Guerro and Mayor Pro Tem Orozco, and the many volunteers, community partners and generous supporters who come alongside us to provide such critical services to friends and neighbors in need," Coley said.

Some of those friends and neighbors include the senior population.

"A lot of the people we end up doing more for are older since they may be on a fixed income and they just don't have the resources financially or physically to rehab," Stiles said. "Whether it's a fence or painting their house, it's just a way to beautify their neighborhood so everybody there can be proud of it."

And it's not just about the materials.

"Especially for older individuals," Stiles said, "it lets them know we see them and that there are people there who still care about them."

With care comes safety, according to Stiles, who said that, along with rehabilitation, volunteers thoroughly inspect homes for safety to identify any further work that might be needed. West Sacramento departments take time from their daily city schedule to contribute labor, including "parks employees that kind of divert the work that they normally do on that day to focus on the projects we've identified," Stiles said.

"Folks will kind of go

through the house in general and just let the resident know if there are things that are unsafe also," Stiles said. "So really making sure someone has eyes on the whole house."

With all the labor involved in the two-day event, Community Fun Day complements the hard work with free food and activities for all residents, regardless of whether they volunteer.

"It's just a feel-good event," Stiles said. "It's a really good way for people to know that the city and others are looking out for them and are there to lend a helping hand. "

California Highway Patrol Swears in 106 New CHP Officers

SACRAMENTO, CA (MPG) - The newest members of the California Highway Patrol (CHP) were sworn in May 10 during a graduation ceremony at the CHP Academy in West Sacramento. The 106 officers are part of the CHP's multiyear recruiting campaign to fill 1,000 vacant officer positions by hiring qualified individuals from California's diverse communities.

"These men and women have chosen to dedicate themselves to a career in public service. They have completed several months of rigorous training at the CHP Academy to prepare them to serve the people of California," said CHP Commissioner Sean Duryee. "While this job is one of the most difficult things they will do in their entire life, it is also the most rewarding thing that they will do, and we are proud to have them as part of the CHP family."

The swearing-in ceremony for the new officers marks the completion of a challenging 26-week journey at the CHP Academy. They will report to one of the 103 CHP Area offices throughout the state to begin serving the people of California.

At the CHP Academy, cadet training starts with nobility in policing, leadership, professionalism and ethics, and cultural diversity. Additionally, cadets receive instruction on mental illness response and crisis intervention techniques. Training also covers vehicle patrol, crash investigation, first aid, and the apprehension of suspected violators, including those who drive under the influence. Cadets also receive training in traffic control, report writing, recovery of stolen vehicles, assisting the motoring public, issuing citations, emergency scene management, and various codes, including the California Vehicle Code, Penal Code, and Health and Safety Code.

The CHP has seen an outpouring of interest in joining the ranks since the onset of a multiyear recruitment campaign in June 2022. In the first four months of 2024, the CHP received more than 7,600 cadet applications - a more than 100% increase from the same period in 2022. To accommodate the surge of interest, the CHP has been holding three Academy classes simultaneously for the first time in the Department's history. The next cadet graduation from the CHP Academy is scheduled for July 12, 2024.

Continued from page 1 were meeting everyone's concerns," Ubaidullah said. "We were trying to put together a calendar that meets all those requirements and accommodates all the students, staff and families."

Calendars and changes are "hot-button issues," according to Board Trustee Sarah Kirby Gonzalez. Both Kirby-Gonzalez and Trustee and Vice-President Coby Pizzotti said many shared concerns with the proposed schedule's lack of the option to stay the same.

Kirby-Gonzalez said it would be option A if she had to choose but "had there been an option to stay the same," her decision might be different.

"If between now and the next time you come to us,

there is an option to end a week earlier and take out that spring break being two weeks, then I would be interested to see that otherwise option A makes sense," Kirby Gonzalez said.

Ubaidullah said the committee recommends that Option A be approved at a future board meeting.

"It is one of the best options we have thus far recommended or asked for approval because it meets the requirement of the 88 PE instructional days as well as all of the requirements we have for staff and it also addresses some of the areas we needed to have breaks," Ubaidullah said, adding the June 4 end date is so staff and students can have a "robust week."

Pizzotti disagreed.

"You made a comment

about a robust work week into June; I will say there is not a lot of teaching going on in the last week of June; there is very little, in fact," Pizzotti said, adding the last couple of weeks of school is about transition, not education. "You're not doing long division and practicing that."

Pizzotti also expressed concern about how PE semester hours could be slotted for just one semester rather than throughout the year based on grade.

"I remember going to PE every single day during my high school career from freshmen to senior year; it just wasn't an option to do it all truncated into one area," Pizzotti said.

The Washington Unified Calander Committee must return to the school board officials for approval. ★

Continued from page 1 and youth programs. This total includes gifts from the Borman family, community benefactor Susan Marszal and former Supervisor Susan Peters.

Current Supervisor Rich Desmond included the Parks Foundation among 24 Big Day of Giving donations. His choices included Carmichael Kiwanis, Sacramento Fine Arts Center, Fair Oaks Rotary, Carmichael HART and the San Juan Education Foundation. "I dedicate District 3 discretionary funds, as well as my personal funds," he said. "I chose organizations that help our most vulnerable residents, care for animals, promote arts and culture, and generally improve quality of life."

Boosted by Desmond's donation and a further \$20,000 in gifts, Sacramento Fine Arts Center exceeded Big Day of Giving hopes.

"These donations are vital to keeping the center and our programs going," said Sacramento Fine Arts Center executive Angelia Gordon. "We're grateful for so much generosity." Nature protecters opened

wallets wide across the region. Placer Land Trust's appeal yielded nearly \$194,000. The American River Conservancy was enriched by more than \$34,000. The American River Parkway Foundation and Save the American River Association gained \$21,048 and \$18,395

respectively. Soil Born Farms, a Rancho Cordova enterprise that promotes sustainable food production, harvested almost \$21,000

May 7 also restocked food closets. Donors fed Sacramento Food Bank and Family Services more than \$255,000; Sacramento Loaves and Fishes more than \$165,000; Yolo Food Bank almost \$146,000. Locally, Fair Oaks/Orangevale Food Bank gained more than \$33,000. Carmichael's Homeless Assistance Resources Team was boosted by almost \$5,000.

Top regional beneficiaries included Sacramento Philharmonic and Opera with more than \$327,000 to sing about. The Salvation Army drummed up more than \$322,000; Sacramento SPCA scooped \$221,705; ACC Senior Services got \$204,957.

Culture was handsomely applauded. B Street Theatre (The Sophia) raised nearly \$104,000. The Crocker Art Museum collected more than \$92,570. CapRadio beamed in around \$94,000. Stage patrons backed Fair Oaks Theater Festival to the tune of \$10,000.

In North Highlands, California Aerospace Museum was refueled with more than \$26,000. "Sending kids to programs

"Sending kids to programs for hands-on STEM learning would not be possible for some families without this generosity," said museum director Karen Jones. "Almost 86 per cent of our summer campers are on scholarships. These are largely enabled by

BDOG."
Youth charities compelled grown-up generosity. Sacramento Children's Home collected more than \$176,500. Shriners Hospitals brought in \$82,677. Kiwanis Family House banked \$73,500-plus. Children's Receiving Home of Sacramento supporters gave more than \$59,000.

"Big Day of Giving allows the community to learn about nonprofits," explained Sacramento Region Community Foundation officer Kelly Siefkin. "Participating organizations also love to build relationships with new donors. This year, we lowered the gift minimum to \$10. This made philanthropy more accessible."

Perhaps \$10 doesn't seem much. But small donations make a huge difference. With average gifts still under \$50, they added up to \$13.2 million."



ute. How often does Dave Ramsey tell people to borrow money? Almost never. Why am I doing it now, in this situation? Because the IRS is the worst creditor on the planet. They have almost unlimited power, which they use and abuse, and they have ridiculously high penalties and interest rates. With a personal loan from a local bank or credit union, you'll at least have more input and flexibility in deciding the terms of the agreement.

Now, I don't know about you, but if the person doing my taxes screwed things up to the tune of \$18,000, I'd find someone else in a heartbeat. I understand you want to work with someone nice, and free is usually a great price. But in this case, free was not so free after all.

Just go to your local bank or credit union, explain the situation and see what you can work out. I always recommend small banks or credit unions over any of the mega banks. Places like Bank of America and Fifth Third just have no soul or empathy whatsoever. And the customer service at a credit union or small bank is a hundred times better than what you'll find at a big bank. Sure, they're still bankers, but there's a human element in there. You're not just a number to them like you are to the mega banks.

I hate debt, Laura, and I'm sorry you guys are in this situation. But 100% of the time, I'd rather have personal loan debt than IRS debt. In my mind, it's the lesser of two evils.

Social Security Matters Older Husband and Working Wife Seek Guidance

Dear Rusty: I am 74 years old, retired and receiving Social Security. My wife will be 65 in January of 2025. Our hope was to start paying off some credit card expense by her receiving SS when she turns 65, however it appears there would be a substantial reduction to her benefits. Her work income is \$37,500 a year, and she wasn't planning on retiring from work at age 65. Because I am 11 years older, we felt it makes sense to use her Social Security as a means to lower our debt. We have \$27,000 in credit card debt, and I don't really want to use my 401(k) funds due to taxes. We pretty much live on my Social Security and pension. Signed: Seeking Suggestions

Dear Seeking: Your wife's full retirement age (FRA) for Social Security purposes is age 67. Because she will not yet have reached her FRA in January 2025 (when she is 65), if she claims SS to start at that time, not only will her monthly amount be reduced, but she will be subject to Social Security's annual earnings test. The earnings test sets a limit for how much can be earned by beneficiaries who claim SS before FRA.

The earnings limit for 2024

is \$22,320. The limit for next year is not yet published (it's based on changes to the national wage index) but will be a bit higher – likely about \$23,500. Thus, I can't provide the exact impact, but if your wife's 2025 earnings exceed next year's limit, Social Security will take back \$1 in benefits for every \$2 over the limit (half of the amount over the limit). So, if your wife earns \$37,500 per year, that will likely be about \$14,000 over the limit and Social Security will take back half of that (\$7,000). They "take back" by withholding future benefits, or you can repay them in a lump sum. So, you will have a choice – repay Social Security from your other assets, or they will withhold your wife's SS benefits for the number of months needed to offset her penalty for exceeding the earnings limit. The number of months they will withhold depends on how much is owed and what your wife's monthly SS benefit is. For example, if your wife's age-65 SS benefit is about average (\$1,900) and her penalty for exceeding the limit is \$7,000, Social Security would withhold your wife's benefit for 4 months to

Unless your wife tells them in advance that she will exceed the limit, Social Security will find out the following year (after you file your income taxes). But, in any case, your wife cannot avoid the annual earnings test for working before reaching her full retirement age. The earnings test goes away when

your wife reaches her FRA of 67. Until that time, if she continues working she will have a choice to have her benefits withheld for a portion of the year, or simply repay Social Security in a lump sum (in which case her benefits would continue uninterrupted).

FYI, there is a silver lining in this, because if your wife has benefits withheld because she exceeds the earnings limit before her FRA, after she reaches her full retirement age Social Security will give her time credit for the months when benefits were withheld, which will result in her monthly Social Security payment amount increasing somewhat at her full retirement age. Thus, over time, your wife may recover the benefits which were withheld for exceeding the annual earnings limit. But to get 100% of the benefit she's earned from a lifetime of working, and be exempt from Social Security's earnings limit, she would need to wait until she reaches her FRA to claim.

Controller Cohen Issues April Cash Report

Fiscal year-to-date revenues still trend below expectations

California State Controller's Office News Release

SACRAMENTO, CA (MPG) - On May 10, State Controller Malia M. Cohen released her monthly cash report covering the state's General Fund revenues, disbursements and actual cash balance for the fiscal year through April 30, 2024. The state ended April with \$95.8 billion in unused borrowable resources, while fiscal year-to-date receipts continue below estimates contained in the

2024-25 Governor's proposed

The Governor's Budget estimated that the state would collect nearly \$16.3 billion in personal income taxes in April. As shown on the State Controller's Office April 2024 Personal Income Tax Tracker webpage, the state exceeded the revenue target by approximately \$150 million.

"With April personal income tax revenues just tracking with the most recent budget estimates, fiscal year-to-date revenues

continue at lower-than-expected levels," said Controller Cohen. "The high level of borrowable resources is due in large part to the \$26 billion the state has prudently built up and reserved for rainy days and economic uncertainties. Maintaining enough cash to cushion against economic downturns has been one of California's strengths in its credit ratings and ensures the state will continue to meet its payment obligations."

Fiscal year-to-date receipts

through April were \$169.8 billion, nearly \$4.8 billion below the Governor's Budget estimates, or 2.7 percent. The state's cash position is \$7.6 billion better than expected with disbursements of \$184.9 billion for the fiscal year nearly \$12.4 billion, or 6.3 percent, less than proposed budget projections.

As the chief fiscal officer of California, Controller Cohen is responsible for accountability and disbursement of the state's financial resources. The

Controller has independent auditing authority over government agencies that spend state funds. She is a member of numerous financing authorities, and fiscal and financial oversight entities including the Franchise Tax Board. 





Among the nominees, seven volunteers were nominated for Youth Volunteer of the Year, 13 were nominated for Individual Volunteer of the Year and three volunteer coordinators were nominated for Volunteer Manager of the Year. The evaluation was conducted by a panel of three judges: Barbara Fitzwater, retired volunteer manager at Kaiser Permanente; Tiffany Maese, volunteer coordinator at the Sacramento County Sheriff's Office; and Janice Wagaman, formerly associated with the Front Street Animal Shelter.

The Margaret Einspahr Youth Volunteer of the Year award acknowledges a youth volunteer under age 21 who has shown exceptional dedication to community service, having contributed a minimum of 25 hours of service between January and December 2023. Recipients of this award receive a \$500 scholarship funded by the Margaret Einspahr Memorial Fund to honor Margaret Einspahr's legacy as a dedicated leader in the field of volunteerism.

The 2024 winner of the Youth Volunteer award was Riya Janardhan, a high school junior, nominated by WEAVE, a nonprofit organization dedicated to promoting safe and healthy relationships and support survivors of sexual assault, domestic violence, and sex trafficking in Sacramento. Janardhan was

nominated for her dedication to advocating for women's rights and gender equality.

"Being a girl myself and having to experience different stereotypes, I don't want to have to experience this at such a young age," Janardhan said. "It's something I strive to want to fix."

Other nominees for this position included Kevin Leach, nominated by Meristem in Fair Oaks; Kai Nakaoka, nominated by Scouting America in Sacramento; Maximum Truong, nominated by the Sacramento Tree Foundation; and Kristy Yu, Flynn Ng, and Cara Taylor, nominated by the Sacramento Public

The Individual Volunteer of the Year award is presented to a volunteer over age 21, who has dedicated a minimum of 25 hours of service. The award recipient receives a \$100 award for their organization.

The winner for this year's award was Patricia Estopinal, nominated by Court Appointed Special Advocates Sacramento (CASA), an organization focused on ensuring support for children in the foster care system through volunteer advocates.

"This award means so much because for the past 14 years being able to have a relationship with foster youth, to have a relationship where you know that you're the one constant, no

matter what is going on in their lives, it's just such a meaningful

relationship," Estopinal said. The nominees for the positions included Beatriz Bueno and Jane Shapiro, nominated by the Sacramento Medical Serve Corps in McClellan; Anne Marie Christian, Daisey Maldonado and Karina Villanueva, nominated by Dignity Health Methodist Hospital in Sacramento; Mary Kay Edson, nominated by the Sacramento Public Library; Ron Hills, nominated by Vitalant in Mather; Marissa Honey-Plate, nominated by the Miss Sacramento County Scholarship Organization in Antelope; Rodney Horton, nominated by the American River Parkway Foundation in Carmichael; Nicky Smolter, nominated by the Lavender Library in Sacramento; Matthew Tran, nominated by the Sacramento Tree Foundation in Folsom; and Kristy Venrick Mardon, nominated by Only Sunshine Sanctuary in Fair

Volunteer Manager of the Year honors a volunteer manager who demonstrated outstanding leadership and dedication to supporting volunteers. The winner received a \$100 award for their organization, along with a one-year complimentary DOVIA Sacramento organization membership.

The 2024 winner was Marlene

von Friederichs-Fitzwater nominated for her work with Joshua's House and Health Communication Research Institute located in Yolo County. She has spent the past decade building Joshuas House, a hospice facility for terminally-ill homeless individuals. Von Friederichs-Fitzwater has raised \$2.5 million and created a volunteer organization to provide high-quality care.

Other nominations included Marissa Honey-Plata nominated by Miss Sacramento County Scholarship Organization and Justin Rubio with Sacramento Tree Foundation.

During the ceremony, several guest speakers talked about the importance of volunteering and the work they have done throughout the years. Lynn Pesely, winner of the 2023 DOVIA Volunteer Manager award, talked about her work with the Sacramento Medical Reserve Corps. Helen Dang, Miss Sacramento County, and Nicole Vicks, Miss Capitol City, winners of the Miss Sacramento County Scholarship program, mentioned their work with advocacy and action for the houseless and Stomp Out Bullying

"One second, one minute, one action can change someone's life," Dang said. "All it takes is one good dead to build the foundation of lasting change."

IRS Warns Taxpayers They May Be Scam Victims in Certain Scenarios

WASHINGTON, D.C. (MPG) - On May 14, the Internal Revenue Service issued a consumer alert following ongoing concerns about a series of tax scams and inaccurate social media advice that led thousands of taxpayers to file inflated refund claims during the past tax season.

The IRS warned taxpayers not to fall for these scams centered around the Fuel Tax Credit, the Sick and Family Leave Credit and Household Employment taxes. The IRS has seen thousands of dubious claims come in where it appears taxpayers are claiming credits for which they are not eligible, leading to refunds being delayed and the need for taxpayers to show they have legitimate documentation to support these claims.

The IRS continues to urge taxpayers to avoid these scams as myths continue to persist that these are ways to obtain a huge refund. Many of these scams were highlighted during this spring's annual Dirty Dozen series, including the Fuel Tax Credit scam, bad social media advice and "ghost preparers."

For taxpayers who did fall for these traps, they need to follow steps to verify their eligibility for the claim. Some taxpayers could also face steep financial penalties, potential follow-up audits or criminal action for improper claims. The IRS encourages people to review the guidelines, talk to a trusted tax preparer and, in some cases, file an amended return to remove claims for which they're ineligible to avoid

potential penalties. "Scam artists and social media posts have perpetuated a number of false and misleading claims

that have tricked well-meaning taxpayers into believing they're entitled to big, windfall tax refunds," said IRS Commissioner Danny Werfel. "These bad claims have been caught during our fraud review process. Taxpayers who filed these claims should realize they've been tricked, and they face an extensive review process and a long potential wait if they're owed a refund for other things."

Problem claims involve Fuel Tax Credit, Sick and Family Leave Credit, Household Employment taxes.

The IRS has identified three common themes that continue to pop up among these bad refund claims. They involve legitimate tax provisions, but they are limited to very specialized situations. The vast majority of the related claims coming in do not

Fuel Tax Credit: This specialized credit is designed for off-highway business and farming use. Taxpayers need a business purpose and a qualifying business activity such as running a farm or purchasing aviation gasoline to be eligible for the credit. Most taxpayers don't qualify for this credit.

Credits for Sick Leave and Family Leave: This specialized credit is available for self-employed individuals for 2020 and 2021 during the pandemic; the credit is not available for 2023 tax returns. The IRS is seeing repeated instances where taxpayers are incorrectly using Form 7202, Credits for Sick Leave and Family Leave for Certain Self-Employed Individuals, to incorrectly claim a credit based on income earned as an

employee and not as a self-em-

ployed individual.

Household Employment taxes: Taxpayers "invent" fictional household employees and then file Schedule H (Form 1040). Household Employment Taxes, to claim a refund based on false sick and family medical leave wages they never paid.

and people sharing bad advice," Werfel said. "Scam artists constantly prey on people's hopes and try to use the complexity of the tax system to convince people there are secret ways to get a big refund. These three credits illustrate that it's important to carefully review the tax return for accuracy before filing and rely on the advice of a trusted tax professional, not some fly-by-night preparer or a questionable source

they hear on social media."

Potentially fraudulent refunds frozen; improper claims could face follow-up compliance

Given the questionable nature of many of these claims, the IRS has frozen the refunds for these taxpayers. Taxpayers have to follow several specific steps to resolve these issues.

Taxpayers whose refunds have been frozen will generally receive one of several letters from the IRS asking for additional information.

Initially, taxpayers may have received a letter asking them to verify their identity. In these situations, if they filed the return in question, they should review whether their tax return is accurate. For example, did they actually qualify for one of the three credits listed above? Or if they used a tax preparer, check to see if the preparer actually signed the tax return. When tax preparers don't sign a tax return, it is a red flag that the taxpayer is being

Taxpayers who improperly claimed these credits do not need to visit a Taxpayer Assistance Center (TAC) to verify their identity. However, they may need to amend their tax return to remove the improperly claimed

Taxpayers should use the IRS.gov tool Should I File an Amended Return? to determine if they should amend their return. If they submit an amended return, they do not need to visit a TAC.

A number of taxpayers who initially received correspondence asking about their identity may be receiving an additional

letter seeking additional docu-

mentation to show they actually

qualify for the credits they

claimed. Taxpayers who verified their identity in-person may receive these letters. Taxpayers who haven't verified their identity yet and receive one of these letters asking for additional documentation should follow the

These letters - IRS Notice 3176c – apply to potentially frivolous tax returns, which includes incorrect claims for Fuel Tax Credits, Sick and Family Leave Credits and Household Employment taxes.

advice on the most recent letter.

Legitimate taxpayers qualifying for these credits can submit documentation showing they actually qualify for the credit. But people who don't qualify for these credits risk facing a penalty of up to \$5,000 per return for filing a frivolous claim. Taxpayers submitting inaccurate claims also face the risk of an audit. Those who knowingly filed a false tax return also face potential criminal prosecution.

To avoid penalties and potential follow-up action by the IRS, taxpayers who incorrectly filed for these claims need to promptly submit an accurate tax return without the claims. Taxpayers can visit the IRS.gov tool Should I File an Amended Return? to determine if they should amend their return. If they submit an amended return, they do not need to visit an IRS Taxpayer Assistance Center. Taxpayers in this situation can also visit a trusted tax professional for advice.

The IRS noted that the entire refund amount is frozen on returns with these bad claims. Taxpayers will not receive any portion of their refund, even if they also claimed legitimate credits.
