

Music Fest Rocks Old Town

ELK GROVE, CA (MPG) - The inaugural Elk Grove Music Festival gathered a lineup of rock and country bands to Old Town Plaza on May 18. While attendees listened to the live music, they visited an array of food and craft vendors, and a beer, wine and spirits garden.

Presented by the city of Elk Grove, the one-day festival was the brainchild of Enrique Silva, owner of Coatza Brewing Co. in Old Elk Grove.

The event opened with the National Anthem

performed by Sacramento singer Brian Rose. Afterward, students of the School of Rock took the stage.

The Elk Grove branch of the music education franchise is located in Old Elk Grove, just across the railroad tracks from the plaza. Thirteen members of the school's House Band performed covers from the pop rock of Paramore to the heavy metal of Korn. Solos gave various musicians a chance to show off their skills.

Maddy Vine, director of early education for School of Rock Northern California, said the

Holiday Keeps Minds on the Fallen

SACRAMENTO, CA (MPG) - As Memorial Day draws near, communities prepare to honor and commemorate the sacrifices of fallen heroes. Several events will be held throughout the Sacramento area, providing community members with ample opportunities to participate in the celebrations.

Memorial Day, observed on the last Monday in May, honors service members who have died in military service to the nation, according to the Department of Defense. The holiday has roots dating back to the post-Civil War era, when citizens would informally place spring flower memorials on the graves of fallen soldiers.

All Sacramento-area residents are invited to join in the upcoming observances at any of the following locations.

On May 27, community members will also gather at the East Lawn ceremony at 10 a.m., where attendees can gather to honor the fallen heroes of the United States Armed Forces.

The event is being hosted at multiple locations, including 9189 E. Stockton Blvd., Elk Grove; East Lawn Sierra Hills at 5757 Greenback Lane, Sacramento; and East Lawn Memorial Park, 4300 Folsom Blvd., East Sacramento.

The Memorial Day ceremony promises to be a moving tribute where distinguished military speakers such as Bob Hilton and Gilbert Morales will take the stage, along with musician and bagpiper Liz Tubbs. Part of the program will include the Armed Forces Medley and the POW/MIA (Prisoner of War/Missing in Action) ceremony. Complimentary refreshments will be provided.

Other events include the Memorial Day tribute at Mount Vernon Memorial Park at 11 a.m. May 27 at 8201 Greenback Lane.

Starting at 5:30 a.m. May 27, Boy and Girl Scout troops will raise donated American flags around the park, followed by the fire department hoisting a 50-foot flag at the entrance at 10 a.m.

"On Memorial Day, it is important to stop and reflect on the American patriots who have paid the ultimate sacrifice to keep us free," said Mount Vernon Memorial Park's

Cosumnes Fire: Work Continues on Cutting Long Hospital Waits

ELK GROVE, CA (MPG) - Cosumnes Fire Department officials on May 15 provided an update on the time its ambulance crews spend waiting for hospitals to accept patients. The issue, which can occupy medical personnel for long periods of time, came up at the regular Cosumnes Community Services District board meeting.

Director Peter Sakaris noted that ambulance patient offload time (APOT), or wall time, decreased in April.

According to the fire department's April report, wall time was less than 40 minutes in 90% of the cases in which the agency transported someone to a hospital. In previous months, the wait times were longer; in January, for example, the 90th-percentile wall time was one hour and 40 minutes.

Assistant Fire Chief Robert Kasparian said it is normal for wall times to drop in April.

"(The decrease) is pretty consistent with what we've seen for the month of April," Kasparian said. "We typically have a high APOT time



January, February, March, which is a result of flu season, with COVID and everything. ... And then, as we've looked at the trending, it's about on par with what we've seen over the past five years."

Wall time had decreased by about two minutes countywide, according to Kasparian. Kaiser Permanente South Sacramento, the destination for half of Cosumnes Fire's hospital transports, cut its wall time from 76

minutes to 52 minutes.

Wall time has been an ongoing concern for Cosumnes Fire and medical first responders across the region. When an ambulance crew takes a patient to the hospital, the crew must wait with the patient until the hospital admits them, reducing the agency's ability to respond to other medical emergencies.

Looking at regional and state

Chu Goes Beyond the Call for Adult Protective Services

SACRAMENTO COUNTY, CA (MPG) - This month, Sacramento County Department of Child, Family and Adult Services (DCFAS) is celebrating employee, Irene Chu, as part of the video and story series “Beyond the Call: Chronicles of Compassion in Child, Family and Adult Services.”

Having started her career with the County in Child Protective Services, Irene eventually transitioned to working with older adults through Adult Protective Services (APS). Irene has over 27 years of experience working for the County. Her background in counseling helps give her a unique perspective, allowing her to engage with clients and guide them through decision-making processes.


“The mission of Adult Protective Services is to protect the health and safety of older adults and dependent adults in our community in the least restrictive environment,” Irene explains. That mission involves a delicate balance of advocating for their well-being while also respecting their autonomy and choices.

Irene wants people to know that APS operates under regulations that encourage employees to respect the rights of older adults while addressing issues such as self-neglect, which is a unique challenge.

“Self-neglect cases require a nuanced approach,” Irene said. This is because self-neglect cases highlight the complex nature of ensuring the safety of someone while still honoring their boundaries and individual agency. Self-neglect is when someone doesn’t take care of their basic needs like personal hygiene or eating. Self-neglect can have many underlying causes including depression, isolation, or an underlying condition like undiagnosed Alzheimer’s disease. Irene said APS workers encourage clients to weigh the pros and cons to decide whether they want help for self-neglect.

“Ultimately, we let them [the client] make the decision. Because ultimately, they have to feel that they own it, they have the ownership of that choice,” Irene explains.

As a Program Planner, Irene’s job goes far beyond advocating for older and

disabled adults. She helps newer staff members as they learn the ropes, provides presentations, runs statistical reports, and writes and monitors contracts. Currently, Irene is also handling a housing project that helps shelter older adults through rehousing and homeless prevention services. The project, called HomeSafe, showcases Irene’s commitment to providing innovative solutions to address issues in her community.

Reflecting on her 27 years with the County, Irene says she is grateful for her career. These experiences helped her professionally and allowed her to make a meaningful impact on the lives of those she serves. As Irene continues her work, she hopes sharing her story will encourage others to seek out a long-lasting career with Sacramento County.

“I really like it so much because I really enjoy all the opportunities that I was given through the years,” Irene said.

DCFAS is proud of the dedication and passion that Irene and many other employees demonstrate. Irene is a shining example of going beyond the call, and that is why the County is happy to feature her in the ongoing video series “Beyond the Call: Chronicles of Compassion in Child, Family and Adult Services.”

Throughout the year, the County will continue to explore different roles within DCFAS, share how workers use their personal experience to better serve those in need, and teach people about the ongoing efforts DCFAS makes to serve Sacramento County. ★

County OKs \$3 Mil Fund for Neighborhood Improvements

SACRAMENTO COUNTY, CA (MPG) - During the Fiscal Year 2022-2023 budget hearings, the Sacramento County Board of Supervisors approved \$3,000,000 in funding, budgeted in the Neighborhood Revitalization Fund, for a Neighborhood Improvement Initiative.

The Neighborhood Improvement Initiative aims to target the elimination of blight and enhance public spaces through investments in projects improving safety and livability in underserved areas of the county, with a specific focus on Environmental Justice communities, commercial corridors and areas adjacent to vacant or blighted properties.

“I am extremely proud of this investment,” said Third District

Supervisor Rich Desmond. “The Neighborhood Improvement Initiative is funding projects that are really important to many of our communities and are crucial to their identity, pride and sense of place.”

Said County Board of Supervisors Chair and Second District Supervisor Patrick Kennedy, “This initiative really reflects our support of the diverse needs in the county. We’re not just revitalizing spaces; we’re improving safety, connections and dignity in our communities.”

The County Board of Supervisors directed the Office of Economic Development to conduct extensive outreach to develop a comprehensive list of potential projects for the Neighborhood Improvement Initiative. During summer and fall 2023, the Office of Economic Development, with the supervisory district offices and

county Departments of Transportation and Community Development, met with community partners, residents and businesses through community meetings and online engagement to gather feedback and have the public suggest projects.

County staff evaluated project feasibility and community benefits within each supervisorial district for recommendations to receive Neighborhood Improvement Initiative funding. On May 7, the Board of Supervisors approved the allocation of all \$3,000,000 for 12 projects, primarily within Environmental Justice communities, commercial corridors and/or areas adjacent to vacant or blighted properties located throughout each supervisorial district.

attempts to address the issue, Kasparian said Sacramento County recently allowed transport to destinations besides hospitals, such as mental health facilities.

Senate Bill 1180, authored by State Sen. Angelique Ashby, D-Sacramento, would allow the department to be reimbursed for transport to alternate destinations.

“With regards to the

entire county and the APOT times, I think it’s holding pretty steady,” Kasparian said. “We’re seeing a couple minutes’ changes here and there. Some of the hospitals are doing much better than they have in the past, but overall, I think we still have a long way to go.”

In other business, the board approved the release of \$57,863 in unclaimed checks to the district. The checks, issued by the

district as payment for various services, went unclaimed for at least three years, at which point state law allows the district to reclaim the funds. A staff report said the district had given notice of the unclaimed checks starting Feb. 23, with the final deadline to collect the money by April 8.

The board voted 4-0 to reclaim the money. Board President Jim Luttrell was absent. ★

hair out, we’ve got soloists stepping forward to shred. Stage presence and persona is a big part of the charisma of rock ‘n’ roll music and what we try to embody here at School of Rock,” Vine said.
The band will also learn about the lives of traveling musicians when it goes on tour this year, starting in Cleveland and traveling to Nashville. Besides playing gigs, the students will visit landmarks like the Rock & Roll Hall of Fame.
Vine said the band’s set at the music festival was “spectacular.”
“I think this is one of their most



But First, Answer Me This

“First, I’m curious as to what kind of church you are running up there?” asked a caller to my church office.

His was the kind of question I get lately since returning to the pastor role.

Most often, callers are like the young mother of three who told me, “I have three churches I’m considering attending, but first I’m asking the pastors to answer some questions.”

She squashed that ordinal number “FIRST,” as if drawing a line in the theological sand.

“FIRST, does your church teach tithing?”

I assumed she knew most churches encourage donations, but not wanting to scare her off, I was slow to answer. Was she looking for a discount? Or was she searching for a rich church?

Some people call the church directly

and others find me through my local column. Readers usually leave a voicemail, graciously giving me time to formulate an answer.

I played back a message from a man last week wanting to know how he could donate to Chispa Project. I returned the call, excited to tell him about my upcoming trip to Honduras, but he too began with a question.

FIRST, “I want to know if angels are able to speak to us.”

His challenging question made me want to ask, “Can I call a friend? Or ask the audience?” Maybe I should have said, “Yes. The angels are telling you to donate to Chispa Project at Chispaproject.org/chaplain.”

Another man saw that I had a woman scheduled to preach while I was away.

“FIRST of all, should women really be allowed to preach in church?”

I knew he was referring to 1 Timothy 2:12: “I do not permit a woman to teach or to assume authority over a man; she must be quiet” (NIV).

Since I assumed he knew I invited the guest pastor, his question seemed more challenging than inquisitory, intoned much like the political questions I get.

“You must FIRST believe that abortion

is wrong,” suggested a Pro-life advocate.

“Isn’t God against homosexuality?” was the message left in a weathered tone. “God FIRST made man and then made woman.”

“We need to FIRST return prayer to the schools,” said one visitor who dared attend without first checking my political pedigree.

“God is on the side of Israel! Shouldn’t we all be calling for the destruction of Hamas?” asked one local pastor.

I know that many books have been written about all of these issues by good Christians on both sides. I know sincere believers can disagree about things.

But I try to discourage those seeking a binary faith of yes-and-no answers by sharing first the words from The Message in Matthew 22:36-40.

“When asked what was the FIRST and most important of all of God’s laws, Jesus said, Love the Lord your God with all your passion and prayer and intelligence.’ This is the most important, the first on any list.

“But there is a second to set alongside it: ‘Love others as well as you love yourself.’ These two commands are pegs; everything in God’s Law and the Prophets hangs from them.”

I know I didn’t answer most of my callers as they would have hoped. But perhaps once I’ve mastered Jesus’ list, I’ll have better responses to their questions.

Finally, my best call began last week, with “FIRST, I think your new picture makes you look like Jean-Luc Picard.”

Of course, as a Trek fan, I knew he was referring to Patrick Stewart, the fictional captain of the USS Enterprise-D in “Star Trek: The Next Generation.”

I felt a bit affronted as Stewart is totally bald. I’m not – yet.

Should I allow this caller to make the final cut for our church membership? Stay tuned.

Eagles Tame the Flames to Reach Semifinals

ELK GROVE, CA (MPG) - In the Division I quarterfinals, the No. 3 seed Pleasant Grove Eagles defeated the No. 6 seed Lodi Flames by a score of 3-0 to leave them as the lone local school in this bracket.

The pitching was dominated by junior Madeline Lawson who pitched a complete game shutout with eight strikeouts. “She was on her game today and that’s what she does with mixing it up well: keeps them on their toes and uses all nine quadrants of the zone,” said head coach of the Eagles Brian Cherry.

Lawson did this without being 100% as Cherry said that his starting pitcher was sore and dealing with tendinitis, but he said even then she was outstanding.

The battery of Lawson and senior Grace Cable has been key to the success of the Eagles’ pitching throughout this whole season, Cherry said.

“She’s (Cable) caught 95% of our games and that makes a big difference when she learns the pitcher and the pitcher is confident with her, so it definitely makes a big difference having her catch Madeline all year long,” Cherry said.

The modern-day method of receiving for catchers is something that Cable does

well, as she starts her mitt below the zone and works her hands up with the ball as it’s being caught to be able to steal strikes for her pitchers. This has helped throughout the season, Cherry said.

“It’s new for the catchers, it’s new for the umpires and it’s definitely changing our sport because from NCAA down it’s catching on,” Cherry said.

As for the offense, this was a big drop-off from the 12 runs they put up against the McClatchy Lions in the first round..

“We had nine or 10 fly-outs today and we just didn’t make the adjustment so we were popping up a lot today even if we kept talking about; it we couldn’t adjust but we took advantage of some of their errors but we’re a much better-hitting team than what we showed today,” Cherry said.

Despite that, Cherry said they had a lot of solid contact on fly balls that were hit in the air but got caught because of the wind pushing in.

An RBI single in the first inning from senior Riley Bigley put the Eagles up early with the runner getting on base thanks to an error from the Flames.

“That definitely deflates a team when you come up right up in the first inning and score then we held them and our first

run came off of an error dropped in the outfield, so it definitely changes the tempo for us in a positive way,” Cherry said.

The offense for the Eagles was sealed by a Little League home run with a combo of errors from the Flame that scored two runs on a hit from senior Lindsay Paredes.

The Eagles will take on the No. 2 seed and reigning section champions Oak Ridge Trojans in the semifinals, and although these two haven’t faced each other, they have faced opponents that the Eagles can learn from.

The Trojans took down the Sheldon Huskies twice by a score of 9-1, 6-0

and the Cosumnes Oaks Wolfpack by a score of 8-0 earlier in the season.

“We haven’t played them this year or in a few years actually and they’re ranked No. 2 for a reason,” Cherry said. “We’ll be ready for them and bring our A game.”

Last year, the Eagles were the No. 1 seed and

were eliminated in the semifinals by the Inderkum Tigers to just miss out on taking on the Trojans in the section championship game.

The Eagles will travel to take on the Trojans at 5 p.m. May 20 to potentially move on to the section championship game for the first time since 2014.★



ELK GROVE, CA (MPG) - The Laguna Creek High School softball team capped its 2024 season with a second consecutive Metro League title, a school record and a nail-biter of a playoff game.

The Cardinals have a number of strong returners as they prepare to enter the Delta League next season.

They include Johnson, a junior, and sophomore Mia Gonzalez, who torched opposing pitchers this year, both hitting well over .400. Sophia Rials added power, knocking in 22 RBI. Freshmen Ella Lovato and Jaysa Crable also put up strong numbers this season.★

Herd Reach Section Championships

ELK GROVE, CA (MPG) - With their backs against the wall, the Elk Grove Thundering Herd held on to their section championship aspirations with an extra-inning 7-6 win over the No. 1 seed Whitney Wildcats at home on May 15.

The Herd came out of the gates swinging as they tacked on four runs in the first inning, totaling six runs by the end of the fourth.

“There’s a sense of urgency and we’re grinding for hits, so we were able to string some together early on and get some runs across,” said head coach of the Herd Joe Bellotti. “All we’re doing is getting to tomorrow with an opportunity.”

The first runs of the ball-game came off the bat of senior Ned Frutchey with a deep drive into center-field that bounced over the bounce for two RBIs on a ground-rule double.

The two other runs of the first inning came on a triple from senior Troy Taylor to give his team the 4-0 lead and a chance to even the three-game series.

It seemed that the Herd

was going to cruise to a win to force a game three and even the series at 1-1 as ace Herd pitcher Russell Pettis was dominating.

At the end of the fourth inning, Pettis had gotten outs through soft contact, whether groundouts or fly-outs with no danger from the Wildcats offense.

It wasn’t until the fifth inning that the Wildcats got on the board with a home run against Pettis.

In the sixth inning, the Wildcats’ lineup batted around for a total of five runs to tie the game at 6-6.

Pettis, an ace for this Herd pitching staff, would go 5.2 innings pitched while allowing nine hits and six earned runs, which led to the 6-6 tie in the sixth inning.

“I didn’t think he had his best stuff, but him battling and competing for us gave us all the opportunity we needed, and for him to eat up all those innings in a game like this where we didn’t have to kill the bullpen it was big,” Bellotti said.

Sophomore Tristen Bartlett came in during the sixth to stop the bleeding, as this could’ve spelled out the ending of the Herd’s season.

Bartlett got a strikeout to hold off the Wildcats and would go on to pitch 2.1 innings while allowing two hits and no runs with two strikeouts.

“He’s (Bartlett) has been doing this for us all year as a late-inning guy, and he’s a guy who likes the ball in his hand, and it wasn’t always pretty but he competes and when you compete and give us a shot that’s all we can really ask for,” Bellotti said.

In the bottom of the eighth inning with one out, a double from sophomore Anthony Bascherini was

followed by an out, which led to two intentional walks back to back to load the bases.

“We got a big at-bat from Bascherini hitting that double to start that inning to put pressure on them to make some decisions, then Ned (Frutchey) had the good at-bat to finish it off,” Bellotti said.

The walk-off hero for the Herd was Frutchey, who drew the walk to win the game, which was met with a mild celebration but they knew they had another game to win.

“We’re battling, it’s the

end of the year and we got guys banged up, but guys are giving it their all and that’s all we can do,” Bellotti said. “We knew it wasn’t going to be easy and obviously we made it kind of harder on ourselves.”

Bellotti praises his team for making plays when they needed to because he said there were many instances where his team couldn’t have rolled over.


“We’re one game away from a section title game, we know where we’re at, we know we need to pull out all the stops and

obviously we know they aren’t going to roll over and give it to us, especially at their place,” Bellotti said.

In an elimination game the next day, the Herd came from behind a 4-1 deficit in the fifth inning to tie up the game, which led to a run in the sixth and two runs in the seventh for a 7-4 win.

The Herd will play in the section championship game for the first time since 2017 against the Granite Bay Grizzlies at 6 p.m. Friday at Sacramento City College. ★

Three Hornets Collect WAC Honors

SACRAMENTO, CA (MPG) - Senior Gunner Gouldsmith and sophomore JP Smith were each named to the All-Western Athletic Conference second team, while Gouldsmith and junior Tyler White earned spots on the league’s inaugural all-defensive team, as the conference office announced its postseason honor roll as selected May 20 by the head coaches.

For Smith, it marks the sophomore’s second All-WAC honor of his career after he was named to the all-league first team in 2023, while Gouldsmith earned his first career All-WAC award. Meanwhile, Gouldsmith and White were two of the 10 players from around the conference named to the league’s defensive squad.

Entering postseason play with a team-high .324 average and a career-high 78 hits, Gouldsmith is riding a 10-game hitting streak heading into this week’s tournament while batting .476 (20-for-42) with seven runs scored and 12 RBI during his most recent run. The Reno, Nev., native has hit safely in 22 of his last 24 games — and has reached base safely in each of his last 14 — having gone without a hit in a game only eight times while starting all 56 games this year.



JP Smith was selected to the All-WAC second team.

Gouldsmith leads the team with 20 multi-hit games on the season, including a trio of three-hit games, a pair of four-hit contests, and a 5-for-5 effort against Stephen F. Austin on May 11 that ranks tied for third on the school’s single-game list. He also has nine multi-RBI contests on the year, a total that ranks third on the team.

The senior shined even brighter in conference play, batting .354 in 30 WAC contests with 19 runs scored, five doubles, and three home runs, while driving in 18 runs. He slugged .480 in league play while posting a .420 on-base percentage.

Smith comes into the tournament equally as hot, collecting hits in nine of his last 10 games while batting .325 (13-for-40) in that span. Providing the pop at the plate for the Hornets, Smith slugged 20 home runs (good for second in the WAC) to his season stat line to go along with a team-high 44 RBI, standing second on both the school single-season and career lists as his 34 career home runs rank just one shy of the career mark.

The Sacramento native slugged a team-high .583 on the season (good for eighth in the WAC), while also ranking tied for eighth in the league in runs scored (45) and 12th in RBI (44). His 15 multi-hit games rank tied for second on the team

— which also includes a team-high six multi-home run games — while his 14 multi-RBI outings lead Sacramento State heading into tournament play.

White, who enters the tournament batting .280 with 31 runs scored, six doubles, a pair of home runs and 24 RBI, has been perfect as Sacramento State’s centerfielder, having not committed an error in 113 chances. Gouldsmith, meanwhile, has been an integral part of the Hornets’ up-the-middle defense, having a hand in 31 of the team’s 43 double plays turned.

The Hornets open WAC Tournament play on Tuesday (May 21) at 4 p.m., taking on No. 5-seeded Tarleton State in an elimination game. The winner advances to face No. 4 California Baptist as the double-elimination portion of the tournament begins on Wednesday (May 22), also at 4 p.m.

All games of the tournament will be streamed live via the ESPN+ platform. Links to follow along for every Sacramento State contest will be posted on the baseball schedule page at HornetSports.com when they become available.
