Making the Sale at Livestock Auction

ELK GROVE, CA (MPG) - Months of hard work for Elk Grove agriculture students paid off on May 26 as they sold hand-raised livestock at the Sacramento County Fair Junior Livestock Auction.

The auction buildings at Cal Expo were abuzz with activity on auction day, as exhibitors prepared their animals for their moment

in the spotlight, spectators and bidders milled around for a good view of the auction ring, and auctioneers pattered through hundreds of entries from across the region.

Local students whose animals were named supreme champion in their category were Elk Grove FFA's Julia Bacon with a rabbit meat pen and Kris Johnson with a market turkey; Pleasant Grove FFA's Braedyn Brown with a market steer, and Robert Goldthorpe with a chicken meat pen; Bradshaw 4-H's Emree Lauer with market eggs; and Franklin 4-H's Lauren Tadman with a market hog.

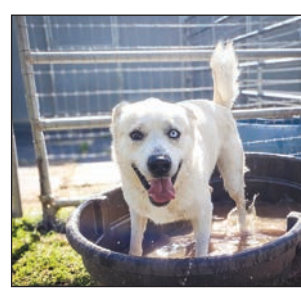
Dozens of other local students were also recognized for the quality of their livestock.

Additionally, Joy Stewart of Pleasant Grove FFA and Hailey Borges

of Sheldon 4-H won belt buckles for demonstrating their livestock knowledge in the Purple Circle Sweepstakes.

Among the bidders was Sacramento County Supervisor Pat Hume, who said he planned to bid on several lambs and goats. He selects students based on letters that some send him before the auction, as well as by checking with local FFAs and 4-Hs

Evacuate Pets to Sheltering Annex

SACRAMENTO COUNTY, CA (MPG) - When it comes to evacuations, the public needs to remember the five "Ps" before they leave: People and Pets, Prescriptions, Papers, Personal Needs and Priceless Items.

In some cases, Pets (and livestock) can pose a unique challenge during evacuations. Sacramento County is addressing this issue.

In December, the Sacramento County Board of Supervisors adopted an Agricultural Pass program to facilitate the coordinated re-entry of commercial agricultural producers to care for their animals.

The Board of Supervisors has now introduced additional guidance for safeguarding evacuated animals. During its May 21 meeting, the supervisors approved the Sacramento County Animal Sheltering Annex, which outlines new protocols for protecting pets and livestock during evacuations.

The Annex's development was driven by the necessity that arose from previous disasters in Sacramento County and aligned with new legislation. During the 2023 flood event, area farms reported more than \$38 million in losses, including losses of animals that could not be evacuated.

The Annex was a collaborative effort involving government officials and various agencies. It outlines the roles of entities such as the county agricultural commissioner, law enforcement, public health and the Office of Emergency Services in protecting or evacuating family pets and livestock.

With the support of partners such as the American Red Cross in coordinating shelter spaces that can accommodate animals and the appointment of an animal coordinator for the Emergency Operations Center (EOC), the plan aims to ensure that necessary measures are taken to address the needs of displaced animals. ★

ELK GROVE, CA (MPG) - Big Truck Day rolled into Elk Grove once again on May 12, delighting children and families, and this time with even more trucks.

"We're bigger than we've ever been before," said organizer Sean

Gallagher, Elk Grove's deputy public works director.

Besides longtime attendees such as trash collector Republic Services and Sacramento Area Sewer District, the annual showcase of the Elk Grove area's working trucks included several newcomers: Sacramento County Water Agency, Elk Grove Water District, Odyssey Landscaping and

 popular vehicles, and children honked the horns of the trucks while parents took pictures of their kids at the steering wheels. Some vehicles, like an Elk Grove Transit Services bus, offered tours, and others had activities for kids to try and souvenirs to take home. A bucket truck and a crane truck towered over the scene.

The crane truck belonged to West Coast Arborists, which uses the vehicle to remove trees in places where felling them would be unsafe.

The crane can lift up to 28 tons, allowing the company to recover large pieces of timber for its Street Tree Revival program.

"We take our wood and repurpose it," said Sacramento Valley Area Manager James Speck, pointing to Taylor Guitars. "Their No. 1 selling guitar is from our ash that we cut down in the urban forest, so we try to reuse everything we can, and the key is taking the logs out whole and keeping them big and usable."

Cody Smart of Applied Landscaping Materials showed the truck that

hauls and dispenses the company's main product, bark chips for landscaping. Smart said the truck has a mechanism that pushes the bark toward a hose, allowing it to be distributed, and the truck can cover a bit more than half a football field in an hour.

Applied Landscaping maintains amenities such as cityscapes and school playgrounds. Smart highlighted the truck's playground work for passing children.

"All those kids play in the playground, so it's something easy they can relate to," Smart said. "So we're just trying to keep them safe and have fun because ... some of the kids will take the bark home with them, whether it's in their shoes or with them, so we have to fill it (the playground) up to make sure it's compliant."

Sacramento Area Sewer District brought in a large vehicle that was designed to support a much smaller one. Sized to fit inside a pipe, the sewer district's inspection robot is equipped with lights and a camera to show an operator the state of a pipeline. The big truck holds the robot's equipment and a

display of the camera feed. For Big Truck Day, children could drive the robot through a section of pipe, finding stickers hidden inside and a wayward rubber duck.

"They're learning that it takes special types of tools to help us get our job done, and these robotic cameras are definitely one of those tools that help prevent a lot of bad things from happening in the sewer pipes," sewer district spokesperson LeeAnn Salerno said.

Gallagher, the city's deputy public works director, was partial to the city's vacuum truck, which helps prevent rainy weather from causing floods.

"We use it for storm drain cleaning, which is really important during our winter season, to make sure our system's working to perfection if we can make it that way,"

Gallagher said, "but it helps clean the pipes and keep the roads clear of water."

Gallagher said the event helps guests understand

the work of the people who keep Elk Grove running.

"A lot of these vendors and agencies work 24/7 to service the people of Elk

Grove, so we just want to showcase what they do and the equipment, and really help people learn about what public works is," Gallagher said. ★

to learn which students might need some financial help.

"I like to support these programs because it teaches kids responsibility and character and, hopefully, a little bit about agriculture so they see the value in putting food on our plates," Hume said.

The Citizen spoke to students who raised steer, some of whom talked about how an animal's personality can change the difficulty of their project.

Abigail Ritchie of Pleasant Grove FFA was happy in the morning to see that her steer was where she left him the night before.

"Sometimes, steers escape during tie-out so it was nice that he was where he's supposed to be," Ritchie

said. "But he's been walking good. He hasn't had any tantrums today. My last year's steer dragged me around after the auction, so I'm excited that didn't happen this year."

Ritchie highlighted the 1,240-pound steer's recognition as reserve champion in the angus division because it was a ranch calf, not bred for show quality.

From Elk Grove FFA, Brianna Kneppel's 1,369-pound steer earned her FFA reserve grand champion, among the best in species at the fair. Although she received a higher rank last year, grand champion, Kneppel said the latest distinction was "such an accomplishment" because of how much work she needed to put in.

"This year, I worked especially hard because I started off with a

really rough steer. He was not the nicest, and I definitely put time and dedication into this steer," Kneppel said. "This year, I struggled with him not wanting to walk or being aggressive, such as trying to head-butt me or charge at me."

Kneppel said she deals with bad behavior by taking a moment to breathe, exercise patience and reduce stress. She looked forward to getting a new steer to raise around October.

Animal husbandry immediately hooked Kneppel when she started raising sheep with 4-H at age 9. She hoped to pursue the field after high school and eventually "raise a whole herd of show cattle that I can pass down to younger generations so that others, too, can fulfill their show needs." ★

SACRAMENTO, CA (MPG) - Applications for the Fall 2024 semester at Sacramento State far surpass applications for the previous year, suggesting a potentially significant boost in attendance.

Sac State's campaign, "The Way of the Hornet," is meant to increase University visibility in the region through use of social media, the Sac State website, posters, billboards and advertising on public transportation, and a significant presence at Sacramento International Airport. That campaign will expand in the fall. ★

1. The Board hereby proposes to continue to levy the Assessment Districts benefit assessments pursuant to the Act and Article XIIID of the California Constitution. The Board appoints SCI Consulting Group as the Engineer of Work and directs SCI Consulting Group to perform the professional services necessary to levy the benefit assessments for fiscal year 2024-2025.
2. SCI Consulting Group, the Engineer of Work, has prepared Engineer's Reports in accordance with Article XIIID of the California Constitution and the Act ("Reports"). The Reports have been made, filed with the Secretary of the Board and duly considered by the Board and are hereby deemed sufficient and preliminarily approved. The Reports shall stand as the Engineer's Reports for all subsequent proceedings under and pursuant to the foregoing resolution.
3. It is the intention of this Board to levy and collect assessments within the Assessment Districts for fiscal year 2024-2025. Within the Assessment Districts, the existing and proposed improvements (the "Improvements") are generally described as the: installation, maintenance and servicing of public recreational facilities and improvements, including, but not limited to, turf and play areas, playground equipment, hard court surfaces, ground cover, shrubs and trees, irrigation and sprinkler systems, landscaping, park grounds and facilities, drainage systems, lighting, fencing, entry monuments, hardcourt recreation areas, landscape corridors, trails, other recreational facilities, graffiti removal and repainting, and labor, materials, supplies, utilities and equipment, as applicable, at each of the locations owned, operated or maintained within the boundaries of the Assessment Districts that participates with the Cosumnes Community Services District in any of the installation, maintenance and servicing described herein. 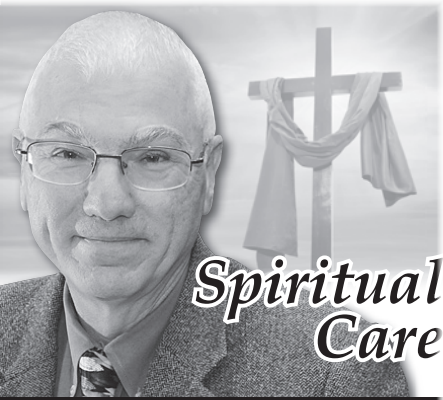

Four Chaplains, One Faith

Readers: I'm on vacation this week, so I'm retelling a Memorial Day story I wrote five years ago.

Today, I'm on the Zuiderdam, a Holland America cruise ship, sailing the Baltic Sea enjoying some amazing food and fun entertainment.

But sailing in such luxury over Memorial Day gives me a pang of guilt. I can't help but wonder how sparse it was for the men and women of our armed forces who boarded troop ships bound for war.

I can't help but wonder what it was like for the "Four Chaplains" of World War II.

Their story begins in 1943 on board the USS Dorchester, a 5,649-ton luxury liner converted into a U.S. Army troopship. Heavy with more than 900 men, the ship fell behind its escort off the Greenland coast.

Gale-force winds made for a nauseating voyage, according to later reports. Fortunately, among those doing their best to alleviate the discomfort were

four chaplains: Father John Washington, the Rev. Clark Poling, Rabbi Alexander Goode and the Rev. George Fox.

Like a lot of chaplains on ships, they pulled double duty as activity directors. They organized sing-alongs and talent shows, but mostly they took confessions and held worship services, no matter what their faith.

On the evening of Feb. 2, 1943, the ship's captain, concerned over the sightings of three enemy submarines, instructed passengers to wear life jackets to bed. Deep in the ship, the engine heat and overwhelming claustrophobia made it too uncomfortable for those sleeping in the lower decks to follow the order.

On Feb. 3 at 12:55 a.m., as the Dorchester approached Greenland, a German periscope sliced through the icy Atlantic waters. An officer aboard the submarine U-223 gave orders to fire a fan of three torpedoes. One decisive hit on the Dorchester's starboard side below the water line killed scores in a searing flash of flames.

Troops, some dressed only in their underwear, clambered on deck. Among them were the four chaplains: two Protestant pastors, a Catholic priest and a Jewish rabbi. Survivors would later recall these men of faith seeking to calm the passengers and organize them into lifeboats.

When the chaplains saw many were without life vests, they dug around and found extras to give to the men. They

instructed the soldiers to pray as they abandoned their ship and imbued them with courage to remain steadfast in their purpose.

Eventually, the chaplains discovered that there just weren't enough life jackets. With the supply depleted, each chaplain removed his own vest and gave it to another man.

The following information comes from the vantage point of those who made it into the lifeboats.

"I could hear men crying, pleading, praying," a soldier named William B. Bednar recalled. "I could also hear the chaplains preaching courage. Their voices were the only thing that kept me going."

It is said that in the light of the fiery oil, the chaplains were seen standing arm in arm on the ship's deck, leading an inter-faith service.

Eighteen minutes after the torpedo hit, the Dorchester rolled into the Labrador Sea on its starboard side.

In the most published quote of the tragedy, survivor John Ladd called the chaplains' steadfastness as "the finest thing I have seen or hope to see this side of heaven."

It would be the third largest U.S. maritime loss during World War II: 672 men died on the Dorchester, most from hypothermia. Only 230 men saw the sun rise in Greenland.

A Memorial Day eulogy 60 years later repeated the sentiment when it recalled the

chaplains' act as "Despair caught in hope's grasp. Four chaplains. Two faiths. One God."

The nephew of Chaplain Fox, David Fox-Benton, urges us to "Remember, this was 1943. Protestants didn't talk to Catholics back then, let alone either of them talk to a Jew."

The chaplains were never eligible for the Medal of Honor since they were never under "direct fire." Therefore, Congress created a special medal in 1960 that praised the chaplains for their "selfless acts of courage, compassion and faith." The award was called the "Chaplain's Medal for Heroism," and it can never be awarded again.

I expect to come home next month on a commercial airline. But to those who never made it home from war, let us pledge to never forget.

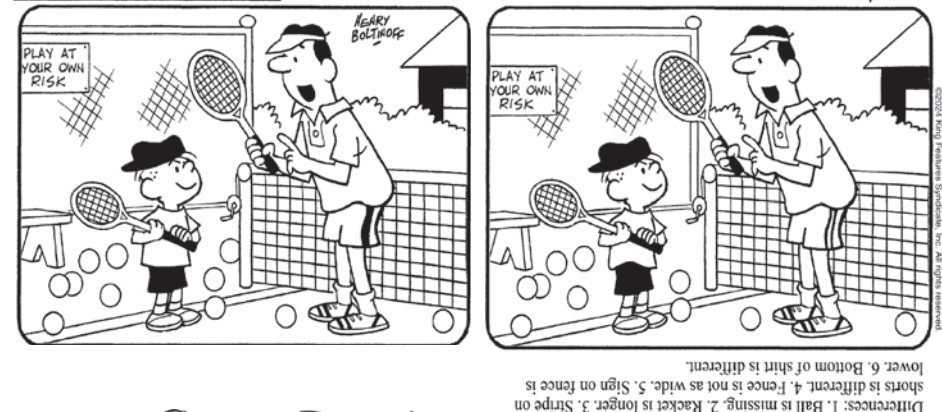

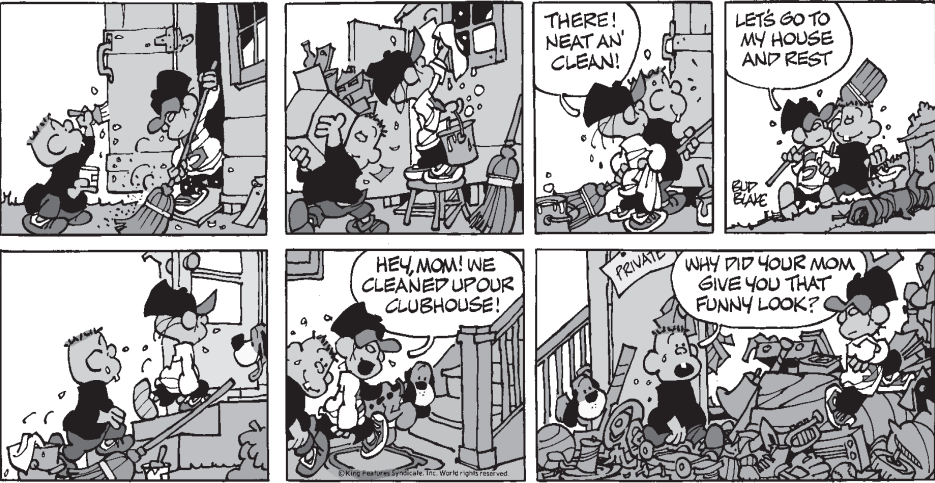

SACRAMENTO COUNTY, CA (MPG) - County partner and homeless service provider, First Step Communities held its 2nd Community Health Fair on Friday, April 26. The fair was a huge success with more than 250 attendees, 54 community vendors and hundreds of services provided.

The River District and the Willow Clinic were also partners in presenting the Health Fair.

The fair included service providers connecting attendees to animal care, medical care, dental care, haircuts, fresh food, benefit assistance, mental health screenings, showers, vaccinations, substance abuse treatment, domestic violence resources and more.

Several Sacramento County departments participated in the fair, connecting directly with their clients and potential clients, providing much needed education and access to critical County services.

Public Health Division

Sexual Health Promotion Unit: The sexual health promotion unit provides testing for HIV and education and safety supplies to prevent the spread of sexually transmitted diseases like HIV, Syphilis and Hepatitis C. Attendees could leave with educational materials and condoms.

Immunization Assistance Program: The Public Health COVID-19 strike team provides vaccinations to both adults and children for COVID-19 and influenza. Children as young as six months old can be vaccinated by the strike team.

Wellness Without Walls Mobile Medicine Van: provides easy, accessible care such as refilling prescriptions, rapid STD testing, minor wound care, basic physical exams, and vital statistic checks such as blood pressure and glucose levels.

Division of Behavioral Health

Homeless Engagement and Response Team (HEART): HEART staff was

offering on the spot mental health assessments to create linkages to more in-depth behavioral health resources. HEART has both medical clinicians and peer specialists that have relatable lived experience to share with clients.

Substance Use Prevention and Treatment: The alcohol and drug team handed out free Narcan to attendees to help prevent the dangers of an opioid overdose.

Anyone can use or administer Narcan safely while they wait for first responders to arrive. The team also provided a resource list for Countywide treatment services.

Probation Department

Probation officers provided an easy and accessible access point for probation clients to check-in with their probation officer. The team also provided general education on the probation system and the work they do, and how clients can

positively interface with the justice system.

Department of Human Assistance (DHA)

DHA provided information about benefit assistance and eligibility – such as cash assistance, food benefits and general assistance. Residents can check their eligibility for benefits online or by visiting a DHA field office. DHA is also hiring for several entry level positions and gave out job flyers to people looking for work.

Serving the complex needs of the County's unhoused residents requires multi-agency collaboration.

The Community Health Fair is a great example of bringing critical resources together in one place that is easy to access for the people that need them the most. This opportunity also allowed service providers to meet each other and further the community collaboration needed to have a lasting impact on homelessness. ★

Cosumnes Oaks' McFarland Takes State Title in Hurdles

ELK GROVE, CA (MPG) - The 104 annual CIF State Track and Field Championships took place on May 24 and 25 at Veterans Memorial Stadium at Buchanan High School in Clovis.

Many local athletes competed, with one particular athlete from Cosumnes Oaks bringing home the gold at the state championship.

In the 110m Hurdles (39"), Myles McFarland, the senior of Cosumnes Oaks, also took first place with a personal record mark of 13.69 to become

the first area runner to win the state title in this competition since 1936.

"I just want to thank God to be able to come here for this performance," McFarland said in an interview for MileSplit CA. "It's an amazing feeling and I believed I could win so I went out there and proved to everybody else that I was the better guy today."

Last year in the state finals, McFarland said he was disqualified so it was amazing for him to come back and handle business.

The San Jose State commit for track and field said it means a lot

for him to be the big competition for other runners at a place like the State Championships.

"It means a lot to have that target on my back, but I was made to deal with these things and through all the tribulations and trials and I always find a way to be that guy," he said.

McFarland ends his high school career as state champion and to emphasize that, he said on his best day he cannot be beaten.

Also for Cosumnes Oaks in the long jump, freshman Tatiana Youngblood placed eighth with a mark of 18-04.50. ★

ELK GROVE, CA (MPG) - The other local teams in action last week on the diamond in postseason play included the Elk Grove Thundering Herd and Pleasant Grove Eagles in softball, while the Bradshaw Christian Pride competed for their section title.

Bradshaw Christian Pride (Baseball)

The No. 1 seed with an overall 28-1 record heading into the Division V CIF Sac-Joaquin Section Championship, Bradshaw Christian Pride took down the Sutter Huskies by a score of 8-3.

The Pride clinched their seventh section title in the program's history on May 22 at Islanders Park in Lathrop.

One of the captains on this Pride team, Stanford commit David Wiser, started on the mound. He pitched a complete game while allowing four hits, surrendering three runs with only two being earned and six strikeouts, according to MaxPreps.

Offensively the Pride were led by Jake Johnson, who went 1-3 with a triple for two RBIs, while Micah Nicholson, Alex Crosno, Brandon Burden and Landon Carter each drove in a run, according to

For head coach of the Pride, Drew Rickert, this is his sixth section title with the baseball program. He also won five section titles for the Pride's football program.

The Pride got back to the section title after coming up just short last year and will go on to play the Branson Bulls from Ross at home in the first round of the Division IV CIF NorCal Baseball Championship.

Pleasant Grove Eagles (Softball)

The No. 3 seed Pleasant Grove Eagles faced off against the No. 2 seed Oak Ridge Trojans as they looked to reach the Division I CIF Sac-Joaquin Section Championship game for the first time since 2014.

Ultimately they came up short in extra innings with a score of 3-2 in favor of the Trojans on May 20 at their home diamond in El Dorado Hills.

Eagles ace Madeline Lawson started, although after the quarterfinal matchup, Eagles head coach Brian Cherry said she was dealing with tendinitis and soreness.

Despite that, Lawson would pitch 7.1 innings while allowing five hits, three runs with one earned and nine strikeouts, according to MaxPreps.

The Trojans got out to an early lead in the first inning, but the Eagles managed to tie the game in the

top of the sixth by a score of 2-2, later getting walked off in the eighth inning, according to MaxPreps.

The Eagles hadn't given up a run throughout their playoff run until this game.

Offensively, the Eagles were able to push runs across thanks to a home run from Madeline Lawson to help her own cause and an RBI double from Natalie Brozaitis, according to MaxPreps.

The Eagles' season was ended by the eventual

section champions and ended with an overall record of 19-4 and Delta League champions with a 10-2 record.

Elk Grove Thundering Herd (Softball)

As for the Division II CIF Sac-Joaquin Section semifinals, the No. 3 seed Elk Grove Thundering Herd faced the No. 7 Rocklin Thunder, hoping to reach their first section title since 2010.

The Herd will have to continue waiting for that championship as they fell by a score of 6-4 to the eventual champions at their home diamond on May 21.

The Thunder came out swinging as they tacked on three runs in the first inning on starting pitcher Madison Carda.

Carda would go on to pitch 2.2 innings while allowing six hits and five runs. She was relieved by freshman Kaylee Buck in the third inning, who would go on to pitch 4.1 innings while allowing six hits but only one run.

The four runs for the Herd were pushed across by Loie Moore, Angelina Barros, Katelyn Maciel and Annabele Focht.

The Herd end with an overall record of 18-11 and as the runners-up in the Delta League with a record of 8-4. ★

Herd Lose Championship in Extra Innings

ELK GROVE, CA (MPG) - In the bottom of the eleventh inning with the Division II Sac-Joaquin Section Championship on the line, the Elk Grove Thundering Herd was ready to send it to the twelfth inning against the Granite Bay Grizzlies.

The reason being, they had Russell Pettis on the mound under the bright lights of Sacramento City College in a tie game at 3-3.

Pettis had starred all season alongside the other starting pitcher in the Herd rotation, Ned Frutchet, who also started the championship game.

A runner ended up on third base due to a leadoff walk, followed by a sacrifice bunt then a groundout to second base to allow the runner to advance.

With two strikes, Pettis seemed he was going to get out of this inning. The previous inning, Pettis got out of a bases-loaded jam to keep the game alive.

The unexpected happened when Pettis tried to get the Grizzlies' batter to go fishing on a pitch outside that was bounced. The Herd's catcher, Evan Gentil, did everything he could to throw his body in front of the pitch.

The pitch went to the backstop and Gentil rushed back to get a throw to home plate to get an out

and preserve the tie game.

Pettis was there at the plate as the runner came running down the line. It was a perfect feed to make it a bang-bang play.

The runner got his hand in as Pettis tagged the runner high on his chest with the umpire not hesitating and calling the runner safe.

The Elk Grove Thundering Herd lost the Section Championship on a walk-off wild pitch by a score of 4-3 to the Granite Bay Grizzlies, allowing them to clinch their third consecutive section title.

"It's tough; it was a dog-fight game," Herd head coach Joe Bellotti said. "It didn't go our way and that play at the plate is tough. It's bang-bang and that's just how it went."

Before heading into extras, this game began with Frutchet for the Herd on the mound with his counterpart being Texas A&M commit Chase Bentley for the Grizzlies.

Frutchet was met by a rude awakening in the bottom of the first inning with Bentley helping his own cause with a towering two-run homerun to get the Grizzlies ahead 2-0.

After this, Frutchet would settle in to go on to pitch six innings while allowing two hits, two earned runs and six strikeouts.

On the offensive side, the Herd started off threatening as Bentley struggled

to find the zone with a walk and hit by a pitch to start off with Ethan and Chase Groves, but Bentley settled in to get out of it and pitch six innings.

Not without any hiccups, though, with the Herd pushing a run across to cut the deficit to 2-1 when Troy Taylor led off the inning with a walk then came across to score after an RBI double down the left-field line from Anthony Bascherini.

The Grizzlies would answer in the third inning to extend their lead to 3-1 until the sixth inning in Bentley's last inning on the mound.

Frutchet as the second batter of the sixth inning walked and came across to score on a two-out RBI triple from Taylor down the right field line to make it 3-2.

The next half-inning in the bottom of the sixth, Frutchet would retire the side in his last inning of work to give his team a chance in the top of the seventh.

Facing elimination, the leadoff hitter in the inning, Bascherini, would swing at the first pitch to give him a single, but it was hit sharply enough that it was misplayed by the Grizzlies center fielder to put the tying run in scoring position.

A sacrifice bunt from Tristen Bartlett advanced the pinch-runner for

Bascherini, Devin Mitchell, to third and brought Ethan Groves to the plate.

Ethan would hit a fly-ball into centerfield at a comfortable enough depth to allow himself to start celebrating down the line heading toward first as he brought Mitchell in to score to tie the championship game in the top of the seventh.

Pettis would come into the bottom of the seventh inning to strike out the side and send it to extra innings and would go on to pitch four shutout innings.

This wouldn't come without difficulties, though, with Pettis getting out of a bases-loaded jam with one out in the bottom of the tenth.

He struck out a Grizzly for the second out, then a dramatic lineout to right field had the Herd holding their breath and the Grizzlies celebrating, yet it ended up caught to send it to the eleventh.

The Herd also rallied but came up short when, in the top of the eleventh, Julian Arguello singled, followed by back-to-back errors from the Grizzlies defense to load the bases.

With no outs and the infield drawn in to try to get the force out at home plate, Gentil would hit a scorching line drive to first base that was met by a loud pop of the glove of the Grizzlies' first

baseman.

It was caught by Bentley, the starting pitcher, who was then moved to first base to play defense, and the batter who had the huge hit early on for the Grizzlies.

The worst part of it all for the Herd was Bentley turned around and stepped on first for the double play given the huge lead the runner on first took with the infield drawn in.

With two outs, the Herd couldn't capitalize to take the lead, and the following inning the Grizzlies walked it off to win the Section Championship.

"We were one swing away and it was going back and forth and as the game went on, I think the pressure can start building a little bit, but I think our guys did a great job of competing," Bellotti said.

Bellotti afterward praised the performances from both Frutchet and Pettis on the mound.

"Ned and Russ both pitched their butts off for us; they did great through

the adversity and they never blinked and found ways to get out of jams to give us a shot," Bellotti said.

The Herd hadn't reached this instance since 2017 in what was legendary coach Jeff Carlson's penultimate season at the helm. Bellotti was able to bring them back although they could not add to their 11 section titles.

"This is the goal of where you're always trying to end up and I thank the seniors for the work they put in and I think we'll have a good young group coming back," Bellotti said.

Despite the loss, the Herd will play in the CIF NorCal Baseball Championships as the No. 5 seed against the No. 4 seed Kingsburg Vikings.

"I can't say enough good things about this group of young men. You tip your hat off to Granite Bay; they did a great job but our guys battled their butts off," Bellotti said. ★
