'All of Them Are Heroes'

Galt Memorial Day Honors Two World War II Soldiers

GALT, CA (MPG) - The Galt-Arno Cemetery District highlighted two World War II veterans on May 27 at its annual Memorial Day observance.

The ceremony included remarks from multiple speakers, including cemetery district director Belinda Ellis and the Rev. Michael Dubé of Shepherd of the Valley Lutheran

Church. Galt Mayor Paul Sandhu said that Memorial Day "is a day to reflect on the importance of freedom and the values our soldiers fought and died for."

Sandhu added that service members' sacrifices should be remembered every day, not just on the last Monday in May.

One of the veterans to receive a tribute was Teodulo Fabiana. His daughter, Lucia Hearsom,

read an account of Fabiana's service in the Pacific theater of World War II. Hearsom said Fabiana traveled from the Philippines to the United States in 1939, at 23 years old. On Dec. 7, 1941, Japan attacked Pearl Harbor and hours later launched its invasion of the Philippines. Hearsom said Fabiana enlisted with the U.S. Army in Sacramento, in 1942.

Fabiana served in New

Guinea and the Philippines, and completed his service in 1945, receiving multiple decorations.

"My father loved this country. He participated in voting and spoke about it at length. I recall my father had me sing 'The Star-Spangled Banner' when I was a child at our residence," Hearsom said.

Fabiana died on Nov. 30, 1980, at age 74. He received a posthumous

GALT, CA (MPG) - The Sacramento County Fair buzzed with excitement as youngsters proudly paraded their livestock before eager onlookers on May 26. Among them were participants from two venerable organizations dedicated to shaping the leaders of tomorrow: 4-H and Future Farmers of America (FFA).

The Sacramento County Fair is all about mixing education with fun, a tradition the Sacramento County Fair Foundation (SCFF) is dedicated to preserve and enhance. The foundation's mission is to educate the youth and adults in Sacramento County about the significance of hands-on agriculture, helping them become more informed citizens, and support agricultural literacy.

"The Sacramento County Fair embodies a commitment to educating our community and its youth in agriculture, business, and technology," states organizers on the fair's website.

The Junior Livestock Auction, a highlight of the fair, gives 4-H and FFA members the chance to showcase their animals and hard work. It is an opportunity for these young participants to learn about entrepreneurship and responsibility while earning recognition for their efforts.

4-H is a nationwide organization focused on empowering youth aged 5 to 18 with practical skills and leadership opportunities. Through direct projects in areas such as agriculture, science and civic engagement, younger children and teens learn valuable lessons while having fun. The four H's—Head, Heart, Hands, and Health—serve as guiding principles, shaping the character and values of its members.

FFA, or Future Farmers of America, is all about preparing young students from seventh-grade until

graduation, for success in agriculture and beyond. Members gain firsthand experience, develop leadership skills and explore career opportunities in fields such as farming, science and business.

Colby Otto, 9 and an Arcohe Elementary School third-grader, achieved notable success in the Herald 4-H program. He earned the title of Reserve Champion in the Heavyweight Market Goat category and placed sixth in the Novice Showmanship.

"I was nervous to show my wether but liked showing my doe, Fern in both showmanship and the breeding show," said Colby Otto about his experience at the county fair. "Fern is going to become a mama and I'm excited to hopefully show a goat that I raised myself next year at the county fair."

His sister, Paige Otto, 11 and an Arcohe Elementary fifth-grader, also showed exceptional achievements within the Herald 4-H program. She attained the prestigious titles of Supreme Champion in both Market Lamb and Ewe categories, along with Reserve Supreme Champion in the Ram category and recognition as the Champion 4-H Junior Showman.

"I have wanted to show sheep for as long as I can remember. This is my second year with the Herald 4-H, and I have truly enjoyed learning more about raising and showing livestock," said Paige.

"I have dedicated a lot of time to attending livestock camps and receiving coaching from supportive mentors who help me achieve my goals. I want to keep improving as a showman and sheep breeder. One day, I hope to compete in major shows like those in Arizona, Louisville, or Denver."

Their 12-year-old brother, Caleb Otto, also participated at the county fair with the Herald 4-H program.

He secured the title of Reserve Champion in the Light Cross Market Hog category and earned the esteemed designation of Supreme Champion Boar. Caleb also showcased his skills by ranking 10th in the 4-H Junior showmanship.

"I enjoy showing pigs with my friends at the county fair. I also enjoy

showing pigs we've raised as a family, feeding and watching them grow since they were weaned," he said.

Sadie Smith, another fair participant, shared her experience with the program and raising livestock.

"My favorite part of my project was giving Patches a bath," said Sadie about the pig she raised for the county fair. "I have learned so many lessons, 4-H has helped me learn how to speak in public and learn the basics of farm business. It is a lot of work but I have enjoyed it very much."

Caedence Xiong, a sophomore in Sheldon High's FFA program, raised a marked lamb for the Sacramento County Fair and recounts her involvement with the program, what she has learned and what she enjoys most.

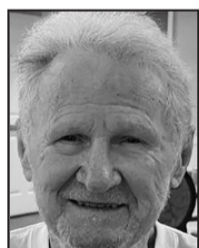
As another year of the

GALT, CA (MPG) - Triple Crown Car Wash held a ribbon-cutting ceremony on May 31, with new management looking forward to becoming involved in the community.

Triple Crown is located at 604 Fairway Drive. Now under new management, it was formerly known as Big Sponge Car Wash. Triple Crown held its grand opening on June 1.

Besides express service

Congressional Gold Medal in 2016, with the passage of a law honoring the Filipino veterans of World War II. In 2024, he received the Medal of Honor.

"My father would be proud of all he has been awarded by the United States of America, in life and in death," Hearsom said. "I'm so proud of my father and so happy to be here today, honoring my father and all veterans. All of them are heroes. God bless America."

Mike C. Lopez's life and service in the Second World War were recounted by his great-grandson, Justin Moe. Born in Las Vegas in 1914, to two Mexican immigrants, Lopez helped raise his siblings and worked in agriculture and mining.

After the U.S. entered the war, Lopez was conscripted into the Army, leaving his pregnant wife as he began training, eventually becoming a combat engineer.

"According to surviving correspondence, Mike was an extremely gifted engineer in what he did due to his mining experience, not only being able to handle

any power tool but also skilled in explosives," Moe said.

Lopez served in operations in Sicily, southern Italy and southern France, before traveling north and eventually crossing the Rhine to attack the core of German industry.

Lopez died in 1989 from lung cancer.

"While Mike may not be

with us anymore, his legacy continues to live on, not only as a virtue of work ethic and service but also fostering an appreciation for those who served in uniform, both now and in the past," Moe said.

At the ceremony's conclusion, Moe participated

in a dove release.

Cosumnes Fire Chief Felipe Rodriguez spoke about those who lost their lives in military service. As a Navy reservist, he was deployed to Guantanamo Bay following the Sept. 11 attacks.

Rodriguez named three Galt service members killed in action: Marine Corps Lance Cpl. Rodney Martinez, Army Pfc. Charles Davis and Army Spc. Duane Paepke Jr., who died in 1967, 1968 and 1969, respectively, while serving in Vietnam.

Memorial Day "is a day to honor the valor and merit of the over 1.3 million young people who lost not only the life they were living but also lost the life they never had

the opportunity to live," Rodriguez said.

Chris Angle, a local veteran who works with the Department of Veterans Affairs, said Memorial Day is not about her but those who pledged to defend the country from "enemies both foreign and domestic" and fulfilled the promise with their lives.

"When they came to face the ultimate sacrifice, what was it that they were feeling? Was there a sense of fear? Was there a sense of unknown? Was there a sense of pride? I think they experienced all of it," Angle said.

These service members "gave it all so we could enjoy moments like this and that is what Memorial Day is about," he said. ★

Career-Prep Award Winner Lands Job at Ace

GALT, CA (MPG) - The 28th annual School to World award ceremony on May 22 gave disabled students an opportunity to celebrate their progress toward joining the workforce. Special recognition went to a student whose efforts led to a job offer.

Organized by Sacramento County Office of Education (SCOE) and Galt Joint Union High School District, the event featured 58 students in two of the organizations' programs: WorkAbility and Transition Partnership Program. The initiatives are designed to help students with disabilities transition from school into the workforce or postsecondary education.

"This morning, we gather to recognize you, students, for your effort and hard work," said Shawn O'Briant, a Sacramento County Office of Education vocational specialist. "From learning to search for jobs to writing resumes and filling out applications, you participated in mock interviews or supported interviews, and some of you, your first independent interview. And finally, you participated in and completed the work experience with one of our many local-area business

partners." O'Briant congratulated the students who received their first job; he noted that their job might change as their working life continues.

"Being willing to try new work (and) jobs and gain experience is an important part of job development. This trains us to develop skills that support growth and promotion or decision-making that leads to career advancement or change," O'Briant said.

He recognized the businesses and organizations who provide work opportunities: SETA Head Start, South County Services, Plush Puppy Dog Grooming, Hope for Horses, Nina's Flowers & Gifts, Estrellita Culinary Arts, Life's a Grind, Galt-Marian O. Lawrence Library, Denny's, CVS, Golden Living Center, Dry Creek Ranch Golf Course, Galt Market, Fifth Street

Salon and Ace Hardware of Galt.

O'Briant and Georgina Cantero, the district's Transition Partnership Program coordinator, called students forward one by one and gave each a certificate.

Afterward, O'Briant named the recipient of the School to World Award, Liberty Ranch High School student Dallas Weller, who has taken part in WorkAbility for three years.

The award recognizes a student who has shown perseverance in overcoming obstacles while also meeting their school requirements.

"He (Weller) is recognized by his teacher and school staff as an outstanding student. ... He's shown remarkable growth and commitment and has been a hard worker in each of his work experiences over the past few years,"

O'Briant said, announcing that Weller received a job offer from his latest work experience location, Ace Hardware.

Coming forward to speak, Weller expressed gratitude for his selection and he thanked administration, business owners and classmates for attending the ceremony.

"While working at Ace Hardware, I've learned about front-facing, stocking and how to communicate with customers. I have gained a lot of skills working and a lot of life lessons," Weller said.

Ace Hardware manager Adam Lawrence told the Herald it was "incredible" to see his future employee

win the School to World Award. He said the recognition speaks to Weller's progress since coming to Ace Hardware.

Lawrence said the Galt store participates in WorkAbility because he enjoys bringing out people's potential, and WorkAbility allows students to develop work skills such as stocking, product knowledge and customer service. He said confidence is the biggest benefit that students get from their Ace work experience.

"I get so many students that ... I may not get more than a couple of words out of them in an interview, but by the time we have an exit interview with them, they're telling me all about what they've experienced, both in the store and outside of the store," Lawrence said.

In his concluding remarks, O'Briant encouraged the students to "continue to work hard."

"Don't count on luck; make your own. Find your talents and pursue your interests and invest in yourselves," O'Briant said. "You're worth it. Work hard every day to reach your goals and do your best every day. If you do that, you won't need luck but we wish you the best of luck anyways." ★

NOTICE IS HEREBY GIVEN that on Tuesday, July 2, 2024, at the hour of 9am, or as soon thereafter as the matter may be heard, the Board of Directors of the Clay Water District, acting as a groundwater sustainability agency in the Cosumnes Subbasin, will hold a public meeting and hearing at 12901 Twin Cities Rd. Herald, CA 95638. In compliance with the Americans with Disabilities Act and in response to the COVID-19 pandemic, if you need special assistance to participate in this meeting or have concerns about attending the meeting in person, please contact Board Chair Gary Silva at (208) 481-4407 to make reasonable arrangements or for call-in information. The Board will consider the following matter:

Proposed modification of the existing groundwater sustainability fee established by RESOLUTION No. 2021.07.20.01 in 2021 (the "Groundwater Sustainability Fee") to fund the costs of a groundwater sustainability program in the Cosumnes Subbasin, including, but not limited to, the implementation of the Cosumnes Subbasin Groundwater Sustainability Plan, fund associated groundwater management activities, and meet the requirements of the Sustainable Groundwater Management Act.

The Clay Water District GSA proposes to levy the Groundwater Sustainability Fee under its authority granted by California Water Code section 10730 on all irrigated land within the Clay Water District GSA area within the Cosumnes Subbasin.

The Groundwater Sustainability Fee would be charged in the amount of \$10 per acre irrigated with groundwater with a base fee charge of \$35.59 per parcel for persons using groundwater.

The Clay Water District GSA will also impose a fee on de minimis users of water (less than 2-acre feet per year for domestic purposes, see Cal. Water Code sec. 10721 (e) only after the GSA unless the agency has regulated the users pursuant to this part. This Resolution modifies the previous fee to place a fee on de minimis extractors, residential, commercial, irrigated agriculture and public water system using groundwater.

In order to keep pace with inflationary costs of service in carrying out the Agency's purposes for which the Fees are collected, The Agency may apply an annual inflation increase. The initial Annual Adjustments can only be in place for 5-years after approval of this Resolution, but can be extended through further Board action in the future. Each Fee presented above, will be adjusted annually for inflationary increases in the cost of service based on a 12-month period, as measured by the U.S. Department of Labor, Bureau of Labor Statistics, Consumer Price Index for All Urban Consumers (CPI-U) West All Items (Series Id: CUUR0400SA0) for June through May of each respective year. The Annual Fee Adjustment will be limited to the lower of the actual cost of service increase, or the CPI-U increase, but will not less than zero.

Data upon which the proposed Groundwater Sustainability Fee is based may be obtained from the Clay Water District online at www.SloughhouseRCD.org on the Groundwater page. All interested persons are invited to present their views and comments on this matter.
