Launched in 2019, RydeFreeRT was the first unrestricted youth fare-free ride program in the country, according to Sacramento Regional Transit District. The 265,000 youth living in Sacramento Regional Transit District's service area, from transitional kindergarten to 12th-grade, including home-schooled students, foster and unhoused youth, can ride

The RydeFreeRT program has helped boost student ridership, which now accounts for nearly 25% of all Sacramento Regional Transit District bus and light rail rides over the last year. In fact, student ridership is on pace to carry 4.2 million youth in Fiscal Year 2024, double what it was in 2019 pre-pandemic. Note: The RydeFreeRT

program does not apply to those over 18 years old that

are pursuing their GED. ★

## **County Supports Housing for Veterans** and **Homeless**

SACRAMENTO COUNTY, CA (MPG) - On June 11, the Sacramento County Board of Supervisors approved the transfer of 2.2 acres of land and \$3 million in American Rescue Plan Act (ARPA) funding to the City of Rancho Cordova for the development of Mather Veterans Village Phase 4, located on the former Mather Air Force Base. This project will provide new affordable housing and services for homeless and disabled veterans and homeless families at very low incomes.

Mather Veterans Village is collaborative effort between Sacramento County, the City of Rancho Cordova, Mercy Housing California and Nation's Finest. This initiative builds upon the success of three previous phases, which serve more than 160 formerly homeless veteran households. Phase 4 will include a three-story building with 70 apartments, 58 one-bedroom units,12 two-bedroom units, a community building and parking for 45 cars.

Sacramento County has more than 75,000 veterans. The latest point in time count shows there are nearly 600 veterans currently homeless and more than 60% are unsheltered. The Mather Veterans Village Phase 4 project aligns with ongoing efforts to expand access to housing and supportive services within the county.

"This project is a significant step forward in providing much-needed support to our homeless and disabled veterans,' said Emily Halcon, director of Sacramento County's Department of Homeless Services and Housing. "We're proud to contribute land and create additional permanent supportive housing and affordable units for our veterans that are exiting homelessness." Said Fifth District County

Supervisor Pat Hume, "This collaboration shows our commitment to supporting those who have served our country and those who are in need. It's a hopeful sign of what we can achieve when we work together." The conveyance of the

land and allocation of American Rescue Plan Act funds to the City of Rancho Cordova is being coordinated by Sacramento County's Office of Economic Development and the Real Estate Division. ## Libraries to Provide Free Meals to Youth This Summer

SACRAMENTO, CA (MPG) -As another blisteringly hot summer unfolds, library officials make it a priority to provide support to youth while they are out of school and parents are working.

Fourteen public libraries throughout the area are offering free meals to local youth as needed throughout the summer.

Lunch at the Library provides free meals for young people when school is out for the summer. Starting June 18 through Aug. 9, meals will be distributed at 14 library locations Tuesdays through Fridays from noon to 1 p.m.

Lunch is available for youth 18 and under who are physically present for free. Meals must be consumed on-site. No registration is required. Drop-ins are welcome. Eligibility documentation is not required. Look for signage at the library or meeting room entrance.

"The Sacramento Public Library has been doing this since 2013," said Christie Hamm, youth services director.

"Libraries have stepped in to help kids whose families might be stressed. Our meals come with whole grains and fruits and vegetables. So, they get a good healthy meal, and we also help them get connected with our different summer reading programs," she continued. "It's a great time, and a friendly and welcoming place for them to come to."

According to Hamm, all are welcome to enjoy

the free lunches and there is no income requirement. The youth are encouraged to come to the library and engage in reading programs, computer and STEAM programs, book groups, and could even win prizes. The programming varies by library branch.


"Lunch is just the beginning of connecting people to other services the library provides," Hamm said.

The lunches are funded by the U.S. Department of Agriculture (USDA) and programs are funded by the California State

# Fighting Through Homelessness to Housing

SACRAMENTO COUNTY, CA (MPG) - Keri and Sandra look fondly at each other with a bond forged by two people who have shown up for each other during some hard times. Sandra went through other case managers but somehow when she met Keri, she knew that Keri would be the one to help her change her life.

"She loves her clients; you can just tell," Sandra said. "And she always tells the truth. I appreciate that."

Keri lowers her head in acknowledgment; it's true, she does love her clients. But she's quick to return the compliment: "Sandra always showed up. She always does the work. She is on it."

The mutual respect they have for one another might seem trivial but it isn't. Missed connections and opportunities are the top reasons folks don't get housed. Lost paperwork, lost phones, lost and broken relationships.

Keri is a Community Health Worker with Community Health Works (CoHeWo) - an outreach organization contracted by Sacramento County to do encampment outreach in the parkway, unincorporated county and with the multi-disciplinary teams in the City of Sacramento. CoHeWo outreach staff provide support and services ranging from helping to get an I.D. to rehousing, furnishing a new apartment or helping with a deposit. But more than anything, CoHeWo staff relentlessly show up with compassion and a drive to

make a difference in the

lives of their clients.

Sandra lost her job driving for Lyft at the start of the COVID-19 pandemic. After 20 years as a security guard, she decided to make a change to a job that allowed her to set her own hours and income, and also pay for an apartment and a steady rotation of leased cars. When the pandemic hit, Lyft fired her. She sued for wrongful termination but the case was tied up for years. Her income vanished. Her ability to pay for her apartment and car: gone. She lost her home and her car within a matter of months and had very little money to live on. Sandra spent a few weeks on her daughter's couch but the strained relationship wore out her welcome faster than expected.

Sandra bounced around between living in a tent on the river and near Township 9, living in the City Safe Ground, and eventually living in her car after winning her wrongful termination suit. She went through and graduated from several programs, including Salvation Army, Women's Empowerment and Mather Community Campus.

"Being homeless is a fight, every day," Sandra said. "People slashed my tent and stole my stuff. I try to keep to myself; I don't want trouble. It is dangerous out here as a woman alone."

One day, a border collie dog jumped into the back of her car. The dog refused to get out and had no collar. Sandra took her to the nearest vet to scan her for a chip. With no chip detected and a seemingly instant

bond, Sandra decided to

keep her and name her Lady. Sandra scheduled her for spay surgery but Lady got pregnant before that day came. Sandra was able to rehome all the puppies, except one: a spirited, split-nosed mix that stole her heart and captured the attention of everyone he met! Lucky became quite an attraction. His nasal cavities formed independently, creating a very unique look. When Keri took over

Sandra's case, Sandra knew that somehow, this community health worker was different. She would be the one to get her into housing. Keri and Sandra looked for places to get shelter but Sandra's situation proved difficult. Because of her two big dogs, Sandra's options were very limited. While some shelters now accept pets, pets have historically been a huge barrier to people getting shelter. Sacramento County has been working to change those restrictions with its Safe Stay shelter model that allows people to shelter, with their pets, in individual units. No one should have to choose ter and their pet.

between the safety of shel-Keri worked with Sandra for nearly six months

before she was able to helped me so much." get her a referral into the Wong Center, now known as Mutual Housing's project "The Boulevard." The Boulevard is an affordable housing project with 127 units, 50 of them funded by the Sacramento County Division of Behavioral Health to be used as Permanent Supportive Housing for clients exiting homelessness who also have behavioral health challenges. Applications can be extremely competitive, given the incredible need for affordable housing in the region.

Keri and Sandra worked tirelessly to get all the documents Sandra needed to qualify for her apartment: financial receipts, EBT documentation and chime receipts. She was able to get into the lottery system for a unit.

"Getting an affordable housing unit requires so much work. You have to jump through a lot of hoops. So many people don't want to do it but I was willing to. I did the work. That is why I got in. I met so many people out on the river who really just want winter housing. But I was desperate for permanent housing.'

On March 19, 2024, Sandra, Lady and Lucky moved into their brandnew apartment at The Boulevard. The County's contract with CoHeWo paid for furniture, towels, supplies to get her started.

a microwave and cleaning "I know I am lucky to be here but I also know I earned this," Sandra said. "I did the work I needed to do. I showed up. I checked in every week. I never gave

up. And I had Keri. She

Sandra is the supervisor of the Garden Club at the Boulevard. She is responsible for making sure the garden is watered and the children stay out of it. At night, she volunteers her time as their security guard. She hopes that she will one day have another paid job doing what she enjoys. Sandra loves to draw, paint and make jewelry. Making skull jewelry is her favorite design. Everyone loves Lady and Lucky. Lucky, with his bizarre nose, is a great conversation starter.

Sandra lives a pretty quiet life. While she gets along with everyone, she still spends most of her time alone with her dogs and stays out of trouble: "I recognize a lot of people here from out on the streets. I am always thinking like a security guard."

For now, Sandra can stay at The Boulevard but one of her main barriers to long-term housing is that she doesn't have any source of income. Focused on stabilizing her life, with a strong emphasis on her health, is her number one priority. Sandra has had various forms of cancer for more than 30 years. Sandra is a survivor but she knows the clock is ticking. Establishing a healthcare provider through CalAIM Enhanced Care Management (ECM) will get her the help she needs. Sandra's referral has been approved and she is just waiting for a primary care provider to be assigned.

"I'm positive God still has a plan for me," Sandra said. "I am not through yet."





SACRAMENTO, CA (MPG) -Sacramento's beloved K-ZAP, the all-volunteer LPFM rock/blues radio station broadcasting 24/7 at 93.3 FM in the metro Sacramento area, on the K-ZAP apps and streaming at k-zap.org, launched its "10 To Feed

## California Restaurants Now Want an Exemption from the State's New Hidden Fees Law

In "1984," George Orwell's novel about a dystopian future, he describes "newspeak," a propagandistic language of euphemisms and inversions used by officialdom to mask the reality of their meaning.

We got a dose of California-style newspeak last week when state Sen. Bill Dodd, a Napa Democrat, introduced Senate Bill 1524. It would exempt restaurants from his previous legislation, SB 478, which requires businesses to fully include extra fees in their prices, rather than tacking them on after services or goods have been delivered.

Dodd declared his proposed new legislation would "enhance consumer protection" for restaurant patrons by "clarifying state law" on how fees and other service charges should be disclosed.

"Restaurant customers shouldn't be surprised when they get their checks by a slew of extra charges they were not expecting," Dodd said. "Many restaurants are up-front with their business practices but too many aren't, necessitating action."

In fact, Dodd's original legislation, passed last year and due to take effect on July 1, was aimed at eliminating "a slew of extra charges" on restaurant bills and other consumer transactions. But SB 1524 would

reduce consumer protection by allowing restaurants to avoid full disclosure of their prices by burying the notices of extra fees within their menus, where customers are least likely to notice them.

The deceptive descriptions of Dodd's new legislation accompany assertions by bill sponsors in the restaurant industry and their unions that if surcharges are included in food prices, they would somehow lead to pay reductions.

"Cutting the pay of banquet servers and ballpark workers was never the intention of SB 478, as the bill's authors have made clear," said Mario Yedidia, western political director for UNITE HERE, a union that represents some food service workers.

"This will enable restaurants to continue to support increased pay equity and to make contributions to worker health care and other employee benefits," added Matthew Sutton, senior vice president of the California Restaurant Association.

There is absolutely nothing in the current law that prevents restaurants from raising their prices as much as they desire to increase their workers' pay and benefits. That's simply business as usual throughout the economy.

Nor is requiring restaurants and other businesses to list their full prices before consumers decide whether to make transactions such a novel idea.

Take, for instance, gasoline prices.

If you pay \$5 for a gallon of gas, it includes about \$1.50 in state and federal taxes and other surcharges. The full prices are displayed on signs and on the gas

pumps themselves. Gas stations cannot advertise fuel for \$3.50 and then tack on the extra fees and taxes after you've already filled your

Before you buy a house and take on a mortgage, state law requires you to be informed of transaction fees before signing the final papers. Same applies for buying a new car.

When SB 478 was going through the Legislature last year, somehow those in the restaurant business assumed that it would not compel them to list full prices in their menus, even though there was nothing in the bill itself to support that assumption.

Uncertainty about SB 478's effect on restaurants led Attorney General Rob Bonta to declare recently that they would be subject to the new law, generating a strong backlash from those in the industry and pressure on Dodd and other legislators to grant an exemption.

We shouldn't be fooled by the newspeak descriptions of SB 1524. It does not "enhance consumer protection." It would purposely undermine consumer protection by allowing restaurants to resume their bait-andswitch tactics - giving patrons menu prices that don't fully reflect what their final bills will be.

There's Nothing Passive About Real Estate

Dear Dave,

We sold our rental property recently. When we bought it, we thought it would be a good source of passive income. But owning it wasn't passive at all. It got to the point where the work and hassle became too much. We have \$240,000 from the sale, and we're debt-free except for our home. We owe \$140,000 on our house, and could pay it off instantly, but part of me wants to invest the proceeds from the sale of the rental property. Is it better to become completely debt-free at this point, or should we invest it so we can have even more money for retirement?

Dear Anthony

You mean you had to actively manage your rental property? Listen, anyone who tells you real estate is passive income is full of crap. It's a natural extension of the garbage people spout about how it's okay to go into debt to buy real estate, **Dave Ramsey Says** 

because the renter is making your payments. No, it's your payment. And when the renter doesn't pay, or it sits empty, guess what? You have to pay it.

If you want passive income, buy an S&P 500 index fund. Set it and forget it. You won't have to fix a leaky roof, replace worn out appliances or try to collect from deadbeat tenants. Real estate is a great way to invest, if you do it the right way. I love it. It's anything but passive, though.

Let me ask you this about your situation. If you had a paid-for house, would you borrow \$140,000 against it to invest? Of course not. It's pretty much the same thing, and that would be dumb. I love that you're thinking about the future, Anthony. And I know the compound interest you're visualizing down the road is really tempting. Your compound interest calculator will tell you some amazing things, but what it's leaving out is risk. It also can't tell you about the carefree way you'll walk, and how it'll feel like a huge weight has been lifted off your shoulders when you don't have a house payment. You'll be able to live life on your terms, and all the decisions you make will come from a completely different point of view—one that isn't burdened by the weight of bankers hovering around, waiting for you to give them what's theirs.

The borrower is always a slave to the lender. Think about it. Only one implication of slavery is mathematical. All the rest are spiritual, physical, relational, emotional and mental. Being debt-free changes your life from the inside-out. Not only does it make your life better, but it allows you to give with incredibly generosity, and be an agent for positive change in the lives of others.

Pay off the house!

## **Social Security Matters** I'm Already Collecting Social Security - How

Dear Rusty: I don't understand exactly how the Windfall Elimination Provision (WEP) works for my situation. I turned 62 in 2017 and am currently still working in a "non-covered" job, not paying into Social Security, but from which I will get a government pension when I retire. I began collecting Social Security at my full retirement age in 2021 and am now collecting \$1507 per month thanks to the cost of living adjustments since I started. Will my Social Security benefit be reduced by \$587 if I retire this year? Signed: Confused by WEP

Dear Confused: You're certainly not alone to be confused by WEP, and your situation is somewhat special because you started your SS benefits before taking your "non-covered" government pension. And, unfortunately, most tools and charts which suggest how much WEP will reduce your Social Security benefit don't accommodate that nuance very well.

In your case, when you claimed Social Security at your full retirement age (FRA), you were awarded

the full benefit you were enti-

tled to, unreduced by WEP

because you were not yet

collecting your non-covered government pension. You were able to collect your full SS amount and receive each year's full cost of living adjustments (COLA) to those higher amounts. What actually happens is that each person's Primary Insurance Amount (PIA) is first determined at age 62, and Social Security applies an annually awarded COLA to their PIA (primary insurance amount), even if they're not yet receiving benefits. You received your full PIA, including COLA, because you claimed at your full retirement age. But when you start collecting your pension from your non-covered government job, the Windfall Elimination Provision (WEP) will kick in and reduce your Social Security benefit.

The amount of WEP reduction depends on how many years you had contributed to Social Security from "substantial" earnings but, with 20 or fewer years, the maximum WEP reduction is determined by the year you turn 62 and doesn't change. Since you turned 62 in 2017, your maximum WEP reduction, according to Social Security's process, is \$442.50 - lower than the \$587 you suspect.

Nevertheless, due to the way Social Security calculates the WEP reduction, the reduction from your current amount will seem larger than the WEP maximum. And that's because of the way Social Security applies the WEP reduction to your benefit. They start by first removing all cost-of-living increases since you were 62 from your primary insurance amount (PIA). They will then take your PIA (sans

COLA) and subtract \$442.50

Will My WEP Reduction be Calculated? (if you have more than 20 years of substantial SS-covered earnings they will subtract less), and then they will reapply all the cost-of-living increases since you were 62 to your WEP-reduced PIA. What just happened, in effect, is that your previous (pre-WEP) COLA increases were removed from your PIA, and those same COLA percentages were reapplied to your smaller WEPreduced PIA, to arrive at your new monthly benefit amount under the Windfall Elimination Provision. And that new amount will be lower than your previous SS benefit amount by more than the published maximum WEP reduction for the year you turned 62.

> A word of caution: Timely notification to Social Security of your non-covered pension is very important. As soon as you receive your non-covered pension award letter, deliver it to your local Social Security office and request a WEP recalculation of your SS retirement benefit. The WEP recalculation will likely take months to process, during which time you will continue to receive your higher non-WEP SS benefit. That means you will be overpaid for the period between when your non-covered pension started and the month your new WEP SS payment began, and that overpayment must be refunded to Social Security. Other nominees for this position included Kevin Leach, nominated by Meristem in Fair Oaks; Kai Nakaoka, nominated by Scouting America in Sacramento; Maximum Truong, nominated by the Sacramento Tree Foundation; and Kristy Yu, Flynn Ng, and Cara Taylor, nominated by the Sacramento Public Library

The Individual Volunteer of the Year award is presented to a volunteer over age 21, who has dedicated a minimum of 25 hours of service. The award recipient receives a \$100 award for their organization.

The winner for this year's award was Patricia Estopinal, nominated by Court Appointed Special Advocates Sacramento (CASA), an organization focused on ensuring support for children in the foster care system through volunteer advocates.

"This award means so much because for the past 14 years being able to have a relationship with foster youth, to have a relationship where you know that you're the one constant, no matter what is going on in their lives, it's just such a meaningful relationship," Estopinal said

The nominees for the positions included Beatriz Bueno and Jane Shapiro, nominated by the Sacramento Medical Serve Corps in McClellan; Anne Marie

Christian, Daisey Maldonado and Karina Villanueva, nominated by Dignity Health Methodist Hospital in Sacramento; Mary Kay Edson, nominated by the Sacramento Public Library; Ron Hills, nominated by Vitalant in Mather; Marissa Honey-Plate, nominated by the Miss Sacramento County Scholarship Organization in Antelope; Rodney Horton, nominated by the American River Parkway Foundation in Carmichael; Nicky Smolter, nominated by the Lavender Library in Sacramento; Matthew Tran, nominated by the Sacramento Tree Foundation in Folsom; and Kristy Venrick Mardon, nominated by Only Sunshine Sanctuary in Fair Oaks.

Volunteer Manager of the Year honors a volunteer manager who demonstrated outstanding leadership and dedication to supporting volunteers. The winner received a \$100 award for their organization, along with a one-year complimentary DOVIA Sacramento organization membership.

The 2024 winner was Marlene von Friederichs-Fitzwater nominated for her work with Joshua's House and Health Communication Research Institute located in Yolo County. She has spent the past decade building Joshuas House, a hospice facility for terminally-ill homeless individuals. Von Friederichs-Fitzwater has raised \$2.5 million and created a volunteer organization to provide high-quality care.

Other nominations included Marissa Honey-Plata nominated by Miss Sacramento County Scholarship Organization and Justin Rubio with Sacramento Tree Foundation.

During the ceremony, several guest speakers talked about the importance of volunteering and the work they have done throughout the years. Lynn Pesely, winner of the 2023 DOVIA Volunteer Manager award, talked about her work with the Sacramento Medical Reserve Corps. Helen Dang, Miss Sacramento County, and Nicole Vicks, Miss Capitol City, winners of the Miss Sacramento County Scholarship program, mentioned their work with advocacy and action for the houseless and Stomp Out Bullying

"One second, one minute, one action can change someone's life," Dang said. "All it takes is one good dead to build the foundation of lasting change."





# Student Loan Relief Deadline Approaching for 300,000 California Borrowers

As many as 300,000 Californians have until June 30 to take advantage of a one-time offer to qualify for faster student loan forgiveness, lower monthly payments or outright forgiveness for federal loans borrowed before 2010.

The U.S. Department of Education's June 30 deadline is a big deal because borrowers who submit their applications would become eligible to receive credit for past years of repayment that previously didn't qualify for student loan forgiveness.

The department's one-time "adjustment" will largely help borrowers who took out federal student loans before 2010 called Federal Family Education Loans — as well as borrowers with two other types of loans.

Why is the department doing this? To "remedy years of administrative failures that effectively denied the promise of loan forgiveness to certain borrowers," said Education Secretary Miguel Cardona in a 2022 press release. The deadline for this remedy has been extended several times, but student loan advocates believe June 30 will be the final opportunity for this one-time benefit.

Nationally, about half of borrowers 60 and older have been repaying their student loans for more than 15 years, a key reason why debt among this population has skyrocketed.

By May, more than 1 million Americans have already gotten \$51 billion in debt relief through this adjustment program, according to the department.

The student loan landscape is notoriously complicated. A National Public Radio reporter whose investigation exposed how borrowers placed in the wrong repayment category lost the ability to gain credit toward loan forgiveness, quipped that if none of this makes sense, "You're not alone."

To meet the June 30 deadline, borrowers must submit applications to consolidate their loans into so-called direct consolidation loans. Only loans in the direct program are eligible for loan forgiveness after 10 or 20 years of payments, depending on a borrower's employment situation. Direct loans also qualify for lower monthly payments.

Some borrowers may see no reason to consolidate, but for many others, meeting the June 30 deadline will be a

To apply, a borrower needs to create an account with the Federal Student Aid office and then complete the consolidation application, which itself takes about 30 minutes.

#### California State Agency Tries to Help

Most Californians with loans that aren't in the direct program should apply to consolidate, said Celina Damian, the state's first Student Loan Servicing Ombudsperson.

This week California is also debuting a network of 14 nonprofit organizations that collectively received \$7 million in state grants to help California borrowers navigate the maze of student loan policies, hurdles and deadlines.

The Student Loan Empowerment Network will offer California borrowers in-person or phone consultations to handle their student loan quandaries, including issues surrounding private student loans that are governed by a different set of rules.

"It was created really to just have somewhere for borrowers to go and provide more help than I can provide," Damian said. Until last week, she was the only person in state government doing this work.

ment doing this work.

Between March 20 and May 1,
Damian communicated by phone
or email with 1,400 borrowers
after her office sent an email to
Californians who'd likely bene-

fit from loan consolidation.

Some borrowers didn't realize they possessed federal loans that were eligible for any loan forgiveness, Damian said. The borrowers instead thought they were repaying private loans. Others thought her agency's outreach was initially a scam. "So they would reach out and say, 'Is this real? I thought there was no option for me," she recounted.

Damian stressed that a growing number of California borrowers are senior citizens who may struggle to complete the federal online application. "The oldest one I spoke to was about 83, 84", she said. "These are loans they took out in the '90s."

Several times borrowers nearly gave up trying to apply, so she told them to complete the paper version of the application and email her photos of their paperwork. She then collated their photos into

a PDF document and submitted the paperwork to the U.S. Department of Education on their behalf.

#### eir behalf. How Did We Get Here?

Federal Family Education Loans were common loans issued by private lenders but guaranteed by the federal government. In 2010, these loans were discontinued and the federal government began issuing student loans directly.

The old loans qualify for federal loan forgiveness programs with less generous repayment plans and require more years of repayment.

These loans are also ineligible for Public Service Loan Forgiveness, a loan program for government and nonprofit workers that forgives federal undergraduate and graduate student loan debt after 10 years of payments. The only way to qualify for that loan forgiveness is by repaying direct loans which borrowers with Federal Family Education Loans can do if they consolidate by June 30. Once their consolidation goes through, borrowers will need to apply for the Public Service Loan Forgiveness program, but they will have inherited past credit already through the steps they took to consolidate.

Borrowers need to only apply for consolidation by the June 30 deadline. The department's actual review process will take at least 60 days.

Borrowers who are found to have made at least 20 years of payments for undergraduate loans or 25 years for graduate loans will see their loans fully forgiven — a tax-free

perk through 2025.

## Things to Consider for

Student Loan Forgiveness
A key benefit of consolidation: Borrowers can choose to be placed on the SAVE repayment plan, which bases monthly payments on current income and offers loan forgiveness for any income level after 20 or 25 years.

The SAVE plan also doesn't charge interest as long borrowers make regular payments.

Not all periods of repayment will count toward one's loan credit under the federal government's one-time program. Any time spent in default won't count.

Loans in periods of deferment will count, but only before 2013. If loans were deferred because a borrower re-entered college, such as to complete a bachelor's or earn a master's degree, that time won't count toward the borrower's credit.

If borrowers have older loans and Parent PLUS loans that they took out on behalf of their children, they should weigh their options, Damian said. Parent PLUS loans are eligible for only one type of loan forgiveness plan that's less generous, and consolidating those loans with other loans will block the borrower from the newer repayment plans.

Consolidation may not be for everyone. Borrowers with high incomes, a low loan balance and a discounted interest rate from their lender may not necessarily benefit from this, said Betsy Mayotte, president and founder of The Institute of Student Loan Advisors, a nonprofit group. "But for just about everybody else, there isn't going to be a downside."

# 1 in 6 New Trucks and Buses in California Are Zero-Emission

**SACRAMENTO, CA (MPG)** - The sales of new zero-emission medium- and heavy-duty trucks in California in 2023 have doubled from the prior year, now representing 1 out of every 6 new vehicles sold for services that include last-mile delivery, freight transportation, and school buses, according to a report released by the state on June 6.

With 18,473 medium- and heavy-duty ZEVs sold in California in 2023, the state has exceeded its Advanced Clean Trucks (ACT) goal two years ahead of schedule and selling five times the required amount. Since 2021, a total of 26,921 medium-and heavy-duty ZEVs have been sold in California.

"California is once again proving what can be done by turning ambition into action. We're achieving our goals years ahead of schedule. The fifth biggest economy in the world is moving away from dirty polluting big rigs and delivery fleets – cleaning our air and protecting public health," said Governor Gavin Newsom.

The latest figures are a preliminary look at annual data that tracks sales of mediumand heavy-duty vehicles in California and points to continued momentum for zero-emission vehicles ahead of rules that start phasing in later this year requiring the gradual deployment of clean vehicle technology for fleets.

"California set visionary targets to move key transportation sectors toward zero-emissions technology and the market is stepping up to be part of the solution for cleaner air and climate action well ahead of required targets," said CARB Chair Liane Randolph. "The data shows that the future is zero-emissions and that fleets are finding value in making the switch early."

#### Why it Matters

The Advanced Clean Trucks and Advanced Clean Fleets regulations

establish a phased-in shift toward sales and use of zero-emission technology.

California communities that sit near trucking corridors and warehouse locations with heavy truck traffic, which often are low-income and communities of color, have some of the worst air in the nation.

While trucks represent only 6% of the vehicles on California's roads, they account for over 35% of the state's transportation-generated nitrogen oxide emissions and a quarter of the state's on-road greenhouse gas emissions.

#### **How We Got Here**

Advanced Clean Trucks requires manufacturers of medium- and heavy-duty vehicles to phase-in the sale of zero-emission options in California as an increasing percentage of sales.

A similar rule has been adopted by 10 other states, including New York, New Jersey, New Mexico, Massachusetts, Washington, Oregon, Vermont, Colorado, Rhode Island and Maryland. Together, these 11 states represent over 25% of new heavy-duty vehicle registrations annually in the nation.

The Advanced Clean Fleets regulation includes a first-of-its kind requirement for all medium- and heavy-duty vehicles sold into California fleets to be zero-emissions beginning in 2036 and is expected to introduce 1,690,000 ZEVs into the California fleets by 2050.

To ensure that the needed technology will be available to meet upcoming milestones, CARB and the nation's leading truck and engine companies signed the Clean Truck Partnership in July 2023, which commits participating manufacturers to meeting California's vehicle standards, regardless of whether any other entity challenges California's authority to set more stringent emissions standards under the federal Clean Air Act. In turn, CARB has agreed to work collaboratively with manufacturers to provide more flexibility in meeting CARB's requirements. ★
