# **City Officials** Pass Operating Budget

YUBA CITY, CA (MPG) -Mayor Shon Harris and councilmembers adopted the 2024-25 Fiscal Year Operating Budget totaling more than \$61 million.

To be exact, the budget is \$61,775,000, according to Yuba City Finance Director Spencer Morrison, who gave a "high-level overview of the Fiscal Year 2024-25 Operating Budget" on June 18 for general and enterprise funds.

"My team starts around January, and after this budget is adopted, we still have the publishing of the remaining budget, so it is quite a lengthy process," Morrison said.

The finance director noted the capital budget presentation.

"This is not an operating surplus per se but rather unused reserves transferred into the General Fund in July of 2023, so those reserves will go on to help close budget deficits in the future," Morrison said.

SACRAMENTO REGION, CA (MPG). - The 18th annual California Capital Airshow, presented by Sacramento County in partnership with the City of Rancho Cordova, returns 3:30 to 9:30 p.m. July 13 and July 14 to Mather Airport in Sacramento.

The two-day event will feature an extraordinary lineup of performers, including the Italian jet team, Frecce Tricolori, and the United States Air Force Thunderbirds, plus miles of ground attractions and the return of nighttime aerial performances. Both days conclude with a massive pyro-musical fireworks show.

"This year's show offers a truly once-in-a-lifetime experience," said Darcy Brewer, California Capital Airshow executive director. "Our attendees will enjoy performances by two world-renowned jet teams, Frecce Tricolori and the Thunderbirds, along

with some of the most skilled pilots from around the globe, right here in Sacramento."

This unique show features four hours of nonstop aerial performances beginning at 5:30 p.m. both days. The United States Air Force Thunderbirds will kick off the event followed by Frecce Tricolori, U.S. Navy F-18 Super Hornet, U.S. Air Force

F-35 Lightning and C-17 Globemaster demo teams and an impressive roster of highly skilled civilian performers including priceless vintage warbirds.

As the sun sets, the show will continue with maximum afterburner followed by aircraft lighting up the night sky with pyrotechnics, walls of fire, spectacular fireworks and a 500-drone show.

Before presenting final figures, Morrison said that "like every other household, city, and government across the country," rising costs, including energy, gas, insurance, and labor, keep money tight.

"As we get into this budget, we will be drawing on recommended reserves," Morrison said of the \$5.5 million set aside in a stabilization fund.

"Adequate reserves" total \$30 million, according to Morrison, who said \$8 million is set aside in a Health City reserve 2023-24 account, equaling the 15% required per policy.

Diona Pope, city accounting manager, presented a graph of General Fund revenues before she listed the most significant changes for this Fiscal Year 2024-25, then the same for the expenditures. Expenditure budget changes include \$2.5 million in safety and non-safety payroll, \$785,000 in materials, supplies and services, \$452,000 in liability insurance, \$245,000 in gas and electric costs, and \$210,000 in animal services.

After noting total expenditure changes of \$4,373,000, Pope pointed to pension rates that Pope said would be updated upon receiving the latest actuarial reports in July or August. As for water revenues, expenses, and debt coverage, Pope said,

# **Legendary Locomotive Makes 19 Whistle Stops** *Big Boy No. 4014 Features Public Display Days in Roseville*

**NORTHERN CALIFORNIA REGION** (**MPG**) - Union Pacific's legendary Big Boy No. 4014, the world's largest operating steam locomotive built to conquer mountains, will make 19 whistle-stops in five states this summer during its 2024 Westward Bound Tour from Wyoming to California.

In addition, this mighty steam locomotive will be on public display for two days in Roseville (nearby Placer County) from July 12 to July 13. The display days offer an up-close look at the 1.2-million-pound marvel along with the "Experience the Union Pacific" rail car, a captivating walk-through exhibition that provides a unique glimpse into the rich history of railroading.

Northern California residents will also be able to see the steam locomotive in Oroville during a whistle stop on July 11, tentatively scheduled from 2:15 to 2:45 p.m. at Old Depot, 2181 High St., Oroville. # **Big Boy History**

Twenty-five Big Boy locomotives were built for Union Pacific to haul freight over the steep grade of the Wasatch Mountain Range in Utah during World War II. Eight were preserved after the locomotives were retired six decades ago, but only Big Boy No. 4014 is still in operation.

During World War II Union Pacific operated some of the most modern and powerful steam locomotives ever built. Among them were the famous "Big Boys," the largest steam locomotives in the world. Working with them were the "800-class" high-speed passenger locomotives, as well as hundreds of older class steam engines. Union Pacific's steam

legacy continues today with the preservation and operation of its historic fleet – No. 844 and No. 4014.



# Auditions Announced for 'Jekyll & Hyde,' the Musical

OROVILLE, CA (MPG) - Michelle Solis appeared in Butte County Superior Court at 1:30 p.m. June 27 for sentencing. The former Gridley Unified School District teacher faced felony charges of 261.5 (d) PC or unlawful sexual intercourse with a minor and a charge of 288.2 (a)(2) PC. Solis was found guilty by Judge Micheal Deems of sex with a minor and referred to probation until the sentencing hearing originally scheduled for June 6. At the June 6 hearing, Solis' defense was able to secure a continuance to June 27 for sentencing, requesting that Solis undergo psychiatric evaluations before the court settled on a final verdict.

After a world premiere run in Houston, Texas, the musical embarked on a national tour of the United States prior to its Broadway debut in 1997.

The roles are all for actors 18 years of age and older. There are no parts for minors. All others are encouraged to audition. For the audition, prepare one minute of a song to perform. Please bring musical accompaniment in the form of a backing track or sheet music for a pianist. Rehearsals will begin the week of July 15. Presented through a special arrangement with Music Theatre International, performance dates are September 27 through 29 and October 4 through 6. The original story of The Strange Case of Dr. Jekyll and Mr. Hyde follows Gabriel John Utterson, a London-based legal practitioner who investigates a series of strange occurrences between his old friend, Dr. Henry Jekyll, and a murderous criminal named Edward Hyde. It is one of the most famous pieces of English literature and is considered to be a defining book of the gothic horror genre. The novella has also had a sizeable impact on popular culture, with the phrase "Jekyll and Hyde" being used in vernacular to refer to people with an outwardly good but sometimes shockingly evil nature. The production will be a first for the Yuba-Sutter community so don't miss it.

On June 27, Solis appeared before Deems at Butte County Superior Court with attorney Matthew Clinton Smith.

Smith informed the court that the physician conducting the testing had been hospitalized and therefore a final report had not been produced.

The court confirmed that it had received

that the report in question was what he had based his statement of mitigation on, continuing with "as such, I'm not in a position to address the mitigating factors at sentencing."

If he had known earlier, Smith said, he would have sought out another physician to finalize the evaluation before the day's sentencing.

Prosecuting Supervising Deputy District Attorney Jennifer Bennett stated that the people were opposed to the request for continuance and noted that for the charge, a static 99 evaluation was "not applicable for a female offender, and that there are other ways for the defense to obtain mitigating factors from the defendant."

Bennett agreed that if the judge decided to grant the continuance, the prosecution and the people would ask that Solis be remanded to jail.

Deems granted a continuance to 1:30 p.m. July 18 and remanded Solis to jail with no bail.  $\star$

# Block Grant Provides More Than Half-Million

YUBA CITY, CA (MPG) - A Community Development Block Grant (CDBG) provides decent housing and a suitable living environment, expanding opportunities for low- and moderate-income residents. However, as Public Works director Ben Moody noted at the Yuba City City Council June 18 meeting, it also does much more. The grant provides recreational equipment, offers more pathways for disabled individuals and replaces necessary vehicles. Moody explained that the city's entitlement jurisdiction receives annual U.S. Department of Housing and Urban Development (HUD) grant funds. Yuba City officials are providing all that and more with the 2024 Community Development Block Grant Action Plan, according to Moody, who said the city coordinates with HUD on household threshold applications. This year, inflation figured significantly into the numbers, according to Moody. "It changed quite a bit this year, which was interesting," Moody said. "It went from almost \$50 thousand to \$87 thousand, which is a big deal."



According to HUD's definitions, Moody said a household making less than 50% of the Area Median Income (AMI) is considered low-income.

"The Area Media Income this year was updated for a family of four to almost \$88 thousand dollars, and moderate-income is less than 80% of that," Moody said. "So qualifying individuals are in that range of a family having less than \$44 thousand and the moderate \$70 thousand."

This year, Yuba City

received \$567,725 in Community Development Block Grant funding.

"It's been trending down a little bit," Moody said of the funding in recent years. "With that funding, there are some stipulations."

A maximum of \$113,158, 20%, of funds must be allocated to program administration, according to Moody, who said that is "entirely normal." Another \$85,158, 15%, must be allocated to homeless-related services.

"That is an area we receive a lot of applications," Moody said. "So it's always kind of a pinch point as far as how much funding is available for those types of services."

The annual process began in February of this year with a notice of funding available made public through media, the city's website, and local agencies. In March, public workshops were held, and in May, the public notice for comment on the Community Development Block Grant Action Plan went out. It ended with Moody's presentation that night.

"We worked with the mayor and vice-mayor to review the applicants," Moody said, adding there is always more need than available money. "We received 1.8 million in applications."

Moody detailed specific proposed funding projects, including replacing Patriot Park Playground equipment at \$160K and providing ADA-accessible sidewalk and curb improvements citywide at \$186,000.

The local food bank's costs total around \$54,000, including the repair of a delivery vehicle, which cost \$28,000. Yuba-Sutter Food Bank Director Maria Ball and Board Chair Jackie Sillman were present and grateful for the funding.

"We are looking up at the slide up there about inflation and all the different costs, and the food bank is really feeling it," Ball said, noting since 2023, the number of people the food bank feeds has doubled. "We feed about 25,000 people each month, and we really appreciate your consideration."

After Mayor Shon Harris thanked Ball for her work at the food bank, the council officially adopted the proposed funding for HUD processing. "We are looking to double last year's goal of \$12,000 to a hopeful \$25,000," said Talley when asked what he hopes to accomplish this year.

Talley's passion for serving his community is evident, as he continues to set goals for his fundraisers and beat them, setting them higher every year.

"Last year, during our November food drive, we fed 275 families Thanksgiving dinner," Talley said. "And this year, I want to make it 500."

"This food drive is close to my heart because I came from food insecurity. I know what it's like to be hungry. We aren't just trying to get people to come buy stuff from our store; we want to spread love

# Live Oak City Council Approves Budget

**LIVE OAK, CA (MPG)** - At the Live Oak City Council June 19 meeting, Interim Public Works Director Jeff Nelson provided an update about the Wastewater Treatment Plant Solar Power Project, which will construct a solar power collection facility over one of the ponds at the treatment plant.

"It's going to meet a large portion of the treatment plant's electrical demand," Nelson said.

Project funding is coming from a \$1.68-million grant from the State Water Resources Control Board, which was awarded to the city in 2018. Some funding was released to cover the design process, so City Council earlier this year approved a consulting agreement with EDesignC to begin designing the project and preparing construction bid documents.

But the bulk of the funding won't be available to the city until the selected construction bid is reviewed by the State Water Resources Control Board and approved by City Council.

"We have a very aggressive schedule to try to meet the conditions of the grant," Nelson said, because the funding agreement must be submitted by the end of the year. The city will release the request for bids in July, with plans for the selected contractor to start work by November. Construction completion is expected by May or June 2025.

Councilmember Bob Woten said, "I think that it's a fantastic idea. I'm glad you're on top of it to get it moving for us."

Councilmember Jeramy Chapdelaine agreed: "It's good to see it moving forward."

Mayor Ashley Hernandez said, "I'm excited for this. I always love something that we can offset costs for the city."

Since this was an informational item, no council action was required.

City Council next considered the quarterly write-off of past due water and sewer accounts to be sent to collections. The 10 delinquent account holders were renters, and their accounts total \$3,547.71 in unpaid sewer and water charges. Notices were sent to these account holders but there has been no response.

City Council voted unanimously to send the delinquent accounts to collections.

Councilmembers then reviewed the proposed budget for Fiscal Year 2024-2025, which was presented by Interim City Manager Mark Scott and Finance Director James Ramsey.

The proposed budget totals \$13.9 million in spending, with \$4.9 coming from the General Fund and the remaining \$8.9 million coming from enterprise funds and restricted special revenue funds. The city expects to have a balance of \$9.34 million in funds available at the end of this fiscal we going to go in the future?" Scott said. "Because we've got a situation where the Water Enterprise is literally taking funding from the General Fund. We can't do that very much longer. The council is aware of that."

City Council has already directed staff to bring forward a proposal for a wastewater study, Scott said, so staff is looking for grant sources to cover that cost.

"So, as we look at this, we can see that we have to stop the deficit from the water fund and we're going to need to start looking seriously at future growth of our economy," Scott said. "We're just not in a city in a situation where we can expect our local population to pick up the difference. People haven't got that kind of disposable income."

Over the coming years, Scott said, the city needs to look at "building our economy and building our tax base," because the current level of tax revenue cannot continue to cover the level of service the city wants to provide.

For example, this proposed budget has increased costs for the police and fire service contracts. The city will be allocating some one-time funding to cover it this year, including the last \$850,000 of the city's federal American Rescue Plan Act (ARPA) award. But the City will need to figure out how to fund those costs in coming years.

"We've got a revenue issue," said Scott. "We've got to have strategies going forward."

The city needs to be looking at commercial investments to bring more fees and sales tax revenue to Live Oak, Scott said: "We've got to build our economy. ... Aggressively, we need to change our position in the world as a place to do business."

He recommended that the City Council establish policies to guide what types of development and investment will be best for the city and ensure it is an attractive place to do business. "It may take us 10 years to make this happen," said Scott, "but this needs to be the year you start."

In order to ensure a balanced budget this fiscal year, Scott said that many significant capital projects were not included in the budget. "We're not going to put what-ifs in there. ... And frankly, if we hadn't left that out, you'd be looking at a negative fund balance." But Scott said that they always put very conservative estimates into the budget, and typically the expenditures won't hit 100% of what was budgeted. So, there will likely be room to make amendments as the year progresses, once the Council has identified their priorities for additional spending.

Councilmember Woten thanked staff for their hard work on the report.

"It's a very positive budget," he said. "I think that it's a great place to start and moving us forward from where we've been."

# Did Political Bias Actually Influence California Court Ruling on Anti-Tax Ballot Measure?

When the California Supreme Court unanimously declared a week ago that a highly controversial tax limitation measure could not appear on the November ballot, its proponents immediately cried foul.

They alleged that a court dominated by Democratic appointees had acted with political motives rather than legal reasoning, ruling that The Taxpayer Protection and Government Accountability Act was a revision of the state constitution and could not be proposed through a citizen's initiative.

"Clearly, the state Supreme Court has now sent a signal that they are part of the progressive agenda in California, that we are a one-party state in California and there is no independent judiciary in California anymore," Rob Lapsley, president of the California Business Roundtable, a major sponsor of the measure, told reporters.

In a statement, Jon Coupal, president of the Howard Jarvis Taxpayer Association — another sponsor — was equally critical, saying, "The seven justices of the Supreme Court yielded to the wishes of the political branches (and) put politics ahead of the state Constitution.

"It is now obvious that all three branches of California's government executive, legislative and judiciary — believe the government may decide how much money it needs and raise taxes accordingly, and the voters may not constrain them."

Given their backgrounds, it's reasonable to assume that most if not all of the justices may personally dislike a measure to redefine many fees as taxes and put very strict limits on state and local governments' ability to increase them. But did that cause them to block the measure and cloak their bias in a blizzard of legal language, as the sponsors claim?

The justices seemingly anticipated that its motives would be questioned, stressing "the limited nature of our inquiry" very early in their ruling.

"We do not consider or weigh the economic or social wisdom or general propriety of the initiative," Justice Goodwin Liu declared, adding, "The only question before us is whether the measure may be validly enacted by initiative."

A careful reading of the 51-page decision acquits Liu and his colleagues of alleged ideological bias. It's evident that in drafting the measure, proponents overreached by making very fundamental changes in California's governance system, amounting to a revision of the Constitution that can only be proposed by the Legislature or a constitutional convention.

The court said the measure's most obviously revisionist aspect would have compelled the Legislature to submit any tax increases to voters for ratification, thereby impairing legislative taxation powers that have been part of the state's structure for its entire 174-year history.

"No speculation regarding potential future consequences is needed to conclude that the (Taxpayer Protection Act) is a revision on its face," Liu wrote. "The measure would fundamentally restructure the most basic of governmental powers. The TPA would exclude the levying of new taxes from the Legislature's control by requiring voter approval of all such measures."

Some critics have suggested that the current court would have invalidated Proposition 13, the iconic 1978 property tax limitation measure. But Liu also addressed that, writing that Prop. 13's changes "operate functionally within a relatively narrow range to accomplish a new system of taxation which may provide substantial tax relief for our citizens. We decline to hold that such a limited purpose cannot be achieved directly by the people through the initiative process."

In other words, had the Business Roundtable and Coupal's group proposed less sweeping changes in taxing authority, such a measure may have survived the legal challenge that Gov. Gavin Newsom, the Legislature and local governments mounted.

Given the legal uncertainty in California about who can levy what taxes on which activities, a clarifying ballot measure would be welcomed.



ing revenue, producing a declining debt coverage ratio."

The budget also includes capital requests, including replacing police canines and purchasing a new utility dump trailer. Additional vehicles for various departments, including water treatment, maintenance, and fire, are also included in the figures.

"This is a bare-bones budget," Councilmember Mike Pasquale, who was on the budget ad hoc committee, said. "I will go to task with anyone that we are not bare bones."

Councilmember Marc Boomgarden said he "labored hard on this one." While he said he was "in no way in conflict with the work of the ad hoc committee" or the city staff, he cannot support this budget.

"As we embark on this journey of asking our residents to consider taxing themselves, it is imperative to me that we spend

wisely," Boomgarden said. While not wanting to

"I need to be true to myself," Boomgaarden said, noting some items are "highly, highly questionable."

Councilmember Dave Shaw said the city's hard work on the budget over the last five years is evident compared to area regions.

"If you look at Sutter County, it is upside down; the city of Sacramento is upside down," Shaw said.

All councilmembers, except for Boomgaarden, approved the budget. ★

Make sure you do this with a kind spirit, James. Most people in your sister's position already know deep down that they're making bad decisions. So, it's important that you talk to her in a gentle, caring way. See if you can get her to talk about what's really going on with her money. You could even let her know you might consider giving her some money as a gift if you had any extra lying around—and you knew she was in control financially. But you're not really helping someone who's financially incompetent, or just plain immature, when you give them cash or even loan them money.

You're not helping someone if you participate in their misbehavior with them, so you've got to look at the big picture in situations like this. Your sister hasn't just hit a hard time, with lots of unexpected expenses or a job loss. Right now, her behavior with money isn't just a bump in the road, it's a lifestyle.

Sometimes you have to love someone enough to sit them down, and tell them the truth. Even if it's family, that can also mean saying no and telling them it's time to straighten up and start acting right.

## California Avocado Growers Eye Pause of Mexican Imports

With the supply of Mexican avocados tapering off and prices rising, California growers have ramped up harvest, hoping to send the bulk of their crop to the market while it remains strong. They may see prices jump even higher if the U.S. Department of Agriculture does not immediately resume full inspections of avocados from the Mexican state of Michoacan, the global epicenter of avocado production. Inspections were halted there after two USDA inspectors were attacked earlier this month. Officials said USDA inspections in Michoacan will "gradually" return.

## Salinas Valley Farmers Report Gains in Battle Against Lettuce Virus

California lettuce growers are so far breathing a sigh of relief this year that the dreaded impatiens necrotic spot virus that has devastated Salinas Valley lettuce crops in recent years seems to have receded. But agricultural researchers warn that it will take extensive work and vigilance to prevent a future outbreak that could be costly for affected crops. That vigilance includes aggressive weeding efforts to prevent INSV-carrying thrips from finding weed hosts and spreading the virus to nearby farm fields. In 2022, the lettuce virus caused \$150 million in crop losses in the famed Salad Bowl region.

## California Melon Growers Report Ample Supply for Fourth of July and Beyond

California watermelons, cantaloupes, honeydews and mixed melons will arrive in grocery stores in time for the Independence Day holiday. Melon season has shifted to the San Joaquin Valley as harvest wraps up in the Southern California desert in the Imperial Valley and in Yuma, Arizona. Harvest in the San Joaquin Valley is expected to continue through October and resume in the desert from October to December. Stanislaus County farmer Matt Maring said there may be a surplus of melons on the market as the season progresses.

#### Dairies Undertake Climate-Smart Practices to Manage Manure and Nourish Crops

Prompted by drought-induced water-allocation cutbacks in 2014, the diversified DeJager Farms began looking at buried drip irrigation and manure water from its dairy operations to try to help its farming operations survive.

Since then, the Chowchilla-based producer of milk, beef, row crops and specialty crops has installed seven irrigation systems that treat and filter manure water from nearby dairy operations to support crops such as silage corn. Such efforts are being increasingly supported by climate-smart agriculture grants for dairy producers.

The charges stem from an investigation by Yuba County Animal Care Services (ACS). Animal Care Services officers responded to the couple's home on May 7 after several complaints were made by concerned neighbors.

More than 150 cats were rescued from the home. The couple, who ran a feral cat rescue, lived in the house with their child.

The couple was booked at the Yuba County Jail for 597(b)PC-animal abuse or cruelty and 273a(a) PC-willful child endangerment. As of June 25, they are no longer in custody. Brandon and Valerie Arens are presumed innocent unless and until proven guilty beyond a reasonable doubt in a court of law.



While the petition succeeded in pressuring Democrats to remove the poison pill amendments from their public safety legislation, the overall message does not seem to have sunk in for Gov. Newsom and his allies.

After insisting for months that voters should not consider changes to Prop. 47, Newsom unveiled his own soft-on-crime competing ballot measure yesterday. This sneaky maneuver is meant to confuse voters and kill the citizen-led initiative, undermining the will of the people and putting their safety at risk.

"Californians can see right through Newsom's political games and are fighting back against efforts to mislead and disenfranchise them," said Assembly Republican Leader James Gallagher (R-Yuba City). "Democrats know their constituents want an opportunity to vote on the initiative without interference. Direct democracy scares them-and so they're going to try their best to thwart voters and preserve the status quo."

As Newsom comes up with increasingly creative (and cynical) maneuvers to sabotage the initiative and put Californians at risk, Assembly Republicans will continue to oppose efforts to mislead voters and prevent them from voting on this qualified initiative.

Wow, Kings fans, a busy week for the NBA, and to a lesser extent for our own Sacramento Kings.

The much anticipated #13 pick consummated in the Kings choosing a 6'2" guard from Providence. Devin Carter by all accounts is a bonified first round pick, and many pundits had him going in the top ten. This may have been the primary reason the Kings chose to select Carter at #13, as opposed to taking a lesser talent at one of the big man positions.

Make no mistake about it, the Sacramento Kings are not big up front, and Domantas Sabonis may be the quintessential rebounder in the NBA, but that doesn't mean he can't use some help alongside. Our forwards are on the small side, and since we didn't address this issue with the first-round pick, free agency or a trade will be the only avenue left for Sacramento to shore up its front line.

For me, the player that I believed would fit the puzzle best was Jonas Valanciunas, as he would play nicely alongside Domantas, allowing Sabonis to slide into the #4 spot.

That unfortunately will not happen, since the Washington Wizards just signed Valanciunas to a three-year, \$30-million deal.

I am at a loss to explain why the Kings weren't in the mix and giving it an all-out effort to sign this talented big man, but I remain hopeful that Monte McNair has a plan in place to fix the Kings ever-present needs at power forward.

In a somewhat surprising move, the Kings traded heralded and ever-popular Davion Mitchell along with benchman Sasha Vezenkov to the Toronto Raptors for Jalen McDaniels. Sadly, the Kings second-round pick Jamal Shead was included in the deal, so from the 2024 draft Sacramento rests their hopes on Devin Carter.

I am convinced there is more to come, and I withhold any grade with regards to Monte McNair's offseason moves at this point.

Former GMs have done far worse, and free agency can be a panacea for a team that may not have solved all their needs in the draft. To be sure, there were players on the board at #13 that fit the mode for the type of front-line player the Kings need, but the question is whether they had the skill set to make a difference, and step into the starting lineup.

In all likelihood Devin Carter will come off the bench in much the same way that Davion Mitchell did, and I for one am going to miss Davion's fiery spirit and tenacious defense, but at the same time I don't want to diminish the potential that Devin Carter brings to the team.

Carter's 6'9" wingspan helped him garnish 8.7 rebounds last season for Providence, while claiming Big East player of the year honors. Devin Carter, son of former NBA player Anthony Carter, plays with a confidence and swagger that will fit in nicely to a league that eats up players that lack tenacity.

Sacramento, barring injury, is replete with talented and multi-dimensional guards, so what remains is Monte McNair's ability to fix the Kings undersized front line.


Reportedly, Sacramento is interested in Brandon Ingram, and the real question is whether they are willing to pay the high price he demands. Ingram is considered one of the premier forwards in the NBA coming off a season in which he scored 20 points per game with 5 rebounds and nearly 6 assists. In 2016 Ingram was the #2 overall pick in the NBA draft, so adding this already proven NBA forward would be a welcome addition to a team that is hoping to become a perennial playoff team.

Also, a contender for the Kings starting lineup could be Laker forward Kyle Kuzma, who if signed would come at a much more affordable price for Sacramento. At the end of the day, payroll plays its part, so don't be surprised if Kuzma is in the mix.

Stay tuned all you Kings fans, because Monte McNair is not by any means finished with the 2025 roster. This will be interesting at the very least so hang onto your seats!

Enjoy the summer and look forward to an exciting 2025 upcoming season! It could be special.

# What Happened to Marysville

"What happened to Marysville?" While at a funeral, that was the question asked by those away from the city for decades.

Former residents and visitors wanted answers. Buildings shuttered? Inhabited but neglected properties? How is the lake they used to ski on? Crumbling residential streets? Why are all the yards and trees dying?

Everything rises and falls on leadership (John Maxwell). Certainly, there have been decades of city council blunders. The council's decision to become property speculators and bury citizens with \$17 million in debt was a city killer. The B Street "investment" recently sold for less than \$2 million.

The council's halt to pumping Yuba River snow water into Ellis Lake produced an algae- laden slew. Millions have been wasted on egg-head pond experiments. Marysville may outdo New York's embarrassment to restore Central Park's Wollman Ice Rink.

That attraction was built and gifted to New York in 1949. It was a global landmark. Mayor Koch closed it as inoperable in 1980 as the government was unable to maintain it and then conceded defeat. His restoration went \$12 million over the \$4.7 million budget, with completion a world away.

Marysville businesses have been encouraged to relocate by unfriendly bureaucrats and off-putting regulations. A starving man never requests a menu. The to close Upper Cut Barber Shop. Has any official come to the shop's rescue as Gavin Newsom's troops still harass barbers and want \$140,000 in fines for cutting hair during Covid. Is the council good for anything?

The residents also have made horrible choices. Was it 1971 that they voted to use eminent domain to remove blocks of historic downtown? Meanwhile Old Sacramento restored their Gold Rush era structures and built a Railroad Museum.

An often-forgotten decision that economically cursed Marysville was made by voters in 1927. A plan for the citizens to purchase Marysville Water Company, a private entity, was defeated 927 to 433 in a special election. The water company property was valued at \$372,500. The ability to control the city's destiny was forfeited by succumbing to a private water monopoly.

The Federated Water Service acquired 75% of the Marysville Water Company stock for \$344,255. The new owners then transferred the holdings to California Water Service Company which operated other systems around the valley.

Through the post-WWII years up to the 1970s Marysville water was affordable, with no meters. Lawns, landscaping and parks were lush.

However, in the 1980s forward, Cal Water Service (CWS) has become a major dividend producing corporation with a multitude of mega-paid executives. It moved to new headquarters in San Jose in the 1960s and began acquiring water districts in other states. California Public Utility District (CPUC) and its administrative judges collude with utilities for routine rate increases.

Marysville's CWS added meters and spiking unaffordable rates. Take a drive through town to survey the impact. The CWS water Water District charges. These other providers are municipal districts beholden to the citizens and not the CPUC for rates.

In 2013, an uprising of Marysville residents filed a CPUC complaint against CWS that was rejected by a utility judge. Since 2003, Californian Water Service (CWS) had bumped rates nearly every year for a net cumulative 121.80% over ten years -- an average 12% annually. Additional increases were proposed at that time -- 18.4% in 2014, 20.1% in 2015 and 9.4% in 2016 or another 47.9 % over 36 months.

Angry citizens also asked the city council to purchase CWS and return to a municipal system. Soon council members received campaign contributions, lunch dates and a newly landscaped city hall from CWS. A few nonprofits also awoke to cash in their stockings.

Often, the council members' excuse is "that (the problem) happened before they were there." Grow up. So much for campaign materials saying they are the leaders we need. The council's answer to problems is "same ol', same ol"-- more taxes (Measure C), no operational changes.

With the police department costing more than a million dollars a square mile, a million could be saved by using the Yuba County Sheriff's Department (YCSO) for city enforcement. Much of MPD is a duplication of YCSO across the street.

Taxpayers cannot afford the CalPERS (government pensions) Ponzi scheme. Since the city and county are married to CalPERS the immediate fix for financial survival is eliminating government employees. First root-out duplication (MPD/ YCSO) and then use private contractors for other services.

July tends to be the warmest month of the year along with August, and it looks like it's living up to it with the way it is starting. It's the time of the year to get out early to do gardening and watering. The mornings tend to be comfortable.

Continue to enjoy the bounty from your vegetable garden by fertilizing monthly using a vegetable fertilizer. It is best to avoid high nitrogen fertilizers because they create too much just green growth at the expense of more fruiting. Keep an eye out for tomato worms – they blend in so well making It hard to see them and they can defoliate a plant quickly. Spray them with Bacillus Thuringiensis (or BT for short) to kill them. It is specific for caterpillars and is organic. Some people hand pick them, others cut them in two with their pruners. I like the BT method but I know some people who have chickens and the chickens love them when they are pulled off the plant and tossed to them. So I've been told.

A common summertime pest is the budworm that seems to prefer geraniums and petunias, making holes in the buds and the stems. They, too, can be controlled by BT. It is a good product to have in your supply of garden pest control items. Lady Bugs and Praying Mantis are two great insects for controlling the bad guys. Many garden supply stores have them to sell earlier in the season, but they may be harder to find now. If you have them in your yard, try to avoid them when spraying insecticides.

July, is a typically warm month, but it is still okay to plant, as long as you avoid the hottest part of the day and water very well. Any planting done in the summer should be watered well and very regularly, so it remains well hydrated. Using a product called 'Superthrive' at the time of planting and then once a week or so will help make the transition from container to the ground easier. If you really need to transplant a well established plant, some root is usually lost and 'Superthrive' will certainly help that, too. For planting this time of year, it is best to do it in the evening as the temperatures are cooling off. The biggest thing to remember is to make sure to pay close attention to the watering. The ground should be moist at planting, then use deep watering practices. Water daily for the first week and then deep

soak two or three times a week. Make sure you mulch well too. That saves water and keeps the roots cool during the summer.

Keep your plants well watered through the summer. Watering plants in your landscape with drip irrigation is a very good way to do it. Be sure to check your drip system periodically to make sure all is in working order. Rather than waiting till a plant is dying because the emitter was not working.

Drip systems are water savers since they are targeted at the plant and not all of the space around. That also helps to keep the weeds down since the whole area isn't always being kept wet. Most weeds can use just as much water as the plants, so keeping them cleared away will save water. Mulching around the base of plants will help prevent evaporation reducing the need of frequent watering, also helping to keep them weed free.

We find that trees on drip systems are sometimes short on water because they are on the same timer as shrubs on the system. Trees require more water in the hot weather than shrubs, so if you can't run the system longer, supplement the water by laying a hose with a slow trickle at the base of the tree for several hours once or twice a week. If you see droopy leaves that are dry around the edges on your tree, that is a sign that the tree is not getting enough water. Those are actually the first signs of not enough water. It is best to give trees a good deep watering 2 to 3 times a week, rather than to water them daily with a lesser amount of water. As a general rule it is better to water new plantings or plants in containers in the morning so they have moisture to draw on all day. If you can't do it early in the morning, then a good soak in the late evening is the next best. Most of the water will stay through the night and be available for the following day.

Just remember to increase the watering for your plants during the extreme hot spells.

Continued from page 1 reasons. They need these diplomas to get back into the job market or to continue higher education or to remain in their current positions. We serve as a bridge between their current needs and their future goals. Continuing education and providing support to our most committed adults is an honor for us."


"In just two years, we have grown into one of the largest adult education schools in the region," said Seth Stemen, trustee for the Marysville Joint Unified School District Board. "During the 2022-2023 school year, the Marysville Joint Unified School District Adult School served 300 students, with 28 earning their diplomas. In 2023-2024, the school served over 400 students, with more than 40 earning diplomas. Additionally, this year we have established partnerships with Yuba County Health and Human Services, Local Union 228, Marysville Joint Unified School District's transportation and paraprofessional training programs and we have collaborated with Wham Beauty School to offer cosmetology courses as part of our adult education program. More such partnerships to expand CTE options are in the developmental stage."

The Marysville Joint Unified School District adult education program was closed in 2012, due to government funding cuts to school districts. In the aftermath, consortium funding allowed school districts to collaborate as a group of districts, County Offices of Education and Community Colleges and access State adult education funds. However, Marysville Joint Unified School District was not part of the original consortium and now faces the challenge of finding alternative ways to fund the ongoing program. Although the district received some unspent funds from the regional consortium last year, they haven't received the same support this year. As a result, they are now solely responsible for finding solutions to continue this vital program.

"We have to be creative in pursuit of ongoing funds," said Randy Davis, Marysville Joint Unified School District board president. "The legislative language limits our participation in an existing consortium and doesn't require the consortium to include new members. It's concerning that the language supports regional consortium leaders from withholding unspent funds from a newly established program that is meeting the same needs."

According to the school district, "Experience, creativity and an innovative approach has helped grow this program to ensure that we are there to serve the neediest members of our large county. Marysville Joint Unified School District will actively seek alternatives to ensure this program remains selffunded for generations to come. The resilience of adult learners and the opportunities of the families to be back in the job market are not just concerns for Marysville Joint they are concerns for the entire county. Marysville Joint Unified School District has taken the necessary steps to get adults back in the job market and impact the economic growth of Yuba County."★

**MARYSVILLE, CA (MPG)** - The Marysville Drakes capped off their final four-game road trip of the year as they went 3-1 and swept the Bakersfield Train Robbers in three games from Monday, June 24, through Wednesday, June 26.

The Bakersfield series had importance due to the Train Robbers holding the second spot in the Pacific Division standings by a few games over Marysville.

The Drakes were swept by Bakersfield in a three-game series during the second week of the season and had a horrific 3-10 road record heading into the past trip.

Marysville took care of the Train Robbers thanks to late-game heroics and extra-base hits. In the series opener on June 24, Drakes' catcher Sean Connolly hit his first home run of the season for a threerun shot in the eighth inning to take the lead.

The Marysville defense and pitching held up for six outs to take the first game of the series. In the second game of the series, Drakes' pitcher Earl Johnson Jr. pitched a quality start as he tossed seven innings, surrendered two runs and seven hits, and struck out eight.

The game was deadlocked at two from the fifth inning until the top of the tenth where late-game heroics favored Marysville again as shortstop Josh Leslie hit a three-run blast to give the Drakes a late lead for the second consecutive night.

Marysville pitcher Garrett Mos relieved Johnson Jr. in the eighth and controlled the Bakersfield lineup as he pitched three scoreless innings to seal up the first time of the year that the Drakes' have won consecutive road games.

In the third and final game of the Train Robbers' series, emotions were taken too far by a couple members of both teams. Marysville manager Bill Rogan expressed to the Dispatch that he believed the Bakersfield manager was a "sore loser," and disagreed with certain actions he displayed in the finale.

"It put a sour taste in my mouth. I'm glad we won the three games and came up in big situations," Rogan said.

Leslie hit a two-run single in the top of the 10th inning to give the Drakes their third consecutive late-inning victory.

Leslie expressed to the Dispatch that no matter what the score was during the game, it wasn't over until the 27 outs in a regular game were recorded.

Although Marysville gained significant ground on Bakersfield with the sweep, they gave a little back as they lost against the Vallejo Seaweed to round out the road trip on June 27 in an 8-7 defeat.

Rogan told the Dispatch that they just had late momentum again, but it was too late. The Drakes hosted Vallejo the following night and kept up with the theme of late inning fun.

Marysville was down to their final six outs and down one prior to exploding for a 12-run eighth inning that featured a couple of three-run home runs by infielder Declan Peterson and outfielder Joe Starick. doubles, and he hit the go-ahead RBI double in the eighth.

Green told the Dispatch that they were in a good rhythm, and peaking at the right time of the year would be a huge thing. He added that the Bakersfield series was big in the sense they won close games late and came together.

Rogan expressed he was happy with a solid performance from everyone in the game. Marysville pitcher AJ Cordova pitched six innings giving up four runs from seven hits as he struck out five batters.

Rogan added that the one thing he could always count on from his players was the effort night in and out that they brought to the ballpark.

The Drakes ended the week with a solid 10-3 victory over Martinez to end the week 5-1 and the month of June with a 16-8 record.

Marysville has 22 games in July to finish off the regular season prior to their first game this past Tuesday, July 2.


The Drakes hit the road nine more times compared to their 13 remaining home games at Bryant field where they have been successful.
