**DIXON, CA (MPG)** - Teri Brown, who has served as the Dixon Women's Improvement Club Secretary for three years is stepping up her game: She's the new President for the 2024-2025 year.

Numerous officers and Committee Chairs were installed recently in the oldest club in Dixon: the Dixon Women's Improvement Club established 124 years ago in 1899 to beautify and improve the town of Dixon. The founders were women from families who had settled in the Dixon area following the Gold Rush of 1849 and worked to improve their town, garnering most notably the Dixon Carnegie Library and Dixon Women's Improvement Club Park surrounding that library in downtown Dixon.

Outgoing President Debra

Dingman highlighted the many experiences and achievements of the past year including hearing from guest speakers on interesting topics such as growing herbs, City Development, City Recreation for Seniors, and Dixon's water issues. The members also enjoyed making pumpkin succulent centerpieces, vision boards, and flower arrangements. They took field trips to museums and the UC Davis Raptor Center and are working with a committee to add decorated benches outside the public library.

They held a huge successful fundraising dinner in February that netted thousands for scholarships and community grants, plus they updated the Dixon Community Resource Guide, an online source listing contact information for variety of services, sports, schools, clubs, etc. which is easily available through a Google search.

This year's luncheon was catered

by Bud's Pub & Grill and was themed 'Bee Positive.' Tables were decorated with miniature honeycombs, other assorted bee decorations and 'bee' sayings in recognition of World Bee Day that month.

Dingman, who will now serve as Director at Large, then recognized the DWIC Officers for 2024-2025. They were President Teri Brown; Vice-President Jewel Fink; Recording Secretary Ashley Alvarez; Treasurer Cindy Heeney; and Financial Reviewer Martha Dukes.

Next, the Committee Chairs were introduced. They are Community Grants Teri Brown; Rose Garden Jeanne Bei; Historian Pamela Marks; Hospitality and Membership Binky Eason and Angela Remides; Parliamentarian Jewel Fink; Scholarships Diane Schroeder; Publicity Debra Dingman; and

## Parks and Recreation Commission Appointments, Vacancy

**DIXON, CA (MPG)** - If there is public fun here, the Parks & Recreation Commission is behind it.

Dixon City Recreation manager Austin Gerge said the city's public works and parks and recreation staff work closely with the Parks & Recreation Commission.

"Staff presents the commission with a variety of items for their input and consideration," George said. "In the past few years, these projects have included new playground equipment, grant applications and social media contests on our local parks."

Linda Babb, Public Works Administrative Clerk II, said it's important that all Parks and Recreation Commission appointments are filled "so that we can maintain a quorum and have participation from a variety of community members."

The seven-member committee, including one student, scopes ways to bring activity and amusement to Dixon.

Members, who the mayor appoints after a recruitment process, are limited to serving three consecutive two-year terms, except for students who serve a one-year term.

An adolescent's point of view is key to the commission's vision, according to George.

"The student position allows us to have input from our youth," George said. "The youth in Dixon access our parks and recreation facilities on a daily basis, so it is important for the city to have their participation."

Mayor Steve Bird reappointed incumbents Rudy Baltazar and Ronald Butts and new member Terry Lake on June 18. However, another two-year term vacancy is open for the commission, which meets at 7 p.m. every fourth Tuesday of the month at City Hall Council Chambers.

Officials are asking any interested residents to step up to the plate to complete the seven-member committee.

"Recreation has a wide range of activities, so having commissioners with diverse interests helps by bringing their experience and passion from the different branches of recreation," George said.

Volunteering offers much more than just a \$75 stipend every meeting; it provides an opportunity for

# Officials Adopt 5-Year Upgrade Plans

**DIXON, CA (MPG)** - The 5-Year Capital Improvement Plan (CIP) promises street repairs and water rehabilitation, among other projects.

City engineer and utilities director Jonathon Fong detailed the half-decade proposed capital improvement plan, which included 96 projects and eight new plans totaling approximately \$160 million, to the mayor and council on June 18.

According to the resolution approving the capital improvement plan, there have been “significant revisions to the Five-Year CIP compared to the previous year” due to the General Plan 2040, the Transportation Impact Fee update, and the Streets and Water System Master Plans alterations.

The staff report categorizes the capital improvement plan by city departments, traditionally including “construction projects to rehabilitate existing facilities and to construct new facilities to serve the needs of projected growth.”

“The CIP also includes non-construction projects such as major equipment purchases and studies,” according to the staff report. “Staff employs a computer program, Plan-it, to identify projects and funding sources and schedule project implementation for the life of this five-year program.”

The eight projects added to the capital improvement plan for the 2029 deadline are the East A Street and South 7th sewer repair, fire ladder truck, City Hall

mold, water infiltration, Hall Park expansion, Northwest Park shade structure, Hall Park barbecue shade renovation and Northwest Park agriculture well.

“All the projects are fully funded in year one of the Fiscal Year 2024-25 budget,” Fong said.

However, according to the staff report, “implementation of projects in Years 2-5 may change as funding estimates are updated each year.”

Fong detailed the capital improvement plan approval process, noting it must pass three commissions: transportation advisory, parks and recreation, and planning before council adoption.

The Planning Commission approved the overall capital improvement plan; however, according to Fong, one commission member requested “a study related to the five acres per thousand-park standards in the General Plan 2040.”

Resident John Schrader said his only “concern” was clarifying the noted water rehabilitation of more than \$16 million.

“If I understand this correctly, that is all contingent upon the water rate increase going through as a source for that,” Shrader said.

Another \$16-million concern for Shrader was the proposed Chromium treatment for city water, which also depends on a rate increase.

Schrader’s public comments were not addressed, and the capital improvement plan was adopted unanimously by the mayor and council members. ★

## LETTER TO THE EDITOR

Cal Water June 2024 Rate Increase

Dear homeowners in Dixon served by Cal Water; you need to be informed about a Cal Water rate increase on your June 2024 water bill. Cal Water increased your 5/8” service charge from \$31.82 to \$50.84, an increase of \$19.02 (60%). The increase was needed to fund infrastructure improvements to keep your drinking water safe, clean, and reliable according to the letter in your Cal Water bill.

Also, in the letter the company explains that in order to promote ‘affordability,’ they changed their tier quantity structure (charge for the amount of water used) to heavily discount the charge for the first 4,488 gallons of water (6CCF) from \$5.0679 (per CCF) down to \$2.0252 (per CCF), a reduction of -\$3.6538 (-64%).

If you live in a small home or apartment in Dixon served by Cal Water in May 2024 your bill might have been \$52.09 (excluding misc. charges) = (\$31.82 (for the 5/8” service charge) + \$20.27 for 4 CCF (2,992 gallons). With the June 2024 increase, your bill will probably be around \$58.94 (excluding misc. charges) = (\$50.84 (5/8”

service charge) + \$8.10 for 4 CCF. This is an increase of \$6.85 (13.2%) from your May 24 bill. The increase in the service charge more than offsets the decrease in the charge for water used.

Cal Water increased their fixed revenue (5/8” service charge fee) and reduced their variable revenue (charge per gallon of water), thereby reducing the decrease in revenue lost from those households that conserve (use less water.) Cal Water is a private company and in the business of making money. Households using less water means less revenue, so to prevent the loss of revenue appears that they just increased the fixed revenue (service charge fee).

By the way, your neighbors across the street from you and who have water provided by the City of Dixon would only be paying \$19.26 (excluding misc. fees) = \$14.34 (service charge) and \$4.92 (4 CCF.) This is -\$39.68 (-67%) lower than what you will be paying with Cal Water. However, those rates will undoubtedly increase in order to cover needed infrastructure improvements.

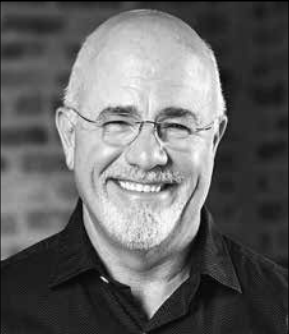

Make sure you do this with a kind spirit, James. Most people in your sister's position already know deep down that they're making bad decisions. So, it's important that you talk to her in a gentle, caring way. See if you can get her to talk about what's really going on with her money. You could even let her know you might consider giving her some money as a gift if you had any extra lying around—and you knew she was in control financially. But you're not really helping someone who's financially incompetent, or just plain immature, when you give them cash or even loan them money.

You're not helping someone if you participate in their misbehavior with

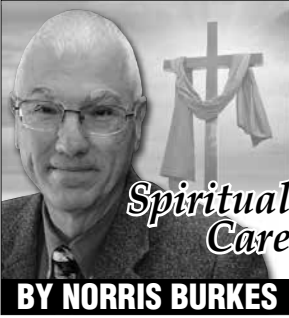
them, so you've got to look at the big picture in situations like this. Your sister hasn't just hit a hard time, with lots of unexpected expenses or a job loss. Right now, her behavior with money isn't just a bump in the road, it's a lifestyle.

# Back to the Grind

If I say “1492,” chances are it’ll bring to mind that old school rhyme, “In 1492, Columbus sailed the ocean blue.”

But now I suspect I’ll remember 1492 in a different light. That’s because last month I flew to Tegucigalpa, Honduras, to sharpen 1,492 pencils.

You say, “That’s an expensive trip for such a menial chore.”

Yes, I get your point, but if you’re a regular reader of this column, you know that Chispa Project needed those pencils for the inauguration of their 88th Honduran library at Pedro Nufio Elementary School.

I know I’m not the sharpest stick in the pencil box, but still I expected the project director to match me to something more in line with my talents.

After all, the director is my daughter, Sara Brakhane. She knows that I’ve spoken to dozens of U.S. audiences. I thought she might arrange a speaking gig in a Honduran soccer stadium.

At the very least, she should have arranged for me to mentor the school’s principal and share the B.F. Skinner Psychology of Education I learned in seminary.

I mean, what’s the harm in a little nepotism?

A lot, apparently.

She assigned me to count pencils, sharpen them, and drop said writing instruments into 421 of the new

school backpacks.

Of course, I wasn’t the only volunteer that arrived on the Dallas connection. The less jet-lagged and talented ones were slotted for important jobs.

Under the direction of Lester Reconco, an artistic Chispa employee, volunteers helped paint a large mural onto the library wall. It was no Banksy or Wyland Whale, but in quick time, our fledgling artists brought the room to life with bright primary colors.

Designed to inspire, the drawing features a Honduran boy in an oceanside scene. He’s reclined on a wave of books while reading. On a field of blue, volunteers added a sailboat, a swan, and multiple fish.

Other artists meticulously painted a line of books that encompassed the room. (Photo on my website.)

Meanwhile my pencil sharpener overheated and forced Sara to assign me to the painting team. However, it was still not the fame I sought.

My job was to pour various paints into red Solo cups, lug them to the talent, and wash their brushes. My nickname was Pour-Pour-Norris.

Suddenly, I became a truly irreplaceable member of the team.

I know this because I begged others to replace me. They would not.

But finally, after two days of painting, the moment came to shelve the books in the new library.

From the school parking lot, our volunteers worked an assembly line offloading 850 new books from our bus. We carried the books through a bustling playground of kids playing soccer and girl-chase-boy games.

Still, several stopped to hug us, sharing broad and cheeky smiles that stretched

for miles and miles. Suddenly we were surrounded by a gaggle of schoolgirls and boys, all grinning with unrehearsed wonder. They weren’t subtle. They wanted to see the new books we were shelving.

If you know the excitement U.S. children express over a new video game, you can conceive the enthusiasm building in these students as they saw their first children’s picture book.

On the final two days, Chispa volunteers hosted the library inauguration, a sort of all-day birthday party. Students rotated among classrooms for hands-on-fun that included puppets, science experiments and storytelling.

I never did get to deliver my Skinner lecture. But I can share with you that, like Skinner, Chispa believes that changing the environment can make education enjoyable and effective for all students.

Books are used to affect that change.

And the school where we were is definitely an environment that needed changing.


This rural school sits near the city’s landfill where many parents work to collect trash, operate the landfill’s incinerator, or commute by bus to a day laborer job.

When we left Honduras, the new library we had painted and filled with rows of new books had changed their environment for the better.

Chispa’s challenging slogan suggests we all “Help change the story.” I like to think that sometimes their stories can be changed, and a sharpened pencil can write that new story.

So, with more libraries coming soon, shall I “pencil you in” for the next volunteer trip? In the meantime, I guess you can say, it’s back to the grind for me. ★

## “SHARK WEEK” DELIVERS ENOUGH SCARES TO KEEP YOU OUT OF THE OCEAN

**“SHARK WEEK” ON DISCOVERY CHANNEL**

The longest-running series on television happens to be the soap opera “General Hospital,” first airing in 1963. Even though “Shark Week” on the Discovery Channel runs for a week every summer, the fact that it’s been on the air since 1988 is still impressive.

This year’s host of “Shark Week” is John Cena, an actor and professional wrestler who actually looks like he might be able to grapple with a shark and survive intact.

Starting on Sunday, July 7, the annual celebration and investigation of shark habits and behaviors kicks off with “Belly of the Beast: Bigger and Bloodier,” one of last year’s most popular shows.

“Belly of the Beast” features a marine biologist, marine scientist, and cameraman traveling to a new location and heading back into the belly of a 29-foot whale decoy with new shark attractant features to create the biggest feeding frenzy ever with 18-foot “Breeder” sharks in New Zealand.

Closer to home, “Makozilla” probes the wave of savage assaults against the sea lion population of California’s coast that has sparked fears of a monstrous predator dubbed “Mako-Zilla.”

Recent discoveries, including a 600-pound mauled sea lion with massive gashes, hint that a 16-foot-long predator could be responsible. A team of shark experts embarks on a mission to unveil the identity of the colossal predator haunting the coast.

The second night brings “Great White Serial Killer: Sea of Blood,” recounting three fatal Great White Shark attacks that occurred off a small Mexican fishing village, including one in which a victim was decapitated.

Shark attack survivor Paul De Gelder joins a shark investigator and a local biologist to launch a plan to identify the killers and keep the villagers in the Sea of Cortez safe.

Tuesday night brings “6000lb. Shark,” where marine biologists go searching for the fattest Great White Sharks off the coast of New Zealand and attempt to obtain their poop to study what they are eating.

I could pass on the excrement research, but these scientists will use cutting-edge science with the aim of weighing a Great White accurately for the first time, revealing if the sharks can reach a staggering 6,000 pounds.

Middle of the week delivers “Great White North” looking into a growing population of aggressive Great White Sharks in an unlikely location, Canada.

Shark expert Andy Casagrande heads out on an expedition along Nova Scotia’s coast to investigate a surge of Great White Shark encounters and figure out if this

new population could be the largest in the world.

Thursday night’s “Monster of Oz,” finds in southwestern Australia an unknown predator with a taste for Great White and Mako Sharks, igniting fears of sea monsters in the abyss. Filmmakers and scientists attempt to track down the killer.

On Friday, “The Real Sharkano” has shark advocate and attack survivor Paul De Gelder (he’s in several of the programs) visiting an ultra-remote island of shark-worshipping natives to see if their secret ways of swimming with deadly sharks holds the secret to humans and sharks living together in peace.

In “Shark Attack Island,” a South Pacific paradise has become a shark attack hot spot with Bull, Tiger, and Great White sharks moving closer and closer to the resort beaches, fatally attacking seven people in the last five years.

On the last night of Saturday, July 13, “Sharktopia” takes us to Indonesia’s Raja Ampat islands, where a team of researchers hunt for one of the region’s last living leopard sharks.

But as they venture deeper into the unknown, the journey brings them face to face with some of the weirdest and wildest sharks on earth.

Using the latest underwater ultrasound and birthing tag technology in “Mothersharker: Hammer Time,” researchers aim to solve the mystery of where the elusive pregnant scalloped hammerheads give birth, and it may be closer than anyone realizes.


With the exception of the first and last nights, three programs air nightly to fill out the “Shark Week” extravaganza with probably more information, particularly on Great White Sharks, that may keep you out of the ocean just like “Jaws” did a half-century ago.

Discovery is not alone in the “shark” game. National Geographic has announced, on the heels of the 50th anniversary of the bestselling book by Peter Benchley that went on to become a box-office sensation, the greenlight for “JAWS @ 50” (working title) to air next summer.

This feature documentary will include footage and photography from the Benchley and director Steven Spielberg files, and all-new interviews from the worlds of film, literature, pop culture, and ocean conservation.

The film will capture our endless fascination (think “Shark Week”) with sharks and the changing dialogue about these awe-inspiring creatures. National Geographic reminds us that they have celebrated sharks for over two decades with their annual “Sharkfest” summer event.


“JAW S @50” is touted as creating a thrilling sense of discovery, showcasing a new generation of ocean scientists and explorers who help us better understand sharks and deepen our understanding of their vital role in a healthy ocean. ★

# Did Political Bias Actually Influence California Court Ruling on Anti-Tax Ballot Measure?

When the California Supreme Court unanimously declared a week ago that a highly controversial tax limitation measure could not appear on the November ballot, its proponents immediately cried foul.

They alleged that a court dominated by Democratic appointees had acted with political motives rather than legal reasoning, ruling that The Taxpayer Protection and Government Accountability Act was a revision of the state constitution and could not be proposed through a citizen’s initiative.

“Clearly, the state Supreme Court has now sent a signal that they are part of the progressive agenda in California, that we are a one-party state in California and there is no independent judiciary in California anymore,” Rob Lapsley, president of the California Business Roundtable, a major sponsor of the measure, told reporters.

In a statement, Jon Coupal, president of the Howard Jarvis Taxpayer Association — another sponsor — was equally critical, saying, “The seven justices of the Supreme Court yielded to the wishes of the political branches (and) put politics ahead of

the state Constitution.

“It is now obvious that all three branches of California’s government — executive, legislative and judiciary — believe the government may decide how much money it needs and raise taxes accordingly, and the voters may not constrain them.”

Given their backgrounds, it’s reasonable to assume that most if not all of the justices may personally dislike a measure to redefine many fees as taxes and put very strict limits on state and local governments’ ability to increase them. But did that cause them to block the measure and cloak their bias in a blizzard of legal language, as the sponsors claim?

The justices seemingly anticipated that its motives would be questioned, stressing “the limited nature of our inquiry” very early in their ruling.

“We do not consider or weigh the economic or social wisdom or general propriety of the initiative,” Justice Goodwin Liu declared, adding, “The only question before us is whether the measure may be validly enacted by initiative.”

A careful reading of the 51-page decision acquits Liu and his colleagues of alleged ideological bias. It’s evident that in drafting the measure, proponents overreached by making very fundamental changes in California’s governance system, amounting to a revision of the Constitution that can only be proposed by the Legislature or a constitutional convention.

The court said the measure’s most obviously revisionist aspect

would have compelled the Legislature to submit any tax increases to voters for ratification, thereby impairing legislative taxation powers that have been part of the state’s structure for its entire 174-year history.

“No speculation regarding potential future consequences is needed to conclude that the (Taxpayer Protection Act) is a revision on its face,” Liu wrote. “The measure would fundamentally restructure the most basic of governmental powers. The TPA would exclude the levying of new taxes from the Legislature’s control by requiring voter approval of all such measures.”

Some critics have suggested that the current court would have invalidated Proposition 13, the iconic 1978 property tax limitation measure. But Liu also addressed that, writing that Prop. 13’s changes “operate functionally within a relatively narrow range to accomplish a new system of taxation which may provide substantial tax relief for our citizens. We decline to hold that such a limited purpose cannot be achieved directly by the people through the initiative process.”

In other words, had the Business Roundtable and Coupal’s group proposed less sweeping changes in taxing authority, such a measure may have survived the legal challenge that Gov. Gavin Newsom, the Legislature and local governments mounted.

Given the legal uncertainty in California about who can levy what taxes on which activities, a clarifying ballot measure would be welcomed. ★

# Social Security Matters

## Grieving Husband Asks About His Survivor Benefits

**Dear Rusty:** My wife died May 4, 2024. I notified Social Security, and they have removed the direct deposit made to my joint checking account on May 8, 2024. What are my options now for obtaining any benefits from my wife’s Social Security account?

**Signed: Grieving Husband**

**Dear Grieving Husband:** Please accept our sincere condolences for the loss of your wife. Rest assured that we’re here to assist with any Social Security questions you may have at this difficult time.

FYI, a person must live the entire month to be eligible for SS benefits for that month (Social Security benefits aren’t paid for the month a person dies). For this reason, and as a matter of standard protocol, Social Security instructed the bank to return any payments received for your wife after her death. This is often referred to as the “claw back” rule.

In some circumstances, however, Social Security “claws back” money

which rightfully belongs to the deceased, as they did in this case. Your wife’s Social Security payment received on May 8th was her payment for the month of April, and she was fully entitled to that payment because she lived for the entire month of April. I suggest that you download, fill out, and submit Form SSA-1724 to your local Social Security office to recover that May 8th payment, which rightfully belongs to your wife’s estate. Note that the bank will automatically return any future SS payments received for your wife.

As your wife’s surviving spouse, you are also entitled to a one-time lump sum “death benefit” of \$255, which you can request by calling your local SS field office (get the number at [www.ssa.gov/locator](http://www.ssa.gov/locator)), or by calling 1.800.772.1213. During that call you can also explore whether you are entitled to any additional SS benefit as a surviving spouse.

If your wife’s monthly SS retirement benefit was more than your current monthly SS benefit, you will be entitled to receive her higher monthly amount instead of your own smaller amount (FYI, if you haven’t yet reached your own full retirement age your survivor benefit will be reduced). And if you are not yet collecting your own SS benefit, you have the option to claim your survivor benefit from

your wife first while allowing your personal SS retirement benefit to continue to grow, up to maximum at age 70 if you like.

Just be aware that if you haven’t yet reached your full retirement age (FRA) and you are still working, any SS benefit you take before your FRA will be subject to Social Security’s “earnings test” which limits how much can be earned before they take away some of your SS benefits. The 2024 annual earnings limit is \$22,320 (changes annually) for those who claim prior to the year they attain full retirement age, and SS will take away \$1 of benefits for every \$2 over the annual limit. The “earnings test” no longer applies after you reach your full retirement age.

# Legendary Locomotive Makes 19 Whistle Stops

## Big Boy No. 4014 Features Public Display Days in Roseville

**NORTHERN CALIFORNIA REGION (MPG)** - Union Pacific’s legendary Big Boy No. 4014, the world’s largest operating steam locomotive built to conquer mountains, will make 19 whistle-stops in five states this summer during its 2024 Westward Bound Tour from Wyoming to California.

### Big Boy History

Twenty-five Big Boy locomotives were built for Union Pacific to haul freight over the steep grade of the Wasatch Mountain Range in Utah during World War II. Eight were preserved after the locomotives were retired six decades ago, but only Big Boy No. 4014 is still in operation.

During World War II Union Pacific operated some of the most modern and powerful steam locomotives ever built. Among them were the famous “Big Boys,” the largest steam locomotives in the world. Working with them were the “800-class” high-speed passenger locomotives, as well as hundreds of older class steam engines. Union Pacific’s steam

legacy continues today with the preservation and operation of its historic fleet – No. 844 and No. 4014.

“With the Roseville railyard being the largest rail facility on the West Coast, handling 98% of all rail traffic coming into Northern California, we are all excited to view and experience this rolling museum of rail history in Downtown Roseville,” said Roseville City Councilmember Scott Alvord.

Alvord and his wife, Karen, previously owned a restaurant on Vernon Street, parallel to the Roseville train tracks, for 12 years. “The railroad has always given Roseville character,” he said, which is why they chose that restaurant location.


