**YUBA CITY, CA (MPG)** - It was nearly 90 degrees at 9:45 a.m. when children began filling up the intersection of Plumas and Center streets in Yuba City on July 4.

At the forefront, the usual suspects of this annual event could be seen, including the Color Guard, Yuba City Police Department members, the Yuba City Fire Department and local

officials such as Dave Shaw, Wade Kirchner and Marc Boomgaarden.

"This is definitely one of the highlights of our job," said Yuba City Mayor Shon Harris as he and his team began gathering the horde of kids into numbered rows.

As the children squirmed to get into place, Jerry Gregg, one of Yuba City's primary event photographers, eagerly began snapping away at the crowd.

"I've only photographed this about

three times," said Gregg. "The first time, I didn't even know that it went all the way down to the fountain. Next year, I'm hoping that we can get my grandson in it."

For many, the Children's Parade has been a tradition that goes back more than a quarter century. The festivity calls for all to join in a nearly half-mile trek, either on foot or on a non-motorized wheeled device of their choosing. Most opted for

## West Nile Virus Found in Yuba County

& Vector Control  
District News Release**

**YUBA COUNTY, CA (MPG)** - The Sutter-Yuba Mosquito and Vector Control District has detected the first evidence of West Nile virus (WNV) in Yuba County this year.

One mosquito sample collected on June 25 in the east Marysville area tested positive for West Nile. Thus far this year, the district has had no detections of West Nile virus in dead birds, sentinel chicken flocks or humans.

But hot daytime temperatures are hastening mosquito production, with traps showing an increase of this West Nile virus vector for this time of year, according to the Sutter-Yuba Mosquito & Vector Control District. The district's surveillance system continues to be in full operation and mosquito control efforts are being instituted in areas where detections are made.

The Sutter-Yuba Mosquito and Vector Control District reminds the public that prevention of mosquito bites is the best way to protect against West Nile virus and other mosquito borne viruses at home and when traveling. Taking simple steps to prevent mosquito bites are the best ways to keep you and your family healthy.

Remembering the four "D"s is an easy way to help prevent mosquito bites, according to the district:

D - DEET - apply mosquito repellants containing DEET, picaridin, oil of lemon eucalyptus or IR3535 when mosquitoes are active or biting. These are the EPA-approved mosquito repellents recommended to prevent bites (<https://www.epa.gov/insect-repellents/find-repellent-right-you>). Always follow package instructions for appropriate age and directions for use.

D - Dawn and Dusk - limit outdoor activity at dawn and dusk when the mosquitoes that carry West Nile virus are most active. Wear long sleeves and pants if you must be outdoors when mosquitoes are present.

D - Doors and windows - keep screens in good repair and keep mosquitoes out by making sure that the screens on your doors and windows are not broken or torn.

D - Drain all standing water around the outside of your home, including buckets, jar lids, tires and flowerpot trays. Report green swimming pools to the district.

**GRIMES, CA (MPG)** - As you work your way over the Meridian Bridge down Highway 20 towards Colusa, you'll approach a left turn off the highway that says "Grimes." Take that turn and you'll truly find yourself immersed in farm country.

Winding through the country roads towards Grimes, there's a heartland feel with every cornfield, hay field, and vegetable crop you pass - all in different states of the agriculture cycle. Even in the midst of this Independence Day holiday, farmers could still be seen hard at work riding their tractors, tending to their fields, and checking irrigation pumps along the canal.

Pulling into town and parking in the shade of grain silos, a small town Fourth of July celebration was starting to take shape. An energetic buzz fills the air as residents and vendors chatter, selling their goods and painting the picture

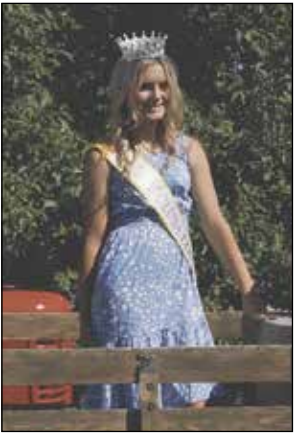
of small-town America. The parade in Grimes, population of about 350, comes alive with the patriotic spirit of American Independence.

The parade then begins to move through the crowd followed by the Grand Marshal riding in the back of a boat and local children and families on bikes leading the way.

But the true highlight was the stream of vintage World War II vehicles and those representing different eras and branches of the Armed Services. Each one was adorned with flags and carried a crew of smiling

# California State Fair Honors the State’s Agricultural Industry, with Much to See and Enjoy!

**SACRAMENTO REGION, CA (MPG)** - The 170th California State Fair offers 17 days of old-fashioned fun for the whole family, from July 12 to July 28.

Lucky for us that we don’t have to drive too far; the first state fair sponsored by the California State Agricultural Society, was held in San Francisco on Oct. 4, 1854, and rotated to different cities for the next six years. In 1861, however, Sacramento became the permanent location for the extravaganza.

While today’s California State Fair still honors the state’s agricultural industry, there is much more to see and enjoy at the annual event.

There are plenty of activities for all ages. That

includes eating funnel cakes, waffles to sliders; listening to top musicians; riding Butler Amusements’ thrilling Zipper to the classic and calmer Crown Merry Go Round; and checking out competitions and exhibits that feature our neighbors’ talents and skills.

Besides the nightly concerts, entertainment is ongoing each day. For starters, there’s the Tanzanite African Acrobats, the Stilt Circus and the Salsa Steel Band.

The many competitions include the Open Livestock Show with beef cattle, sheep, Boer goats, dairy cattle, dairy goats, Nigerian dwarf goats, pygmy goats, angora and fiber goats, longhorn cattle, llamas and alpaca.

And the always popular Junior Livestock competition spotlights the dedicated youth FFA members with their beef cattle, sheep, swine, goats, dairy cattle and dairy goats.

Exhibits range from a Candy Maze Selfie Exhibit, a Student Showcase & CA Crafts Exhibit, Animation

Academy to a fine art and photography exhibit.

The California State Fair is open different hours of the week.

Main Gate and Blue Gate hours are from 11 a.m. to 10 p.m. Monday through Thursday and from 10 a.m. to 10 p.m. Friday through Sunday.

Green Gate opens at 2 p.m. Monday, Wednesday, Thursday and Friday, and at 11 a.m. Tuesday, Saturday and Sunday.

Carnival and Skyride hours are from 2 to 11 p.m. Monday, Wednesday, Thursday and Friday, and from 11 a.m. to 11 p.m. Tuesday, Saturday

and Sunday.

Kids Park hours are 1 to 11 p.m. Monday, Wednesday, Thursday and Friday, and 11 a.m. to 11 p.m. Tuesday, Saturday and Sunday.

Exhibit Building hours are 11 a.m. to 10 p.m. Monday through Thursday; and from 10 a.m. to 10 p.m. Friday through Sunday.

The Monorail opens at 11 a.m. Monday through Thursday, and at 10 a.m. Friday through Sunday.

Tickets can be bought online at <https://calex-postatefair.com/tickets> or at the fair’s box office. Several ticket prices and packages are offered. Daily tickets to the fair and food festival

start at \$16 for adults (\$14 in advance), \$12 (\$10 in advance) for seniors 62 and older and \$10 (\$8 in advance) for children ages 5 to 12. Fair admission is free for children 4 and under.

In addition, a Family Fun Pack is \$49.99 and includes four single-day general admissions, four ride tickets (each good for one ride in the Carnival or on the Monorail), and a parking pass.

The Toyota Concert Series is free with fair admission ticket in the area behind the General Admission seating area to the first 700 concert-goers. Seats can also be reserved, starting at \$25.

Parking is \$15 a day or three days for \$30.

There are also different prices for the carnival rides, starting at \$1 per ticket and carnival fast passes from \$10 to \$15. An Unlimited Ride Wristband bought at the Carnival is \$39 Mondays, Wednesdays and Thursdays, and \$44 Fridays, Saturdays and Sundays.

Cal Expo is at 1600 Exposition Blvd. in Sacramento, northeast of the American River.

**MATHER, CA (MPG)** - The 18th annual California Capital Airshow, presented by Sacramento County in partnership with the City of Rancho Cordova, runs from 3:30 to 9:30 p.m. July 13 and 14 at Mather Airport in Sacramento.

The two-day event will feature an extraordinary lineup of performers, including the Italian jet team, Frece Tricolori, and the United States Air Force Thunderbirds, plus miles of ground attractions and the return of nighttime aerial performances concluding with a massive pyro-musical fireworks and 500-drone show.

The Airshow is part of Frece Tricolori’s first North American tour in more than 30 years and is the only location in the Western United States where spectators can witness its full performance. Frece Tricolori consists of 10 high-flying Aermacchi MB-339 aircraft, making it the Guinness World Record holder of the most jet aircraft in a military aerobatic display team.

Aerial performances will run 5:30 to 9:30 p.m. both days and will begin with the United States Air Force Thunderbirds, followed by Frece Tricolori, U.S. Navy

F-18 Super Hornet, U.S. Air Force F-35 Lightning and C-17 Globemaster demo teams, and an impressive roster of highly-skilled civilian performers.

Tickets are still available for purchase at [CaliforniaCapitalAirshow.com](http://CaliforniaCapitalAirshow.com) and will not be sold at the gate. Adult General Admission tickets start at \$42.50 and each ticket includes free admission for up to six youth (ages 15 and under) and free parking. **YUBA CITY, CA (MPG)** - Entering and exiting here has some new flare.

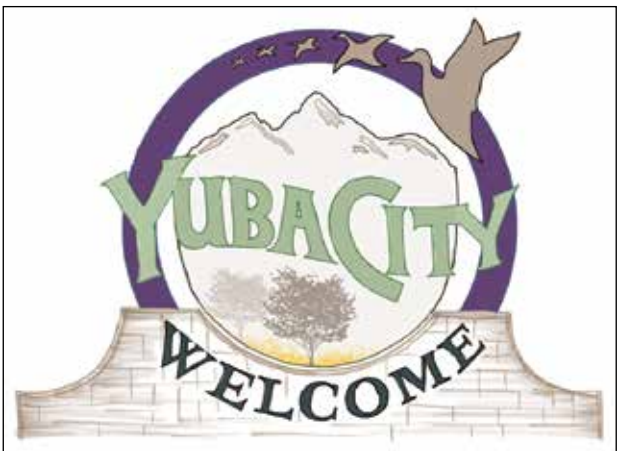
Winning artist Raveena Sroya's decorative Yuba City welcome sign display transforms the present banner from disrepair into a symbolic hello and good-bye. The winner of the community-wide competition's use of color, wildlife, and agricultural references perfectly depicts Yuba.

After creating the committee in March, the City Welcome Sign Ad Committee, which included Councilmen Wade Kirchner and Michael Pasquale, narrowed down 10 artists to three in May. The committee evaluated each entry on creativity, alignment with city branding, aesthetic appeal, community relevance, implementation feasibility, and overall impression.

"A Welcome Sign Design Competition was initiated to engage the creativity and talents of our residents, inviting them to contribute to a lasting symbol of our community's identity," Mayor Shon Harris said. "The competition received submissions from individuals of all ages and backgrounds, demonstrating the diverse artistic talent and civic pride present in our city."

City Manager Diana Langley said entrance signs make an impression on those traveling through a city.

"With the need to replace the previous signs, the City Council and staff saw an opportunity to engage with the community and

solicit design concepts for new signs," Langley said. "It was exciting to receive ten design concept submissions, all reflecting different aspects of our community."

Langley said that Yuba City's development liaison Ashley Potocnik "did a fantastic job coordinating the Call for Artists, convening an Ad Hoc Group to review the design concept submissions and select the top three and then bringing the top three designs to the entire City Council for selection of a winner."

"Ashley's enthusiasm for this project reflects the dedication and professionalism that she applies to assist anyone interested in developing in Yuba City," Langley said.

Langley cited Sroya's description of the winning sign that details Yuba City in each feature:

"The design uses the existing masonry base. The central feature of the design is the Sutter Buttes carved out of the top of a circle. The words Yuba City would be mounted to this background using the City's primary color, 'Drake.'"

"Circles are a symbol of unity which is important with a diverse community such as we have in Yuba City, so I've added a ring around the sign using one of the City's accent colors to show this. Smaller details include orchard trees and birds to highlight the city's agricultural community and wildlife. The birds and lettering are taken from the City's logo for consistency with the city brand."

The notable artist received an oversized check for \$200 from the Yuba City City Council, complemented by praise and a proclamation for her creative contribution to the community.

"The winning design will not only serve as a gateway to our city but also as a source of pride for our residents and an inviting symbol for visitors," Harris said.

The mayor acknowledged, and thanked the nine other artists, whose "submission has added value to this initiative and highlighted the artistic spirit of our community." ★

decorated bikes, scooters, skates and wagons, although a few strollers and push carts also made it into the mix.

The parade traditionally starts with a brief announcement and the Pledge of Allegiance before setting off. To avoid overcrowding, local officials released the flood of riders one row at a time, which accumulated into hundreds of riders gliding south toward the Town Square fountain.

Their arrival was greeted by live music triumphantly floating into the air, courtesy of the Yuba Sutter Symphony under the direction of Corey Kersting.

"Corey believes this is his 12th year; he thinks they started in 2012," said Morgan Kersting, Kersting's wife. # SCSO Boat Patrol Saves Drowning Male

- On Sunday, July 7, Sutter County Sheriff's Boat Patrol was patrolling the area of Feather River Parkway when deputies noticed a group of subjects on a beach, just below the 5th Street bridge motioning for help. Our boat patrol deputies immediately noticed a subject thrashing in the water, approximately 100 yards from the riverbank, caught in heavy current. The victim was later identified as an adult male. He was in

obvious distress and not wearing a lifejacket. Boat patrol deputies responded to the location of the drowning male, and were able to throw him a life-jacket and rescue rope. After securing the male safely into our vessel, boat patrol deputies also noticed two female adults on rafts, who were caught in heavy current after attempting to save the male subject. The females were roughly one quarter of a mile down the river and were also recovered safely.

All three victims were transported back to their vehicles and no medical attention was needed. ★

## Environmental Opposition to Vital Sacramento Area Highway Project is Ridiculous

Some things are just so ridiculous that they demand critical attention. One of them is the opposition from environmental groups to widening the Interstate 80 freeway between Sacramento and Davis.

For years, motorists have complained about what has been dubbed the “Davis bottleneck” that often backs up traffic for miles. What should be no more than a 10- or 15-minute drive can often take 45 minutes or more.

The state Department of Transportation wants to convert median strips into new traffic lanes that would require a toll payment to traverse. Environmentalists, who are trying to block the project in court, contend that it would merely encourage more drivers to use the stretch of freeway and therefore relief from congestion would be only temporary.

Opponents also complain that Caltrans and local officials are using the subterfuge of improving pavement to widen the freeway, and that the project runs counter to official state policy of reducing vehicular traffic as a way to reduce greenhouse gasses.

“These projects are being oversold to the public as a way to reduce congestion; they are not,” Susan Handy,

director of the National Center for Sustainable Transportation, told the Los Angeles Times. “A court decision is going to be very important.”

Ironically, Handy’s organization is housed in the UC Davis campus, where the chronic congestion spills over.

The complaints might have some validity if this stretch was merely another local commuter route, but it isn’t. Interstate 80 is one of the nation’s most important transcontinental arteries, running 2,901 from San Francisco to the New York City metropolitan area with much of its route in western states following 19th-century immigrant trails.

The only other east-west interstates are either hundreds of miles to the north or hundreds to the south. That makes I-80 an extremely important route for interstate cargo, a fact evident to anyone who shares the freeway with an endless stream of large trucks.

Moreover, there are no alternative routes because the eastern portion of the freeway is a causeway over a marshy area that’s home to wildlife and is often flooded during winter and spring months. Water is diverted into the “Yolo Bypass” from the Sacramento River as an important element of the Sacramento region’s flood protection system.

Simply put, trucks and cars must either use I-80 between Sacramento and the Bay Area or not move at all. The notion that widening will increase traffic is ludicrous: The traffic will be there regardless because it has nowhere else to go.

“We experience some of

the most severe congestion in California seven days a week,” Autumn Bernstein, executive director of the Yolo Transportation District, told the LA Times. “We have more than five hours of congested traffic in the eastbound direction and (in) Davis every afternoon.”


The ultimate fate of the project is not certain. The California Transportation Commission gave its approval in May and allocated money to begin work, but the environmental groups are suing, characterizing it as a showdown over the state’s official policy of avoiding projects that increase carrying capacity and lead to more traffic.

It’s unfortunate that Caltrans officials decided they needed to hide expansion of the freeway as a pavement improvement project and make it a joint project with local officials — with some token funding for mass transit — to sidestep a direct confrontation over environmental impacts.

In a more rational world, the need would be obvious, and officialdom would be criticized for waiting so long to do something about a bottleneck.

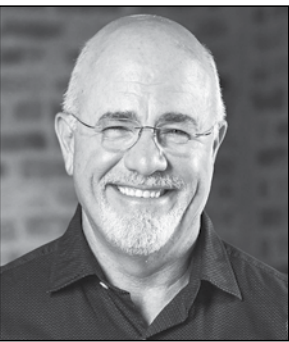

not to use credit cards, and why they shouldn't. So, I can't very well go around encouraging folks to just swipe their credit cards when they buy from my company.

For starters, that client is way out of bounds. It's not their place to tell you how to run your business. But you're lucky to only have one person getting pushy about the whole credit card deal. Everything about the credit industry today is out of control. But even though your case is a little different than mine, you have every right to not accept credit cards—especially if you have a moral or values-related issue with the product.

As time goes by, you'll probably have a few other people turn up their noses at the idea of not being able to pay with a credit card, but if you consistently offer great services or products at great prices, those experiences will only be a bump in the road. You don't want to be argumentative when things like this happen, so maybe you can just smile, and let them know you always appreciate input from your clients.

I'm sure you and your husband work hard to make your business the best it can

be. The fact that you're still around over a decade after opening up shop is proof of that. You've probably realized, too, that being in business for yourself isn't all sunshine and rainbows every day. Regardless, no one has the right to get in your face over how your business is structured or try to push you into doing things differently. Listening to, and evaluating, suggestions from clients only makes sense. It's a smart thing for any business owner to do. But this one client is saying you should change a long-standing operating principle based on a whim—their whim.

### USDA begins accepting applications to help dairies impacted by Avian flu

The U.S. Department of Agriculture began accepting applications Monday for financial assistance to dairy producers who incur losses due to Highly Pathogenic Avian Influenza. The funds, to be provided through the Emergency Assistance for Livestock, Honeybees and Farm-raised Fish Program, would assist in covering a portion of financial losses resulting from reduced milk production when cattle are removed from commercial milking in dairy herds after a confirmed positive avian influenza test. Twelve states have reported dairy cattle infections.

### Study Examines Improved Tomato Storage to Curb Postharvest Loss

Some 30% of harvested fruits and vegetables worldwide are never eaten due to damage, spoiling or appearance. Now researchers at University of California, Davis, are studying ways to extend shelf life to help California tomato growers avoid postharvest crop loss. New published research examines changes in tomatoes at the molecular level to better understand what happens during postharvest handling and cold storage. Researchers say the findings may help establish optimal tomato handling and storage guidelines to reduce food loss and waste.

### Researchers Study Biochar Filtration for Purifying Reclaimed Water for Crops

Researchers in California are testing potential low-cost technology to make reclaimed water safer for agricultural use. A \$1 million project being undertaken by scientists at the U.S. Department of Agriculture's Salinity Laboratory at University of California, Riverside, is testing the effectiveness of biochar in filtering the reclaimed water. Researchers say using biochar polishers could potentially remove the need to detect antibiotics, assisting treatment plants that do not have advanced detection or treatment technologies.

### American Farm Bureau Federation: Fourth of July Cookout gets more Costly

Families celebrating the Fourth of July holiday will continue to find stubbornly high prices at the grocery store, according to the 2024 American Farm Bureau Federation annual market basket survey. An Independence Day cookout will cost \$71.22 for 10 guests this year, with the grocery bill up 5% from 2023 and almost 30% from just five years ago. A \$7.12 per-person cost represents a record high since AFBF began the survey in 2013. The cookout favorites include cheeseburgers, chicken breasts, pork chops, homemade potato salad, strawberries and ice cream. ★

## The Student Housing Market

My daughter is going to be a junior at UC Santa Cruz this fall and had to move out of her college sponsored apartment. The housing market is extremely tight in Santa Cruz, like many college towns, and having lost the lottery to keep her apartment, we are now tossed into the fray of competing with hundreds of other families looking for a place for her to live.

Spending a few days viewing the available rentals last week, I quickly realized the housing situation in Santa Cruz is beyond ridiculous.

Think of the worst motel room you can imagine with a small kitchenette with about 500 square foot in total, running from \$2500 a month or more.

Yes, it's that bad.

Add in the fact that every available place we saw was either rented or had an application or three already submitted. Since the market is so crazy, managers are slow to return calls, websites are inaccurate or don't function very well and what websites do work are inundated with applicants.

Santa Cruz is not ideally situated for easy access. If one wants to go further out to find something, you face monumental traffic concerns adding 30 minutes of stop and go driving in almost every direction.

It became apparent that to find a place, we had to switch gears and adopt the method of simply driving around and stopping in every apartment complex we could find that looked safe and trying to find a resident manager so we could inquire about something that might be coming vacant soon but had not yet been listed.

Similar to one of the best ways to find a used car to buy, we had more success driving all over town and doing the footwork needed and hopefully get lucky than competing in the public marketplace of the web. In my past articles on how to find a used car worthy of owning, although the public web is a good place to find your ride, some of the best cars I have found have simply been stopping at a parked car with a for sale sign on it.

Using old fashion footwork, you eliminate much of your competition by finding something that is not exposed to the many buyers that peruse the web looking for the same deals you are.

Truth be told, we found a jewel of a cottage up on the hill overlooking both the amusement park and the beach that had not been listed and, wrestling with the uninspired agent and barely functioning application web page, we may have successfully found a place. A rather nice

place in fact, without the competition of the internet.

I say may, because although it looks promising, we have not yet received the final say on whether we have the place as of the time of this writing.

It's easy to blame the greed of landlords for such a fiasco as the Santa Cruz housing market is, but the fact of the matter is prices are ridiculously high because the demand there is off the charts.

Thank goodness they're kids living in these places because truthfully, unless you're willing and able to pony up at least three grand or more a month to house your kid, they're going to be living in a fecal crater of an apartment and most kids are happy just having a place of their own.

Speaking to acquaintances around town I often hear the suggestion that there should be something done to rein in rents such as implementing rent control or forcing landlords to drop rents to reasonable levels (whatever that is), but such measures stymie free market fundamentals which would make housing even less available.

True, such edicts as rent control might drop rents for some, but many more applicants would not be able to find a place at all. Either that or a black market for housing would pop up which might eliminate the protections offered by housing authorities as renters sign away their rights to report deficiencies or dangerous conditions in exchange for that coveted lease.

Compounding the problems is that a portion of the low cost rentals are being taken up by publically assisted tenants which have a portion or all of their rent paid by government programs. When private applicants who have limited funds compete with government funds and housing edicts, the available inventory of student housing is further reduced, making the situation even more difficult.

# Man Arrested for Setting Backfire During Thompson Fire

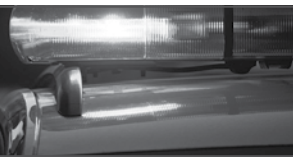

# New Noise Ordinance Exceptions Waste and Rogue Management

**YUBA CITY, CA (MPG)** - No need to turn down the music after 10 p.m. in the downtown business district.

A downtown noise ordinance exception was the topic of conversation at the June 18 and July 2 Yuba City Council meetings when the first reading was waived for adopting the new law.

Deputy Director of Development Services Doug Libby presented City Council members with new noise regulations extended from 10 p.m. to midnight for entertainment activities associated with restaurants, bars or other approved locations in the downtown business district.

Libby detailed the background, noting that individual City Council members supported developing the downtown area into an entertainment zone to draw visitors.

“This is encouraged today by the Downtown Business Association’s annual Summer and Winter Stroll events and other activities,” Libby said, noting the current regulation limits noise associated with large gatherings at 10 p.m.

“Although that is really appropriate for a residential area if you are trying to encourage any form of nightlife in your downtown area, it presents some challenges,” Libby said.

According to Libby, the current noise ordinance excludes emergency response vehicles, parades and legal fireworks. Exemptions are also provided for publicly-owned land, religious activities, railroad activities, the Yuba-Sutter Fair and organized sports events.

Libby detailed the exact location for the exception that applies to properties zoned community or general commercial, including fronting Plumas Street between Colusa Avenue (State Highway 20) to Bridge Street and properties fronting Center Street between Plumas and Shasta Streets.

If the noise level is too loud for some, the “city reserves the right to require a noise study to be prepared at the business’s expense if it is believed noise impacts will not be mitigated,” Libby said.

“This is really a first step into developing our downtown into more of an entertainment area,”

Libby said, noting the Central City Specific Plan is 32 years old. “It requires updating.”

Libby said the city anticipates receiving \$350,000 from a Federal Reconnecting Communities Grant through the Sacramento Area of Council of Governments (SACOG).

“This will involve a lot of community outreach to get input from not only individual citizens but as well the businesses on how they want to see the downtown area develop for the next thirty years,” Libby said. “This will include updated noise analysis.”

Libby informed City Council of the published public hearing notice for the exception, exempt from environmental review. Libby recommended that officials adopt the noise ordinance exception and waive the first reading.

Resident Sumiko Sprague, who has lived on Shasta Street for 14 years, said her residence is “directly affected by this ordinance.”

“A major issue I already have is that the current ordinances aren’t even followed,” Sprague said. “It’s consistent; whenever any event happens, the sound prolongs past 10 o’clock. It’s been that way for as long as we have been there.”

The resident questioned the officials’ motives.

“At this point, I don’t see how extending it to midnight is going to change anything. What regulations are in place for that to be managed if it’s not already being managed?” Sprague asked officials.

Sprague also questioned drawing more entertainment to what she called the predominantly family-oriented community.

“Is the entertainment extended from 10 to 12 really what Yuba City is trying to enhance?” Sprague asked.

Attempting to portray “a nightlife” vibe is not attractive to Sprague, who said that after living in the region for 14 years, it is not that. According to Sprague, any change should enhance daytime events, including Summer Stroll.

“I would like to very much oppose extending anything when we are not even respecting what exists currently,” Sprague said.

On the other side of the ordinance, Yuba City Downtown Business Association board member Sandy Drown defended the exception with thanks “for granting us the opportunity to establish this ordinance in harmony with the vision of our organization.”

Drown thanked Councilmember Dave Shaw and city staff, including Libby, for their “invaluable contribution” to making the resolution possible.

“We have had several discussions to collaborate and advance this initiative,” Drown said.

Drown countered Sprague, saying Summer Strolls end at 9 p.m.

“I help close down all the strolls, and at 10 o’clock, there is no music because we don’t have that opportunity,” Drown said.

On the contrary, Drown said, “This ordinance would give us an opportunity to make that event later because of the heat for our community and others to enjoy.”

Mayor Shon Harris addressed Sprague, encouraging her to contact the facilities that are not respecting the ordinance as it stands.

“One-hundred feet notwithstanding, I don’t think anyone wants to have any bad feelings,” said Harris, adding that the intent is to provide entertainment options for the community and business owners. “No one wants to create problems for you.” ★

Cities and counties in California are rife with waste, celebrity-style salaries and rogue management. On rare occasions, officials are arrested for exploiting hard-working taxpayers.

In 2010, Bell (35,000 pop) City Manager Robert Rizzo was sentenced to 12 years in prison. Five other officials, including four City Council members and the assistant city manager, were charged with misappropriation of public funds and received sentences. The people that should have served as checks on the plunder were in on it. They all gave one another extraordinary salaries and benefits, Rizzo with \$1.5 million.

Rizzo's assistant, Angela Spaccia, took \$376,288 a year, more than the top administrator for Los Angeles County. Police Chief Randy Adams received \$457,000, 33% more than Los Angeles Police Chief Charlie Beck. All three resigned following news reports and a public protest. All but one of the members of the City Council received \$100,000 annually for their part-time position.

The salaries were made possible by a sparse turn-out special election, giving the city "Charter" status. By comparison, council members in cities similar to Bell’s size make an average of \$4,800 a year, prosecutors noted.

The California Attorney General filed the charges against Bell officials.

In 2018, Gridley Chief of Police Dean Price retired/ resigned after his salary was

publicized. Price received \$329,621 in total compensation. Gridley is 2.1 square miles with 7,000 residents.

Yuba/Sutter officials are frantically raising executive salaries while screaming that they are out of money and must cut services.

Most Yuba County Supervisors are supporting a child car seat project (\$140,000) that provides free seats at a cost of more than \$1,000 each. Less expensive seats can be had for under \$100 online or at a store.

It is illegal to transport small children without a car seat. However, are Yuba County parents unable to afford a car seat or figure out how to install it in a car? Ninety-nine percent of parents solve this on their own.

If you offer free turkeys at Thanksgiving, even people that can afford one will take a hand-out. The county bureaucrats will consider it a banner accomplishment if they distribute 100 plus car seats for \$140,000.

The challenge is this. “County Health” (an oxymoron) must concoct some reason to exist. Historically health was maintained by families, private doctors, clinics, hospitals etc. There are no studies finding that health bureaucrats are the Gurus of Well-Being. In fact, their medical advice is often wrong, will make you sick, or kill you. Look at the medical recommendations on county websites.

It’s like our literacy rate. The country was literate before government usurped education. Now, “Johnnie can’t read.”

Sometimes there are outlier examples where a leader reforms the obese, invasive monster called government.

Indianapolis Department of Parks and Recreation had a problem. The end of the 1992 fiscal year was near with money left in its budget. Rather than return the "extra" money to the general fund and risk having a smaller

future budget, the department decided to stock up on supplies.

So, now it’s February and stored in the department's warehouse is a 40-ton mountain of chalk. The four-year supply—enough to line a baseball field with 101 miles between the bases—is now useless.

Why? To save money / time, the department then switched to spray paint ball-field lines. More efficient and cost-effective.

When the heap of obsolete chalk became known, new Indianapolis Mayor Stephen Goldsmith didn't berate park officials. He called media attention to the perverse incentives that make it rational for bureaucrats to purchase 1,600 50-pound bags of chalk. "The problem is they are trapped in a system that punishes initiative, ignores efficiency, and rewards big spenders," said the mayor.

Goldsmith eliminated about 450 of 4,700 full-time employees from the city's payroll in his first 16 months, including 160 mostly managerial-level employees within the first three months. They conducted a city garage sale, liquidated unused stuff, sold-off excess properties, and ended leases on unused spaces.

All government services were vetted. What was provided? Why? Could it be done better and cheaper by others? Taxpayers are stuck with fewer lifelong salaries of government employees when private contractors do the work.

Goldsmith turned financial disaster into a national model for governance. When officials today say it can’t be done, they mean they don’t want to do it. They need to go.

# Grand Jury Addresses Missile Site Contamination

**NORTHERN CALIFORNIA, CA (MPG)** - One of the 2023-2024 Placer County Grand Jury Final Consolidated Report’s 13 individual reports addressed the trichloroethylene (TCE) contamination spreading today from a Lincoln Titan 1-A Missile Site that closed in 1965.

The 58 county grand juries, made up of interested community members, investigate operations of the various officers, departments and agencies of local government, according to California Courts, Judicial Council of California.

The grand jury is part of the county judicial system authorized by the California State Constitution.

What’s striking about this year’s report is that the grand jury took on the missile site’s contamination that falls under the responsibility of a federal agency, the U.S. Army Corps of Engineers and the state’s Central Valley Regional Water Quality Control Board. The Water Board oversees what corrective

actions the Army Corps will finally take to eliminate the TCE.

The areas which are not within Placer County Grand Jury jurisdiction include federal agencies and state agencies.

Yet the Placer County Grand Jury addressed today’s contamination spreading into a Lincoln active-adult community from the missile site because “it is important to educate the citizens of Placer County about this issue. Cleanup of former military sites contaminated with toxic chemicals such as TCE is a lengthy process. The process typically involves assessments, cleanup plans and implementation, with involvement from multiple stakeholders. It is crucial to prioritize safety and effectiveness in these cleanup efforts.”

The grand jury’s 18-page report, “From Missiles to Meadows: Restoring Nature’s Balance,” stressed that the former Lincoln missile site “poses environmental health risks due to past activities, including chemical use, chemical spills and unexploded ordnance (military

supplies such as weapons, rockets, or armor). The source of contamination is trichloroethylene (TCE), a solvent which was used to clean the liquid oxygen Rocket Propellant-1 piping and was discharged into the ground...”

The grand jury found that “Cleanup efforts will require soil remediation and groundwater monitoring to mitigate environmental impacts.

To date, no remediation efforts have been completed, resulting in health and environmental concerns from the community. Without cleanup efforts, the contamination poses a risk to the surrounding environment and public health. It is essential for proper authorities to prioritize and initiate cleanup efforts to address these potentially serious hazards. This remediation project underscores the importance of monitoring and managing environmental contamination at former military sites to ensure public safety and environmental preservation.”

A little history is in order. The

54 former intercontinental ballistic missile (ICBM) silo sites in California, Colorado, Wyoming and Washington built during the Cold War in the early 1960s were designed to destroy enemy targets anywhere around the world within an hour of launch.

The two-stage missiles were stored in underground silos and raised to ground level for launch, according to the Library of Congress. Furthermore, each complex consisted of three missile silos supported by a network of underground fuel storage tanks, equipment terminal, antennas and connecting tunnels.

Beale Air Force Base 851st Strategic Missile Squadron oversaw Northern California’s triangle of Titan I missile silo complexes in Lincoln, Chico and Live Oaks.

Co-founder Anne Constantin Birge of the grassroots Titan 1-A Missile Site Environmental Contamination and Remediation Committee trying to speed up the cleanup process appreciated the grand jury report.

The report accurately stated

that no remediation efforts have been completed, according to Birge.

“Many thanks to the members of the Placer County Grand Jury for succinctly and clearly putting the issues on the table for all to see,” Birge said. “And, for the Water Board and United States Army Corps of Engineers to know, there are others watching them.”★

Injuries plagued and put Peterson on the injury list a lot

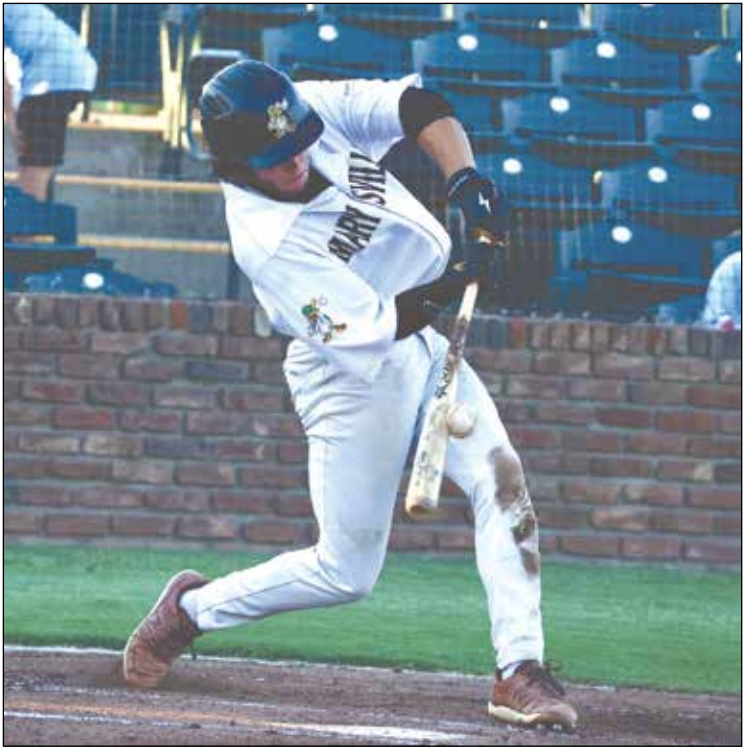
last season for his first year on the Drakes, but the leadership skills he displays on and off the field make it no question he is the leader of the clubhouse.
