RANCHO CORDOVA, CA (MPG) - The 18th annual California Capital Airshow took over the skies at Mather Airport on July 13 and 14, delivering a weekend packed with aerial acrobatics, educational opportunities and community engagement. Assessor Wynn Releases Property Assessment Roll

SACRAMENTO COUNTY, CA (MPG) - Sacramento County Assessor Christina Wynn announced on July 8 that the annual assessment roll reached a new record high of nearly \$243 billion, a 5.18% increase over last year. The assessment roll reflects the total gross assessed value of locally assessed real, business, and personal property in Sacramento County as of January 1, 2024. After the deduction of property tax exemptions for homeowners, disabled veterans, and charitable organizations, the net assessed value is just over \$233 billion.

The annual increase is primarily attributed to the sustained increase in average home prices over the last few years and ongoing new housing development and construction projects.

The 2024-25 assessment roll will generate approximately \$2.3 billion in ad valorem property tax revenue. This year's roll growth will yield an additional \$115 million in gross revenue over last year. Property tax revenue funds over 175 local government agencies, including schools, special districts such as fire, park, and community service districts, as well as cities, and redevelopment agencies and is one of the largest sources of discretionary revenue for Sacramento County's General Fund. While the total assessed value for the County increased by 5.18%, the assessed value of most properties increased only 2% due to the protections of Proposition 13. Most of the roll growth resulted from assessed values established at current market levels for properties that changed ownership or experienced new construction in 2023. Properties appraised and assessed at market value each year include properties impacted by decline in value conditions (Prop 8), mobile homes, and personal property not subject to Proposition 13 such as boats, aircraft, and business personal property. The values of these properties may fluctuate more than 2% each year. American River College's MESA Helps Students Succeed

Alina Kralya tinkers with a microcontroller for one of her computer science projects at American River College (in Sacramento). Nearby, a group of other first-generation college students sit in green and blue chairs, chatting about their math homework. It's a typical scene at this community college space for students in the Math, Engineering, and Science Achievement program, called MESA.

Two years ago, Kralya was in her first year at an engineering university in Ukraine when the Russian invasion and the subsequent war uprooted her family. After moving around Eastern Europe,

State Fair in Full Swing

SACRAMENTO REGION, CA (MPG) - Question: How are the Beach Boys and Flo Rida, Sacramento, a variety of fun competitions and exhibits, and a carnival connected?

Answer: They're all part of the 170th California State Fair, which is open 10 more days this month.

The California State Fair opened July 12 and runs through July 28.

Special days include Tuesdays at the Fair with free admission for children 12 and under. Plus all ages pay \$2 per carnival ride on Tuesdays. Fridays are Senior Savings Day with anyone 62 and older pay \$10 admission.

On July 19 and July 20, professional chefs will use a mystery ingredient to prepare a threecourse, restaurant-quality meal at the Save Mart California's Kitchen. The prelims are from 11 a.m. to 1 p.m., 2 to 4 p.m. and 6 to 8 p.m. July 19. Finals are from 6 to 8 p.m. July 20.

Fairgoers can enter an old-fashioned pie eating contest at 2 p.m. July 23 featuring cream pies from Save Mart Supermarkets at the Promenade Stage. Contestants can expect to have their faces covered in cream and crumbs by the end of the contest.

Appreciation Day for military, veteran and first responders on July 24 shows gratitude and celebrates the individuals and organizations that keep the country and communities safe. It's free admission for active duty, reserve and veteran personnel from all military branches; active members of law enforcement, firefighters and first responder units; and active-duty military spouses and dependents. The free tickets are available online at the Veteran Tickets Foundation at www.vettix.org or First Tickets at www.1sttix.org. Or veteran, military personnel and first responders can present valid

military ID, proof of service or ID showing active first responder status at the California State Fair Admission Gates.

The Multicultural Gospel Celebration from 10 a.m. to 8 p.m. July 27 at the PG&E Center Stage will feature choirs, groups, ensembles and a youth choir.

The Toyota Concert Series is free with a state fair admission ticket. The first 700 fairgoers can line up at the back of the stage venue starting at 5 p.m. for first-come, first-served seating in the area behind the General Admission seating area. ADA (Americans with Disabilities Act) space is available on a first-come, first served basis. Reserved seats for the Toyota Concert Series are also available, starting at \$25.

Green Gate opens at 2 p.m. Monday, Wednesday, Thursday and Friday, and at 11 a.m. Tuesday, Saturday and Sunday.

Carnival and Skyride hours are from 2 to 11 p.m. Monday, Wednesday, Thursday and Friday, and from 11 a.m. to 11 p.m. Tuesday, Saturday and Sunday.

Kids' Park hours are 1 to 11 p.m. Monday, Wednesday, Thursday and Friday, and 11 a.m. to 11 p.m. Tuesday, Saturday and Sunday.

Exhibit Building hours are 11 a.m. to 10 p.m. Monday through Thursday; and from 10 a.m. to 10 p.m. Friday through Sunday.

There are also different prices for the carnival rides, starting at \$1 per ticket and carnival fast passes from \$10 to \$15. An Unlimited Ride Wristband bought at the Carnival is \$39 Mondays, Wednesdays and Thursdays, and \$44 Fridays, Saturdays and Sundays.

Plenty of Fair Food for All Tastes

The Sacramento County

Environmental Management Department (EMD) inspectors ensure that the operators of the 160 food stands at the California State Fair are preparing those traditional fair delicacies such as corn dogs and snow cones to bacon cinnamon rolls and funnel cakes using safe food practices.

"Food vendors at the California State Fair face the same level of inspection as all other restaurants in Sacramento County," said Rolando Villareal, Environmental Health Division chief. "We want to ensure that they are all following safe food handling practices and adhering to state health codes to keep their customers from getting sick."

Health inspectors will work throughout the duration of the fair doing unannounced inspections, investigating food-related complaints, and providing education to vendors. Some of what inspectors will look for are preparation of fresh food every day and keeping hot food hot and cold food cold. No cooling of food for the next day use is allowed. Also looked for are proper handwashing procedures, and ensuring there are safe water supplies and proper sewage disposal.

"The Frecce Tricolori are the most mesmerizing and elegant performance I have ever seen in my life," Brewer said. On the ground, visitors had the rare opportunity to tour large military transport aircraft such as the C-5 Super Galaxy and the KC-135 Stratotanker. Interactive exhibits provided insights into various missions, including aerial refueling and humanitarian aid. Public safety and first responder displays highlighted the crucial roles that airplanes and helicopters play in law enforcement, medical evacuation and firefighting.

One of the airshow's unique aspects is its commitment to community engagement and education. As a nonprofit organization, the California Capital Airshow uses the event's proceeds to fund scholarships, internships and free educational programs throughout the year.

Continued from page 1 needs tutoring or just a quiet place to study away from her younger siblings, she comes to the MESA center.

She's still buzzing with excitement about a recent conference for female engineers she attended in San Jose. The program covered her entrance fee and transportation costs, and staff helped her set up her LinkedIn profile for the event. "Listening to all those successful ladies in STEM, oh my gosh, it was so nice," she said.

California allotted millions of dollars in 2022 to create the same program at community colleges across the state. Currently, 91 out of 115 campuses have programs established, with three more set to create one next year. The state hopes the expansion will reduce barriers to STEM jobs for "underserved and underrepresented" students. As the initiative rolls out statewide, questions remain about how long the funding will last, and how the programs can track how well they're working.

To enroll in the program, students must be both low-income and a first-generation college student. The students' parents can't hold a bachelor's degree in any country to meet the first-generation requirement.

Less than one in five community college students in California who want to transfer to a university succeed in doing so within four years, according to a report from the Public Policy Institute of California. For Black and Latino students, transfer pathways are even weaker: 13% for Black students and 16% for Latinos.

Beyond bolstering transfer rates, the goals for MESA include increasing representation of Blacks, Latinos, and Native Americans in STEM industries. In 2021, 9% of STEM workers nationwide were Black, while 15% were Hispanic or Latino, according to a report from the National Center for Science and Engineering Statistics.

"The community needs people to be in these positions as doctors, as scientists, as engineers, as computer scientists who actually understand the community that is being served," said Edrina Rashidi, the officer of advocacy for the Community College Association of MESA Directors, who recently lobbied for more legislative support for the programs.

Students in the program have access to a range of support, such as tutoring, academic counseling and help finding internships or scholarships. The physical centers offer computer equipment, textbooks and a place to study. Program directors work closely with students to connect them to resources. As of fall 2023, 4,279 students were enrolled at a MESA program on their campus, according to state data.

into the California Education Code. Over 50 colleges have taken advantage of the funds in the last two years, nearly tripling the number of programs from 34 to 94.

Each college received a total of \$428,576 for the 2022-23 school year, in the form of a grant from the state. This past year and every year through 2027 they'll get at least \$280,000 each. However, the state chancellor's office expects colleges to eventually start covering some of the costs, so that the programs can stay afloat if the state money disappears, according to the statewide MESA project monitor Stephanie Ricks-Albert.

The state grants will be up for renewal in 2027. Rashidi said more legislation is being written that could establish a minimum funding level, to guarantee stable funding for the programs.

The program also exists in different forms across the state and nation. In California, many universities and high schools have MESA programs or clubs that are overseen by the UC Office of the President with a budget of about \$7 million.

Inside a MESA Program

Computers, STEM textbooks, whiteboards, a free-to-use printer and a coffee machine occupy the MESA center at American River College, housed on the first floor of the sleek new Diane Bryant STEM Innovation Center. A line of university pennants hangs from one wall; on another, three astronauts smile from a poster that reads, "FROM MESA TO NASA." Over 200 students have access to this space. It's where tutors like Marco Alaniz, who is also a MESA student studying computer science, can often be found. He's had a love for programming since his mom bought him a computer as a little kid, but he struggled when he started college the first time over 20 years ago, and ultimately dropped out.

management habits. "So really, growing up, I was kind of on my own on that, just kind of figuring things out."

After about 15 years of working odd jobs to pay the bills, Alaniz enrolled in American River College in 2019 in Sacramento to give his computer science degree another shot. For the past year, he has tutored MESA students. It doesn't pay enough for him to quit his job so he can take classes full time, but he really enjoys breaking down difficult concepts for his fellow classmates, and it's even made him consider a career in education.

Samuel Morrison, the college's interim MESA project lead, explained that the cost of living is one the biggest challenges for the low-income students he serves. He helps connect them to scholarships and internships, as the programs are required to do. One creative way the college has found to financially assist its students is to create paid projects with faculty mentorship and research opportunities students can apply for.

"So students are finding, OK, this is a stipend that I can use to pay for gas to get to school, or I can use to supplement food costs," Morrison said.

Still, the college lacks a designated MESA academic counselor. Kralya, the Ukrainian student, explained that the general counselors she's seen are not always familiar with STEM-specific transfer programs, which can differ between universities. Adding financial aid to the mix makes things even more complicated; Kralya and Alaniz both had to declare multiple majors to get certain transfer requirements covered by financial aid. "That's why we have to find a really good counselor who can tell us this, because this information is not listed anywhere," Kralya said. The state requires the programs to have designated counselors, but getting an in-house counselor can be a lengthy and complicated process, Morrison said. He hopes to have one on board by the spring of 2025.

Students can also sign up for field trips, which include conferences and college tours. Students this semester visited the Sacramento State University planetarium, attended the Women in Engineering conference in San Jose, and toured UC Berkeley and UC Santa Cruz.

At programs across the state, students who are either low-income or first-generation, but not both, can still access certain resources, such as tutoring and counseling, but can't go on field trips or receive paid research opportunities. There are currently 1,345 of them enrolled systemwide, called ASEM students, or "Friends of MESA" at some colleges.

Growing Pains as Programs Roll Out Systemwide

Two years after new funding opened the doors for more programs, many still need to hire staff, find the required minimum 500 square feet of space to house the center, or recruit students to officially get off the ground.

Just hiring a program director to lead the program can be a lengthy process. A year and a half after receiving its grant, the program at Laney College in Oakland is still without a director. The college's dean of math and sciences, Inger Stark, appointed math instructor Kyla Oh as the program's faculty lead for the program in the interim.

The Need for More Granular **Program Data**

Tracking MESA programs in a comprehensive way is not easy. Some basic data is available through public dashboards, but directors want easy access to more in-depth information about their programs to help make sure they're meeting their goals.

"We actually have no way of measuring our success, still, with the Chancellor's Office," said Rashidi, the lead advocate for MESA directors.

Basic information, such as the total number of MESA students in the system, is available through the California Community Colleges Chancellor's Office public data tool, DataMart. However, that information isn't broken down by race, gender or major. Granular data could give program directors the ability to quickly check if their efforts to reach students from underserved backgrounds are working.

Limited information on MESA student success is publicly available. Of the MESA students who first attempted to complete a transfer-level math course in the 2021-22 school year, 79% passed within one year, compared to a 54% completion rate for the general student body, according to the Transfer-Level English and Math Completion Dashboard.

CalMatters requested MESA transfer statistics and racial data from the Chancellor's Office. According to the data, about 62% of MESA students were Hispanic or Latino as of December 2023, while 4% were Black.

To count transfers, the Chancellor's Office counted students who were in MESA in one school year, and then enrolled at a university the next year. By this metric, MESA programs collectively transferred 1,010 students after the 2021-22 school year, including 563 Hispanic or Latino students and 23 Black students.

Nearly half of MESA students enroll at a university within four years of taking their first community college class, as of 2017, the most recent year complete data is available. Students were considered to be MESA students if they participated in the program at any point during their first three years in the community college system.

State Funds Expansion of MESA Programs Systemwide

Four years ago, MESA programs had a \$2.5 million statewide budget. After lobbying efforts from the MESA directors association, the program now has a \$39.4 million statewide budget and was written

"I just wasn't prepared," Alaniz said. Because his parents never went to college, they didn't have the experience to help him navigate school or teach him time

"It has definitely slowed us down," said Stark. The bulk of the work falls on Oh, who teaches fewer credits so that she has time to focus on the program. Stark squeezes the administrative side of the program into her workday as a dean.

Right now, the state money covers the entire program, which launched in April with an initial cohort of 14 students. Stark is determined to ensure the program stays afloat through any changes in the funding, but she's spent enough time in her community college district to have seen many "beautiful initiatives" get weeded out.

"It is heartbreaking," she said. "A huge amount of work can fall on the grams at the end of the current grant cycle, and the results could affect how much money programs will receive in the future, according to an emailed statement from Melissa Villarin, a spokesperson for California Community Colleges. Any additional funding would be based on "program and campus metrics," according to the statement.

Rancho Cordova Police Address Mail Theft Concerns

RANCHO CORDOVA, CA (MPG) - During the July 15 Rancho Cordova City Council meeting, Rancho Cordova Police Chief Matthew Tamayo discussed mail theft and his department's efforts to combat this community concern.

Tamayo highlighted the national surge in mail theft incidents during the COVID-19 pandemic.

"Prior to COVID-19 in 2019, there were approximately 100,000 reported incidents of mail theft nationwide," Tamayo said. "However, in 2020, this number more than doubled to 250,000."

Addressing the responsibilities surrounding mail theft, Tamayo clarified the procedures for residents encountering such incidents.

"If residents notice their mail has been stolen without any other damage, we refer them to the United States Postal Service

(USPS)," he said. "For crimes in progress, immediate contact with 9-1-1 ensures a prompt response from law enforcement."

The meeting also emphasized best practices for preventing mail theft, including daily mail retrieval, refraining from leaving outgoing mail unattended, and utilizing USPS Hold Mail services during extended absences.

Tamayo stressed the importance of community vigilance and reporting suspicious activities.

"In recent operations, the RCPD (Rancho Cordova Police Department), in collaboration with federal authorities, made notable arrests related to mail theft," Tamayo said. "For instance, a primary perpetrator responsible for multiple mail thefts in Anatolia, Folsom and surrounding areas was apprehended on federal charges, resulting in a substantial decrease in community mailbox thefts thereafter."

Councilmember Linda Budge

advocated for enhanced lighting around mailboxes to deter criminal activity.

"Better-lit mailboxes would reduce the attractiveness of these crimes," Tamayo agreed, noting that mail theft typically occurs under the cover of darkness, making lighting a practical deterrent.

Councilman Donald Terry suggested alternatives to traditional mail for sensitive communications.

"To mitigate risks, consider opting for electronic statements over paper mail for important documents," Terry said.

The Rancho Cordova City Council also addressed updates on illegal firework enforcement and updated ordinances aimed at prevention.

Russell Ducharme, Neighborhood Service manager, provided a detailed report on the city's efforts over the July 4th weekend to curb illegal fireworks activity. Despite challenges posed by adverse weather conditions, Ducharme highlighted the effectiveness of enhanced surveillance methods, stating, "It was extremely warm, which limited flight time for our drone teams, but we were still able to monitor and assess the situation across our city."

The city amplified its enforcement strategy this year, increasing drone teams from two to three and introducing the Rancho Connect app for residents to report illicit fireworks.

"We received a total of 111 calls for service related to illegal fireworks, with 48 calls originating from the Rancho Cordova Connect app," Code Enforcement supervisor Brittany Mariscal said. "Additionally, 75 properties were identified for administrative citation."

In response to the issue, City Council adopted new ordinance measures, including a \$1,000 fine for first time violations and escalated fines for repeat offenders.

"Administrative citations are being issued this week for in-person violations, totaling approximately 25, with drone violation notices set to follow next week, covering about 50 incidents," Mariscal said.

Council members expressed optimism about the impact of these measures, noting an 80% reduction in complaints.

Councilmember Garrett Gatewood inquired on behalf of Planning manager Darcy Goulart on the correlation between the decrease in calls and the new ordinances, prompting a discussion on contributing factors.

"The ordinance certainly played a role, coupled with adverse weather and the timing of the holiday. It's encouraging to see fewer complaints, suggesting our efforts are yielding results,"-Terry said.

Looking forward, Budge expressed interest in mapping the geographic distribution of complaints, suggesting, "Understanding where calls originate will provide valuable insights into hotspot areas."

We Want to Claim SS at 62. When Should we Apply? will be paid on the 3rd



Dear Rusty: My wife and I are going to be taking Social Security at 62. She will be 62 on April 15, 2025. I will be 62 August 7, 2025. When should we apply for Social Security? Signed: Ready to file

Dear Ready: Social Security recommends you apply for benefits about 2 -3 months prior to when you want your benefits to start (to get them time to process your application). You will specify on your application when you wish your benefit to start, so applying early isn't a problem. Just a few things to keep in mind:

Your first month of eligibility will be the first month you are 62 for the entire month. In your wife's case, her first month of eligibility will be May 2025, and in your case your first month of eligibility will be September 2025. Your wife's benefits

Wednesday of every month, and your benefits will be received on the 2nd Wednesday of every month (payment dates depend on when your birthday falls).

Social Security Matters

Social Security has an earnings test for those collecting early benefits (before your full retirement age). If you are working and exceed the earnings limit, SS will take away some of your benefits. The earning limit for 2024 is \$22,320 and, if that is exceeded, SS will take away \$1 in benefit for every \$2 you are over the limit (the limit changes annually, so the 2025 limit will be more). Thus, if you plan to work after collecting, you must stay aware of the earning test. If you earn substantially more than the earnings limit, you even may be temporarily ineligible to collect benefits (until you either earn less or reach your full retirement age (FRA) when the earning test no longer applies).

By claiming at 62, you will incur a cut in benefits of about 30% from the amount you would get by waiting until your FRA to claim. And, except for annual cost of living adjustments, that is a permanent reduction. FYI, your benefit will continue to grow if you wait longer to claim.

Deciding when to claim Social Security should take into account your financial needs, your life expectancy, and your goals as a couple. Claiming at 62 is the right choice for many, but waiting longer, if feasible, will result in a higher monthly amount, which could be beneficial if your life expectancy is long. 

Not too far away or long ago, I was working as a hospital chaplain at Sutter Medical Center in Sacramento when a nurse suggested I visit one of her patients. The only reason she offered for her referral was that our patient might need "some counseling or something."

Before entering the room, I sought more explanation from the patient's chart. Turning to the patient history page, I read aloud, "Patient is consuming multiple sixpacks each day."

"Something indeed," I muttered, repeating the nurse's euphemism.

A few steps away in the room, I met a man who was writhing in the pain of detoxification. I knew little about the process, but I once heard a doctor say that "Detox makes waterboarding look tame."

Fixing me with a crazed look, the patient ordered me to "Get some &%@'n drugs, Doc!" He was, no doubt, assuming that the male entering his room wearing a necktie was his doctor.

I took a deep breath and assured him I was his chaplain, not his doctor.

Arming himself again with a limited vocabulary, he fired another volley aimed at convincing me he didn't care whether I was the pope; he wanted his drugs.

I nodded and left the room to relay his message to the nurse.

A bit shocked, the old-school nurse asked me, "Did you tell him that he shouldn't talk to a chaplain that way?" she asked.

My forthcoming answer seemed to surprise her nearly as much as the patient's vocabulary.

"No. I think his language represents a

kind of prayer."

Some Prayers Come in A Different Language

"Prayer?" she asked, as if now questioning my sobriety.

I took her stance as invitation to say more. In the next few minutes, I shared my belief that God hears our expressions of agony, loss or pain as a prayer.

These prayers can be expressed in a wordless whimper, and God hears them. They can be voiced with bloodcurdling screams, and God hears them. They may be vented with words that offend the offhanded listener. The point is no matter how these words are uttered, God hears them and knows how to interpret them.

Our problem often comes when, perhaps like this nurse, we close our hearts and our ears to the kind of language expressed in that level of pain. We do this because we think pain ought not become offensive. "Pain should be neat and controlled," we reason.

That's not the way the Psalmist saw it when he wrote, "I cry aloud to the Lord; I lift up my voice to the Lord for mercy. I pour out my complaint before him; before him I tell my trouble" (Psalm 142:1-2).

And it certainly wasn't the way Job saw it when he lost his entire family. "Therefore I will not keep silent; I will speak out in the anguish of my spirit, I will complain in the bitterness of my soul" (Job 7:11).

I'm not saying we should encourage this language in everyday use. I'm saying that if God doesn't turn his ears away from even the most excruciating levels of human pain, then how can we?

At the end of the day, I like the metaphor Susan Lenzkes uses in her book, "When Life Takes What Matters." She says expressing our anger is like beating upon the chest of God, but "... we beat on His chest from within the circle of His arms."

I returned a few hours later to find that his nurse had finally given him the pain meds he needed.

He apologized for the language he'd used toward his chaplain. "No worries," I said. "All forgiven."

A few minutes after that, I found the nurse in her station.

"Thanks for your help," I said.

"God answers prayer chaplain, but sometimes he gets help from a nurse." \star

Two years ago, the Sacramento Kings made the playoffs for the first time in 16 years and Mike Brown captured coach of the year honors as a result.

While compiling 48 wins, the Kings inexplicably led the entire NBA in points scored. Yes, it was the #1 offense in the NBA in no small part due to rookie sensation Keegan Murray, who set a franchise rookie record by scoring 206 three-pointers.

Domantas Sabonis demonstrated his overwhelming value by leading the lead in rebounds, while adding 19 points per night in the scoring column.

Lightning fast De'Aaron Fox lead the team in scoring with a 25-point average, while Malik Monk added 13.5 points coming off the bench.

Yes, the 2022-23 season was fun to watch but the naysayers were quick to note that defense was hard to find.

Davion Mitchell made his defensive presence felt every game, and frequently took on the opposing team's top guard. The real question as fans are beginning to come down from the high of signing DeMar DeRozan, is whether Monte McNair has another move to make. The Kings still need help in the big man area of the team, and either a power forward or another center to complement Alex Len would be a more than welcome addition. Whether or not McNair makes another move, the upcoming season should present a real show every night. Scoring is contagious, and if De'Aaron continues his progress with regards to three-point shooting, and Keegan Murray can find the three-point stroke that set the rookie record two years ago, a Kings ticket will be the most sought-after seat in town.

Domantas will undoubtedly continue his undaunted rebounding and nightly double-double production that has made him one of the most durable big men in team history, but he could use a supporting cast on the boards.

I believe Alex Len's best basketball is still ahead of him, and I applaud the Kings for recognizing his value, and signing him to a one-year \$3,303,000 contract. Drafted 5th overall in the 2013 NBA draft, at 7'1" and 255 pounds, Alex already represents the profile of the big man needed by the Kings, and it remains to be seen if Alex can turn into a late bloomer and make a significant contribution.

Don't give up on Len! This guy could easily surprise us all, and what may have seemed like an insignificant one-year contract, could be big for the Kings.

Keep your eyes on the Summer League team Kings fans! There are a number of interesting players, and 6'11" Drew Timme is one of them. Undrafted, Monte McNair is looking for a diamond in the rough, and adding Timme to the Kings bench could help the big man position as well.

There were times last season, albeit few, in which Mike Brown played Alex Len alongside Domantas Sabonis, and it gave the team a rebounding edge. I, for one, would like to see more of this experiment, whether with Len or someone like Drew Timme. It wouldn't necessarily represent a starting lineup contingent, but in-game could produce some interesting results.

Stay tuned Kings fans. The team is looking stronger than ever, and whether Monte McNair has one more rabbit to pull from his hat or not, the 2024-25 season is one to look forward to!

California Lawmakers' Safety Gets New Attention After Trump Shooting

Former President Donald Trump evaded serious injury, or death, by mere centimeters after a bullet struck his upper right ear during a campaign rally July 13 in Pennsylvania. The Republican presidential candidate pumped his fist, his face bloodied, as Secret Service agents hustled him off the stage following the shooting. But one spectator was killed, two were critically injured and the Secret Service killed the suspected shooter, identified by the FBI as a 20-year-old Pennsylvania man.

Saturday's mayhem is the most recent known assassination attempt of a president or presidential candidate since the 1981 shooting of President Ronald Reagan, and renewed conversations about the country's deep partisan divide, gun safety and dangerous political rhetoric — especially violent threats toward officials and candidates.

So it's no wonder that beefing up personal security has been a priority for some lawmakers. As explained earlier by CalMatters Capitol reporter Sameea Kamal, the Secretary of the Senate and chief administrative officer of the Assembly said that there has been heightened concern about political violence in recent years, and a bill is underway to protect California lawmakers and candidates from rampant threats.

The measure, Assembly Bill 2041, would allow candidates and elected officials to use more campaign funds for personal security for themselves, family members and staff. Democratic Assemblymember Mia Bonta of Oakland is carrying the bill and said she hopes to "see it across the finish line for the safety of candidates across the state." If passed, Bonta's measure could be enacted in time for the November election.

Bonta, in a statement: "(Saturday's) events show that political violence continues to plague our democracy. ... This bill has had bipartisan support because people on both sides of the aisle recognize the safety needs in this charged political climate."

Gov. Gavin Newsom, whose office did not immediately reply to a request for comment, vetoed similar legislation last year, saying that the bill did not clearly define "security

expenses." Bonta's

newest bill, however, has been amended to specify what's considered a security expense, as well as clarifies disclosure requirements for transparency.

The bill sailed through the Assembly this year and is expected to be up for a floor vote in the Senate shortly after the Legislature returns from summer recess in August, according to Bonta's office. It has received

no vote in opposition so

far, though three Republican senators voted against last year's bill. During a March hearing in the Assembly's elections committee, Republican Assemblymember Tom Lackey of Palmdale raised concerns about the "broad potential interpretation of security expenses."

California is no stranger to shootings tied to the Oval Office. In 1975, a member of the Manson family cult attempted to shoot President Gerald Ford near the state Capitol in Sacramento while Ford was en route to meet then-Gov. Jerry Brown. And in 1968, U.S. Sen. Robert F. Kennedy died shortly after being shot at the Ambassador Hotel in Los Angeles while running for the Democratic presidential nomination.

On July 14, Newsom said he has deployed 61 Highway Patrol and police officers to assist local, state and federal law enforcement during the Republican National Convention in Milwaukee, which kicks off July 15. "Public safety transcends party lines," said Newsom in a statement. The plan to send these officers has been in the works since May.

FBI Investigation Encourages Tips from the Public

Gov. Newsom promptly posted on social media that "violence has NO place in our democracy," a reaction echoed by Assembly Speaker Robert Rivas.

Assembly GOP leader James Gallagher said in an initial statement that "we must completely shut down those who would use violence to snuff out their political opponents." July 14, he followed up with a post asserting that "calling Trump a modern-day Hitler and making crazed assertions about the end of democracy has not been helpful to the chaos that we now find ourselves in."

In a statement, Senate Republican leader Brian Jones urged "Americans to take a step back and acknowledge the need for common ground, rather than seeing politics as a polarizing exercise."

And former House Speaker Nancy Pelosi, whose husband Paul was struck in the head with a hammer by an assailant in their San Francisco home, posted on social media: "I know firsthand that political violence of any kind has no place in our society. I thank God that former President Trump is safe."

Saturday's chilling incident comes at a key point in the 2024 presidential race.

Democrats have been divided over whether to rally behind Biden — or to find a way to push him off the 2024 ticket. Republicans, on the other hand, were already in lockstep behind Trump as they gather in Milwaukee to officially nominate him — and see him reveal his running mate.

California is sending the biggest delegation to the convention — and thanks to the state GOP changing its rules for a winner-take-all primary in March, all 169 are pledged to Trump. It's only one sign of how firmly Trump controls the California party.

And while Biden — or any Democrat — is the odds-on favorite to secure California's 54 electoral votes in November (of the 270 needed to win), Republicans hope Trump's coattails and Biden's troubles, fueled by his weak performance in the June 27 debate, will help them add to the dozen congressional seats they now hold (compared to 40 for Democrats).

"We resolve political differences at the ballot box, through activism and by participating in political discourse," said California Secretary of State Shirley Weber in a statement. "There is absolutely no room for political violence." ★

FBI News Release

WASHINGTON, D.C. (MPG) - The FBI continues to investigate the shooting incident at the July 13 rally in Butler, Pennsylvania, which resulted in one victim's death and injuries to former President Trump and other spectators, as an assassination attempt on former President Donald Trump and as potential domestic terrorism.

The investigation is still in the early stages, and the FBI is providing the following updates, as of 12:05 p.m. July 15:

FBI technical specialists successfully gained access to alleged shooter Thomas Matthew Crooks' phone and they continue to analyze his electronic devices.

The searches of the subject's residence and vehicle are complete.

The FBI has conducted nearly 100 interviews with law enforcement personnel, event attendees and other witnesses. That work continues.

While the investigative work continues, FBI victim services personnel have offered assistance to the victims of Saturday's incident.

While the investigation to date indicates the shooter acted alone, the FBI continues to conduct logical investigative activity to determine if there were any co-conspirators associated with this attack. At this time, there are no current public safety concerns.

The FBI has not identified a motive for the shooter's actions but is working to determine the sequence of events and the shooter's movements prior to the shooting, collecting and reviewing evidence, conducting interviews and following up on all leads. The shooter's telephone was obtained for examination.

Suspicious devices found at both locations have been rendered safe by bomb technicians and are being evaluated at the FBI Laboratory.

The firearm used in the shooting was purchased legally.

The shooter was not known to the FBI prior to this incident.

The FBI has received hundreds of digital media tips, which include photos and videos taken at the scene, and continues to review incoming tips. Anyone with information that might assist with the ongoing investigation is encouraged to submit it online at tips.fbi.gov or call 1-800-CALL-FBI.




