## Top Floor of Hotel Marysville at Risk of **Falling**

MARYSVILLE, CA (MPG) -Only the top floor of the five-story Hotel Marysville presents a significant fall hazard and traffic could safely be restored to the two southbound lanes of Highway 70 if a 10-foothigh debris catch-barrier is erected, according to an engineering report received Tuesday by the City of Marysville.

After the Emeryville engineering firm WJE report was delivered three days earlier than expected, City Manager Jim Schaad emailed acting District 3 Caltrans Director Sergio Aceves recommending Caltrans install the barrier and convert the southbound lanes to two-way traffic "as a cost-effective,

near-term solution." "The city wishes to allow its surface streets affected by Caltrans...detours to resume normal traffic flows to the businesses within the community as well as provide better access for the businesses on E Street," Schaad said in an email Wednesday morning.

As the city awaits Caltrans' consideration of the recommendation, it now has a clearer picture of the stability of the hulking structure that was in poor shape even before the fire, according to the engineering report. "The conditions observed at the Hotel Marysville are a mix of damage due to the fire and firefighting activities and pre-existing deterioration of the building due to decades of vacancy and lack of maintenance, the report states. "The amount of heat experienced throughout the building varied significantly based on the condition of the finishes, which are completely burned in

some areas and mostly intact in other areas.

The report concludes, "The Hotel Marysville building was in poor condition prior to a fire on June 15, 2024. The fire destroyed the roof diaphragm and removed the lateral bracing for the topstory exterior walls, which are constructed of unreinforced brick masonry. These top-story walls are very slender and are now susceptible to falling out of-plane and onto the sidewalks and streets below.

NORTHERN CALIFORNIA (MPG) - Hundreds braved scorching temperatures to line railroad tracks from Oroville to Roseville, awaiting a glimpse of the world's largest operating steam locomotive, Union Pacific's Big Boy engine 4014.

Union Pacific's Big Boy strolled comfortably into Oroville around 2:15 Thursday, July 11, puffing steam and blasting it's powerful whistle for onlookers.

The hulking engine took a break from its tour of the western states in Oroville for about 30 minutes before continuing to Roseville, where it would be on display for a 2-day stint.

Train-lovers and the curious of all ages could be seen alongside the tracks, gathering not only at scheduled stops but railroad crossings throughout the countryside.

The Herald caught up with hopeful viewers on Central House Rd, near Honcut, shortly after 3 p.m. July 11. Multiple cars had pulled off to the side of the dirt road, with a small crowd gathering for the event.

Drones, professional photography and videography equipment, and cell phones were at the ready as many hoped to document the historic event on cameras.

Area children excitedly buzzed around the tracks, looking up the line toward Oroville, waiting to catch the glimpse of a light or movement after its scheduled

The crowd's patience would be rewarded as a white light would eventually appear down the tracks in the distance. Cries "here it comes!" and "look!" rang through the small crowd as they cleared the crossing arms, tracks and watched as the Big Boy made its approach.

Pumping a cloud of steam into the air, flanked by a waving American flag and the California State Flag, the massive black engine did not slow as it blasted through the crossing, blaring it's horn as engineers waved to onlookers. Cheers, smiles and "hurrahs" abounded as the Big Boy came and left bystanders in awe.

Ellie, 7, from Loma Rica had come out with her parents and little sister to see the locomotive. Ellie told the Herald with excited eyes and a large grin on her face, that "it was awesome" to see the large train go by.

"Worth the wait," "that was so cool!" and "WOW!" could be heard as spectators quickly packed up their gear and headed to the safety of air-conditioned vehicles, ears ringing with the memory of the trains

Skye Wilkins, 16, of Gridley told the Herald that "it was super cool to see and such an amazing experience to see an old train running." Her sister Brooklyn, 9, added, "I really liked it and I could see the people inside of it! It was so fast!"

The Big Boy left Roseville Sunday, June 13 on its return leg of the journey to its home in Cheyenne, Wyoming. The Union Pacific Museum hosted a special passenger trip from Roseville to Sparks, which

## Local Brewery Brings Home Gold State Fair in Full Swing

YUBA CITY, CA (MPG) -"Prost" is German for cheers and it's also the name of the newest award-winning lager at Sutter Buttes Brewing in Yuba City.

Scott Sargent, the brewery's president, submitted the beer, along with two others, to the California State Fair this past spring and learned last month that "Prost!" had won gold in the category of best European Pale Lager. This placement means that Prost! received the highest ratings out of all other entries in its category and Sargent estimated there were at least a dozen competitors.

"This has only been our

any beers to the state fair and that's pretty much one of the biggest beer competitions in California," said Sargent.

Prost! is billed as a Munich style lager, a German beer characterized by its golden color and a crisp, refreshing flavor with restrained bitterness. It was brewed locally inside the Sutter Buttes Brewery and tested on its steady base of customers.

"The beer tells the story itself in how it sells and it's our Number One selling beer right now," Sargent said proudly. "We're blessed to have some fabulous beer critics in our regular crew. They can be brutally honest about what they think but most of the time the feedback is good."

#### **Plenty of Fair Food** for All Tastes

The Sacramento County Environmental Management Department (EMD) inspectors ensure that the operators of the 160 food stands at the California State Fair are preparing those traditional fair delicacies such as corn dogs and snow cones to bacon cinnamon rolls and funnel cakes using safe food practices.

"Food vendors at the California State Fair face the same level of inspection as all other restaurants in Sacramento County," said Rolando Villareal, Environmental Health Division chief. "We want to ensure that they are all following safe food handling practices and adhering to state health codes to keep their customers from getting sick."

Health inspectors will work throughout the duration of the fair doing unannounced inspections, investigating food-related complaints, and providing education to vendors. Some of what inspectors will look for are preparation of fresh food every day and keeping hot food hot and cold food cold. No cooling of food for the next day use is allowed. Also looked for are proper handwashing procedures, and ensuring there are safe water supplies and proper sewage disposal.

Through high school Brud received many athletic awards in basketball, baseball, and football and was team captain and Most Valuable Player (MVP) in football. In his senior year was assigned the defensive line coach for Gridley HS football team and was selected for the All Northstate team. Brud was also one of the athletic student leaders



who founded the Gridley Invitational Basketball Tournament (GIBT) in 1954.

Upon graduation from Gridley High School he attended Yuba College to earn his A.A.. He continued to play baseball and football where he was a two time All-Conference and later inducted into the Yuba College Hall of Fame. He transferred to CSU, Chico where he graduated with a B.S. in physical education and biological science in 1958. During his tenure at CSUC he coached freshman football, played two years of football where he was team captain, was nominated All-Conference, and voted Most Inspirational. Later he was inducted into the CSUC football "Team of the Century". On top of this he also lettered in basketball, baseball, and boxing.

Brud moved back to Gridley and took over his father's business, New Look Dry Cleaners, which later evolved into Continental Athletic Supply in 1966. Under Brud's leadership, Continental Athletic Supply was a charter member of the National Athletic Equipment Reconditioners Association (NAERA), beginning in 1974, and Brud served as president for two terms. He also served several years as a representative on the National Operating Committee

on Standards of Athletic Equipment (NOCSAE), the organization that sets the standards for athletic equipment.

Brud served as a Gridley City Councilman and president of the Chamber of Commerce. He was part of a group of Gridley citizens who started the Gridley "Go-Fish" swim team which later evolved into the Gridley Gators. He was also a founding member of the Gridlev Pop Warner which later evolved into Gridley Youth Football. He served on the alumni boards for both Yuba College and CSU, Chico along with the Old Timers Scholarship Foundation for many years.

Brud was a man of compassion, great kindness, and loyalty. He had a wonderful sense of humor and could deliver a joke with magnificent ease. You could find him on the dance floor at most events, cutting a rug with the best of them. As his son's grew up he coached them in both baseball and football. Upon his semi-retirement from Continental Athletic Supply, Brud cherished his time with his grand-children. His hobbies included golfing and fly fishing. He had many amazing adventures fly fishing with friends throughout North America.

### \$50,000 Reward Remains Active in 2021 Oroville Campground Murder



**Butte County Sheriff's** Office News Release

OROVILLE, CA (MPG) - On July 3, 2021, Butte County Sheriff's Office (BCSO) deputies were dispatched to the Bidwell Canyon Campground, to assist California State Parks Peace

Officers with a homicide investigation.

Detectives responded and determined that during a group camping trip, 20-year-old Tyler Dickson of San Pablo was fatally shot while sleeping inside a tent. Over the past three years, Butte County Sheriff's Office detectives

have actively and zealously investigated this case, however, it has remained unsolved.

During the investigation, Butte County Sheriff's Office requested Governor Gavin Newsom's Office issue a reward through the Governor's Reward program to encourage those with pertinent information to come forward.

In 2022, after reviewing the circumstances of the case, Governor Newsom's Office issued a \$50,000 reward for information leading to an arrest and conviction of the person(s) responsible for the murder of Tyler Dickson.

Despite the passing of three years since the murder, the Governor's Reward remains in effect.

"Our investigation leads us to believe that the person(s) responsible for Tyler's death were part of a large group of people he was camping with, all of whom were from out of the area. Based on our investigation, we know there are members of this camping group with information that could lead to us being able to solve this case, but thus far they have been less than cooperative. Despite the passage of time, we remain committed to solving this case and delivering justice for Tyler and his family," said Sheriff Kory Honea.

Butte County Sheriff's Office encourages those with pertinent information to come forward. Anyone with information is requested to contact Detective Mike Worch at 530-538-7671. ★

### Governor Newsom and Fire Officials Highlight California's Wildfire Readiness and Response

SACRAMENTO, CA (MPG) - California's peak wildfire season is here, and it's significantly more active than the last five years.

So far this year, there have been more than 3,500 wildfires across California, with 207,415 acres burned and 128 structures damaged or destroyed. That's compared to just 10,080 acres at this time last year – and the five-year average of 38,593 acres

The state continues to expand its aerial firefighting force, which is the largest in the world. California also continues to leverage new technologies to support its firefighting capabilities.

Governor Gavin Newsom joined state

fire and emergency officials in Sacramento at CAL FIRE McClellan Air Tanker Base to provide an update on California's wildfire response and readiness.

'The last couple years brought welcome relief for California as we saw historically low levels of wildfire. This season is shaping up to be very active, bringing the threat of dangerous wildfire to many parts of our state. California is ready with the world's largest aerial firefighting fleet and new technology that helps us fight fire smarter - and we're already seeing our investments pay off.," said Governor Gavin Newsom.

The recently signed 2024 budget agreement maintains \$2.6 billion through 2028 to protect Californians from wildfires and improve forest health. This is in addition to \$200 million per year for healthy forest and fire prevention programs, including prescribed fire and other fuel reduction projects. The administration is implementing shorter workweeks for state firefighters and aims to bring on more than 2,400 additional firefighters over five years to augment staffing levels.

Californians can visit ready.ca.gov for resources and safety tips on wildfire, heat and other natural disasters.

Below is a recap of the ways California

is keeping communities safe from wildfire.

#### New aircraft, night-flying capabilities, and expanded drone deployment

Expansion of helitack bases

Five additional helitack bases are operational, after personnel completed. training, bringing the total to eight bases equipped for night operations.

Night-flying aircraft have been activated in response to many wildfires this year.

Contracted aircraft add to CAL FIRE's permanent fleet of over 60 aircraft.

20 additional helicopters and 4 airplanes, including five night-flying capable helicopters.

#### **Drone deployment**

CAL FIRE currently operates 159 unmanned aerial systems, representing a doubling in CAL FIRE's use of UAS for aerial ignition, support of prescribed burns, and wildfire containment.

Ongoing transfer and outfitting of seven C-130 aircraft from the federal government.

Harnessing recent innovations

Fire Integrated Real-Time Intelligence

System (FIRIS) to map wildfire information in real-time.

Tecnosylva Wildfire Projection Tool to predict wildfire spread.

Partnership with Department of Defense, using satellites to map wildfires. LiDAR Investments to make detailed, 3-D maps of more than 30 million acres of topography and vegetation in high-risk areas.

Wildfire Threat Intelligence Center (WFTIC), serving as California's integrated hub for wildfire and weather intelligence.



The lot is quiet where once a robust hotel stood. A bloom of oak trees provides shade for the ghosts from the past.

The place was called the Gridley Hotel.

Ernest Wickman, an immigrant from Germany who came to the United States when he was 18, built it in 1890. He worked on a farm in Illinois, moving to California five years later.

Wickman eventually settled in Chico, farming for the next ten years. He grew wheat and obtained more land near Biggs.

In 1885, Wickman purchased 190 arches of land just outside of Gridley. Five years later, he bought a lot of land and built the Gridley Hotel—using brick he manufactured on his ranch.

The hotel was popular with visitors and townspeople alike. Its look was inviting, with palm tree archways supporting the balcony above. Each room was clean and wellequipped with modern conveniences. The dining room was friendly, inviting folks to stop by when

Railroad tickets were on sale at the hotel for excursions. All fares included a bus ride.

**The Gridley Hotel** 

In 1912, an occultist from Oakland occupied a room for curious visitors. Several months later, on Kentucky Street and Sycamore, Bro. Benjamin came to town to heal the residents.

Called specialists, the duo removed 150 gallstones. According to them, there was "no pain, and no operation" the work done by secret European remedies. Wildly successful for a spell, the brothers never returned to Gridley.

The hotel, which had been standing for 45 years, received a renovation in 1935.

Eight years later, a mystery occurred. Someone tossed a smoking mattress out of a room. Nobody could determine what room the mattress had come from. There were no witnesses. The case remains unsolved.

The grand hotel was torn down in 1975 despite pleas from residents.

The lot has been empty ever since. All remnants of the past are goneexcept one's imagination. Stroll down Hazel and stop near the plaque dedicated to Officer Arthur D Miner, who died in the line of duty.

California Lawmakers' Safety Gets New Attention After Trump

**Shooting**

Former President Donald Trump evaded serious injury, or death, by mere centimeters after a bullet struck his upper right ear during a campaign rally July 13 in Pennsylvania. The Republican presidential candidate pumped his fist, his face bloodied, as Secret Service agents hustled him off the stage following the shooting. But one spectator was killed, two were critically injured and the Secret Service killed the suspected shooter, identified by the FBI as a 20-year-old Pennsylvania man.

Saturday's mayhem is the most recent known assassination attempt of a president or presidential candidate since the 1981 shooting of President Ronald Reagan, and renewed conversations about the country's deep partisan divide, gun safety and dangerous political rhetoric — especially violent threats toward officials and candidates.

So it's no wonder that beefing up personal security has been a priority for some lawmakers. As explained earlier by CalMatters Capitol reporter Sameea Kamal, the Secretary of the Senate and chief administrative officer of the Assembly said that there has been heightened concern about political violence in recent years, and a bill is underway to protect California lawmakers and candidates from rampant threats.

The measure, Assembly Bill 2041, would allow candidates and elected officials to use more campaign funds for personal security for themselves, family members and staff. Democratic Assemblymember Mia Bonta of Oakland is carrying the bill and said she hopes to "see it across the finish line for the safety of candidates across the state." If passed, Bonta's measure could be enacted in time for the November election.

Bonta, in a statement: "(Saturday's) events show that political violence continues to plague our democracy. ... This bill has had bipartisan support because people on both sides of the aisle recognize the safety needs in this charged political climate."

Gov. Gavin Newsom, whose office did not immediately reply to a request for comment, vetoed similar legislation last year, saying that the bill did not clearly define "security expenses." Bonta's newest bill, however, has been amended specify what's considered a security expense, as well as clarifies disclosure requirements for transparency.

The bill sailed through Assembly this year and is expected to be up for a floor vote in the Senate shortly after the Legislature returns from summer recess in August, according to Bonta's office. It has received no vote in opposition so

far, though three Republican senators voted against last year's bill. During a March hear-

ing in the Assembly's elections committee, Republican Assemblymember Tom Lackey of Palmdale raised concerns about the "broad potential interpretation of security expenses." California is no stranger to shootings

Jerry Brown. And in 1968, U.S. Sen. Robert F. Kennedy died shortly after being shot at the Ambassador Hotel in Los Angeles while running for the Democratic presidential nomination.



## **FBI Investigation Encourages** Tips from the Public

WASHINGTON, D.C. (MPG) - The FBI continues to investigate the shooting incident at the July 13 rally in Butler, Pennsylvania, which resulted in one victim's death and injuries to former President Trump and other spectators, as an assassination attempt on former President Donald Trump and as potential domestic terrorism.

The investigation is still in the early stages, and the FBI is providing the following updates, as of 12:05 p.m. July

FBI technical specialists successfully gained access to alleged shooter Thomas Matthew Crooks' phone and they continue to analyze his electronic devices.

The searches of the subject's residence and vehicle are complete.

The FBI has conducted nearly 100 interviews with law enforcement personnel, event attendees and other witnesses.

That work continues. While the investigative work continues, FBI victim services personnel have offered assistance to the victims of

While the investigation to date indicates the shooter acted alone, the FBI continues to conduct logical

Saturday's incident.

investigative activity to determine if there were any co-conspirators associated with this attack. At this time, there are no current public safety concerns.

The FBI has not identified a motive for the shooter's actions but is working to determine the sequence of events and the shooter's movements prior to the shooting, collecting and reviewing evidence, conducting interviews and following up on all leads. The shooter's telephone was obtained for examination.

Suspicious devices found at both locations have been rendered safe by bomb technicians and are being evaluated at the FBI Laboratory.

The firearm used in the shooting was purchased legally.

The shooter was not known to the FBI prior to this incident.

The FBI has received hundreds of digital media tips, which include photos and videos taken at the scene, and continues to review incoming tips. Anyone with information that might assist with the ongoing investigation is encouraged to submit it online at tips.fbi.gov or call 1-800-CALL-FBI.

There are enclosed "fish traps" located in several coves, and still used by local tribes today. Try: Carey Special, Egg Sucking Leech, Sculpin flies. (b)

Klamath River near Iron Gate area. CDFW released two million Chinook Salmon smolts, 6-months old and 3-inches long. Smolts carry coded wire tags and clipped adipose fins. American River still turning out Shad, but you have to work for them. Try: Shad Fly. (a)



#### As Heat Surges, Farmers Work to Protect Crops, Livestock

California farmers are working to reduce impacts of a lingering heat wave that has increased their costs and jeopardized production. With prolonged triple-digit temperatures pummeling the state's key agricultural regions-topping 110 degrees in some areas in recent days—farmers are irrigating fields more frequently. They are deploying misters and fans to cool livestock and shortening daytime work for agricultural employees or working after sundown. Some dairy farmers say milk production can drop 15% to 20% during peak heat days.

#### Burning Phaseout to Change Ways of Disposing Agricultural Waste

On Jan. 1, farmers in the eight counties in the San Joaquin Valley Air Pollution Control District will be prohibited from nearly all open burning under a state law adopted in 2003. The law aimed to address health impacts of poor air quality on largely Latino farm towns in the San Joaquin Valley, where the air quality is among the worst in the nation. Agricultural burning, which accounts for about 4% of the region's fine particulate pollution, has long been the cheapest and easiest way to dispose of orchard and vineyard removals. Farmers are adapting to new options.

#### New Water Regulation Seeks Increased Efficiency from Urban Providers

The California State Water Resources Control Board has approved a regulation seeking to promote more efficient water use by large water utilities to address the state's anticipated 10% water supply shortfall by 2040. The regulation applies to the state's largest urban retail water suppliers, which serve 95% of California residents. The goal is to produce about 500,000 acre-feet of water savings annually by 2040—enough to supply more than 1.4 million households for a year. The rule does not apply to individuals or households.

#### Yolo County Farm Produces Seeds to Restore California's Wildlands

In Yolo County, nestled among sprawling orchards and field crops, is a one-of-a-kind farm. Each spring and summer, Hedgerow Farms turns into a patchwork of yellows, greens and violets as its fields of native wildflowers come into bloom. For more than three decades, the farm has cultivated native plants for seed production, supplying land managers working to restore wildlife preserves and other nature areas. Hedgerow Farms produces around 400 species of native grasses and wildflowers, which it sells to government agencies and other land managers. \*







# Engineering Report Finds Only Top Floor of Hotel Marysville at Risk of Falling

Continued from page 1 Apart from the lack of bracing at the top story, the structure does not appear to have been substantially destabilized by the fire damage."

The report states that the top-story masonry walls must be stabilized prior to anyone entering the building to abate existing hazardous materials. It makes several recommendations regarding abatement work which the city will share with interested demolition contractors.


As for long-term stabilization of the Hotel Marysville, constructed in 1926, the engineering firm provided this assessment: The building is in generally poor condition due to its age and a lack of maintenance in the decades it has been vacant. Now, due to the fire, the roof is destroyed, further exposing the floor framing to the elements. Even if the topstory walls are stabilized, the building will continue to deteriorate and may become unstable over time due to this deterioration. If the building is to remain, weather protection over the open roof and windows is necessary to slow the deterioration of the concrete structure.

In the longer term, the roof diaphragm should be replaced, and the concrete spalling throughout the building should be repaired in order to restore protection to the steel reinforcement and restore the structural integrity of the floor framing.

Feather River Plaza, LLC, is the recorded owner of the Hotel Marysville property. The city has demanded the company abate the public safety

issues identified since the fire and has filed suit in Yuba County Superior Court seeking a court order that gives the City authority to abate the public safety issues if the owner does not. The city continues to encourage Feather River Plaza, LLC. to address the structural and hazardous materials issues that exist on their property.

Feather River Plaza had previously offered the city the property as well as two properties across the street in their current condition, however based on the city's research the market value of the properties collectively are less than the cost to abate the hotel structure. The city has proposed a counter to the owner's counsel that would allow the city to fully recover costs to remove the building, but the owner has rejected that offer.

# Automatic Voter Registration in California Takes a Step Back

SACRAMENTO, CA (MPG) - On June 26, the Assembly elections committee approved a pared-back version of a bill that would have created an automatic voter registration system in California, with some cautious "yes" votes and continued concerns from opponents.

Senate Bill 299 by Sen. Monique Limón would have changed the current "opt-out" system of voter registration at the Department of Motor Vehicles to one where someone applying for a driver's license or ID would be automatically registered if eligible and notified after — a system in place in 11 other states.

The bill was amended to take a step back, and instead just allow the Secretary of State to create a list of people "preapproved for registration" — those of voting age who have provided the DMV with proof of citizenship.

There are no details yet on

what the trigger would be to move people on this proposed list to the rolls of registered voters, but it would require the person to take "some action to acknowledge and confirm their registration," according to Neal Ubriani, policy and research director for the Washington, D.C.-based Institute for Responsive Government, the group behind the effort in other states. That addressed one concern expressed by elections committee Chairperson Gail Pellerin and opponents. Limón said passing the bill would allow stakeholders to develop that

The committee passed the bill on a 5-0 vote.

"I do believe the author and I and all the groups in support and opposition all have the same goal: To improve voter registration for all Californians," Pellerin, a Democrat from Santa Cruz, said in her recommendation to support the bill.

"I do feel very strongly that voter registration should be something that a voter consents to do and knows that they're doing that. I think we could set up the procedures for that with this pre-approved voter registration list."

The bill is designed to try and sign up more of the 4.7 million Californians who are eligible but not registered — especially those from historically underrepresented communities.

The coalition behind the bill said the committee approval

moves it closer to its goal: Getting more working-class, Black, Latinx, Asian American, and young people to vote, its representatives said. "When we know who in our
