Vet to Celebrate 100th Birthday

not every day that a figure in the community turns 100 years old, let alone a World War II veteran.

Barbara Brewer, a longtime area resident and World War II veteran, will turn 100 on Aug. 13, a feat that not many can say they have accomplished.

Messenger Publishing Group recently spoke with Brewer via FaceTime to learn more about her and the century she has lived passion for her country.

Born in 1924 in Panguitch, Utah, Brewer battled a "tough" childhood that included being orphaned at age eight. But with gall and determination, Brewer persisted.

Shortly after graduating high school, Brewer and one of her good friends moved to Long Beach, California in 1942. She immediately took a job as a welder on the Liberty

ships, which used during the war.

"She was a real Rosie the Riveter," her daughter, Bev Hawkins, said.

Two years later, in 1944, Brewer joined the Army and was stationed in

Fort Benning, Georgia.

NCOA Plays a Vital Local Role

SACRAMENTO REGION. CA (MPG) - The Non Commissioned Officers Association (NCOA), a military service organization established in 1960, plays a vital role in supporting members across all United States Armed Forces branches and their families from Rancho Cordova and the greater Sacramento area through programs and initiatives.

With a mission focused on enhancing quality of life and supporting the professional development of non-commissioned officers, the association operates under the motto "Strength in Unity." Throughout the year, the organization raises funds through various programs and allocates them to area veterans

The Non Commissioned Officers Association also collaborates with the Rancho Cordova Area Chamber of Commerce to promote community recycling events, enhancing

environmental sustainability efforts.

A cornerstone of the association's support is the partnership with Volunteers of America for the Sacramento Stand Down, a multi-day event providing critical services such as legal aid and medical and psychological treatments to homeless veterans. The Non Commissioned Officers Association contributed more than 500 towels for veterans in need at the event.

"It's an opportunity to help those veterans to be cared for," said Non Commissioned Officers Association International Auxiliary President Tammy Sullivan. "It happens all over Sacramento. Some of our most recent locations include Placer County and Elk Grove."

Another significant program involves the association's partnership with the Veterans Administration (VA), where representatives actively assist in securing homes and furniture for homeless veterans. The association operates four warehouses in Rancho Cordova for storing donated items. Members meticulously maintain a list of Continued on page 4

SACRAMENTO COUNTY. CA (MPG) - Extreme heat waves continue to affect Sacramento County and it's crucial for pet owners to ensure their furry friends stay safe and comfortable. When temperatures rise, pets face increased risks of heat-related illnesses. Here are some essential tips to help your pets beat

Never leave pets in parked cars: Even on mild days, the temperature inside a parked car can rise rapidly, turning it into a deadly trap. Leaving pets unattended in cars is both dangerous and illegal in California.

the heat:

Hydrate: Always provide fresh water for your pets to keep them hydrated. If your pet is experiencing a heat-related illness, never give them cold water to drink or soak in. This could shock their system.

Avoid peak heat hours: Schedule walks and outdoor activities during cooler parts of the day, such as early mornings or evenings. Hot asphalt and concrete can burn your pet's paw pads, so test the surface with your hand first.

Provide shade and cool environments: Ensure outdoor pets have access to shaded areas and fresh water. Indoors, keep them in air-conditioned rooms or use fans to improve air circulation.

Use sunscreen: Pets with light skin or fur are susceptible to sunburn. Apply pet-safe sunscreen to sensitive areas like their ears and nose.

"It was right at the time," Brewer said when asked why she joined. While in the Army, Brewer worked as a dental assistant and was also on the Army softball team.

"I had great officers," Brewer said.

However, it was no easy task to be a woman in the military at the time. Brewer said women faced marriage discrimination, meaning the married men in the military had significantly more privileges than the married women did. But, Brewer emphasized, she thoroughly enjoyed her time in the Army and "liked what she did."

Brewer met her future husband, Bill, while in the Army, and they were married at Fort Benning.

"I would've stayed in the Army if I hadn't gotten married," Brewer said. "I loved it."

In 1952, Brewer and Bill had three sons and they relocated to Sacramento, where Bill worked as a civilian employee at McLellan Air Force Base. The couple later added a daughter and another son to their family and the Brewers raised their children in Citrus Heights.

In the 65 years she lived in Citrus Heights, Brewer immersed herself in the local community. She was a devoted Citrus Heights Women's Club member,

bowled in a league at Fireside Lanes, and frequently played pinochle at Rush Park. She "loved" living in Citrus Heights and remarked how "friendly" the people there

Later, Brewer moved to Atria Carmichael Oaks, where she lived for the past three years before recently relocating to Colfax to be with family.

Now living with her son and daughter-in-law, Brewer is always surrounded by many of her family members.

With five children, 10 grandchildren, and 16 great-grandchildren, Brewer has raised quite the brood. When asked how she plans to celebrate her 100th birthday, Brewer said her big family is coming into town and they plan to celebrate with her. So are there any secrets

So are there any secr to making it to 100?

Brewer kept it short and sweet and emphasized the importance of hygiene, saying, "Have good teeth and a healthy diet. And stay clean."

She made sure to leave some patriotic words of inspiration, especially to women: "All girls should go into the military," Brewer said. "Don't be afraid to join."

swimming in pools or natural bodies of water. Use life jackets and avoid swimming in strong currents or water that is too cold.

Recognize heatstroke symptoms: Watch for signs like excessive panting, drooling, glazed eyes, rapid pulse, lethargy, vomiting and collapse. If you suspect heatstroke, move your pet to a cool area and seek immediate veterinary attention. Gradual cooling helps stabilize their internal temperature without causing additional stress or shock to their system.



Handel's Ice Cream is Coming to Citrus Heights

citrus Heights, ca (MPG) - A delicious, cold treat is coming to Citrus Heights as a new Handel's Homemade Ice Cream store at 8055 Madison Ave. looks to open soon in the Almond Orchard Shopping Center.

Carol Sitzenstatter, first vice president for commercial services for Ray Stone, Inc. of Sacramento, confirms the lease of a 3,500-square-foot anchor position in the plaza that faces Madison Avenue. Sitzenstatter handled the lease transaction for the landlord, Matt Goldstein, with Galleli Real estate as the tenant representative.

Blake and Melissa Carlile, owners and franchisees of the new Citrus Heights location, and five others in the Sacramento area, say they are looking for a late September opening date.

Melissa Carlile is a former teacher in the Sacramento area, turned ice cream entrepreneur, and her husband, Blake, is a firefighter with Metro Fire. Together the couple have four children, the youngest under age seven.

The Citrus Heights store will be the couple's sixth location in six years and its largest store, she said. Together, the couple have also opened Handel's Homemade Ice Cream stores in Folsom, Roseville, Elk Grove, Natomas and Rancho Cordova.

"I'm excited to bring Handel's Ice Cream to Citrus Heights and nearby Fair Oaks," Melissa Carlile said.

The city boundary line between Citrus Heights and Fair Oaks is divided by Madison Avenue.

Carlile said the success of their other five stores encouraged them to consider looking for an additional location for further local expansion. A vacant 3,500-square-foot anchor space in the Almond Orchard Shopping Center fits their requirements, offering ample parking and a safe area where families can enjoy a cold, refreshing ice cream treat.

"This will be our largest store and we're planning to include a separate

area for parties and special events," she said.

Interior construction has required the demolition of existing concrete flooring and the installation of new drainage to handle the requirements of multiple ice cream freezers, she said.

Store staff will fluctuate seasonally, Melissa Carlile said. She expects to hire up to 30 employees before the store's opening, she said: "For many, it's a great first-time job and a perfect job for high school students."

As of January, Handel's operates 125 corporate and franchise stores in 12 states.

A Handel's Ice Cream franchise typically involves the establishment and general operation of a retail ice cream parlor, according to the company. Approximate start-up costs range from \$311,000 to \$936,000, according to the company with an initial franchise fee of \$50,000.

Handel's Ice Cream originated in Youngstown, Ohio and is continuing to open franchise locations across the West.

According to the company, Handel's features almost 50 different flavors of ice cream that are made fresh daily by hand in all its stores. The ice creamery began in 1945 with Alice Handel's signature strawberry ice cream recipe.

Handel's is known for its fourscoop ice cream sampler, piled-high three-scoop cones, milkshakes and a wide range of seasonal and popular ice cream flavors that is typically available for take-out by the scoop, in a bowl, a sundae or cookie sandwich, on a cone or in a pint.

The company has grown from a local favorite on the East Coast to a national brand with locations opening across the country. The company continues to use Alice Handel's original methods and recipes.

"The space where Handel's Ice Cream will open was previously filled by a commercial office tenant and that space had been vacant for some time," Sitzenstatter said. "Interior construction work only recently has started, so it's too early to know their opening date."

Miller's Ace Hardware, also located in the plaza nearby, adjacent to the Vitalant blood donation center, recently celebrated its first anniversary of business in the plaza.

Physical improvements to the

Almond Orchard Shopping Center are continuing, with the addition of new monument signage, new flags and fresh landscaping throughout the shopping plaza, Sitzenstatter said.

"We continue to actively market the few spaces which are available in the Almond Orchard Plaza, and we are targeting nail salons and more restaurants to compliment Fabians Italian Bistro & Bar, Pastry Heaven Bakery, Kork Sips & Snacks, El Balcon Taqueria and Del's Pizza, which are located here," Sitzenstatter said.

Said Melissa Carlile, "The Handel's Ice Cream store will be a great new addition to The Almond Orchard Plaza which is a very family and community-focused center."

Continued from page 1 veterans' needs and available resources, ensuring efficient matching and furnishing of homes with appliances and furniture. Additionally, they facilitate direct delivery of these essentials to veterans' residences, further enhancing their support efforts.

Association members also plan to increase outreach efforts to connect with the Veterans Village residents in Sacramento.

The Non Commissioned Officers Association members had an informational booth June 20 at the annual Rancho Cordova Business Expo & Job Fair.

"As a result of the business expo, we were able to start a partnership with JumpKing to acquire used, yet functional beds and mattresses for donation," Sullivan said. "We see a huge demand for these items when it comes to this program."

The Non Commissioned Officers Association also collaborates with Move America Forward, a nonprofit military charity based in Sacramento, to assemble and send care packages for troops overseas, showcasing the organization's commitment through practical, community-driven initiatives.

"I'm proud of our collaboration with the Veterans of Foreign Wars where we raise money to buy appliances such as grills and commercial toasters," said Scott Rodowick, the auxiliary chapter treasurer, reflecting on some of the association's initiatives. "These items are integral to our participation in barbecues, which serve as outreach programs aimed at keeping everybody connected."

Sullivan highlighted unique challenges faced by veterans in the region, including the need for stronger peer-to-peer connections due to the absence of active military bases nearby. To address this, the Non Commissioned Officers Association organizes events such as the Irreverent Warrior Silkie Hike, an annual veteran-only hiking

event in Rancho Cordova, fostering camaraderie and support among veterans. Additionally, members emphasize support for post-traumatic stress disorder (PTSD) treatment and aim to improve coordination among veterans'organizations for more effective outreach.

Area residents, businesses and volunteers interested in supporting the Non Commissioned Officers Association's mission can engage through volunteering opportunities listed on the association's website at ncoausa.org or by following its social media presence. Sullivan emphasized the importance of community awareness and involvement in bolstering their efforts to assist veterans effectively.

"There are so many ways and varying levels of degrees to get involved," Rodowick said. "It's a great group of wonderful people and the greatest gift is when you are helping others. Especially those that put their lives on the line to give us the freedoms we enjoy today."

The Noncommissioned Officers Association meets regularly in Rancho Cordova and other locations throughout Sacramento, with monthly gatherings aimed at fostering community and support among members. Two local chapters include the Central Valley and the Spirit of Sacramento Auxiliary Chapters comprising about 90 members in the Sacramento area.

When asked why residents should join the Non Commissioned Officers Association, Sullivan emphasized the organization's responsibility to veterans and the community.

"We enjoy the freedoms of today because of those veterans and sometimes this gets lost," Sullivan said. "We all have someone or know someone that has put that uniform on and that uniform represents this country and everything this country stands for. We should honor that."


Rodowick said that members do not have to be connected to the military to join. Anyone can be a part of the organization."

"A man's got to know his limitations," is the famous advice given by Clint Eastwood in his role as Dirty Harry, in the 1973 movie, "Magnum Force." As a spiritual columnist, I see some spiritual awareness in those words.

While my limitations are unlimited, I can briefly share three settings where it's helpful for me to "know my limitations."

Three Things I'm Too Inept to Manage

I can't seem to learn Italian so I can order a venti or grande iced tea at Starbucks. I remind the clerk, "This is America, darn it. Give me the Jumbo Super Slurper."

I'm unskilled in the self-check line at the grocery store. Those computer voices fluster me. They sound too much like creepy Hal in 2001 Space Odyssey, just endlessly repeating, "Unauthorized item in the bagging area."

I can't manage accuracy when the grocery store asks for my personal information on the store application for "preferred card." I don't need the avalanche of junk mail, text messages or email spam they bring, so I use the name "Ima Snooty."

Three Things I'm Too Clumsy to Accomplish at Church.

I don't care to hug strangers. This limitation is a trait of the INFP, a type from the Myers Briggs personality test. The letters stand for "Introverted, Intuitive, Feeling, and Prospecting" and, according to the test, an INFP "tends to be quiet, openminded, and imaginative, and they apply a caring and creative approach to everything they do."

As an INFP, I sometimes feel like I'd rather run to my car after my sermon than stay around and hug people.

I'm unable to think of the word that fills in the "fill-in-the-blank" sermon outlines found in many church bulletins. These

outlines are akin to karaoke and were popularized by the now-retired evangelical pastor Rick Warren.

I'm too rhythmically challenged to clap to the beat of contemporary church music. I have to make a choice: sing or clap. And since people tend to get hurt when I clap, I

stick to singing.

I cannot, will not, tell you that your faith and beliefs are wrong and mine are right. Some Christians are fond of quoting John 14:6 concerning Jesus being the only way to God. But if you are reciting the verse to other faiths, you are not sharing your faith, you're shouting your condemnation.

I won't impose my faith on you in a public situation by giving a public prayer when I know that the audience may not be of my faith. Because, if I only pray what doesn't offend me and -- you can only hear what doesn't offend you -- then we dilute both of our faiths.

I won't debate you. I'm not going to argue religion with you. Neither will I engage in disputes over abortion, the death penalty, theology, politics, evolution or the existence of God. I will, however, engage in a thoughtful examination of the issues. Maybe it's the INFP personality, but my dad taught me that it can take more courage to walk away from an argument.

That's enough of the negative limitations. Before I finish, let me tell you where I tend to be limit-less.

I try to be an example of struggling faith. "What is that?" you ask. Struggling faith recognizes that no one has faith completely figured out. God is too big to be contained in one religion. We can learn things about faith from people of other faiths, and even from people who profess no faith at all.

I want to follow the direction of I Peter 3:15: "Be ready to speak up and tell anyone who asks why you're living the way you are and always with the utmost

Finally, if you ask me, I will pray with you without limits. My prayers are voiced in plain English without the "thee" and "thou" from King James's Old English. However, given my touch of ADD, the prayers won't be a grande or a venti size prayer, just a small one.

Just don't ask me to do one of those huggy prayers. After all, a pastor really should know his/her limitations.

New California Law Aims to Address Teacher Shortage

California Commission on Teacher Credentialing News Release

SACRAMENTO, CA (MPG) - The California Commission on Teacher Credentialing is optimistic that a new state law intended to address the teacher shortage will help eliminate barriers to the profession and attract more prospective educators into

Senate Bill 153, signed by Governor Gavin Newsom on June 29, and effective immediately, allows for a qualifying bachelor's degree or higher in any subject to be all that is needed for an individual to demonstrate basic skills required for admission to most teacher preparation programs.

This means that if an applicant holds a bachelor's degree or higher from a regionally accredited institution of higher education, teacher preparation programs will no longer need to verify demonstrated competence in reading, writing, and mathematics through any other options, including passing the California Basic Skills Examination for Teachers (CBEST) or performing a transcript review.

"This change in state educator preparation policy represents a major shift that will benefit the vast majority of prospective educators in California," said Mary Vixie Sandy, executive director, California Commission on Teacher Credentialing.

"Now is a great time for anyone with a qualifying bachelor's degree or higher who has considered teaching to take the next step to pursue their passion for education and

apply to one of the state's many accredited teacher preparation programs." The Commission's recent teacher supply

annual report to the Legislature tracked an

11.2 % year-over-year decrease in the number of new teaching credentials issued between 2021-22 and 2022-23. In the most recent 2022-23 fiscal year data, there were 14,636 new teaching credentials issued compared to 16,484 the previous year.

"The CSU greatly appreciates the state's decision to recognize the bachelor's degree as demonstration of basic skills competence for educator credentials," said Commissioner Shireen Pavri, assistant vice chancellor of the Educator and Leadership Program at California State University.

'We believe this is exactly the right move toward reducing barriers for those considering teaching, counseling, and other education professions in California."

The State of California has provided approximately \$1.6 billion since 2016-17 to address the teacher shortage.

The 2022-23 state budget funded eight career counselors staffed at the Commission on Teacher Credentialing to provide one-on-one assistance to anyone interested in becoming an educator.

These experienced staff members serve as career guidance counselors, credential experts, subject matter experts, and resource specialists for individuals seeking to make the transition into a PK-12 educational career.

California Has Seen Many Towns Created, But as Population Drops a Big Project Has Stalled

When California emerged from its colonial beginnings nearly two centuries ago and began coalescing into a distinct society, its towns and villages tended to be located either on navigable rivers, such as Sacramento, or around the 21 missions that Spanish explorer priests had established, such as San Diego.

In the late 19th century, with California having experienced a massive population boom during the Gold Rush and become a state, entirely new communities sprung up. These settlements were often carved out of farm and ranch land by developers and railroads, the small San Joaquin Valley city of Hanford being one of the latter.

For example, the small villages south of San Francisco, such as Hillsborough, were designed as refuges for the wealthy from the noise, pollution and violence of San Francisco — and eventually led to the formation of San Mateo County as a protective bulwark.

The creation of new towns continued for most of the 20th century. In Orange County, the descendants of 19th century ranchers converted chunks of their vast holdings into new towns to absorb the region's massive post-World War II population growth.

The most spectacular example was — and still is — the City of Irvine, named for a

ranching family, and home to a quarter-million people and a major University of California campus. Dick O'Neill, heir to a huge Orange County cattle ranch, created two cities — Mission Viejo and Rancho Santa Margarita.

On the outskirts of Sacramento, along the Cosumnes River, another ranching family successfully created a stand-alone community called Rancho Murieta.

Creating new towns can be a risky endeavor. Developers can spend millions to plan their new communities and install infrastructure but may wait decades to see a profit.

California City, in the Antelope Valley 100 miles north of Los Angeles, was founded in 1958, but its remote location and somewhat inhospitable terrain and climate made attracting residents difficult. It's still there and has about 15,000 residents, but that's way short of the original ambition.

Mountain House, created three decades ago in a corner of San Joaquin County to attract commuters to Bay Area jobs, also struggled, particularly during the collapse of the housing market during the Great Recession. However, it survived: Today it has about 25,000 residents and on July 1 became an incorporated city.

The Tejon Ranch, an immense cattle ranch in the Tehachapi Mountains, has been trying for decades to create a new residential community, but it has faced massive opposition from environmental groups. It is finally beginning construction on an apartment complex.

That brings us to California's latest effort to carve out a new community, this one in a rural portion of Solano County.

California Forever, a

company backed by Silicon Valley billionaires, quietly – even sneakily — bought more than 50,000 acres of ranchland, after which it finally revealed plans for a new community that would eventually have 400,000 residents.

The secrecy and scope of the project generated immediate opposition, particularly after the company said it would seek approval via a November election ballot measure, bypassing hurdles such as the California Environmental Quality Act.

With approval by Solano County voters in doubt, California Forever has shelved its ballot measure. Company officials say they now will strive to gain popular support before proceeding.

The explosive growth that California experienced in the first 170 years of its existence as a state has now abated, probably for good. California has been losing population in recent years and at best it will probably see population stagnation in the future.

That said, California still has a housing shortage, and state policy is to encourage infill projects in or near cities rather than developing open spaces, which California Forever would do.

The chances for California Forever to join the ranks of new town developers are slim at best.

The NBA summer league is over, but changes to the Kings ultimate roster for the upcoming season are not nearly over.

GM Monte McNair has earned his stripes by consistently making solid moves that will give Sacramento Kings fans potentially the best NBA team they've seen since the Webber/Bibby era, in which the Kings won a gaudy 61 games in 2021/22.

At this juncture, making predictions that would rival that season seems ludicrous, but make no mistake about it, McNair has his sights on a 60-win season, and he's scouring the NBA and beyond to find components that will get this franchise to that end.

The power forward position continues to be a point of focus, and although the Kings recently acquired Orlando Robinson, the search continues for a true rim protector that can play defense and add even a modicum of scoring while he's on the hardwood.

Potentially, that player could be a bench player for the Portland Trailblazers by the name of Robert Williams III. At 26 years of age, Williams' best playing days are still in front of him, and his seven points and six rebounds a year ago for the Trailblazers doesn't tell the full story. At 6'9" and 250 lbs., Williams is a true shot blocker, and the thinking here is given more playing time, this young man could become a true double-double threat.

The Kings are all too familiar with a double-double threat, as big man Domantas Sabonis has led the NBA in double-doubles the past two seasons, while leading the entire NBA in rebounding at the same time. Imagine if the Kings could surround this stevedore with just a little more support around the rim!

The only Sacramento King currently playing basketball in the Paris Olympics is none other than Trey Lyles, and although he's had a less than stellar performance so far for his home country of Canada, I remain convinced that if used correctly for the Kings, Lyles not only could give the Kings a boost in the upcoming season, he could actually break into the starting lineup.

Most pundits think I'm crazy, but I have

always seen a higher ceiling in Trey, and the only way we will ever know if I'm right, is to increase his playing time.

Trev is a consistent three-point shooter and solid rebounder behind Domantas, and I believe as the Kings continue to search for power-forward solutions, they should look no further than their own bench.

I have to believe that Monte McNair shares some of my zeal for this talented big man, or we would have already seen him in either a trade or trade rumors.

The real question is not McNair, but coach Brown. During last season's campaign, there was no consistent rotation for Lyles coming off the bench, and he went through stretches in which his minutes were sparing to say the least.

For any player, and particularly a big man, there must be that vote of confidence, that is demonstrated by his consistent time on the court, and that includes hardwood time during the last five minutes of a game. Show him that you trust his game when it means the most, and watch his confidence grow.

I give Mike Brown high marks for understanding how to bring along Keon Ellis, but his reluctance to use Trey Lyles when the Kings are starving for front-court players, remains a mystery to me.

The summer league did reveal that the Kings have a burgeoning star in your Boogie Ellis, who did pretty much what he wanted to against opposing summer league players. Boogie has been invited to training camp, and although the Kings remain guard heavy, Boogie's instant offense and frenetic defense means he deserves a closer look. At only 23 years of age, the Kings want to make sure they don't pass on a guard that may very well portend happy times for their future. The big man/power forward rumors are

ubiquitous, but I'm convinced that Monte McNair has at least one more notable move to make, and it's my educated guess it will come in the form of a power forward. Stay tuned this off-season as its roster moves aren't over yet!

Social Security Matters

Does Congress Pay Into Social Security?

Dear Rusty: I've been told that members of Congress do not have Social Security deducted from their pay; Additionally, that their retirement dollars come from the Social Security Administration purse even if they only serve as a member of Congress for a short number of terms. Also, if this is true, are there other individuals that enjoy these advantages?

Thank you in advance for your service as a Social Security Advisor. Signed: **Concerned Senior**

Dear Concerned Senior: I'm afraid this is one of those "urban legend" kind of rumors that just seems to keep popping up, especially when the issues surrounding Social Security's financial problems come up. In addition to being untrue, it often is used to display the public's animosity toward elected officials and the feeling that Congress-and other elected officials-are

above the fray, so to speak, and therefore not affected by the implications of Social Security's looming insolvency problem.

Here's the reality. Since January 1, 1984, all members of Congress, the President and Vice President, Federal judges, and most political appointees, are covered under the Social Security program. The rumor that these elected officials do not pay Social Security tax most likely is attributable to the fact that from 1920 to 1983, they were participants in the Civil Service Retirement System - CSRS - the federal retirement plan federal workers used even before the Social Security Act was passed. CSRS provided a pension for federal employees, so they were exempted from contributing to or collecting from the new Social Security program.

In 1987, then, the federal government officially changed over to FERS - the Federal Employee Retirement System – and all employes hired from that point forward are now covered under FERS. There are multiple parts to FERS, and one of them is mandatory FICA contributions. So, all federal employees—including members of Congress—are subject to the 6.2% FICA tax, are eligible for Social

Security retirement benefits, and are governed by the multitude of rules and regulations associated with Social Security. But other than standard SS benefits which they may normally be entitled, no Social Security funds are used to supplement Congressional retirement.

In other words, the rumor that Congress didn't pay into Social Security was actually true prior to 1984, but today it is a misstatement of fact. And the federal employee retirement plans (both the prior CSRS plan and the current FERS plan) are totally independent of Social Security and do not negatively affect program solvency.






