DIXON, CA (MPG) - On Aug. 17, wine and food connoisseurs will flock to downtown Dixon.

This event is a two-decade tradition.

"This will be the best Wine and Art Stroll we have ever had," said Downtown Dixon Business Association President Jill Ferguson-Orr.

With wine glasses in hand, attendees visit various businesses to sample wine and appetizers. They will hear live music and see art displays during the visits. Entry tickets are \$35, which includes a commemorative wine glass. Wine tasters must be at least 21 years old. Participating businesses at this year's event include Kevin Johnson's Remax Gold Real Estate, Bud's Pub and Grill, Busy Bee Yoga, Luke's Lounge, The Moose Lodge, Dixon History Museum, The Creative Space, Cynde's Place and First Northern Bank. Others include B Street Barber Shop, Barrett-Leber Realty, Every Baking Moment, Dawson's Bar and Grill, Avila Flooring, PIP Wine Bar, Tres Banditas, Century 21 Epic, BobTail Apparel, Sofia Grace Boutique, Art of Touch, All Good Ink, Vida Salon Nino's Cut and Shave, Dixon Frosty, ARCK Loans, Chamber of Commerce, Almond Tree Mortgage, The Farmstead, and Grocery Outlet. "We are really proud of the quality of vendors and everything we do goes back downtown for Oktoberfest, Halloween, and the Christmas Tree Lighting," Orr said. "These functions are all sponsored by the Downtown Dixon Business Association and are an enduring legacy of former DDBA President Rob Salaber.' The event was first organized by Salaber in 2002.

DIXON, CA (MPG) - The water rate increase is officially in effect.

"Here is the one I think everyone is waiting for," Mayor Steve Bird said before announcing the adoption of the water rate increase on July 16. The once-looming increase is now a reality after detailed draft studies, creating an ad hoc committee, and holding public workshops and hearings.

The water rate increase is among a few Dixon water issues, including

the city's recent joining of a lawsuit against the state of California over Chromium water levels and the recent approval of \$119,000 for more work on the Valley Glen Well Project in southern Dixon.

With no other way to wipe out the \$417,000 annual operating deficit that includes deferred capital projects, passing the increase meant hearing from the public beforehand. IB Water Rate Study Consultant Habib Isaac made it clear before adopting the increase that he would "not answer any questions from the public," rather only to the council.



The resident above expressed concern for group homes affected by the rate increase, citing the Americans with Disabilities Act.

Officials contend the increase will help fund critical and near-term projects. A water meter replacement program, a new well, electrical upgrades, and well upgrades and replacement are just a few of the projects totaling \$13.5 million.

Even with an increase, officials pointed out that existing rates remain at some of the region's lowest levels before and after the rise. However, the silver lining seemed to upset resident Richard Ropiak even more, with the local reminding officials, "We are on a water bowl; we better have the *Continued on page 8*

When You Know You Can Help, Apply

While at a recent appointment, I shared a conversation with a Dixon teacher. School was due to start shortly and I know those are usually exciting times for teachers as they get their classrooms decorated and stocked for another school year with children.

Since I had been covering the school board and trying to keep up on some of the Dixon plans, I mentioned that I was aware of the numerous openings in our district and that I knew of a few people who were hired without teaching credentials. She said that was no surprise as even our district superintendent didn't have one. That was a source of contention with a lot of Dixon teachers.

For experienced teachers, they have gone through extra education and expense to be able to teach so I can see why there might be some resentment. On the other hand, what an awesome opportunity for those who want to teach—they get to experience teaching while they finish any requirements. It seems to me that those are the people who are truly excited for the opportunity.

Now remember, I'm old enough to have lived through decades of school ups and downs in this state and wanted to remind readers that this is just another change.

Here is some history: Early in California, the responsibility of certifying qualifications for teachers was held by schools and districts. In the late 1940s, there was a movement to increase professionalism in teaching through state standards and uniform governance.

According to an article by Sidney A. Inglis in a government booklet on the History of Policies and Forces Shaping California Teacher Credentialing, it was in the 1950s when growing national dissatisfaction with the public-school curriculum and the preparation of teachers ultimately fed into politics. A State Senator, Hugo Fisher, pushed for subject matter preparation of elementary and secondary teachers and reduced emphasis of lesson planning and classroom management.

The Ryan Act of 1970 created the first independent standards board in the nation, the Commission on Teacher Preparation and Licensing. The purpose was a step toward establishing teaching as a recognized profession.

Their mission states, "The Commission on Teacher Credentialing is to ensure integrity and high quality in the preparation, conduct and professional growth of the educators who serve California's public schools. Its work shall reflect both statutory mandates that govern the Commission and research on professional practices."

I found an entire chapter about the 1990s when I was back in college where that Commission was highly influential in school reform and pushed for smaller class size, thus creating a demand for teachers. Every young woman I knew at that time wanted to become a teacher, but it took an extra two years of college coursework and apprenticeship. When Covid hit, the world of teaching dramatically changed creating a national teacher shortage that is one of the worst in California. There are three main reasons: 1) Rapid decline in teacher preparation enrollments; 2) New demand for better teacher-pupil ratios in districts seeking to return to recession course offerings and class sizes; and 3) Teacher turnover.

So now is just another wave of change in Dixon's teachers' demand and supply. If you know you can help, apply on EdJoin. com. While some teachers are leaving for more money elsewhere, there are newbies who can't wait to become part of Dixon Unified and educate our students.

SACRAMENTO, CA (MPG) - The California Commission on Teacher Credentialing is optimistic that a new state law intended to address the teacher shortage will help eliminate barriers to the profession and attract more prospective educators into classrooms.

Senate Bill 153, signed by Governor Gavin Newsom on June 29, and effective immediately, allows for a qualifying bachelor's degree or higher in any subject to be all that is needed for an individual to demonstrate basic skills required for admission to most teacher preparation programs.

This means that if an applicant holds a bachelor's degree or higher from a regionally accredited institution of higher education, teacher preparation programs will no longer need to verify demonstrated competence in reading, writing, and mathematics through any other options, including passing the California Basic Skills Examination for Teachers (CBEST) or performing a transcript review.

"This change in state educator preparation policy represents a major shift that will benefit the vast majority of prospective educators in California," said Mary Vixie Sandy, executive director, California Commission on Teacher Credentialing.

"Now is a great time for anyone with a qualifying bachelor's degree or higher who has considered teaching to take the next step to pursue their passion for education and apply to one of the state's many accredited teacher preparation programs."

The Commission's recent teacher supply annual report to the Legislature tracked recent 2022-23 fiscal year data, there were 14,636 new teaching credentials issued compared to 16,484 the previous year.

"The CSU greatly appreciates the state's decision to recognize the bachelor's degree as demonstration of basic skills competence for educator credentials," said Commissioner Shireen Pavri, assistant vice chancellor of the Educator and Leadership Program at California State University.

"We believe this is exactly the right move toward reducing barriers for those considering teaching, counseling, and other education professions in California."

The State of California has provided approximately \$1.6 billion since 2016-17 to address the teacher shortage.

The 2022-23 state budget funded eight career counselors staffed at the Commission on Teacher Credentialing to provide one-on-one assistance to anyone interested in becoming an educator.

These experienced staff members serve as career guidance counselors, credential experts, subject matter experts, and resource specialists for individuals seeking to make the transition into a PK-12 educational career.

More than Farm Fresh

DIXON, CA (MPG) - Where can you find plump produce and community connections while helping sustain local soil?

Answer: the Dixon Farmer's Market on Thursday nights.

Becca Bernard and her partner, Ahmad (Simba) Baratti, the farm and market manager, consider it an honor to feed residents the finest fruits and vegetables farmed locally for several reasons, including health.

"There is ample scientific evidence showing that eating healthier correlates with a longer life expectancy," Bernard said, adding that there are worldwide "blue zones" where people live the longest due to diet. "Eating fresh fruits, vegetables, nuts, and other natural foods is the secret to a healthier life."

While Bernard said the duo's primary goal is to increase awareness and access to fresh, unprocessed foods, it is also about variety.

"We work with dozens of farmers and vendors to provide a diverse selection of locally grown and made foods," Bernard said.

Diversity breeds connection in the market. According to Bernard, farmers who sell directly to residents receive high-quality feedback from their customers through weekly interactions.

"We love hearing about the delicious recipes our customers create with the ingredients they buy from us," Bernard said. "These relationships lead to many possibilities, including customer suggestions for new crops to grow or introducing you to unique varieties of vegetables."

Beyond local love is cost. Bernard said farmers make only 15 cents per product, with the rest going to retail

costs. Buying directly from local farmers offers fresher produce while local economic sustainability, especially for

becoming stewards of the land once again," Bernard said. "We must think not just one or two seasons ahead but for our great-grandchildren seven generations down the road, who will rely on this same soil for sustenance."

Doing so entails eating less big-box and more local. By shopping at farmers markets, Bernard said, patrons become a part of the sustainability cycle, stewarding the land.

"The sweetness of a peak-season strawberry or a juicy fig bursting from the skin in summer is unmatched," Bernard said. "Although it can be challenging to adjust to seasonal eating, it makes the return of our favorite fruits and vegetables that much more special."

Along with a longer life and local sustainability, there are undeniable connections among those wandering through the farmer's market on Thursday nights. Bernard will be the first to talk about the serendipitous encounters between marketgoers.

"About 10 years ago, a mutual friend introduced me to Simba at the Davis farmers market," Bernard said. "Over the years, our friendship blossomed into a relationship, and now, seven years later, we work together to connect communities with the farmers who grow their food."

Fast-forward and the couple cannot express enough gratitude to the weekly regulars who support the local small businesses and farmers.

"We love chatting with you, saying hi to your kiddos and dogs, and seeing you interact with each other to foster a community of care and concern," Bernard said. "The community becomes an extended family, allowing us to check in on each other and share life updates about the grandkids or your most recent road trips."

Scammers Target PG&E Customers, Here's What Not to Fall Victim to

NORTHERN CALIFORNIA, CA (MPG) - Utility scams have continued at an alarming rate during 2024, with Pacific Gas and Electric (PG&E) customers reporting over \$334,000 in losses to scammers. To stop this trend, PG&E is committed to helping customers recognize the signs of a scam and avoid falling victim.

A typical sign of a scam targeting a utility customer includes a caller claiming to be from PG&E and threatening disconnection if immediate payment is not made via a pre-paid debit card, digital payment mobile application, or other methods of money transfer. As a reminder, PG&E will never send a single notification to a customer within one hour of a service interruption and will never ask customers to make payments with a pre-paid debit card, gift card, any form of cryptocurrency, or instant mobile payment applications, like Zelle® or Venmo.

"Scammers seek to create a sense of panic, threatening disconnection of utility services if immediate payment is not made,"said Matt Foley, lead customer scam investigator for PG&E. "If a phone call, visit to your home or email doesn't feel right, don't fall for it. Hang up, shut the door or delete it. Remember, PG&E will never ask for your financial information over the phone or via email, nor will we request payment via pre-paid debit cards or other methods of money transfer, including mobile applications."

During 2024, PG&E has received nearly 15,000 reports of scams targeting residential and business customers with customers reporting losses of over \$334,000. The average scam victim lost over \$600, and over 500 customers have reported falling victim. This number is likely just the tip of the iceberg however, as many scams go unreported.

Business customers also are not immune from scam attempts. In fact, PG&E has received 528 reports of scams targeting small and medium-sized businesses this year, and these attempts frequently occur during busy business hours when scammers hope to catch unsuspecting victims while they are distracted or stressed.

Another recent scam trend involves scammers creating fake websites which provide a fraudulent phone number when you search services related to PGE such as "bill pay" or "start/stop" service. These sites and phone numbers often appear when a handheld device is used to search for and contact PGE. As a reminder, customers looking to contact PG&E should either call our customer service number, 800-743-5000 or by logging into your account at www.pge.com.

Scammers can be convincing and often target those who are most vulnerable, including senior citizens and low-income communities. owners during busy customer service hours. However, with the right information, customers can learn to detect and report these predatory scams by visiting www.pge.com/ scams or by calling 1-833-500-SCAM. Signs of a potential scam

Signs of a potential scam

Threat to disconnect: Scammers may aggressively demand immediate payment for an alleged past due bill.

Request for immediate payment: Scammers may instruct the customer to purchase a prepaid card, then call them back supposedly to make a bill payment.

Request for prepaid card: When the customer calls back, the caller asks the customer for the prepaid card's number, which grants the scammer instant access to the card's funds.

Refund or rebate offers: Scammers may say that your utility company overbilled you and owes you a refund, or that you are entitled to a rebate, and ask you for your personal financial information.

Scammers Impersonating Trusted Phone Numbers: Scammers are now able to create authentic looking 800 numbers which appear on your phone display. The numbers don't lead back to PG&E if called back, however, so if you have doubts, hang up and either log into your account at pge.com to confirm your bill details or call PG&E at 1-833-500-SCAM. If customers ever feel that they are in physical danger, they should call 9-1-1.

How customers can protect themselves


Customers should never purchase a prepaid card to avoid service disconnection or shutoff. PG&E does not specify how customers should make a bill payment and offers a variety of ways to pay a bill, including accepting payments online, by phone, automatic bank draft, mail or in person.

If a scammer threatens immediate disconnection or shutoff of service without prior notification, customers should hang up the phone, delete the email, or shut the door. Customers with delinquent accounts receive an advance disconnection notification, typically by mail and included with their regular monthly bill.

Signing up for an online account at pge. com is another safeguard. Not only can customers log in to check their balance and payment history, but they can also sign up for recurring payments, paperless billing and helpful alerts.

Customers who suspect that they have been victims of fraud, or who feel threatened during contact with one of these scammers, should contact local law enforcement. The Federal Trade Commission's website is also a good source of information about how to protect personal information.



UC Regents Approve New Student Housing at UC Davis

DAVIS, CA (MPG) - UC Davis will break ground on a new residence hall next spring in the Segundo area, following approval this week by the UC Board of Regents. The \$100 million project aims to address the growing demand for on-campus housing and commitments the campus has made with the city of Davis.

The new complex, tentatively titled the "Segundo Infill Project," will span 118,000 square feet and feature 206 rooms, accommodating 494 students in double and triple occupancy configurations. The residence hall will stand five stories tall, offering students modern amenities, study nooks, social spaces and 600 bike spaces.

The university considered building higher than five floors, but in California, buildings six stories or higher fall under different building codes and incur significantly higher costs. Opting for a five-story structure helps manage expenses and ensure housing remains affordable, while still providing needed supply. The residence hall will feature a concrete

podium and steel frame, ensuring durability, longevity and a quieter living environment.

Constructed on what are currently parking lots 22 and 16, the site will also transform its surroundings; parking will be restored in lot 16 after construction is completed.

"The UC Davis campus has added 6,500 beds since 2017 to meet demand given undergraduate housing guarantees and enrollment growth and to make progress toward Long-Range Development Plan goals and MOU commitments with the city of Davis," Chancellor Gary S. May said before the Board of Regents meeting. "We are pleased that the regents have approved this item so that UC Davis can continue to make considerable progress toward

these important housing commitments and goals."

As of fall 2023, UC Davis provides on-campus housing for 38% of Davis-based undergraduate and graduate students. The new residence hall will help the university move closer to its goal of housing 48% of its Davisbased students on campus, as outlined in the Long-Range Development Plan (LRDP) and the Memorandum of Understanding (MOU) with the city of Davis.

The entire project will be 100% electric and will aim for a minimum LEED Gold certification, with a goal of obtaining LEED Platinum.

The residence hall is expected to be ready for occupancy by the fall quarter of 2027. \star on Wednesday, July 31.

California Has Seen Many Towns Created, But as Population Drops a Big Project Has Stalled

When California emerged from its colonial beginnings nearly two centuries ago and began coalescing into a distinct society, its towns and villages tended to be located either on navigable rivers, such as Sacramento, or around the 21 missions that Spanish explorer priests had established, such as San Diego.

In the late 19th century, with California having experienced a massive population boom during the Gold Rush and become a state, entirely new communities sprung up. These settlements were often carved out of farm and ranch land by developers and railroads, the small San Joaquin Valley city of Hanford being one of the latter.

For example, the small villages south of San Francisco, such as Hillsborough, were designed as refuges for the wealthy from the noise, pollution and violence of San Francisco — and eventually led to the formation of San Mateo County as a protective bulwark.

The creation of new towns continued for most of the 20th century. In Orange County, the descendants of 19th century ranchers converted chunks of their vast holdings into new towns to absorb the region's massive post-World War II population growth.

The most spectacular example was — and still is — the City of Irvine, named for a

ranching family, and home to a quarter-million people and a major University of California campus. Dick O'Neill, heir to a huge Orange County cattle ranch, created two cities — Mission Viejo and Rancho Santa Margarita.

On the outskirts of Sacramento, along the Cosumnes River, another ranching family successfully created a stand-alone community called Rancho Murieta.

Creating new towns can be a risky endeavor. Developers can spend millions to plan their new communities and install infrastructure but may wait decades to see a profit.

California City, in the Antelope Valley 100 miles north of Los Angeles, was founded in 1958, but its remote location and somewhat inhospitable terrain and climate made attracting residents difficult. It's still there and has about 15,000 residents, but that's way short of the original ambition.

Mountain House, created three decades ago in a corner of San Joaquin County to attract commuters to Bay Area jobs, also struggled, particularly during the collapse of the housing market during the Great Recession. However, it survived: Today it has about 25,000 residents and on July 1 became an incorporated city.

The Tejon Ranch, an immense cattle ranch in the Tehachapi Mountains, has been trying for decades to create a new residential community, but it has faced massive opposition from environmental groups. It is finally beginning construction on an apartment complex.

That brings us to California's latest effort to carve out a new community, this one in a rural portion of Solano County.

California Forever, a



company backed by Silicon Valley billionaires, quietly even sneakily — bought more than 50,000 acres of ranchland, after which it finally revealed plans for a new community that would eventually have 400,000 residents.

The secrecy and scope of the project generated immediate opposition, particularly after the company said it would seek approval via a November election ballot measure, bypassing hurdles such as the California Environmental Quality Act.

With approval by Solano County voters in doubt, California Forever has shelved its ballot measure. Company officials say they now will strive to gain popular support before proceeding.

The explosive growth that California experienced in the first 170 years of its existence as a state has now abated, probably for good. California has been losing population in recent years and at best it will probably see population stagnation in the future.

That said, California still has a housing shortage, and state policy is to encourage infill projects in or near cities rather than developing open spaces, which California Forever would do.

The chances for California Forever to join the ranks of new town developers are slim at best.

"DEADPOOL & WOLVERINE" RATED R

"Make Superhero Movies Fun Again" could be the mantra for "Deadpool & Wolverine," an R-rated action comedy that leans heavily into the rivalry of two superheroes and their unabashed proclivity for bloody fights and hurling profanity-laced insults.

The long-awaited return of a "Deadpool" film is a saving grace for the Marvel Cinematic Universe, which has received disappointing box office numbers for recent films, including the overly hyped "Captain Marvel."

But just when it feels like the superhero genre has been exhausted, along comes Ryan Reynolds and Hugh Jackman to deliver a wallop of crowd-pleasing excitement filled with giddy, humorous irreverence and blockbuster action.

Wade Wilson (Ryan Reynolds), wearing a really bad toupee, has hung up his Deadpool costume to sell used cars. His trademark red ensemble has been retired since he failed to be accepted into the Avengers.

Wade's ordinary civilian life takes a wild turn when the Time Variance Authority, under the leadership of the officious Mr. Paradox (Matthew Macfadyen), sucks him into a mission. Deadpool's universe faces extinction, so it is time to suit up again.

An existential threat looms over Deadpool and his friends, including estranged girlfriend Vanessa (Morena Baccarin) and his unsighted roommate Blind Al (Leslie Uggams). This is all the more reason for Deadpool to trade hawking autos to packing his swords once more.

There is not much point in trying to explain the apocalyptic threat that kills timelines. Just know that a place known as The Void, set in a barren landscape reminiscent of "Mad Max," is run by the villainous Cassandra (Emma Corwin), who looks like an emaciated model minus the hair.

While Wade may not be that thrilled to enter the superhero arena, Wolverine (Hugh Jackman), deep-sixed in "Logan," is resurrected, so to speak, and still much in need of anger management.

GM Monte McNair has earned his stripes by consistently making solid moves that will give Sacramento Kings fans potentially the best NBA team they've seen since the Webber/Bibby era, in which the Kings won a gaudy 61 games in 2021/22.

At this juncture, making predictions that would rival that season seems ludicrous, but make no mistake about it, McNair has his sights on a 60-win season, and he's scouring the NBA and beyond to find components that will get this franchise to that end.

The power forward position continues to be a point of focus, and although the Kings recently acquired Orlando Robinson, the search continues for a true rim protector that can play defense and add even a modicum of scoring while he's on the hardwood.

The Kings are all too familiar with a double-double threat, as big man Domantas Sabonis has led the NBA in double-doubles the past two seasons, while leading the entire NBA in rebounding at the same time. Imagine if the Kings could surround this stevedore with just a little more support around the rim!

The only Sacramento King currently playing basketball in the Paris Olympics is none other than Trey Lyles, and although he's had a less than stellar performance so far for his home country of Canada, I remain convinced that if used correctly for the Kings, Lyles not only could give the Kings a boost in the upcoming season, he could actually break into the starting lineup.

Most pundits think I'm crazy, but I have

always seen a higher ceiling in Trey, and the only way we will ever know if I'm right, is to increase his playing time.

Trey is a consistent three-point shooter and solid rebounder behind Domantas, and I believe as the Kings continue to search for power-forward solutions, they should look no further than their own bench.

I have to believe that Monte McNair shares some of my zeal for this talented big man, or we would have already seen him in either a trade or trade rumors.

The real question is not McNair, but coach Brown. During last season's campaign, there was no consistent rotation for Lyles coming off the bench, and he went through stretches in which his minutes were sparing to say the least.

For any player, and particularly a big man, there must be that vote of confidence, that is demonstrated by his consistent time on the court, and that includes hardwood time during the last five minutes of a game. Show him that you trust his game when it means the most, and watch his confidence grow.

I give Mike Brown high marks for understanding how to bring along Keon Ellis, but his reluctance to use Trey Lyles when the Kings are starving for front-court players, remains a mystery to me.

The summer league did reveal that the Kings have a burgeoning star in your Boogie Ellis, who did pretty much what he wanted to against opposing summer league players. Boogie has been invited to training camp, and although the Kings remain guard heavy, Boogie's instant offense and frenetic defense means he deserves a closer look. At only 23 years of age, the Kings want to make sure they don't pass on a guard that may very well portend happy times for their future.

The big man/power forward rumors are ubiquitous, but I'm convinced that Monte McNair has at least one more notable move to make, and it's my educated guess it will come in the form of a power forward.

Stay tuned this off-season as its roster moves aren't over yet!

Heat Wave Impacts Supply of California Table Grapes

The recent prolonged heat wave has slowed the supply of California table grapes, with vines shutting down and picking crews working fewer hours just as the state's main growing region ramps up harvest. San Joaquin Valley growers, who produce most of the nation's fresh-market grapes, say the excessive heat has begun to damage some varieties while inhibiting growth of others. Kern County grower Mark Hall said the extended heat spell has affected quality. Some fruit that didn't get picked on time turned mushy. But less fruit on the market has helped prices.

Cling Peach Harvest Crews Rise Early to Beat Heat, Protect Fruit

California clingstone peach growers are working to harvest the season's crop before high temperatures lead to overripe fruit and bruising. Trying to beat a prolonged heat wave, Merced County farmer Mark Cederlind said he started crews at daybreak last week to pick his extraearly Carson variety, which is among dozens of clings planted to ripen throughout the season for the canning and frozen markets. California cling peach growers are expected to produce 242,074 tons of peaches for canned and frozen fruit markets this year, up 10% from 2023.

Planned State Pesticide Notification Program Stirs Debate

The California Department of Pesticide Regulation moved closer this month to finalizing a new regulation that would provide advance public notice of restricted-use pesticide applications on farms. The new regulation would create an online map of planned applications, drawing the data from the notices of intent farmers submit to county agricultural commissioners before they are permitted to apply restricted-use pesticides. Growers and farm advocates have complained the rule unfairly targets agriculture while exempting other sectors that use pesticides.

California Researchers Honored with 2024 Wolf Prize in Agriculture

Venkatesan Sundaresan, a plant biology and plant science professor at the University of California, Davis, has been awarded a 2024 Wolf Prize in Agriculture for key discoveries on plant developmental biology of relevance to crop improvement. The Wolf Prize in Agriculture, considered by many the Nobel Prize for agriculture, has been awarded annually since 1978 and carries a monetary award of \$100,000. Sundaresan shares the award with Joanne Chory of the Salk Institute in San Diego and Elliot Meyerowitz of the California Institute of Technology.



Continued from page 1 best rates and the best water."

Ropiak said residents here have "paid our share" for water rates, and the burden should now be on new residents moving in.

"They should pay their share; they have the money," Ropiak said. "To tell us that we have to pay for other people who haven't paid their share is lunacy."

There are two facts officials wanted to assure the public was aware of regarding the water rate increase: the increase only applies to the water portion of the utility bill, not the sewer, and the last rate increase was in 2013, with construction costs now 49% higher more than a decade later.

But those facts are irrelevant to many residents who stood at the podium in protest. The Independent Voice took pictures and heard comments by the public but the City of Dixon was unable to provide resident names for the report.

The first resident called the increase a "sleight of hand."

"You can't raise rates on the premise that your wells need to be repaired," he said. "You want to raise rates, put it out to vote; let the city of Dixon and people decide."

After he called the move "illegal and unethical," another resident pleaded for officials not to pass the increase, saying the 35-page document left her with more questions than answers. While holding up the study that she called "very difficult" to read for a layman, the resident said she, even as a medical field analyst, finds it hard to read.

"I went through it with a highlighter and pen, and what I saw I did not care for," she said before asking about where all the revenue from the new houses built has gone. "I have been here almost 30 years and am well aware of what was here."

Another resident brought up the Americans with Disabilities Act (ADA). She questioned if the water rates go up and someone lives in a group home with incontinence issues, "they are going to need more water in that group home."

"We have to abide by the ADA right and come up with a rate for people with disabilities," she said.

Solano County Taxpayer's Association President Michael Nolan said he was "authorized to deliver several hundred protests" that night, noting he handed them off before speaking.

Holding up the notice letter, Nolan claimed residents were not fully informed that a water rate increase was to take place that evening, except for one mentioned on line 29.

"Quite honestly, a lot of people did not read that line," Nolan said. "The paper is folded twice, so it is below the third fold."

Most of all, Nolan was concerned about the increase not being on the ballot. Citing the government code that "basically requires a ballot to be mailed and returned by the voter," Nolan questioned why the provisions did not apply.

"I think you should find that out before you go any further," Nolan said.

Officials did not heed Nolan's warning. Before passing the increase, Vice-Mayor Kevin Johnson said the hardest decision to make is after the public stands at the podium disappointed.

"I spent the last 14 months analyzing the water system," Johnson said, adding that one of the reasons he ran for office was the water issues. "There was not a moment we were not diligent in what we did." ★



"A man's got to know his limitations," is the famous advice given by Clint Eastwood in his role as Dirty Harry, in the 1973 movie, "Magnum Force." As a spiritual columnist, I see some spiritual awareness in those words.

While my limitations are unlimited, I can briefly share three settings where it's helpful for me to "know my limitations."

Three Things I'm Too Inept to Manage

I can't seem to learn Italian so I can order a venti or grande iced tea at Starbucks. I remind the clerk, "This is America, darn it. Give me the Jumbo Super Slurper."

I'm unskilled in the self-check line at

the grocery store. Those computer voices fluster me. They sound too much like creepy Hal in 2001 Space Odyssey, just endlessly repeating, "Unauthorized item in the bagging area."

I can't manage accuracy when the grocery store asks for my personal information on the store application for "preferred card." I don't need the avalanche of junk mail, text messages or email spam they bring, so I use the name "Ima Snooty."

Three Things I'm Too Clumsy to Accomplish at Church.

I don't care to hug strangers. This limitation is a trait of the INFP, a type from the Myers Briggs personality test. The letters stand for "Introverted, Intuitive, Feeling, and Prospecting" and, according to the test, an INFP "tends to be quiet, openminded, and imaginative, and they apply a caring and creative approach to everything they do."

As an INFP, I sometimes feel like I'd rather run to my car after my sermon than stay around and hug people.

I'm unable to think of the word that fills in the "fill-in-the-blank" sermon outlines found in many church bulletins. These outlines are akin to karaoke and were popularized by the now-retired evangelical pastor Rick Warren.

My Limitless Limitations

I'm too rhythmically challenged to clap to the beat of contemporary church music. I have to make a choice: sing or clap. And since people tend to get hurt when I clap, I stick to singing.

Three Situations Where my Faith is Stronger Because it's Limited

On a more serious note, I'm a man who acknowledges his faith limitations.

I cannot, will not, tell you that your faith and beliefs are wrong and mine are right. Some Christians are fond of quoting John 14:6 concerning Jesus being the only way to God. But if you are reciting the verse to other faiths, you are not sharing your faith, you're shouting your condemnation.

I won't impose my faith on you in a public situation by giving a public prayer when I know that the audience may not be of my faith. Because, if I only pray what doesn't offend me and -- you can only hear what doesn't offend you -- then we dilute both of our faiths.

I won't debate you. I'm not going to argue religion with you. Neither will I engage in disputes over abortion, the death penalty, theology, politics, evolution or the existence of God. I will, however, engage in a thoughtful examination of the issues. Maybe it's the INFP personality, but my dad taught me that it can take more courage to walk away from an argument.

That's enough of the negative limitations. Before I finish, let me tell you where I tend to be limit-less.

I try to be an example of struggling faith. "What is that?" you ask. Struggling faith recognizes that no one has faith completely figured out. God is too big to be contained in one religion. We can learn things about faith from people of other faiths, and even from people who profess no faith at all.

I want to follow the direction of I Peter 3:15: "Be ready to speak up and tell anyone who asks why you're living the way you are and always with the utmost courtesy."

Finally, if you ask me, I will pray with you without limits. My prayers are voiced in plain English without the "thee" and "thou" from King James's Old English. However, given my touch of ADD, the prayers won't be a grande or a venti size prayer, just a small one.

Just don't ask me to do one of those huggy prayers. After all, a pastor really should know his/her limitations.



including Dixon's Anna Anderson, going to the Pan American Championships to be held in Brazil the last week of August.

"We have built a group to help our athletes to get better and they have continuously trained together," said Sensei Kathy Ernest. Anderson joined the team of athletes Elise Beal, Meili Urata-Espinosa, and Sasha Venzon of United Bay Area Karate Club in San Jose and Jancy Baguhin of Tokon Martial Arts in Sacramento.

Anderson started karate when she was about 10 years old. Just last month, she was one of seven Ramtown Karate students who traveled to Lafayette, La., to compete at the US Karate National Team Trials.
