GRIDLEY, CA (MPG) - A special event honoring two beloved locals is set to open grandstand entertainment at the who were both known for their positive impact in the community.

Becker was just 18 when he lost his life in a tragic incident that would spark difficult conversations in the community about suicide and bring awareness to CTE (Chronic Traumatic Encephalopathy). Becker was a first-year offensive lineman at Eastern Washington University, known for his involvement in Gridley FFA and community service, along with his

athletic talents.

On the other hand, Mardesich fought a long, difficult battle with cancer, passing away at the age of 53. He was well respected in the Gridley and Biggs communities, a local farmer known for his love of rodeo. Kourtney Becker, Becker's mother, told the Herald that Matt Reed approached the Becker and Mardesich families hoping to bring back team roping under the new Continued on page 10

LIVE OAK, CA (MPG) - At the Aug. 7 Live Oak City Council meeting, councilmembers considered an agreement with Graham Backflow Services (GBS) for Cross-Connection Control in their water system, which is mandated by the State Water Resources Control Board to protect the public health from water contamination.

New regulations went into effect in July that require public water systems to have policies for the testing, maintenance and repair of their water system backflow preventers as well as the creation of a Cross-Connection Control Policy Handbook. The City of Live Oak has until next July to comply with these regulations but there is not currently any employee in the city's Public Works Department with the necessary licenses, certifications and expertise to complete this work.

The city has been hiring Graham Backflow Services to perform backflow testing and maintenance activities as needed. The Water Department now wants to establish a formal contract with Graham Backflow Services to continue these services and to develop the city's Cross-Connection Ordinance and Cross-Connection Control Plan, as required by the state. "Backflow is the unwanted reversal of flow after the water leaves your distribution system and passes through the meter," John Graham of Graham Backflow Services said. "The water purveyor loses all control over the quality of the water." This can lead to water contamination, which is a serious public health issue. So, Graham said, ensuring the city is meeting the prevention requirements will both protect public health and ensure compliance with the state regulations. Graham said part of the process will also involve educating residents to ensure any repairs they perform at their homes don't create unintentional contamination issues for their household. Councilmember Bob Woten asked if households in Live Oak would be monitored to ensure they are meeting the requirements. Graham said that it could be included in the policy plan or the city can put backflow prevention measures in place at the meters to ensure any household contamination doesn't reach the larger water supply.

Tommy Ross from Swing Strategies sends this updated list of things you can vote on at the November election. Starting with Proposition 2, a School Bond authorizes the state to issue \$10 billion in general obligation bonds for K-12 school facility repair,

modernization, and construction. Proposition 3 - Marriage Equality Repeals the provision of the California Constitution that limits marriage to a "man and a woman." It replaces it with a provision that expressly affirms that the right to marry is a fundamental right. Proposition 4 - Climate Bond Authorizes the state to issue \$10 billion in general obligation bonds to finance projects for water upgrades, wildfire and forest programs, flood control, and other climate programs. Proposition 5 -Voter Threshold Reduction to Pass Bonds Reduces the voter threshold from 2/3 to 55% for local governments to incur bond indebtedness measures related to funding the construction, reconstruction, rehabilitation, or replacement of public infrastructure and affordable housing. Proposition 6 - Prison Labor Ban

Prohibits the Department of Corrections and Rehabilitation from disciplining an incarcerated person for refusing a work assignment. Proposition 32 - Statewide Minimum Wage Increase Increases the state minimum wage to \$18 per hour, plus annual adjustments for inflation. Be prepared for many mailers to arrive in your mailbox in the coming months as the great experiment in direct democracy moves ahead in California. Only 26 of the States have this method of making laws by direct democracy. If you are considering moving to Texas, you will give up this type of fun, high-impact government (although I think that is why many have left California).

# Sportsman Expo Returns in 2024



# FFA and 4-H'ers Prepare for Fair

GRIDLEY, CA (MPG) - Would a County Fair be complete without a Junior Livestock Show and Auction?

Bella Bastiani, Sydnee Stopplemore and Destiny Hutchison don't think so. Each of these three girls has a raised market animal to show and sell at the Fair. They have all worked very hard with their animals, kept detailed financial records and sent out Buyer's Letters to introduce their animals to potential buyers.

Bastiani is 16 years old and a member of Gridley High School FFA. She describes herself as "really passionate" about her livestock. She had a market lamb at Silver Dollar Fair in May. This is her second year raising a market turkey for the Butte County Fair. All turkeys entered must be younger than 22 weeks of age.

"Some kids are hesitant to try [market animals] because of the expense. Smaller market animals make it easier to get into, because they are cheaper and have a larger profit," Bastiani said. She breeds Nigerian Dwarf goats and sheep, as well.

Hutchison, age 16 and also a member of FFA, is showing a turkey for the first time.

She too had a lamb at the Silver Dollar Fair. "Turkeys are low maintenance and do not require as much training," she said.

All turkeys entered in the show are shown with a walking stick and flipped to show the belly/meat. Each one must weigh at least 15 pounds and not exceed 35. Hutchison has three turkeys that all bonded with the lamb she raised. She has enjoyed raising her turkey fair entry "Blue" and would do it again.

Lastly, Stopplemore, 13, lives in Richvale and is a member of the Biggs 4-H club. This will be her fifth fair showing a market hog, and this year's is named Dexter. Her previous hogs have sold for \$10-16 per pound. The weigh-in for market hogs is 210 lbs. up to 270. Entries can weigh more than 270 but will not be paid for weight above that. She has worked very hard on her Buyer's Letters, hand-delivering them with a home-baked treat (baking is one of her other 4-H projects). She also serves on the 4-H board as Activities Commissioner.

Interim City Manager Mark Scott explained that this contract will authorize Graham to begin the preliminary work of establishing the policy but it will be up to City Council to provide direction throughout the process and to ultimately approve and implement the plan.

Graham Backflow Services submitted a proposal for a three-year contract with services including assembly testing, hazard assessments and administrative costs at \$46,575 per year. The first year will also include an additional fee for the ordinance development and Cross-Connection Control Plan, with \$58,075 as the first-year total. These costs are not included in the budget, so a budget amendment would need to be approved by City Council before the contract could be executed.

City Council voted unanimously to approve the contract with Graham Backflow Services.

Parks and Recreation director Luis Cibrian updated City Council about the progress on the new dog park, which first broke ground in January. Staff initially said the park would open in the early summer but Cibrian said that

weather issues delayed project completion. But he was "happy" to report that staff are now completing the final work and the park will be ready for a grand opening this month.

Cibrian suggested either Aug. 22 or 29 for the ribbon-cutting ceremony. Staff will plan for an early night event to avoid the heat of the day and when residents are off work.

Vice-Mayor Nancy Santana said she wants to ensure the dog park looks nice, because she recently drove by and saw it was full of star thistle. She suggested staff could start a schedule of irrigating and mowing the grounds.

The previous City Council direction for the dog park was to maintain the natural landscape, Cibrian said, so irrigation was not built into the project plans nor accounted for in the project budget. If City

Council directs it, Cibrian said, staff could seed the park over the winter and run an irrigation line.

Santana said she was worried about dogs having to deal with foxtails and thistles on the natural landscape.

"I want to make sure we do it right," Santana said.

Interim City Manager Scott said that City Council might want to bring in a consultant with expertise in designing and managing a dog park to ensure it's done right.

The council's consensus was to hold the ribbon cutting as early as possible, since residents have been eagerly awaiting the opening, so Aug. 22 was selected for the grand opening event.

The next meeting of the Live Oak City Council is scheduled for 6 p.m. Aug. 21 in the Council Chambers at City Hall, 9955 Live Oak Blvd.

# **Oroville Man Gets 30 Years to Life for Killing Two Florida Brothers**

OROVILLE, CA (MPG) - In a long-awaited court hearing on Aug. 7, Austin Hogan, 25, of Oroville, was sentenced to 30 years to life in state prison for his involvement in the October 2020 double homicide of two brothers from Florida. Hogan had previously pleaded guilty to two counts of second-degree murder in June 2023, but his sentencing was postponed due to his role as a key witness in the trial of his codefendant Kyle Smith.

Butte County District Attorney Mike Ramsey said the family of Jerry Bonds, 39, and Randy Bonds, 33, reported them missing to the Butte County Sheriff's Office on

Oct. 21, 2020. On the same date, the Reno Police Department received a tip from a man who said he had just talked with three visitors who told him they had just killed two black men in the Oroville area.

Butte County Sheriff's detectives soon learned the Bonds brothers had flown into a Los Angeles airport on Oct. 19, 2020, rented an Audi, and drove to Oroville to purchase marijuana. After checking into a local motel, they went missing.

Surveillance video from a Reno casino was found showing Hogan, and codefendants Michael Griff, 25, and Kyle Smith, 28, abandoning the victims' rented Audi in the casino parking lot in the early morning hours of Oct. 22, 2020. Later that day, Butte County Sheriff's detectives located the three at an Oroville residence and placed the trio under arrest.

Under questioning by detectives, Kyle Smith provided law enforcement with the location of where the Bonds brothers were shot and killed at a remote location near rural Forbestown. Detectives requested a statement from Hogan, but he chose to remain silent.

On Feb. 28, 2023, with his attorney present, Hogan finally did provide a statement to prosecutors that Smith had encouraged Hogan to do the shooting. When Hogan pled guilty on June 14, 2023, he also signed an agreement to testify truthfully at Smith's trial while agreeing to postpone his sentencing until Smith's case was resolved. As a result, Smith pled to two counts of second-degree murder and was sentenced on July 24, 2024, to more than 30 years to life in state prison.

At Hogan's sentencing hearing on Aug. 7, the family of Randy and Jerry Bonds described the pain they have had to endure due to the killings. Randy and Jerry's mother described how many of the Bonds' children had special occasions that were missed by Jerry and Randy due to the defendant's actions. She thanked the Court, the Butte County District Attorney's Office, and the Butte County Sheriff's Office for bringing the killers of her two sons to justice.

Michael Griff was previously sentenced on June 13, 2023, to 50 years to life in state prison after pleading guilty to two counts of first-degree murder.

## Robber Pleads No Contest to Attempted Murder for Robbery Gone Wrong

CHICO, CA (MPG) - A Chico man pleaded no contest on Aug. 7 in Butte County Superior Court to attempted first-degree murder for an attempted robbery in September 2023 in which he shot and paralyzed his intended victim.

Jaden Christopher Hollowell, 21, entered a plea of no contest – which is legally the same as a guilty plea - to a single count of attempted first-degree murder.

Butte County District Attorney Mike Ramsey said the robbery occurred in a vehicle in the 1200 block of Notre Dame Boulevard in Chico where the victim, a 25-yearold Yuba City marijuana dealer, was delivering marijuana at Hollowell's request.

Ramsey said the investigation revealed Hollowell and a 16-yearold juvenile cohort lured the victim dealer to a parking lot of an apartment complex, where they pulled handguns on the victim as he sat in his truck. The victim resisted the robbery attempt and was shot in the

face by Hollowell, who claimed he thought the victim was pulling a gun on him. A butane lighter in the shape of a pistol was later found in the victim's truck.

Chico Police officers responded to the parking lot where they found the victim in his vehicle, and he was rushed to Enloe Hospital and then life-flighted to UC Davis due to the severity of his injuries. Ramsey said Hollowell's bullet went through the victim's nasal cavity and into his spine. The victim is now paralyzed from the chest down from his injuries.

Through extensive follow-up, including nearby surveillance videos, Chico police detectives were able to identify Hollowell and also tentatively his juvenile cohort. The pair had fled the area and disposed of their firearms.

Ramsey said once detectives had identified Hollowell, they obtained an arrest warrant for him, and he was charged with attempting to rob the victim and shooting him in the process. The investigation into the juvenile's participation and identification is ongoing.

Ramsey said Hollowell had

previously been convicted of possession of a concealed firearm and domestic violence in 2021 and was on probation supervision at the time of this robbery.

Ramsey said Hollowell agreed to plead guilty to attempted first-degree murder and stipulate, or agree, that he will receive the upper term sentence of seven years to life in the state prison when he returns to court on Sept. 4 for sentencing.

Hollowell will remain in Butte County Jail without bail until his sentencing and transport to state prison to begin serving his life sentence.  $\star$ 

# **BCSO Investigating Dog Mauling Death**

FEATHER FALLS, CA (MPG) - On Aug. 8, at approximately 1:58 a.m., a resident contacted the Butte County Sheriff's Office (BCSO) and reported he found a deceased victim on Blackhawk Trail, Feather Falls, California. Deputies immediately responded and located the deceased victim, who was later identified as Davina Corbin, 56, of Feather Falls.

On Aug. 8, a forensic pathologist performed an autopsy on Ms. Corbin. During the autopsy, the forensic pathologist located numerous bite marks and injuries on Ms. Corbin's body. Based on the evidence located during the autopsy, the forensic pathologist believed Ms. Corbin's cause of death was attributed to a domestic dog attack.

Deputies and detectives conducted an extensive investigation. During the investigation, detectives

obtained a search warrant for a residence on Blackhawk Trail. The residence was located directly in front of the area where Ms. Corbin was located. During the service of the search warrant, detectives located approximately 25 Great Dane dogs. Butte County Animal Control responded. Deputies and detectives spent the entire day capturing the dogs, who were running loose in the area. To date, approximately 23 dogs have been captured and turned over to animal control.

Detectives are currently attempting to capture the two outstanding dogs.

The California Department of Fish and Wildlife sent the clothing Ms. Corbin was wearing to a lab for DNA analysis. The lab confirmed Ms. Corbin's clothing was covered in DNA consistent with domestic dog(s). The lab is in the process of conducting additional testing, in an attempt to determine which dogs(s) attacked Ms. Corbin.

This is an on-going investigation. The Butte County Sheriff's Office will provide additional information when available. Based on the preliminary investigation, detectives located evidence giving them cause to believe Ms. Corbin, who resided in the area, was walking when she was attacked by the dog(s).

The Butte County Sheriff's Office encourages those with pertinent information to come forward. If anyone has information about the current location of the two outstanding dogs, they are encouraged to contact Butte County Animal Control or the Butte County Sheriff's Office at 530-538-7322.

**CDFW Soliciting Hunter Input on Sacramento** Valley Wildlife Areas, Federal Refuges

#### NORTHERN SACRAMENTO VALLEY, CA (MPG)

- The California Department of Fish and Wildlife (CDFW), along with the U.S. Fish and Wildlife Service (USFWS), will hold an online outreach meeting to take comments and recommendations from licensed hunters on public land hunting programs in the northern Sacramento Valley. The meeting will also provide updates on habitat conditions, availability of water for wetlands, Highly Pathogenic Avian Influenza and hunting access opportunities.

State lands to be discussed include the Gray Lodge and Upper Butte Basin wildlife areas, including the Little Dry Creek,

Howard Slough, and Llano Seco units. Federal refuge personnel will speak about the Sacramento National Wildlife Refuge Complex, including the Delevan, Sacramento, Colusa, and Sutter refuges.

The meeting will be conducted using Microsoft Teams on Tuesday, Aug. 27 from 4 to 6 p.m. Please e-mail the Gray Lodge Wildlife Area at glwla@wildlife. ca.gov for a link and instructions on how to submit comments and questions.

The California Department of Fish and Wildlife annually provides an opportunity for licensed hunters to comment and make recommendations on public hunting programs, including anticipated habitat conditions in the hunting areas on Type A wildlife areas through public meetings and outreach.



# **Cohasset Man Arraigned for Looting from Neighbors During Park Fire**

#### Butte County District Attorney's Office News Release

**COHASSET, CA (MPG)** - A Cohasset Man was in Butte County Superior Court on Aug. 8 to enter a plea to charges of looting during the Park Fire in Cohasset.

Joshua Keith Emerson, 44, of Cohasset, pleaded not guilty to counts of looting a vehicle and tools from a neighbor's shop building as the neighbor was evacuated during the Park Fire. He was also charged with entering a closed location during a state of emergency. His co-defendant, Rose Sutton, 41, who posted bail before her court date, will appear in court on Oct. 4, where she will be arraigned on her charges for concealing the stolen property taken by Emerson, as well as for entering a closed location during a state of emergency.

Butte County District Attorney Mike Ramsey stated that on July 30, an evacuated resident of Cohasset was escorted back to his property by the Sheriff's Office to check on his property. When the resident arrived at his property, he discovered his unique Mitsubishi Jeep and miscellaneous Milwaukee tools were missing from his shop.

The resident shared the description of his stolen vehicle on Facebook, and a concerned citizen recognized the vehicle

where it was parked at an intersection near Jasper Drive in southeast Chico later the same day. Once the vehicle was discovered, local law enforcement began searching the surrounding neighborhood for any security footage that could lead to identifying the thief.

Ramsey said Butte County Sheriff's detectives found several surveillance videos from private residences showing Joshua Emerson driving the Jeep into the Jasper Drive neighborhood with Rose Sutton riding as a passenger.

Evidence revealed that after dropping Sutton off at her family member's residence, Emerson drove the vehicle multiple blocks away and parked it in an attempt to further conceal the vehicle.

On Aug. 1, after receiving a search warrant signed by a Butte County Judge, the Butte County Sheriff's Office searched the residence Emerson and Sutton were staying at and a motorhome belonging to Sutton. Emerson and Sutton were located on the property, arrested, and transported to the Butte County Jail for their crimes. The Cohasset resident's property, including the Mitsubishi Jeep and the tools, was successfully returned to him.

Ramsey reminded the community that the District Attorney's Office and local law enforcement view looting cases as especially heinous and he intends to prosecute looters to the full extent of the law.

"Looters undermine the trust of the community and are one of the reasons people are fearful to leave their residences during an evacuation. Let this case be a warning to looters, the crime will not pay," Ramsey said.

Emerson will be back in court on Aug. 22 for the setting of his preliminary hearing. Until then, he remains in custody with bail set at \$500,000, an increased amount requested by the Butte County District Attorney's Office. If convicted of all charges Emerson faces a maximum of three years and eight months in county jail.



#### Dear Dave,

I've made a lot of stupid money mistakes in the past. Even though I finally paid off six figures in debt a few years ago and am in control of my finances for the first time in my life, I'm having a hard time forgiving myself for all the dumb things I did. I have an emergency fund and other savings set aside, and I'm almost ready to buy a house. But it seems like there's still a cloud hanging over my head from all my bad decisions. How do I stop obsessing over my past financial mistakes?

#### Dear Brea

If you've had enough determination to pay off six figures' worth of debt and to build savings on top of that in the last few years, you're doing a phenomenal job! Most people would just make excuses or give up, but you educated yourself, put your head down and stomped out all that debt. I'm very proud of you, hon. What you've done speaks volumes about your character and self-discipline.

### **Dave Ramsey Says** When You Know Better, **Do Better**

The late Maya Angelou once said, "Do the best you can until you know better. Then when you know better, do better." That's the key for you, I think. Doing dumb things doesn't always mean you're a dumb person. Sometimes, we just don't have the knowledge or guidance we need to do things the right way. But once you learned a few things and saw there was a better way-a smarter way-you jumped in and made incredible things happen. You cleaned up your finances, and you changed your entire future for the better. I think that's pretty cool. And you know what else? It makes you a pretty smart lady.

I think part of your struggle may be the fact that you've spent more time making the wrong decisions with money than you've spent making the right ones. That's understandable. But time will help heal that struggle. It'll distance you emotionally from the old you until you're confident in the new you-not just in your actions, but in your heart and mind. I mean, think about it this way: If you violated trust with a friend, how would you rebuild it? First, it would take time. And second, it would take a series of trustworthy actions.

Let's say someone had a drinking problem for a long time, but they've been dry for three months. After three months, their spouse still might not trust them with the checkbook. I totally get that. It's a good start, but it's not like they haven't had a drink in three years. That's where time comes into play. The more time they demonstrate a solid pattern of not going back to the bottle, the more evidence they create for why others should trust them.

I think you've developed a pretty good track record of being smart with your money, Brea. So cut yourself some slack. If God is willing to forgive us for the really bad things we say and do, you need to be able to extend a little grace to yourself for the dumb things in your financial past.

them they are signs from God.


God used pillars of fire and earthquakes to move people. He still does. Look at the signs around us, eclipses, earthquakes, floods, and wind. They could be signs in some ways.



#### **Reduced Plantings, Heat Affect** 2024 Processing Tomato Crop

With searing heat waves impacting pollination for some plantings and harvest for others, California processing tomato growers said they were anticipating average yields at best. As farmers began harvesting across the Central Valley during the past few weeks, the crop was already set to be a light one. Tomato processors contracted 40,000 fewer acres from farmers this year due to bolstered inventory from last year's bumper crop, aiming to process about 10% less tonnage, according to the U.S. Department of Agriculture.

#### New Report Says Water Supplies Will Shrink Without Infrastructure Improvements

Delivery capability and reliability of the State Water Project, a 700-mile network of reservoirs and canals, could be reduced by 23% in 20 years due to changing flow patterns and extreme weather shifts, according to a new report from the California Department of Water Resources. DWR Director Karla Nemeth said the analysis "underscores the need to modernize and upgrade our aging infrastructure so we can capture water supplies when it's wet." She said, "Modernizing the State Water Project is critical to delivering on the human right to water in California."



#### Water Projects Review Seeks to Balance Farm, Environmental Needs

State and federal agencies face a challenge to balance the beneficial uses of water needed by farmers with needs of the Sacramento-San Joaquin Delta ecosystem amid challenges of climate change. A new draft environmental impact statement for the U.S. Bureau of Reclamation seeks to influence operations for California's two primary water-delivery systems, which guide pumping of water through the Sacramento-San Joaquin Delta, sending water south to tens of millions of people and to millions of acres of farmland. Comments on the report are due by Sept. 9.

#### Project Studies Specialty-Crop Production in Urban Areas And On Vacant Lots

Researchers from University of California Cooperative Extension in San Diego County are investigating the economic feasibility of growing high-value specialty crops in urban settings such as vacant lots. In Carlsbad, researchers have created the Small-Scale Urban Ag Demonstration Site. Funded by the U.S. Department of Agriculture National Institute of Food and Agriculture, the farm is designed to evaluate containerized production both outdoors and under hoop houses. In the trial, researchers are growing turmeric, ginger and blueberries.



For those new to the world of team roping, two riders work in tandem to bring down a steer. The goal is to catch the animal as quickly as possible, the "header" attempting to rope the animal's horns while the "heeler" swipes the steer's hind legs.

Years ago, Becker, whose family had been life-long friends with the Mardesich family, expressed an interest in team roping. Mardesich trained Becker in practice and helped him get to competition level within just a few months of starting out.


