

"The River City Tigers' defense was formidable, allowing only 77 points throughout the season and contributing significantly to their success," the mayor added.

The loudest applause came at the

22 touchdowns, and running back Howard Warren, who rushed for 635 vards and scored nine touchdowns," Mayor Guererro said.

The mayor recognized Manny Ramirez's partners and owners, Jose Villanueva and head coach Derrick Watkins, as well as the "instrumental" coaching staff fostering an environment of growth and achievement.

Mayor **Addresses Utility Crisis**

WEST SACRAMENTO, CA (MPG) - City officials want to cut power to their partnership with Pacific Gas and Electric (PG&E) due to high rates.

At the Aug. 7 regular council meeting, Councilwoman Norma Alcala said residents' emails and phone calls detail PG&E's high rates while the major utility company is making "record profits right now."

"And yet they are still increasing our rates," Alcala said. "I am anxious to hear what the public has to say because it is affecting a lot of people."

Mayor Martha Guererro called out a "utility crisis" here for some residents whose utility rates are too high, suggesting officials consider a future agenda addressing other utility options.

"We have had some experience working with Valley Clean Energy," Guererro said regarding her predecessors before recently seeing a Pioneer Community Energy presentation as the second vice president for the League of Cities. Noting she was limited to what she could say legally, the mayor mentioned every present energy-use concern and why the Sacramento Municipal Utility District (SMUD) is another viable option. "The reason we don't have SMUD is because it requires a vote, which we tried in the past and it failed," said Guererro, adding that is why Pioneer Community Energy is now on the radar. According to the city manager, one option is to join the California Community Choice Association, where cities can buy electricity for residents and businesses rather than use it. "There are a number of CCA's out there, including in our backyard," City Manager Aaron Laurel said.



Continued from page 1 pointed out "the support and enthusiasm of team volunteers, fans, player's families and community members who have played a vital role in the team's success."

The decree ended, noting River City Tigers' significant contributions to the community through charitable events, including hosting a Youth Football Camp.

Clad in black jerseys, the team sat behind Manny Ramirez, the team's founder and co-owner, at the Aug. 7 meeting. With a big gold football to his left, Ramirez humbly spoke before the mayor and council proclamation, touting the team's achievements in the California Football Conference Association, which partners amateur and semi-professional football players across the region.

Completing the team's third year, Ramirez said, "Despite the obstacles and challenges we faced, we never waivered in our determination to achieve our goals after facing disappointment in the playoffs for two consecutive years." According to the co-owner, the motto of "accountability and teamwork" is behind the team's success

"We pushed each other to become better on and off the field," Ramirez said.

Like the mayor, Ramirez's short speech broke because of applause, causing a big smile on Ramirez, who said the team remains steadfast in its mission to positively impact the community.

"Through our various charity events such as our free youth football camp, turkey drive and Toys for Tots football game, we have been able to support and uplift those in need," Ramirez said, giving thanks to his two biggest fans, his mother and fiancée, down to the water boy and concession stand volunteer.

"We definitely want to give a big shout-out to West Sacramento for opening their arms with a generous and courteous proclamation award," Ramirez said. "Go Tigers."

Councilwoman Norma Alcala was the first fan to shout out, touting the teams' scores and for putting West Sacramento on the map.

"Eleven wins and one loss; that is incredible," Alcala said, adding their team's charity work is a win. "That means a lot to this community since we have a lot of folks that go without and you are helping, which makes all the difference."

Councilwoman Verna Sulpizio-Hull said what is "phenomenal" is the 75-member team and entire volunteer crew.

"And on top of that, you have your family supporting you," Sulpizio-Hull said, echoing Alcala's sentiments about community charity. "That is above and beyond."

Sulpizio-Hull ended saying she looks forward to another successful season in 2025.

Guererro closed the short ceremony, noting that one of their biggest fans "remembered sitting in the bleachers at River City High School Stadium" scoring those touchdowns, cheering you on and just being among you and your family members."

Continued from page 1 SMUD throughout the county, which, as you mentioned, failed the vote," Laurel said, adding it is much more than just yea or nay to pass due to the regulatory environment and more.

Laurel recommended returning in the fall after the energy use study is complete, "along with an analysis by staff on the CCA industry" and "more background on the SMUD annexation and what that actually looks like as a process."

Winters Councilwoman Jesse Loren, a Valley Clean Energy board member, was on the other side of the dais, telling the mayor and council about her city's experience with the SMUD process.

"I serve with other members of your dais on various regional boards," Loren said, adding she was coming forth in the "Yolo County way" spirit.

Loren reminded the mayor and council that Valley Clean Energy "opened the door" to West Sacramento and Winters in 2017.

While SMUD might be "far more attractive," according to Loren, no deal can be made if they do not want to partner with West Sacramento.

"Not only is it a ballot process but they have to have an appetite to grow," Loren said. "That is not something they have expressed at this time."

While West Sacramento has not benefited from decreased utility bills, Winters has benefited with "lower costs," Loren said, followed by another Valley Clean Energy board member.

Like Loren. Lucas Frerichs said that while "we would love to have a utility like SMUD rates 40% lower literally across the river than

we do here in Yolo County," it might not be feasible.

"We currently have rates that are lower than PG&E," Frerichs said of Valley Clean Energy.

Vying for the mayor and council's attention, Pioneer Energy Company Chair and Auburn Councilwoman Alice Dowdin Calvillo also plugged her program, noting \$85 million in rate savings for the company's customers.

Calvillo said the company is "certainly not trying to step" on Clean Valley Energy's "toes by any means;" however, due to recent discussions, it was essential to come to the table.

Guererro said that she looks forward to future studies and comprehensive citywide presentations from both companies soon.

"I am looking forward to conversing with the community next month," Guererro said.

City of West Sacramento Measure K Funding Report

Background


Approved by voters in November, 2002, Measure K is a one-quarter (1/4) cent general purpose sales tax, with specific funding categories. In June 2019, the City Council approved Resolution 02-58 that provides recommended target funding percentages based on annual revenues of \$2,500,000 to the specified categories. All funding from Measure K is directed to the following categories:

- Water/Lighting and Landscape Rate Reduction: 30%
- Road Maintenance and Street Sweeping: 30%
- West Sacramento Library: 15%
- Fire and Police Protection Enhancement: 15%
- · Afterschool and other Childcare Programs/Park Safety and Enhancements: 10%
- Light Rail/Street Car Operations: 10%

Transparency and Oversight

All Measure N funds have been appropriated in accordance with the funding categories noted below and approved by voters. No funds were used for any other purpose.

The annual, independent audit completed by LSL CPAs was conducted for the year ending June 30, 2023. The audit confirmed that all financial records are accurate and compliant with relevant regulations. Annual audit reports are included in the City's Annual Comprehensive Financial Report.



Social Security Matters *Will My Wife Get a Spousal Benefit from Me?*

Dear Rusty: I will be turning 70 (yikes) this coming November. I will begin taking my Social Security benefit at that time. My age 70 SS benefit will be approximately \$4,500 per month. My spouse (who is currently 74) began receiving her SS benefits about 10 years ago - before her FRA. She receives approximately \$1,900 per month.

My question is, based on my expected SS monthly benefit of approximately \$4,500, would my spouse be eligible for an increase in her monthly SS benefit? I've read some articles about this topic, but none of them seem to be on point - so I thought I'd reach out to you. *Signed: Seeking Answers*

Dear Seeking: Congratulations on choosing a claiming strategy which will maximize your Social Security. Waiting until age 70 to claim guarantees you will get the most you can personally receive for the rest of your life, along with annual Cost of Living Adjustments (COLA). But the spouse benefits available to your wife when you claim are not based on your age 70 amount. Rather, spouse benefits are calculated using full retirement age (FRA) amounts. Here's what that means:

If your age 70 benefit will be about \$4,500 then your FRA amount was likely around \$3,450. If vour wife claimed at, say, 64, then her FRA entitlement would probably have been around \$2,200. Your wife will only get a spousal boost if 50% of your FRA amount (not your age 70 amount) is more than her own FRA entitlement. From what you've shared, 50% of your FRA amount would be about \$1,750, which is less than your wife's FRA entitlement (and her current age 64 amount), which means that she would not be eligible for a spousal boost to her own amount from you.

Spouse benefits can be tricky, because they're based on FRA entitlements, regardless of the age at which benefits are actually claimed. That is not so, however, for surviving spouse benefits. If you were to predecease your wife, her benefit would be your entire \$4,500 amount, instead of her own smaller current amount. Surviving spouse benefits are based on the amount each of you are currently receiving, not on your amounts at your full retirement age.

I hope this answers your question, but we're always here if you need any further assistance.

California Seizes More Than \$120 Million In Illegal Cannabis Since January

SACRAMENTO, CA (MPG) - In strong support of California's legal cannabis market, Governor Gavin Newsom announced that since January, California's Unified Cannabis Enforcement Task Force (UCETF) has seized more than \$120 million worth of illegal cannabis, destroyed nearly 37 tons of unlicensed cannabis, including 122,914 illegal plants. As part of these operations, state law enforcement officials have also seized 22 firearms.

"The legal cannabis market brings billions of dollars to our state's economy, helping to sustain California's position as the fifth largest economy in the world. We will not tolerate illegal operations that threaten our economy and the health and well-being of California communities," Governor Gavin Newsom said.

In recent months, the task force conducted operations in 11 California counties, including Mendocino, Tuolumne, Shasta, Orange, Kern, Alameda, Yuba, Trinity, Los Angeles, Butte and Humboldt.

"UCETF's efforts are continuing to break new ground in unlicensed cannabis enforcement by leveraging the expertise and knowledge of its diverse group of partners to disrupt the unlicensed market," said Bill Jones, Chief of the Law Enforcement Division with the Department of Cannabis Control.

Taking down illicit cannabis

Governor Newsom has directed state agencies to aggressively target the organized criminal enterprises involved in the illicit cannabis market. These illegal schemes not only threaten California's legal cannabis market, but the use of illegal pesticides and unregulated practices harm California's environment and water quality. California is also focused on ending the exploitation of vulnerable workers at these sites, who are often victims of labor violations and human trafficking.

"The continued success of UCETF is a testament to the collaboration between its partner agencies. Due to the high level of engagement from each of the agencies involved, we are able to move swiftly against those who choose to continue to grow cannabis illegally," said Nathaniel Arnold, Chief of the Law Enforcement Division with the California Department of Fish and Wildlife and co-lead of the Unified Cannabis

Enforcement Task Force. "We will continue to rely on the individual and combined strengths of these agencies to support those who are cultivating legally in a manner that is safe for the consumer, the general public, and the environment."

A unified strategy across California

In 2022, Governor Newsom created the Unified Cannabis Enforcement Task Force to further align state efforts and increase cannabis enforcement coordination between state, local, and federal partners. The enforcement actions protect consumer and public safety, safeguard the environment, and deprive illegal cannabis operators and transnational criminal organizations of illicit revenue that harms consumers and undercuts the regulated cannabis market in California.

Since its inception, the Unified Cannabis Enforcement Task Force has seized over \$465 million in unlicensed cannabis by serving 309 search warrants. The taskforce has also eradicated 470,435 illegal cannabis plants, seized 150 illegal firearms, and arrested 38 individuals.



Well Kings fans, the Olympics are over, and in no time fans will be talking about the start of training camp. Yes, in less than 60 days the hometown hoopsters will be back together, with a team composed of explosive offensive talents, and some question marks on the defensive side of the ball.

With the re-signing of Malik Monk, and the heralded signing of 6-time allstar DeMar DeRozan, the Kings have an offensive nightly threat that will rival any opposing team in the NBA. Don't forget, without DeRozan, the Kings led the NBA in scoring just 2 seasons ago, and with his addition to the lineup, players like Fox, Sabonis, Murray and Monk will have better looks on a nightly basis.

Without question, DeRozan will require a lot of defensive attention, and three-point shooters like Murray and Fox will benefit greatly by his presence on the court.

The Kings continue to look for the power forward to body-up alongside Domantas Sabonis, and last week sought after Lauri Markkanen who re-signed with the Utah Jazz for a reported \$238-million contract over five years. His signing after August 6 means that he cannot be traded for at least six months, after the 2025 trade deadline, and for all intents and purposes makes Mr. Markkanen a name to no longer discuss.

Color announcer Kyle Draper jumped in last week with his own thoughts as to who might be a good fit at power forward when he expressed his enthusiasm for another Utah Jazz standout, in big man John Collins. Collins showed a lot of promise last season putting up 15.1 points per game, while securing 8.5 rebounds. This while he only garnished 28 minutes of playing time per game. Collins is only 26 years of age and stands 6'9" with a 6'11" wingspan. Nice stats for a power forward with a bright future in the NBA, so perhaps Draper is working two jobs as scout and game announcer.

I like hearing from all quarters as it relates to players that might improve the Sacramento Kings front court, and as high as I am on Domantas Sabonis, I know this talented big man needs more help on the boards.

I am high and guardedly hopeful that the

recent signing of Orlando Robinson will pay dividends this season, and I applaud Monte McNair's search for a diamond in the rough.

Every year some player surfaces to the top and surprises everyone with a breakout year, and in many circumstances this occurs because they finally found a team to give them a true opportunity to shine.

Keon Ellis made significant strides last season because coach Brown built his confidence gradually throughout the season, even making him a starter for a lengthy stretch. Keon's best basketball is still in front of him, and that is after he endured a stint in the G league where he showcased his talents and worked his way up to the big club.

I believe that same confidence would do wonders for Trey Lyles, and like Ellis I am convinced we have not yet seen the top side of Mr. Lyles.

Keep your eyes on Boogie Ellis, who like his namesake Keon looked like a man among boys in the recent summer league games. The Ellis boys could potentially play significant minutes for the Kings this season, and like Keon, I like the defensive effort Boogie brings to the floor to go along with his three-point shooting.

Not to be overlooked is our top draft choice of two years ago Keegan Murray, who had an ambitious rookie season to be followed by his sophomore year that had mixed reviews. This former NCAA Division I leading scorer (822 points, 2021-22) in the nation may very well surprise everyone this year and propel himself into an all-star year. Keegan added a mid-range game last season that will undoubtedly play well alongside newcomer DeMar DeRozan.

I remain convinced that McNair is not through tinkering with this lineup, and when the Kings break training camp this season, look for at least one more power forward to join the group we have today.

The Sacramento Kings glass is half full, and I can't wait to see the upcoming season in full splendor.

Texas Scores a Goal on California as Chevron Moves Headquarters to Houston

The war between Gov. Gavin Newsom and the state's once-immense oil industry entered a new phase a few days ago when Chevron, California's oldest and best known producer of gasoline and other petroleum products, announced it was moving its corporate headquarters to Texas.

Chevron, which dates its origins to the California Star Oil Works, which struck oil in the Santa Susana Mountains of Southern California in 1876, characterized the move from San Ramon to Houston as merely an ordinary managerial consolidation.

However, given its prominence, Newsom's recurrent vilification of the industry and his vow to end sales of gasoline-powered cars as a way of becoming carbon-neutral by 2045, the move's political aspects could not be ignored.

Initially, Newsom posted on social media a video denouncing oil industry "price gouging," including a melty-face emoji characterizing the industry's reaction to California's efforts to dampen gas prices.

But his office quickly took down the video and issued a statement saying Chevron's announcement "is the logical culmination of a long process that has repeatedly been foreshadowed by Chevron."

Predictably, Texas' Republican Gov. Greg Abbott, a frequent foil for Newsom, immediately cast Chevron's move as a "snub" to California in a posting on X, formerly Twitter, calling Texas Chevron's "true home."

A more stinging rebuke came from the Bay Area Council, a business group that hews to a moderate political line and has often been supportive of Newsom.

"Chasing jobs and employers out of California is no way to run the economy," Jim Wunderman, the organization's president, said. "It's an embarrassment for California that we've lost so many global companies because of misguided policies that make it incredibly difficult to do business here. California's elected leaders need to take stock of the decisions they're making that affect millions of families and workers, impact the state budget and have grave consequences for the future economic health of this state."

Were Chevron's move an isolated event, it would be only temporarily interesting. However, California has seen a steady exodus of corporations, as the Bay Area Council noted, thus reinforcing its image of hostility to business.

Just days earlier, Elon Musk, who had already moved his Tesla corporate headquarters to Texas, announced that X and SpaceX would follow.

Chevron's announcement also comes amid a flurry of layoffs and corporate retrenchments in the Bay Area's high-tech industry, which have contributed to the state's having the nation's highest unemployment rate.

Moreover, we may not have heard the last of Chevron's moves. The company had been warning California officials that it might close its two refineries in the state, which are major producers of the state's unique gasoline blend.

Voters in Richmond, the site of one Chevron refinery, will decide in November whether to impose a special tax on the refinery, \$1 per barrel, and the company has accused Richmond's leaders of "playing chicken" with their largest taxpayer and employer.

Politico reported that Andy Walz, a top Chevron executive, warned in an interview about the potential consequences of the Richmond tax measure. "I'm not going to tell you that that's the death knell, but we're getting close," he said, adding, "if I can't invest there, and I can't get a return, we will move on."

Newsom and other California politicians openly intend to eventually shut down the oil industry to reduce the state's carbon footprint. But they want a gradual reduction so many millions of gasoline-powered cars still on the road can run until phased out.

Were Chevron and other producers to decide, as Walz warns, that continuing operations in a politically hostile California no longer pencils out, the state could see an abrupt and economically devastating fuel shortage.

Reduced Plantings, Heat Affect 2024 Processing Tomato Crop

With searing heat waves impacting pollination for some plantings and harvest for others, California processing tomato growers said they were anticipating average yields at best. As farmers began harvesting across the Central Valley during the past few weeks, the crop was already set to be a light one. Tomato processors contracted 40,000 fewer acres from farmers this year due to bolstered inventory from last year's bumper crop, aiming to process about 10% less tonnage, according to the U.S. Department of Agriculture.

New Report Says Water Supplies Will Shrink Without Infrastructure Improvements

Delivery capability and reliability of the State Water Project, a 700-mile network of reservoirs and canals, could be reduced by 23% in 20 years due to changing flow patterns and extreme weather shifts, according to a new report from the California Department of Water Resources. DWR Director Karla Nemeth said the analysis "underscores the need to modernize and upgrade our aging infrastructure so we can capture water supplies when it's wet." She said, "Modernizing the State Water Project is critical to delivering on the human right to water in California."

Water Projects Review Seeks to Balance Farm, Environmental Needs

State and federal agencies face a challenge to balance the beneficial uses of water needed by farmers with needs of the Sacramento-San Joaquin Delta ecosystem amid challenges of climate change. A new draft environmental impact statement for the U.S. Bureau of Reclamation seeks to influence operations for California's two primary water-delivery systems, which guide pumping of water through the Sacramento-San Joaquin Delta, sending water south to tens of millions of people and to millions of acres of farmland. Comments on the report are due by Sept. 9.

Project Studies Specialty-Crop Production in Urban Areas And On Vacant Lots

Researchers from University of California Cooperative Extension in San Diego County are investigating the economic feasibility of growing high-value specialty crops in urban settings such as vacant lots. In Carlsbad, researchers have created the Small-Scale Urban Ag Demonstration Site. Funded by the U.S. Department of Agriculture National Institute of Food and Agriculture, the farm is designed to evaluate containerized production both outdoors and under hoop houses. In the trial, researchers are growing turmeric, ginger and blueberries.

UC Students Push for A Place to Get — And Stay — Sober on Every Campus



Often with few dollars and no full-time staffer, these programs foster a community of peers who together navigate their sobriety through the thicket of tempting or illicit substances that are often rife on their college campuses.

The programs serve multiple purposes: group meetings, more targeted support from a campus coordinator who may also refer the students to mental or medical help on or off campus, and if there's money, social events. Some, like the one at UC Davis, distribute fentanyl test strips and Narcan, an overdose-reversing nasal spray, for free. Unlike more familiar substance recovery programs such as Alcoholics Anonymous or Narcotics Anonymous, collegiate recovery programs don't demand abstinence from all substances when a person pursues recovery from one in particular. The program's "harm reduction" approach is meant to appeal to more students who aren't ready to fully abstain from all substances but need help quitting or dialing back from a substance that's personally destructive. "What I've seen for a lot of people is, once they get involved in the (college recovery program) and they see people that are totally sober, they're like, 'Oh, I can still have fun being totally sober," said Stephanie Lake, the coordinator at UC Davis's college recovery program, Aggies for Recovery, and a full-time substance abuse therapist on the campus. "A lot of them do eventually get to total sobriety but harm reduction at least gives them a way where they're reducing the harm of their drugs so that they're able to function in a better capacity."

practice that became more common in the past five years. One of the weekly meetings uses an Alcoholics Anonymous or Narcotics Anonymous speaker format to give students a sense of how those meetings look like, she added.

Still, students hooked on certain hard drugs struggle to moderate their consumption. Lake described one student she counseled a few years ago who wanted to continue using heroin on weekends. She told the student to see if he could limit his usage after three weeks. He couldn't but also didn't want to quit. A few months later, he came back to her, ready to get sober. Lake then referred him to treatment. Collegiate recovery programs are located on campus, another benefit, UC officials wrote in an agenda item to regents last month. That's because not all students have the transportation means or time to seek services that are off campus, such as Alcoholics Anonymous, Narcotics Anonymous, intensive outpatient services and Suboxone treatment.

She also guides two student facilitators who work part-time leading the group meetings. They include Ashlyn Reed, an incoming fourth-year student. The program has been instrumental in helping her remain off the substance that she has struggled with the most — nicotine. It's her fourth time quitting; this sixmonth stint has been the longest she has gone without smoking. She said the group meetings helped her examine why she relied on nicotine as an emotional crutch. "What am I hiding from or trying to avoid?" she said. But she also feels the limits of the program without a full-time coordinator. "We're the best kept secret on campus, and we don't want to be," she said. Without a full-time coordinator, there's no one to market the program on campus, where hundreds of student and community groups compete for attention from the campus's 40,000 students through leaflets, live events and other outreach.

CRPs should have," said Hariharan, who recently was elected as the student association's president.

Ryan King, a spokesperson for the UC Office of the President wrote that each "campus sets priorities within its budget and must balance competing priorities." He added that the system is exploring additional funding through the California Youth Behavioral Health Initiative and the recently passed Proposition 1, a state initiative to raise billions of dollars for housing and treatment facilities for mentally ill Californians. The UC maintains a \$50 billion budget and about a fifth of that is for its main education mission, including student services.

A small collegiate recovery program at half of the University of California's 10 campuses holds regular weekly meetings for students in some stage of battling drug and alcohol addiction or some other form of self-harm.

The University of California Student Association, which represents the system's 233,000 undergraduates, is mounting a campaign to bring the program and university funding to every campus. After almost a year of advocacy, the student organization brought the program to UC's largest stage, the UC Regents meeting, in July. Student advocates want a full-time coordinator at every campus, ongoing funding for each program and a private, dedicated meeting space at every UC.

The University Office of the President maintains that every campus has some kind of drug prevention, intervention and treatment program. But student advocates say the collegiate recovery programs are unique and provide an important outlet for students who need a nuanced approach to vanquishing their drug dependencies. The first was founded at Brown University in 1977. Today, scores exist on campuses across the country.

The need for drug recovery centers

The university system estimates that the existing programs served 4,000 students last year. A 2023 national survey indicates that 1.6% of UC undergraduates are in some form of drug or alcohol recovery.

But likely many more could benefit from a drug recovery program. The same 2023 survey showed that, depending on the campus, around 50% to 70% of undergraduates reported drinking at least once and a third to half have tried cannabis. Smaller, but still notable, shares of students have used other drugs at least once: roughly 3% to 10% used cocaine; as much as 2% tried meth. Among UC Berkeley students, nearly 1% had tried heroin.

Need for full-time coordinators

The UC Student Association stresses that each campus needs a fulltime coordinator. At UC Davis, Lake officially spends 5% of her time in that role, on top of the four to six students she sees daily for counseling. The campus intends to hire a full-time coordinator this fall, which she says couldn't come soon enough.

She couldn't apply for outside grants to fund the recovery program because she was busy with her full-time therapist job. The recovery program sponsors events on weekends, making it hard for her to attend after a full week's work seeing other Students pushing for a recovery program on every campus insist on ongoing university funding to support them as well as dedicated space for the meetings.

Aditi Hariharan, a UC Davis student who has advocated on behalf of the UC Student Association for these centers, expressed concern that some regents at the July meeting encouraged campuses to seek county health grants to fund the programs. Navigating county bureaucracy is difficult, she and other student advocates said, and even if the funding comes through, it's not a guaranteed ongoing source.

"County grants are also temporary and need to be reapplied and reapplied, and don't assure that permanent funding that "If there was a space where they could just hang out during that day, there wouldn't be so much temptation to relapse," Lake said. The campus's program relies on temporary meeting spaces, including the lobby of a student health services building.

UC Berkeley's center just received its own space. Previously, students attending meetings in an administrative building would need to sometimes enter the police department to gain access to the building — an awkward encounter for individuals trying to confide to each other about substance abuse. Other times, campus deans would cross the communal space during group meetings.

"The fentanyl crisis and everything else, it's a scary time for me as a counselor," Lake said. Having the collegiate recovery program "is just super, super important."
