

RANCHO CORDOVA, CA (MPG) - United Methodist Church in Rancho Cordova hosts Girl Scout Troop 702. The troop has been meeting there for an hour every other week for around eleven years.

A couple of years ago, Girl Scout Isabella Lopez noticed that an old mural on an outside wall had faded from time and weather.

We all got together and began to draw out our ideas."

Exciting Future for Waegell **Property**

RANCHO CORDOVA, CA (MPG) - The Rancho Cordova Planning Commission on Aug. 14 discussed the future development of the Waegell property as it pertains to a new project by Reynen & Bardis to transform the site into a new community.

Darcy Goulart, planning manager for the city of Rancho Cordova, introduced the official name of the development, which is Legado.

The Waegell property, which lies within the Grant Line North Planning Area, is the largest remaining undeveloped parcel in the area. The General Plan for this zone anticipates a population of 16,600 people, with 6,916 dwelling units and 3,634 jobs. Although specific land uses have not been designated, the plan encourages a mix of residential densities and commercial developments.

"I want to highlight the constraints related to the project," said Katherine Bardis, representing the development team. "Constraints related to 50% of the property absorbed by wetlands, Laguna Creek corridor and the Blodgett reservoir. There are areas of the property that we will be working around and try to factor in as both constraints and enhancements to the project." The proposed plan includes seven residential villages, numerous greenways, parks and a comprehensive trail system to ensure community connectivity. "I want to make sure we have a variety of housing types and are mixing and blending those," said Commissioner Cynthia Stauss highlighting the importance of integrating housing. Goulart also shared notes made by the Rancho Cordova City Council on July 1 regarding its vision for the property's future development of the property. During the session the council emphasized the need for new urbanism, including a range of housing densities and types, from executive housing to more diverse residential options. They also highlighted the importance of cohesive pedestrian connectivity ensuring residents have accessibility to various amenities. Commissioners also had the opportunity to share their ideas and suggestions on the project's development.

RANCHO CORDOVA, CA (MPG) - The Cordova Community Council and the Rancho Cordova Area Chamber of Commerce's monthly luncheon Aug. 16 at the Rancho Cordova City Hall featured Visit Rancho Cordova President and CEO Marc Sapoznik.

Sapoznik, who has more than 20 years of experience in the tourism industry, detailed the strides that Rancho Cordova has made over the years and explained what Visit Rancho Cordova does and how it impacts the city.

"Marc Sapoznik has helped rebrand Rancho Cordova as a destination and secured a 28% regional revenue growth in the past three years," said Rancho Cordova Area Chamber of Commerce President and CEO Diann Rogers.

Sapoznik explained that

Visit Rancho Cordova operates as a Destination Management Organization (DMO) focusing on promoting the city as an attractive location for visitors, residents and businesses. The organization uses various methods to

promote the city, including sponsorships, merchandise, networking, advertisements and newsletters. One key funding source for Visit Rancho Cordova is the Tourism Business Improvement District (LBID), which allows the organization to operate without relying on city or county tax dollars.

"When it comes to success, it's 'we.' We get to do things as a team and work with partners from across the region," Sapoznik said. "All of our team members are focused on promoting Rancho Cordova as a place people want to be."

Promoting tourism in Rancho Cordova is crucial for economic development and revenue generation. By attracting visitors, the city boosts local businesses such as hotels and restaurants. This influx of tourism also creates and sustains jobs within the city, rather than outsourcing them elsewhere.

"Tourism is a \$1.3-trillion industry in the United States," Sapoznik said, citing the industry's critical role in driving revenue, creating jobs and enhancing visitor Continued on page 11

Charles Chiu, "Far East Deep South" Documentary Subject, Dies

RANCHO CORDOVA, CA (MPG) -Rancho Cordova resident and U.S. Air Force veteran Charles Chiu, who was the central figure in the award-winning documentary "Far East Deep South," died on Aug. 4 at age 86.

Chiu, a beloved husband, father, and grandfather, passed away with his family by his side following cardiac arrest and a prolonged battle with kidney disease.

Chiu served honorably for 25 years in the U.S. Air Force, retiring as a master sergeant. Throughout his career, he was primarily stationed at Travis Air Force Base as well at the McClellen and Mather Air Force Bases. He also dedicated more than 30 years working for the Employment Development Department (EDD).

Born on April 17, 1938, in Sunwui (also known as Xinhui), China, Chiu was the son of K.C. Lou, a merchant in Pace, Mississippi, and Jung Yuk Lon. When Chiu was one year old, his father returned to the U.S. to run their family grocery store. Strict U.S. immigration laws of that era, such as the Chinese Exclusion Act, made it difficult for Chinese women and children to enter the United States. When Charles was eight years old, his father died in Mississippi, and as a result, Chiu never had the opportunity to know him. His quest to recover his lost history is chronicled in "Far East Deep South."

Chiu immigrated to the U.S. at 14 aboard the S.S. Cleveland, arriving in San Francisco in 1952 with his grandmother. He attended and graduated from Oakland Technical High School while working various jobs to support himself and his grandmother. He married Rebecca, on Aug. 12, 1973, in San Francisco and enjoyed nearly 51 years together, raising two sons, Baldwin and Edwin. In 1982,

Chiu moved his family from San Francisco to Rancho Cordova, where he lived until his death.

In recent years, Chiu developed a profound understanding of his family's history through the making of the documentary, "Far East Deep South." The film opened Chiu's eyes to the history that he and others never knew about Chinese families in the Mississippi Delta during the Jim Crow and Chinese Exclusion era. Through this journey, Chiu gained insight into the complex circumstances that separated him from his father and the depth of his father's love.

Subsequently, Chiu became passionate about educating others about restrictive immigration laws such as the Chinese Exclusion Act and the interconnected history between the Black and Chinese American communities in the segregated South. He also sought to highlight the long-standing legacy that many

Chinese families, including his own, have in America.

Chiu will be laid to rest at Mount Vernon Memorial Park in Fair Oaks and his full obituary can be viewed on their website. He is survived by his wife, two sons, two daughters-in-law (including Larissa Lam, director of "Far East Deep South") and

three granddaughters.

About "Far East Deep South" "Far East Deep South" is an award-winning documentary about Chinese American families in the Mississippi Delta during segregation that premiered on the World Channel (PBS) series, "America Reframed." The film won a 2022 Telly Award and is currently streaming on Tubi, PBS Passport, Xfinity and Kanopy. The film was directed by Larissa Lam and produced by Baldwin Chiu and Larissa Lam. SACRAMENTO REGION, CA (MPG) - National Football League (NFL) FLAG games give boys and girls of all abilities an opportunity to develop fundamental football skills in a positive, inclusive environment, according to the NFL FLAG organization.

And now area youth will have an opportunity to develop those skills.

That's because the nonprofit Playmakers Character and Leadership Academy is launching a free, inaugural Playmaker Flag Football in Citrus Heights next month.

Children with developmental differences of any ability, desire and age, plus their families, are encouraged to attend. There will be two leagues, one for boys and girls between the ages of 6 and 14, and another league for boys and girls with developmental differences.

Optimist Club of Country Club and Verde Design are providing the resources for The Playmakers to offer the free NFL Youth Flag Football.

All participants will receive a jersey, wristband and qualified coaching from high school and college players.

The games and practices will be held at both Mesa Verde High School and San Juan High School in Citrus Heights.

"This program is possible through the cooperation of both Mesa and San Juan High schools, working together for the community of Citrus Heights, beginning mid-September through November," said Playmakers founder Greg Roeszler. "Optimists and Verde Design want all kids and families to have the opportunity to participate. Playmakers ensures the character/leadership component of the coaching and oversight."

The nonprofit Playmakers organization was founded by Roeszler in 2009 to build leadership and character through sports and academics. Roeszler is an Encina High School varsity football coach and a former quarterback/punter at the University of Minnesota and San Diego State, and camp quarterback with the Oakland Raiders

Jerry Ahlin Has Been All in on Rugby

- For nearly 50 years, Jerry Ahlin has been a fixture in the rugby community within Rancho Cordova and the Greater Sacramento area. Whether he was playing the sport, coaching area youth or doing his part to help grow the game across the country, Ahlin's name has been synonymous with rugby. His efforts have surely been recognized, as he is being inducted into the Rancho Cordova Sports Hall of Fame this September.

Ahlin, 79, is a co-founder and president of the Sacramento Valley Rugby Foundation. The organization is most-notably known for hosting their annual Kick-Off Tournament at Cordova High School, which has hosted over 120 teams from California to Canada for several years every January until 2020 when the COVID-19 pandemic halted operations. For Ahlin, being inducted into the Rancho Cordova Sports Hall of Fame for his role in rugby is special.

"It's nice to be recognized," he said. "It certainly is an honor because there has been a lot of fantastic athletes and coaches and teams that have been honored through the years. Rancho Cordova has had a great history with athletics, so it is definitely an honor."

Ahlin was born and

raised in Boise, Idaho, where he excelled at football. He played quarterback and linebacker at the University of Idaho, where he graduated in 1967. He then enjoyed stints as a linebacker with the Hamilton Tiger-Cats of the Canadian Football League as well as the Dallas Cowboys of the National Football League. His athletic achievements earned Ahlin induction into the Idaho High School Hall of Fame, as well as the Idaho Hall of Fame.

Ahlin moved to the area in 1971 for a job, and soon found himself introduced to the game of rugby. He would go on to play with the Sacramento Capitals, and participated as a player for the next 25 years. Various relationships and connections led he and several area coaches to form the Sacramento Valley Rugby Foundation, and the rest was history.

Although his playing days are over, Ahlin is still trying to help grow the sport. Ahlin stated that his foundation has been trying to negotiate with the city to build a state-of-the-art rugby facility at Mather Park for the past 20 years, which has been in his words "quite the battle."





There have been more items in the news recently about diseases which are new in the United States of America and they have to be fought by our local Vector Control Board.

As was said in the news in July of this year, "The Centers for Disease Control and Prevention recently alerted health care providers about the increase risk of dengue virus infections in the United States in 2024 based on an unprecedented number of cases being reported globally and higher-then-expected cases identified among U.S. travelers."

Climate change has also expanded mosquito habitats. For several species, populations are growing earlier in the year than they would have decades ago. For example, in the United States, Aedes scapularis mosquitos are from the tropics and can carry yellow fever. Human metapneumovirus can cause upper and lower respiratory disease in people of all ages. So the most important thing our can

do is make sure there aren't places in your home, like water pots or other places in which water allows mosquitoes to breed.

Most of the people in the United States are watching the news, and paying attention to the people who are running for different elected offices. Something really important is that all of us have to pay attention to people who are running for offices. Don't just listen to the social media as the best source information. Many times there really is nothing but someone's personal opinion, and people find out later that they aren't very knowledgeable and they just babble on. Make the time to learn on your own before you pass a proposition, or vote for a person. You have to make the time to learn before you pass your vote on to someone or a proposition.

Dear Dave,

Recently, I began running my farm operation debtfree. I have 350 acres, and all the varying expenses often makes it difficult to budget correctly. I also have about \$240,000 in debt from bad financial decisions in the past. Do you have any suggestions for budgeting in a volatile industry like mine?

– Thomas

Dear Thomas,

First, you want to set up a separate budget and run a profit and loss statement. You'll want to estimate the income for the year as best you can, and you'll need to estimate your expenses item by item and category by category for the year. After that, you'll want to break it down by month. This is called laying out a business pro for-

ma—a business budget.

Next, you've got two goals to work toward with your profits. By profits, I mean after you've paid household expenses. That includes a living wage, enough to operate, keep food on the table, the lights on and that sort of thing. After basic living expenses are out of the way, your net profit in the business should be divided between retained earnings-or savings-and debt reduction. The idea is that you're going to put the lion's share toward paying off debt for now. Still, you need to have something set aside for a rainy day. In your case, that could be taken literally.

Keep in mind that in business, retained earnings are used for more than just emergencies. They're also for buying more land, equipment and anything else that'll grow your operation. But you always want a pad in there. What if you have an unusual year, and your budget estimates are way off? It could be unexpected expenditures, or the fact you simply had a bad year. In business, that's an emergency, and you'd take that out of retained earnings.

Doing a budget, whether it's in business or personal finance, gets easier and more accurate with time and practice. You won't get everything right the first couple of tries, but with a little time and experience your budgeting skills and estimates will become more accurate.

I hope this helps, Thomas. Thanks for all your hard work!

Congratulations to Kings standout De'Aaron Fox and his wife Recee! Their young family has recently added a baby girl, and on behalf of all Kings fans I want to say a hearty congratulations to you both.

Many Kings fans have enjoyed watching Recee and baby Reign the past season, as they sit courtside and root on De'Aaron and the Kings nightly.

As an NBA veteran and former all-star, I fully expect De'Aaron to have another allstar season this year, and with the added presence of DeMar DeRozan, Fox could potentially have his best year yet.

Many believe with De'Aaron's improved three-point shooting, and his dynamic drives to the hoop, DeRozan's stellar midrange game may give Fox even better looks at the basket.

The same can be said for Keegan Murray, whose three-point shooting fell off a bit after having an eye-popping rookie season.

Teams tightened up the D on Keegan in his sophomore campaign, and the open looks he enjoyed in his rookie season were harder to find last year.

Look for DeRozan to help Keegan get back on track, and I believe every Kings fan is firmly convinced that Keegan's best basketball is still in front of him.

I have listened to NBA pundits that have downgraded the Kings to a 44-win prospect in the coming season, and this writer wonders what these supposed experts are looking at.

I see a 50-plus win team hitting the hardwood for Sacramento this year, and that is without Monte McNair making any further improvements to the roster. McNair has done a yeoman's job as a young GM, and is already developing a reputation as a GM not to be taken lightly.

Not since the Geoff Petrie days have we seen someone in the front office with the acumen that our own Monte McNair has demonstrated. So, take heart Kings fans, because I believe McNair is here for the long haul, and his 13-year stint with the Houston Rockets has proven invaluable to the Kings, as he continues to make prudent moves that are consistently improving this team.

Many fans criticized choosing another guard in acquiring Devin Carter, but I firmly believe that utilizing the philosophy of choosing the best possible talent, regardless of position, was the correct prescription for the Kings, and just like choosing Keegan Murray two years ago, I believe that young Carter will prove his value in the 2nd half of the 2024/2025 season.

Many believe that the only reason he wasn't taken in the top 10 was due to impending shoulder surgery that has already taken place. Carter's availability looks to be sometime in late January, so his rookie campaign will consist of only half a season. I'm convinced that McNair chose wisely, so working him into the lineup in the all-important drive to the finish could make Devin Carter another fan favorite.

The continued talk is that the Kings still need a power forward to match up with stalwart big man Donatas Sabonis, and there still remains quality players that are on the open market.

One name I haven't heard mentioned is Indiana Pacers small forward Doug McDermott, who may yet be a sleeper that just needs more time on the hardwood.

A playoff team last year and a good one, the Pacers gave McDermott only 14 minutes per game while adding 5.5 points per game each night. McDermott was the 11th pick overall in the 2014 draft, and at 32 years of age could bring a veteran presence to a young Kings roster.

Tobias Harris is more of a household name, and while scoring 17.2 points per game for the 76ers last season, has scored 20 or more for the season twice in his 9-year career, and would also fit nicely into the Sacramento lineup.

Stay tuned Kings fans, because the roster for the upcoming season is not yet cast in stone, and just one more move could propel this playoff bound team to a place deep in the playoffs!

Section 3. Except as provided in the Rate and Method, properties or entities of the State of California, federal or local governments shall be exempt from any levy of the special taxes unless specifically provided otherwise in the Rate and Method. In no event shall the special taxes be levied on any parcel within the CFD in excess of the maximum tax specified in the Rate and Method.

Section 4. All of the collections of the special tax shall be used as provided for in the Act and in the Resolution of Formation including, but not limited to, the payment of principal and interest on the Bonds, the replenishment of the reserve fund for the Bonds, the payment of the costs of the Facilities, as applicable according to the Rate and Method, the payment of the costs of the Authority in administering the CFD, and the costs of collecting and administering the special tax.

Section 5. The special taxes shall be collected in the same manner as ordinary ad valorem taxes are collected and shall have the same lien priority, and be subject to the same penalties and the same procedure and sale in cases of delinquency as provided for ad valorem taxes; provided, however, that this Board may provide for other appropriate methods of collection by resolutions of this Board. In addition, the provisions of Section 53356.1 of the Act shall apply to delinquent special tax payments. The Executive Director of the Authority is hereby authorized and directed to provide all necessary information to the auditor/tax collector of the County of Sacramento in order to effect proper billing and collection of the special tax, so that the special tax shall be included on the secured property tax roll of the County of Sacramento for each fiscal year, as needed, until the Bonds are paid in full or such longer period of time provided in the Rate and Method.

Section 6. If for any reason any portion of this Ordinance is found to be invalid, or if the special tax is found inapplicable to any particular parcel within the CFD, by a court of competent jurisdiction, the balance of this Ordinance and the application of the special tax to the remaining parcels within the CFD shall not be affected.

Section 7. An Authorized Signatory shall sign this Ordinance and the Secretary shall cause the same to be published within 15 days after its passage at least once in a newspaper of general circulation published and circulated in the Authority.

Section 8. This Ordinance shall take effect 30 days from the date of final passage.

California Commissioner Faces Criticism as He Tries to Solve Crisis in Home Insurance Coverage

"Father Knows Best" was a popular radio show in the post-World War era that morphed into an even more popular television series starring actor Robert Young.

Young's character, Jim Anderson, was an insurance company executive - probably the only time American mass media have positively portrayed such a figure. Young later played a much more sympathetic role, a doctor who made house calls, in "Marcus Welby, MD."

Insurance to indemnify us for liabilities and damages to our homes, cars and businesses is a modern necessity, but consciously or subconsciously we often resent paying for coverage that is seldom invoked.

Politicians tend to play on that resentment by promising, if elected, to protect voters from rapacious insurers.

In California, that attitude took the form of a 1998 ballot measure sponsored by a self-designated consumer protection group, that made the state insurance commissioner an elected official with new authority to regulate insurers.

The sponsoring group, Consumer Watchdog, has since been paid millions of dollars in "intervenor fees" for inserting itself into insurance rate cases pending in the Department of Insurance, but it claims to have saved Californians \$6 billion.

Ever since he launched

his 2018 campaign for insurance commissioner, former state Sen. Ricardo Lara has faced sharp criticism from Consumer Watchdog, which denounced him as a tool of the insurance industry.

However Lara has had to contend with an unprecedented crisis in California's insurance market. The disastrous wildfires that have swept through California in the last half-decade prompted many insurers to curtail their exposure, some to the point of abandoning the state altogether.

California's insurance regulatory system, they said, made it impossible to accurately project potential losses and adjust their premiums accordingly.

As tens of thousands of policies were canceled or not renewed, property owners scrambled to find new coverage, and many turned to the state's insurer of last resort, the FAIR program, that offers only limited reimbursement for losses at high cost.

Furthermore, because mortgage lenders require borrowers to maintain insurance coverage on their property, the insurance crisis has contributed to California's housing crisis.

Lara, backed by Gov. Gavin Newsom, has proposed systemic changes in how insurance is priced. He agreed with insurers that their rate proposals should be processed more rapidly, that they should be allowed to include potential losses from wildfires and other catastrophes in their rates, and that the costs of reinsurance ---to spread the financial burden of losses — should be folded into premiums.

"We do not have the luxury of time," Lara said in a press release last week as he announced the adoption of new rules to speed up rate cases.

Consumer Watchdog is still nipping at Lara's heels, saying "we remain concerned that the new procedures announced by the commissioner will short-circuit public participation and rates will be rubber-stamped."

"Consumer Watchdog will analyze this action to determine if it is an illegal underground regulation or otherwise violates Proposition 103 by shutting consumers out of the process," it added.

Anticipating the criticism, Lara's announcement last week said, "Any intervenor groups engaged on certain rate filings must provide a 'substantial contribution' to the rate review process and not duplicate the work of the department's rate review experts to be eligible for compensation."

Would Lara's proposed regulatory changes likely make insurance coverage more expensive in fire-prone regions? Yes, but there are no free lunches and it's better to have costlier coverage than none

If nothing else, Lara deserves credit for actually doing something about a severe crisis, rather than passing the buck – a contrast with how California officials are dealing with another crisis, homelessness.



Californians: Your Rent May Go Up Because of Rising Insurance Rates

CALIFORNIA (MPG) - Like single-family homeowners in California, landlords are facing higher insurance premiums, too. And they're passing along some of those costs to their tenants.

Many insurance companies have stopped writing policies in the state because of increased wildfire risks, but that's not the only reason. They say in the case of any catastrophe, the potential costs of replacing any residential or commercial property, from labor to material costs, is just plain more expensive now. So even owners of properties in areas that are not at high risk for wildfires have had their policies canceled because their buildings may need repairs or improvements. Landlords are having to find other insurers, or having to turn to the ever-growing and more expensive FAIR Plan, the insurance industry-run plan that is mandated under California law to be the insurer of last resort.

This is where the insurance crisis could worsen the housing crisis, according to some experts. Increased insurance costs for properties other than single-family homes are starting to affect the rental market — in a state where almost half of residents are renters — and could compound the state's housing problems, they say.

Josh Hoover, an insurance broker in the Los Angeles area, handles mostly commercial accounts and said "it's almost impossible" to find coverage for any large structure. In late 2022, Allstate said it would stop writing new property insurance in the state, including commercial policies. Then State Farm, the biggest insurer in the state, recently canceled policies for tens of thousands of homes, residential community associations, business owners and commercial apartment properties. "Even buildings made in the '80s are now considered old, which is ridiculous," Hoover said. "Most carriers want everything updated in the last 30 years. They want a new roof, electrical redone, plumbing redone — they want you to have copper pipes."

in San Bernardino that was built in the 1960s, said its co-owner, Uwe Karbenk. Karbenk found an outof-state insurer instead of going with the more expensive FAIR Plan, but his premium has still increased by \$28,000 to more than \$41,000 a year.

Combined with state laws that limit how much he is allowed to raise the rent each year — 5% plus inflation, or up to 10% in some cases, with possibly other rent-control measures on the way — Karbenk said being a landlord in California is "a little bit like death by a thousand cuts." He added that if his profit margin continues to shrink, he would rather invest in something else besides real estate.

"One of these measures, it's not a big deal," Karbenk said. "But over the years, it's really difficult for mom-and-pops."

Mike Placido and his wife are definitely a momand-pop. They own two "I'll pass along as much as I possibly can, as much as the market can bear, and I'll shoulder the rest. I have no choice."

Yet Another Worry for Renters

About 44% of Californians are renters, according to the U.S. Census. The median monthly rent in the state is \$2,850, a third higher than the national figure, according to online real estate marketer Zillow. About 30% of the state's renters are considered severely cost-burdened, meaning they spend at least half of their income on housing, according to an analysis by the Public Policy Institute of California. Now their rents could rise to even more burdensome levels.

Shanti Singh, legislative director for statewide renters' rights organization Tenants Together, said "it's still kind of an unknown how common it is" that tenants' rents are rising along with insurance costs, partly because not all landlords say why they're raising rents. "insurance costs" in the subject line.

Singh said she fears things will only get worse for renters as the effects of climate change, such as wildfires, continue to weigh on the affordability of insurance, and in turn, housing.

"Tenants are going to have the least recourse," Singh said. They "always

uninhabitable and uninsurable — whichever comes first.

Sarah Karlinsky, director of research at the Terner Center for Housing Innovation at UC Berkeley, said the lack of enough housing within already developed cities means more building "at the fringe of regions, in places that are more dangerous," climate change make it more important than ever for renters to have their own insurance, said Emily Rogan, senior program officer for United Policyholders, a consumer advocacy group.

Renters insurance would cover the costs for tenants to stay "somewhere else as you figure out where to live in case of a severe weather event," Rogan said.

Effects on Commercial Properties and Businesses

Small businesses that rent their space will be affected by their landlords' rising premiums, too.

John Reed owns a mixed-use commercial property in Oakhurst, outside Yosemite — an area that has seen its share of fires in the past several years. Last year, his fire insurance cost about \$2,800, but Berkshire Hathaway canceled his policy. He got three different quotes from the FAIR Plan, with the highest being \$24,000. Then, he found a plan from Lloyd's of London for about \$14,000

Earlier this year, Farmers canceled the policy on a 33-unit apartment building rental properties, a fourunit building in San Gabriel and a duplex in Alhambra. He said they bought the properties as a way to supplement their retirement income when the time comes in a few years.

When State Farm canceled the policy on their San Gabriel property, Placido got a quote from the FAIR Plan for \$8,600, much higher than their old \$2,600 premium. Instead, he was able to cobble together three different policies from a Florida-based insurer to get the coverage the old policy provided for \$6,500, a 150% increase. So he said he plans to raise rents in January.

"It's not like I'm some land baron," Placido said. "It depends on the landlords," Singh said. "Some are transparent; a lot of them aren't."

Any significant rent increases have not yet shown up in Zillow's data, which shows California's median rent is actually down about \$100 compared with last year, though it has climbed higher since the beginning of the year.

In the Bay Area, two renters who didn't want to be named out of fear of retaliation from their landlord said the rents at their live-work complex jumped earlier this year, and the reason was spelled out to them in an email that had

end up bearing a disproportionate brunt of what they can afford."

Housing and Climate Change

Singh and others who deal with California's lack of affordable housing expressed concern about whether certain parts of the state will eventually be also known as the wildland urban interface, or the WUI, in wildfire speak.

"If we don't want to continue down this road, we have to fundamentally rethink our development patterns," Karlinsky added.

Laurie Johnson, an urban planner and former chief catastrophe response and resiliency officer for the California Earthquake Authority, pointed out that some property owners in the state who own their buildings and have no mortgages might choose not to insure their properties because of the rising costs. That's worrisome, she said.

"It feels like we want to keep our multifamily stock insured and don't want to take the risk of losing it," Johnson said. Hoover, the insurance broker, agreed and said he has had some clients tell him they plan to forgo insurance.

Johnson added that just as jurisdictions have been requiring seismic retrofitting in case of earthquakes, protection against fires and other catastrophes — and the ability to replace whatever might be lost — is vital: "You would be displacing so many people."

The growing risks of

to pass on his increased costs to his six tenants. "As a landlord, I can't hit them with the whole burden all at once," he said. "If I'm able to afford it, I will try to spread that out over a two- or three-year period."

California's insurance commissioner, Ricardo Lara, has unveiled a multipart plan to address the state's insurance woes, mainly focused on wildfires. For example, insurers will be allowed to use catastrophe models if they agree to write policies in certain areas of the state. But Insurance Department spokesperson Michael Soller pointed out that Lara also recently announced a deal with the FAIR Plan that creates a high-value commercial coverage option.

"The reforms will have broad benefits for the availability of insurance," Soller said.

Back to School: Prioritizing Safety for Families on Grant Line Road

Rancho Cordova City Councilwoman Siri Pulipati had left her son at daycare minutes before her nightmare unfolded. On Grant Line Road, she steered slightly to the right when she saw a wide-body truck barreling toward her.

"I just moved a little to the right, and the next thing I know, my tire hit the edge of the road," Pulipati recently recalled. "I blew through the fence and rolled into the middle of the fields. As the ambulance was taking me away, my first thought was, 'Thank God my child was



not in the car with me."" While improving traffic flow through the Sacramento region has always been the Capital Southeast Connector Expressway's focus, improving safety throughout the route has been an equal goal.

The Connector

Expressway's route from Elk Grove to Highway 50 in El Dorado County has always been known for its dangers. During the Gold Rush, it was the rocky dirt track that about 300,000 gold miners used to receive supplies and send their bounty to market. The route is legendary for broken wheels on mule and horse-drawn carts, and many sections flooded during rainstorms.

Today's dangers are related to the number of vehicles speeding along a road designed for travel in past eras. Grant Line Road, a backbone arterial for the south county, poses safety risks for the thousands who rely on it daily. Potholes, sharp curves, and elevations

that obstruct the view of oncoming traffic are common, and there are long sections of the road with narrow or essentially no shoulders. Bicycling is a grave risk.

Upon completion, the Capital Southeast Connector Expressway literally eliminates all those problems, and more.

As the school year begins, the familiar challenges of commuting along Grant Line Road are once again at the forefront of concerns for many families in Rancho Cordova and Folsom. The road's current condition is more than just an inconvenience—it is a danger.

The Capital SouthEast Connector Expressway is not just about repairing a dangerous roadway; it's about transforming it into a modern, efficient, and safe corridor that meets the needs of our growing population.

Recently, the project received \$25 million in critical federal financial support, underscoring the project's importance and potential to improve safety and ease congestion.

We will soon be requesting a matching state grant to further advance the work. Securing these additional funds is essential to ensuring that the project can begin widening the road and its shoulders, adding new lanes, and upgrading intersections. The project also includes a new bike and pedestrian path offering safe travel options.

The success of the Capital SouthEast Connector depends not only on the work of engineers and construction crews but also on community support and engagement. 
What is the Capital Q SouthEast Connector **Expressway?**

The planned Connector A is a four-lane expressway that will link Interstate 5 and Highway 99 near Elk Grove to Highway 50 in El Dorado County. The new expressway will act as a southeastern beltway circumventing downtown Sacramento and relieving congestion by directing commuter and commercial traffic around the city. Travelers to and from areas south of Sacramento will no longer need to go through the city to get to their destinations. The Capital Southeast Connector Expressway will feature a parallel bike and pedestrian trail that connects residents to recreational, entertainment and retail facilities, and to each other.

planning community development, and ensuring the safe movement of agricultural and other products. According to a 2022 economic study, the completed Capital Southeast **Connector Expressway would** save commuters between \$500 million and \$1.5 billion in travel time saved from 2026-2046 compared to using current roadways. The study also found that the completed Capital Southeast **Connector Expressway would** generate:

- \$1.8 billion of increased economic output
- \$770 million of new labor income
- \$1.1 billion in added value to the region
- \$80 million in new state and local taxes on production and imports



Revenue from a one-half A cent transportation sales tax passed in 2004, combined with other local, state, and federal funds, finances the project. For example, the next phase of the Capital Southeast Connector Expressway recently received \$25 million from the U.S. **Transportation Department** to transform a dilapidated and dangerous section of Grant Line Road into a modern expressway. These funds, along with other, will be used to complete that portion of the project at a total cost of \$60 million.

What was the purpose **Q** of the transportation sales tax, when does it expire, how much revenue has it generated over the last two decades, and how much has been allocated to the Capital Southeast **Connector Expressway?** Sacramento County's ${f H}$ transportation sales tax expires in 2039. Voters overwhelmingly approved the tax measure to maintain and improve I-5, I-80, Hwy 50, Hwy 99, and local roads; increase transit for seniors, and expand light rail. The only new project specified in the ballot measure was the **Capital Southeast Connector** Expressway. Through 2023, the sales tax has generated over \$2 billion, with about \$58 million allocated to the **Capital Southeast Connector** Expressway.

What are the statics Q regarding how people choose to travel in and through Sacramento?

Comparing car and com-A mercial traffic to bus and light rail use can be complex, but statistics show that most residents of Sacramento and El Dorado Counties prefer to travel by car. For example, the light rail Gold Line, which runs from downtown to Folsom, averages 9,000 boardings per day, according to Sacramento RT. By comparison, a 2017 CalTrans study documented an average of 156,000 vehicles using Highway 50 daily near its intersection with Sunrise Avenue, a location served by the Capital SouthEast Connector Expressway. With

an average of 1.6 people per vehicle, this means approximately a quarter-million people were served daily on Highway 50 back in 2017.

Q What are the primary challenges to completing the Capital SouthEast **Connector Expressway?** The main challenges A are funding and politics. Political support is crucial for securing funds from local, state, and federal sources, and there are many worthy projects competing for the funding. The Capital SouthEast **Connector Expressway has** received bipartisan support, which has been beneficial. For example, three Republican and Democratic members of Congress from the area recently requested a combined \$30 million in federal funding for the project, demonstrating that infrastructure needs can transcend political divisions. As Congressman Kevin Kiley (R) observed, "This project is a testament to what is possible

when everyone in our region works together. When you consider the political divisions in this country, local regional projects that tangibly impact people's lives can help bridge those gaps."
