SACRAMENTO REGION, CA (MPG) - A volunteer team has taken on a mission to clear miles of abandoned fishing line from local rivers and waterways.

Calling themselves "Project Pick Up Fishing Line," 10 nature lovers are leading other helpers to comb riverbanks for an almost invisible danger. "Fishing line causes suffering and death to birds and a host of other river inhabitants," explained Jann Nichols, the group founder. Nichols, a photographer, has documented many situations of animal entanglement.

Project Pick-Up has successfully lobbied for county agencies to place receptacles and signage in fishing spots.

"We want people to be aware that a careless act can endanger lives," Nichols said. "We also want them to know there are people you can call to save a trapped or injured creature." Nichols and friends were recently on hand when a swan died after ingesting fishing line at Cameron Park Lake in El Dorado County. Its organs were so damaged and the bird in such distress that euthanasia was the rescuers' only resort.

SACRAMENTO REGION, CA (MPG) - While Labor Day is the last holiday of the summer, mosquito activity and the risk of West Nile virus continue for all area residents.

On Aug. 30, the Sacramento-Yolo Mosquito & Vector Control District reminded the public to protect themselves from mosquitoes, especially as many would be at outdoor activities for the long holiday weekend.

"Mosquito samples and dead birds are still testing positive for West Nile virus," said District Manager Gary Goodman on Aug. 30. "While we have been enjoying the cooler weather, temperatures are expected to climb back up next week. This means mosquitoes will be out and there is still a possibility of being bitten and becoming sick with West Nile. "Stay protected by always using an effective repellent when spending time outdoors," Goodman added. The Centers for Disease Control and Prevention recommends using an insect repellent that contains the active ingredients DEET, Picaridin, IR3535 or the plant-based Oil of Lemon Eucalyptus. Be sure to always follow label directions when applying repellent. This season, virus activity has been steady and widespread in both Sacramento and Yolo counties. "We still have a few weeks before the summer season officially ends so it's very important for everyone to do their part and protect themselves, especially as we head into the holiday weekend," Goodman said. While West Nile virus is the main concern, the invasive mosquitoes, Aedes aegypti and Aedes albopictus continue to spread throughout both counties. Invasive mosquitoes are a public health threat because they are capable of transmitting debilitating diseases such as Zika, dengue and chikungunya. Invasive mosquitoes were detected for the first time within district boundaries in 2019 and since then Continued on page 2

"In some cases, rescuers have freed birds from hooks and line," she reported. "In tragic cases, animals don't survive. Pets can also come to grief on trails through similar accidents."

Nichols acknowledged that lines get snagged and accidents happen.

"But usually, our volunteers are easily able to free and dispose of fishing gear," she said. "If we can do this, so could anglers. We're also collecting hundreds of items of trash left in fishing spots. Litter is not abandoned by

# Park Concerts Rock On

CARMICHAEL, CA (MPG) - As the 2024 music season resumes, four concerts will bring rock back to Carmichael Park. The first performance kicks off this Friday, Sept. 6.

"He'd swallowed so much line that his intestines were accordioned," explained rescue expert and Project Pick-Up volunteer Leslie Ackerman. "It was heartbreaking. A beautiful bird's agony is something you never forget. The incident inspired us even more to continue our cleanup efforts and to educate people."

In their spare time, the volunteers address areas that they say are most abused. Mather Lake in Rancho Cordova, the American River at Watt Avenue, Cameron Park Lake and Willow Creek in Folsom are top trouble spots.

"We come back from these places with grocery bags filled," Nichols said. "Fishing lines, hooks and lures from the ground or from trees and grasses," Nichols added. "Honestly, the stuff is all over the place. For many people, it's invisible. To our eyes, line catches the light like spider webs. Often, we need long grabbers to reach it. Sometimes, divers find line tangled underwater. They help us dispose of it. Fishermen sometimes help us, too. Along with the careless culprits, many responsible people use the river."

The volunteers keep their harvest as evidence of how pervasive the problem is. They assembled more than 2,000 hooks and sinkers for a recent Mather Lake display. The haul also included dozens of bulging bags of lines.

"Aquatic birds are often drawn to anglers in the hope of a feed," Nichols noted. "They can swallow a lure or get snagged. If a hook is lodged on their body, feeding and mobility is threatened. Suffering and death often follow."

"I started this project last year when I saw a young osprey tethered to the nest," she recalled. "Its parents had brought in a branch entangled with fishing line. The baby was snarled for a week, close to fledging time. I couldn't sleep for worrying. It took some time for rescuers to access the nest but the baby was saved."

"Around that time, several cygnets died from line entanglement at Cameron Park Lake," Nichols continued. "I decided to do whatever I could to prevent this from happening again. I started picking up line wherever I saw it."

Nichols was soon joined by friends who wanted to help.

"They'd also seen injured wildlife in situations they could not forget," Nichols said. "Seeing animal suffering is a powerful motivation."

The volunteers fund their own activities. Equipment includes gloves, clippers and long-handled retrievers. Sunscreen is another essential.

"It's hard work but it's also nice to be out in nature," Nichols said. "You know you're helping wildlife and pets have a safer environment."

## Phone-Free Schools Act Clears Legislature, Heads for Signature

**SACRAMENTO, CA (MPG)** - On Aug. 29, the Legislature passed landmark legislation authored by Assemblymembers Josh Hoover (R-Folsom), Al Muratsuchi (D-Torrance), Josh Lowenthal (D-Long Beach), and David Alvarez (D-San Diego) to limit the use of smartphones in schools. Assembly Bill 3216, also known as the Phone-Free Schools Act, requires school districts in California to adopt a policy no later than July 1, 2026, that limits or prohibits the use of smartphones by students during the school day.

"Today, the Legislature took meaningful action to support students and transform schools across California," said Assemblyman Josh Hoover. "As a parent and former school board member, I am incredibly grateful for this bipartisan effort to put kids first and improve their academic and mental health outcomes. I thank the Governor for his leadership on this issue and urge him to sign this bill to create phone-free schools across our state."

"Research continues to demonstrate the potential harms of smartphone use among children. The growing use of these devices in a child's everyday life can contribute to lower test scores, anxiety, depression, and even suicide. I am grateful for the Legislature's leadership on limiting the use of smartphones during the school day and I look forward to working with the Governor," Hoover added.

The bill now heads to Governor Gavin Newsom's desk for signature, who has signaled support for the legislation in recent weeks.

Many school districts have already limited or prohibited smartphone use in schools and have seen resounding success. Administrators have reported increased social interaction among peers, decreased instances of bullying on campus, and improvements in academic outcomes. A 2016 study found that when smartphones were removed from classrooms standardized test scores increased by an average of six percent, with even greater improvements among low achieving students. The Phone-Free Schools Act will continue to build on this success by expanding limitations on smartphones statewide.

A piece published in The Atlantic earlier this year by NYU social psychologist Jonathan Haidt described a number of the potential harms that smartphone use is contributing to in children:

Grades suffer when learning is disrupted as a result of smartphone distractions in the classroom

Up to 15% of teenagers engage in "problematic social media use," which includes symptoms such as preoccupation, withdrawal symptoms, neglect of other areas of life, and lying to parents and friends about time spent on social media

The latest Gallup data found that American teenagers spend around five hours per day on social media platforms alone.

As smartphones have become ubiquitous since 2010, we have seen a 70% increase in the number of high school seniors expressing that "life often feels meaningless (now more than 1 in 5 seniors express this).

Rates of anxiety, depression, and suicide are on the rise among young people.

Poor mental health outcomes and smartphone use are most strongly correlated in kids under the age of 14.

# **Suicide Prevention Month Can Save Lives**

**NORTHERN CALIFORNIA** (**MPG**) - September is Suicide Prevention Month, a time to raise awareness and discuss this urgently increasing crisis, according to NAMI (National Alliance on Mental Illness).

NAMI has somber statistics: suicide is the second leading cause of death among those aged 10 to 14, the third leading cause of death among those aged 15 to 24 and the 12th leading cause of death overall in the U.S.

Or, as the U.S. Department of Health and Human Services reports, more than 49,000 people in the United States died by suicide in 2022. That's one death every 11 minutes.

And millions more experience suicidal thoughts.

Suicidal thoughts can affect anyone regardless of age, gender or background, according to the NAMI website at nami.org. While suicidal thoughts are common, however, they should not be considered normal and often indicate more serious issues.

Many events and activities promoting suicide prevention awareness will be held locally, regionally and nationally throughout September.

During Suicide Prevention Month, NAMI and numerous other mental health organizations stress that all of us can help prevent suicide by reaching out to those who need help.

The National Institute of Mental Health lists

five action steps to help someone having suicidal thoughts.

The first step is **Ask** "Are you thinking about suicide?" It's not an easy question to ask but it can help start a conversation.

The second step is **Be there**: Listening without judgment is key to learning what the person is thinking and feeling.

The third step is **Help keep them safe**: Reducing access to highly lethal items or places can help prevent suicide.

The fourth step is **Help them connect**: Connecting the person with the 988 Suicide & Crisis Lifeline (call or text 988) and other community resources can give them a safety net. You can also assist by reaching out to a trusted family member, friend, spiritual advisor or mental health professional.

The fifth National Institute of Mental Health step is **Follow up**:

Staying in touch with the person after they have experienced a crisis or been discharged from care can make a difference. Studies show that supportive, ongoing contact can play an important role in suicide prevention.

## How You Can Help

The advocacy groups say to educate yourself and others about suicide prevention by checking out the 988 Suicide & Crisis Lifeline at www.samhsa.gov/ find-help/988.

And visit the Suicide Prevention Resource Center at https://sprc.org. Each year, the resource center creates many ways to get involved in Suicide Prevention Awareness Month.

The U.S. Substance Abuse and Mental Health Services Administration invites residents throughout the country to participate in 988 Day on Sept. 8. 988 Day is a national initiative dedicated to raising awareness about the federal agency's 988 resource and emphasizing the importance of mental health and suicide prevention.

According to the 988 Suicide & Crisis Lifeline website at 988lifeline. org, "We can all help prevent suicide. The 988 Lifeline provides 24/7, free and confidential support for people in distress, prevention and crisis resources for you or your loved ones, and best practices for professionals in the United States."

The National Institute of Mental Health website at https://www. nimh.nih.gov lists warning signs that indicate someone might be considering suicide. During National Suicide Prevention Month, the institute reminds residents that warning signs include the following:

Talking about wanting to die or wanting to kill themselves, talking



about feeling empty or hopeless or having no reason to live, talking about feeling trapped or feeling that there are no solutions, feeling unbearable emotional or physical pain, talking about being a burden to others, withdrawing from family and friends, giving away important possessions, saying goodbye to friends and family, putting affairs in order, such as making a will, taking great risks that could lead to death, such as driving extremely fast, or talking or thinking about death often.

Other serious warning signs that someone might be at risk for attempting suicide include:

Displaying extreme mood swings, suddenly changing from very sad to very calm or happy, making a plan or looking for ways to kill themselves, such as searching for lethal methods online, stockpiling pills or buying a gun, talking about feeling great guilt or shame, using alcohol or drugs more often, acting anxious or agitated, changing eating or sleeping habits, and showing rage or talking about seeking revenge.

According to the National Institute of Mental Health, suicidal thoughts or actions are a sign of extreme distress and should not be ignored. If these warning signs apply to you or someone you know, the institute urges you to get help as soon as possible, particularly if the behavior is new or has recently increased.

Think about this. When you sell a piece of your ownership to people who are looking for a return, instead of caring about your dream, vou're creating the potential for a big mess. A lot of times, these folks will seem like silent partners-which is an oxymoron in small business. They might even present themselves that way in the beginning. But the truth is most people who've put money into your business won't keep silent. They're all going to have different opinions and ideas, and there's a strong possibility these are going to clash at some point with the vision you have for your company.

In short, I would not recommend a fledgling small business, even one that's doing well, to seek out investors. Period. Cash flow your growth, Trey. ## Aiming to Improve Ability to Measure How Much Water is Flowing

### California Department of Water **Resources News Release**

SACRAMENTO, CA (MPG) - On Aug. 15, the Department of Water Resources (DWR) announced a new partnership opportunity to support the state's ability to measure stream and river flows through the California Stream Gage Improvement Program (CalSIP) as climate extremes continue to impact the state's water supply.

As part of the approximately \$7 million program, the Department of Water Resources is seeking to partner with public agencies to install, upgrade and/or reactivate existing stream gage stations. This effort will expand California's ability to access critical data that can inform important water management decisions during both flood and drought conditions.

"California can't manage what we don't measure. Expanding our network of gages in rivers and streams helps us all make better decisions about managing our precious water supply while protecting vulnerable communities from flooding and drought," said Department of Water Resources Director Karla Nemeth.

"It also benefits our natural environment, improving our understanding of the needs of salmon and other native fish especially during drought conditions."

A stream gage is a set of instruments installed along a river or stream that measures, records, and transmits data on flow, water temperature, and dissolved oxygen levels. Water agencies and the public rely on the essential information these gages provide for multiple purposes including planning, forecasting, and warning about floods and drought conditions; managing and informing reservoir operations; monitoring environmental conditions to protect aquatic habitats; planning for safe and enjoyable recreational activities; assessing groundwater and surface water interaction and monitoring stream flow impacts due to long-term changes in weather patterns

While there are approximately 1,000 active stream gages across the state sharing information publicly, many watersheds lack vital information on their surface water resources. Users of this data include emergency responders, water managers, environmental and transportation agencies, universities, utilities, recreators, researchers, and Tribes.

"Filling gaps in our stream gage network is essential for protecting life and property from flooding, improving water supply forecasting now and into the future amidst an ever-changing climate, and enhancing recreational opportunities like rafting and fishing," said Teresa Connor, the California Stream Gage Improvement Program manager with the Department of Water Resources.

The Department of Water Resources is now accepting interest forms which will be reviewed and evaluated monthly to identify eligible projects through Dec. 31. The funding will allow approved entities to purchase and install stream gage equipment as well as operate and maintain stations through June 30, 2027. Local entities will need to operate and maintain the gage and can elect to perform the operations either with staff or hire an experienced consultant to perform the installation and operations of the gage if the operation is consistent with industry standards.

Real-time stream data transmitted from these gages will then be publicly shared on the California Data Exchange Center website. Applicants are encouraged to apply as soon as possible. Additional information on eligible agencies, how to apply, and application deadlines can be found in the program guidelines.

This work is funded by the Budget Act of 2023 and is part of a larger effort authorized by Senate Bill 19 to address gaging information gaps in coordination with the State Water Resources Control Board, the California Department of Fish & Wildlife, and the California Department of Conservation.



## **Social Security Matters** For Advice on When to Claim Social Security

Dear Rusty: I could use some advice on whether or not I should start collecting my Social Security benefits now. I am 67 and 3 months old, and plan to continue working for at least for the next year or two. Signed: Seeking Answers

Dear Seeking: Deciding when to claim Social Security is, indeed, an important decision, as it will affect you for the rest of your life. Mainly, deciding when to claim your SS retirement benefit should consider your financial needs, but your life expectancy and marital status are equally important.

At your current age (past your full retirement age of 66 years & six months) you are already earning Delayed Retirement Credits (DRCs) at the rate of .677% higher benefit for each month you continue to delay. That adds up to an additional 8% benefit for each full year you

to claim, and that growth will continue until you are 70 years old. At that point, vour benefit will be 28% higher than it would have been at your full retirement age (FRA). If you expect to achieve about "average" life expectancy (about 84 for a man your current age), then waiting until 70 to claim will get you both a higher monthly amount and the most you can get in cumulative lifetime benefits. Waiting, however, only makes sense if you expect at least average longevity. If your health is poor and you have reason to believe you won't live to the "average," then claiming earlier makes more sense. FYI, you may find this tool helpful to determine your potential life expectancy: https://socialsecurityreport. org/tools/life-expectancy-calculator/.

You can, of course, simply delay claiming for as long as you are still working, and then file for benefits at that time. When your paychecks stop is frequently the best time to start your SS benefits (to supplement the lost work income). And, if you are married and your wife will be entitled to a survivor benefit from you, then waiting longer to claim enhances the benefit your surviving spouse receives at your death (your surviving spouse would get your benefit amount, instead of her own smaller amount). If that is a consideration, then waiting - at least until you stop working (or age 70 if feasible) is often a prudent choice.

So, the choice is yours to make, considering your financial needs, life expectancy, and marital status. You no longer need to worry about Social Security's annual earnings test (for those collecting benefits before their FRA) but, if it is financially feasible, waiting still longer will mean a higher monthly benefit for the rest of vour life.

## SB 549 Heats Up

### **Elevate Public Affairs News Release**

SACRAMENTO REGION, CA (MPG) - The California Gaming Association, California Cardroom Alliance and Communities for California Cardrooms announce growing opposition with many labor unions joining in opposition to Senate Bill 549 by Senator Josh Newman as it could have a "devastating impact on public sector jobs."

Joining in opposition to SB 549 includes the American Federation of State, County and Municipal Employees (AFSCME), California Professional Firefighters, and SEIU California and Teamsters Local 630 as well as a growing number of locals such as AFSCME District Council 36, **AFSCME District Council 57, AFSCME** Local 101, International Union of Painters and Allied Trades DC 36, Los Angeles County Firefighters Local 1014 and the Los Angeles County Professional Peace Officers Association.

They join a growing number of cities that have filed letters in opposition including California Contract Cities Association, California Cities for Self-Reliance Joint Powers Authority, California Cities Gaming Authority, City of Bell Gardens, Town of Colma, City of Chula Vista, City of Citrus Heights, City of Commerce, City of Compton, City of Emeryville, City of Gardena, City of Hawaiian Gardens, City of Inglewood, City of Oceanside, City of San Jose and City of Tracy.

SB 549 will create a PAGA-like law for gaming tribes to be able to sue their competitors – the cardrooms. This would usurp state regulators and the Attorney General which oversee the legality and permissibility of cardroom games. It would also permit for the first time ever a one-sided injustice as cardrooms would not be allowed to sue tribal casinos. The joint letter opposing SB 549 by these labor unions state: "SB 549 Could Have a Devastating Impact on Public Sector Jobs: SB 549 is an attack on local cardrooms, which are a significant source of revenue for general funds in many cities across California... Many have revenue sharing agreements with municipalities providing a significant amount of funding for essential public services like police, fire, parks and recreation, etc. The measure could easily force cardrooms out of business and result in a loss of \$500 million in tax revenue statewide — meaning less revenue for public safety, public health, homelessness services and infrastructure.

The loss of local tax revenue could spell devastation for many cities across California. For example, approximately 78% of the City of Hawaiian Gardens' general fund comes from cardroom revenues. Similarly, 50% of the City of Commerce's general fund comes from cardroom revenues. Larger cities like San Jose and Fresno would also be seriously impacted. This bill will destabilize essential services.

If signed into law, cities who depend on this revenue stream could be forced into municipal bankruptcy or even disincorporation. This could have potentially devastating impacts that puts jobs, pensions and the financial wellbeing of working families at risk. We have seen this happen before: the Orange County Bankruptcy."

"SB 549 Puts Workers in the Middle: The mere cost of litigation alone could lead to lower wages, loss of jobs or cardroom closures. And cardroom closures could devastate some cities who may have to file for municipal bankruptcy or disincorporate."

The document then outlines a list of six urgent priorities that require immediate attention to create a livable, lovable downtown, before concluding with a Livability Strategy is published following a slew of headlines and comments over the last year on housing and building conversions. U.C. Berkley's Terner Center for Housing Innovation recently published a research and policy piece on construction defect liability law and slowing California condo development.

"Amongst the many successes downtown Sacramento must be, it must also be a great urban neighborhood with a lot more housing," said Brent Toderian, co-author of the Downtown Sacramento Livability Strategy and previous State of Downtown speaker.

"This strategy won't sit on a shelf collecting dust, because Sacramento leaders and downtown champions can't let it. It's been crafted

call-to-action for elected and community leaders to take action on the items listed.

"The Downtown Sacramento Livability Strategy reinforces the significant progress being made at the local level and serves as a call to action for additional measures to address both the supply and demand sides of the urban neighborhood continuum," said Scott Ford, Deputy Director with Downtown Sacramento Partnership.

## Fast Food Workers Got a \$20 Minimum Wage, **But Is It Working? It's Debatable**

Every session of the California Legislature seems to produce at least one bill that generates high-octane political debate and media attention.

As the 2023-24 session winds down this week, Senate Bill 1047, which would impose rules on artificial intelligence developers, is generating fierce lobbying and drawing global interest.

During the final days of last year's session, the focus was on a very different issue — whether the state should impose a \$20-per-hour minimum wage for fast food workers and create a Fast Food Council to oversee working conditions.

A year before, Assembly Bill 257 created the council and empowered it to set an initial minimum wage of at least \$22 an hour, while assuming that franchised fast food outlets were subsidiaries of the parent company, rather than independently owned.

The fast food industry responded with a referendum that, if ratified by voters, would cancel out the new law, thus renewing the debate in the 2023 session. A last-minute deal repealed AB 257 and substituted another measure, AB 1228, that dictated a \$20 minimum wage and removed what the industry considered to be a threat to the franchise system. In return, the referendum was dropped.

The \$20 wage took effect last April, but only after a new squabble erupted over which sellers of food would be covered, colored by a Bloomberg article alleging that Newsom had demanded an exemption to benefit a campaign donor who owns two dozen Panera locations in California.

Newsom declared that the story was "absurd" and gave assurances that Panera and other similar businesses would be covered. The businessman, billionaire Greg Flynn, also said he would honor the \$20 wage.

End of fast food angst? Of course not.

Six months after the \$20 wage took effect there's a new debate in political, media and academic circles over its impact.

Fast food prices have been increasing, but how much higher wages are driving the rise and how fast food operations have changed are two new issues.

This month, Newsom declared that California fast food outlets had created 11,000 new jobs since the law was signed.

"What's good for workers is good for business, and as California's fast food industry continues booming every single month our workers are finally getting the pay they deserve," Newsom said. "Despite those who pedaled lies about how this would doom the industry, California's economy and workers are again proving them wrong."

The industry didn't agree. "Every day you see headlines of restaurant closures, employee job losses and hours cut, and rising food

prices for consumers," the International Franchise Association said in a statement. "Local restaurant owners in California are already struggling to cope with the \$20/hour wage, as the Fast Food Council considers additional wage increases. All the while, workers and consumers are feeling the pinch."

Brooke Armour, president of the California Center for Jobs and the Economy, an adjunct of the Business Roundtable, criticized Newsom's declaration as reflecting just one month of preliminary data and concluding, "Despite what some are saying, the data are clear: newly passed fast food minimum wage laws are leading to job losses in California."

Christopher Thornberg, founding partner of Beacon Economics, also was critical in an analysis of the state's economic trends. "California's well-intended push to reduce income inequality via wage floors is beginning to have a significant negative impact on some of our most vulnerable workers — our youth, particularly those from lower income households," Thornberg wrote.

What California has wrought in the fast food industry could be the harbinger of more direct regulation of other industries, and not just in California, for better or worse. It's not surprising, therefore, that its effects will be debated ad nauseam.







# **Teaching Kindness, Character Through Flag Football**

**SACRAMENTO REGION, CA (MPG)** - The Playmakers organization is a nonprofit that works with local youth to build character through free sports programs throughout the year.

By promoting kindness and social inclusion, Playmakers supports all youth and their families, with a particular focus on those with developmental differences and special needs. This year, for the first time, Playmakers founder Greg Roeszler (known as Coach Roz) is excited to announce an NFL FLAG football league for local youth.

The eight-game season will kick off on Sept. 28, running from 9 a.m. to 1 p.m. for eight consecutive Saturdays. The league will play at Mesa Verde High School's new state-of-the-art stadium at 7501 Carriage Drive in Citrus Heights. Each day will begin with athletic practice and skills development, followed by a flag football game. The league will split into two groups, one for youth between the ages of 6 and 14, and the other with a more flexible age range for youth with special needs.

The coaches are volunteer student athletes from local high schools, Mesa Verde and San Juan. These two rival schools will be "working together under the Playmakers' umbrella on character building and inclusiveness," Coach Roeszler said.

"There are a lot of families that can't afford the fees to play flag football" or other organized sports, the coach said, which is why Playmakers programs are always completely free to kids and their families. The funding for this NFL FLAG football league comes from The Optimists of Country Club, a local civic group based out of Citrus Heights, and Verde Design, which built the new stadium at Mesa Verde.

Playmakers is facilitating the league, with Roeszler running the program and providing coaching training and inclusivity awareness to the student athletes.

Roeszler acknowledged the dedication of "two unbelievable volunteers who pulled this together," Rick Johnson and Jim Szymanski, who worked so quickly to implement this new league: negotiating with the NFL for official inclusion as an NFL FLAG football league region (with all the associated uniforms, equipment, and gear), working with the San Juan Unified School District to secure the stadium location, and coordinating with the high schools to recruit student volunteers.

"The fact that rival schools are working together for inclusiveness and character building is amazing. The administration is so supportive, and it can change the culture of a campus," Roeszler said, "and our NFL players are extremely pleased that this is being done at the grassroots level."

He added that it was "incredible and so encouraging" to have local civic groups getting involved, because it is so important to provide opportunities for all kids to enjoy the benefits of sports and athletics, while having fun, learning to kind to each other, and striving to be the best they can be."

# California's Water Workforce Is Aging, Promoting The Next Generation of Workers Is Essential

A career building and maintaining California's water and wastewater treatment systems may be unglamorous, failing to spring to mind — at least it did for me — when young people contemplate their future careers.

However, the state faces a looming shortage of workers in these critical roles. It is imperative to support local, state and federal policies that help fill them.

Some 17 million workers will be retiring from infrastructure jobs during the next 10 years, taking their skills and institutional knowledge with them, as the workforce ages. According to a US Water Alliance report, approximately one-third of water utility operators are eligible to retire during the next decade. In 2018, Brookings projected that water utilities must fill 9,200 water treatment positions annually.

While President Biden and Congress agreed to spend \$1 trillion on thousands of infrastructure projects, including \$50 billion alone on water resilience projects in the West, California needs to ensure that there are enough workers equipped with the knowhow and sweat equity to build and

operate these projects.

These are jobs that get your hands dirty. It's work that makes a difference. It typically requires less formal education than many other jobs, but can offer a lifelong career, good pay and solid opportunities for advancement.

Infrastructure work pays 30% more to lower-income workers and those just starting their careers, relative to all jobs nationally.

I got my own start after high school by joining my brother's remodeling business — kitchens, bathrooms and the like — in San Jose, where I grew up. But a friend in Sacramento stumbled into wastewater collections for Sacramento County and encouraged me to visit his plant. There I discovered the range of jobs available: electricians, control technicians and treatment and distribution operators.

Even though I pursued online specialty courses, it took a few years for my first job in the water industry to come together.

My work requires lots of on-the-job training, but all of it is teachable and learnable. Once hired, workers can bid through labor unions for other available positions they're qualified for. Even if they decide to go elsewhere, they'll leave the department knowing how a water distribution system works.

I have noticed that more attention is being paid these days to proactively recruit water industry workers, helping them understand the training and skills needed to grow in the industry. Last fall, I even told my story to a joint session of the California Public Utilities Commission and the California Workforce Development Board, as the state seeks to widen doors to infrastructure jobs, especially for disadvantaged workers.

When I entered this field, serendipity was my guide. Today, there are resources such as the EPA report "Making Water a Career of Choice," with case studies of utility-worker pathways to encourage more people to consider working in water systems. In the years ahead, tens of thousands more workers will be needed to meet California's water delivery and other infrastructure needs, and more effort required to attract new talent into this crucial industry.

While work in the water industry may seem obscure, it is rewarding, meaningful and essential for the wellbeing of communities throughout our state. Promoting community college, state university, private sector and state and federal programs designed to inspire and train the next generation of water infrastructure leaders is vital for California's future.

Encouraging more young people to enter this career field will not only help California meet its mushrooming needs, but will provide important, well-paying work for those who don't mind rolling up their sleeves to keep California's water pipelines flowing.
