CITRUS HEIGHTS, CA (MPG) -The historic Rusch Home and Gardens in Citrus Heights is the site for the Sept. 14 annual Battle of the Bands and BBQs event to raise funds to assist American Legion Post 637, which provides emergency assistance to veterans in need throughout the year.

The Citrus Heights Community Marching Band will also receive funds from the event as they partner with the American Legion post to raise the funds for local veterans, some of whom are homeless.

637Commander Charles Stone said that "the purpose of the event is to raise funds to assist veterans

in our community while providing a fun and entertaining way to honor those who have served/are

serving, while remembering those we have lost."

Activities during the day will be both poignant and entertaining.

The Sept. 14 event begins at 11:15 a.m. with a Ghost Soldier Ceremony honoring Marine Sgt. Nichole L. Gee from Roseville, who was killed in action at age 23 while supporting the withdrawal from Afghanistan in August 2021.

Four local bands and seven local barbecue competitors are donating their time and talents for a day of music and good food, while battling for the best in their category.

The Agents of Discovery app is available to park visitors, free of charge. While in participating parks, users will be encouraged to explore new areas to find "challenges" that will... well, challenge their knowledge of the parks.

"Our team has been diligently creating engaging challenges to ensure that visitors have an enjoyable and educational experience," said Liz Bellas, director of Regional Parks. "Agents of Discovery will provide valuable insights about our local parks and open spaces, showcasing the many benefits of parks and recreation for people of all ages."

If you've ever played games such as Pokémon GO or Harry Potter Wizards Unite, you're likely familiar with augmented reality. This technology combines visuals and audio from the game with the user's actual environment in real-time.

When users enter the active park area, they will begin receiving tips through the app that will help them find and complete the challenges.

Helping many veterans, American Legion Post Post 637 members asked longtime supporter Frost for her ideas on how to raise funds to continue reaching out to even more veterans needing help at different times in their lives.

The first Battle of the Bands and BBQs was in 2016.

The concept of having a fundraiser to provide funds while allowing the community to be a part of the process has received strong support from businesses and individuals. All proceeds will go to the Vets Helping Vets Fund and the Citrus Heights Community Marching Band.

The Battle of the Bands and BBQs will be from 10:30 a.m. to 3 p.m. Sept. 14 at Rusch Home and Gardens, 7301 Antelope Road. Tickets will be available at the door.

Suicide Prevention Month Can Save Lives

NORTHERN CALIFORNIA (MPG) - September is Suicide Prevention Month, a time to raise awareness and discuss this urgently increasing crisis, according to NAMI (National Alliance on Mental

NAMI has somber statistics: suicide is the second leading cause of death among those aged 10 to 14, the third leading cause of death among those aged 15 to 24 and the 12th leading cause of death overall in the U.S.

Or, as the U.S. Department of Health and Human Services reports, more than 49,000 people in the United States died by suicide in 2022. That's one death every 11 minutes.

And millions more experience suicidal thoughts.

Suicidal thoughts can affect anyone regardless of age, gender or background, according to the NAMI website at nami.org. While suicidal thoughts are common, however, they should not be considered normal and often indicate more serious issues.

Many events and activities promoting suicide prevention awareness will be held locally, regionally and nationally throughout September.

During Suicide Prevention Month, NAMI and numerous other mental health organizations stress that all of us can help prevent suicide by reaching out to those who need help.

The National Institute of Mental Health lists five action steps to help someone having suicidal thoughts.

The first step is **Ask** "Are you thinking about suicide?" It's not an easy question to ask but it can help start a conversation.

The second step is Be there: Listening without judgment is key to learning what the person is thinking and feeling.

The third step is Help keep them safe: Reducing access to highly lethal items or places can help prevent suicide.

The fourth step is Help them connect: Connecting the person with the 988 Suicide & Crisis Lifeline (call or text 988) and other community resources can give them a safety net. You can also assist by reaching out to a trusted family member, friend, spiritual advisor or mental health professional.

The fifth National Institute of Mental Health step is Follow up: Staying in touch with the person after they have experienced a crisis or been discharged from care can make a difference. Studies show that supportive, ongoing contact can play an important role in suicide prevention.

The advocacy groups say to educate yourself and others about suicide prevention by checking out the 988

And visit the Suicide Prevention Resource Center at https://sprc.org. Each year, the resource center creates many ways to get involved in Suicide Prevention Awareness Month.

The U.S. Substance Abuse and Mental Health Services Administration invites residents throughout the country to participate in 988 Day on Sept. 8. 988 Day is a national initiative dedicated to raising awareness about the federal agency's 988 resource and emphasizing the importance of mental health and suicide prevention.

According to the 988 Suicide & Crisis Lifeline website at 988lifeline. org, "We can all help prevent suicide. The 988 Lifeline provides 24/7, free and confidential support for people in distress, prevention and crisis resources for you or your loved ones, and best practices for professionals in the United States."

The National Institute of Mental Health website at https://www.nimh. nih.gov lists warning signs that indicate someone might be considering suicide. During National Suicide Prevention Month, the institute reminds residents that warning signs include the following:

Talking about wanting to die or wanting to kill themselves, talking about feeling empty or hopeless or having no reason to live, talking about feeling trapped or feeling that there are no solutions, feeling unbearable emotional or physical pain, talking about being a burden to others, withdrawing from family and friends, giving away important possessions, saying goodbye to friends and family, putting affairs in order, such as making a will, taking great risks that could lead to death, such as driving extremely fast, or talking or thinking about death often.

Other serious warning signs that someone might be at risk for attempting suicide include:

Displaying extreme mood swings, suddenly changing from very sad to very calm or happy, making a plan or looking for ways to kill themselves, such as searching for lethal methods online, stockpiling pills or buying a gun, talking about feeling great guilt or shame, using alcohol or drugs more often, acting anxious or agitated, changing eating or sleeping habits, and showing rage or talking about seeking revenge.

According to the National Institute of Mental Health, suicidal thoughts or actions are a sign of extreme distress and should not be ignored. If these warning signs apply to you or someone you know, the institute urges you to get help as soon as possible, particularly if the behavior is new or has recently

SACRAMENTO REGION, CA (MPG) - The Playmakers organization is a nonprofit that works with local youth to build character through free sports programs throughou the year.

By promoting kindness and social inclusion, Playmakers supports all youth and their families, with a particular focus on those with developmental differences and special needs. This year, for the first time, Playmakers founder Greg Roeszler (known as Coach Roz) is excited to announce an NFL FLAG football league for local youth.

The eight-game season will kick off on Sept. 28, running from 9 a.m. to 1 p.m. for eight consecutive Saturdays. The league will play at Mesa Verde High School's new state-of-the-art stadium at 7501 Carriage Drive in Citrus Heights. Each day will begin with athletic practice and skills development, followed by a flag football game. The league will split into two groups, one for youth between the ages of 6 and 14, and the other with a more flexible age range for youth with special needs.

The coaches are volunteer student athletes from local high schools, Mesa Verde and San Juan. These two rival schools will be "working together under the Playmakers' umbrella on character building and inclusiveness," Coach Roeszler said.

"There are a lot of families that can't afford the fees to play flag football" or other organized sports, the coach said, which is why Playmakers programs are always completely free

to kids and their families. The funding for this NFL FLAG football league comes from The Optimists of Country Club, a local civic group based out of Citrus Heights, and Verde Design, which built the new stadium at Mesa Verde.

Playmakers is facilitating the league, with Roeszler running the program and providing coaching training and inclusivity awareness to the student athletes.

Roeszler acknowledged the dedication of "two unbelievable volunteers who pulled this together," Rick Johnson and Jim Szymanski, who worked so quickly to implement this new league: negotiating with the NFL for official inclusion as an NFL FLAG football league region (with all the associated uniforms, equipment, and gear), working with the San Juan Unified School District to secure the stadium location,

and coordinating with the high schools to recruit student volunteers.

"The fact that rival

schools are working together for inclusiveness and character building is amazing. The administration is so supportive, and it can change the culture of a campus," Roeszler said, "and our NFL players are extremely pleased that this is being done at the grassroots level."

He added that it was "incredible and so encouraging" to have local civic groups getting involved, because it is so important to provide opportunities for all kids to enjoy the benefits of sports and athletics. while having fun, learning to kind to each other, and striving to be the best they can be."

Eagle Rescue Heroes Saluted

- Two professional tree climbers have been recognized for their heroism in rescuing a fallen bald eaglet last April.

Sacramento County Supervisor Rich Desmond last week presented resolutions to Placerville residents Kiover Lara and Gabriel Cuevas. The ceremony also saluted the career of Fair Oaks-based wildlife rescue specialist Ben Nuckolls, who supervised the mission that saved the three-week-old eaglet.

"It's just great that people like Kiover and Gabriel used their skills and courage to save our national bird from a situation that seemed like mission impossible," Desmond said. "And Ben Nuckolls is an incredible asset to the safety of wildlife on our American River Parkway."

Co-operating in the perilous rescue that made national news, the heroes gained brief celebrity. The foothills arborist company that employs Cuevas and Lara got a welcome business boost.

On April 27, climber Lara, 45, and 'ground man' partner Cuevas, 42, were enjoying a quiet Saturday off. Their boss, Mauro Rios, was doing godfather duties at a Quinceañera party. A nephew relayed a desperate call from a nest site observer: a bald eaglet known as Diecinueve (Spanish for 19) was dangling 100 feet up. The nest tree topped a ravine and firefighters deemed the terrain too steep and dangerous for ladders.

Sierra Pacific Tree Care owner Rios told his best climbers that an eagle needed rescuing.

"Kiover never says no," reported the boss. "He does anything we ask of him."

Rios OKed the use of company equipment and help was quickly dispatched.

Baby Diecinueve had alternated between frantic flapping and exhaustion for at least 10 hours

before the rescue. Supervising efforts, Nuckolls warned the climbers that they would be unpaid and must work at their own risk.

Lara responded that he had retrieved plenty of cats from trees but, he conceded, "Eagles, no." He and Cuevas scrambled

downhill to the tree base. Above, circling eagle parents shouted outrage.

"The leap on that tree worried

"The lean on that tree worried us," Lara said. "We were also concerned the mother eagle might come at us. We said a prayer and figured it would be all right."

With Cuevas manning safety ropes, up Lara scrambled. Hearts thumped below.

"We were all scared," admitted an onlooker. "Not just that Kiover might fall; the higher he climbed, the closer the baby's mama circled."

Lara quickly reached and untangled the three-pound bundle of feathers.

"He was bigger than I thought," he recalled. "He felt soft and fluffy, like a stuffed toy. He looked at me bravely. I told him: you'll be OK, baby."

With precious cargo, descent was slower. When climbers and a cage appeared over the canyon ridge, firefighters cheered. Volunteers blinked back tears.

In minutes, Nuckolls and fellow rescuer Leslie Ackerman spirited the dehydrated eaglet to Gold Country Wildlife Rescue in Auburn. This facility operates in conjunction with the Lincolnbased Bird of Prey Health Group.

Diecinueve was given fluids and anti-inflammatory medication. Otherwise undamaged, Diecinueve was later moved for rehab at Lake Tahoe Wildlife Care in South Lake Tahoe. When fully grown, his release would be managed by this agency.

"My family and I love eagles. We were relieved the little guy was safe and would one day fly free. Supervisor Desmond's award makes us proud," said

climber Lara.

"I'm thankful that Kiover and Gabriel and other volunteers were on hand and we could all work together. Rescuing wildlife has always been my passion. Because this nest site is close to my home, I had an extra interest in the situation. Like many people, I'd watched this beautiful family for years. I felt a special responsibility

to help them," added rescue specialist Nuckolls.

Social Security Matters *For Advice on When to Claim*

For Advice on When to Claim Social Security

Dear Rusty: I could use some advice on whether or not I should start collecting my Social Security benefits now. I am 67 and 3 months old, and plan to continue working for at least for the next year or two. **Signed: Seeking Answers**

Dear Seeking: Deciding when to claim Social Security is, indeed, an important decision, as it will affect you for the rest of your life. Mainly, deciding when to claim your SS retirement benefit should consider your financial needs, but your life expectancy and marital status are equally important.

At your current age (past your full retirement age of 66 years & six months) you are already earning Delayed Retirement Credits (DRCs) at the rate of .677% higher benefit for each month you continue to delay. That adds up to an additional 8% benefit for each full year you

wait beyond your FRA to claim, and that growth will continue until you are 70 years old. At that point, your benefit will be 28% higher than it would have been at your full retirement age (FRA). If you expect to achieve about "average" life expectancy (about 84 for a man your current age), then waiting until 70 to claim will get you both a higher monthly amount and the most you can get in cumulative lifetime benefits. Waiting, however, only makes sense if you expect at least average longevity. If your health is poor and you have reason to believe you won't live to the "average," then claiming earlier makes more sense. FYI, you may find this tool helpful to determine your potential life expectancy: https://socialsecurityreport. org/tools/life-expectancy-calculator/.

You can, of course, simply delay claiming for as long as you are still working, and then file for benefits at that time. When your paychecks stop is frequently the best time to start your SS benefits (to supplement the lost work income). And, if you are married and your wife will be entitled to a survivor benefit from you, then waiting longer to claim enhances the benefit your surviving spouse receives

at your death (your surviving spouse would get your benefit amount, instead of her own smaller amount). If that is a consideration, then waiting – at least until you stop working (or age 70 if feasible) is often a prudent choice.

So, the choice is yours to make, considering your financial needs, life expectancy, and marital status. You no longer need to worry about Social Security's annual earnings test (for those collecting benefits before their FRA) but, if it is financially feasible, waiting still longer will mean a higher monthly benefit for the rest of your life.

Fast Food Workers Got a \$20 Minimum Wage, But Is It Working? It's Debatable

Every session of the California Legislature seems to produce at least one bill that generates high-octane political debate and media attention.

As the 2023-24 session winds down this week, Senate Bill 1047, which would impose rules on artificial intelligence developers, is generating fierce lobbying and drawing global interest.

During the final days of last year's session, the focus was on a very different issue whether the state should impose a \$20-per-hour minimum wage for fast food workers and create a Fast Food Council to oversee working conditions.

A year before, Assembly Bill 257 created the council and empowered it to set an initial minimum wage of at least \$22 an hour, while assuming that franchised fast food outlets were subsidiaries of the parent company, rather than independently owned.

The fast food industry responded with a referendum that, if ratified by voters, would cancel out the new law, thus renewing the debate in the 2023 session. A last-minute deal repealed AB 257 and substituted another measure, AB 1228, that dictated a \$20 minimum wage and removed what the industry considered to be a threat to the franchise system. In return, the referendum was dropped.

The \$20 wage took effect last April, but only after a new squabble erupted over which sellers of food would be covered, colored by a Bloomberg article alleging that Newsom had demanded an exemption to benefit a campaign donor who owns two dozen Panera locations in California.

Newsom declared that the story was "absurd" and gave assurances that Panera and other similar businesses would be covered. The businessman, billionaire Greg Flynn, also said he would honor the \$20 wage.

End of fast food angst? Of course not.

Six months after the \$20 wage took effect there's a new debate in political, media and academic circles over its impact.

Fast food prices have been increasing, but how much higher wages are driving the rise and how fast food operations have changed are two new issues.

This month, Newsom declared that California fast food outlets had created 11,000 new jobs since the law was signed.

"What's good for workers is good for business, and as California's fast food industry continues booming every single month our workers are finally getting the pay they deserve," Newsom said. "Despite those who pedaled lies about how this would doom the industry, California's economy and workers are again proving them wrong.'

The industry didn't agree. "Every day you see headlines of restaurant closures, employee job losses and hours cut, and rising food prices for consumers," the International Franchise Association said in a statement. "Local restaurant owners in California are already struggling to cope with the \$20/hour wage, as the Fast Food Council considers additional wage increases. All the while, workers and consumers are feeling the pinch."


Brooke Armour, president of the California Center for Jobs and the Economy, an adjunct of the Business Roundtable, criticized Newsom's declaration as reflecting just one month of preliminary data and concluding, "Despite what some are saying, the data are clear: newly passed fast food minimum wage laws are leading to job losses in California."

Christopher Thornberg, founding partner of Beacon Economics, also was critical in an analysis of the state's economic trends. "California's well-intended push to reduce income inequality via wage floors is beginning to have a significant negative impact on some of our most vulnerable workers — our youth, particularly those from lower income households," Thornberg wrote.

What California has wrought in the fast food industry could be the harbinger of more direct regulation of other industries, and not just in California, for better or worse. It's not surprising, therefore, that its effects will be debated ad nauseam.

Labor Day Reading Needn't be Laborious



Early September, just after Labor day, I share my annual book recommendations as well as shamelessly plug my own four books. So if you read only one book this year, read all four of mine.

But after that, please read "The Kingdom, the Power, and the Glory: American Evangelicals in an Age of Extremism" by Tim Alberta. (Harper Books, 2024.)

The title may sound a bit like a political argument, but it recounts the heartfelt struggle by a journalist who suddenly loses his beloved pastor dad. He's honored to preach his father's funeral, but he's soon lambasted by family friends for his journalistic coverage of the political machinery that has crept into the church.

The situation sends Alberta on a journey to understand the tension between his professional responsibilities as a journalist and his deeply personal, conservative, Christian faith.

The book's main strength is Alberta's storytelling. Each chapter employs biblical insight and shares stories of everyday pastors who struggle to understand their role in contemporary politics.

Spoiler alert: Alberta deeply believes that God calls his followers to obey Jesus, not politicians. His conclusions are so biblically-based that I read the last chapter aloud as my sermon a few months back.

Also mentioned in some of my past sermons is the book "An Immense World," by Pulitzer Prize-winning science journalist, Ed

The book challenged my human-centric perspective, the tendency to limit my views to only what I personally can make out with my own eyes.

Yong bases his book on the Umwelt Concept, a theory that differentiates how creatures perceive their environs in ways that are often unimaginable to humans.

For example, bats use echolocation to navigate in complete darkness, while certain fish can detect electric fields in the water. These abilities demonstrate the vast diversity of sensory experiences across the animal kingdom.

By simplifying complex scientific concepts, Yong makes them understandable for readers of all backgrounds. Anecdotes and interviews with researchers bring the science to life, highlighting the astonishing diversity of perception in the animal kingdom. Whether you're a science enthusiast or

simply curious about the natural world, "An Immense World" is a must-read that will leave you marveling at the unseen wonders The next book on my list, "The Demon of

Unrest," by Erik Larson, may evoke images of the Jan. 6 attack on the nation's capital and those who sought to circumvent the certification of the electoral college.

Well, not quite. But almost.

This insurrection began 164 years ago, November 6, 1860, after congress peacefully certified the election results for Abraham

Drawing on diaries, secret communiques, slave ledgers and plantation records, the book focuses on a lonely federal fortress in Charleston Harbor: Fort Sumter.

The fort becomes a helpless pawn, as South Carolina leads one state after another to secede from the Union. Within six months of the election, the Confederacy opens the Civil War by shelling the U.S. garrison of Fort Sumter on April 12, 1861.

At the heart of this battle is Major Robert Anderson, Sumter's commander and a former slave owner sympathetic to the South but loyal to the Union. In the middle of it all, the overwhelmed

Lincoln must deal with his double-dealing Secretary of State, William Seward, as he tries to avoid a war that will eventually kill 750,000 Americans. Erik Larson's sharp prose and keen

insights have caused me to read all his books. But "Demons of Unrest" is a definite read for anyone interested in how history can repeat itself.

After reading these, I hope you'll consider reading one of my books: "Tell it to the Chaplain," "Thriving Beyond Surviving," "Hero's Highway" and "No Small Miracles."

Finally, if you happen to be the romantic type, check out Davalynn Spencer's books. This award-winning Christian romance writer has edited my column for 15 years and is clearly a good judge of great writing.

Phone-Free Schools Act Clears Legislature, Heads for Signature

SACRAMENTO, CA (MPG) - On Aug. 29, the Legislature passed landmark legislation authored by Assemblymembers Josh Hoover (R-Folsom), Al Muratsuchi (D-Torrance), Josh Lowenthal (D-Long Beach), and David Alvarez (D-San Diego) to limit the use of smartphones in schools. Assembly Bill 3216, also known as the Phone-Free Schools Act, requires school districts in California to adopt a policy no later than July 1, 2026, that limits or prohibits the use of smartphones by students during the school day.

"Today, the Legislature took

Assemblyman Josh Hoover. "As a parent and former school board member, I am incredibly grateful for this bipartisan effort to put kids first and improve their academic and mental health outcomes. I thank the Governor for his leadership on this issue and urge him to sign this bill to create phone-free schools across our state."

"Research continues to demonstrate the potential harms of smartphone use among children. The growing use of these devices in a child's everyday life can contribute to lower test scores, anxiety, depression, and even suicide. I am grateful for the Legislature's leadership on limiting the use of smartphones during the school day and I look forward to working with the Governor," Hoover added.

The bill now heads to Governor Gavin Newsom's desk for signature, who has signaled support for the legislation in recent weeks.

Many school districts have already limited or prohibited smartphone use in schools and have seen resounding success. Administrators have reported increased social interaction among peers, decreased instances of bullying on campus, and improvements in academic outcomes. A 2016 study found that when smartphones were removed from classrooms standardized test scores increased by an average of six percent, with even greater improvements among low achieving students. The Phone-Free Schools Act will continue to build on this success by expanding limitations on smartphones statewide.

A piece published in The Atlantic earlier this year by NYU social psychologist Jonathan Haidt described a number of the potential harms that smartphone use is contributing to in children:

Grades suffer when learning is disrupted as a result of smartphone distractions in the

Up to 15% of teenagers engage in "problematic social media use," which includes symptoms such as preoccupation, withdrawal symptoms, neglect of other areas of life, and lying to parents and friends about time spent on social media

The latest Gallup data found that American teenagers spend around five hours per day on social media platforms alone.

As smartphones have become ubiquitous since 2010, we have seen a 70% increase in the number of high school seniors expressing that "life often feels meaningless (now more than 1 in 5 seniors express this).

Rates of anxiety, depression, and suicide are on the rise among young people.

Poor mental health outcomes and smartphone use are most strongly correlated in kids under the age of 14.

But the truth is most people who've put money into your business won't keep silent. They're all going to have different opinions and ideas, and there's a strong possibility these are going to clash at some point with the vision you have for your company.

In short, I would not recommend a fledgling small business, even one that's doing well, to seek out investors. Period. Cash flow your growth, Trey. Cash flow your equipment purchases, and the markets you enter, also. Does this mean you might miss a good opportunity here and there? Sure, it does. But it also means you'll be missing opportunities to fail. Too much success too soon is one of the biggest reasons why small businesses shut down. When you grow too quickly, you run the risk of outgrowing your financial resources, your infrastructure and your human resources.

Do what you can to ensure growth is steady, but play it smart. Don't grow so fast that you crack the foundation of your company.

Planning Commission Approves Motions to Move Sayonara Habitat Project Forward

CITRUS HEIGHTS, CA (MPG) -

The Citrus Heights Planning Commission unanimously approved motions for a tentative subdivision map and its design review for the pending construction of 26 new half-plex housing units to be built by Habitat for Humanity of Sacramento on Sayonara Drive.

Chief city planner Alison Bermudez presented a project overview to Citrus Heights Planning Commission members. Habitat for Humanity of Greater Sacramento (HFHGS) President and CEO Leah Miller then answered additional questions voiced by the commission before it voted.

The Citrus Heights Planning Commission approved a motion to approve a tentative subdivision map to allow for the subdivision of the project area into 26 single-family homes based on the findings contained in the city's staff report and its attached conditions of approval. A Design Review Permit was also approved to allow for the project's construction subject to the city's Small Lot Housing Ordinance. Commissioners also adopted Resolution No. 24-06, finding that the project is categorically exempt per Section 15332 from the California Environmental Quality Act (CEQA) and from Section 15194 (Affordable Housing).

Construction of the 26 new units by Habitat for Humanity on 12 vacant city-owned lots in Citrus Heights, using CalHome funding, will meet the city's obligation to replace blighted rental units that were demolished between 2008 and 2010.

The Citrus Heights City



The Citrus Heights Planning Commission considered and unanimously approved motions for a tentative subdivision map and its design review for the pending construction of 26 new half-plex housing units to be built by Habitat for Humanity of Sacramento on Sayonara Drive. Council declared the property surplus in May 2022 and the state of California approved the surplus declaration in June 2022.

In all, there will be two two-bedroom/one-bathroom units (971 square feet), 12 threebedroom-two-bathroom units (1,214 square feet), 10 four-bedroom two-bathroom units (1,407 square feet) and two five-bedroom, two-bathroom units (1,523 square feet) built, according to project plans described by chief city planner Alison Bermudez.

The total approximate average cost for infrastructure and construction of each home is approximately \$330,000, according to Habitat for Humanity of Greater Sacramento.

Secured funds include an estimated \$1.9 million from the city of Citrus Heights and \$1,050,000 in federal Community Project Funding obtained with support from Congressman Ami Bera. Other Sayonara project funding will come from multiple sources,

including corporate sponsorships, individual giving and special events, Miller said in an earlier interview.

In a summary of the city's findings for design review approval, Bermudez told commission members that the project is "consistent with the city's General Plan and zoning code, complies with the design standards with appropriate landscape and offers an attractive and desirable site layout and safe and efficient access and circulation."

The new, for sale housing units, which will be built on their own parcel with a front yard and a private backyard, will be sold to qualifying low-income households that participate in Habita for Humanity's existing program that provides affordable home ownership opportunities, Miller

Labor is typically provided by volunteers who will help build the new homes (no experience is necessary); training and tools are provided by Habitat for Humanity when actual construction starts.

The all-elecn e w two-, three- and four-bedroom duet style homes feature drought-tolerant landscaping, energy- efficient heating systems, low-flow plumbing systems, security alarm systems, solar battery storage and rooftop solar panels. When completed, the project will provide housing for nearly 120 low-income individuals, including children.

Miller said construction will be done in three stages of eight to 10 units per stage, with each stage taking approximately a year to complete.

A "self-help" contributed labor component is also required, with each home-buyer household providing 500 hours of sweat equity in building their or their neighbor's homes, Miller added.

Lot site infrastructure improvements are scheduled to start this October and be finished by

March 2025. The application period for the 26 new single-family homes will start in April 2025. with a targeted completion by January 2027, over a period of 22 months, according to chief city planner Bermudez in her presentation.

Habitat for Humanity of Greater Sacramento also announced that it has received funding from the state department housing and community development to provide an owner-occupied rehabilitation program to low-income residents of Sacramento and Yolo counties, Miller said.

The city of Citrus Heights has referred five single-family and three mobile home low-income homeowners to Habitat for **Humanity of Greater Sacramento** to provide health and safety repairs.

"We're excited that due to our partnership with the city, HFHGS will be able to help eight Citrus Heights residents on its current home repair waitlist," Miller said.

The current waitlist includes 121 households in single family homes and 59 households in mobile homes, she added.

- The dedicated efforts of Sacramento County's Division of Behavioral Health Services (BHS), in partnership with community-based providers, continue to positively impact youth with High Fidelity Wraparound (HFW) Services. Zavion and Serenity are two inspiring teens whose stories exemplify how support services can positively change lives.

Think of Sacramento County's High Fidelity Wraparound Services, more commonly referred to as the Wraparound Program, as a personalized support system that helps kids and families when they are most vulnerable. It's a team of caring professionals who "wrap" around these youth and their families during tough times.

Whether it's to help foster youth or youth who have been involved with law enforcement, or providing a family with the tools they need to stay together, the Wraparound Program makes a real difference.

For Zavion, he faced more challenges than many could even imagine. He frequently encountered obstacles that left him feeling lost and uncertain about his future at a young age. With the help of the Wraparound Program, he found the strength to turn his

"You know, I've been through some really rough times, but I got through it by challenging myself," said Zavion with a sense of accomplishment while reflecting on his journey. "It's been rough, but I've accomplished something."

Zavion completed his high school credits, graduated and was recently offered an internship at a wellness center where

he now supports other young people in his community. This fall, he's preparing for a new milestone – starting community college.

Serenity's story is equally inspiring. She was initially referred to the Wraparound Program with significant challenges, including a difficult home environment and struggles with aggression but embraced the help offered to her. She quickly dove deep into therapy and learned new ways to cope, and her hard work paid off.

Serenity graduated from high school early and earned a scholarship to a college in Vermont. She has volunteered her time at a wellness center, traveled to Africa and is writing a book about her experiences to share with others who might be fac-

ing similar challenges.

"It is gratifying to watch these kids get the opportunity to change the trajectory of their futures," said Brian Olden, Wraparound Program Monitor for Sacramento County. "Zavion and Serenity illustrate the combined effort of clients who make good use of services, as well as the dedication, persistence, and hard work of the providers who steadfastly adhere to the HFW principles." Much of the success seen

with Sacramento County's High Fidelity Wraparound services comes from its focus on giving families a voice in their care, working collaboratively with other services and supporting children in stable, loving environments. To help keep kids from bouncing

around from home to home,

the Wraparound Program's pri-

mary objective is stability and

permanency, which reduces the need for group home placements and institutional care.

Sacramento County partners with, and funds contracts for, three local nonprofit agencies to provide High Fidelity Wraparound Services – River Oak Center for Children, Sacramento Children's Home and Stanford Sierra Youth and Families.

In addition to Probation and Child Welfare, Behavioral Health Services and wraparound provider agencies collaborate with various child-serving systems and individuals including schools, regional centers and health care providers.

Child Protective Services (CPS) and Sacramento

Probation departments refer

youth to the Wraparound

Program. With the referral,


Behavioral Health Services County staff coordinate the implementation of care and together all agencies work to ensure every child has a chance to thrive.

An estimated 90% of youth are referred by Child Protective Services and 10% by probation. Not all families and youth referred are ready to engage but the impact of Sacramento County's High Fidelity Wraparound Services remains clear. In the last quarter of Fiscal Year 2023 - 2024, 80% of the youth who completed the program were able to successfully move forward, ready to embrace a brighter future.
