

### **End of Year Parade Planning Continues**

**Green Light** for New **Traffic Signals**

YUBA CITY, CA (MPG) -Elected officials approved a little more than \$1 million in signal hardware upgrades, which are streetlights. On Aug. 20, Public Works and Development Services Director Ben Moody said that a California Local Highway Safety Improvement grant will fund the new 53-light citywide scheme. "This is actually a fun one for me," Moody said. "It is a visible project." The upgrades include enlarging the traffic light bulbs from eight to 12 inches, removing and replacing signal backplates to yellow, installing reflective tape around backplates and replacing existing street name signs with LED internally illuminated street name signs. While Yuba City will replace 35 lights, Caltrans will remove 18 and replace them with Type IX Street Name Signs made with diamond-grade reflective sheeting. "We are going to clean up the rest of the city with the bird and the logo, so they match," Moody said. "That's one of my bucket list items I have been trying to get across for a while, so I am looking forward to that." Before telling the project timeline, Moody said that each streetlight "is a little bit different but it's really putting that reflective tape and fixing the illuminated street name signs. "We are looking to advertise in September, contract award in October, construction begins in the fall through the winter, Continued on page 5

YUBA CITY, CA (MPG) - Imagine the entire population of Roseville descending here for an event.

That is the magnitude of the 2024 Nagar Kirtan Sikh Parade, according to Fire Chief Jesse Alexander.

Mayor Shon Harris called Nov. 2 through 4 the "most major event in the entire city" on Aug. 20. The mayor said he and Vice Mayor David Shaw continue to meet with a local temple president for the upcoming event, which is so big it requires an ad hoc committee.

"We are very interested in your perspective and how things are going on your end," Harris said to both Police Chief Brian Baker and Fire Chief Jesse Alexander, who started off with the Roseville perspective

regarding planning and logistics for a massive population.

The event requires a special permit process with "very significant components that are outlined but still need to be added to the application," according to Alexander.

"That makes it challenging for us to complete the process," Alexander said.

Harris recalled giving Alexander a list but was unsure of the "specific items" requested; however, the mayor remembered the temple president saving the city was not meeting the suggested deadlines.

Alexander said there are 19 items on the list, with only one requirement met. Unmet deadlines include traffic, parking, shuttle plans, and security ancillary items, all due on Aug. 5.

Baker said law enforcement has

met with temple officials to contract for traffic patrol.

"They told us that they will have that plan within the next two weeks, so we are anxiously awaiting that so we can assure they have a safe parade route," Baker said, noting a large flood of vehicles will impact neighborhoods and businesses.

The police chief detailed city-controlled matters, which entails local-only parking from "Hooper Road west to Madison and then north of Butte House Road."

The local parking would have set hours from Friday through Sunday. That is why the city is implement-

ing a bus route. Buses only work well with a dedicated route, without stops for pedestrians or lights, according to Baker, who said it makes it an

### Administrative Hearing Sept. 6 to Decide Future of Hotel Marysville

MARYSVILLE, CA (MPG) - An administrative hearing that could determine the future of the Hotel Marysville has been scheduled for 9 a.m. Friday, Sept. 6 in the council chambers at Marysville City Hall.

The hearing is open to the public.

The owners of the five-story hotel have appealed the City of Marysville's notice of violation of the city's ordinance related to structures that are a public nuisance because they pose an imminent threat to the public.

Since the June 15 fire that ravaged the 100-year-old five-story structure, the City of Marysville has made multiple attempts to convince the property owners into address the building, which poses a threat of collapsing, according to two different engineering reports, and is riddled with friable asbestos.

A fenced security perimeter exists around the building, blocking the two northbound lanes of Highway 70 in front of the hotel and hampering normal operations for several businesses.

On Aug. 1, the City issued a Notice of Violation and Penalty Order, citing both the longtime neglect and the damage caused by the fire, and demanding the public nuisance be abated, either by shoring it up or demolishing it. The notice was issued *Continued on page 4*

inefficient mode of transportation for those traveling to the temple and parade.

"We are going to have a realistic approach to this," Baker said. "We are not going to be out there telling people they cannot pass if they are trying to get to their grandmother's 75th birthday party."

The police chief ended by saying the "significant event that benefits many facets of our community," the city is not alone in limiting access to neighborhoods, noting "they were very successful with this in Nappa with Bottle Rock."

Police will go door to door with information pamphlets and passes for residents affected by the procedure.

"That's the big takeaway, a little bit

different this year," Baker said.

Alexander had more to say regarding sanctioned parking.

"I am going to be blatantly honest: this event keeps me up all year long because there are best practices and industry standards, and people expect to show up to an event like this and be able to call 911, be able to be in a safe environment, be able to be picked up and transported to the hospital in a timely fashion," Alexander said. "I want to make sure we are meeting those conditions."

Vice Mayor Shaw called the event preparation this year a "learning experience," while officials sought to meet the August deadline, they are still "further along than they were, and I would rather take a little bit of a longer time and get it right."

### **Cordi Winery Celebrates 15 Years of Success**

**LIVE OAK, CA (MPG)** - "Family Farmed. Family Crafted," is Cordi Winery's motto.

From beginning to end, Reece and Teresa Cordi, along with daughters, Juleah and Emily, operate a "full production facility from vine to bottle and do it all by hand." After a friendly welcome, they gave a tour of their property and shared in the wine making process. They also showed off the beautifully refurbished tasting room, which is a mid-1900's bunkhouse that housed Hispanic workers at one time. They even placed their rustic style pavers one by one all by hand. It was refreshing to experience the Cordis utilizing the concept of 'vertical integration', where all production processes occur in-house.

In addition, the Cordis have played an integral part in helping neighboring vintners start their businesses. Owners of the Munger Family Vineyard and Sicilia Vineyards make mention of the Cordis.

Prior to becoming vintners, they were almond growers. That changed during a 2008 winter storm when they lost the majority of their crops to powerfully strong winds. Although catastrophic, they knew they had three important things: soil, climate, and aspiration. So, in the summer of 2009, they planted 300 Primitivo vines, and Sutter County's very first commercial winery was born. Now, one could argue that the 2008 storm was a tragedy; then again, it could have been divine intervention. A few

weeks ago, they celebrated their 15th anniversary.

What makes Cordi wines so unique?

Well, the Cordis specialize in 100% single varietal wines. Simply put: only one grape is used, which is on the label. They focus on the grapes' characteristics and take steps to keep the quality preserved. Located at the Sutter Buttes base, the soil is rich and loamy; and the sunny, warm days followed by cool evenings make it the perfect climate.

Added to the mix is the wildlife scenery. Just a few miles from Gray Lodge Wildlife Area, the wild animals and birds spill over into surrounding areas. Spectacular views of the Northern Sutter Buttes provide

the perfect backdrop to sit back, relax, and sip a glass of one of their award-winning 12 varietals in the vineyard, on the patio, or underneath the symbolic beauty of the winery's weeping willow.

Cordi Winery is open two weekends a month and is working on several upcoming events. They also offer a few wine club options and are carried at Yuba City's Bel Air, Raley's, and New Earth Market.

### **Brewfest Returns to Bryant Park on Saturday**

**YUBA CITY, CA (MPG)** - While last year's weather may have put a damper on things, organizers of the 11th annual Yuba-Sutter Brewfest are hoping to knock things out of the park this Saturday.

"We actually moved it two weeks up from last year to try and avoid the rain," said John Argyilan, a manager at Yuba City's Happy Viking. "So far, the forecast The competition Sargent is alluding to is called the Brewer's Cup, a segment of Brewfest billed as the only Beer Judge Certification Program (BJCP) event within the Yuba-Sutter area.

"It's a 100% sanctioned BJCP competition, the only one I want to say within 200 miles of our area," said Argyilan.

"This will be our second annual competition. The judges will rate them (the beers) and then we take the best in class from each style and put them all head-tohead against each other and vote one as the best overall beer. The winner takes home a huge trophy which will go back with them to their brewery for the year." The history of Brewfest goes back 11 years to its days at the Yuba Sutter Fairgrounds in Yuba City where it was held annually in March. It wasn't until last year that the group, now known as the Sutter Buttes Social Club, tried moving things to Bryant Park in Marysville, a venue which was also used for the 2022 Hoptober Festival - an unrelated forprofit event organized by Alma Festivals Entertainment, Inc. In contrast, the Sutter Buttes Social Club is a 501C3 organization whose mission is to improve the quality of life for underserved youth.

Argyilan serves as the event's designated "brew wrangler."

In total, 22 breweries will be represented at this year's festivities including some of California's top-rated brands such as Sierra Nevada, Firestone Walker Brewing Company and Belching Beaver.

"We're bringing in some of the best breweries throughout the state, and even a couple from Oregon," added Argyilan.

With a nod to keeping things local, this year's featured brewery will be none other than the Sutter Buttes Brewing of Yuba City.

Scott Sargent, the brewery's owner, said he looks forward to greeting everyone at the gate and having the privilege of giving them their first pour.

"I think our beers stand up to just about anybody's," said Sargent. "And I'm excited about being up there with some of the best beers in California and going head-to-head with them to see what people think."

In fact, the entire Brewfest event is volunteer based with almost all the proceeds being donated toward charitable efforts such as back to school shopping sprees,

youth sports camps, and scholarships.

"This is our biggest fundraiser of the year," said Chris Mathews, president of the Sutter Buttes Social Club. "In year's past we were able to raise around \$10,000, this year our goal is to knock that out of the park and do more than that, but we're looking for more sponsorships and attendees to help make that dream possible."

Brewfest will be held at noon for VIP entry and 1 p.m. for general admission. on

Saturday, Sept. 7. Tickets for those who intend to consume adult beverages start at around \$65 each, but this price includes limitless beer samplings and food from local vendors such as Midtown Grill, Rail House and Sopa Thai.

"The only thing you'll need to take money out for is raffles," added Argyilan.

## Assemblyman Gallagher **Addresses Homelessness**



'I think the better approach to homelessness is what I term more of an empowerment strategy as opposed to an enablement strategy," said District 3 State Assemblyman James Gallagher.

#### **CALIFORNIA REGION (MPG) -**

According to a 2023 report to Congress by the U.S. Department of Housing and Urban Development there were 181.399 homeless individuals in California.

For State Assembly Minority Leader James Gallagher, that is a problem that requires a solution at the legislative level. He recently told the Territorial Dispatch that the State of California's approach so far to homelessness is piecemeal and expensive, and enabling rather than empowering.

Sometimes it's good to find a political middle ground, especially before diving into a divisive topic such as homelessness, during a newspaper interview. That common ground was independent league baseball, namely the Marysville Drakes, who play in the Pecos League.

"It's good to have baseball in Marysville. I certainly support all the teams that have been through...There's a lot of history connected to it," Gallagher said.

do with the team's infield grass and seating which has its roots in the early 20th century.

"The thing that's cool about that is that it's the site of Bryant Field," he continued. "Bryant Field is a historic stadium in Marysville and everybody used to come out, and my dad was actually a batboy for the Marysville Giants, and my grandfather played for many years in that semi-pro league for the Yuba City Bears and the Marysville Giants."

Both teams played at Bryant Field, with its brickwork trim, at the corner of 14th and B streets.

Today, the ballpark provides little protection from the elements if one were looking for shelter, one of the chief concerns of California's homeless population.



people who just have fallen on hard times and the best way to help them is just to meet them where they're at, give them all kinds of things including syringes and let them stay in public parks, and let them stay in front of businesses, and essentially cater to them and then build really expensive housing like they did in L.A.'s case. According to their own audit, \$760,000 a unit they spent to house one homeless person."

"Those (strategies) aren't working. And, in fact, it's just really enabling the problem," Gallagher continued. "We want to empower people out of it and I think the best way to do that is to one, vou sav, hev, vou cannot stay in certain places. You can't be in public parks and in front of businesses."

Gallagher didn't mention what the other side of the aisle was doing without providing a solution himself.

"My proposal: regional sheltering facilities that have services built into them — drug treatment, mental health. These don't have to be expensive apartments. They can be pallet shelters like some jurisdictions have used, essentially like Tuff Sheds with insulation," he said. "They're clean. It's a place you can stay. You have shelter and then also with those places, you have the ability to get help with whatever it is you might need — mental health, drug treatment, getting you on a better path — and then you can move into a place like transitional housing. But all toward empowering that person off the street, getting treatment for what they really need that has caused their home-

Every session of the California Legislature seems to produce at least one bill that generates high-octane political debate and media attention.

As the 2023-24 session winds down this week, Senate Bill 1047, which would impose rules on artificial intelligence developers, is generating fierce lobbying and drawing global interest.

During the final days of last year's session, the focus was on a very different issue whether the state should impose a \$20-per-hour minimum wage for fast food workers and create a Fast Food Council to oversee working conditions.

A year before, Assembly Bill 257 created the council and empowered it to set an initial minimum wage of at least \$22 an hour, while assuming that franchised fast food outlets were subsidiaries of the parent company, rather than independently owned.

The fast food industry responded with a referendum that, if ratified by voters, would cancel out the new law, thus renewing the debate in the 2023 session. A last-minute deal repealed AB 257 and substituted another measure, AB 1228, that dictated a \$20 minimum wage and removed what the industry considered to be a threat to the franchise system. In return, the referendum was dropped.

Fast Food Workers Got a \$20 Minimum Wage,

The \$20 wage took effect last April, but only after a new squabble erupted over which sellers of food would be covered, colored by a Bloomberg article alleging that Newsom had demanded an exemption to benefit a campaign donor who owns two dozen Panera locations in California.

Newsom declared that the story was "absurd" and gave assurances that Panera and other similar businesses would be covered. The businessman, billionaire Greg Flynn, also said he would honor the \$20 wage.

End of fast food angst? Of course not.

Six months after the \$20 wage took effect there's a new debate in political, media and academic circles over its impact.

Fast food prices have been increasing, but how much higher wages are driving the rise and how fast food operations have changed are two new issues.

This month, Newsom declared that California fast food outlets had created 11,000 new jobs since the law was signed.

"What's good for workers is good for business, and as California's fast food industry continues booming every single month our workers are finally getting the pay they deserve," Newsom said. "Despite those who pedaled lies about how this would doom the industry, California's economy and workers are again proving them wrong."

The industry didn't agree. "Every day you see headlines of restaurant closures, employee job losses and hours cut, and rising food prices for consumers," the International Franchise Association said in a statement. "Local restaurant owners in California are already struggling to cope with the \$20/hour wage, as the Fast Food Council considers additional wage increases. All the while, workers and consumers are feeling the pinch."

Brooke Armour, president of the California Center for Jobs and the Economy, an adjunct of the Business Roundtable, criticized Newsom's declaration as reflecting just one month of preliminary data and concluding, "Despite what some are saying, the data are clear: newly passed fast food minimum wage laws are leading to job losses in California."

Christopher Thornberg, founding partner of Beacon Economics, also was critical in an analysis of the state's economic trends. "California's well-intended push to reduce income inequality via wage floors is beginning to have a significant negative impact on some of our most vulnerable workers — our youth, particularly those from lower income households," Thornberg wrote.

What California has wrought in the fast food industry could be the harbinger of more direct regulation of other industries, and not just in California, for better or worse. It's not surprising, therefore, that its effects will be debated ad nauseam.

to Feather River Plaza LLC, a limited liability company that has owned the Hotel Marysville but failed to develop it for 17 years.

Principals of the LLC received notices of the violation at addresses in Rhode Island and Los Angeles. A Los Angeles real estate attorney has been representing the property owners, who have not been to Marysville to explain what they intend to do with the hotel since the fire.

The limited liability company appealed the notice on Aug. 15.

The hearing will be conducted by three building officials not affiliated with the city. The officials will receive testimony about the structure's condition and will be provided an opportunity to view the structure before determining whether the public is a public nuisance that needs to be abated.

The city also sent notice on Aug. 15 warning the owner the owner that it would be in violation if they did not prevent contaminants from entering the city's storm drain system in the event of rain. The owners Counsel rebuffed this notice on Aug. 23, stating, among other things, that, "The Owner has not engaged in—and is not threatening

But the truth is most people who've put money into your business won't keep silent. They're all going to have different opinions and ideas, and there's a strong possibility these are going to clash at some point with the vision you have for your company.

In short, I would not recommend a fledgling small business, even one that's doing well, to seek out investors. Period. Cash flow your growth, Trey. Cash flow your equipment purchases, and the markets you enter, also. Does this mean you might miss a good opportunity here and there? Sure, it does. But it also means you'll be missing opportunities to fail. Too much success too soon is one of the biggest reasons why small businesses shut down. When you grow too quickly, you run the risk of outgrowing your financial resources, your infrastructure and your human resources.

Do what you can to ensure growth is steady, but play it smart. Don't grow so fast that you crack the foundation of your company.

#### California Fig Sector Hopes to Raise Profile of the Fruit

Figs are in peak season, and California growers say they have a quality crop this year that more retailers should promote for fresh eating, even if most of their production still ends up going to make dried fruit. They have been trying to change that for years by promoting fresh figs while they're in season and educating consumers, who may know the fruit only as a filling for a certain cookie. "We're really trying to liberate the fig from the Newton," said Karla Stockli, CEO of the California Fresh Fig Growers Association and the California Fig Advisory Board.

#### Imperial Valley Farmers Reduce Forage Crop Production to Save Water

Irrigators cut off water to a huge portion of the Imperial Valley's half-million acres of farmland earlier this month after the federal government approved a longawaited program designed to bolster water levels on the Colorado River. The conservation agreement, authorized Aug. 12 by the U.S. Bureau of Reclamation and the Imperial Irrigation District, pays farmers to stop irrigating forage crops such as alfalfa for a period during the summer. Farmers participating in the "deficit irrigation" program will be compensated to sacrifice one or two hay cuttings.

#### Water-right Hearing Could Advance Long-planned Sites Reservoir

The plan to build California's first new major reservoir in decades is advancing as the state considers whether to issue a water-right permit for the proposed Sites Reservoir, an off-stream water storage project that could store up to 1.5 million acre-feet of annually. The California State Water Resources Control Board last week began a public hearing process on the project's water-right permit application. Representatives of agriculture, water districts and government agencies are urging the state water board to approve the waterright permit to advance the project.

#### UC Davis, Other Institutions to Study Seaweed as 'Sustainable' Specialty Crop

A multi-state grant has been awarded to help develop Pacific dulse seaweed as "a sustainable, nutritious specialty crop," the U.S. Department of Agriculture announced last week. The project is being undertaken by University of California, Davis, Oregon State University, University of Alaska Fairbanks and Kelp Line LLC. The effort is one of 65 projects to share in \$82.3 million in funding from the USDA's Specialty Crop Multi-State Grant Program. More than \$23.3 million in funding was awarded for specialty crop programs in California.

and hopefully done in the spring," Moody said.

Moody told officials that he was requesting "approval of the specs and authorize us to bid" \$800,000 for different types of signals, depending on the location. According to Moody, about \$571,000 is allotted for city lights and about \$510,000 for the Caltrans portion.

"The city is going to use all of their money, and we may be a little lighter on the Caltrans money, but depending on how the bids come in, we can maybe shift some of those buckets of money to cover it," Moody said. "We will break that down when we return to recommend an award."







### **Suicide Prevention Month Can Save Lives**

#### NORTHERN CALIFORNIA

(MPG) - September is Suicide Prevention Month, a time to raise awareness and discuss this urgently increasing crisis, according to NAMI (National Alliance on Mental Illness).

NAMI has somber statistics: suicide is the second leading cause of death among those aged 10 to 14, the third leading cause of death among those aged 15 to 24 and the 12th leading cause of death overall in the U.S.

Or, as the U.S. Department of Health and Human Services reports, more than 49,000 people in the United States died by suicide in 2022. That's one death every 11 minutes.

And millions more experience suicidal thoughts.

Suicidal thoughts can affect anyone regardless of age, gender or background, according to the NAMI website at nami.org. While suicidal thoughts are common, however, they should not be considered normal and often indicate more serious issues.

Many events and activities promoting suicide prevention awareness will be held locally, regionally and nationally throughout September.

During Suicide Prevention Month, NAMI and numerous other mental health organizations stress that all of us can help prevent suicide by reaching out to those who need help.

The National Institute of Mental Health lists five action steps to help someone having suicidal thoughts.

The first step is **Ask** "Are you thinking about suicide?" It's not an easy question to ask but it can help start a conversation.

The second step is **Be there**: Listening without judgment is key to learning what the person is thinking and feeling.

The third step is **Help keep them safe**: Reducing access to highly lethal items or places can help prevent suicide.

The fourth step is **Help them connect**: Connecting the person with the 988 Suicide & Crisis Lifeline (call or text 988) and other community resources can give them a safety net. You can also assist by reaching out to a trusted family member, friend, spiritual advisor or mental health professional.

The fifth National Institute of Mental Health step is **Follow up**:

Staying in touch with the person after they have experienced a crisis or been discharged from care can make a difference. Studies show that supportive, ongoing contact can play an important role in suicide prevention.

How You Can Help The advocacy groups say to educate yourself and others about suicide prevention by checking out the 988 Suicide & Crisis Lifeline at www.samhsa.gov/ find-help/988.

And visit the Suicide Prevention Resource Center at https://sprc.org. Each year, the resource center creates many ways to get involved in Suicide Prevention Awareness Month.

The U.S. Substance Abuse and Mental Health Services Administration invites residents throughout the country to participate in 988 Day on Sept. 8. 988 Day is a national initiative dedicated to raising awareness about the federal agency's 988 resource and emphasizing the importance of mental health and suicide prevention.

According to the 988 Suicide & Crisis Lifeline website at 988lifeline.org, "We can all help prevent suicide. The 988 Lifeline provides 24/7, free and confidential support for people in distress, prevention and crisis resources for you or your loved ones, and best practices for professionals in the United States."

The National Institute of Mental Health website at https://www.nimh. nih.gov lists warning signs that indicate someone might be considering suicide. During National Suicide Prevention Month, the institute reminds residents that warning signs include the following:


Talking about wanting to die or wanting to kill themselves, talking about feeling empty or hopeless or having no reason to live, talking about feeling trapped or feeling that there are no solutions, feeling unbearable emotional or physical pain, talking about being a burden to others, withdrawing from family and friends, giving away important possessions, saying goodbye to friends and family, putting affairs in order, such as making a will, taking great risks that could lead to death, such as driving extremely fast, or talking or thinking about death often.

Other serious warning signs that someone might be at risk for attempting suicide include:

Displaying extreme mood swings, suddenly changing from very sad to very calm or happy, making a plan or looking for ways to kill themselves, such as searching for lethal methods online, stockpiling pills or buying a gun, talking about feeling great guilt or shame, using alcohol or drugs more often, acting anxious or agitated, changing eating or sleeping habits, and showing rage or talking about seeking revenge.

According to the National Institute of Mental Health, suicidal thoughts or actions are a sign of extreme distress and should not be ignored. If these warning signs apply to you or someone you know, the institute urges you to get help as soon as possible, particularly if the behavior is new or has recently increased.
