# **City Settles Second Oak Rose Lawsuit**

ELK GROVE, CA (MPG) - The city of Elk Grove has reached a settlement in a state lawsuit stemming from the city's rejection of the proposed Oak Rose Apartments.

As part of the settlement, the city has agreed to meet certain reporting requirements, pay the state's legal costs and find a location for new affordable housing. The agreement brings a close to the remaining lawsuit related to the project, more than a year after it was filed by California Attorney General Rob Bonta, Gov. Gavin Newsom and the state Department of Housing and Community Development.

The dispute between city and state began in July 2022, when Elk Grove City Council voted against approving Oak Rose Apartments, which would have brought 66 affordable housing units to Old Town Elk Grove, along with supportive services

Council cited Oak Rose's inclusion of ground-floor residential units in their rejection but the lawsuits pointed to an earlier Old Town development that got approval despite also having ground-floor residential.

Relatedly, under California Senate Bill (SB) 35, affordable housing projects must be given an expedited review process if they meet "objective" zoning and design standards laid out ahead of time by a city.

"This settlement reflects what I've said all along: California's housing laws are not optional. Local governments that violate our laws to deny affordable housing opportunities to Californians will be held accountable," Bonta said. "While I am pleased that this is now behind us, and that Elk Grove ultimately approved even more homes

for residents.

The state and the developer, Excelerate Housing Group, responded by filing separate lawsuits against the city of Elk Grove. They accused the city of applying its building code inconsistently. City

Excelerate's lawsuit settled earlier this year.

In a statement on Sept. 4, Bonta said exceptions must not be made in state

for those most in need, the city's refusal to do the right thing over and over again cannot be swept under the rug."

# Planners OK Tree Removal for Medical Offices

ELK GROVE, CA (MPG) - Elk Grove Planning Commission signed off on three projects at its Sept. 5 regular meeting: a medical office park, an RV storage project and industrial warehouses.

A major element of the design review for the proposed Allen Ranch Medical Buildings was the decision to cut down dozens of trees on the site.

Located on the east side of Laguna Springs Drive, 350 feet south of Elk Grove Boulevard, the development will consist of seven one-story medical buildings, ranging in size from 4,200 square feet to 20,000 square feet. The buildings would have about 65,700 square feet of floor space total.

Construction will involve the removal of 56 live oak and valley oak trees, which are designated as "trees of local importance." Thirtyone of the removals are due to the site layout, and 25 are for health and public safety reasons.

"Many of the oak trees on the site are in significantly compromised health," senior planner Sarah Kirchgessner said, citing an arborist report on the site. "And the applicant did place a priority on retaining trees that have the best opportunity

to thrive in the post-development condition."

Kirchgessner said that there are existing trees along Laguna Springs Drive and that the project will bring 76 new trees.

Commissioners Oscar O'con and Sandra Poole, and Commission Chair Suman Singha said they had concerns about the tree removals but they were reassured by the information from staff.

"I'm glad to see the normal mitigation requirements and the fact that 76 new trees are being planted as replacement. ... I mean, I understand they're not going to be trees of local importance but they will be trees at the end of the day," Singha said. "So that's what you're looking at, is making sure there's enough greenery in the city."

Poole commended city staff and the applicant for their diligence "to try to save as many trees as possible."

The item passed with a 4-0 vote. Commissioner Juan Fernandez was absent.

The commission approved a conditional use permit for a planned M2 Waterman RV Storage project east of Waterman Road. In a 4-0 vote, the commission also agreed to divide the parcel where the project will be located into seven pieces. Consisting of a 1,650-square-foot office building, two canopies and 302 covered *Continued on Page 3*

Musical Mayhem Productions is a nonprofit performing arts organization for students ages 4 through 19. The organization has been recognized nationally at the Junior Theater Festival and is a pilot company for new musicals not yet released

# **Gallagher Criticizes Undemocratic End of Session**

Assembly Republican News Release

SACRAMENTO, CA (MPG) - On Sept. 9, Assembly Republican Leader James Gallagher (Yuba City) demanded answers from the Assembly Rules Committee in the wake of several parliamentary violations that crushed debate and caused chaos at the end of the 2024 legislative session.

In the final hours of the session, Democrats illegally amended the Assembly's rules to limit debate on bills

to just 30 seconds per person and refused to recognize multiple Republican lawmakers attempting to speak on behalf of their constituents.

Additionally, Democrats repeatedly and improperly ignored motions to permanently adjourn the special session convened to take up Gov. Newsom's gas storage mandate proposal.

"A vital part of a thriving democracy is fair and equitable debate. The people of California didn't get that this year," said Gallagher. "Californians deserve an investigation into the unlawful and undemocratic actions taken by the supermajority that silenced Republican voices and stamped out important discussions. We're elected to provide a voice for our constituents - if Democrats continue to run the Assembly as chaotically and unfairly as they did, that can't happen. Our constituents deserve answers."

On top of Democrats' actions to silence Republican lawmakers, poor time management and political squabbles led to a frantic rush to consider dozens of bills in the final minutes of the legislative session.

Despite spending hours on ceremonies and speeches, adjourning early the night before, and not convening until 2:30 p.m. on the final day, legislators crammed through bills with little to no debate while multiple other proposals failed to meet the midnight deadline for passage.

Football season has begun, but make no mistake about it, basketball fans are eagerly anticipating the upcoming camp and preseason for the Sacramento Kings.

This year's team will take on a decidedly offensive look, as they have added a perennial 20 points per game with DeMar DeRozan to their already potent offense.

Last season with the Bulls, DeRozan averaged 24 points per game, but he has exceeded 27 points per game twice in his already legendary career. This bodes well for the hometown team, as threepoint shooters like Keegan Murray, Malik Monk, and De'Aaron Fox will undoubtedly get better looks, as defenders try to control the frenetic mid-range game of DeMar DeRozan.

The Kings can actually put 5 scorers on the court at the same time, and although Keon Ellis is known for his ferocious defense, his offensive game has come to life as well. We saw a man among boys in the NBA summer league, as Keon did pretty much what he wanted as he scored at will against the newcomers and younger players in the league.

Keon's experience from last year, particularly as a starter, will in all likelihood lead to a standout year in the upcoming campaign.

Starters for the Kings that we can already pencil in include Domantas Sabonis, De'Aaron Fox, Keegan Murray, and of course the standout offseason acquisition of DeMar DeRozan. That leaves one spot to be filled, and everyone seems to be coming up with their own personal favorite. The leading candidates are Malik Monk, Keon Ellis, and Kevin Huerter who is returning from a shoulder injury that cut short his 2023/2024 season.

Huerter and Ellis are accustomed to starting, but Malik Monk has made it known that he would like to transition from the 6th man position to the starting lineup.

The unknown quotient is coach Mike Brown who has a difficult decision to make. Hopefully he will give each of the three an opportunity to start in preseason games, but the preseason is short, and the body of work will be minimal to make a decision.

There are those for whom it's not who starts but who finishes, but I respond by saying, starting is a place of pride, and I've yet to meet the player that would rather come off the bench than start a game.

Trey Lyles has never gotten the love from coach Brown that Keon Ellis receives, and I contend that Trey has acquitted himself well, and to the point that his name should be in the conversation. When Trey plays alongside Sabonis the Kings present a much more formidable front line, and Lyles could be the missing ingredient the Kings need to give Domantas the wingman he needs to help clean the boards.

The truth is, whether Huerter, Monk, Ellis, or Lyles, all four of these players represent quality NBA talent, and Brown has some notable ballers to make his final selection.

All that said, the bench will be strong this year, and if Alex Len can take just one more step, I believe this 1st round draft choice from 2013 could finally live up to the potential that so many pundits believed that he had when originally drafted.

I like Len's game, and his effort is unquestionable. He acquits himself well when Sabonis needs a breather, and if he can take that next step, I can see moments when he and Sabonis are on the court together.

If I haven't yet mentioned your favorite player, dark horses like Colby Jones, Jordan McLaughlin, Boogie Ellis, or newcomers Orlando Robinson and Isaiah Crawford are waiting in the wings to make their presence known.

Just as Keon Ellis emerged last season, one of these players is waiting to show the Sacramento Kings fans that they deserve some accolades, and it will surprise me if I'm not surprised by one the aforementioned candidates.

Let's not forget that we haven't even mentioned Kings' top draft choice Devin Carter, and although he is scheduled to miss the first half of the upcoming season, Devin no doubt will be eagerly awaiting his opportunity to show the Sacramento fans why this 22-year-old was drafted #13 overall.

Continued from page 1 homelessness crisis, local governments have "a legal and moral responsibility" to work with the state to provide housing.

In its own statement, the city of Elk Grove emphasized its investments in affordable housing.

"Today's settlement announcement underscores Elk Grove's continued commitment to the development of all forms of affordable housing and its focus on putting its resources towards its housing goals. Since 2004, Elk Grove has provided \$78 million in funding for affordable housing projects in Elk Grove, including transitional housing and permanent supportive housing," the city said.

It called for the state to collaborate more with local governments, saying that "Elk Grove is proud of the role it has played as a leader in the development of affordable housing in the region. The City is hopeful that in the future the State will work more collaboratively with cities to partner in the development of affordable housing rather than use precious resources in the pursuit of unnecessary litigation."

Newsom criticized the city's rejection of Oak Rose.

"We can't solve California's homelessness crisis without creating new housing and supportive services," Newsom said. "Elk Grove is not immune to this challenge, and the city's decision wasting valuable time and resources — is especially shameful. We expect Elk Grove to follow the law continued refusal will not be tolerated."

In addition to paying \$150,000 to cover the state's legal expenses, for a five-year period the city has agreed to provide the Department of Housing and Community Development with a copy of any application to build affordable housing, as well as submit monthly reports on the progress of proposed affordable housing projects. For that same

period, if the city rejects a project that includes affordable housing, it will have to explain how the decision is consistent with its "obligation to ...combat historic patterns of segregation and foster more inclusive communities."

Elk Grove must also identify a new site for low-income housing with equivalent development capacity to the original location. The site will be in an area of the city with the highest economic, educational and health outcomes.

This new location is separate from an affordable development provided for in the settlement with Excelerate. Coral Blossom Apartments, planned for a parcel on Elk Grove-Florin Road, south of Calvine Road, will comprise 66 units for people at risk of homelessness.

The Elk Grove Planning Commission recently allowed Coral Blossom to proceed over objections from nearby residents and business owners, citing SB 35 and the state's litigation. ★

and uncovered RV parking stalls, the project will take up one of the newly created parcels. It will run from Charolais Way in the north and Wayne Heintz Street in the south. No use has been proposed for the other six parcels, five of which sit between Waterman and the RV project; the seventh is on the south side of Wayne Heintz.


The commission voted 4-0 to approve a major design review of two industrial warehouse buildings east of the intersection of Elkmont and Iron Rock ways. The applicant requested minor deviations from city building code, slightly reducing the number of parking spots and widening the spacing of landscaped islands in the parking lot. Associate planner Joseph Daguman said the adjustments would improve the site's usability. The warehouses and associated offices will take up about 42,300 square feet on a 2.8-acre lot.

Daguman noted that the applicant had updated its design to add canopies requested by the city; city staff recommended deleting a related condition of approval from the design review.

Representing the applicant, consultant Jim Gillum agreed with the condition's removal.

The Development Services director said the commission's regular meetings on Sept. 19 and Oct. 3 will probably be canceled due to a lack of agenda items.  $\star$



Last year I wrote a book called, "Tell It to the Chaplain." If you've seen it, then you're likely wondering why this headline makes the opposite request.

My title refers to certain phrases people use that cause me to jokingly reply, "Don't ever say that to a chaplain."

When they cock their head in search of an explanation, I tell them that I'm a retired healthcare chaplain and I may inject a totally different meaning into common sayings.

For instance, I once asked my photojournalism professor if he could stay after class to explain my new camera.

"I really can't," he said, "I'm on my way out."

"Please don't say that to a chaplain," I replied. "On the way out' means you're going to meet God."

"No – no. I have a faculty meeting," he said. "And God's not often there."

On another day, I ran breathlessly to an airline gate, only to be told by the agent,

Don't Tell it to the Chaplain

"They've already departed."

Ouch. Don't say that to a chaplain. "Departed" describes someone who has taken flight to their celestial destination.

At some point, chaplains call these folks the "dearly departed." On a different occasion, my neigh-

bors described how they moved out of the city into our forested

lake community in the California foothills.

"It just feels like we're in a better place now," the husband blurted.

I winced at "a better place" since the phrase most often describes the afterlife.

In another example, I was walking with my friend Roger through a sports stadium when he abruptly stopped at a concession stand to buy a Pepsi.

"Keep walking," he said, "Meet me on the other side."

Of course, I knew he

was simply asking me to meet him at our seats on the other side of the stadium.

But as a chaplain, he should have known that I'd make a heavenly inference that we'd not meet again until we got to the "Other Side." Finally, I once stood on the banks of the Jordan River as our Israeli tour guide pointed toward the land "just beyond the river."

I nudged my wife and said, "I wish he wouldn't say that."

I started humming the refrain to Fanny Crosby's hymn, "Near the Cross."

"In the cross, in the cross, Be my glory ever; Till my raptured soul shall find Rest beyond the river."

Becky groaned, recognizing this as one of my favorite fragments.

I jest with these phrases because I love puns, but I also appreciate them as a comforting way to remember the three people I've lost in the past four years.

My brother, the one I called "Brotherman," died of COVID in December 2020. He was so full of conspiracy

theories that he wasn't contented in this world, so I really do feel a sense of comfort knowing he's very much "in a better place."

And, as you know, I lost my mother last month. I thank all of you who sent me

numerous messages and cards.

But most reassuring is how I still hear the notes of her operatic voice singing those Crosby hymns. "Near the Cross" was among her favorites, and I take consolation believing she's found her "rest beyond the river."

However, my most difficult loss came four years ago this month, when I lost my life-long best friend, Roger Williams. On the last day I saw him, we sat on his couch, shoulder to shoulder, the same way we'd stood for 45 years.

As we said our temporary goodbyes, I held his cooling hand and laid my head on his shoulder. Then, in between my sobs, I told him that I'd see him "on the other side."

"That's OK, Norris," he said. "It'll be all right." Soon he was asleep. Four days later, Roger died at 63 years of age.

So, sometimes all I have left to say is "See you, Mom. See you, Roger. See ya, Brotherman. I'll meet you all "in a better place," "on the other side" just "beyond the river."



# **Franklin Alum Chase Davis** Promoted to Double-A

ELK GROVE, CA (MPG) -Although there hasn't been too much success from the Major Leaguers from Elk Grove this season, we can look to the minor leagues for a success story.

The Franklin High School and University of Arizona alumnus Chase Davis was promoted to Double-A on Sept. 6 within the St. Louis Cardinals organization.

Davis was drafted by the Cardinals with the 21 overall pick of the 2023 MLB Amateur Draft out of the University of Arizona where in 147 games across three years he slashed .319/.444/.644.

The professional career of Davis kicked off in A-ball in 2023 where he played 34 games and played 74 more games at that same level to start 2024 for the Palm Beach Cardinals.

Through his first 74 games this year in A-ball, Davis slashed .232/.337/.401 with eight home runs and 48 RBIs, which earned him a promotion to High-A to the Peoria Chiefs.

It took 30 games in Peoria for the Cardinals to promote him once again, this time to the Cardinals' Double-A affiliate Springfield Cardinals, as he slashed .301/.388/.451 with three home runs and 18 RBIs.

Well, Davis did not take long to make his presence felt in Springfield, Mo. In his first at-bat on Sept. 7 he sent a ball soaring over the right field wall for a 378foot home run.

"I knew that pitcher wanted to get ahead with something slow," Davis said to reporters after the game. "That first at-bat. I know they wanted to attack and get that get-meover curveball, but I took advantage and happened to get a good swing on it." All it takes is to look in the comments section of any of Davis' highlights to see Carlos Gonzalez, mostly known for his time with the Colorado Rockies and his sweet left-handed

swing, in comparison.

Regardless of the comparisons, Davis' swing is one of the prettier ones you'll see and one that will have the public raving once he gets promoted to the major league squad.

Davis was getting Carlos Gonzalez comparisons across social media users while he was still at the University of Arizona.

He got to be a Wildcat in Arizona thanks to his contributions as a Franklin Wildcat, where he slashed .294/.451/.502 across three varsity seasons before having his senior season canceled due to the COVID-19 pandemic.

It seemed that Davis was on his way to being drafted in 2020 out of high school, but due to the pandemic, MLB decided to only have five rounds of the draft as opposed to the 40 rounds from the previous year.

This allowed Davis to attend the University of Arizona, where he developed into a first-round draft pick and got to Double-A where he also made a leaping catch on the warning track in front of the outfield wall to rob an extra-base hit in his debut.

"That ball was well-hit. It was one of those fly balls where, as an outfielder, you practice for all the time," Davis said. "I was going back on the wall, much farther from the wall than I thought I was. I was still able to get the glove on it and make a play."

Davis has bounced around from city to city this season and continues to produce despite moving up in levels across professional baseball.

"At the end of the day, it's baseball. The game doesn't change." Davis said of his whirlwind year. "Things may get a little better at different levels, but I understand that I've got a job to do." At the time of publication, Davis has two hits in six at-bats across two games and will likely end his season with the Springfield Cardinals, as the regular season ends on Sept. 20.

# **Eagles Soar Over Tigers to Remain Undefeated**

**ELK GROVE, CA (MPG)** - The Pleasant Grove Eagles are soaring high. Head coach Josh Crabtree and his squad are undefeated and have yet to surrender a single point this season after their 40-0 win over the Tokay Tigers at home.

Before the matchup, the National Anthem included a fly-over thanks to the father of senior wide receiver Cody Nydeggar, a lieutenant colonel in the Air Force, to kick off the Eagles' homecoming game.

With the Tigers taking on newly added Delta League opponent the Laguna Creek Cardinals the previous week for a losing score of 62-40, Crabtree said he told his team that looking at MaxPreps doesn't tell the whole story of that team.

"I've been ringing bells, sounding alarms all week with my guys like, 'Hey, don't think that MaxPreps tells the whole story of that team,' They got some good football players, they got a good coaching staff and to be honest with you, I was concerned coming into this game," Crabtree said.

Coming into this game, the Eagles' senior quarterback Cole Davis was the leader in passing yards in the whole CIF Sac-Joaquin Section with a total of 554 yards, good for 26 completions on 34 attempts and five touchdowns, according

to MaxPreps.

Not only are the Eagles a threat in the air on offense, but senior running back Bobby Mitchell is also an offensive threat. The previous week against the Lodi Flames, he had three touchdowns on a total of 14 carries as he rushed for a total of 82 yards.

"I brought them up in my first year as the head football coach here two years ago; they were sophomores, and they've paid their dues," Crabtree said. "It's fun for me to watch them flourish and have success. It makes it easier to call plays when you don't have to hide one, run the ball or throw the ball. It's a great situation for us."

Not only does Crabtree praise the results on the field, but he described both Davis and Mitchell as unselfish and great leaders.

The Eagles got downfield with Davis connecting with his receivers and Mitchell's running game to culminate in a touchdown for Mitchell, the first of two he would have along with a total of 141 yards rushing on 12 carries.

With no hesitation, Crabtree went for the two-point conversion to put them up 8-0, the first of two conversions from senior Jacob Beals, which would later give them a 16-0 lead.

"He's (Beals) a tough

kid to tackle, so they had bodies there but he's a slippery kid, so we like the numbers advantage and we took it twice and those are big-momentum plays," Crabtree said. "When you look up at the scoreboard and it says 16-0 as opposed to 14, it's two points, but psychologically, it's bigger than that."

The offense kept piling on as Davis would go on to throw for 170 yards with two touchdowns to receivers Nydeggar and senior Jack Maddox to go on to put 40 points on the board.

The Tigers could not put anything together offensively due to the Eagles' lockdown defense for their third straight shutout of the young season.

"We've been on a run where we've had some good play and some good luck," Crabtree said. "Shutouts are rare and to have three in a row is a credit to the kids. It's a credit to the kids. It's a credit to my defensive staff. I love looking at a zero underneath an opponent's name."

Standouts on defense for Crabtree on the night were Maddox Ali, an All-League player for the Eagles last season, and Roman Patterson.

This year marks 24 years of coaching for Crabtree, who said this is one of the best group he's ever coached.

"I've coached teams that

had six or seven scholarship kids on it, I coached at the college level for a while, but this group of kids are just amazing kids," Crabtree said.

There's one game left in the Eagles' schedule before they begin their Delta League schedule, and they'll be looking to adjust as they allowed too many penalties against the Tigers, Crabtree said.

"We had a bunch of penalties tonight which were out of character for us. There's a lot of little things and we were fortunate that we had a bit of a lead, but we can't continue to do that so there's plenty for us to work on," Crabtree said.

The Eagles didn't align properly a couple of times on defense and there was a delay of game among other things that even erased some touchdowns off the board due to penalties.

The last opponent for the Eagles before league play is the Lincoln Trojans, who are currently 1-2 overall this season. The Eagles will travel to Stockton for what Crabtree said will be a big challenge for them.

"They bring a ton of talent to the table. Their running back could be the best running back in the whole section so it's going to be a huge challenge for us," Crabtree said.

"That coaching staff does a good job and they have tons of athletes. Their quarterback can run and throw."



The Capital SouthEast Connector Expressway, stretching from Elk Grove to Highway 50 in El Dorado County, is more than just a roadway project. In partnership with the South Sacramento Habitat Conservation Plan, the project is designed to ensure the long-term viability of area plant and wildlife species while preserving agricultural and ranch land.

When completed, the Capital SouthEast Connector will reduce greenhouse gases, pollutant emissions, vehicle miles traveled, and regional congestion. The project has obtained environmental permits and has agreed to purchase lands to replace impacted agricultural land or vernal pools.

### Q What is the Capital SouthEast Connector Expressway?


The planned Connector is A an expressway that will link Interstate 5 and Highway 99 near Elk Grove to Highway 50 in El Dorado County. The new expressway will relieve congestion by directing commuter and commercial traffic around the city on a safe expressway. Travelers to and from areas south of Sacramento will no longer need to go through the city to get to their destinations. The Capital SouthEast Connector Expressway also features a parallel bike and pedestrian trail.

particularly Hwy 50, and from fewer toxic fumes spewing from thousands of vehicles stuck in traffic. Southeastern Sacramento County residents will have a safe new route to avoid Hwy 50 congestion and bypass downtown traffic. Businesses, companies, farmers, and ranchers will also be able to receive supplies and send products to market more safely and quickly. Most importantly, the modernized roadway will be safe to travel, unlike current conditions that endanger lives.

specifically to construct a new expressway connecting I-5 and Hwy 99 in the Elk Grove area to Hwy 50 in El Dorado County, now known as the Capital SouthEast Connector. Since the vote, the tax has generated about \$2 billion. To date, the Capital SouthEast Connector has received about \$58 million of those funds, which were paired with federal and state funds to complete 11 miles of the 34-mile project.

### Q Where have the transportation tax funds not allocated to the Capital SouthEast Connector been used?

The transportation sales A tax funds are allocated according to a formula voters approved when they approved the tax. The largest single recipient of the funds since the tax began is the Regional Transit Authority (38%, amounting to \$709 million) for operating and maintaining light rail and bus services; and providing transportation options to seniors and individuals with disabilities. Street and road maintenance projects have received 29.4%, amounting to \$545.5 million. Overall, capital improvement projects have received 20.4%, amounting to \$377.4 million. The rest of the funds went to smaller projects, and less than 3/4 of one percent is spent on program administration. 

The Capital SouthEast **A**Connector is part of the "Sacramento Blueprint," adopted over 20 years ago by SACOG's board of directors and still consulted today. The Blueprint's goal is to integrate land use and transportation planning to improve the region's quality of life. It was SACOG's idea to create the Capital SouthEast Connector Joint Powers Authority to manage the design and construction of the expressway. Over the years, SACOG has been mostly supportive of efforts to advance the project, and SACOG recently determined that constructing a segment of the project was the region's number one transportation priority, greatly enhancing a successful project application for federal funding.

QWhat environmental impacts will the South-East Connector Expressway create, and how will they be mitigated?

A Like any road project, the Capital SouthEast Connector will affect the environment during and after construction, but all federal, state, and local regulations to protect the environment are being followed. After construction, the environment will be greatly enhanced due to a design that controls and channels damaging groundwater that currently floods the roadway and adjacent lands. The Connector Joint Powers Authority is a member of the South Sacramento Conservation Agency (SCCA) that oversees compliance with

the South Sacramento Habitat Conservation Plan and its rules for road construction. The Connector project has obtained environmental permits and has also agreed to purchase lands to replace impacted agricultural land or vernal pools in accordance with the conservation plan's vision.

### Q How will the Capital SouthEast Connector affect bike and pedestrian traffic in the area?

A Bicyclists and pedestrians who currently face grave danger will be able to avoid traffic entirely by using a paved, Class 1 bike trail that will be built separate from the expressway along its entire length. The bike trail is designed to enable residents to walk or ride their bikes to visit friends in neighboring communities; or peddle to work, local restaurants, stores, parks, and entertainment venues; or simply to exercise and enjoy the outdoors.
