





CITRUS HEIGHTS, CA (MPG) - A colorful new 3-D immersive sidewalk mural depicting a magical "secret garden" has been completed in the Marketplace at Birdcage shopping plaza in Citrus Heights. backside of Pet Food Express, said Monika Foley, Gerrity Group vice president of placemaking.

"We are so excited about our newest additions to the center, including the 3-D immersive sidewalk mural which Julio has painted," Foley said.

"We wanted to add a fun element for the community and for our guests to explore at the center in an immersive way," Foley said. "The goal of the mural program in the Market Place at Birdcage is to connect the center to the community." Jiminez also created a series of smaller colorful 3-D paintings depicting flowers, butterflies and bumblebees between the buildings which lead to his larger secret garden mural on the main sidewalk across from Citrus Heights Modern Dentistry, facing Chuze Fitness and Old Navy. "They are the sort of 'breadcrumbs' that lead to the larger mural which I painted," he said.

Council Vacancy Holds Until After Election

CITRUS HEIGHTS, CA (MPG) - The first action at the Sept. 11 Citrus Heights City Council meeting was for council members to fill the seat recently vacated by former Mayor Bret Daniels.

Councilmember Tim Schaefer nominated Vice-Mayor Jayna Karpinski-Costa to serve as the new mayor and Councilmember MariJane Lopez-Taff to serve as vicemayor. Councilmember Porsche Middleton seconded the motion and it was unanimously approved.

Bret Daniel's resignation, which was effective Aug. 31, also left a vacancy on City Council for District 1. The vacancy can be addressed by appointing someone to fill the seat or by holding a special election. Since there is already a general election coming up this November, in which the council seats for districts 1 and 3 will be up for election, City Council

 During Public Comment,

Citrus Heights resident and former councilmember Al Fox urged City Council to hold the vacancy until after the election. Fox said that the four remaining councilmembers are capable of finding consensus and governing the city, and that staff time of bringing on an appointee for such a short time would not be worth the effort. The focus now should not be on training an appointee, Fox said, but on the campaigns of the new council candidates.

City Councilmembers agreed and voted unanimously to hold the vacancy until after the November election.

Councilmembers then considered updates to the zoning code, a process undertaken each year to clarify existing standards and ensure compliance with current state laws. This year, the most significant change was a proposal to eliminate duplicative processes in the review of applications for alcohol sales. Any business requesting to sell alcohol must obtain a license from California's Department of Alcoholic Beverage Control (ABC).

In that review process, Alcoholic Beverage Control considers an applicant's proximity to *Continued on page 11*

House is a Sacramento native and graduated from Cordova High School in 1987. He has a 36-year tenure in public service, including four years in the Army serving as a firefighter. In 2000, he joined Sacramento Metro Fire and was named fire chief in August 2023.

House began his speech by saying, "I couldn't be

Calling Metro Fire a "fine organization," he provided a background of the fire department, the work they do and the advancements they are making toward providing 24/7 safety for all Sacramento residents. chalk, and his 10 by 20-foot 3-D garden mural was painted with aerosol spray cans in Birdcage and is one of his largest permanent painted works.

A complete gallery of Jiminez' sidewalk paintings in the MarketPlace at Birdcage can be seen at https://sunrisemarketplace.com/art/murals/julio-jiminez.

"I invite everyone to pause before each smaller sidewalk mural and fully immerse themselves in each," Jiminez said.

It's easy to see how the suggested movement of the yellow and black bumblebees that Jiminez has painted quickly catches your eve in each of his individual smaller murals. Some of the butterflies look as if they are about to alight on the individual flower petals beneath them.

Benches placed around Jimenez's featured sidewalk mural also invite the public to enjoy his work as they pause in their shopping. Footprints placed at the head of the mural invite visitors how best to take a "selfie" to capture its multi-dimension effects.

"The orientation of the mural takes into account the alignment of the sun as it travels," Jiminez explained. "Your visual perspective of the work will change with the height of the sun in the sky and the time of day."

Foley said that Gerrity Group wanted to bring awareness to the many talented artists in California and showcase their work, while adding color and beautification in Birdcage.

"We've enjoyed working with executive director Kathilynn Carpenter and her team at Sunrise MarketPlace to bring more awareness to MarketPlace at Birdcage," Foley said.

In 2021, Sunrise MarketPlace worked with Wide Open Walls, an annual Sacramento mural event to bring more murals to buildings in the district.

There are currently eight murals from seven artists completed throughout the Sunrise MarketPlace Shopping District. Each

was custom designed and painted by the participating artist, Carpenter said. The district

encompasses a collection of more than 400 stores, restaurants and services in the Sunrise/ Greenback business corridor.

"While we (Gerrity Group) are not planning to add any other murals at the property at this time, we will re-visit this opportunity to do so in Citrus Heights with Kathilynn Carpenter in 2025," Foley said.

work, according to Carpenter. Besides the substantial number of mural projects in the district, which can be seen at sunrisemarketplace.com/art.

there's also a special collection of "Masterpieces i n the Marketplace,"

according to Carpenter. The district has also transformed its utility service boxes into art-wrapped showcases with works by prominent world-renowned artists.

A variety of iconic works showcase 19th century, Japanese woodblock, impressionism, abstract and local contemporary art. The project includes artists such as Van Gogh, Degas and Renoir. Utilizing SMUD's Transformer Box Wrap Program to enhance the aesthetic environment and deter graffiti, Sunrise MarketPlace was the first to develop a themed art installation of this scale, Carpenter said. \star

"In the last 10 years, our call volume has doubled," he said.

In fact, House stated that in 2023, the fire department received more than 100,000 calls to 911. The department is expecting 110,000 calls by the end of 2024.

"So, we have to look at doing other things, having other capabilities and providing additional services because today's population demands that," House said. "We have to evolve. We have to have a higher degree of capability.'

House emphasized that Sac Metro Fire must adapt to the growing demand of its services, predominantly concerning the fentanyl, mental health and homelessness crises. Those issues must now be addressed.

"I've made it a priority to get involved with every single player in Sacramento County and ask, 'How do we think outside the box and get our resources together so we're not working on islands?"" House said. "We're collaborating like never before, and with the help of Supervisors Rich Desmond and Sue Frost, we've been able to exercise outside the normal funds of the fire department to get additional funding to incorporate help into the sensitive areas of today's communities," he said.

The result: Mobile Integrated Health, which is the first of its kind in the nation.

The premise behind the program is to make the emergency process easier, quicker and more affordable for all parties involved. Or, in House's words, "Getting the right resource to the right call to have the right outcome to get them (the caller) to the right place."

"You should be proud of your fire department," House concluded.

The fire chief then introduced Battalion Chief Perryman to elaborate on the program, saying, "As firefighters, we need to be good human beings first. This (Perryman) is a good human being all the way around."

Perryman began his career in 2002 as an EMT (Emergency Medical Technician) and paramedic before joining Metro Fire in 2006 as a firefighter, according to Magnani. He was promoted to captain in 2013 and then battalion chief in 2022.

Perryman spoke further about the Mobile Integrated Health program, which was his creation.

"I'm really passionate about this project I've been working on because it affects so much," Perryman said.

First, not every medical issue calls for a trip to the ER, according to Perryman. By utilizing Mobile Integrated Health, an on-scene nurse practitioner/physician's assistant can treat, diagnose, write medications and communicate with the patient's primary care provider, therefore saving both the first responder and the patient a lengthy (and oftentimes unnecessary) ER visit. This also allows officers to spend more time patrolling the streets rather than waiting in the ER with someone, which they do any time they use a taser on someone.

Perryman shared several stories of 911 callers that were repeatedly sent to the ER but found no solutions for their issues until the Mobile Integrated Health professionals were able to "go in and dig and find out what's going on."

"The person's care is elevated," Perryman said about Mobile Integrated Health.

"Think of the bills," Perryman said, referring to the price of an ambulance, an ER visit, medications and more. Mobile Integrated Health is saving not only patients', but insurance companies' money, as well.

According to Perryman, the program is currently funded by the Sacramento County Board of Supervisors and grant money, with funds to open another unit in South Sacramento. The existing one is located in North Sacramento.

The next step for Mobile Integrated Health would be the signing of SB1180, a bill awaiting Governor Newsom's signature that would allow Mobile Integrated Health to bill for its services. According to Perryman, Mobile Integrated Health can currently only charge for the equivalent of a physician's visit, which ranges from \$100 to \$150. Perryman emphasized that Mobile Integrated Health is "not here to make money" and they just want to "cover their costs."

House joined Perryman to reiterate a few final points, and ended by saying, "We have to be adaptable visionaries that just can't sit around on our heels and say all we do is fight fires. We have to be better than that.'

Social Security Matters *About Widow's Benefits vs. Benefits from my Ex-spouse*

Dear Rusty: In November I will be 60 and eligible for widow's benefits. My late husband's Social Security was approximately \$2,300 when he passed around 7 years ago. FYI, my ex-husband is still working and will probably receive the highest SS when he retires in about 5 years (we were married for more than 10 years). Either of these is more than my own Social Security will be, so how does this work? Will this turn into my Social Security? Can I start on one and switch to the other later? Signed: Wondering Widow

Dear Wondering Widow: Provided you have not remarried before age 60, you have a choice which benefit to receive - either your deceased husband's benefit as his surviving spouse, or your ex-spouse benefit from your ex-husband while he is still living. Taking your survivor benefit from your deceased husband will likely be best because it is based on 100% of his SS amount when he died, whereas your ex-spouse benefit from your living ex-husband is based on 50% of his FRA entitlement. To get an ex-spouse benefit from your ex-husband (which you can't get until you are 62), your own SS retirement benefit would need to be less than 50% of your ex's FRA entitlement.

As you know, you will be eligible for survivor (widow's) benefits from your deceased husband when you are 60 but be aware that by taking your survivor benefit at 60, it will be reduced for early claiming. Rather than 100% of your husband's SS benefit, at age 60 you will get about 71.5%. Your surviving spouse benefit reaches maximum at your full retirement age (FRA) of 67 and will grow to that point but will be reduced if taken prior to that.

Also, if you are working, Social Security's "earnings test" will apply until you reach your full retirement age, so your plans for working may influence your decision on when to claim your widow's benefit. If you exceed the earnings limit (\$22,320 for 2024; it changes annually), Social Security will take away \$1 in benefits for every \$2 you are over the limit. They "take away" by withholding future benefits until the penalty is satisfied, which means you would go some number of months without benefits. And, if you substantially exceed the earnings limit you may even be temporarily ineligible for any

SS benefits (until you earn less or reach your FRA - the earnings test goes away at your FRA).

If you claim your surviving spouse benefits from your deceased husband first, and your ex-husband later dies, you do have the option to switch to the higher survivor benefit from your ex-husband. In effect, if both husbands are deceased, you have a choice which benefit to take (and, obviously, you'd chose the higher of the two).

None of this, however, happens automatically. To claim your surviving spouse benefit you will need to contact Social Security directly at 1.800.772.1213 (or call your local SS office) to make an appointment to apply for widow's benefits.

California Schools Face Twin Perils: Chronic Absenteeism and Declining Enrollment

California's public schools have a numbers problem and it's not just that their students don't score very highly in national tests of mathematics ability.

Their other numbers problem is the financial squeeze posed by declining enrollment, especially in large urban districts, compounded by apparently growing levels of chronic absenteeism, or truancy.

percent of "Thirty California public school students were chronically absent from school in 2021-22 — a near tripling of the percentage in 2018-19," the Public Policy Institute of California declared in a recent report. "Although we do not know if this stark increase in chronic absenteeism, defined as missing at least 10% of the school year or at least 18 days, will continue, the data from last year raises concerns about the pace of students' learning recovery after the educational setbacks of the COVID-19 pandemic."

California is one of just seven states that base state financial support of local school systems on attendance, rather than enrollment, so the declines in enrollment and attendance comprise a double financial whammy, one of the reasons many school districts are facing budget deficits.

Enrollment is an immutable effect of demographic change,

both the out-migration of young families to other states and lower birth rates. Chronic truancy, on the other hand, first became notable during the COVID-19 pandemic, when schools were closed for months and many students were unable to keep up with studies via the internet.

Another report from the Public Policy Institute of California found that "schools with greater increases in chronic absenteeism saw steeper drops in proficiency rates on the Smarter Balanced (SBAC) English and math tests, when comparing pre-pandemic levels (2018-19) to 2021-22."

During the pandemic, the Legislature and Gov. Gavin Newsom temporarily deviated from basing state aid on attendance, given the massive dislocation of school closures. The situation also reinvigorated an old debate over whether using attendance is outmoded and California should shift to an enrollment-based system.

Policy Analysis for California Education, a think tank maintained by the state's major universities, chimed in with its own take on the issue, to wit: "We find that about 90 percent of districts would receive more funding under an enrollment-based formula than they would under the current ADA-based system, with the biggest boost going to high school districts and districts with more low-income, English learner, and foster youth students."

ADA refers to average daily attendance.

The analysis estimated that switching to enrollment would cost about \$3.4 billion a year, since truant students would still qualify their schools for aid. It cautioned, however, that while "switching from attendance to enrollment may help districts gain greater fiscal stability and may shift more resources to school districts with greater student needs," on the other hand, "the current system includes a fiscal incentive that, most agree, encourages higher attendance, even if that attendance definition is relatively weak."

In other words, switching to enrollment would take schools off the hook in battling truancy.


Last year, Anthony Portantino, a Democratic state senator from Glendale, introduced legislation, backed by the public education establishment, including state schools Supt. Tony Thurmond, to make the change.

"Enrollment-based funding ensures that California schools are funded more equitably and have greater financial stability and predictability," Portantino said.

However, with the state facing chronic budget deficits of its own and barely able to supply schools with their constitutionally mandated levels of money, Senate Bill 98 faltered. It eventually morphed into merely an instruction to the Legislative Analyst's Office, the Legislature's budget advisor, to study the effects of changing to an enrollment-based system and report on it by Jan. 1, 2026.

That's known in political circles as kicking the can down the road, a time-dishonored way for officials to avoid making decisions.

"You shall make no idols." "Stay focused on Me" might have made a more optimistic rewrite for God's idea of discouraging theological adultery.



I'm concerned that if she can't handle her finances on her own, what will happen if we move in together? Your advice would be appreciated.

I can't say if she's technically bankrupt at this point. But for starters, she definitely needs to sell the car and find a cheaper place to live. I'm also not

sure how long you two have been seeing each other, but this is someone to keep dating, not marry or let move in.

The hard reality is that bankruptcy's not going to solve anything if she's got a heart problem. By "heart problem," I mean if she buys things thinking stuff will make her happy and living way beyond her means in the process. Lots of folks mistakenly think they are where they live or what they drive. Those are the kinds of heart problems I'm talking about. And it's the way I was years ago before going broke knocked some sense into me. It wasn't until then I realized I had to make some serious changes in my life.

Don't get me wrong. What I've just said doesn't mean this lady's a bad person. It just means she's got some growing up to do. And all the money matters aside, you don't just up and quit your job without a solid plan in place unless there's a serious matter of principle at stake, or you're the victim of abuse or harassment. Leaving one job for another is fine. But the idea of suddenly deciding you just don't like something, then walking away from it when you've got a bunch of financial obligations, is just plain irresponsible. You don't jump off the dock until the boat arrives!

Again, I don't know all the details behind her finances, but chances are she's not bankrupt. There are some character issues in all this that need to be addressed, though. If it were me, I'd suggest she spend some time seeing a good financial counselor-one with the heart of a teacher. 

areas such as schools, parks and churches, and also looks at police records and the potential for public nuisance.

If a proposed business is located in an area considered by ABC to be over-concentrated with existing alcohol sale licenses, the applicant must request a Letter of Public Convenience and Necessity (PCN) from the City Council.

Additionally, under the current code, the applicant must also obtain a use permit from the Citrus Heights Planning Commission. So many applicants must go through at least two reviews, with many requiring all three.

Staff found that these various reviews are duplicative and repetitive, and the time and cost needed to navigate the process could discourage new businesses. The proposed amendment would remove the requirement for a use permit, if the new business had standard operational hours (closing by 10 p.m. on Sunday through Thursday and 11 p.m. on Friday and Saturday). But non-standard operations would still require a use permit through the Planning Commission.

Under this change, new

businesses in under-concentrated areas would only need to undergo Alcoholic Beverage Control review for licensing, and any in over-concentrated areas would then apply to the City Council for a Letter of Public Convenience and Necessity. The city retains its ability to protest any license application submitted to Alcoholic Beverage Control.

During the public hearing, Citrus Heights Chamber of Commerce Executive Director Sheri Merrick said she supported the change: "It will help our business community immensely."

The city also received a letter of support from Sunrise MarketPlace Business Improvement District Executive Director Kathilynn Carpenter.

Mayor Karpinski-Costa said, "We don't want to be known as the city with more red tape than we need to have," and City Council voted unanimously to approve the zoning code updates, including the change to alcohol sale application review.

Council next considered an Economic Development Support Fund request from the Citrus Heights Chamber of Commerce for a \$25,000 grant. The city's Economic Development Support Fund provides grants and sponsorships to business associations, businesses and other organizations to support economic development within Citrus Heights.

The Chamber of Commerce requested \$10,000 for the annual Chairman's Circle sponsorship (which the city has sponsored since 2012), \$7,000 for the annual cost to rent the Citrus Heights Community Center to host monthly chamber luncheons and \$8,000 to support relocating its office to a more central location within the city.

City Council voted unanimously to approve the total funding request of \$25,000 for the Citrus Heights Chamber of Commerce.

The Citrus Heights Police Department (CHPD) brought back the updated nuisance camping ordinance. At the last meeting, City Council voted to approve it but with an exception for passenger vehicles to ensure people living out of their cars would be able to find somewhere safe to sleep. Before the change went into effect, the Citrus Heights Police Department wanted to offer some additional information.

According to the Citrus Heights Police Department, the updated ordinance against nuisance camping would increase public safety, reduce blight and bring the city's ordinance in line with recent legal updates at the state level. But creating an exception for passenger vehicles would limit officers' enforcement ability in cases of nuisance camping, particularly because there is a broad definition for passenger vehicles that can include RVs, motorhomes, vans, trucks, cars and any non-commercial vehicle that carries passengers. Citrus Heights would also be the only city in the region that would have a specific exception for vehicle camping.

During the meeting's Public Comment, several members of the public asked the council to maintain the exception for passenger vehicles, since there are limited housing options for homeless people and a car might be the last safe space available to them.

One resident cautioned that as the only city in the region with such an exception, it could encourage people from other areas to come to Citrus Heights to take advantage of the loophole for vehicle camping.

Citrus Heights Police Department Chief Alex Turcotte affirmed that the ordinance is not a mandate that officers must enforce, just a tool that gives them the ability to use their discretion on a case-by-case basis. Turcotte said that Citrus Heights Police officers have compassion for the homeless population and work with partner agencies to refer people to supportive services. Turcotte said they must balance that compassion with "the rights of the other citizens" to enjoy the city, access services and maintain their properties.

Councilmember Middleton said it was a difficult decision but she had faith that the Citrus Heights Police Department will "find that balance."

Karpinski-Costa agreed and said, "I trust the police department."

Councilmember Schaefer said he did not want to exclude motorhomes. Since those are included in the passenger vehicle definition, Schaefer made a motion to update the ordinance to remove the passenger vehicle exclusion. City Council voted unanimously to approve the nuisance camping ordinance as originally presented, without the exclusion for passenger vehicles.

The next Citrus Heights City Council meeting is scheduled for 6 p.m. Sept. 25 at City Hall, 6360 Fountain Square Drive. ★


