

YUBA CITY, CA (MPG) - The 49ers, Yuba College's resident football team, received a complete overhaul this summer with a new staff of coaches and players.

Tim Mulvehill, 49ers head coach,

Citywide Competition Brings in Dozens

YUBA CITY, CA (MPG) - Local opinion matters here.

So much so that city officials left it up to residents to redesign and name the town welcome sign and revamp the water tower and city mural.

Since March, Yuba City Senior Engineer Josh Wolffe has spoken about improvements on Plumas Street under the water tower and the murals adjacent to the water tower and along Center Street, funded by a 2022 Clean California grant for \$2.2 million.

Each project called for committee formation.

The Territorial Dispatch has followed both the Welcome Sign and Plumas Water Tower Plaza competitions, most recently reporting on the winning artist and resident Raveena Sroya's use of color, wildlife, and agriculture to welcome and bid farewell to visitors.

This time, it's all about the Plumas Street Water Tower, which offers another chance for any local to reflect their brand with the city.

came on in June with the goal of "rebuilding, reviving and refreshing" the team from the ground up.

"Through our online poll, we received 94 separate submissions, containing about 64 different names," Wolffe said. "We also received numerous suggestions via Facebook comments and one hardcopy name submission."

Like the welcome sign mural, the water tower and mural project has a committee comprised of two council members and Planning, Senior, Youth, and Parks and Recreation Commission representatives.

"It is important to involve the various commissions listed above, as they represent many facets of our diverse community; their input will help guide the decision in the direction that represents the community's desires well," Wolffe said.

Wolffe said the Water Tower Plaza Name and Mural Designs Ad Hoc Committee formed to ensure a fair and best-interest selection of the mural design and plaza name.

"It was important to include the business owners, Downtown Business Association, and Yuba Sutter Arts because they are directly adjacent to this plaza and, therefore, are direct stakeholders in this project," Wolffe said.

Mayor Shon Haris and Vice-Mayor Dave Shaw sit on the committee, whose approval determines the permanent marking in the city.

Adventure Awaits at the California Swan Festival

MARYSVILLE, CA (MPG) - The fall season brings acres of flooded fields to the Yuba Sutter region as farmers prepare for next year's crop. Water works its magic on the soil, breaking down waste and thwarting weeds, while the artificial wetlands that emerge give refuge to millions

of migrating birds along the Pacific Flyway.

Swans and snow geese are among the most recognizable species that come to rest their weary wings. The sheer number of their arrival inspires crowds of photographers, birders and curious passers-by each year. It is this annual spectacle that sparked the creation of the California Swan Festival, a three-day event that will return to Marysville from Nov. 8 to Nov. 10.

"Our festival highlights the graceful and elegant Tundra Swans that stand out among the teeming masses of waterfowl and shorebirds, encouraging you to seek out the star of the show," said Alyssa Lindman, the Sutter Buttes Regional Land Trust executive director. "Each species has unique behaviors like feeding, *Continued on page 2*

preening, and posturing that are fascinating to observe. We're thrilled to bring this event back to our region, offering families and especially youngsters a oneof-a-kind experience."

Previously, the Swan Festival was hosted by the Yuba-Sutter Chamber of Commerce but a new partnership this year has been forged with the Sutter Buttes Regional Land Trust (SBRLT). Organizers say that this merge will highlight regional conservation efforts while bringing awareness to the importance of wintering waterbirds and other diverse wildlife migrating through Yuba, Sutter and Colusa counties.

"Ultimately, it felt like a good fit for us to take over and I was really excited about that because we didn't have any large outreach events like this," Lindman said. "It was challenging but I think the rewards and benefits from getting back up and running are so meaningful to the community."

This year's California Swan Festival exhibit hall will be stationed at the Yuba College campus in Maryville, located at 2088 North Beale Road. Here, guests can enjoy a vendor fair and a free Kids' Zone with activities, live animal presentations, and expert presenters.

West Coast Falconry is expected to be in attendance with opportunities to take photos with their birds and NorCal Bats will return with up-close encounters with a variety of bat species. Another return exhibitor will be Barbara Steinberg of California Watchable Wildlife, a group aimed at celebrating the state's

wildlife and diverse habitats by acknowledging and elevating the value that wildlife viewing brings to individuals, families, communities and industries.

"California Watchable Wildlife and Sutter Buttes Regional Land Trust are very much aligned with a mission of preservation and conservation of our open spaces and agricultural lands," Steinberg said. "We are a statewide program but our concerns for rural regions, like the Yuba-Sutter counties, is paramount. A lesser-known destination, we hope to grow the economy for the region and SBRLT through our joint efforts."

In addition to the exhibits deployed at Yuba College, guests can register for a variety of tours catered to outdoor enthusiasts of all ages and levels of experience. From kayaking the Feather River to hiking the sacred lands of the Sutter Buttes Mountain range, adventure can be found at the California Swan Festival. Other less strenuous tours include sightseeing at a local winery or sunset caravaning to witness evening "fly offs" where thousands of birds take to the sky in their nightly ritual.

"It's truly a breathtaking sight," Lindman said.

Tour registration will open on Oct. 8. For more information about the California Swan Festival or to register for tours, visit caswanfestival.org. Organizers stated that excess proceeds from the event will be used to benefit the Sutter Buttes Regional Land Trust's mission,

Continued from page 1 with school, housing, commuting, meals and more and stay on call for them at any hour of the day or night.

"I get worried about the boys, I'm always thinking 'Did they make it to practice? Did they make it home? Did they eat?' So we're there to help them emotionally, mentally, spiritually and physically and I hope they get that," said Martinez. Financial struggles have also been an issue for the team, especially those new to the area. With long commutes and rising prices, Mulvehill estimates, at least a dozen of his players are currently unhoused or living in their vehicles. In an effort to combat this, Jeff Stephens, founder of a local nonprofit organization known as SAYLove, arranged a spaghetti feed fundraising dinner on Sept. 20 at Hope Point Nazarene Church in Yuba City.

"You know, I've lived in this area forever and I've never gone to a Yuba College game or don't know too much about the program," said Stephens. "But I'm getting excited about it because he's talking about what he's coming out more and being a part of the atmosphere and everything, so I think it's going to be really good for this area," added Stephens.

While the spaghetti dinner might not have garnered the attendance that organizers were hoping for, the message of support was clear. Funds here will go toward providing access to resources such as academic counseling and support, proper hydration, nutrition, technology, equipment and travel necessities. MARYSVILLE, CA (MPG) - The Yuba Sutter Rotary Night Club is proud to announce its latest gift to the community with the unveiling of its first two-story, portable "Little Library."

Dubbed "LL1," the flagship unit will be based at the Sutter Theater Center for the Arts. This Little Library is different than the permanent units that have popped up around Yuba Sutter over the years. These unique new Little Free Libraries, in addition to being much larger than standard, fixed single shelf libraries, are portable with three shelves and are designed to be rolled in and out of businesses during normal operating hours or for special events thus ensuring their longevity and maintenance.

Books for all ages will be stocked; from children's book to young adult books to reference books, non-fiction, fiction, poetry, and so much more. The Little Libraries will also have information about our local libraries and their programs too.

The Yuba Sutter Rotary Night Club identified the need for greater access to books, especially considering the reduced hours in the public libraries due to budget cuts. Club members gathered for a construction party a few weekends ago and, voila, "LL1" sprang to life!

Pam Nowak, club member and artist, lent her remarkable talents to decorate the library with images of characters leaping from open books. "LL1" will be deployed outside the Sutter Theater Center for the Arts at the corner of Church and Plumas Streets starting on Friday, Sept. 27, just in time for opening night of "Jekyll & Hyde, the Musical," at the Theater.

The introduction of this new program by the Yuba Sutter Rotary Night Club is timed to coincide with two important related events. First, September is Rotary Literacy Month, a time dedicated to emphasizing

the importance of literacy in our communities. Throughout this month, Rotarians worldwide will engage in initiatives to promote reading, education, and lifelong learning. The organization recognizes literacy as a foundational skill that empowers individuals, transforms communities, and breaks cycles of poverty. The goal is to make literacy a priority and to foster an environment where everyone, especially children, has access to the resources they need to develop strong reading skills.

Last week, Sept. 22-28, was also Banned Books Week, established by the American Library Association in 1982. Little Free Libraries began in 2009 when Todd Bol, a resident of Hudson, Wisconsin, built a small model of a schoolhouse, filled it with books, and placed it in his front yard. This simple act of sharing books with neighbors quickly gained traction. By 2023, there were over 150,000 registered Little Free Libraries in more than 100 countries. A central part of these efforts is ensuring that books are accessible to all, regardless of socio-economic status.

Together, these initiatives

District 5 Candidates Put Forth Their Platforms

YUBA CITY, CA (MPG) - Last Wednesday, an open-tothe-public Candidates Forum was held for Yuba City Council District 5 running candidates, which are Toni Cole, John Buckland and Vincenzo Corazza, homelessness and budget cuts.

Janell Willis, the Yuba Sutter Chamber of Commerce executive director, and Robert Bendorf, a retired county administrator and advisor, moderated the evening's event and gave 90 seconds knowledge of city operations and inner workings, and I understand the passion folks have for making things a little bit better. Both candidates had dif-

Cole added, "Development is how we attract business and revenue. We want to engage youth. Some are graduating with no skills. After taking a few more questions, closing arguments commenced.

Emphasizing his experience on the council and as a retired police lieutenant, Buckland said, "I know how to get funding for things and I wrote a number of grants to improve the quality of life. There are things in my past that I accomplished; the greatest was serving on the council to represent the citizens." Cole finished by saying, "Lots of military settled here and it has been built on their backs. I would like to bring that culture back. I lived in New Orleans and people don't leave that city. Sometimes, it takes leaving home to realize what you have here. I will speak to my candidacy. I do offer a new perspective that is eclectic." All candidates are running in the upcoming November election.

who is the 'proxy' candidate on the ballot.

Corazza explained his unique position and then left immediately.

"I don't fit the mold as a volunteer candidate. A direct democracy model is where you get to participate in the voting process. I act as a conduit. A proxy member polls the democracy and District 5 is experimenting," Corazza said.

After Corazza's exit, Cole and Buckland continued taking questions. Some topics discussed were the proposed 1% sales tax increase, Prop 36, for opening statements, 30 seconds for each answer and two minutes for closing statements. Twelve two-part questions were asked of each candidate, each answered accordingly and were given time to rebut.

Cole started by explaining why she wants this position.

"Civic virtue is very important to me. American values are very valuable," Cole said.

Buckland responded by saying, "I've served on council for eight years and I'm a longtime resident of Yuba City. I have fering opinions when it came to the proposed 1% sales tax increase, which would bring it to 8.25%.

Cole said, "I am in favor of this tax. Our city is like a household. You have to adjust your budget."

Buckland opposed the tax increase and said, "I cannot support Measure D as it is currently structured. This will last forever."

When it comes to bringing new business to the region, Buckland said, "When a business like Costco comes around, we don't push them across the bridge. You have to work with them to get the spend their money." Proposition 36, the initiative that would increase punishment for theft and other crimes, was discussed.

Buckland said, "If we don't pass it, we are going down a very slippery slope. We need to make sure we are enforcing and there has to be consequences for recidivism in continued activities."

Cole added, "I'm an emphatic 'yes' on Prop 36. It will hopefully fix the next generation. If families aren't doing what they should, then there should be law and order. The law seems to be on the side of the criminal. I believe in due process. We have to have Prop 36 passed and our jails and DA staffed to prosecute these guys. Sometimes, people have to hit rock bottom before getting better. Some people think it isn't compassionate but I think it will help people in the long term."

as the council will be involved in final approval of the name," Mayor Harris said. "Being engaged from the beginning allows us to be immersed in the process and work shoulder to shoulder with the community members involved in the process."

The mayor said the process "allows us to hear their priorities, perspectives and desires directly from them."

"The park, and its name, will become an instant staple in Yuba City for generations to come," Harris said. "Accordingly, it is important that we understand that, take the decision seriously, and play an active role in the process."

The senior engineer agreed.

"We wanted to provide the entire community with the opportunity to submit ideas for names, such that we would name the plaza in alignment with the Community's desires," Wolffe said, adding the name must comply with the City's Park Naming Policy.

Officials will consider the names at an upcoming meeting. \star

Resident Brings Safety Concerns to Council

YUBA CITY, CA (MPG) - Kristy Macy does not feel safe in the home she has lived in for almost two decades.

It hasn't always been this way, according to the local who raised her concerns before the Yuba City City Council at the Sept. 10 meeting.

As in every regular meeting, Mayor Shon Harris notes the three-minute limit "appearance of interested citizens," who can speak on concerns.

As usual, Harris noted that public comment can be "on anything within the scope of the city's jurisdiction, including items not listed on the agenda." However, citizens who want to make a point can turn in written requests 24 hours prior to the meeting, giving them five minutes to speak.

Macy did that.

"There have been three years of dangerous activities and deplorable conditions occurring at the neighbor's house next door, 640 Tabor Ave.," Macy said, adding that the property is unique in that it "end caps" the block.

"I have owned this property since 2003 and I have lived next door to my neighbor, David Hope, who inherited the property after his mother died," Macy said, adding her "developmentally delayed and elderly neighbor personally shared concerns about keeping up the property after his mother died."

"Instead of moving out and going to some sort of senior-assisted property, he started to invite

criminals and transients to his property," Macy said.

Macy used up all five minutes to detail specific concerns. Due to the law that city officials cannot speak during public comment, the Territorial Dispatch contacted city officials after the meeting regarding Macy's concerns.

Deputy Development Services director Doug Libby said complaints regarding 640 Taber Ave. have occurred over the years. City Manager Diana Langley said the Yuba City Police Department has responded to multiple calls for service to the property and continues to do necessary enforcement as needed.

Libby said the most recent complaint activity began in April 2023.

"Since that time, 15 complaints have been received," Libby said, adding issues raised range from onsite trash accumulation, multiple recreational vehicles on the property with people living in them, and improper disposal of grey water.

"Other complaints received relate to the poor condition of the home," Libby said.

Langley said, "The city is sympathetic to Ms. Macy's situation, as well as the similar plight of the other surrounding neighbors."

"We encourage Ms. Macy and her neighbors to continue to call the Police Department and code enforcement so that we can document and address the issues," Langley said.

Macy shared why she said Hope's home became a "transient flophouse."

"In my opinion, he is being taken advantage of because of some of his inability to see the criminal activity going, specifically when he moves in Johnathon Wayne Peterson, who is a wellknown criminal in this area," Macy said, adding that Peterson took complete control of the property in 2022. "He stalked and harassed me and my son for the time that he was there."

Macy said that she began contacting law enforcement and probation departments because Peterson "wasn't being supervised."

However, Macy said, the "regular acts of intimidation, threats of violence, damage to the property" continued.

"He was deflating tires on our cars, prowling, and was killing cats and leaving them on my driveway," Macy said. In 2022, Massey said Peterson was arrested for his behavior, due to a "very violent evening" between her and Peterson. Macy said after Peterson, a woman named Antonia Madrid, who Macy alleges has a "long criminal history of manufacturing methamphetamine," moved in.

"The amount of deplorable conditions has escalated," Macy said. "The criminal organization, which is all I can call it, is happening, including methamphetamine manufacturing, selling, prostitution, selling animals, has gone on for two-and-a- half years."

Yuba City Police Chief Brian Baker said there is no credible information that drugs are being manufactured on the premises.

"We will continue to patrol the area and address matters of a criminal nature as they present themselves," Baker said.

Libby said the Department of Code Enforcement coordinates with the Police Department where a complaint includes a criminal component.

"Code enforcement officers have had ongoing coordination to push for action. Four citations have been issued with fines totaling \$1,960," Libby said. "Due to the fines being unpaid, the City Council unanimously acted on July 16, 2024, by adopting Resolution 24-101 that placed the unpaid fines onto the annual property tax bill."

Baker said his department strives to respond to and handle complaints regarding criminal activity. residence, we have been working with our partners in code enforcement to address the concerns of the neighborhood," Baker said.

Macy said at the end of 2023, she "was told by law enforcement I should file a civil lawsuit."

"So I went through the process of filing a civil lawsuit, and in February, I received a judgment of one million dollars and for all nuisance activity to stop immediately," Macy said.

It hasn't stopped, according to Macy.

"I want to stop and say, I reported a lot of this and have been in regular contact with code enforcement and I am not here to demonize any of these agencies," Macy said.

Macy said she speaks for other citizens who are scared to come forward.

Langley said while Macy's situation is monitored, "the City Council and city staff encourage residents to share their public safety concerns so that we have awareness and can take appropriate action, within the city's authority, to address the concerns."

Libby said, "The property owner needs to be motivated by monetary fines to take corrective action."

"The city is continuing its efforts with code enforcement exploring available legal remedies to abate the private property violations," Libby said.

Mayor Harris said officials "hear her concerns, sympathize with her, and will continue to address the problems as best as possible."

SUTTER COUNTY, CA (MPG) - Sutter County Sheriff's Office, along with agents of the Department of Alcoholic Beverage Control (ABC), have cited two clerks for selling alcohol to minors on Sept. 26. The actions were the result of a Minor Decov operation in which minors under the direct supervision of department agents, attempted to purchase alcohol from seven retail licensees in Sutter County.

Sacramento Kings fans will be watching with great interest, as training camp begins Oct. 1, and there will be long shots looking to make the team. Names like Terry Taylor, Skal Labissiere, Jalen McDaniels, Colby Jones, Boogie Ellis and recent invite Justin Powell are but a few of the players with aspirations of making the big club roster.

Add Orlando Robinson's name to the list, but Orlando could potentially have a good chance of making the opening day roster because of his NBA experience with the Miami Heat, and his size. Robinson at 6'10" represents the type of front court player the Kings are in desperate need of, and he showed flashes with Miami that give the Kings hope that this aspiring 24-year-old may be able to provide some valuable minutes off the bench.

Without question Sacramento will be leaning on the talents of power forward Trey Lyles, who at 28 is in his prime, and showed Kings fans last year that even coming off the bench, Trey can be an impact player. Like his teammates De'Aaron Fox and Malik Monk, Lyles came to the NBA from the Kentucky Wildcats and was drafted twelfth overall in the 2015 NBA draft by the Utah Jazz. Trey spent time with the Denver Nuggets, San Antonio Spurs and Detroit Pistons, before being acquired by the Sacramento Kings in February of 2022.

Lyles found a home in Sacramento, and his production immediately took a jump, as the Kings gave their young big man an average of nearly 23 minutes per game. Showing this kind of confidence led to Lyles most productive season as a pro, and in 2022 Trey averaged 10.6 points per game.

The last two seasons, for reasons that are difficult to understand, Lyle's time on the hardwood has diminished, and with it his scoring as well. Averaging seven points per game, Lyles has struggled to get the consistent playing time he needs to be a double-digit contributor, and I am hopeful, that coming into his prime and going into his fourth season as a Sacramento King, coach Brown will give this talented forward more time on the court.

As fans we each have our favorites, but in Trey Lyles I see a player that needs to feel the confidence of his team and his coach, and I would like to see how he would produce in a starting role.

The Kings have been unable thus far to land an impact power forward, and it may be inevitable that they may have to look from within or continue to build this roster via the draft.

Without question Monte McNair has had opportunities to land an impact forward, but I give him great credit for passing up on trades that would have sent the Kings in the wrong direction. Too many NBA general managers are looking for steals, and I love the fact that McNair has kept the fabric of today's team intact.

Many pundits and I could myself as one, feel that with the addition of DeMar DeRozan the Sacramento Kings have arrived, and without that elusive forward they have been seeking, I want to see what the team we have assembled can do.

In just a little over a week the Golden State Warriors come to town, and thirsty for basketball Kings fans will get their first taste of the new look Kings.

I can't deny that I will miss Davion Mitchell, but I am also very curious to see what newcomers like Orlando Robinson or Boogie Ellis may contribute. Is there a diamond in the rough on this team?

I don't know that I ever expected to read or hear that NBA pundits would rate the Sacramento Kings as the best basketball team in the state of California, but that is exactly what is occurring.

The LA Lakers, Golden State Warriors, and LA Clipper do not represent bad basketball teams, so to be touted as the best of them, should be something to make every Sacramento fan smile.

So, break out those cow bells Kings fans, and get ready to light the beam 50 times or more! It can happen and I expect it to happen!

Statement from Rep. LaMalfa on Passage of the Fix Our Forests Act

Office of Rep. LaMalfa News Release

WASHINGTON, D.C. (MPG) - This week, the House passed H.R. 8790, the Fix Our Forests Act, a strongly bipartisan piece of legislation focused on improving forest management and reducing the threat of catastrophic wildfires. The act promotes enhanced cooperation among federal, state, and tribal land managers while strengthening local restoration efforts.

Rep. LaMalfa (R-CA), released the following statement:

"The Fix Our Forests Act is a hard-fought bipartisan compromise that will begin getting the work we need done in our forests to reduce fuels and risk of major wildfire. This bill starts to peel back the bureaucracy and limit some of the lawsuits that have hampered so many good forestry projects. I was happy to see my bill to increase the use of grazing on federal lands to reduce fire fuels, as well as my bill to provide greater setbacks near powerlines to prevent trees from falling into them and starting fires, were included. Fix Our Forests combined with the reforms in the bipartisan Farm Bill we are hoping to pass this fall will make a huge difference in finally addressing our forest management crisis," said Rep. LaMalfa.

The Fix Our Forests Act streamlines the consultation process for the U.S. Forest Service and Bureau of Land Management, preventing environmental groups from stalling projects or forcing unnecessary revisions to management plans. Additionally, the act mandates clearer reporting on hazardous fuels reduction efforts, addressing prior misrepresentation by federal agencies regarding the number of acres treated. It also explores the establishment of a Western headquarters for the U.S. Forest Service.

The bill also incorporates Rep. LaMalfa's language to expand

the clearance zone for hazardous trees around electric power lines, and his bill, H.R. 7666, was included as an amendment that directs the U.S. Forest Service to expand the use of livestock grazing in fuels management programs.

Congressman Doug LaMalfa is a lifelong farmer representing California's First Congressional District, including Butte, Colusa, Glenn, Lassen, Modoc, Shasta, Siskiyou, Sutter, Tehama and Yuba Counties.





Gallagher Applauds Request for Major Disaster Declaration for the Park Fire

SACRAMENTO, CA (MPG) - Assemblyman James Gallagher (R-Yuba City) applauded California's request for a Presidential Major Disaster Declaration to assist with the recovery from this summer's Park Fire.

If granted, the Major Disaster Declaration would unlock access to federal assistance including FEMA Individual Assistance and Hazard Mitigation programs, U.S. Small Business Administration Disaster Loans and U.S. Department of Agriculture Emergency Loans for residents and businesses in Butte and Tehama Counties that were impacted by the fire.

"I'm glad to see the state recognize the challenges facing Butte and Tehama Counties as they work to recover from the Park Fire," said Gallagher. "Everyone impacted by this fire has shown remarkable resilience, but they can't do it alone. No more delays - all levels of government need to step up and get these folks the help they've been asking for."

The Park Fire was started on July 24, when a violent sex offender pushed his burning car into a ravine in Chico. The fire exploded in the following days, eventually becoming the fourth largest wildfire in California history, burning 429,603 acres and destroying more than 700 structures.



Avoiding the Poor House in Plumas Lake

Just imagine paying on eleven school bonds, with more to come. That's exactly what the Plumas Lake (PL) community is facing on election day. And PL is already the most expensive place to live in Yuba-Sutter Counties.

Plumas Lake residents will see five new local school bonds on their ballots Nov 5. They currently pay for six.

Plumas Lake Elementary School District (PLSESD) wants three bonds (Bonds D, E, F) and Wheatland High School District wants two bonds (Bonds B and C). Voters rejected similar bonds in March 2024, which followed prior attempts by the PLESD in 2008, 2016, 2018, 2020 and 2022.

If the five (5) school bonds pass, homeowners, property owners and farmers will be paying on eleven school bonds for almost 40 years. Every school bond increases property taxes.

The State's School Facility Bond Program (matching funds for bonds) is broke. For a bail-out, the State of California has placed Prop 2 on the ballot. That is a \$10 Billion School Construction Bond. If taxpayers say "Yes" they will pay for that bond as well.

A new report from the North State Building Industry Association showed that Plumas Lake and Yuba County are leading in new home sales in the region. Building has been frenzied with no plan to pay for schools. The bond burden for decades will default to home and landowners.

Plumas Lake home and property owners already have tax fatigue - high property taxes, a Mello-Roos facilities tax, other assessments and 6 school bonds.

The Plumas Lake Specific Plan was approved in 1993 – 31 years ago. The plan was never updated. The Specific Plan states, "Because of the population involved, it is likely that an additional two or three middle schools will need to be developed within the Plan area.

In addition, a need for a total of 12 to 15 elementary schools can be foreseen".

Supervisor Gary Bradford recently elected to a third term has ignored the outdated Specific Plan but staunchly supports the wild development. With no other plan in place, the Plumas Lake community is under pressure to pay for more bonds.

Every acre and every structure will be assessed to pay more.

Proponents of the bonds claim that new schools increase property values. It is likely to have the opposite effect. Many people may purchase homes elsewhere to avoid the high property taxes, 11 bonds plus assessments. Property values may plummet. Some will be taxed out of their homes.

Learning can occur anytime, anywhere, and as a life-long process. The future should not include creating more brick-andmortar schools. Many districts are closing and selling school buildings as millions flee the state.

Meanwhile, California has a 30% chronic absenteeism problem (30% of students missing at least 18 unexcused days a year). And the majority of attendees cannot perform at grade level in key subjects. If property owners were not forced to pay for government schools and most children forced to attend them, these schools would be closing faster than a bad taco truck.

Parents should have the freedom to choose where and how their children are trained.

Parents that choose other forms of education like homeschooling, private schools or online courses, should be able to use taxes paid for their students. Forcing property owners with no students to pay for schools is wrong, as well.

People are better stewards of their money than government. Removing these restrictions will provide families more money and choice for education. California families are financially struggling with the high cost of housing, food, gas, utilities, and insurance. To burden homeowners with extra taxes for schools is wrong.

Legislators should remove prevailing wage mandates (originated with Davis – Bacon Act 1931) on school construction. Studies show 25% or more of construction costs could be saved.

Vote No on all bonds and tax measures Nov 5.

Hitch In Higher Ed Master Plan: California's Colleges Still Don't Work Well Together

California's Master Plan for Higher Education, adopted 64 years ago, envisioned that three systems — the University of California, California State University and dozens of community colleges — would cooperatively, seamlessly and inexpensively generate the educated citizenry and workforce a rapidly growing state needed.

The plan assumed that community colleges eventually numbering more than 100 — would provide sub-professional job training to some students while preparing others for transfers to four-year schools.

The state colleges (later state universities) would train teachers, engineers, accountants and other professionals and award master's degrees in some fields.

The University of California would admit students with especially high potential, educate them in scientific and other complex fields up to the doctorate level and conduct research.

It didn't quite work out that way.

The three systems often have been more competitive than cooperative, particularly when vying for money from governors and state legislators. They've erected barriers that make transfers difficult and squabble over academic turf.

Community colleges, for instance, have encountered stiff opposition from the state university system as they sought legislative permission to award four-year degrees in some fields, while the state universities have faced equally tough resistance from the UC system to their efforts to award doctorate degrees.

The master plan's assumption that higher education in California would be inexpensive to students also has taken a beating as other programs and services claimed ever-larger shares of the state budget.

That's been particularly true since 1978, when the passage of Proposition 13, California's iconic property tax limit, forced the state to become the major source of financing for K-12 schools, a role that a 1988 ballot measure, Proposition 98, lodged into the state constitution.

The current state budget allocates more than \$81 billion to K-12 schools while higher education would get less than \$24 billion. UC estimates that a year of attendance at one of its campuses costs about \$45,000.

Finally, students who seek to transfer from community colleges to either a UC campus or a state university face daunting barriers because the three have differing notions of how that should occur, as a new report from state Auditor Grant Parks underscores.

"Although most transfer students who applied to CSU and UC gained admission to at least one campus in those systems, CCC students still struggle to transfer," Parks said in a letter summarizing his agency's audit. "Only about 1 in 5 students who began community college from 2017 to 2019 and intended to transfer did so within four years, and transfer rates were even lower for students from certain regions and demographic groups. The vast majority of students who did not transfer never reached the point of applying to CSU or UC, mainly because they had not earned enough units."

Parks suggests that community colleges could make transfers easier with counseling and giving students "a clear roadmap," but he points out that "another barrier to transfer is the variation in transfer requirements across and within the three systems, which makes the process difficult for students to navigate."

There's nothing that would prevent the three systems from reducing the barriers to transfer that Parks cites, but they have taken only fitful and obviously inadequate steps in that direction.

Parks' report is only the latest bit of evidence that the 1960-vintage master plan never worked out as planned and needs a thorough overhaul if its rosy vision is to even approach reality.

Although the plan's deficiencies have been obvious for years, neither governors nor legislators have expressed interest in making needed changes, because the politics of dysfunction are so daunting.

NEVADA COUNTY, CA (MPG) -On the morning of Sept. 15, about 30 people gathered in front of the Lime Kiln Schoolhouse on Duggans Road to witness the unveiling of a plaque commemorating one of Nevada County's newest landmarks.

The school was landmarked by the Board of Supervisors earlier this year at the recommendation of the Nevada County Historical Landmarks Commission. Originally built in 1868, the present building was built in 1909 following a fire. It served as a school until 1957, when it was incorporated into the Pleasant Ridge School District. The property was then converted into a private residence, currently owned by Shelly Bennett.

attendance were former Lime Kiln students. Rusty Clark, Superintendent of the Pleasant Ridge School District, spoke about the importance of history. Commissioner Mike Kochis, a retired schoolteacher, spoke about the history of pioneer schoolhouses in the western part of the county and Commissioner Felicia Tracy reminisced about attending the school, to which she sometimes rode on horseback.
