# History Represented at the Sikh Parade

**SUTTER COUNTY, CA (MPG)** - Sutter County has been reeling with activity all week as it enters the beginning of the holiday season.

Halloween night gave way to the first day of the annual Sikh Festival which ended with no more than 24 hours to prepare for the 2024 presidential election. Needless to say, it's busy in Yuba-Sutter and the Sikh Festival is easily one of the region's largest attractions.

Each year, the Yuba City Sikh Festival, also known as Nagar Kirtan, draws in around 200,000 people to the area. This festival is one of the largest Sikh gatherings outside of India and is celebrated annually within the Tierra Buena neighborhood surrounding the Gurdwara Sahib Yuba City temple.

Sikhism, also known as Sikhi, is an

Indian religion and philosophy that originated in the Punjab region of the Indian subcontinent around the end

of the 15th century CE. Nagar Kirtan is a Sikh tradition that translates to Nagar (town or neighborhood) and Kirtan, a term for singing Shabads (divine hymns). These events involve a procession of the Sikh congregation who join in singing hymns throughout a town or neighborhood. In Yuba City, Nagar Kirtan started on Friday, which was marked by a 30-minute firework show despite the rain.

Just 45 miles south, at the steps of the Sacramento State capital, a Sikh advocacy group known as the Jakara Movement was concluding its three-week journey from Bakersfield. Here, approximately 30 individuals embarked on a 350-mile walk on foot to raise awareness and commemorate a Sikh massacre that happened in India approximately 40 years ago.

# 'Malling' Fun in Yuba Sutter

**YUBA-SUTTER, CA (MPG)** - Millennials across the region might be shocked to find themselves suddenly relevant again as fashion trends from the '80s and '90s continue to make a comeback. This vintage resurgence has also started to include old pastimes such as roller skating, bowling, going to the arcade and dare we say malling.

"After being cooped up during COVID, people are getting back to shopping at malls," said Glynis Buschmann, a longtime Yuba City resident and community photographer. "Despite mail and delivery services, nothing compares to touching merchandise, interacting with people and enjoying something in the food court."

Rachel Madsen, also of Yuba City, said she never stopped malling. Nathan Jennings of Plumas Lake encourages malling as an alternative to "doom scrolling" and excessive screen

use. "It was my favorite to just get out and have the feeling of independence when I was younger," said Jennings. "No money, no worries, got to hang out with friends. Today, I enjoy the time spent with my daughter just walking around and watching her

shop." A mall, by definition, is a large building or series of connected buildings containing a variety of retail stores and typically restaurants and other opportunities for leisure and recreation. In the United States, open air shopping centers came first

with the establishment of Lakewood Shopping Center in California in 1952. Next came the fully enclosed and climate-controlled version with the opening of Southdale Center in Minnesota in 1956. Fast forward 20 years and more than 25,000 shopping centers came first

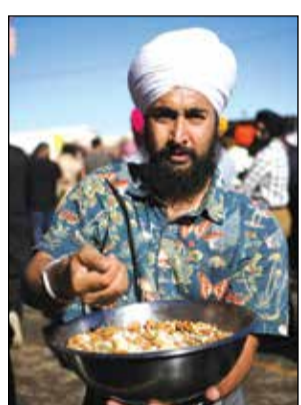

the former Indian Prime Minister Indira Gandhi sent an army to occupy the Golden Temple, the holiest of Sikh sites, to discourage and intimidate Sikh separatists in India who had been advocating for their own ethno-religious sovereign state called Khalistan within the Punjab region. The attack was called Operation Blue Star, and it resulted in the death of civilians, Sikh devotees and Jarnail Singh Bhindranwale, a Sikh religious leader and

political revolutionary. In retaliation, Gandhi's Sikh bodyguards assassinated her and what ensued was a series of anti-Sikh riots that killed thousands. Many Sikhs came to live in America around this time, seeking refuge from the Indian government.

Last year, the California Legislature took action to recognize what happened in 1984 as a genocide as threats of violence against Sikh activists continue to grow in both the United States and Canada. This threat was most recently exemplified with the assassination of Hardeep Singh Nijjar last year in British Columbia.

Locally, a social media post gained traction when it was posted just days before the scheduled Sikh festivities in Yuba City. This screenshot showed a supposed Unclassified/LES (Law Enforcement Sensitive) report from the Federal Bureau of Investigation detailing the possibility of a planned

shooting attempt from Indian organized crime groups with anti-Sikh sentiments.

The Sutter County Sheriff's Office reported no credible evidence suggesting a shooting during the parade; however, various law enforcement groups were heavily armed and present throughout the parade route on Sunday.

Despite these rumors, the Sikh Parade saw thousands congregating along Butte House Road and Tierra Buena Road to shop at the bazaar, witness the parade and partake in an abundance of free food and beverages. For Sikh followers, this event is meant to bring the message of God to the community by showing unity and generosity to one another. The Khalistan movement was also highly visible as Sikh followers continue to advocate for the establishment of their own free state.

The official start time of the parade was 11 a.m., however, it is a

slow-moving procession, one which was not completed until close to 5 p.m. In addition to prayers, hymns and honoring God, the Sikhs use this as an educational opportunity to showcase their history and honor many of their religious martyrs. The knives and swords carried by some members represent the Sikh's warrior spirit and the concept of "Just War" or Dharam Yudh, the action of defending righteousness with war or violence but only as a last resort.

"We're peaceful but prepared," explained one Sikh parade attendee.

Those able to navigate through the crowds and to the Sikh temple were welcome inside to pray and observe. It was said that Sikhs believe all faiths are inclusive and that all paths lead to the one true God. Anyone can become a Sikh, regardless of race, gender or nationality, and non-Sikhs are welcome to participate in Sikh religious services and activities. ★

## Burn Permit Suspension Lifted

### California Department of Forestry and Fire Protection (CA FIRE) News Release

**MARYSVILLE, CA (MPG)** - Nevada, Yuba, Placer and Sutter Counties burn permit suspension lifted effective Friday, Nov. 1, at 8 a.m.

CAL FIRE Nevada-Yuba-Placer Unit Chief Brian Estes is formally cancelling the burn permit suspension and advises that those possessing current and valid agriculture and residential burn permits can now resume burning on permissible burn days.

Agriculture burns must be inspected by CAL FIRE prior to burning until the end of the peak fire season. Inspections may be required for burns other than agriculture burns. This can be verified by contacting your local Air Quality Management District.

Residents wishing to burn

MUST verify it is a permissive burn day prior to burning by contacting:

Nevada and Sierra Counties – Northern Sierra Air Quality Management District. Northern Sierra's burn day website: <https://myairdistrict.com/> (530) 274-7928

Yuba and Sutter County – Feather River Air Quality Management District: (530) 741-6299

CAL FIRE burn permits will be required until cooler temperatures, higher humidity and the chance of winter weather diminish the threat of wildfire. Property owners and residents are asked to use caution while conducting debris or agriculture burns, follow all guidelines provided and always maintain control of the fire. Individuals can be held civilly and/or criminally liable for allowing a fire

to escape their control and/or burn onto neighboring property.

**Pile Burning Requirements:**  
Only dry, natural vegetative material such as leaves, pine needles and tree trimmings may be burned.

The burning of trash, painted wood or other debris is not allowed.

Do NOT burn on windy days. Piles should be no larger than four feet in diameter and in height. You can add to pile as it burns down.

Clear a 10-foot diameter down to bare soil around your piles.

Have a shovel and a water source nearby.

An adult is required to always be in attendance of the fire.

Safe residential pile burning of forest residue by landowners is a crucial tool in reducing fire hazards. For more information on burning, visit the CAL FIRE website at [www.fire.ca.gov](http://www.fire.ca.gov). ★

Additional research shows that the area immediately surrounding the home is the most critical for preventing ignition from embers.\*

Here are a few simple steps to create five feet of defensible space around your home:

Remove bushes, trees, and plants within five feet of your home

Clear out pine needles and debris from your gutters and roof



3

Move BBQ grills, patio furniture, and anything combustible from the sides of your home

# Sam's Arena Officially Up and Kicking

*Yuba City celebrates renovations to its only indoor soccer arena*

**YUBA CITY, CA (MPG)** - When Champions Indoor Soccer Arena in Yuba City decided to shut down, Samatha Kruse knew it was time to take action.

As a Live Oak native, she knew how much soccer meant to the local community and how far people would have to drive to access facilities like this elsewhere.

"There's not a lot of places like this around here where you can really just go out and enjoy or have fun as a kind of healthy alternative," said Kruse. "Soccer's not really my personal passion but I love business. I had been looking for my first investment and my mom was super sad about the idea of this place closing, she came here all the time, so I thought it would be a good opportunity to keep it alive and bring the community together."

Kruse now works for a tech-based travel company in Los Angeles and said she felt blessed to be financially stable enough to take on this project as her first business adventure. Bringing Sam's Arena to life was a 20,000-plus-square-foot commitment that included the complete renovation of an indoor warehouse housing two soccer fields, room for spectators, a catering kitchen, arcade and event space.

"It's been a journey and just this last month it's been very, very hectic but I'm glad we got it all put together and ready to go in time for the public to enjoy today," Kruse said. "I'd like to thank my grandpa in particular because he helped me very much

throughout school and things like that to be able to get into the position I am today and the way that I'm able to do all this."

With just over a month in business, Sam's Arena is already kicking up traction. On Oct. 29, the team celebrated its grand opening and official ribbon cutting with the Yuba-Sutter Chamber of Commerce during which they received recognitions from Yuba City Mayor Shon Harris, Yuba City City Council, Doug LaMalfa and Assemblyman James Gallagher.

"We're having a wonderful time celebrating the opening of another business here in Yuba City," said Harris as he presented Kruse with an official proclamation. "Opening a business is not an easy thing as you alluded to already. It takes a lot of work, a lot of unseen work and it shows here today."

The arena's grand opening was heavily attended with several dozen local youth testing the fields and getting a few extra miles out of their Halloween costumes. At 8 p.m., the Amanecidos 530 and Atlético de Madrid, two of the region's undefeated men's soccer leagues, went head-to-head for a highly-anticipated match. The Amanecidos were down 3-0 but pulled it off 10-8, securing their title as league champion, an honor they've now held for five straight seasons. Spectators report that it was a very good game with plenty of action.

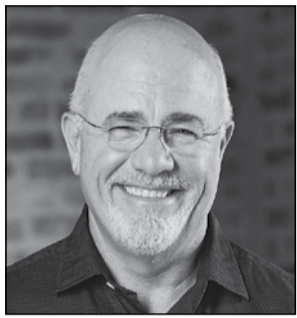

## Reducing Cal Fair Premiums

As an authorized California Fair Plan (CFP) agent, I hear almost daily about how high CFP premiums are for homeowners who have CFP for their fire coverage. In last week's article, I detailed some of the reasons rates on all types of insurance have skyrocketed and you can obtain a copy of that article by emailing me.

Although it is doubtful insurance rates will come down anytime soon, there may be ways to reduce your premiums from CFP by taking a careful look at the coverages and elected options you currently have on your policy.

Your deductible may warrant a look. The deductible is the amount you will pay on certain coverages of your policy before the insurance pays anything. Higher deductibles will reduce your premiums and sometimes by a lot. Consider that in a wildfire, there will be payments in the many hundreds of thousands and a \$20,000.00 deductible may not be felt by the homeowner in a complete wipe out as it will be a very small percentage of the total payout. The flip side of that is if you have a partial loss like a kitchen fire and the bill to rebuild that part of the house comes in at say \$80,000.00, the insurance will deduct the \$20,000.00 and cut you a check for \$60,000.00. So in a partial fire, you WILL feel the deductible yet in a complete obliteration, you may not even care.

Then I always ask the homeowner if they were completely wiped out in a wildfire, would you move or rebuild?

If they say they would move, a detailed review of coverage amounts may be considered. Seeing as if you are wiped clean and your neighborhood now looks like the moon, if you add up all the coverages you may be paid for, you quite possibly will get more than your house is currently worth on the resale market and perhaps a lot more.

Remember that the insurance will build you a new house with all the fixings yet the house you lost was used. So much like a used car versus a new car, the value of your house as it sits now is much less than if the insurance has to build you a new one.

You can see your homes current approximate value on the website Zillow. Now look at your current insurance policy and add up all the coverages listed and you might find the total is a heck of a lot more than what Zillow says your home is worth. Then keep in mind if you move and take the check instead, you will still own the lot which has its own worth, yet perhaps get much more than your homes current value on the resale

market.

If you answered you would rebuild instead of move, it will probably cost a heck of a lot more to build you a new house than the Zillow estimate. In that case, you better be sure your coverages will cover the cost to build a *new home with all new stuff* and up to the current codes. The actual costs could be more than your current coverages. Hence the "will you move" is a valid question to consider.

Speaking of coverages, when agents enter your specific amounts in each sector of the policy, there is no standardized method all agents use to arrive at said amounts. In other words, three different agents may arrive at three different amounts in each coverage sector. Remember that the insurance companies and insurance agents have no way of knowing exactly how much it will cost to rebuild YOUR home with all the specific contents and amenities until the day arrives to do so. Nor will they know what the prices of those things will cost at the time you have an event. Simply put, there are many unknowns when it comes to valuing your home and all its contents. Although there are methodologies available to accurately try and determine adequate coverages of your home and agents will always strive to ascertain an accurate valuation, there is no way of knowing for sure if and when you have an event what the costs will be. Also keep in mind the person responsible for accepting the proposed coverages is you and you alone.

In conclusion, it is tantamount both you and your agent should be forthright in obtaining all information required and use due diligence in accessing what your specific needs are as to coverage amounts. Once that is done carefully and with great detail, you might find it is possible to reduce your insurance costs and still be adequately covered as best as can be estimated at the time the policy is written.

## California's Transition Off Carbon Fuels Could Upset Gasoline Supply, Prices

California motorists buy and consume a billion gallons of gasoline each month and are very sensitive about pump prices, which are markedly higher than those in other states. Naturally, they are a political football.

Gov. Gavin Newsom has repeatedly characterized refiners as price gougers, even though most of the differences are caused by taxes, fees and regulatory mandates. Recently, he persuaded the Legislature to pass a watered-down version of his proposal requiring refiners to maintain higher reserves to avoid price spikes.

However the gasoline situation is far more complicated than Newsom's approach, and California may be facing a period of volatility on both supply and price as it attempts to wean itself from combustion-powered transportation, its largest single source of greenhouse gas emissions.

The California Air Resources Board is on the verge of expanding its program of reducing the amount of carbon in the current gasoline recipe, regarded as an interim step before completely converting vehicles to electricity or some other non-polluting power.

Last year, CARB published an analysis of the proposed Low Carbon Fuel

Standard to provide "the economic incentives to produce cleaner fuels like electricity, hydrogen and biofuels that are needed to displace fossil fuels and reduce transportation sector emissions."

The report estimated that adoption could immediately increase gas prices by 47 cents a gallon and then, "on average, from 2031 through 2046 the proposed amendments are projected to potentially increase the price of gasoline by \$1.15 per gallon, the price of diesel by \$1.50 per gallon and fossil jet fuel by \$1.21 per gallon."

The cost estimate generated a storm of media and political attention and CARB backed off, continuing the adoption process but refusing to put a number on the potential pump price. Last week, the board's top official conducted an electronic press conference in which he stressed positive impacts, but continued to sidestep questions about consumer impacts.

"It's a win-win," executive officer Steven Cliff insisted. "We get public health benefits, we reduce health costs, we see lower costs of driving and we help turbocharge those investments in clean energy infrastructure that helps drive our zero emissions future."

CARB now intends to act on the policy three days after Election Day, without offering any estimate of consumer costs — a potential signal that those costs will be hefty.

While Newsom wants to be remembered as someone who tried to reduce gasoline prices, his governorship probably will be one that substantially increased them.

The other uncertainty is whether California will have

enough gasoline, even a variety with less carbon, over the next two decades as it transitions away from carbon fuels altogether.

California once had dozens of refineries producing the state's unique fuel blend, but in recent years just nine. After the Legislature gave Newsom the new laws on gasoline reserves, one refiner, Phillips 66, announced that it would shutter its plant in Southern California that's no longer profitable. The company said the closure had nothing to do with politics.

Very quickly, Valero, which has two refineries in the state, hinted that it may follow suit. CEO Lane Riggs said during a conference call that "all options are on the table" for the company's two California refineries, one in Benicia and the other in Wilmington, because of increasing state regulation of operations.

"Clearly the California regulatory environment is putting pressure on operators out there and how they might think about going forward with their operations," Riggs said.

Transitioning transportation to non-carbon power — while maintaining sufficient and reasonably priced supplies for gas-powered cars until they're replaced — was destined to be a fraught process.

If poorly managed, it could be a monumental disaster.

# 'Malling' Fun in Yuba Sutter

malls would be available to residents throughout the country.

By the 1980s, malls had become an iconic gathering place for young people and accounted for the majority of all retail sales in America. During the 1990s, approximately 140 new malls were opened each year but that momentum quickly started to ease toward the turn of the century and since 2007 few, if any, new conventional enclosed malls have been built in the United States.

The Yuba-Sutter region tracks right alongside this timeline with the area's first mall, Peach Tree Mall, being built in 1972. Peach Tree Mall was met with great success until 1986 when a levee break on the Yuba River caused great damage and flooding. In 1990, Yuba City opened its first and only enclosed mall originally called "The Mall at Yuba City" and later "Yuba Sutter Mall" and finally "Yuba Sutter Marketplace" as it emerged from the COVID-19 related lockdowns of 2020.

"The owner did an incredible job in transforming the property and the tenant line-up," said Bob Harlan, executive director for Yuba-Sutter-Colusa United Way. "A total revival."

Indeed, the scene and vibe at Yuba Sutter Marketplace is beginning to feel notably different. Two years ago, it had a remarkable boon with the addition of new businesses and anchor stores such as Hobby Lobby, Burlington, Five Below, Turners and

Boot Barn.

Community life inside the mall is also beginning to flourish. Ground Up near the food court hosts weekly jiu jitsu classes and training sessions where members develop close-knit ties. Next door is Adventure Alley, a new indoor play area geared toward the region's youngest shoppers. Those between the ages of 4 and 11 might also enjoy Kids Club, a free monthly program that typically involves crafts, stories, presentations and other fun activities. Starting this weekend, Nov. 8, mothers and those expecting can find support and connection at the Mother & Babies Group, a weekly session hosted by Sutter County Public Health Maternal Child Health. GameStop is also getting in on the action by hosting monthly Pokémon nights with the next one scheduled for Friday, Nov. 8, starting at 3 p.m.

"It's been really fun," said Reid Mertes, a GameStop employee. "We get to hang out, trade cards

and teach them the game and just have a good time."

Gaming in particular seems to be carving its own niche on the Yuba-Sutter malling scene with a heavy leaning toward anime culture. Aside from GameStop and At the Pier Arcade, Power Up Toys also opened in 2022, and Gamer Life, a retro inspired store had its grand opening anniversary celebration this past weekend. Two more new additions are MINISO, a store overflowing with Asian-inspired toys and collectibles, and Kiddleton, a Japanese arcade company focused on claw machines filled to the brim with the latest trending Anime products and exclusive "Kawaii" toys.

Following this Asian-influenced trend, shoppers can now find boba or bubble teas in the food court, a place bustling with a variety of cultural options and flavors. From El Salvadorian pupusas to Italian calzons and Vietnamese pho, there seems to be something to satisfy everyone's taste

buds. Among the newest additions is Magna's Burgers & Dogs which features classic American dishes with a Peruvian twist.

This is Nathan Street's first service industry venture and with 109 five-star Google reviews, he said that "things are going pretty well."

"Statistically, having a hundred reviews is rare but having a hundred five-star reviews is even rarer and that puts us in the top 2 to 5 percent of all businesses in the United States," said Street.

Street started cooking at a very young age but his passion was amplified by the birth of his first child, who was extremely allergic to milk and peanuts.

"With that, you can't buy most traditional stuff at the store so I learned to bake and cook just about everything, anything normal so that my kid could have a normal life," explained Street.

Street's skill paired with his life experience living in Peru for several years led to the opening of Magna's which incorporates many

of his original recipes enhanced with Peruvian spices and peppers. For example, Magna's signature "awesome sauce" adds an extra level of flavor to any dish with a tart but subtle smokiness. Likewise, the Lucuma shake is also quite popular with a taste that resembles taro or vanilla bean but with a nuttier finish that's slightly less sweet.

Next but certainly not least is the addition of Carters, which opened in August, and Shoe Palace, which opened in October in the old FYE location.

What else can you do at Yuba Sutter Marketplace? How about get a massage, go to the gym, cash a check, rent a car, have your portrait taken or even donate plasma. Yes, the

option to donate plasma for compensation will be available very shortly at ABO Plasma inside the mall.

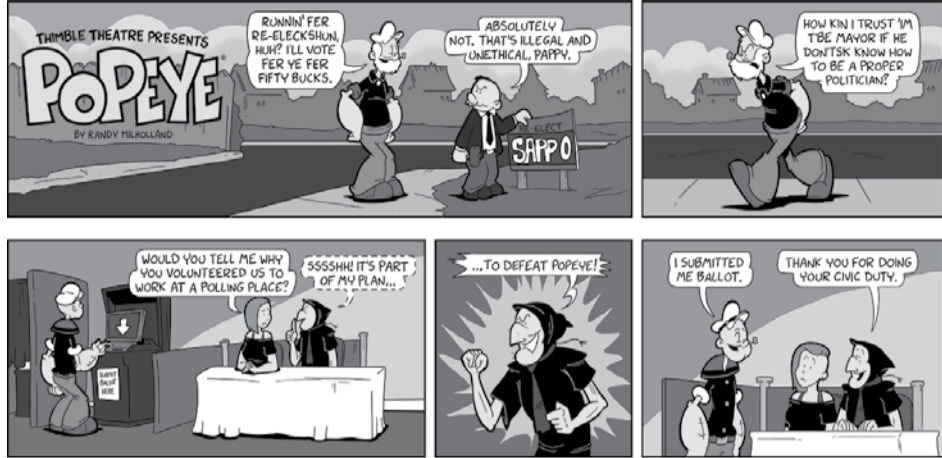

# Kings Korner

What a difference a week makes. Entering last week, the Sacramento Kings had lost all of their preseason games, and the first two games of the regular season.

Enter the Portland Trailblazers on Oct. 28 and the home crowd was treated to what everyone had envisioned the new and improved Sacramento Kings would look like.

DeMar DeRozan carved up the defensive of the Trailblazers along with point guard DeAaron Fox for 23 and 24 points respectively, but the real key was the way DeRozan got to his spots and made his mid-range game look easy.

Combined with the lightning quickness of Fox, this tandem poses a threat to opposing defenses every night, and other teams had better bring their "A" game when they come to Sac Town.

Finally breaking into the win column and lighting the beam for the first time in the 2024/2025 campaign, lifted a heavy weight off the shoulders of the Kings players and fans alike, but the week was not over. Convincing victories on the road over Utah and the Atlanta Hawks gave the Kings a three-game winning streak and lifted the team over 500.

DeRozan looked like a natural fit as the Kings made victories over the Jazz and Hawks look pedestrian, and had the Kings been able to shoot a little better from the charity stripe, it's entirely possible the overtime loss to the Toronto Raptors could have been the Kings 4th win in a row.

Sacramento will wrap up their road trip Monday night against the formidable Miami Heat (after press time), but it's obvious that some of the swagger has returned to the team.

I'm impressed with DeMar DeRozan in nearly every facet of his game, and like Malik Monk, DeRozan will be an asset and a role model as it relates to free throw shooting. An 84% career free throw shooter, DeMar has proven his reliability at the charity strip, and with the Kings coming off the 2023/2024 campaign in the cellar of the NBA in free throw shooting, adding a 6-time all-star that can shoot free throws at a consistently high level, is just

what the doctor ordered for the Kings.

Big man and double-double king Domantas Sabonis, like Fox, has struggled in the past from the free throw line, but has looked better so far this season, and has raised his average. It's still early, but if both Fox and Sabonis can get to 80% or better at the line consistently, look for Sacramento to be lighting the beam with increased regularity.

At 3-3 the Kings may not have a gawdy win-loss record, but the last four games have given all the fans a positive look at what the season can look like.

Although DeRozan has already shown he can connect from long range when called upon, he consistently passes up 3-point opportunities for mid-range looks, and he is deadly from the 10 to 15-foot range. DeMar looks so comfortable in mid-range, his stroke is almost effortless, and with that kind of confidence, he poses a serious late game option to go along with Fox and Sabonis.

Shout out to Kevin Huerter who after a subpar start in game one, has returned to what fans have expected to see, and once again, Huerter has shown his acumen both beyond the 3-point line, and driving to the hoop.

Huerter's defense has taken a step forward as well, so we'll give some attaboys to coach Brown for putting Huerter back in the starting lineup and sticking with him. If we can keep Kevin off the injury list, the 2024/2025 season could be a breakout year for a popular player with a big upside.

More than anything, the recent wins, particularly on the road, are spurring a higher volume of optimism, and look for an already loud arena to get even louder.

For any naysayers that felt it would take a long time for newcomer DeMar DeRozan to fit in, he is well ahead of schedule, and the way he and Fox are sharing the ball is a pleasure to watch.

Stay tuned Kings fans. This is what you've been waiting for, and the best is yet to come!

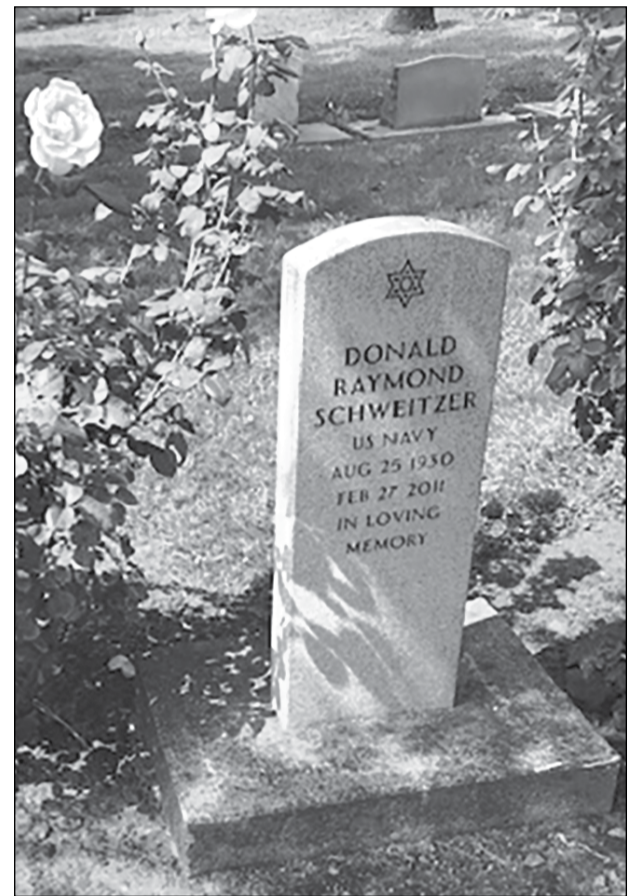
