WEST SACRAMENTO, CA (MPG) - It is crucial to honor and remember those who have served their country and to keep their legacy and memories

That is why every Nov. 11, Americans celebrate Veterans Day, a holiday dedicated to the 19.5 million American heroes who have served in the U.S. military, according to the United Service Organization. The holiday is celebrated on the 11th day of the 11th month to commemorate the moment the armistice ending World War I was signed.

In honor of Veterans Day, the West

Sacramento Veterans of Foreign Wars (VFW) Post 8762 invites all residents to honor those who have served at its annual Veterans Day Parade.

Veterans of Foreign Wars Post Commander of Post 8762 Leo Alatorre emphasized the importance of the event and what it means to the community.

'This event is to showcase our local veterans and let the community honor those who have given so much to our country," Alatorre said. "It's a great way for the community to honor, respect and highlight those who have made the ultimate sacrifice."

The parade will begin at 11 a.m.

on Nov. 11 at 1100 Clarendon St. The route will veer toward Westacre Road, going down Park Boulevard and ending at the corner of Stone and Deerwood streets.

Preceding the parade will be a pancake breakfast held by the Boy Scouts of America Troop 49 at 8:30 a.m. at the parade staging area at 1100 Clarendon St. The breakfast is offered to parade participants and onlookers.

Brian Stiger, Jr., a Veterans Day Parade Committee member, said there were at least 550 spectators at 2023's parade, and they expect no less this year. There were 100 Continued on page 14

#### **Manual Tally** and Unofficial **Election Results Schedule**

#### YOLO COUNTY, CA (MPG) -

The Yolo County Elections Office will select the voting precincts to be included in the one percent manual tally for the Nov. 5 General Election in accordance with the California Elections Code.

The manual tally process validates the totaling of ballots generated by the electronic voting equipment before certifying election results. For each race not included in the one-percent manual tally, an additional voting precinct with that contest will be tallied.

The public and media are invited to observe the voting precinct selection and the manual tally. Due to the spacing in the Yolo County Elections Office, the number of members of the public who would like to observe the manual tally was limited.

The selection of the precincts will take place after press time on Nov. 7 at 3 p.m. at the Yolo County Elections Office (625 Court St., Room B05, Woodland). The manual tally will begin at 10 a.m. Tuesday, Nov. 12.

The following schedule for upcoming unofficial election results for the Nov. 5 General Election are as follows:

#### **Until Certification**

Friday, Nov. 8 by 4 p.m. Tuesday, Nov. 12 by 4 p.m. Friday, Nov. 15 by 4 p.m. Tuesday, Nov. 19 by 4 p.m. Friday, Nov. 22 by 4 p.m.

Tuesday, Nov. 26 by 4 p.m. Due to the requirements outlined in Assembly Bill 3184 (signed into law on 9/22/24), election results cannot be certified in California until Tuesday, Dec. 3, at the earliest. Assembly Bill 3184 establishes specific timelines and procedures for certifying election results in California. Under this law, Yolo County Elections Office will certify the Nov. 5 General Election and provide final official results on Tuesday, Dec. 3.

This model places significant emphasis on coaching, peer-topeer support, mental health and family wellness, job training, career development, and financial empowerment. Its central focus is alleviating financial burdens, stabilizing expenses and fostering self-sufficiency. Since 2016, Raise the Barr's methodology and leadership in the Student Basic Needs Movement has produced a 96% success rate in keeping its members enrolled through graduation.

Work on this project began in June 2020, when Operative Office first acquired the quarter-acre site, which was previously a single-family home.

Emily Ware, Director of Development of Operative Office detailed the formula that enabled the groundbreaking.

"Our success in turning this small site into such a dense and impactful project is largely attributable to the City of West Sacramento's development-friendly

zoning, their willingness to co-invest in nearby infrastructure, and their best-in-class approach to both housing and economic development. The project also owes a great deal to Yolo County Housing's willingness to contribute project-based vouchers, which are crucial for the execution of Raise the Barr's model," Ware said. "The project benefits as well from a steady effort by many staff members at the California Department of Housing & Community Development, whose combined efforts resulted in an Infill Infrastructure Grant to the project. And finally, thanks to creative and thoughtful work by the California Tax Credit Allocation Committee, the California Debt Limit Allocation Committee, and

their respective staff, the project also received an allocation of 4% federal tax credits, state

tax credits, and multifamily revenue bonds, each of which serve as foundational building blocks for the project's financing. R4 is serving as both lender and tax credit investor to the project."

Said Lori Barr, co-founder and CEO of Raise the Barr, "Access to affordable housing is one the biggest barriers to college completion for single parents and their children. Completion of The Huddle on 5th will bring the dreams of many to life. These dreams of earning a degree, securing a career with a family sustaining wage, and having access to opportunities for economic mobility will create a positive change within families and communities for generations. We hope this space serves as a model for more housing of this kind across the state of California. We have only just begun."

Said West Sacramento Mayor Martha Guerrero, "The city is excited for this very unique affordable housing option that will support multiple generations for years to come. We're grateful for this partnership and look forward to welcoming these new residents to our community."

Said Richard Sciortino, co-founder and principal of Brinshore Development, "Opening The Huddle on 5th will make a significant impact on the lives of parent scholars and their children in Yolo County."

Said Ian Evans, executive director of Yolo County Housing, "Yolo County Housing strives to make affordable housing available for all populations in need throughout Yolo County. We're incredibly proud to provide rent vouchers to residents of this meaningful project, and very grateful to Brinshore Development, Operative Office, and Raise the Barr for bringing this project to West Sacramento."

# **Doctors Say Bacterial Pneumonia Increasing, Especially Among Children**

SACRAMENTO, CA (MPG) - Cases of pneumonia caused by the bacteria Mycoplasma, also known as "walking pneumonia," have been on the rise this year in the United States, according to the Centers for Disease Control and Prevention.

The agency reports an increase among all age groups across the United States from March 31 to Oct. 5 of this year, with the peak in August, and levels remaining high. The data come from the National Syndromic Surveillance Program and bioMérieux BIOFIRE Syndromic Trends.

Young children, particularly those ages 2 to 4, have been most affected this year, with an increase from 1% to 7.2% among children ages 2 to 4. Children ages 5 to 17 also saw an increase from 3.6% to 7.4%.

Dean Blumberg, chief of pediatric infectious diseases at UC Davis Children's Hospital, answered some questions about walking pneumonia and what parents and families can do to keep their children healthy. His comments follow below.

#### What is Mycoplasma Pneumonia?

"Pneumonia from Mycoplasma, also known by the nonmedical term 'walking pneumonia,' is caused by the bacteria Mycoplasma pneumoniae, which causes a respiratory tract infection. These can be mild infections which, most often, do not require hospitalization, but for some, they can be severe and

require antibiotics to get better. Both children and adults can get pneumonia from Mycoplasma."

#### What are the Common **Symptoms of Pneumonia** Caused by Mycoplasma?

"Common symptoms can include fever, cough, sore throat, headache and feeling tired.

It's often called 'walking pneumonia' since some people don't feel sick enough to stay home but they are still contagious and can spread the disease to others. Complications can occur that require hospital care, including new or worsening asthma, severe pneumonia and encephalitis (inflammation of the brain).

Children under 5 often have different symptoms, including diarrhea, sneezing, sore throat, stuffy or runny nose, vomiting, watery eyes and wheezing

Symptoms typically last for several weeks.

Some infected people may have no symptoms but it can still damage the lining of the respiratory tract, including the throat, windpipe and lungs.'

#### How is it Spread?

"It can spread person-to-person through the respiratory route, particularly when people are coughing or sneezing. People who live or work in crowded settings are at an increased risk for outbreaks.

It can take one to four weeks for symptoms to appear after someone has been exposed to the bacteria."

#### Who is at Highest Risk for This?

"Anyone is susceptible but those recovering from a respiratory illness are at an increased risk for serious infection. Anyone with a weakened immune system or with preexisting lung conditions such as asthma or reactive airway disease are also at greater risk for serious infection."

#### Is there a Vaccine Available for Mycoplasma Pneumoniae?

"No, unfortunately there is no vaccine."

#### How is it Diagnosed?

"Testing is available through a nose or throat swab PCR test at your doctor's office."

#### **How is this Treated?**

"Macrolides (such as azithromycin) are a class of antibiotics used commonly to treat bacterial pneumonia including infections caused by Mycoplasma pneumoniae. Make sure to take the full course of antibiotics and don't stop when you start feeling better."

#### What are some ways to keep **Families Safe?**


"I think a lot of families may not have heard of Mycoplasma pneumoniae or know that it is going around. I would advise families to follow these common-sense strategies:

Stay home when you are feeling sick. Keep your children away from others if they are not feeling well.


Cover your cough and sneeze and teach your kids to use their batwing to cover their cough or sneeze.

Wear a well-fitted KN95 or N95 mask if you feel sick and need to be out in public or if you are in crowded settings with others. According to the American Academy of Pediatrics, children ages 2 and older can safely wear a mask. But the exception is for anyone who cannot easily remove their own mask or who

has trouble breathing. Those who get worsening symptoms, have difficulty breathing or are unable to keep liquids down, should seek medical attention immediately."

#### **Social Security Matters** Why Does the Government Raid Social Security?

Dear Rusty: The Social Security program is funded by employees and their employers. The federal government does not contribute to the program, right? So why does the federal government feel they have the right to raid the fund? All the money sent to Ukraine and other unnecessary programs could have been used to pay back what they owe to Social Security. Signed: Disgruntled Senior

Dear Disgruntled Senior: You are correct that the Social Security program is mainly funded by payroll taxes on employee earnings and by employers who match those employee contributions. FYI, some additional SS revenue is received from income tax on Social Security benefits, as well as from interest on the special issue government bonds held in the Social Security Trust Fund. But the assertion that the Federal Government used (raided) the Social Security Trust Fund for any other purpose is a myth. All Social Security revenue received since the program began in 1937 has been accounted for, and all excess funds are contained in a special Trust Fund in the form of interest-bearing government bonds, reserved to

pay future benefits. FYI, the interest on those bonds contributed about \$67 billion to the Trust Fund reserves in Social Security reve-

nue, today, is not adequate to pay all benefit obligations, and the extra money needed to pay full SS benefits for everyone is obtained by redeeming Trust Fund reserves. Redemption of those Trust Fund bonds is how the federal government "pays back" the cash loaned to it by Social Security. The excess SS money received from contributions was loaned to the Federal Treasury by the SS Trust Funds, interest-bearing bonds were issued by the government in return for the cash received, and the bonds issued are redeemable as needed by Social Security to pay benefits. FYI, the average interest on the 2023 bonds in the Trust Funds was about 4.125%, whereas the average rate of return on all bonds held in reserve was about 2.387%. This transaction is the same as for any other investment vehicle, except the bonds in the Trust Funds are redeemable at any time without penalty. Said another way, all excess money ever received by Social Security is/was invested in special-issue government bonds, and resides in reserve to pay future benefits, as needed.

"Paying back" the money represented by bonds held in the Trust Funds would not be a wise financial move because it would eliminate all future interest earned by those bonds (again, that interest was about \$67 billion in 2023). Federal money spent for other purposes (e.g., Ukraine) is from the general U.S. Treasury and not from the Social Security Trust Fund, which is held totally separate from the U.S. Treasury. Since inception, all money ever contributed to Social Security has been (and is) used for one purpose (and one purpose only) - to pay Social Security benefits to those eligible (which, by the way, does not include "illegal aliens" or anyone else who is not a legal resident of the United States).

For clarity, Social Security does have a future financial issue because annual benefit obligations are now greater than annual Social Security revenue, and money from the SS Trust Fund is now used to make up the difference. Unless the program is reformed soon, the Trust Fund reserves (about \$2.8 trillion as of 2023) will be depleted and benefits for all Social Security recipients will be cut by about 23% starting in 2033 or 2034 (according to the Trustees of Social Security and the Congressional Budget Office).

Congress needs to act soon to enact Social Security reform to restore the program to fiscal solvency. The Association of Mature American Citizens (AMAC) is steadfastly lobbying Congress to enact the needed Social Security reform as soon as possible.

# A Third Straight Year with No California Salmon Fishing?

Early Fish Counts Suggest It Could Happen

Farmers can estimate the size of a harvest months in advance by counting the blossoms on their trees. Similarly, salmon fishers can cast an eye into the future by counting spawning fish in a river. Fishery managers are doing that now in the Sacramento River and its tributaries, and what they're seeing could be a bad sign for next year.

The low count of returning adult salmon, made by the federally operated Coleman National Fish Hatchery, is preliminary, with several weeks left in the natural spawning period for the Sacramento Valley's fall-run Chinook, backbone of the state's salmon fishing economy.

There is even some possible good news in the numbers — a large percentage of immature Chinook, called "jacks." This demographic slice of the salmon population can be a predictive indicator of ocean abundance for the coming season, and it could be a sign there are more fish in the ocean than many expected — though officials say it's too early

Overall, the unwelcome numbers, mirroring similar figures from last year, are alarming to people who fish, for they portend the possible continuation of the two-year-and-counting statewide ban on salmon fishing, imposed in 2023 following a weak spawning season.

Already, the loss of revenue from the fishery shutdown has devastated the coastal fishing fleet, which is still waiting for \$20 million in federal funds allocated for disaster relief early this year.

R.J. Waldron, who took recreational anglers salmon fishing on his Emeryville charter boat Sundance for more than a decade, recently sold his vessel. The reduced income was too skimpy to pay the overhead costs of owning a boat and renting a slip. He said relief funds, had they been portioned out, would

have kept him afloat. "That would have helped me maintain my boat and basically ride the storm out

until we get salmon fishing back — if we get salmon fishing back," he said.

Sarah Bates, owner of the San Francisco-based commercial vessel The Bounty, said she drew about 90% of her income from Chinook salmon sales prior to the closure and has helped make ends meet by fishing for other species, like black cod, shrimp and rockfish. Others, she said, have been targeting halibut.

Bates said the uncertain outlook has been disorienting for the men and women who shape their lives around a calendar year of fishing seasons and regulations.

"A lot of us feel a little

untethered," she said. At least six more months may pass before financial relief arrives. Barry Thom, executive director of the Pacific States Marine Fisheries Commission which has helped facilitate the grant application process — said in an email that the federal funds could be distributed sometime in May and June of 2025.

The odds of whether fishers will be returning

to work by then still looks like a tossup. U.S. Fish and Wildlife Service's Brett Galyean, project leader at the Coleman hatchery, described "really low" numbers of 3- and 4-yearold adult Chinook. As of Oct. 29, his staff had collected 4 million eggs from female fish — less than one-third the hatchery's target of 14 to 15 million

The spawning run is drawing toward the end, too, with new arrivals at the hatchery now "slowing down," according to Galyean.

At several other Central Valley hatcheries operated by the California Department of Fish and Wildlife, facility managers have only just started counting salmon, an official said. This means overall numbers could still mount to promising levels.

The low returns to Coleman, the state's largest fish hatchery, reflect a long-term decline in Chinook salmon numbers regionwide. As many as 2 million adult Chinook historically spawned in the Central Valley's rivers, and the fish were a keystone feature of marine and inland ecosystems.

The industrialization of the landscape to produce gold, water, cities, and crops has sent salmon runs tumbling. While the Central Valley's fish hatcheries — built last century to augment the wild stocks - release millions of baby Chinook each year, populations have dropped below fishable levels.

In 2022 officials counted just 69,000 adult fallrun Chinook in the entire Sacramento Valley, with a moderate improvement last year. In the mainstem of the Sacramento River alone, a key spawning destination, annual returns have dropped below 4,000 adults — down from an average of almost 60,000 each year from 1990 to 2009.

What ails California's salmon is perennially debated. Water users lean on explanations such as invasive species, reduced floodplain habitat, and climate change. Fishery advocates often stress the importance of water, especially quantity and temperature.

Bates said the Central Valley needs more aggressive floodplain restoration to provide feeding and refuge habitat for small fish, but that sufficient water is the key.

"It's the water — there's no way around it," Bates said. "The water conditions in the Sacramento River and the Delta no longer support juvenile salmon migrating downstream."

Sometimes, the outflow from Lake Shasta and into the Sacramento River during the spawning season is just a few degrees too warm — conditions that can abort millions of eggs and newly born fish and has become a recurring problem in recent years. Hot weather has played a role, though environmentalists say negligent management of the reservoir — especially failure to keep its water sufficiently deep into the late summer – is just as problematic.

As the young salmon migrate downstream, they face such perils as low flows, high temperatures, water pumps and predators. Thiamine

deficiency, a relatively new and emerging ecological hiccup connected to the marine food web, has also impacted Chinook salmon. Climate change is a long-term threat.

Barry Nelson, policy representative for the Golden State Salmon Association, believes the main reason for the Sacramento's salmon collapse has been inadequate river conditions downstream of Shasta, and low smolt survival.

"We sterilized the Sacramento River," he said. "We killed almost all the fish, and rule number one in fisheries management is, if you kill all the baby salmon, three years later you don't have adult salmon."



# Sen. Dodd Returns from Ukraine, Urges Action

Office of Senator Bill Dodd News Release

SACRAMENTO, CA (MPG) - Sen. Bill Dodd, D-Napa, recently returned from a weeklong diplomatic trip to Lviv, Ukraine.

He met with Lviv officials about the ongoing struggle against Russian aggression and toured key facilities, including a military hospital and the Superhuman Center, which provides prosthetic limbs to many of the tens of thousands of military veterans and civilians injured in

"The resilience, determination and resolve of the Ukrainian people is incredible," Dodd said. "We have so much in common, especially our love of freedom and democracy, so it is essential that we stand with them as they fight for their continued independence. I come away from my visit with a renewed sense of urgency to help Ukraine as it recovers from the destructive violence, as well as admiration for their strength and ingenuity. California can play a big role in the healing, and I urge friends and colleagues to consider how they might pitch in."

Dodd traveled to Lviv in western Ukraine during the week of Oct. 14, meeting with Lviv Gov. Maksym Kozytskyy, who is an appointee of Ukraine's President Volodymyr Zelenskyy. Together, they spoke with representatives from the Lviv legislature and education leaders about forging cultural and economic ties between California and the region.

Their meeting came in advance of the Rebuild Ukraine trade summit set for Nov. 11 to Nov. 15 in Poland. The California Governor's Office of Business and Economic Development will lead a delegation of the state's public and private sector groups working to support economic recovery. Economic and business-to-business relationships will boost both economies.

"We must take concrete steps such as investing in and supporting Ukrainian business and technology that will sustain the country's recovery," Dodd said. "We must also strengthen partnerships between our universities and research institutions. There's so much we can do to help and doing so will also enrich our state as well, so it is a win-win."

Dodd toured numerous Lviv facilities, including a military hospital, where he talked to wounded veterans and a military cemetery opened in 2022 where more than 800 soldiers from Lviv have been buried. He was especially moved during a tour of the Superhuman Center, which is helping meet the needs of the 50,000 Ukrainians facing amputations due to the war.

"It's a stark reminder of the tragedy that has unfolded here over the past few years," Dodd said. "In an otherwise beautiful country, there are literally daily funerals for those killed in the war."

In addition, Dodd visited Lviv region infrastructure that was hit by Russian missiles earlier this

year, as well as the Ukrainian Catholic University, where he spoke with the country's emerging leaders in a graduate-level public administration seminar. Dodd also watched demonstrations of cutting-edge technology, including the use of drones.

Now, Dodd is urging Californians to get involved by supporting a Ukraine charity of their choice. A link to the nonprofit Superhuman Center is superhumans.com/en.

Dodd's trip followed his own Ukraine-related initiative, Senate Concurrent Resolution 96, unanimously approved by the Legislature in April, establishing a sister-state relationship with the Lviv region. Following its passage, Dodd honored a delegation of Ukrainian government officials on the Senate floor. In Dodd's district, the Sonoma Sister City Association has long been a sister city with Kaniv, Ukraine, and since the

outbreak of war has raised nearly \$200,000 and sent a fully stocked ambulance to support

Dodd's trip was funded without the use of taxpayer dollars.

# **Matsui Applauds Launch of California Home Energy Rebate Program**

Funded by the Inflation Reduction Act, Rebate Program Will Save Californians up to \$14,000

SACRAMENTO, CA (MPG) - On Oct. 8, Congresswoman Doris Matsui (CA-07) released the following statement after California launched the first phase of its federal Home Energy Rebate programs to help lower families' utility bills. California is implementing the Home Electrification and Appliance Rebates (HEAR) portion of the rebate program—enabling savings on energy efficiency improvements.

"The Inflation Reduction Act is a generational piece of legislation that is delivering on its promise to lower costs for everyday Americans while aggressively fighting the climate crisis. From clean manufacturing to more sustainable transportation, we're making huge investments in a greener, more resilient economy," said Congresswoman Matsui. "The Home Energy Rebate programs empower American families by putting money in people's pockets while also enabling them to lead the clean energy transition and fight the climate crisis."

On Aug. 16, 2022, President Biden signed the landmark Inflation Reduction Act, which provides nearly \$8.8 billion for Home Energy Rebate programs. California was awarded \$292,738,760 of funding for their Home Electrification and Appliance Rebates rebate program that will be overseen by the California Energy Commission.

The first phase will be implemented by TECH Clean California, an existing state program that offers single-family and multifamily rebates on heat pumps for space heating and cooling (i.e., heat pump

HVACs), heat pump water heaters, and more. TECH Clean California is launching its Home Electrification and Appliance Rebates program in phases, with the affordable multifamily program launching first. The single-family program will follow at a later date.

Eligible owners of multifamily buildings can save up to \$14,000 per dwelling unit, including up to \$8,000 for an ENERGY STAR-certified heat pump HVAC, \$4,000 for an electrical panel, \$2,500 for electrical wiring, \$1,750 for an ENERGY STAR-certified heat pump water heater, \$840 for an ENERGY STAR-certified electric stove, cooktop, range, or oven and \$840 for an ENERGY STAR-certified electric heat pump clothes dryer.

#### Available soon

Eligible owners of single-family homes will be able to save up to the following amounts on ENERGY STAR-certified heat pump HVAC units:

\$8,000 for low-income households (i.e., those earning less than 80% of their area's median income) and \$4,000 for middle-income households (i.e., those earning between 80-150% of their area's median income).







I'd like to thank the players who've been a part of the past five years, the front office who've been incredibly supportive, and the fans who welcomed me into the club with tremendous passion and vigor," said Mark Briggs. After serving as the club's academy director, Briggs was hired at the conclusion of the 2019 season as the fourth head coach in club history. Through five seasons, the club finished 74-49-47 through 170 matches with postseason appearances in four of five years. Republic FC would reach the Western Conference Finals in 2023, Conference Semifinals in 2022, and the opening round in 2020 and 2024. Unless you respond timely, a default will be entered upon application by the Plaintiffs, and the Plaintiffs may apply to the Court for the relief demanded in the Complaint. DETAILED SUMMARY OF THE MATTER THAT PLAINTIFFS SEEK TO VALIDATE:

Government Code 53398.50, et seq. ("EIFD Law") authorizes cities and counties to establish "enhanced infrastructure financing districts" to finance public capital facilities and other projects of communitywide significance that provide significant benefits to the district or the surrounding communities. EIFD Law further authorizes the allocation by certain participating taxing entities of all or a portion of the share of the property tax increment revenues generated from within the boundaries of the district that those participating taxing entities would otherwise receive to the district, and that such property tax increment revenues may be pledged to payment of bonds issued by the district.

Both the City and the Authority authorized and established the EIFD to finance certain public and other specific facilities that both agencies authorized and approved in the EIFD's Infrastructure Financing Plan ("IFP"). Pursuant to EIFD Law, the Authority, as the designated governing body of the EIFD, adopted Resolution No. 24-4 authorizing, in part, the issuance of bonds by the EIFD, secured by a pledge of property tax increment revenue generated within the EIFD and allocated by the City to the EIFD, to finance the vital community facilities and projects identified in the IFP. Through Resolution No. 24-4, the Authority, in part: (a) authorized the EIFD to issue bonds in the aggregate principal amount of up to \$686,180,000 (being an amount equal to the value of \$535,000,000 in 2017 dollars, the amount authorized in the IFP, adjusted for inflation to July of 2024 (the "Bonds"); (b) approved the Fiscal Agent Agreement, between a fiscal agent and the EIFD (or by the Authority on behalf of the EIFD), pursuant to which the Bonds will be issued; (c) prescribed the terms and provisions of the Bonds, the application of the

proceeds of the Bonds, and

the pledge and use of property

tax increment revenues to the

repayment of the Bonds; and

(d) authorized the execution

and delivery of the Fiscal Agent

To facilitate these efforts, and as authorized by Resolution No. 24-4, Plaintiffs filed this validation action seeking a judicial decree confirming and validating that all proceedings by and for the Authority, EIFD and City, as set forth in Resolution No. 24-4, were, and are, in the best interests of the Authority, the EIFD, the City and all other interested parties, and were, and are, valid and in conformity with the provisions of all controlling laws and enactments including provisions of EIFD Law.

The proposed judgment would decree that Resolution No. 24-4, its provisions, the issuance of the Bonds as contemplated thereby, and the City's pledge of property tax increment revenues to repayment of the Bonds, were and are valid and authorized by law. Such judgment would be binding on the respective parties and would enjoin future challenges to the validity of the issues as to which the judgment is binding. The specific terms of the proposed judgment are set forth in the Complaint.

#### LEGAL DRAMA "THE LINCOLN LAWYER" GETS BETTER IN THIRD SEASON

#### "THE LINCOLN LAWYER: Season 3" on NETFLIX

Michael Connelly, the prolific author of crime fiction and detective novels, is arguably at the top ranks of writers whose books are worthy of being adapted as screenplays for television or movies.

His most notable characters are LAPD detective Hieronymus "Harry" Bosch and criminal defense attorney Mickey Haller, the central persons, respectively, for the Amazon series "Bosch" and the Netflix incipient franchise "The Lincoln Lawyer," now streaming for its third season.

Before Netflix launched "The Lincoln Lawyer" series in 2022, Connelly's eponymous 2005 novel was first made into the 2011 film of the same title, starring Matthew McConaughey as the Los Angeles defense lawyer who operates out of the back seat of a Lincoln Town Car.

The Ford Motor Company's Lincoln division produced the 1986 Town Car that was featured in the McConaughey film, whereas the streaming series on Netflix features a classic 1963 four-door Lincoln Convertible as the lawyer's car of choice when he's mostly driving for leisure.

The third season picks up where the previous one left off with Mickey Haller (Manuel Garcia-Rulfo) showing up at the West Hollywood jail for Julian LaCosse (Devon Graye), arrested as the suspect in the murder of sex worker Gloria Dayton (Fiona Rene).

Julian has only known Gloria as Giselle Dallinger, who operates under multiple aliases and could not be identified at the County morgue until Haller showed up, noting that she mostly went by Glory Days.

The evidence against Julian, as happens to be the case for many that Haller represents, may be circumstantial but enough threads connect to his culpability with at least a degree of credibility.

On the night of the homicide, Julian is found on a surveillance camera to have arrived and departed from Gloria's apartment building within the timeframe of the murder and the testimony of a neighbor that a loud argument had ensued gave credence to foul play.

It turns out that Gloria was being serviced by Julian's website that allowed sex workers to have prospective clients vetted for safety reasons, leading to Julian insisting that he's not a pimp but acknowledging that he takes twenty percent off the top as commission.

While a few side issues intrude, the ten-episode season is primarily focused on a single compelling case even though a budding odd couple romance blossoms when Haller gets involved with prosecutor Andrea Freeman (Yaya DaCosta), a frequent adversary in the courtroom.

In the second episode, Haller is representing a Hispanic male with shaved head and several face tattoos on an armed robbery charge. After testimony proves to be damning, the defendant viciously assaults Haller.

The prosecutor and Haller approach the bench when requested by the judge, who believes the attack has prejudiced the case in the eyes of the jury. The prosecutor asserts that the assault was staged so Haller could manipulate the court to declare a mistrial.

Detractors of the defense attorney, and there are many who pop up here, including the District Attorney's investigator and former LAPD detective Neil Bishop (Holt McCallany) holding a grudge for being destroyed as a witness, would perhaps justifiably take the view that Haller is calculating. Those who work for Haller are faith-

fully loyal. His second ex-wife Lorna Crane (Becki Newton), a hard-working assistant, is preparing for the bar exam which understandably causes anxiety at

Lorna is now married to former motorcycle gang member Cisco (Angus Sampson), who now works for Haller as an intrepid investigator willing to ride his bike all the way to Las Vegas to track down a potential witness. Office worker Izzy Letts (Jazz

Raycole), who previously chauffeured Haller in his Lincoln Navigator, is busy on the side trying to make a go of her own dance studio that's suddenly threatened by a competitor.

One new member of Haller & Associates is Eddie Rojas (Allyn Moriyon), taking over driving for the boss, after the attorney defended him at trial on a charge of joyriding in an expensive sports car.

On the other side of the ledger, Haller must deal with plenty of unsavory characters. Prison inmate Sly Funaro Sr. (Paul Ben-Victor), a disgraced attorney, and his moron son (Christian Antidormi), are key to Haller connecting with an imprisoned cartel leader (Arturo Del Puerto).

Even sleazier is how shady DEA agent James de Marco (Michael Irby), who has ties to former police officer Neil Bishop, possibly figures into the death of prostitute Glory Days.

For anyone who enjoyed the first two seasons of "The Lincoln Lawyer," the third season exceeds expectations such that the cliffhanger at the last episode will have you hoping no time is wasted for production to start on the next installment.

Without giving away anything that is shocking about the finale, it would be a disservice to the fan base to not have a new chapter, but given the popularity of the series so far, we should feel confident that Mickey Haller is not hanging up his shingle.

To boost access to organic dairy products in schools and youth programs, the U.S. Department of Agriculture has allocated \$15 million to launch the Organic Dairy Product Promotion Program. The initiative is aimed at increasing consumption of organic dairy products among children and young adults while creating new opportunities for small and mid-sized organic dairy farmers. Through the program, USDA will enter into cooperative agreements with four lead organizations, including California State University, Fresno.

#### Podcast Explores How Farmers are Adopting Automation and Robotics

The latest episode of the Voice of California Agriculture podcast highlights key moments from FIRA USA, a threeday showcase of agricultural technology held last week in Woodland. Produced by the California Farm Bureau, this episode explores the adoption of farm automation and robotics. Additionally, it discusses the impacts of Hurricane Milton on Florida agriculture, the ongoing bird flu situation affecting California dairies and the challenges posed by mountain lions to farmers and ranchers.

What a difference a week makes. Entering last week, the Sacramento Kings had lost all of their preseason games, and the first two games of the regular season.

Enter the Portland Trailblazers on Oct. 28 and the home crowd was treated to what everyone had envisioned the new and improved Sacramento Kings would look like.

DeMar DeRozan carved up the defensive of the Trailblazers along with point guard DeAaron Fox for 23 and 24 points respectively, but the real key was the way DeRozan got to his spots and made his mid-range game look easy.

Combined with the lightning quickness of Fox, this tandem poses a threat to opposing defenses every night, and other teams had better bring their "A" game when they come to Sac Town.

Finally breaking into the win column and lighting the beam for the first time in the 2024/2025 campaign, lifted a heavy weight off the shoulders of the Kings players and fans alike, but the week was not over. Convincing victories on the road over Utah and the Atlanta Hawks gave the Kings a three-game winning streak and lifted the team over 500.

DeRozan looked like a natural fit as the Kings made victories over the Jazz and Hawks look pedestrian, and had the Kings been able to shoot a little better from the charity stripe, it's entirely possible the overtime loss to the Toronto Raptors could have been the Kings 4th win

Sacramento will wrap up their road trip Monday night against the formidable Miami Heat (after press time), but it's obvious that some of the swagger has returned to the team.

I'm impressed with DeMar DeRozan in nearly every facet of his game, and like Malik Monk, DeRozan will be an asset and a role model as it relates to free throw shooting. An 84% career free throw shooter, DeMar has proven his reliability at the charity strip, and with the Kings coming off the 2023/2024 campaign in the cellar of the NBA in free throw shooting, adding a 6-time all-star that can shoot free throws at a consistently high level, is just what the doctor ordered for the Kings.

Big man and double-double king Domantas Sabonis, like Fox, has struggled in the past from the free throw line, but has looked better so far this season, and has raised his average. It's still early, but if both Fox and Sabonis can get to 80% or better at the line consistently, look for Sacramento to be lighting the beam with increased regularity.

At 3-3 the Kings may not have a gawdy win-loss record, but the last four games have given all the fans a positive look at what the season can look like.

Although DeRozan has already shown he can connect from long range when called upon, he consistently passes up 3-point opportunities for mid-range looks, and he is deadly from the 10 to 15-foot range. DeMar looks so comfortable in mid-range, his stroke is almost effortless, and with that kind of confidence, he poses a serious late game option to go along with Fox and Sabonis.

Shout out to Kevin Huerter who after a subpar start in game one, has returned to what fans have expected to see, and once again, Huerter has shown his acumen both beyond the 3-point line, and driving to the hoop.

Huerter's defense has taken a step forward as well, so we'll give some atta-boys to coach Brown for putting Huerter back in the starting lineup and sticking with him. If we can keep Kevin off the injury list, the 2024/2025 season could be a breakout year for a popular player with a big upside.

More than anything, the recent wins, particularly on the road, are spurring a higher volume of optimism, and look for an already loud arena to get even louder.

For any naysayers that felt it would take a long time for newcomer DeMar DeRozan to fit in, he is well ahead of schedule, and the way he and Fox are sharing the ball is a pleasure to watch.

Stay tuned Kings fans. This is what you've been waiting for, and the best is yet to come!



#### **California's Transition Off Carbon Fuels Could Upset Gasoline Supply, Prices**

California motorists buy and consume a billion gallons of gasoline each month and are very sensitive about pump prices, which are markedly higher than those in other states. Naturally, they are a political football.

Gov. Gavin Newsom has repeatedly characterized refiners as price gougers, even though most of the differences are caused by taxes, fees and regulatory mandates. Recently, he persuaded the Legislature to pass a watered-down version of his proposal requiring refiners to maintain higher reserves to avoid price spikes.

However the gasoline situation is far more complicated than Newsom's approach, and California may be facing a period of volatility on both supply and price as it attempts to wean itself from combustion-powered transportation, its largest single source of greenhouse gas emissions.

The California Air Resources Board is on the verge of expanding its program of reducing the amount of carbon in the current gasoline recipe, regarded as an interim step before completely converting vehicles to electricity or some other non-polluting power.

Last year, CARB published an analysis of the proposed Low Carbon Fuel Standard to provide "the economic incentives to produce cleaner fuels like electricity, hydrogen and biofuels that are needed to displace fossil fuels and reduce transportation sector emissions."

The report estimated that adoption could immediately increase gas prices by 47 cents a gallon and then, "on average, from 2031 through 2046 the proposed amendments are projected to potentially increase the price of gasoline by \$1.15 per gallon, the price of diesel by \$1.50 per gallon and fossil jet fuel by \$1.21 per gallon."

The cost estimate generated a storm of media and political attention and CARB backed off, continuing the adoption process but refusing to put a number on the potential pump price. Last week, the board's top official conducted an electronic press conference in which he stressed positive impacts, but continued to sidestep questions about consumer impacts.

"It's a win-win," executive officer Steven Cliff insisted. "We get public health benefits, we reduce health costs, we see lower costs of driving and we help turbocharge those investments in clean energy infrastructure that helps drive our zero emissions future."

CARB now intends to act on the policy three days after Election Day, without offering any estimate of consumer costs — a potential signal that those costs will be hefty.

While Newsom wants to be remembered as someone who tried to reduce gasoline prices, his governorship probably will be one that substantially increased them.

The other uncertainty is whether California will have enough gasoline, even a variety with less carbon, over the next two decades as it transitions away from carbon fuels altogether.

California once had dozens of refineries producing the state's unique fuel blend, but in recent years just nine. After the Legislature gave Newsom the new laws on gasoline reserves, one refiner, Phillips 66, announced that it would shutter its plant in Southern California that's no longer profitable. The company said the closure had nothing to do with politics.

Very quickly, Valero, which has two refineries in the state, hinted that it may follow suit. CEO Lane Riggs said during a conference call that "all options are on the table" for the company's two California refineries, one in Benicia and the other in Wilmington, because of increasing state regulation of operations.

"Clearly the California regulatory environment is putting pressure on operators out there and how they might think about going forward with their operations," Riggs said.

Transitioning transportation to non-carbon power while maintaining sufficient and reasonably priced supplies for gas-powered cars until they're replaced was destined to be a fraught process.

If poorly managed, it could be a monumental disaster.


