Rancho Cordova is Innovative

RANCHO CORDOVA, CA (MPG) - The City of Rancho Cordova's annual State of the City address Nov. 6 at City Hall was guided by the theme, "Cities as Laboratories of Democracy."

Mayor David M. Sander, Ph.D., highlighted the city's growth and its commitment to innovation as the city celebrates 21 years of cityhood.

With an audience that included local officials, community leaders and residents, Mayor Sander detailed the city's achievements in a wide range of areas, from infrastructure and economic development to public safety and

community engagement.

"Our city is a place of innovation," Sander said. "Local communities are the true laboratories of democracy, places where

transformative change happens. And right here in Rancho Cordova, we are experimenting with new techniques, new methods and new projects to

enhance the quality of life for our residents."

Since its incorporation, Rancho Cordova has grown rapidly. With a 47% increase in population during the past two decades, the city has seen a growth in housing, business development and public services.

According to Sander, the city has also made strides in economic development. Rancho Cordova continues to attract new businesses and has diversified its economy, providing more job opportunities for residents.

Sander noted the city's success in securing federal grants, including funding for local projects such as

District Attorney's Office Awarded **Program Grant**

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County District Attorney's Office received a \$299,000 grant from the California Office of Traffic Safety (OTS) for the "DUI/ DUID Misdemeanor Prosecution, Education and Outreach" program. The program aims to reduce driving under the influence (DUI) and driving under the influence of drugs (DUID) offenses.

Funding for this program was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

Traffic data from 2020 to 2022 shows an increase in DUI-related crashes involving fatalities and injuries. Sacramento County experienced a 94.44% increase in DUIrelated traffic fatalities from 2020 to 2022 and a 13.11% increase in DUIrelated injuries during that same period.

This grant funds a specialized prosecutor who will be responsible for misdemeanor DUI/DUID cases. The prosecutor will also mentor newly-appointed deputy district attorneys on the successful prosecution of DUI/ DUID cases and conduct roundtable discussions and trainings for law enforcement agencies on new DUI/DUID laws and investigation techniques.

Another grant component is community outreach on DUI/DUID prevention. The grant prosecutor will participate in several education programs for adults and youth, including the DA's Citizens Academy and Youth Academy, as well as the Real DUI Court in Schools program hosted by Arrive Alive, CA. Outreach will also include office podcasts on DUI/ DUIDs and the distribution of informational materials to those charged with DUI/DUID offenses to prevent recidivism.

"Impaired driving remains a significant danger on our roads, particularly drivers suspected of operating a vehicle under the influence of both alcohol and drugs," said Office of Traffic Safety Director Barbara Rooney. "This program will help prevent the tragic consequences of impaired driving and create safer roads for everyone."

the Rancho Cordova Youth Center, Mather Veteran Village and, in partnership with Capital Southeast Connector, a grant to enhance Grant Line Road.

"Financially, the city remains on solid footing, with a budget surplus each year thanks to careful planning and diversified revenue streams," said Sander.

Increased public safety was another topic highlighted by Sander. The Rancho Cordova Police Department's Real-Time Information Center was introduced as a key tool in preventing and responding to criminal activity, helping to drive the crime rate down.

The city's commitment to infrastructure was underscored by several key projects, including the Mather Field Road rehabilitation, Sunrise Boulevard improvements, and the Mills Crossing program and the Zinfandel pedestrian overcrossing enhancing accessibility and safety for residents.

Sander also highlighted the importance of community engagement, citing events such as Good Neighbor Day and Spring Service Day, which foster strong relationships between residents and local

The city's focus on youth and families remains a priority, with programs including the Rancho Cordova Youth Center and the Rancho Cordova Promise Program providing valuable opportunities for education, recreation and personal growth.

"Keeping neighborhoods strong is an integral part of us becoming a city," said Sander. "The approach is multifaceted and involves all departments in the city, including the RCPD (Rancho Cordova Police Department) proactive enforcement program, beautification grants and animal services."

Providing accurate information to residents, businesses, community partners and other stakeholders is a constant and

"This all adds up to a higher quality of life," said Sander. "Our future is bright."

featuring snacks and local libations from the Barrel District, as well as a presentation from the Cordova High School Junior ROTC and the Rancho Cordova River City Band.

Why Trump Won and Won Big! The Issue is Liberty!

November 5 was the most important election in our nation's political history. American flags were everywhere so patriotism was strong, and the people felt they needed to get back to freedom basics. The silent majority came forward. Donald Trump's 900-plus rallies were attended in numbers never seen before. Kamala Harris rallies had to have a concert with someone famous, or have a previous president, Bill Clinton or Barack Obama, with her to break a thousand attending; worse, or have rally goers paid to attend. As anticipated, the people came out for Donald Trump.

In a truly fair election without electronic cheating, illegals voting, voter rolls cleaned up, ballot harvesting, totally uncensored information, media not weaponized and etc. Trump would have won by at least 70%, maybe 75% as we have indicated before. But cheating was off the charts the last two years, more especially the last month, with hundreds of examples, even so, he won with THEIR electronic voting system but not by these percentages. This makes his victory much more profound. No one in American history has experienced more election opposition.

Why this profound victory? Several reasons can be identified. The vast majority of Americans know now that Joe Biden did not win in 2020, Trump did. That Covid-19 was mostly used for mail-in-balloting, which is, and always has been, prone to cheating. That Biden was personally corrupt, had over 20 shell companies extracting millions from foreign countries, some potential enemies, with Hunter selling state secrets. Classified documents were in Joe's possession as a U.S. Senator and Vice President in several different places that should have given him a lengthy prison sentence even before he ran for president in 2020,

Americans now know that the CIA was corrupted decades ago -at least since the Kennedy Assassination. That the FBI has turned rogue even leading the January 6 insurrection while dressed as MAGA. What a difference a week makes, and after Sunday night's thrilling overtime win over a much-heralded Phoenix Suns team that had only one loss on their season record, Sacramento Kings fans are flying high.

After a disappointing and somewhat head scratching start, the Kings have climbed out of an 0-2 hole, to post a respectable 6-4 record after ten games.

Sunday's contest featured three Kings players with 20 points or more, with Huerter and Murray chipping in with 17 and 14 points respectively.

Well balanced is the name of the game, and in the fourth quarter, the Suns were without an answer for the mid-range game of both DeRozan and Fox. Both players drove deep into the paint time and time again, only to step back and take easy 6-to-10-foot jumpers that touched nothing but net.

It was a mid-range clinic, and DeMar DeRozan has already given Kings fans a serious dose of what to expect the rest of the season. This heady veteran has the quintessential mid-range jump shot, and he not only makes them with regularity, he has a habit of getting fouled as well.

Fouling DeRozan is probably not the best strategy for opposing teams as he is shooting a sizzling 86.4% from the charity stripe.

Going into the Nov. 10 game against the Suns, remarkably, the cellar dweller Sacramento Kings in 2023/2024 in free throw shooting, were leading the entire league with an 84% success rate. All but one player on the team is averaging 80% or better from the line, and this represents one of the most dramatic turnarounds in many years.

Only bench player Alex Len, shooting a dismal 50% from the line, is struggling, and if this trend continues the Kings will add significantly to their season win total.

Among the most notable contributors are stalwarts DeAaron Fox and Domantas Sabonis, who after averaging a paltry 71% last season, have raised their averages to 86% and 83% respectively. This is a dramatic improvement, and it begs the question, what happened during the off season to contribute to such a remarkable improvement?

I have noticed that DeAaron is taking just

a split second longer before releasing the ball, and some wrist action has been eliminated. His shot has more push and less wrist, which will undoubtedly lead to more made free throws.

Sabonis' shot looks the same, but his concentration looks better, and he's putting more arc on his shot than in seasons before. All said, we will gladly applaud these

early season results and say going from last to first in the NBA in anything deserves noteworthy credit. After the season's first two games, both

losses, pundits and fans alike were wondering how long it would take for 6-time all-star DeMar DeRozan to fit in with his Kings teammates. The next eight games have answered that question, and with the exception of

the Kings 107-98 loss to the Los Angeles Clippers, the Sac Town boys have been in every game this season. The current 6-4 record could easily be 8-2, but without question, the ranks of Sacramento Kings fans are filling every game with excited basketball fans that are ready for a historic season. My prediction of 50 plus wins, barring injury, will not only happen, it will propel this team beyond the first round of

Many fans are hoping and predicting that Monte McNair will make an in-season trade or acquisition that will strengthen the

The win on Sunday, Nov. 10 saw bench superstar Malik Monk go down with an ankle injury and will reportedly miss the Nov. 11 game against the San Antonio Spurs (after press time). If there is one player the Kings can ill afford to miss its spark plug Malik Monk, and we all wish Malik a speedy recovery.

Stay tuned Kings fans, because these hardwood gladiators that have suddenly discovered the mystery of making free throws, are in action this week against the Spurs, Sun's again, Timberwolves, and the Utah







Social Security Matters Working Septuagenarian Asks **About Disability Benefits**

Dear Rusty: I retired at my full retirement age, am now 79 and will be 80 in December. I have been working consistently since. I get a meager Social Security benefit, only about \$800 due to my federal retirement offset. Most jobs I have held since filing and collecting SS have involved very labor-intensive work, to include my current position. This has taken a toll. My question: is there any

provision in Social Security that permits re-evaluation of Social Security benefits for disability after one has collected and paid into the system for some 15 years? I suspect not but thought I would ask, since at my not so tender age, I am faced with having to cease employment that generates needed income. Signed: Working Still at 79. Dear Still Working: I'm

afraid that Social Security Disability Insurance (SSDI) benefits are no longer available once you reach your SS "full retirement age," or "FRA," which for you was age 66. Indeed, anyone collecting SSDI at full retirement age is automatically converted to their regular SS retirement benefits at the same amount they were previously receiving on SSDI. That's because SSDI benefits are intended to sustain workers up to their SS full retirement age, but SSDI goes away once FRA is attained. Thus, the provision to

apply for SS disability allows only those who have not yet reached their full retirement age to seek disability benefits. Once FRA is reached, SSDI benefits are no longer available. Simply for your awareness, there would be no financial advantage for you to receive SS disability benefits anyway, because the most you can get on SSDI is your full retirement age amount. Thus, since you retired and claimed SS at your full retirement age, no additional disability amount would be available anyway.

FYI, I admire, at your "tender age," that you are still actively working, but I'm afraid you cannot claim more now on Social Security disability because you've already reached your FRA. However, from what you've written, your SS retirement benefit has been affected by the so-called Windfall Elimination Provision (WEP) which affects those with a separate pension earned without contributing to Social Security.

If you've been separately working (and contributing to Social Security) since you left government service, and you now have more than 20 years contributing to SS from other non-government "substantial earnings," it's possible that you can request a reevaluation of your WEP penalty. WEP

provides relief for those who have more than 20 years contributing to Social Security. So, if you have more than that over your lifetime, you could ask that your WEP reduction be reevaluated to consider your additional years contributing to Social Security. If that is the case, your monthly amount would be increased to consider those additional years contributing to SS since you first claimed.

I suggest, if you now have more than 20 years of contributions to Social Security from your non-government work over your lifetime, that you call Social Security to request reevaluation of your WEP retirement amount. FYI, you can see exactly how many years of SS-covered work you have by requesting an "Earnings Statement" from Social Security. You can get this Statement by calling 1.800.772.1213, or you can also get it at your personal "my Social Security" online account at www. ssa.gov/myaccount (Social Security will also be able to tell you this directly when you call). In any case, I wish you good fortune, and hope that reevaluating the WEP reduction to your SS benefit may offer some small financial relief as you go forward.

One Issue Trump and Newsom Agree On? **Homeless Encampments**

When President-elect Donald Trump moves into the White House in January, he will become a key figure in California's homelessness crisis, holding the federal purse strings and setting policy at the national level.

So what will this change of power mean for the state as it tries to move its nearly 186,000 homeless residents — the most in the nation — indoors?

Housing and homeless services experts in California worry the Trump administration will cut federal funding in those areas, while also doing away with policies deemed too "progressive."

But surprisingly, based on what he's said so far about one of the key issues regarding homelessness, Trump's agenda isn't much different from Gov. Gavin Newsom's. Trump pledged to tackle the encampments that have made cities "unlivable" by working with states to ban urban camping and arrest those who don't comply — something many cities in California started doing before Election Day, as Newsom encouraged them to clear camps.

"The homeless have no right to turn every park and sidewalk into a place for them to squat and do drugs," Trump said in a campaign video posted online in April 2023. The video appears to be the last time he revealed specific homelessness policy intentions.

"There is nothing compassionate about letting these individuals live in filth and squalor rather than getting them the help that they need," Trump said.

Newsom, who in most other arenas is one of Trump's biggest foes, has said nearly the exact same thing.

"There is no compassion in allowing people to suffer the indignity of living in an encampment

for years and years," Newsom said in September before signing a package of housing bills. In July, Newsom ordered state agencies to ramp up encampment sweeps, and he threatened to withhold state funding from cities that fail to do

More than two-dozen California cities and counties already have introduced or passed new ordinances cracking down on camps (or updated existing ones to make them more punitive), after the Supreme Court gave them the green light to do so in June.

Trump also said he would move unhoused people to tent cities staffed with doctors and social workers

That plan alarmed Alex

Visotzky, senior California policy fellow for the National Alliance to End Homelessness.

"We need to remember that involuntary carceral approaches don't work and just delay our efforts to end homelessness,"

If Trump pushes these policies at the national level, especially if he offers federal funding for sweeps and tent cities, it could spur California cities to further crack down, Visotzky said.

As the Trump administration gets to work replacing the heads of federal agencies such as the U.S. Interagency Council on Homelessness, there's a good chance policies California has come to rely on will get tossed out along the way, said Sharon Rapport, director of California state policy for the Corporation for Supportive Housing. The new guard likely will scrap at least some policies viewed as the gold standard in California, such as "housing first," which says unhoused people, even those struggling with an addiction or their mental health, should be offered housing with no strings attached, and then services to help

It's also a good bet California would see large cuts to funding for federal housing and homelessness programs — including the voucher program that subsidizes rents for hundreds of thousands of Californians, Rapport said.

That's worrying for organizations such as Abode, which provides housing and other services for homeless Californians in seven counties.

"Federal funding is the brunt of what we receive either directly or through other entities, so it could be really impactful if there's a huge reduction," said CEO Vivian Wan. "It's just going to hurt all of our communities."

California Will Likely Feel the Consequences of Donald Trump's Decisive Victory

Elections have consequences, as California is likely to learn when Donald Trump once again moves into the White House.

The state has been a bastion of anti-Trump sentiment ever since the bombastic billionaire real estate tycoon first ventured into politics nearly a decade ago.

Its political figures particularly Gov. Gavin Newsom, former House Speaker Nancy Pelosi and U.S. Senator-elect Adam Schiff - have sought and achieved notoriety for their public denunciations of Trump. Trump has responded

in kind. As president, he attempted to thwart some California policies, such as its reductions of farmers' supplies, and as a candidate portraying Vice President Kamala Harris's home state as a hellhole of crime and social decay.

There's no reason to believe that Trump, despite election night promises to bridge the nation's stark conflicts, will not continue using California as a punching bag during his second stint as president.

The agricultural water conflict is likely to resurface because the state is still trying to reduce farmers' share. Trump's promised crackdown on undocumented

have its greatest impact on California. The state's aggressive crusade to reduce reliance on carbon-based fuels will conflict with Trump's pledge to ramp up oil and gas production.

That's just three points of friction between California and Trump's second presidency, and many more are out there such as gun control and transgender participation in women's sports. California officialdom

appears ready for four years of confrontation. On election night, Assembly Speaker Robert Rivas told Politico, "California will do everything we can to protect America from Donald Trump." Attorney General Rob Bonta promised to wage legal battles against Trump on gun control and abortion rights, telling the political news outlet, "We have gone down to the detail of what court do we file in."

Positioning as a Trump foe is a slam dunk tactic for California politicians, especially those, such as Bonta, who may aspire to succeed Newsom as governor two years hence. But, one might wonder,

what does Harris's defeat and Trump's victory bode for Newsom? He will no doubt lead the opposition if Trump tries to punish the state, as he anticipated in a recent "They're not going to wait

to wind up. It's ready, fire, aim - not ready, aim, fire," Newsom said. "And that is going to create a dynamic that will be profound in two senses — from a governing

perspective and also from a political attack perspective." However, would he take the next step of joining

> While laboriously building a national political profile in the last two years, Newsom repeatedly denied any ambition of becoming a presidential candidate, saying at one point he has "sub-zero interest."

National political media never bought the line and continued to portray him as a potential aspirant for the White House. However, whatever ambition Newsom may have had if Joe Biden bowed out this year was dashed when Democratic leaders immediately anointed Harris as the substitute.

Her decisive defeat probably means that she has hit the political ceiling, particularly since initial election night finger-pointing dwelled on her shortcomings as a candidate, as well as the Democratic Party. The door is now open for Newsom to run, unless he truly intends to finish out his second term as governor and return to life as a restaurateur and wine merchant.

Newsom has spent half of his 57 years climbing up the political ladder, one rung at a time. Is he really willing to give it up? What he does in the coming months, either entering the Democratic Party's forthcoming battle royale or exiting the national political arena, will answer the question.

My wife and I have paid off all our consumer debt, and we're in Baby Step 3 building up our emergency fund to six months of expenses. When do you recommend buying a new car in the process? Do we have to wait until we've finished all the Baby Steps?

Dear Aaron,

Congratulations! two are taking really positive steps forward in gaining control of your finances. I'm proud of you!

Ok, I'm not sure if you're talking about buying a newer car—like a great two- or three-yearold model-or an actual new car. I don't advise buying a brand new car, unless you have a net worth of at least \$1 million. Why? Because at that point, you've got enough assets that you won't get rocked by the crazy depreciation that comes with buying a brand new vehicle.

Don't get all down after hearing this. I'm not saying you should drive a junker until you pay off your house. I recommend that people drive the minimum they can in terms of a car until they complete the first three Baby Steps. As you already know, Baby Step 1 is a beginner emergency fund of \$1,000. Baby Step 2 is paying off all debt except

for your home, and Baby

Step 3 is fully funding your emergency fund with three to six months of expenses.

After you've accomplished the first three steps, then you can move up to a nicer car. Notice I didn't say move up to a new car. And I want you to model your financial behavior after people who are in the position you want to be in one day!

This Isn't Just a Dispute

Dear Dave,

Recently, my husband and I discovered that his ex-wife used his Social Security number to open three or four credit card accounts. We've called the credit card companies, and we've disputed the charges and explained the situation. Is there anything else we can do? - Kendra

Dear Kendra, File a police report immediately, and if possible, have this woman arrested. That may sound harsh, but the fact is she has committed criminal fraud. That's not something you, or anyone else, should take lightly. If you haven't already, make sure you both also put fraud victim alerts

on your credit reports immediately.

I'm very serious about this, Kendra. Don't stop with just alerting the credit card companies. You should be speaking with, and communicating via email—plus snail mail directly with the fraud victim division at every credit card company involved. And here's the really important part. Make sure they understand that this is a denial of responsibility on your part—not simply a dispute.

Try to be nice, and let them know you're sorry this happened. But clearly explain that all these charges are the result of a criminal act perpetrated against you. You may have to stand your ground with some of the credit card companies, because they might try to lay a guilt trip on you-or outright lieto get you to pay the bills. Don't do it. These charges are not your responsibility.
