

Bringing Clean Water to Rio Linda

RIO LINDA, CA (MPG) - Water, although a necessity, isn't something many residents tend to be picky about.

Alli Ramzan says that should change.

Owner and founder of Sterling Water Supply in Rio Linda, Ramzan aims to provide affordable and pure drinking water to residents. The store, located at 440 Elkhorn Blvd., suite number 4, has been open for a year and a half, according to Ramzan.

"It's a new take on water," Ramzan said.

At Sterling Water Supply, purified water and alkaline water are sold by the gallon, as well as

ice, snow cones and other supplies.

Upon entering the store, the customer is welcomed by colorful walls, a projector screen airing television on the wall, feel-good

music, a fish tank, a couch, a basketball goal for children and a smiling, excited Ramzan.

"I built this business with my own two hands," he said proudly. "I don't

want to be just another water store that meets California requirements. I want to go above and beyond those requirements to achieve the cleanest possible water."

According to Ramzan, Sterling Water Supply has the largest purification system in Sacramento, generating 8,000 gallons of water per day. It is also three times larger than any other water store in the area.

Why should residents switch from tap water to purified water or alkaline water?

According to Ramzan, alkaline water is purified, and added with electrolytes, magnesium

District Attorney's Office Awarded Program Grant

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County District Attorney's Office received a \$299,000 grant from the California Office of Traffic Safety (OTS) for the "DUI/DUID Misdemeanor Prosecution, Education and Outreach" program. The program aims to reduce driving under the influence (DUI) and driving under the influence of drugs (DUID) offenses.

Funding for this program was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

Traffic data from 2020 to 2022 shows an increase in DUI-related crashes involving fatalities and injuries. Sacramento County experienced a 94.44% increase in DUI-related traffic fatalities from 2020 to 2022 and a 13.11% increase in DUI-related injuries during that same period.

This grant funds a specialized prosecutor who will be responsible for misdemeanor DUI/DUID cases. The prosecutor will also mentor newly-appointed deputy district attorneys on the successful prosecution of DUI/DUID cases and conduct roundtable discussions and trainings for law enforcement agencies on new DUI/DUID laws and investigation techniques.

Another grant component is community outreach on DUI/DUID prevention. The grant prosecutor will participate in several education programs for adults and youth, including the DA's Citizens Academy and Youth Academy, as well as the Real DUI Court in Schools program hosted by Arrive Alive, CA. Outreach will also include office podcasts on DUI/DUIDs and the distribution of informational materials to those charged with DUI/DUID offenses to prevent recidivism.

"Impaired driving remains a significant danger on our roads, particularly drivers suspected of operating a vehicle under the influence of both alcohol and drugs," said Office of Traffic Safety Director Barbara Rooney. "This program will help prevent the tragic consequences of impaired driving and create safer roads for everyone."

Said District Attorney Thien Ho, "Given the latest traffic data showing an increase in driving under the influence related

and calcium, making for an improved digestive system, better night's sleep and inhibited growth of cancer cells, among more benefits.

Ramzan pointed out that in normal tap water, chemicals such as lead, mercury, arsenic and aluminum are heavily present.

"The municipal companies are adding heavy amounts of chemicals we should not be ingesting just so the water can be bacteria-free," he added.

Drinking arsenic and mercury daily can lead to long-term health problems, possibly causing cancer, synapses in the brain and leading to early Alzheimer's, according to the California Office of Environmental Health Hazard Assessment (OEHHA).

With Sterling Water Supply's purification system, a \$50,000 system shipped in from Iowa, the lab-tested water comes back as "99.97% pure."

Customers, along with animals, can taste the difference.

Ramzan said that according to his customers, pets massively prefer the purified water to the tap. Restaurant owners frequent the store, as cooking with purified water tastes completely different from cooking with tap water, he said.

Ramzan values the relationships he builds with customers.

"My motto is: 'the first time you come in, you're VIP. The second time you come in, you're family,'" he said.

One customer, Violet Mondy, said she values Ramzan's kindness.

"He is very friendly, very helpful, just someone you want to meet," Mondy said.

So, how did Ramzan get here?

Born in London, Ramzan came to America as a toddler and grew up in New York, where he was studying pre-med, pre-law, eventually earning his master's degree at New York University (NYU). His experience in corporate finance, accounting and business led him to a career on Wall Street, Ramzan said.

Eventually, Ramzan took to real estate and

property management, where he "ran 5.5 million square feet of property and managed high-rise buildings in Midtown Manhattan."

Finally, his long-distance relationship with his now wife, who lived in Davis, led him to California 10 years ago.

"I ended up saying to myself, 'I'm tired of making millions for millionaires,'" Ramzan said. "I wanted to do something pure, where I earned every dollar."

Ramzan spent a year educating himself on "every aspect" of water, and the idea for Sterling Water Supply was born. According to Ramzan, he wanted the business name to evoke purity and cleanness, and "Sterling" fit that description.

Why open in Rio Linda?

"I chose Rio Linda due to the nature of how Rio Linda is," Ramzan said. "You've got that community camaraderie; everybody knows everybody, and I want them to know me."

Ramzan emphasized his commitment to the community, mentioning his involvement in the Chamber of Commerce and how he helps those in need by serving water to those who ask.

"I don't want to just sell water. I want to give knowledge and educate the community about it," Ramzan said. "It's the main thing our lives depend on that a lot of people don't know much about."

"Water should be at its best and should be affordable," Ramzan said. He sells purified water for \$0.45 per gallon, while alkaline water goes for \$1 per gallon. A 10-pound bag of purified ice costs \$5. Snow cones go between \$4 and \$6. Curbside service is just a \$1 fee. There are also membership and rewards options.

Ramzan hopes to open additional Sterling Water Supply stores.

"This makes me want to wake up every day," he added.

Former Foster Parent Sentenced 30 Years to Life

SACRAMENTO COUNTY, CA (MPG) - The Honorable Ernest Sawtelle sentenced Kevin Barker to 30 years to life in prison. On Oct. 7, Barker pled no contest to four counts of committing lewd acts upon a child and possession of child pornography. Barker also admitted to allegations of befriending children for the purpose of molestation, abusing a position of trust and multiple victims.

Barker is a serial child molester with known conduct from 2008 to 2018. He frequented a skate park in Sacramento County to befriend children. He lured those victims to his residence and groomed them with gifts, money, alcohol and marijuana in order to molest them. He also met a child victim at a homeless shelter. Barker took the victim in to live

with him, groomed him with cash and gifts and molested the child for several years.

Barker became a Sacramento County foster parent in 2011. In 2018, Barker's former neighbor saw images of Barker placing a camera to capture pictures of the children in his care and reported him to law enforcement.

The Sacramento Internet Crimes Against Children (ICAC) Task Force served a warrant at Barker's Rancho Cordova residence. During the investigation, detectives located images of a child being abused by Barker.

Under current California law, Barker (age 43) will become eligible for release at an Elder Parole hearing once he reaches the age of 50 and only serves 20 years of his 30-years-to-life sentence. With his in-custody credits, that will be in approximately 14 years. ★

Sales of Intoxicating Hemp Products Prohibited

25,000-Plus Illegal Cannabis Plants Removed

SACRAMENTO COUNTY, CA (MPG) - On Oct. 22, The Sacramento County Board of Supervisors unanimously adopted an ordinance that will prohibit sales of certain products containing intoxicating cannabinoids derived from hemp.

The ordinance applies to businesses in the unincorporated county and will become effective on Nov. 21.

“Our primary concern is the safety and well-being of our community, particularly our children and adolescents,” said District 3 Supervisor Rich Desmond. “By prohibiting the sale of these intoxicating hemp products, we are taking a proactive step to eliminate the risks associated with unregulated substances that can lead to health emergencies.”

“This ordinance reinforces our commitment to protecting public health and ensuring responsible business practices in Sacramento County,” Supervisor Desmond added.

Due to loopholes in the Farm Bill of 2018 and Assembly Bill 45, unregulated products containing intoxicating cannabinoids have been sold in locations such as smoke shops, gas stations and convenience stores.

Because people of any age could purchase

those unregulated products, there was a subsequent rise in emergency room visits and hospitalizations due to ingestion and adverse events, particularly in young children and adolescents.

The amended ordinance of the code (Sacramento County Code Chapter 4.54 and adding sections 4.54.500 through 4.54.560) will prohibit sales of chemically or synthetically altered industrial hemp products with a concentration of higher than .3% of THC.

The ordinance will institute administrative penalties for businesses conducting these sales and allow for suspension or revocation of the business license, should the retailer not comply with the ordinance. Administrative penalties include: \$2,500 for the first violation; \$5,000 for the second violation within one year of the first violation; and \$10,000 for each additional violation within one year of the first violation.

The Business Licensing Division of the County’s Department of Finance previously distributed a letter notifying select business licensees of the proposed intoxicating hemp regulation and will perform additional outreach to the business community of the ordinance’s adoption, effective date and administrative penalties. ★

California Department of Parks and Recreation News Release

SACRAMENTO, CA (MPG) - California State Parks continues to combat illegal cannabis grows within and near state park properties through its Cannabis Watershed Protection Program (CWPP).

During the 2024 season, the Cannabis Watershed Protection Program’s special enforcement team led 16 operations in or near state parks’ properties resulting in seven arrests and the removal of 25,558 cannabis plants, 4,820 pounds of processed cannabis and 18 firearms. Numerous environmental crimes related to water diversion and water pollution were also documented.

“Illegal cannabis cultivation poses a serious threat to California’s unmatched natural resources, and we continue to make progress identifying and eradicating grow sites in and around state parks,” said State Parks Director Armando Quintero. “The State Parks Cannabis Watershed Protection Program team will never stop working to protect these most valuable public lands and ensure their environments are safe for generations to come.”

At California’s largest state park, Anza-Borrego Desert State Park, the enforcement team removed 4,672

cannabis plants, approximately 500 pounds of waste and 1,000 feet of irrigation line. The enforcement team works closely with both the Department of Justice’s Eradication and Prevention of Illicit Cannabis program and Gov. Gavin Newsom’s Unified Cannabis Enforcement Task Force.

The state park units that the Cannabis Watershed Protection Program enforcement team led law enforcement operations in or around this year were Anza-Borrego Desert State Park, Clear Lake State Park, Colonel Allensworth State Historic Park, Lake Oroville State Recreation Area, Onyx Ranch State Vehicle Recreation Area, Saddleback Butte State Park and Smithe Redwoods State Natural Reserve.

Additionally, the enforcement team and other Cannabis Watershed Protection Program staff fully remediated 23 historic grow sites occurring on state park property. These efforts resulted in the removal of approximately 16,000 pounds of waste, including 33,000 feet of plastic irrigation tubing and more than 600 pounds of fertilizer. The environmental impacts of these illicit grow operations can be devastating, such as polluting waterways and altering native ecosystems, and remediation is the first step in addressing effects they have on the landscape. ★

SMUD Lists Unclaimed Checks on its Website

SACRAMENTO, CA (MPG) - Do you have an uncashed check from SMUD?

The names of customers and vendors who have not yet cashed checks dated Sept. 30, 2021 or earlier are now available on smud.org.

The list of names will be posted until Dec. 23.

To file a claim on an uncashed check, the claimant’s name must be included on the list to be valid.

To make a claim, call 916-732-7440 and supply the claimant’s name, current address,

telephone number and the address for the period between Oct. 1, 2020 and Sept. 30, 2021.

Claims can also be mailed to Sacramento Municipal Utility District Unclaimed Monies, 6201 S St., Mail Stop B352, Sacramento, CA 95817-1818.

Each year, SMUD posts this information to find the money’s rightful owner.

Claims must be made by 5 p.m. Dec. 23, or they become the property of SMUD under California Code Section 50050-50057.

Replacement checks will be issued only to the payee or, upon proof of death, to the payee’s beneficiary. ★



This Veterans Day, I want you to do more than just thank a veteran for his or her service.

As a veteran of 28 years, I want to challenge you to go beyond patriotic rhetoric by asking some specific questions of the veterans you encounter.

First, ask us what we did in military service. Don't worry; our stories aren't just about bombs and bullets and boats.

For instance, most of us would love to tell you about how we deployed on more than a few humanitarian missions.

If you ask, we'll tell about operations like "New Horizon," where we built schools, clinics and playgrounds all over South America.

Some of us can tell you about cleaning up New Orleans after Hurricane Katrina, while others will tell you about flying into countries devastated from earthquakes or tsunamis.

Ask us what we did, and we might recollect building runways in the desert, pitching tents in the jungle, hot-loading a plane, setting up communications links in the Australian outback and launching a satellite that gave you the cable TV you enjoy.

Get us talking and we'll tell you about fixing planes, loading planes, flying planes, jumping from planes, fueling planes in flight.

As a chaplain, I can tell you about the blessings I prayed over planes as well as the blessing I had of walking away from a plane crash.

This generation of service members might lose you in their technical talk, but I assure you they are proud to talk about the satellites they control, the drones they fly and the cyber warfare they engage.

did, ask them where they've been.

They'll likely share their version of Johnny Cash's song, "I've Been Everywhere."

They've filled passports doing temporary duty in places like Antigua, Ukraine and Djibouti on the Horn of Africa.

They've flown planes over the North Pole, landed them on the South Pole and navigated submarines under both.

And yes, they've even spent some time in "dark sites" that don't exist.

They shivered with their families on assignment in Minot, N.D., and spent a few sweltering years in Fort Huachuca, Ariz.

My family loved the two years they spent in Izmir, Turkey, while other military families enjoyed the island seclusion of Guam or the Azores.

A few lucky ducks will regale you with stories of embassy duty in Paris, London or Madrid.

But if you want to go deep, ask them what it means to have served.

If you listen well and they think you're interested, they just might tell you.

But it's just as likely they won't be able to tell you. It's just as likely that there will be a hitch in their voice, a mist will form in their eyes, and they'll turn away from that question.

Don't get me wrong. They're proud of the things they've done and they want to share them with you.

But I caution you: There are some things they won't share.

Taking an oath to obey the legal orders of those appointed over them meant that they also did the unimaginable and for some the unspeakable.

I know because they told their chaplain.

They told me about the lives they couldn't save and the lives they had to take. They've shown me their physical wounds and they've bared their moral wounds.

Thankfully, the stories of most servicemembers run the course of everyday life; albeit a life of transfers every two or three years, endless inspections and exercises, family separations, and making ends meet on military pay.

It was a life of long ago, but it was life from only yesterday.



Achieving Organic Targets May Require Creating New Markets

In April, Gov. Gavin Newsom's administration announced California will aim to convert 10% of its cropland to organic agriculture by 2030. Those targets could be a heavy lift in light of recent trends in organic acreage. In 2022, the most recent year with data reported, about 4% of the state's cropland was organic, and after years of expansion, the share of acreage that was organic had declined for two straight years. Some stakeholders are pushing for the state government—as a major food buyer for schools, prisons and other publicly funded institutions—to leverage its purchasing power to create the market needed for California to achieve its goals.

State Water Board Announces Draft Updates to Bay-Delta Plan

California water officials are taking another step forward as part of a broader process to improve conditions for struggling fish populations in the San Francisco Bay and the Sacramento-San Joaquin Delta and its tributaries. Last week, the California State Water Resources Control Board announced draft updates for the Sacramento River and Delta phase of the state's water quality control plan, known as the Bay-Delta plan. Thad Bettner, executive director of the Sacramento River Settlement Contractors, a group that holds contracts with the U.S. Bureau of Reclamation to divert water from the Sacramento River, said the draft updates mark the beginning of the implementation process, which he said "could have significant impacts on agriculture and the environment."

Farmers are in peak season producing Japanese dried persimmons

Otow Orchard in Placer County is in full swing producing hoshigaki, traditional Japanese dried persimmons. Each year, farm owners Tosh and Chris Kuratomi set aside some of the persimmons grown on their 40-acre property, and over about three to six weeks, hand-peel the fruit, string it onto a rack and massage it every three to five days until it's sufficiently dried into a sugary delicacy. They then package it and sell it at their farmstand and by mail order. This year's persimmon crop has been plentiful but with small fruit, Tosh Kuratomi said, adding that he's almost running out of rack space. As usual, customer demand nearly is exceeding supply, even at a cost of \$60 per pound mail order or \$37 per pound at the farm stand.

Online Grocery Shopping Continues to Gain Popularity

A recent report from the U.S. Department of Agriculture highlights a significant shift toward online grocery shopping in the U.S. It notes that about one in five individuals who typically do household grocery shopping made an online purchase in the past month. Shoppers most likely to shop online were women, ages 15-24, non-Hispanic White, married or partnered, from a household with young children and more educated. Time constraints were the top reason for shopping online. Pickup and delivery options were used almost equally. USDA noted that the rise in online grocery shopping presents opportunities to improve food access, encourage healthier choices and reshape the grocery retail landscape. ★

One Issue Trump and Newsom Agree On? Homeless Encampments

When President-elect Donald Trump moves into the White House in January, he will become a key figure in California's homelessness crisis, holding the federal purse strings and setting policy at the national level.

So what will this change of power mean for the state as it tries to move its nearly 186,000 homeless residents — the most in the nation — indoors?

Housing and homeless services experts in California worry the Trump administration will cut federal funding in those areas, while also doing away with policies deemed too "progressive."

But surprisingly, based on what he's said so far about one of the key issues regarding homelessness, Trump's agenda isn't much different from Gov. Gavin Newsom's. Trump pledged to tackle the encampments that have made cities "unlivable" by working with states to ban urban camping and arrest those who don't comply — something many cities in California started doing before Election Day, as Newsom encouraged them to clear camps.

"The homeless have no right to turn every park and sidewalk into a place for them to squat and do drugs," Trump said in a campaign video posted online in April 2023. The video appears to be the last time he revealed specific homelessness policy intentions.

"There is nothing compassionate about letting these individuals live in filth and squalor rather than getting them the help that they need," Trump said.

Newsom, who in most other arenas is one of Trump's biggest foes, has said nearly the exact same thing.

"There is no compassion in allowing people to suffer the indignity of living in an encampment

for years and years," Newsom said in September before signing a package of housing bills. In July, Newsom ordered state agencies to ramp up encampment sweeps, and he threatened to withhold state funding from cities that fail to do the same.

More than two-dozen California cities and counties already have introduced or passed new ordinances cracking down on camps (or updated existing ones to make them more punitive), after the Supreme Court gave them the green light to do so in June.

Trump also said he would move unhoused people to tent cities staffed with doctors and social workers.

That plan alarmed Alex

Visotzky, senior California policy fellow for the National Alliance to End Homelessness.

"We need to remember that involuntary carceral approaches don't work and just delay our efforts to end homelessness," he said.

If Trump pushes these policies at the national level, especially if he offers federal funding for sweeps and tent cities, it could spur California cities to further crack down, Visotzky said.

As the Trump administration gets to work replacing the heads of federal agencies such as the U.S. Interagency Council on Homelessness, there's a good chance California will get tossed

out along the way, said Sharon Rapport, director of California state policy for the Corporation for Supportive Housing. The new guard likely will scrap at least some policies viewed as the gold standard in California, such as "housing first," which says unhoused people, even those struggling with an addiction or their mental health, should be offered housing with no strings attached, and then services to help them recover.

It's also a good bet California would see large cuts to funding for federal housing and homelessness programs — including the voucher program that subsidizes rents for hundreds of thousands of Californians, Rapport said.

That's worrying for organizations such as Abode, which provides housing and other services for homeless Californians in seven counties.

"Federal funding is the brunt of what we receive either directly or through other entities, so it could be really impactful if there's a huge reduction," said CEO Vivian Wan. "It's just going to hurt all of our communities."

California Will Likely Feel the Consequences of Donald Trump's Decisive Victory

Elections have consequences, as California is likely to learn when Donald Trump once again moves into the White House.

The state has been a bastion of anti-Trump sentiment ever since the bombastic billionaire real estate tycoon first ventured into politics nearly a decade ago.

Its political figures — particularly Gov. Gavin Newsom, former House Speaker Nancy Pelosi and U.S. Senator-elect Adam Schiff — have sought and achieved notoriety for their public denunciations of Trump.

Trump has responded in kind. As president, he attempted to thwart some California policies, such as its reductions of farmers' supplies, and as a candidate portraying Vice President Kamala Harris's home state as a hellhole of crime and social decay.

There's no reason to believe that Trump, despite election night promises to bridge the nation's stark conflicts, will not continue using California as a punching bag during his second stint as president.

The agricultural water conflict is likely to resurface because the state is still trying to reduce farmers' share. Trump's promised crack-down on undocumented

immigrants would likely have its greatest impact on California. The state's aggressive crusade to reduce reliance on carbon-based fuels will conflict with Trump's pledge to ramp up oil and gas production.

That's just three points of friction between California and Trump's second presidency, and many more are out there such as gun control and transgender participation in women's sports.

California officialdom appears ready for four years of confrontation. On election night, Assembly Speaker Robert Rivas told Politico, "California will do everything we can to protect America from Donald Trump." Attorney General Rob Bonta promised to wage legal battles against Trump on gun control and abortion rights, telling the political news outlet, "We have gone down to the detail of what court do we file in."

Positioning as a Trump foe is a slam dunk tactic for California politicians, especially those, such as Bonta, who may aspire to succeed Newsom as governor two years hence.

But, one might wonder, what does Harris's defeat and Trump's victory bode for Newsom? He will no doubt lead the opposition if Trump tries to punish the state, as he anticipated in a recent interview.

"They're not going to wait to wind up. It's ready, fire, aim — not ready, aim, fire," Newsom said. "And that is going to create a dynamic that will be profound in two senses — from a governing perspective and also from a political attack perspective."

However, would he take the next step of joining

what will be a clutch of Democratic politicians angling to succeed Trump in 2028?

While laboriously building a national political profile in the last two years, Newsom repeatedly denied any ambition of becoming a presidential candidate, saying at one point he has "sub-zero interest."

National political media never bought the line and continued to portray him as a potential aspirant for the White House. However, whatever ambition Newsom may have had if Joe Biden bowed out this year was dashed when Democratic leaders immediately anointed Harris as the substitute.

Her decisive defeat probably means that she has hit the political ceiling, particularly since initial election night finger-pointing dwelled on her shortcomings as a candidate, as well as the Democratic Party. The door is now open for Newsom to run, unless he truly intends to finish out his second term as governor and return to life as a restaurateur and wine merchant.

Newsom has spent half of his 57 years climbing up the political ladder, one rung at a time. Is he really willing to give it up? What he does in the coming months, either entering the Democratic Party's forthcoming battle royale or exiting the national political arena, will answer the question.

Dear Dave,

My wife and I have paid off all our consumer debt, and we're in Baby Step 3 building up our emergency fund to six months of expenses. When do you recommend buying a new car in the process? Do we have to wait until we've finished all the Baby Steps?

— Aaron

Dear Aaron,

Congratulations! You two are taking really positive steps forward in gaining control of your finances. I'm proud of you!

Ok, I'm not sure if you're talking about buying a newer car—like a great two- or three-year-old model—or an actual new car. I don't advise buying a brand new car, unless you have a net worth of at least \$1 million. Why? Because at that point, you've got enough assets that you won't get rocked by the crazy depreciation that comes with buying a brand new vehicle.

Don't get all down after hearing this. I'm not saying you should drive a junker until you pay off your house. I recommend that people drive the minimum they can in terms of a car until they complete the first three Baby Steps. As you already know, Baby Step 1 is a beginner emergency fund of \$1,000. Baby Step 2 is paying off all debt except for your home, and Baby

Step 3 is fully funding your emergency fund with three to six months of expenses.

After you've accomplished the first three steps, then you can move up to a nicer car. Notice I didn't say move up to a new car. I want you to save up cash, and get a really nice, slightly used car—one that someone else has taken the big hit in depreciation on. That's what the typical millionaire does.

And I want you to model your financial behavior after people who are in the position you want to be in one day!

This Isn't Just a Dispute

Dear Dave,

Recently, my husband and I discovered that his ex-wife used his Social Security number to open three or four credit card accounts. We've called the credit card companies, and we've disputed the charges and explained the situation. Is there anything else we can do?

— Kendra

Dear Kendra,

File a police report immediately, and if possible, have this woman arrested. That may sound harsh, but the fact is she has committed criminal fraud. That's not something you, or anyone else, should take lightly. If you haven't already, make sure you both also put fraud victim alerts

on your credit reports immediately.

I'm very serious about this, Kendra. Don't stop with just alerting the credit card companies. You should be speaking with, and communicating via email—plus snail mail—directly with the fraud victim division at every credit card company involved. And here's the really important part. Make sure they understand that this is a denial of responsibility on your part—not simply a dispute.

Try to be nice, and let them know you're sorry this happened. But clearly explain that all these charges are the result of a criminal act perpetrated against you. You may have to stand your ground with some of the credit card companies, because they might try to lay a guilt trip on you—or outright lie—to get you to pay the bills. Don't do it. These charges are not your responsibility. I'm really sorry this happened to you folks.



Why Trump Won and Won Big! The Issue is Liberty!

WEST SACRAMENTO, CA (MPG) - First pitch of the A's inaugural game at Sutter Health Park in West Sacramento will take place at 7:05 p.m. on Monday, March 31, as the Athletics take on the Chicago Cubs.

Across the 81-game home slate, the A's will play 60 night games, including 25 of their 28 games in June and July. Eleven of the A's 21 total day games will be played in April and May, with only six Sunday day games scheduled from June through August. Night games will begin at 7:05 p.m.

The home schedule features matchups against eight National League clubs, including the San Diego Padres (April 7-9), New York Mets (April 11-13), Philadelphia Phillies (May 23-25), San

Independence Day (July 4). The A's will share Sutter Health Park with the Sacramento River Cats. MLB and MiLB have coordinated home schedules to accommodate both teams, ensuring that there are no instances in which both teams play at home on the same day.

The 60 home night games would tie the 1968 A's for the most in a season in franchise history.

A's season tickets for 2025 are on sale now and will be released in phases. Current A's season ticket holders will be notified when seats comparable to their 2024 plan are available to purchase. Fans who have placed a season ticket deposit will be notified based on priority when tickets are available for purchase. Single-game tickets will go on sale in early 2025. ★
