City Council Rejects Yarbrough Appeal

WEST SACRAMENTO, CA (MPG) - After a more than four-hour public hearing Nov. 6, West Sacramento City Council voted four to one to deny an appeal and approve a resolution to proceed with the Yarbrough development. a project first approved in 2008.

Councilwoman Norma Alcala voted no on the resolution.

The resolution confirmed a Planning Commission decision that a new Environmental Impact Review (EIR) was not needed for the project since there was no evidence of substantial new environmental impacts or substantial increases in identified environmental impacts to the area in the 16 years since the original Environmental Impact

Review was approved.

According to a staff presentation, the project, proposed by ASB Properties on 713 acres in Southport, will consist of 3,004 residential units located around "a

village core with commercial and mixed uses," a privately-owned public golf course and open spaces including a 56-acre lake and canal system. The first of four project phases includes 548 residential

units in the northeast corner of the acreage, along with project infrastructure and improvements to Jefferson Boulevard.

Continued from page 1 since its approval in 2008," city senior planner Daniel Berumen said.

In appealing the decision, Kimber Goddard, a 40-year resident of West Sacramento and "semi-retired trust attorney" mainly took issue with the Environmental Impact Review's age and the impacts a population growth of more than 10,000 residents since 2008 has had on Southport and the city. Traffic issues, road conditions, increasing flood control requirements, along with recent residential and commercial development, were some of the issues Goddard and the seven witnesses who spoke to the council detailed.

"How long before an EIR is too old before it's not meaningful?" Goddard asked. "Well, answer is less than 16 years. This zombie came up from the grave muttering 'no impacts.""

Developer David Stroud of ASB Properties disputed the claims that the Environmental Impact Review didn't address these impacts. He noted the original traffic analysis was done for 9,400 units, so the 3,004 units planned are a

58% reduction.

The project has received all necessary permits, except from the Army Corps of Engineers, which is expected in November. Stroud listed three examples of successfully completed projects with Environmental Impact Review older than Yarbrough's, noted 100year flood requirements were already in place and illustrated how the mixture of residential units would meet the city's current housing needs, especially for affordable housing.

At least five witnesses, including several Southport residents, testified in favor

"That improvement will be started the very first time we are able to pull a grading permit on this project," Stroud said of criticism that Jefferson improvements would be done in spurts. "When you start it, you finish it. You don't start and stop; it costs more."

Alcala said her no vote on the resolution was not against the project, which she supports, but against using the 2008 Environmental Impact Review to address current impacts. In voting to approve the resolution, Councilwoman Dawnté Early, who represents Southport, said the developer met the legal arguments centered on "was that considered" in 2008

"And I heard in response to that was, that was considered, that we did have a plan," she said.

Each year, SMUD posts this information to find the money's rightful owner.

Claims must be made by 5 p.m. Dec. 23, or they become the property of SMUD under California Code Section 50050-50057.

Replacement checks will be issued only to the payee or, upon proof of death, to the payee's beneficiary.

Yolo County's Multi-Disciplinary Interview Center Renamed in Honor of Former Director

WOODLAND, CA (MPG) - The Yolo County Children's Advocacy Center, previously known as the Multi-Disciplinary

Interview Center (MDIC), has officially changed its name to Cameron's Place. Established in 2003, under the Yolo County District Attorney's Office, this center provides forensic interviews and support services for child victims of abuse and their families. Cameron's Place is a vital resource for our community, and we are fortunate to have such a dedicated center in Yolo County.

Cameron's Place is a collaborative effort involving all Yolo County law enforcement agencies, Health and Human Services Agency, Mental Health and Child Welfare, Empower Yolo, Sutter Health, Yolo County Victim Services and the District Attorney's Office, among others. This multi-disciplinary team ensures a comprehensive response to child abuse in

the community.



The center was inspired by the vision of its former director, Cameron Handley, who dedicated her life to supporting children after learning about effective, trauma-informed approaches to handling child abuse cases. Cameron retired in December 2021.

Cameron's Place coor-

dinates investigations, treatment, and prosecution of child abuse cases, significantly reducing trauma for victims. Research shows that centers like this one provide tailored support and save resources while enhancing collaboration among partners. Thanks to the many relationships Cameron built throughout her career, the Multi-Disciplinary Team continues to provide essential services to victims and their families, ensuring that they receive the support they need during them most challenging times.

"Renaming the center honors Cameron's incredible legacy and makes it easier for families to remember us," said Cecilia Lopez, Director of Cameron's Place. "Our mission to advocate for and support the children of Yolo County remains unchanged, as do our location, contact information, and dedicated staff. We are committed to providing the highest level of services and support to our community."

Yolo County Upgrades to a New Evacuation System

WOODLAND, CA (MPG) - Yolo County is introducing a new evacuation notification platform that went live on Nov. 7 called Genasys Protect EVAC.

This upgraded platform will be used to provide ongoing and more responsive and informative evacuation notices to residents during an emergency, including real-time updates. This platform replaces the previous county program specifically called "Know Your Zone."

Genasys Protect EVAC will provide ongoing follow-up notices after the initial Alert Yolo evacuation has been given; Alert Yolo was launched in Yolo County in September 2024. Alert Yolo and Genasys Protect EVAC are part of the unified structure and database for evacuation noticing throughout the region and will work in tandem for seamless community updates and awareness.

Genasys Protect EVAC enables Yolo County and its partners to designate specific evacuation zones throughout the county, playing a vital role in emergency planning and coordination among fire and law enforcement organizations. Residents will still need to be familiar with zone-based evacuation terminology and management that will enhance situational awareness, provide a unified operational picture for first responders, speed up decision-making, improve communication and collaboration with agencies, integrate zone-based maps on county and municipal websites, and increase community awareness of evacuation planning efforts

To familiarize yourself with your zone, follow these quick steps:



Working Septuagenarian Asks **About Disability Benefits**

Dear Rusty: I retired at my full retirement age, am now 79 and will be 80 in December. I have been working consistently since. I get a meager Social Security benefit, only about \$800 due to my federal retirement offset. Most jobs I have held since filing and collecting SS have involved very labor-intensive work, to include my current position. This has taken a toll.

My question: is there any provision in Social Security that permits re-evaluation of Social Security benefits for disability after one has collected and paid into the system for some 15 years? I suspect not but thought I would ask, since at my not so tender age, I am faced with having to cease employment that generates needed income. Signed: Working Still at 79.

Dear Still Working: I'm afraid that Social Security Disability Insurance (SSDI) benefits are no longer available once you reach your SS "full retirement age," or "FRA," which for you was age 66. Indeed, anyone collecting SSDI at full retirement age is automatically converted to their regular SS retirement benefits at the same amount they were previously receiving on SSDI. That's because SSDI benefits are intended to sustain workers up to their SS full retirement age, but SSDI goes away once FRA is attained. Thus, the provision to

apply for SS disability allows only those who have not yet reached their full retirement age to seek disability benefits. Once FRA is reached, SSDI benefits are no longer available. Simply for your awareness, there would be no financial advantage for you to receive SS disability benefits anyway, because the most you can get on SSDI is your full retirement age amount. Thus, since you retired and claimed SS at your full retirement age, no additional disability amount would be available anyway.

FYI, I admire, at your "tender age," that you are still actively working, but I'm afraid you cannot claim more now on Social Security disability because you've already reached your FRA. However, from what you've written, your SS retirement benefit has been affected by the so-called Windfall Elimination Provision (WEP) which affects those with a separate pension earned without contributing to Social Security.

If you've been separately working (and contributing to Social Security) since you left government service, and you now have more than 20 years contributing to SS from other non-government "substantial earnings," it's possible that you can request a reevaluation of your WEP penalty. WEP provides relief for those who have more than 20 years contributing to Social Security. So, if you have more than that over your lifetime, you could ask that your WEP reduction be reevaluated to consider your additional years contributing to Social Security. If that is the case, your monthly amount would be increased to consider those additional years contributing to SS since you first claimed.

I suggest, if you now have more than 20 years of contributions to Social Security from your non-government work over your lifetime, that you call Social Security to request reevaluation of your WEP retirement amount. FYI, you can see exactly how many years of SS-covered work you have by requesting an "Earnings Statement" from Social Security. You can get this Statement by calling 1.800.772.1213, or you can also get it at your personal "my Social Security" online account at www. ssa.gov/myaccount (Social Security will also be able to tell you this directly when you call). In any case, I wish you good fortune, and hope that reevaluating the WEP reduction to your SS benefit may offer some small financial relief as you go forward.

25,000-Plus Illegal Cannabis Plants Removed

SACRAMENTO, CA (MPG) - California State Parks continues to combat illegal cannabis grows within and near state park properties through its Cannabis Watershed Protection Program (CWPP).

During the 2024 season, the Cannabis Watershed Protection Program's special enforcement team led 16 operations in or near state parks' properties resulting in seven arrests and the removal of 25,558 cannabis plants, 4,820 pounds of processed cannabis and 18 firearms. Numerous environmental crimes related to water diversion and water pollution were also documented.

"Illegal cannabis cultivation poses a serious threat to California's unmatched natural resources, and we continue to make progress identifying and eradicating grow sites in and around state parks," said State Parks Director Armando Quintero. "The State Parks Cannabis Watershed Protection Program team will never stop working to protect these most valuable public lands and ensure their environments are safe for generations to come."

At California's largest state park, Anza-Borrego Desert State Park, the enforcement team removed 4,672 cannabis plants, approximately 500 pounds of waste and 1,000 feet of irrigation line. The enforcement team works closely with both the Department of Justice's Eradication and Prevention of Illicit Cannabis program and Gov. Gavin Newsom's Unified Cannabis Enforcement Task Force.

The state park units that the Cannabis Watershed Protection Program enforcement team led law enforcement operations in or around this year were Anza-Borrego Desert State Park, Clear Lake State Park, Colonel Allensworth State Historic Park, Lake Oroville State Recreation Area, Onyx Ranch State Vehicle Recreation Area, Saddleback Butte State Park and Smithe Redwoods State Natural Reserve.

Additionally, the enforcement team and other Cannabis Watershed Protection Program staff fully remediated 23 historic grow sites occurring on state park property. These efforts resulted in the removal of approximately 16,000 pounds of waste, including 33,000 feet of plastic irrigation tubing and more than 600 pounds of fertilizer. The environmental impacts of these illicit grow operations can be devastating, such as polluting waterways and altering native ecosystems, and remediation is the first step in addressing effects they have on the landscape.

One Issue Trump and Newsom Agree On? **Homeless Encampments**

When President-elect Donald Trump moves into the White House in January, he will become a key figure in California's homelessness crisis, holding the federal purse strings and setting policy at the national level.

So what will this change of power mean for the state as it tries to move its nearly 186,000 homeless residents — the most in the nation — indoors?

Housing and homeless services experts in California worry the Trump administration will cut federal funding in those areas, while also doing away with policies deemed too "progressive."

But surprisingly, based on what he's said so far about one of the key issues regarding homelessness. Trump's agenda isn't much different from Gov. Gavin Newsom's. Trump pledged to tackle the encampments that have made cities "unlivable" by working with states to ban urban camping and arrest those who don't comply — something many cities in California started doing before Election Day, as Newsom encouraged them to clear camps.

"The homeless have no right to turn every park and sidewalk into a place for them to squat and do drugs," Trump said in a campaign video posted online in April 2023. The video appears to be the last time he revealed specific homelessness policy intentions.

"There is nothing compassionate about letting these individuals live in filth and squalor rather than getting them the help that they need," Trump said.

Newsom, who in most other arenas is one of Trump's biggest foes, has said nearly the exact same thing.

"There is no compassion in allowing people to suffer the indignity of living in an encampment

for years and years," Newsom said in September before signing a package of housing bills. In July, Newsom ordered state agencies to ramp up encampment sweeps, and he threatened to withhold state funding from cities that fail to do the same.

More than two-dozen California cities and counties already have introduced or passed new ordinances cracking down on camps (or updated existing ones to make them more punitive), after the Supreme Court gave them the green light to do so in June.

Trump also said he would move unhoused people to tent cities staffed with doctors and social

That plan alarmed Alex

Visotzky, senior California policy fellow for the National Alliance to End Homelessness.

"We need to remember that involuntary carceral approaches don't work and just delay our efforts to end homelessness,"

If Trump pushes these policies at the national level, especially if he offers federal funding for sweeps and tent cities, it could spur California cities to further crack down, Visotzky said.

As the Trump administration gets to work replacing the heads of federal agencies such as the U.S. Interagency Council on Homelessness, there's a good chance policies California has come to rely on will get tossed out along the way, said Sharon Rapport, director of California state policy for the Corporation for Supportive Housing. The new guard likely will scrap at least some policies viewed as the gold standard in California, such as "housing first," which says unhoused people, even those struggling with an addiction or their mental health, should be offered housing with no strings attached, and then services to help them recover.

It's also a good bet California would see large cuts to funding for federal housing and homelessness programs — including the voucher program that subsidizes rents for hundreds of thousands of Californians, Rapport said.

That's worrying for organizations such as Abode, which provides housing and other services for homeless Californians in seven counties.

"Federal funding is the brunt of what we receive either directly or through other entities, so it could be really impactful if there's a huge reduction," said CEO Vivian Wan. "It's just going to hurt all of our communities."

California Will Likely Feel the Consequences of Donald Trump's Decisive Victory

Elections have consequences, as California is likely to learn when Donald Trump once again moves into the White House.

The state has been a bastion of anti-Trump sentiment ever since the bombastic billionaire real estate tycoon first ventured into politics nearly a decade ago.

Its political figures particularly Gov. Gavin Newsom, former House Speaker Nancy Pelosi and U.S. Senator-elect Adam Schiff — have sought and achieved notoriety for their public denunciations of Trump.

Trump has responded in kind. As president, he attempted to thwart some California policies, such as its reductions of farmers' supplies, and as a candidate portraying Vice President Kamala Harris's home state as a hellhole of crime and social decay. There's no reason to

believe that Trump, despite election night promises to bridge the nation's stark conflicts, will not continue using California as a punching bag during his second stint as president.

The agricultural water conflict is likely to resurface because the state is still trying to reduce farmers' share. Trump's promised crackdown on undocumented

have its greatest impact on California. The state's aggressive crusade to reduce reliance on carbon-based fuels will conflict with Trump's pledge to ramp up oil and gas production.

That's just three points of friction between California and Trump's second presidency, and many more are out there such as gun control and transgender participation in women's sports. California officialdom

appears ready for four years of confrontation. On election night, Assembly Speaker Robert Rivas told Politico, "California will do everything we can to protect America from Donald Trump." Attorney General Rob Bonta promised to wage legal battles against Trump on gun control and abortion rights, telling the political news outlet, "We have gone down to the detail of what court do we file in."

Positioning as a Trump foe is a slam dunk tactic for California politicians, especially those, such as Bonta, who may aspire to succeed Newsom as governor two years hence.

But, one might wonder,

what does Harris's defeat and Trump's victory bode for Newsom? He will no doubt lead the opposition if Trump tries to punish the state, as he anticipated in a recent "They're not going to wait

to wind up. It's ready, fire, aim - not ready, aim, fire," Newsom said. "And that is going to create a dynamic that will be profound in two senses — from a governing

perspective and also from a political attack perspective." However, would he take

> While laboriously building a national political profile in the last two years, Newsom repeatedly denied any ambition of becoming a presidential candidate, saying at one point he has "sub-zero interest."

> National political media never bought the line and continued to portray him as a potential aspirant for the White House. However, whatever ambition Newsom may have had if Joe Biden bowed out this year was dashed when Democratic leaders immediately anointed

> Harris as the substitute. Her decisive defeat probably means that she has hit the political ceiling, particularly since initial election night finger-pointing dwelled on her shortcomings as a candidate, as well as the Democratic Party. The door is now open for Newsom to run, unless he truly intends to finish out his second term as governor and return to life as a restaurateur and wine merchant.

> Newsom has spent half of his 57 years climbing up the political ladder, one rung at a time. Is he really willing to give it up? What he does in the coming months, either entering the Democratic Party's forthcoming battle royale or exiting the national political arena, will answer the question.

My wife and I have paid off all our consumer debt, and we're in Baby Step 3 building up our emergency fund to six months of expenses. When do you recommend buying a new car in the process? Do we have to wait until we've finished all the Baby Steps?

Dear Aaron,

Congratulations! You two are taking really positive steps forward in gaining control of your finances. I'm proud of you!

Ok, I'm not sure if you're talking about buying a newer car—like a great two- or three-yearold model-or an actual new car. I don't advise buying a brand new car, unless you have a net worth of at least \$1 million. Why? Because at that point, you've got enough assets that you won't get rocked by the crazy depreciation that comes with buying a brand new vehicle.

Don't get all down after hearing this. I'm not saying you should drive a junker until you pay off your house. I recommend that people drive the minimum they can in terms of a car until they complete the first three Baby Steps. As you already know, Baby Step 1 is a beginner emergency fund of \$1,000. Baby Step 2 is paying off all debt except

for your home, and Baby

Step 3 is fully funding your emergency fund with three to six months of ex-

penses. After you've accomplished the first three steps, then you can move up to a nicer car. Notice I didn't say move up to a new car. And I want you to model your financial behavior after people who are in the position you want to be in one day!

This Isn't Just a Dispute

Dear Dave,

Recently, my husband and I discovered that his ex-wife used his Social Security number to open three or four credit card accounts. We've called the credit card companies, and we've disputed the charges and explained the situation. Is there anything else we can do? - Kendra

Dear Kendra, File a police report immediately, and if possible, have this woman arrested. That may sound harsh, but the fact is she has committed criminal fraud. That's not something you, or anvone else, should take lightly. If you haven't already, make sure you both also put fraud victim alerts

on your credit reports immediately.

I'm very serious about this, Kendra. Don't stop with just alerting the credit card companies. You should be speaking with, and communicating via email—plus snail mail directly with the fraud victim division at every credit card company involved. And here's the really important part. Make sure they understand that this is a denial of responsibility on your part—not simply a dispute.

Try to be nice, and let them know you're sorry this happened. But clearly explain that all these charges are the result of a criminal act perpetrated against you. You may have to stand your ground with some of the credit card companies, because they might try to lay a guilt trip on you—or outright lie to get you to pay the bills. Don't do it. These charges are not your responsibility. I'm really sorry this hap-

pened to you folks.



30 days after Election Day to complete their extensive tallying, auditing, and certification work (known as the "official canvass"). The frequency of updated results varies by county.

As of Nov. 7, California's county elections officials have already processed and counted 10,728,985 million ballots from the Nov. 5 General Election. County elections officials estimate 5,472,423 million outstanding ballots remain to be processed and counted. The unprocessed ballots report—a compilation of estimates from county elections officials—is available at electionresults.sos.ca.gov/unprocessed-ballots-status.

Vote-by-mail ballots postmarked on or before Election Day and received by county elections officials no later than 7 days after Election Day must be processed.

"County elections officials have been hard at work processing and counting the millions of ballots cast by California voters. Ensuring the accuracy and the integrity of the vote count is critical to our democracy. State law gives county elections officials up to 30 days after Election Day to complete vote counting, auditing, and certification," Secretary of State Shirley N. Weber said. "In California, we work to ensure every ballot is counted properly and every ballot is accounted for," Secretary Weber added.







Tackling Rising Electric Bills

SACRAMENTO, CA (MPG) - On Oct. 30, Governor Gavin Newsom signed an executive order designed to reduce electric costs for Californians.

The Governor's action encourages electric bill relief while maintaining the state's commitment to achieving carbon neutrality and 100% clean electricity by 2045. The action comes as millions of Californians received an average credit of \$71 on their October electric bills from the California Climate Credit, provided by the state's Cap-and-Trade program.

Tackling rising electricity costs

While California has been successful in keeping electric bills lower than many other states on average thanks to decades of work advancing energy efficiency standards, Californians have seen their electric bills rising in recent years. A major driver has been critical utility wildfire mitigation efforts that have accelerated to match the pace of the climate crisis, as well as several programs added over time.

The Governor's executive order addresses both of these cost drivers by zeroing in on some programs that could be inflating customer bills and evaluating utility wildfire mitigation expenses for potential administrative savings.

The Governor's execu-

Encourages electric bill relief: The executive order asks the California Public Utilities Commission (CPUC) to identify underperforming programs and return any unused energy program funds back to customers receiving electric and gas service from private utilities as one or more credits on their bills.

Maximizes the California Climate Credit: The executive order directs the California Air Resources Board (CARB) to work with the CPUC to determine ways to maximize the California Climate Credit, which is a twice annual credit that shows up on many Californians' electric and gas bills in the spring and fall and is funded by the state's Cap-and-Trade

Manages and reduces electric costs for the longterm: The executive order asks the California Public Utilities Commission to evaluate electric ratepayer supported programs and costs of regulations and make recommendations on additional ways to save consumers money. It also asks the California Public Utilities Commission to pursue any federal funding available to help lower electricity costs for Californians. Additionally, the executive order directs the California Energy Commission (CEC) to evaluate electric ratepayer-funded programs and identify any potential changes that could save Californians money on their bills.

Smarter wildfire mit-

The executive order directs the Office of Energy Infrastructure Safety and requests the California Public Utilities Commission to evaluate utility wildfire safety oversight practices and ensure that utility investments and activities are focused on cost-effective wildfire mitigation measures.

In addition to the Governor's action, earlier this year, the California Public Utilities Commission approved a proposal to reduce the price of residential electricity through a new billing structure authorized by the state Legislature. This follows actions in recent years such as providing direct relief to customers and using state funds, rather than ratepayer monies, to develop a Strategic Reliability Reserve to maintain electric grid reliability during extreme conditions.

The Governor welcomes partnership with the legislature to further additional actions that will address electric bill affordability.

"Californians expect us to take a hard look at their monthly energy and electricity bills and deliver reduced costs and savings for the long-term," said Assembly Speaker Robert Rivas (D-Salinas). "I support increased oversight efforts, because regulators must ensure energy programs are implemented effectively and responsibly. The Governor's action today is another step forward to lessen households' total energy burden and lower the cost of living in our state."

"Rising electricity costs are impacting Californians and their quality of life," said Senate President pro Tempore Mike McGuire (D-North Coast). "The state, including its regulatory agencies, needs buckle down blunt the expanding fiscal impacts on ratepayers. This is an important start by Governor Newsom, and the Senate plans to double down on this progress in

Newsom Issues Executive Order Medicare's Payment System is a Boon for Hospitals and a Bust for Patients

Most people over a certain age are familiar with going in for a colonoscopy, a routine method of screening for and preventing colon cancer. What they might not know is that the cost of the procedure can vary wildly depending on where they get it done.

The problem is that Medicare -- the taxpayer-funded health insurer for Americans 65 and above -- pays hospitals significantly more for common procedures than it pays physicians in private practices or ambulatory surgery centers.

This discrepancy contributes to the swelling cost of health care in our country. It's also compelled hospitals to acquire physician practices in increasing numbers. That saps competition, results in higher prices, and leaves patients with fewer options.

Medicare pays more to hospitals for a long list of procedures. In addition to cancer screenings, these include x-rays, chemotherapy infusions, and heart-imaging procedures like echocardiograms and nuclear cardiology, as well as follow-up appointments.

The current system is good for hospitals' bottom lines. But it's bad for everyone else. Medicare serves some 66 million older Americans. Multiply the price of millions of procedures by two or more, and the cost to the federal government adds up.

This system of unequal payments has other negative impacts, too. For example, it requires Medicare to keep seniors' monthly premiums higher than they need to be. MedPAC estimated that switching to site-neutral payments -- in which the federal government pays the same for procedures no matter where they're performed -- would have saved Medicare beneficiaries \$1.5 billion in 2021.

And since private insurers use Medicare reimbursements as the basis for their own payments, premiums for their beneficiaries are higher than they need to be as well. The insurance company Blue Cross Blue Shield estimates that site-neutral reforms would save people with private insurance \$117 billion a year in premiums.

The double standard has encouraged hospitals to gobble up freestanding clinics and small practices so that they can charge Medicare more, according to MedPAC. As soon as a hospital completes an acquisition, it starts billing for the clinic's services at the hospital rate -- without even making changes that might justify a higher price.

Ultimately, this consolidation leaves patients with fewer options to choose from when deciding on

providers. And if all the health facilities in a community end up owned by the same hospital or health system, then there's no competition to drive better quality or pricing for

The solution is for Medicare to establish site-neutral payments. Such reforms would disincentivize large hospital groups from buying up independent outpatient clinics or the surgery centers where doctors in private practice perform procedures.

In the bigger picture, site-neutral payments would decrease overall healthcare spending. According to the American Action Forum, adopting them would save Medicare \$153 billion over 10 years and the healthcare system as a whole \$672 billion.

It makes little sense to pay hospitals many times more than physicians for equivalent work. Implementing site-neutral payments would make patients, taxpayers, and the healthcare system as a whole much better off.

Christmas lights are mostly not up vet, and still holiday programming is already available before anyone has had the chance to carve up a turkey for Thanksgiving dinner.

You can count on the Hallmark Channel to fill their schedule with a surfeit of Christmas movies. It happens every year, and this one is no exception.

Hallmark didn't even wait for Halloween before launching "Scouting for Christmas," in which Tamera Mowry-Housley's Angela is a busy realtor since her amicable divorce a couple of years ago to Dakota (James Paladino), a paleontologist whose adventures kept him anywhere but home.

Now, she is a devoted if often harried, single mom to smart and loving 10-year-old girl Brooklyn (Audrey Wise Alvarez). Angela's busy schedule makes it hard for her to find time for much of anything, or anyone else.

Angela can barely get Brooklyn to her scout meetings on time, much to the disapproval of other mothers. Brooklyn gets the idea to have William (Carlo Marks), the owner of her favorite bakery, cater her scout troop's annual holiday event, and asks Angela to work on pitching the idea to the other moms.

Despite sensing that her daughter might be trying to play cupid, Angela agrees to help and finds herself enjoying time with William, but is reluctant to open her heart and life to someone new.

When Dakota enters the picture again, after missing his ex-wife, Angela must decide what is best for her daughter and best for her heart. "Scouting for Christmas" presents a holiday dilemma.

After a disappointing and somewhat head scratching start, the Kings have climbed out of an 0-2 hole, to post a respectable 6-4 record after ten games.

Sunday's contest featured three Kings players with 20 points or more, with Huerter and Murray chipping in with 17 and 14 points respectively.

Well balanced is the name of the game, and in the fourth quarter, the Suns were without an answer for the mid-range game of both DeRozan and Fox. Both players drove deep into the paint time and time again, only to step back and take easy 6-to-10-foot jumpers that touched nothing It was a mid-range clinic, and DeMar

DeRozan has already given Kings fans a serious dose of what to expect the rest of the season. This heady veteran has the quintessential mid-range jump shot, and he not only makes them with regularity, he has a habit of getting fouled as well. Fouling DeRozan is probably not the best

strategy for opposing teams as he is shooting a sizzling 86.4% from the charity stripe.

Going into the Nov. 10 game against the Suns, remarkably, the cellar dweller Sacramento Kings in 2023/2024 in free throw shooting, were leading the entire league with an 84% success rate. Achieving Organic Targets May Require Creating New Markets

In April, Gov. Gavin Newsom's administration announced California will aim to convert 10% of its cropland to organic agriculture by 2030. Those targets could be a heavy lift in light of recent trends in organic acreage. In 2022, the most recent year with data reported, about 4% of the state's cropland was organic, and after years of expansion, the share of acreage that was organic had declined for two straight years. Some stakeholders are pushing for the state government—as a major food buyer for schools, prisons and other publicly funded institutions—to leverage its purchasing power to create the market needed for California to achieve its goals.

State Water Board Announces Draft Updates to Bay-Delta Plan

California water officials are taking another step forward as part of a broader process to improve conditions for struggling fish populations in the San Francisco Bay and the Sacramento-San Joaquin Delta and its tributaries. Last week, the California State Water Resources Control Board announced draft updates for the Sacramento River and Delta phase of the state's water quality control plan, known as the Bay-Delta plan. Thad Bettner, executive director of the Sacramento River Settlement Contractors, a group that holds contracts with the U.S. Bureau of Reclamation to divert water from the Sacramento River, said the draft updates mark the beginning of the implementation process, which he said "could have significant impacts on agriculture and the environment."

Farmers are in peak season producing Japanese dried persimmons

Otow Orchard in Placer County is in full swing producing hoshigaki, traditional Japanese dried persimmons. Each year, farm owners Tosh and Chris Kuratomi set aside some of the persimmons grown on their 40-acre property, and over about three to six weeks, handpeel the fruit, string it onto a rack and massage it every three to five days until it's sufficiently dried into a sugary delicacy. They then package it and sell it at their farmstand and by mail order. This year's persimmon crop has been plentiful but with small fruit, Tosh Kuratomi said, adding that he's almost running out of rack space. As usual, customer demand nearly is exceeding supply, even at a cost of \$60 per pound mail order or \$37 per pound at the farm

Online Grocery Shopping Continues to Gain Popularity

A recent report from the U.S. Department of Agriculture highlights a significant shift toward online grocery shopping in the U.S. It notes that about one in five individuals who typically do household grocery shopping made an online purchase in the past month. Shoppers most likely to shop online were women, ages 15-24, non-Hispanic White, married or partnered, from a household with young children and more educated. Time constraints were the top reason for shopping online. Pickup and delivery options were used almost equally. USDA noted that the rise in online grocery shopping presents opportunities to improve food access, encourage healthier choices and reshape the grocery retail landscape.





Lopez was named to the first team for the second straight season and became only the fourth Hornet to win four All-Big Sky honors in a career, joining Katie McCov (firstteam honors in 2005-07 and a second-team award in 2004), Kara Taylor (first-team honors in 2005. 2007-08 and an honorable mention award in 2006), and Aubrey Goodwill (first-team honors in 2021-22, a second-team award in 2020, and an honorable mention selection in 2019).

She is only the 11th Sacramento State women's soccer player to earn multiple All-Big Sky first team awards, and the first time since Jasmyne Dunn and Aubrey Goodwill did so in 2021-22.

Meanwhile, Sharts, Herrman, Dougherty, and Farber, all earned their first awards from the Big Sky Conference.

Lopez enters this year's Big Sky Conference Tournament leading the team in scoring with four goals and three assists for 11 points, while also topping the squad in shot



attempts (42) and shots on goal (17). She finished with goals in back-to-back matches against CSUN and Cal State Bakersfield, while scoring a point in three straight matches with goals against Idaho State and Northern Colorado sandwiched around a two-assist performance against Weber State.

She was named the Big Sky Offensive Player of the Week on Oct. 8 following victories over the Bengals and Wildcats with her goal and two assists. Those performances helped push her into the top 10 in school history in both goals scored and points, entering the postseason tournament ranked tied for seventh with 15 career goals and tied for eighth with 37 points.

In addition to her two goals scored in back-toback matches against Idaho State and Weber State (a feat that earned her Big Sky Defensive Player of the Week laurels), Sharts picked up her first career all-conference honor after helping spearhead a Hornets' back line along with Herrman that allowed the fewest goals (21) in a full season by a Hornet defense since the 2019 squad surrendered only 14.

Herrman, meanwhile, added a pair of assists to her season tally along

with her defensive duties, helping on goals against Cal State Bakersfield and Idaho State.

Dougherty is in the midst of a career year for the Hornets statistically, finishing with a pair of goals and two assists to rank third on the team with six points. Her goal against Houston Christian on Aug. 17 was the game-winner, while also adding the tying goal in a 1-1 draw at Northern Arizona on Oct. 20. Her two assists came against Idaho State and Portland State — the latter helping Sacramento State clinch a Big Sky Tournament berth with a 1-0 win over the Vikings.

Farber finished the season second on the team in scoring with seven points, scoring three goals and adding an assist. The sophomore finished with a career-high three points thanks to a goal and an assist against Houston Christian and added her second goal of the year five days later in a 1-1 draw with UC Santa Barbara, scoring with just 39 seconds remaining in regulation to forge the draw.

Later in the year, Farber opened the scoring in a 3-0 rout of Weber State on Oct. 6, netting her first career game-winner.

The No. 5 seed in this week's Big Sky Tournament, the Hornets put their six-match unbeaten streak (3-0-3) on the line against No. 4-seeded Northern Arizona in one of two opening-round matches on Wednesday, Nov. 6, after press time.

- Join us for this post-Thanksgiving fitness adventure Nov. 30!

Presented by the West Sacramento Recreation Center, Turkey Tri is a popular sprint triathlon that takes place annually, typically around the Thanksgiving holiday. It's a festive, family-friendly event that welcomes athletes of all levels to participate in various race formats designed to offer something for everyone. This year, the Turkey Tri will be at 9 a.m. Nov.

The Turkey Tri features a Fun Run, Kids Bike-Run, a Solo Spring and a Team Relay portion.

The Solo Sprint is the main event of the Turkey Tri. Participants tackle a course that usually includes a 750-yard swim, a 12.5-mile bike ride and a 3.5-mile run. This event is ideal for individual athletes looking to test their endurance and speed across all three disciplines.

Swim Section

The distance of the swim is 750 yards.

The swim takes place in the West Sacramento Recreation Center lap swimming pool.

Athletes start the swim from the pool deck edge and exit at a from where they entered.

Lifeguards are stationed along the pool to ensure participant safety.

Bike Course

The distance of the bike course is 12.5 miles.

The bike course is often a mix of flat road sections and gravel roads, designed to be accessible for beginners while still offering a challenge for experienced

The course begins at the Clarksburg Trail near the West Sacramento Recreation Center that follows a scenic route

through local roads and along the Sacramento River levee. See the route map below for course

There are typically one or two aid stations along the bike course offering water and basic mechanical support.

Run Course

The distance of the run is 3.5

The run will be held at the River City High School Stadium

Aid stations with water will be available at the start / finish line.

The Team Relay allows groups

of three participants to compete together, with each member taking on one leg of the triathlon—swim, bike, or run. This format encourages camaraderie and is perfect for friends, families, or co-workers who want to experience the thrill of a triathlon as a team.

The Fun Run is a more relaxed, non-competitive event designed for those who want to participate in the Turkey Tri atmosphere without the pressure of a full triathlon. The course is shorter, by about half the distance of the sprint triathlon, and is open to participants of all ages and fitness levels. Many people dress in Thanksgiving-themed costumes to add to the festive spirit.

The Kids Bike Run is a special event tailored for younger participants. It typically includes a short, manageable bike ride followed by a brief run, with distances adjusted for different age groups. The focus is on fun, safety and encouraging kids to get active. It's a great way for children to experience the excitement of a triathlon in a supportive environment.


Please use the crosswalks. For community center parking, turn onto
