CARMICHAEL, CA (MPG) -The Stars and Stripes flies proudly on a new flagpole above the Carmichael Veterans Memorial Building at Carmichael Park.

Absent for about 20 years, Old Glory's iconic presence was restored on the eve of Veterans Day. More than 50 supporters saluted, sang the National Anthem and recited the Pledge of Allegiance as the nation's symbol unfurled. A black POW/MIA flag was raised with it.

up and saw there was no flagpole and no flag. I thought, this is one place a flag should be. We need to take care of this."

In fact, the 73-yearold building's original pole had weathered badly and been removed by the Carmichael Park District more than 20 years ago. For budgetary reasons, it was not replaced.

With permission from the Carmichael Park District, Fitzgerald kicked off Operation Raise-the-Flag. He sought donations from hall users and service groups. American Legion (Post 861) members provided \$1,000. Carmichael Kiwanis Club gave \$1,500. Carmichael Elks Lodge, a private family foundation, *Continued on page 5*

CHP Receives Grant to Combat Distracted Driving



California Highway Patrol News Release

SACRAMENTO, CA (MPG) -The California Highway Patrol (CHP) is proud to announce it received a \$350,000 grant to address the growing issue of distracted driving on California roads.

Distracted driving remains a leading cause of traffic crashes across the state, with drivers often diverting their attention from the road to activities such as using mobile devices, eating or drinking, adjusting vehicle controls or engaging in conversations with passengers. Even a brief distraction can lead to severe crashes, injuries or fatalities.

To tackle this critical issue, the CHP will engage communities statewide through educational presentations, participation in local events, enforcement operations and social media. This comprehensive strategy emphasizes education and enforcement to reduce incidences of distracted driving. Education helps foster a safety culture on the road, while enforcement is a necessary deterrent to dangerous behavior. "Every driver needs to recognize the serious dangers associated with distracted driving. Each time you look away from the road, even for a moment, you put yourself, your passengers and others at great risk," said CHP Commissioner Sean Duryee. "We all have a responsibility to make our roads safer by staying focused behind the wheel." The CHP remains committed to ensuring the safety of California's drivers and will continue its efforts to reduce the risks posed by distracted driving. Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

"While I was running them up, I thought to myself, 'What a beautiful sight this is," smiled Army veteran Bob Fitzgerald. "These flags are symbols of our nation and what people have sacrificed for it. I was also grateful the Lord favored us with decent weather."

A retired Air Force

master sergeant who served from 1955 to 1977, Fitzgerald spearheaded the staff restoration project.

"I was at the hall, attending an American Legion meeting, in April," Fitzgerald said. "I looked

Hands on for Crafty Christmas Spree

CARMICHAEL, CA (MPG) - St John the Evangelist School's blowout, "A Holiday Show of Hands," will ensure a crafty Christmas for thousands of shoppers on Dec. 6, 7 and 8.

Now in its 46th year and boasting more 150 vendors, the market annually fills the entire Locust Avenue campus with up to 5,000 guests. Proceeds benefit the Catholic school, which won "Best School" in the recent Best of Carmichael contest.

Entrepreneurism annually soars during the fundraiser. Wares range from funky sweaters to metal sculptures and glittering ornaments. A preview (5 to 9 p.m.) Dec. 6 requires a \$10 admission fee but Dec. 7 and Dec. 8 browsing is free. Doors open at 9 a.m. on both weekend days.

Organizers offer a prize opportunity for admission; guests will be included in a draw for a \$100 gift card. A silent auction will offer

hundreds of items; bids close the afternoon of Dec. 8. Santa and Mother Claus will visit from 11 a.m. to 2 p.m. Dec.7 and Dec. 8.

The fair's gourmet pavilion has been enlarged to include more food vendors.

"December is a cold month, so hot toddies and Sister Margaret's famous Irish coffee will take the chill off," promised organizer Pat Holbus. Home-cooked lasagna and other hot dishes will be available as sit-down or take-out meals throughout the event.

"This year, we've added a gift wrap service on Sunday and Boulevard Coffee will host an expresso bar with specialty coffees," Holbus added.

St John the Evangelist School is located at 5701 Locust Ave. Because fair traffic clogs surrounding streets, free shuttles will run from Carmichael Elks Lodge parking lot to St John's Church.

"People come here from all over Sacramento, even from out of state," Holbus said. "Our market is a Sacramento tradition. It's a weekend that says Christmas is here at last."

Everyone Can Light the World

You might have noticed the press coverage last year for the Light the World images that filled the large screens of Times Square in New York City. Visitors to Times Square were in for a surprise when its famous billboards became a largerthan-life tribute to the true reason for Christmas: Jesus Christ.

Instead of the usual array of promotional brand logos and marketing graphics to entice viewers to purchase more products, the screens were filled with images of the baby Jesus, lying in a straw-lined manger, with a new star in the heavens luminating his face.

The billboard takeover at Times Square in New York City was part of Light the World initiative, an annual movement from The Church of Jesus Christ of Latter-day Saints to bring people from all over the world together to share the light of Jesus Christ during the Christmas season.

The beautiful nativity scene that emerged from the blackout was a tender reminder of the Savior's birth and why we need His light and love in our lives. The event was truly a Silent Night surprise as thousands of people stood in awe

Watching the miraculous events of the first Christmas on the mammoth screens overhead.

The good news is that one does not have to travel to Times Square to embrace the Light the World experience. Following the doctrine of all faiths to "love our neighbors as ourselves," everyone this holiday season can do something to light the world for another, such as donating cans to your local food bank, leaving a kind note for your mail and package carrier, visiting an elderly neighbor, texting someone a note that says "I'm so grateful for you," paying for the person behind you in line, asking a co-worker how you can lighten their load and leaving a small gift at a neighbor's doorstep.

There is a plethora of variety in these community service prospects for individuals, couples, families, or large groups.

One of our holiday family favorites is to prepare gift bags for children living in the margins. Our family, including children and grandchildren, numbers 26, and each of us has an assignment to bring something to add to the gift bags.

We set up a couple of large tables near our Christmas tree and have an assembly line to fill the bags, tie with ribbons and deliver to one of the several organizations that support needy children. It is a joy watching our grandchildren delight in filling these gift bags for others.

Another part of Light the World is the Giving Machines, vending machines with a twist. The Giving Machines have become known internationally for offering livestock that charities distribute to families to help them feed themselves or start small businesses. In a single year, givers purchased 41,000 chickens, 25,000 ducks and 3,800 beehives. Chickens, goats, piglets and beehives provided through the Giving Machines have benefited 20,000 families in Kenya and Tanzania over three years.

One year a family in Kenya received three chickens. Three years later, those three had grown to a flock of over 7,000 that provided food and income to support not only their family but the entire village. Giving Machines partner each year with both global charities and local nonprofits to allow people to donate items to people in need and have raised more than \$32 million since 2017.

The Giving Machines will be back in Northern California this year. The big red vending machines will again be at the Westfield Galleria Mall in Roseville and at the Vintage Fair Mall in Modesto as two of the 106 global locations.

Cell Phone Restrictions Increasingly Implemented in Area Schools

SACRAMENTO, CA (MPG) - Before freshmen and sophomores ever make it to their desks in an English classroom at Rio Americano High School, their cell phones are immediately stored in a collection caddy, where they remain until the period ends. But when they return for social studies classes to the room next door, they are free to check texts or step aside to take a call.

The fate of cell phones at Rio Americano – that individual teachers dictate their own policies for in-class use absent a campus-wide rule – is illustrative of the 91% of U.S. high schools that don't have all-day phone bans.

The number of schools cracking down on phone use is increasing every day, though, in both Sacramento and nationwide.

According to San Juan Unified spokesperson Raj Rai, the district already has a policy that restricts in-class phone use. However, she noted that the rule is more than a decade old, and that enforcement does not look the same at every school.

"We will be reviewing this policy this fall and having conversations with our students, staff and families regarding any potential updates that may need to be made based on feedback collected," Rai said.

Cell phone policies vary across the Sacramento region: students store phones in designated holders in classrooms at McClatchy High School, while West Campus High School has "phone pockets" for all students. Rosemont High School, on the other hand, adopted an all-day ban this year.

Nationwide, schools are turning to the use of "phone lockers" and Yondr pouches, device storage bags that can only be

unlocked by administrators. But while the issue has so far been left to the school and district level, California will soon follow other states in mandating cell phone bans.

In late August, the assembly passed AB 3216, new legislation that will require every California school district to create a policy prohibiting student cell phone use during all school hours by July 2026. The bill was signed in September by Gov. Gavin Newsom, who had previously spoken out in support of a ban.

"We know that excessive smartphone use increases anxiety, depression and other mental health issues," Newsom said in a statement. "This new law will help students focus on academics, social development, and the world in front of them, not their screens, when they're in school."

Leaders of AB 3216's only official opponent, the California School Boards Association, said they feel the legislation is a mistaken "one-size-fits-all approach."

"This bill limits the decision-making authority of the governing board as they would now have to adopt a policy, even if, through local community meetings, it was found that there was no need to limit/prohibit the usage," the association said in a statement. "These decisions are best made at the local level by people who understand, reside, are invested in, and accountable to the communities they serve."

While they understand the benefits, some students, parents and even teachers and school officials aren't sure an all-out ban is the best answer to address excessive cell phone use because of the many ways cell phones are utilized.

"I hope that they can make exceptions for those students who may need reminders for medication or need extra support for outside people that they contact through their phone, but I think the general consensus about banning phones is mostly positive," Rio Americano senior Marin Abood said.

Cell phones are seen as a way to contact students in case of emergency, and limiting access to a student's personal device at all times might be a step too far, many parents and ban opponents say.

The National Parents Union reports that 78% of parents want their children to retain cell phone access during the school day.

Overwhelming parent opposition to complete phone bans comes amid incidents of school violence nationwide.

When fake social media threats of school violence affected dozens of Sacramentoarea schools in September, cell phone access provided parents individualized communication with students in addition to general district statements. During the mid-September threats, students texted their parents to let them know they were OK and coordinated being picked up, according to several students who spoke with Sacramento School Beat.

At the same time, AB 3216 would require an exemption from the cell phone ban in the case of an emergency or threat of violence.

Meanwhile, many teachers see phone bans as the best solution to remove the distractions they cause.

"(Phones) prevent students from having a creative and original thought, and it makes them anxious and sad," Rio Americano English teacher Adam Bearson said. "It's distracting to students."

School administrators and district officials have been forced to balance the wishes of teachers with the concerns of students and parents.

"If a student is at lunchtime and they're just talking to their mom or sister or friend or they need to make a phone call to check on their car insurance, I don't know if the school should necessarily look to be banning that," Rio Americano principal Cliff Kelly said.

The issue of cell phone bans in schools has quickly emerged since U.S. Surgeon General Vivek Murthy, the country's chief public health officer, this summer recommended schools go phone-free.

Research showing the negative impact of social media and cell phone use on teenagers has also been highly publicized this year. Depression rates are surging in both boys and girls, where symptoms have risen 161% and 145%, respectively, since 2010.

College students have experienced a 134% spike in anxiety rates and 106% rise in depression, according to the American College Health Association.

But some critics of outright bans say they're essentially unenforceable – and might simply go too far.

One-of-a-Kind Record and Bookstore Opens in Rancho Cordova

RANCHO CORDOVA, CA (MPG) - Music and book lovers rejoice!

At 2707 Cordova Lane, near KP International Market, a new record store and bookstore has recently opened to the public: Fat Elephant Records, Books, and Music.

This is the only combined record store and bookstore in the city of Rancho Cordova, offering a curated collection of affordable vinyl records, cassette tapes, books, CDs, DVDs and more.

The store's owner and founder is Charles Lago, the executive director of the Rancho Cordova Film Office, who also helps run Black Box Theater and Old Mills Winery. Currently, he works alongside Jose Ruiz, also an employee of the film office, and Rafael Portillo, but plans to hire more store employees as business grows.

"We came across all these records and we kept acquiring them," Lago said. "I thought, 'let's just open a store.' I have a background in bookstores, so why not just do both?" So, Lago negotiated a lease with the property owners and the rest is history.

Customers walking into Fat Elephant are greeted at first with the current, popular records, such as Taylor Swift and Morgan Wallen albums. But the further into the store, the more interesting it gets.

Many Sacramento residents will remember The Beat, a former downtown record store off of J Street that closed in 2013. Lago and Ruiz acquired its sign and now it proudly lights

up the back wall, paying homage to a beloved Sacramento novelty.

Customers can find records and CDs ranging from all types of genres, including classical, which is rare for record stores to carry, according to Lago. Movie soundtrack records are also available, including a rare original "Tarzan" record.

The store also boasts a large world music collection, which includes Latin, French, Italian, German, Indian, Russian and Island music in both records and CDs. Lago, from Europe, noted how someone from another country might be delighted to find an album from an artist that is popular overseas but not necessarily popular in America.

There are even comedy and poetry records for sale but it would take all day to peruse the extensive collection of records at Fat Elephant.

Though the store's records are mostly used, excluding the new releases, Lago emphasized that all books for sale are new, featuring bestsellers, fiction, nonfiction, selfhelp, children's and more.

What makes Fat Elephant special? Lago started with the obvious.

"Record stores in Sacramento rarely carry books," he said. "We have stuff that other record stores won't carry because it might be outdated or rare but what I've noticed is that people buy it."

Lago used an example of a young male customer who Lago assumed wouldn't find anything he liked. To his surprise, the young man bought three

vintage Frank Sinatra records, proving that young people are still interested in buying classic records.

"At Fat Elephant Records, we pride ourselves on curating a wide-ranging inventory that spans genres, time periods and continents," Lago said. "There are very few records above \$40."

Customers can also shop a collection of board games and trinkets, such as journals and coasters made to look like records.

Despite its soft opening six weeks ago, Fat Elephant Records, Books, and Music will have its grand opening celebration from 2 to 5:30 p.m. on Saturday, Nov. 2. The celebration will feature live music, complimentary wine and a 20% discount at the store.

The live music will take place inside, featuring two soloists and one band: TIP Vicious, a local Sacramento hip-hop artist; Linden Wood, a country solo artist; and Lab Rats, a locally based hip-hop band, according to Ruiz.

Two lucky raffle winners will receive a \$100 and a \$50 gift card, according to Lago. The Mexican restaurant next door to the store, El Puerto Restaurant, will be serving tacos and beer, as well.

According to Lago and Ruiz, Fat Elephant is aiming to be an "events-based" venue and a "cultural hub" for the arts, and they will aim to hold one to two events per month.

Anyone interested in selling their vinyl collection and "making sure it ends up in the right hands" can contact Fat Elephant, who might buy or exchange the records, according to Lago.

Fat Elephant Records, Books, and Music is open from 11 a.m. to 6 p.m. Thursdays through Sundays, but after its grand opening, will be open on Wednesdays. After Thanksgiving, the store will aim to be open every day, except Mondays.



and individual donors also chipped in. By September, almost \$4,000 had been

raised. The Carmichael Parks Foundation wrote a check to match the donations.

"We wanted a strong pole that would last," Fitzgerald explained. "To prevent unauthorized persons tinkering with it, it needed an internal halyard."

The veterans' \$8,000 spun aluminum shaft was shipped from Georgia in September. Park District staff cemented its foundation. Fitzgerald purchased two new flags, which will fly 24/7, illuminated at night by electronic apex lights.

Project Raise-the-Flag was completed in time for a Nov. 10 Presentation of Colors and the anthems, salutes, prayers and speeches, and chocolate cake that followed.

"Lots of people helped make this happen," Fitzgerald told the gathering. "As a proud veteran, I found this project rewarding. I hope the Carmichael community and its veterans can also be proud."



California motorists buy and consume a billion gallons of gasoline each month and are very sensitive about pump prices, which are markedly higher than those in other states. Naturally, they are a political football.

Gov. Gavin Newsom has repeatedly characterized refiners as price gougers, even though most of the differences are caused by taxes, fees and regulatory mandates. Recently, he persuaded the Legislature to pass a watered-down version of his proposal requiring refiners to maintain higher reserves to avoid price spikes.

However the gasoline situation is far more complicated than Newsom's approach, and California may be facing a period of volatility on both supply and price as it attempts to wean itself from combustion-powered transportation, its largest single source of greenhouse gas emissions.

The California Air Resources Board is on the verge of expanding its program of reducing the amount of carbon in the current gasoline recipe, regarded as an interim step before completely converting vehicles to electricity or some other non-polluting power.

Last year, CARB published an analysis of the proposed Low Carbon Fuel Standard to provide "the economic incentives to produce cleaner fuels like electricity, hydrogen and biofuels that are needed to displace fossil fuels and reduce transportation sector emissions."

California's Transition Off Carbon Fuels

The report estimated that adoption could immediately increase gas prices by 47 cents a gallon and then, "on average, from 2031 through 2046 the proposed amendments are projected to potentially increase the price of gasoline by \$1.15 per gallon, the price of diesel by \$1.50 per gallon and fossil jet fuel by \$1.21 per gallon."

The cost estimate generated a storm of media and political attention and CARB backed off, continuing the adoption process but refusing to put a number on the potential pump price. Last week, the board's top official conducted an electronic press conference in which he stressed positive impacts, but continued to sidestep questions about consumer impacts.

"It's a win-win," executive officer Steven Cliff insisted. "We get public health benefits, we reduce health costs, we see lower costs of driving and we help turbocharge those investments in clean energy infrastructure that helps drive our zero emissions future."

CARB now intends to act on the policy three days after Election Day, without offering any estimate of consumer costs — a potential signal that those costs will be hefty.

While Newsom wants to be remembered as someone who tried to reduce gasoline prices, his governorship probably will be one that substantially increased them.

enough gasoline, even a variety with less carbon, over the next two decades as it transitions away from carbon fuels altogether.

California once had dozens of refineries producing the state's unique fuel blend, but in recent years just nine. After the Legislature gave Newsom the new laws on gasoline reserves, one refiner, Phillips 66, announced that it would shutter its plant in Southern California that's no longer profitable. The company said the closure had nothing to do with politics.

Very quickly, Valero, which has two refineries in the state, hinted that it may follow suit. CEO Lane Riggs said during a conference call that "all options are on the table" for the company's two California refineries, one in Benicia and the other in Wilmington, because of increasing state regulation of operations.

"Clearly the California regulatory environment is putting pressure on operators out there and how they might think about going forward with their operations," Riggs said.

Transitioning transportation to non-carbon power - while maintaining sufficient and reasonably priced supplies for gas-powered cars until they're replaced was destined to be a fraught process.

If poorly managed, it could be a monumental disaster.

County Addresses Unlawful Camping



Dave Ramsey Says When You Hit Rock Bottom

Sacramento County News Release

SACRAMENTO COUNTY, CA (MPG) - On Nov. 5, The Board of Supervisors took a step towards addressing safety with the adoption of an ordinance amendment curbing unlawful camping on public property.

The amendment of Chapter 9.120 to Title 9 of the Sacramento County Code related to camping included vehicles, trailers, campers and recreational vehicles that, among other issues, undermine the cleanliness and usability of parks, water supplies, and other public resources.

It also prohibits camping within 1,000 feet of a shelter providing services to people experiencing homelessness.

While the ordinance amendment includes more specifics about unlawful camping, the code also addresses the County's duty to protect lives and infrastructure and advances the County's efforts to increase the supply of emergency shelters through the code enforcement (Chapter 9.120.10).

District 3 Supervisor Rich Desmond and District 5 Supervisor Pat Hume requested the amendment to address public safety.

"My priority is to ensure the safety and well-being of our neighborhoods and businesses," said District 3 Supervisor Rich Desmond. "This amendment to prohibit unlawful camping on public property is not about punishing those experiencing homelessness; rather, it's about creating a supportive environment for all community members. We must strike a balance that allows us to address the challenges of homelessness while maintaining the safety

and viability of our public spaces."

"With this ordinance amendment, our goal is to keep the public spaces within our iurisdiction safe, clean, and accessible for everyone," said District 5 Supervisor Pat Hume. "It's essential that our trails, medians, county highways, and public buildings are well-maintained for the health and enjoyment of all residents and visitors. By tackling these challenges, we can foster a safer community for everyone."

Sacramento County spends more than \$220 million annually on programs, services and solutions to homelessness.

The Board of Supervisors recently approved the construction bid for the Watt Avenue Service Center and Safe Stav Center, which will host 225 beds in Safe Stay cabins, 50 people in Safe Parking, 75 people for emergency/weather respite beds as well as Behavioral Health services with case management, storage, job training and more.

The board also approved funding for Joshua House, a facility that provides end-of-life comfort care for people experiencing homelessness and terminal illnesses.

The county is also moving forward with an affordable housing project to shelter and house people exiting homelessness directly off the American River Parkway.

California's Climate Rules Leave Working Class Behind

The next time Governor Newsom puts on his detective hat and tries to get to the bottom of the "price gouging" that is supposedly driving absurdly high gas prices in California, he should start with the most obvious culprit in the state: himself.

Earlier this month, Newsom's California Air Resources Board (CARB) voted to approve changes to the state's Low Carbon Fuel Standard (LCFS), potentially adding \$.65 cents a gallon to the already punitive cost of gasoline. Although consumers may be recoiling at the thought of even higher prices, political leaders must be relishing the opportunity to make it more difficult to own and operate an internal combustion vehicle.

It's obvious that California Democrats and their national counterparts are pushing the state and nation into a rapid Electric Vehicle (EV) future that is having dreadful consequences for families and workers.

Of course, this leftist project is under the guise of "doing something" about climate change, regardless of practicality or without any cost-benefit analysis.

Newsom, for example, issued an executive order mandating that by 2035, all vehicles sold in California are zero-emission, a standard met only by plug-in electric vehicles. Although nobody, including the governor, can say with any precision how an all-electric vehicle fleet would change global climate, if at all, it's easy to see how current EV policies are harming consumers today.

EV subsidies are forcing lowerand working-class fuel consumers to pay for wealthy folks' expensive electric vehicles. "Greening" the electricity supply in California has been a major driver of skyrocketing electricity rates. After all, what good would it be to run electric vehicles on coal power? This has pushed up rates nearly 4-times faster than the national average over the past decade. Pacific Gas & Electric's residential electricity rates are double the national average.

As reported in The Wall Street Journal, "California households owed \$2.1 billion in unpaid utility bills at the end of 2023, more than four times the amount in 2019." While climate effects may be tough to predict, policy makers should have seen this outcome from a mile away.

That's not even counting economic pain caused by the never-ending attacks on the petroleum industry here, which cost jobs and add around \$1.50 in government costs to a gallon of gas, before the LCFS bump earlier this month. Soon, Californians could be paying more in taxes and fees for every gallon of gas than some states pay for an entire gallon.

Elitist Progressives put unpredictable and microscopic changes in potential future weather ahead of blue-collar jobs and affordability today. It's no wonder that the Republican party is making huge inroads among working class voters.

These policy-induced high energy costs are one of the reasons why, when adjusted for cost of living, California has the highest poverty rate in the nation.

Between California's highest-in-the-nation gas taxes and stealthy taxes such as the LCFS, California is banking profits from oil that would make John D. Rockefeller blush. Poorer Californians, who already spend more of their incomes on basics such as transportation, are paying the price.

California is also about to ban Diesel RV sales in the state in a few weeks, choking off another practical, affordable living and travel option for our citizens. It never ends. Just for once, I'd love to see a more balanced approach from our politicians that acknowledges California environmental policy is creating the nation's worst poverty. If that is a price the dominant political class is willing to inflict on our citizens, so be it. It would be nice to at least hear it.

But I stand with the working-class families who are struggling to get by and the many companies who are trying to survive in this hostile state. I support American sovereignty and American jobs. The government gas price gouging and reckless push towards electric vehicles must stop.

New Republic FC Stadium Back on Track

SACRAMENTO, CA (MPG) - A project that was on life support had some much-needed life injected into it on Tuesday, Nov. 12, when the Sacramento City Council voted unanimously to approve the framework for a \$321 million downtown railyards soccer stadium and entertainment venue. A long-awaited development needed to provide a permanent home for the Sacramento Republic Football Club (FC).

According to the information provided by council staff in support of the proposal, the projects being approved include a soccer stadium with supporting infrastructure occupying approximately 31 acres, as well as a new 3600-seat live entertainment venue that would occupy existing historic buildings in the railyard.

The agreement, albeit non-binding, does include information regarding project costs, economic impact and anticipated public and private funding sources. The estimated \$321 million price tag breaks down to, \$175 million for the new stadium, \$56 million for the new live entertainment venue and \$90 million for associated

infrastructure. The projects altogether are expected to generate more than 1,500 jobs for the Sacramento region. The agreement includes a provision by which the city would waive reimbursement for municipal services for off-site police, fire, emergency medical services, traffic control and code enforcement for stadium events for up to a maximum of \$300,000 per year for a ten-year period. The official press release from the city indicates the new stadium will be supported and privately financed by the Wilton Rancheria Tribe which became majority owners of Sacramento Republic FC on Nov. 7. The press release includes a quote from Mayor Darrel Steinberg on the importance of the council's vote.

"We are breaking barriers and making history here in Sacramento," said Mayor Steinberg. "Wilton Rancheria is the first tribe to own a professional men's sports team in North America, and the projects in The Railyards will double the size of the central business district what an incredible opportunity! This is the foundation for something beautiful today that will become even more beautiful in the years and decades to come."

In a Nov. 7 press conference, in advance of the Nov. 12 council vote, city officials joined together with representatives of Sacramento Republic FC, Downtown Railyards Venture LLC and Wilton rancheria Tribe members to celebrate the new energy being pumped into the soccer stadium/railyard development. At the press conference, Wilton Rancheria Chairman Jesus Tarango commented on the importance of the project.

"I am deeply proud to witness this moment, which stands as a profound testament to the resilience and determination of the people of Wilton Rancheria," said Chairman Tarango. "In just over a decade, our Tribe has transformed from landless to becoming a significant economic force in the region. The opportunity to drive a project of such scale and importance, on land where our ancestors once walked, is deeply meaningful. This is not only a chance to honor our history and uplift our community, but also to envision a future where we are not only part of Sacramento's past, but an integral part of its future as well."

According to the city, the stadium project is scheduled for completion by late 2026, and the entertainment venue by 2027. \star

Facing teams from across the nation, the Hornet tandem opened their run with a straight-set victory over Emilia Valentinsson and Sara Zalukar from Miami University, 7-5, 6-3, then outlasted Bryant's team of Caitlyn Munson and Natalia Vela in three sets, 5-7, 6-4, 10-4.

Ferreros and Riva continued to roll on day two, easing past the Naval Academy's Emily Tannenbaum and Parvathi Shanker, 6-2, 6-0, before suffering their first loss of the tournament in the semifinals to Appalachian State's Savannah Dada-Mascoll and Isabella Romanichen, 6-3, 6-1.

With the top three doubles teams earning a spot in the NCAA Tournament, Ferreros and Riva faced off against Celia-Belle Mohr and Sophia Webster from Vanderbilt for third place, winning the first set in a tiebreaker, 7-6 (5), before falling by the scores of 6-0 and 10-5 to finish fourth.

In singles, sophomore Lou Baudoin fell in her main draw opening round match to Charleston Southern's Marina Skegro, 2-6, 6-4, 6-2, but rebounded in the consolation draw defeating Illinois-Chicago's Mayu Ushio, 4-6, 6-1, 6-2, and advancing to the semifinals with a walkover against South Carolina State's Sofiya Chursina.

In the semis, Baudouin was finally subdued, falling to South Dakota's Beata Havlickova, 6-0, 6-4.

The Hornets have wrapped up the fall portion of the team's schedule and will open the spring championship season on Jan. 26 at home against the University of the Pacific. \star

Following the match, Sonko became the third Sacramento State women's soccer player to be named the Big Sky Tournament's MVP, joining Katie McCoy (2007) and Elece McBride (2010). She was one of six named to the all-tournament team along with teammates Teysha-Ray Spinney-Kuahuia, Ellie Farber, Sydney Sharts, Dalen Lau, and Izzy Palmatier, matching the most selections in school history along with the 2007

and 2010 squads.

Social Security Matters Older Veteran Asks about Special Social Security Credit for Military Service

Dear Rusty: I served in the U S Army from January 1958 to Feb 1961. What increase should I receive for those years and who do I call and at what phone number? Signed: Proud Veteran.

Dear Proud Veteran: First, thank you for your military service! I expect you are referring to the "special extra credits for military service" which are available to some who served in in the US Military in earlier years. It is important to note that these "extra credits" take the form of an adjustment to your military pay record while serving and are not an incremental amount added to your monthly Social Security benefit because you served.

Military pay has been subject to deductions for Social Security since 1957. Thus, while serving between 1958 and 1961 you paid SS tax on your military earnings. But, for purposes of determining your Social Security benefit, your military earnings record would be increased by \$300 for each quarter you served on active duty,

up to a maximum of \$1,200 increase per year of service. That means for 1958 - 1960, when calculating your SS benefit, \$1,200 would be added to your military earnings record for each year you served. FYI, for those who served after 1967, this adjustment was automatically made by Social Security. But for service years prior to 1967 (as in your case) you would need to inform Social Security of your service when you claimed SS and provide a copy of your military form DD-214 (your discharge papers). SS would then make the appropriate adjustment to your military earnings record prior to calculating your benefit amount. And, for clarity, additional credits for military service are not available to those who

served after 2001. A key point to understand is that this adjustment to your military pay may - or may not - affect the amount of your Social Security benefit. Social Security determines your benefit amount based on your highest earning 35 years over your entire lifetime (adjusted for inflation). If, after you served in the military, you had at least 35 years of civilian employment where you earned more than your military pay, it is probable that your military pay is not included when calculating your Social Security benefit. If that is the case, it is likely that the "special extra

credits for military service" would have no effect on your Social Security payment. If, however, your military pay (including those special extra credits) for any year is more than you earned in civilian life, then you can contact Social Security (1.800.772.1213), provide them with a copy of your DD-214, and ask that they recalculate your Social Security benefit to include the extra credits for your years of military service.

The Sacramento Kings were 2-2 in the past week, but that doesn't begin to tell the tale.

Beginning with a disappointing 116-96 loss to the San Antonio Spurs and concluding with a thrilling 121-117 win over the Utah Jazz, the Sac Town ballers had an up and down week that ended on a high note.

Sadly, injuries played a role, sidelining big man Domantas Sabonis and newcomer all-star DeMar DeRozan, both with lower back issues.

In between the Spurs and the Jazz, saw the Kings take a tough overtime loss to a talented Minnesota Timberwolves team, and win decisively over the Phoenix Suns by the score of 127-104.

The real story of the week was none other than the offensive show put on by point guard DeAaron Fox, who scored a total of 109 points in back-to-back games against the Timberwolves and the Utah Jazz.

Setting a Sacramento Kings scoring record, DeAaron put the team on his back against the Timberwolves, scoring 60 points and shattering his previous personal record. Just one game later, with Malik Monk, DeMar DeRozan, and Domantas Sabonis sidelined with injuries, Fox backed up his 60-point performance with 49 more, this time in a win over the Jazz.

Thanks to the offensive explosion of DeAaron Fox, the Kings now have a player in the top ten in scoring. DeAaron is currently #6 in the NBA in scoring, and remarkably the Kings are the only team in the NBA to feature three players with a scoring average of 20 points or higher per game.

In addition to raising his scoring average, DeAaron is fifth in the league in steals, averaging 1.8 per game. I look for Fox to challenge the top spot in steals as the season wears on.

Overall, the Kings are off to an 8-6 start, and most pundits and fans alike are well aware that their record could be decidedly better.

Nursing a sore back, Sabonis is on the sidelines, and with nothing definite coming from the Kings organization, Domantas is day to day.

So, what kind of a report card should the Kings receive as they play in their 15th game against the Atlanta Hawks on Monday night.

I give the team a solid B, considering the addition of DeMar DeRozan and understanding it takes time for a starting five to iell.

Let's not forget the energy and scoring punch that Malik Monk brings to this team, and the sooner we see Malik back in action, the better off the Kings will be. Reportedly, Malik has a week to go before he'll be ready for any hardwood action.

Sadly, after witnessing what I consider to be one of the worst officiating seasons in the past 50 years last season, the zebras were back to their old ways Saturday night and were it not for Kings ability to challenge two horrific calls by the referees, the Kings would have likely lost to the Utah Jazz.

I have no answer for what the NBA needs to do, but clearly the officiating is sadly lacking in quality, and this has not always been the case.

I credit the NBA with putting challenges into the mix, but there is still more that needs to be done.

Meanwhile, keep the faith Kings fans. This team is showing a lot of bright spots, so let's get everyone healthy and see if the Sac Town boys can get on a winning streak!





Heavily influenced by Bay Area mandolin great Marla Fibish, he developed nuances traditional Irish tunes on mandolin — picking patterns for the different dance tunes, tone projection, and styling, which continues in his playing today. Tyler represented the next generation of mandolin players at his performance at 2023 San Francisco Festival of Mandolins. He has since journeved into the world of tenor banjo. His banjo style can be characterized by ornate, percussive triplet stylings with a driving, yet hypnotic groove.
