### City **Seeks** Input on New Parking Strategy

### City of Sacramento News Release

SACRAMENTO, CA (MPG) -The City of Sacramento is inviting residents to weigh in on a proposed Parking Strategy, aimed at advancing housing and climate goals by updating parking requirements and optimizing parking management.

The strategy makes recommendations to improve public parking management, expand parking maximums and increase bicycle parking to support active transportation.

The city currently has regulations in place that cap the allowed parking for most new developments in the central city, and for offices, warehousing, and manufacturing throughout the balance of the city.

"The strategy recommends expanding parking maximums to the full central city, and to all developments within a half mile walking distance of existing high-frequency transit stops," said Senior Planner Vic Randall. "This sets a cap on new parking spaces for developments in these areas, rather than reducing existing parking." High-frequency transit stops include SacRT's light rail stations and bus routes 1 (Greenback) and 51 (Stockton Blvd./ Broadway). The strategy also creates a Parking Management Toolkit that offers the City's Parking Services Division strategies to manage parking effectively and efficiently in Sacramento. Additionally, the strategy recommends updating design guidelines to accommodate larger or newer styles of bikes including e-bikes, cargo bicycles or accessible bicycles to provide adequate, secure and weatherproof parking.



SACRAMENTO, CA (MPG) - Over the years, the area around Broadway and 15th Street has had its ups and downs. Past revitalization efforts had some hiccups, and then the pandemic hit. Crime was on the rise, and shops were closing. Other businesses hung on as they suffered an uptick in theft and break-ins. Neighbors began to shy away, which put the area on life

#### support.

But a vibrant upswing is on the horizon. Newly funded projects, robust public safety efforts and the passing of Proposition 36 could be the trifecta Broadway has been waiting for.

Joan Borucki, Executive Director for The Tower District, has been proactive in new efforts to improve conditions in the area. That's good news for the surrounding

communities, like the Land Park neighborhood!

One improvement project is a creative crosswalk inspired by the Asphalt Art initiative. It will be an artistic pedestrian walkway on the four-way intersection at Broadway and Land Park Drive. Asphalt Art is part of a national effort to mitigate traffic and bring a community feel to public pathways. Other cities have Continued on Page 9

# **CHP Swearing-In Rite Marks Milestone**

SACRAMENTO, CA (MPG) -The California Highway Patrol (CHP) proudly announces a major achievement in its ongoing recruitment efforts as it officially swears in 121 new officers, bringing the Department past its goal of hiring over 1,000 officers. This milestone underscores the CHP's commitment to enhancing public safety and strengthening its presence within communities across the state.

The swearing-in ceremony at the CHP Academy in West Sacramento on Nov. 15 marks the culmination of months of rigorous training for these new officers. Each will report for duty to one of the CHP's 102 Area offices throughout the state. This is the largest graduating class since June 2022,

when 128 officers were sworn in.

"Two years ago, we set an ambitious goal of recruiting 1,000 new CHP officers – and today, with this class, we have officially surpassed that goal. But I want to be clear: that goal has always been about more than just filling slots or hitting a number. Each officer is the very manifestation of public service, of peacekeeping. Every cadet graduating today felt a calling to do right by their community and to make the world safer. On behalf of the state and all who call California home, I want to thank each and every member of this graduating class," said Gov. Gavin Newsom.

"Today marks a significant step forward for our agency and all of our communities," said CHP Commissioner Sean Duryee. "By surpassing our recruitment goal, we're adding highly-trained, committed officers who are ready to make a positive impact and meet the evolving needs of California. We're grateful for the dedication and passion these officers bring to their new roles."

The CHP started its successful multi-year recruitment campaign in June 2022.

With over 21,000 applications submitted in the first ten months of 2024, the CHP has already surpassed last year's application total of more than 16,300 over the same period, representing a 29% increase.

To accommodate this increase, the CHP conducts three concurrent cadet classes at its live-in training facility, where more than 250 cadets are currently in training. A new class of 160 cadets will arrive Dec. 1 at the CHP Academy.

Training at the CHP Academy is comprehensive, beginning with a foundation of nobility in policing, leadership, ethics, and cultural diversity. Cadets also receive specialized instruction in responding to mental health crises, vehicle patrol, crash investigation, first aid, and impaired driver evaluation. Additional training covers traffic control, report writing, stolen vehicle recovery, assisting motorists, emergency scene management, and mastery of the California Vehicle, Penal, and Health and Safety Codes.

The CHP is continuing its recruitment efforts. Join us in shaping the future of public safety in California.

### CHP Receives Grant to Combat Distracted Driving

The CHP remains committed to ensuring the safety of California's drivers and will continue its efforts to reduce the risks posed by distracted driving.



### MLB's Athletics Announce 2025 Regular Season Home Game Times

**SACRAMENTO REGION, CA (MPG)** - First pitch of the A's inaugural game at Sutter Health Park in West Sacramento will take place at 7:05 p.m. on Monday, March 31, as the Athletics take on the Chicago Cubs.

Across the 81-game home slate, the A's will play 60 night games, including 25 of their 28 games in June and July. Eleven of the A's 21 total day games will be played in April and May, with only six Sunday day games scheduled from June through August. Night games begin at 7:05 p.m.

The home schedule features matchups against eight National League clubs, including the San Diego Padres (April 7-9), New York Mets (April 11-13), Philadelphia Phillies (May 23-25), San Francisco Giants (July 4-6), Atlanta Braves (July 8-10), Arizona Diamondbacks (Aug. 1-3), and Cincinnati Reds (Sept. 12-14).

The A's will play at home for three

popular summer holidays, taking on the New York Yankees on Mother's Day (May 11), the Phillies over Memorial Day Weekend (May 23-25), and the Giants on Independence Day (July 4).

The A's will share Sutter Health Park with the Sacramento River Cats. MLB and MiLB have coordinated home schedules to accommodate both teams, ensuring that there are no instances in which both teams play at home on the same day.

The 60 home night games would tie the 1968 A's for the most in a season in franchise history.

A's season tickets for 2025 are on sale now and will be released in phases.

Current A's season ticket holders will be notified when seats comparable to their 2024 plan are available to purchase.

Fans who have placed a season ticket deposit will be notified based on priority when tickets are available for purchase. Single-game tickets will go on sale in early 2025. ★

# Kings Korner By V.G. Harris

The Sacramento Kings were 2-2 in the past week, but that doesn't begin to tell the tale.

Beginning with a disappointing 116-96 loss to the San Antonio Spurs and concluding with a thrilling 121-117 win over the Utah Jazz, the Sac Town ballers had an up and down week that ended on a high note.

Sadly, injuries played a role, sidelining big man Domantas Sabonis and newcomer all-star DeMar DeRozan, both with lower back issues.

In between the Spurs and the Jazz, saw the Kings take a tough overtime loss to a talented Minnesota Timberwolves team, and win decisively over the Phoenix Suns by the score of 127-104.

The real story of the week was none other than the offensive show put on by point guard DeAaron Fox, who scored a total of 109 points in back-to-back games against the Timberwolves and the Utah Jazz.

Setting a Sacramento Kings scoring record, DeAaron put the team on his back against the Timberwolves, scoring 60 points and shattering his previous personal record. Just one game later, with Malik Monk, DeMar DeRozan, and Domantas Sabonis sidelined with injuries, Fox backed up his 60-point performance with 49 more, this time in a win over the Jazz.


Thanks to the offensive explosion of DeAaron Fox, the Kings now have a player in the top ten in scoring. DeAaron is currently #6 in the NBA in scoring, and remarkably the Kings are the only team in the NBA to feature three players with a scoring average of 20 points or higher per game.

In addition to raising his scoring average, DeAaron is fifth in the league in steals, averaging 1.8 per game. I look for Fox to challenge the top spot in steals as the season wears on.

Overall, the Kings are off to an 8-6 start, and most pundits and fans alike are well aware that their record could be decidedly better.

It took a few games for DeRozan to become completely comfortable with his teammates, and that should be taken for granted.

Since the first few games, DeMar has been the perfect fit, and teams are having

Domantas continues to rebound with ferocity, and the rebounding champion of the past two seasons, is currently #2 in the NBA behind big man Nikola Jokic.

Nursing a sore back, Sabonis is on the sidelines, and with nothing definite coming from the Kings organization, Domantas is day to day.

So, what kind of a report card should the Kings receive as they play in their 15th game against the Atlanta Hawks on Monday night.

I give the team a solid B, considering the addition of DeMar DeRozan and understanding it takes time for a starting five to jell.

Let's not forget the energy and scoring punch that Malik Monk brings to this team, and the sooner we see Malik back in action, the better off the Kings will be. Reportedly, Malik has a week to go before he'll be ready for any hardwood action.

Sadly, after witnessing what I consider to be one of the worst officiating seasons in the past 50 years last season, the zebras were back to their old ways Saturday night and were it not for Kings ability to challenge two horrific calls by the referees, the Kings would have likely lost to the Utah Jazz.


I have no answer for what the NBA needs to do, but clearly the officiating is sadly lacking in quality, and this has not always been the case.

medical assisting and more. Women's Empowerment also offers its Trellis Gardens transitional workforce housing program for graduates who have secured employment, but still cannot afford market-rate housing for their families. At Trellis Gardens, they can live in cottages for 12 to 18 months as they work to increase income, savings and credit

scores and prepare to move into permanent housing.

# New Republic FC Stadium Back on Track

**SACRAMENTO, CA (MPG)** - A project that was on life support had some much-needed life injected into it on Tuesday, Nov. 12, when the Sacramento City Council voted unanimously to approve the framework for a \$321 million downtown railyards soccer stadium and entertainment venue. A long-awaited development needed to provide a permanent home for the Sacramento Republic Football Club (FC).

According to the information provided by council staff in support of the proposal, the projects being approved include a soccer stadium with supporting infrastructure occupying approximately 31 acres, as well as a new 3600-seat live entertainment venue that would occupy existing historic buildings in the railyard.

The agreement, albeit non-binding, does include information regarding project costs, economic impact and anticipated public and private funding sources. The estimated \$321 million price tag breaks down to, \$175 million for the new stadium, \$56 million for the new live entertainment venue and \$90 million for associated

infrastructure. The projects altogether are expected to generate more than 1,500 jobs for the Sacramento region. The agreement includes a provision by which the city would waive reimbursement for municipal services for off-site police, fire, emergency medical services, traffic control and code enforcement for stadium events for up to a maximum of \$300,000 per year for a ten-year period. The official press release from the city indicates the new stadium will be supported and privately financed by the Wilton Rancheria Tribe which became majority owners of Sacramento Republic FC on Nov. 7. The press release includes a quote from Mayor Darrel Steinberg on the importance of the council's vote.

"We are breaking barriers and making history here in Sacramento," said Mayor Steinberg. "Wilton Rancheria is the first tribe to own a professional men's sports team in North America, and the projects in The Railyards will double the size of the central business district what an incredible opportunity! This is the foundation for something beautiful today that will become even more beautiful in the years and decades to come."

In a Nov. 7 press conference, in advance of the Nov. 12 council vote, city officials joined together with representatives of Sacramento Republic FC, Downtown Railyards Venture LLC and Wilton rancheria Tribe members to celebrate the new energy being pumped into the soccer stadium/railyard development. At the press conference, Wilton Rancheria Chairman Jesus Tarango commented on the importance of the project.

"I am deeply proud to witness this moment, which stands as a profound testament to the resilience and determination of the people of Wilton Rancheria," said Chairman Tarango. "In just over a decade, our Tribe has transformed from landless to becoming a significant economic force in the region. The opportunity to drive a project of such scale and importance, on land where our ancestors once walked, is deeply meaningful. This is not only a chance to honor our history and uplift our community, but also to envision a future where we are not only part of Sacramento's past, but an integral part of its future as well."

According to the city, the stadium project is scheduled for completion by late 2026, and the entertainment venue by 2027.  $\star$

**SACRAMENTO, CA (MPG)** - The Sacramento State doubles duo of Maddy Ferreros and Irene Riva showed well at last weekend's ITA Conference Masters event in Rome, Ga., reaching the main draw semifinals and falling just one win shy of a berth into the 2024 NCAA Individual Championships.

Facing teams from across the nation, the Hornet tandem opened their run with a straight-set victory over Emilia Valentinsson and Sara Zalukar from Miami University, 7-5, 6-3, then outlasted Bryant's team of Caitlyn Munson and Natalia Vela in three sets, 5-7, 6-4, 10-4.

Ferreros and Riva continued to roll on day two, easing past the Naval Academy's Emily Tannenbaum and Parvathi Shanker, 6-2, 6-0, before suffering their first loss of the tournament in the semifinals to Appalachian State's Savannah Dada-Mascoll and Isabella

Romanichen, 6-3, 6-1.

With the top three doubles teams earning a spot in the NCAA Tournament, Ferreros and Riva faced off against Celia-Belle Mohr and Sophia Webster from Vanderbilt for third place, winning the first set in a tiebreaker, 7-6 (5), before falling by the scores of 6-0 and 10-5 to finish fourth.

In singles, sophomore Lou Baudoin fell in her main draw opening round match to Charleston Southern's Marina Skegro, 2-6, 6-4, 6-2, but rebounded in the consolation draw defeating Illinois-Chicago's Mayu Ushio, 4-6, 6-1, 6-2, and advancing to the semifinals with a walkover against South Carolina State's Sofiya Chursina.

In the semis, Baudouin was finally subdued, falling to South Dakota's Beata Havlickova, 6-0, 6-4.

The Hornets have wrapped up the fall portion of the team's schedule and will open the spring championship season on Jan. 26 at home against the University of the Pacific.  $\star$ 

Having appeared in one match and playing in only five minutes during the regular season, Sonko answered when called upon for No. 5-seeded Sacramento State, stopping a pair of penalties following a 2-2 draw against No. 4-seeded Northern Arizona and repeating the feat against regular season champion, host, and topseeded Montana after the Hornets and the Grizzlies played to a scoreless draw.

Two days later, it took eight rounds of penalties to finally decide a winner, but Sonko stopped defending tournament champion Idaho on its fourth attempt as the Hornets drew even and then denied the Vandals on what turned out to be their final attempt of the day to secure the victory.

Following the match, Sonko became the third Sacramento State women's soccer player to be named the Big Sky Tournament's MVP, joining Katie McCoy (2007) and Elece McBride (2010). She was one of six named to the all-tournament team along with teammates Teysha-Ray Spinney-Kuahuia, Ellie Farber, Sydney Sharts, Dalen Lau, and Izzy Palmatier, matching the most selections in school history along with the 2007 Hornet's redshirt freshman goalkeeper Sierra Sonko earned National Player of the Week honors from Top Drawer Soccer on Tuesday, Nov. 12. Riding a nine-match (3-0-6) unbeaten streak dating back to their last loss on Sept. 29, the Hornets open the 2024 NCAA Tournament against top-seeded and host USC on Sunday, Nov. 17 at 2 p.m. at Dignity Health Sports Park Track Stadium in Carson, Calif.



They found a 50 percent decrease in the rate of is to install around twenty more creative crosswalks up and down Broadway, which means there are plenty of opportunities for philanthropic work. Those who sponsor a crosswalk could get their name or company added to the artwork. The four-way why don't we embrace that?" And that's the idea: to bring a mix of local cultures and flavors, highlighting Broadway's unique personality.

Those who participate in these events benefit, too. Borucki stated, "We had an all-woman art event in the parking lot last year. Several female artists came to show their work. Since then, many of them have been commissioned by local businesses to do other pieces." Under the W/X freeway a concept project called 3rd Space is on the table. The spot would be outfitted with pop-up vendors, art, food trucks and music. It would also have lounging spots for people to enjoy checkerboard games and other activities. "3rd Space is an effort to reconnect communities divided by freeways," Borucki explained. For instance, connecting

Southside Park to the Tower District provides a fun, walkable amenity for nearby residents.

It is clear people want to feel safe, and public safety upgrades are also on The Tower District's radar. Their new 24/7 security provider, Elite 1, is collaborating with Sacramento PD and the Sacramento County District Attorney's office to handle criminal behavior. In addition, cutting-edge technology is being installed to identify crime early. Joan Borucki shared the changes are already noticeable, "Walgreens had chronic crime issues, and within one week, there were several arrests. We also have a regular offenders list." This means they have an eye on consistently troublesome people. In addition, the Tower District continues to manage graffiti removal, power washing and illegal

pedestrian crashes and a 25 percent decrease in pedestrian conflicts with drivers.

Speeding and pedestrian accidents have been serious issues in the Broadway area. An art installation that does double duty is appealing. Borucki explained, "A project like this provides both beautification and safety. The U.S. Department of Transportation encourages these crosswalks." She continued, "It also fits in with the big branding of the district-which is creativity."

The crosswalk is expected to be completed by spring 2025. The vision crosswalk alone will cost from \$10,000 to \$15,000, and Borucki is ready to speak to anyone who is interested in sponsoring.

The Tower District is also ramping up fun, local events. On Oct. 13, the district partnered with the lowrider community to bring "Extra Butter" to the Tower parking lot. A disc jockey set the vibe while folks walked through the vendor booths and enjoyed colorful lowrider cars. Across the street, the new School of Rock hosted activities.

Borucki says, "Cruising was such a big part of Broadway's history,

dumping. The new efforts could impact these issues as well.

Finally, the district recently signed a lease for an office space in the old comic building between the Tower Café and Joe Marty's. The office should open by early spring 2025.

The Tower District board wants local business owners and the community to have a welcoming place to drop by and see what they are up to. And they plan to host regular informative public meetings.

All these efforts are being funded through the city, grants and generous donors.

Joan Borucki and the district board envision a colorful, engaging business ecosystem emerging in 2025.



### Fentanyl-Related Deaths on the Decline, County Reports

#### Sacramento County News Release

#### SACRAMENTO COUNTY, CA

(MPG) - Sacramento County has made remarkable progress in the battle against the opioid crisis, reporting a 56% reduction in fentanyl-related deaths between 2023 and 2024. According to the latest data, the County Coroner's Office reported 180 fentanyl-related deaths so far this year, down from 406 in 2023.

"This reduction isn't necessarily due to fewer people using fentanyl, but rather a direct result of the comprehensive support systems we've implemented," said Lori Miller, Behavioral Health Division manager for the Sacramento County Department of Health Services. "The coordinated efforts of local law enforcement, first responders, healthcare providers and community organizations are saving lives."

Sacramento County's approach includes an extensive network of partnerships and initiatives designed to combat the opioid crisis.

Law enforcement agencies, including Sacramento County's Sheriff's Office and Probation Department and the Sacramento City Police Department, have worked tirelessly to conduct enforcement actions, make arrests and seize fentanyl supplies. The partnership with the Sacramento Fire Department and Sacramento Metro Fire's Mobile Medicine Teams have been instrumental in administering Narcan and providing medication-assisted treatment.

In addition, the Sacramento County Department of Child, Family and Adult Services, along with Sacramento County Public Health, has been critical in raising awareness about the dangers of fentanyl through education and distributing Narcan and fentanyl test strips.

The County's Adult Correctional Health Services has also played a role by expanded access to medication-assisted treatment in jails, while community-based organizations continue to provide prevention education, treatment options and harm reduction resources.

"By working together, we've built a robust system of care and support that is not only addressing substance use but also providing people with the tools they need to survive and recover," Miller added.

Maintaining this positive trend requires a continued commitment to education, awareness and accessible resources. Narcan distribution, fentanyl test strips and public education are essential tools in reducing overdoses and keeping people informed. Sacramento County is dedicated to expanding access to these resources, providing community members with the support needed to prevent and respond to fentanyl-related incidents.

While this is an encouraging trend, County officials are cautious as the holiday season approaches -- a time of year that can be challenging for individuals struggling with mental health and substance use disorders.

County officials will continue their efforts and are hopeful that they will end the year with a decrease of 50% or more.


### Building Safer Streets for Sacramento

As your representative on the Sacramento City Council, I believe every Sacramentan deserves safe streets where they can walk, bike, and drive without fear. Yet, this year we've experienced the heartbreaking loss of 31 lives in traffic collisions. Each life lost is a reminder of the work we still need to do — and I'm committed to working with each of you to make change happen.

This week, my colleagues and I on the Law and Legislation Committee took a critical step forward by advancing a proposal to declare a state of emergency for pedestrian and cyclist safety. This declaration is more than a statement; it's a call to action to ensure safety becomes a top priority for our city.

Sacramento's Vision Zero pledge to eliminate traffic fatalities by 2027 is an ambitious goal, and while challenges remain, I believe we can get back on track.

Our focus must be on real solutions: investing in infrastructure that protects lives. To do so, we must identify a dedicated and reliable funding source that ensures consistent



progress year after year. As I said during the committee hearing, "If, in fact, we keep using the excuse of our budget deficit or not having the money, we've got to focus on finding the money and making sure that we focus on this priority - safety."

This issue hits close to home for me. During the hearing, I had the privilege of introducing Alena Wong, a remarkable young woman from District 7. At 12 years old, Alena was struck by a car while biking to school.

She fought through that tragedy and is now thriving at 17, preparing for college. Her resilience is inspiring, and I'm grateful we can share her story of hope and potential.

However, not every family has been as fortunate.

Too many lives, like that of Kaylee Xiong, a promising 18-year-old college student, have been cut short on our streets. These losses are a sobering reminder of why we must act with urgency and determination.

This emergency declaration gives us a chance to create lasting change. By prioritizing funding for road safety improvements, we can build streets where everyone — children biking to school, seniors crossing intersections, and families enjoying their neighborhoods — feels safe.

I'm optimistic about what we can achieve together. We have the opportunity to turn our Vision Zero pledge into reality and make Sacramento a city where every resident can thrive.

Let's work as a community to create safer streets and brighter futures for all.
