Plans Underway for 'Jeweled Palace' Coming to West Sacramento

WEST SACRAMENTO, CA (MPG) - A dazzling landmark is coming to West Sacramento.

At 1029 West Capitol Ave., a brilliant 10,000 square-foot temple is planned to be built in the heart of the City of Dharma Realm (CDR).

The City of Dharma Relam is a 14.1-acre Buddhist worship site in West Sacramento, home to Buddhist nuns, students and volunteers.

The land where the site resides has a rich history, having once been the site of the well-known El Rancho Hotel, a tennis resort popular in its time that hosted Frank Sinatra. Remnants of its past, such as the tennis courts and racket emblems on certain buildings, remain visible on the grounds, adding a unique historical layer to the site.

Although it could take one to two years to finalize approval and design plans, the temple's anticipated

grandeur is already turning heads.

Messenger Publishing Group recently toured the site and learned more about the City of Dharma Realm and its upcoming plans for construction. Tammy Wu, a representative of the City of Dharma Realm, and Brian Holloway, president of Holloway Land Company, gave the tour

California Approves Changing 'SQUAW' Term Locations

California Natural Resources Agency News Release

Editor's note: One of the 30-plus locations in 15 counties that previously contained the derogatory term "squaw" is West Sacramento.

SACRAMENTO, CA (MPG)

- In a monumental step toward addressing historic injustices and honoring California's Native American communities, the California Advisory Committee on Geographic Names (CACGN) has officially approved the renaming of more than 30 locations in 15 counties that previously contained the derogatory term "squaw" (hereafter referred to as the "sq_" term).

The Assembly Bill-2022 renaming effort, led by Assemblymembers James Ramos, signed by Governor Gavin Newsom and implemented by the California Natural Resources Agency, marks a significant milestone for Native American women.

From the city of West Sacramento, "The City of West Sacramento was honored to collaborate with the Yocha Dehe Wintun Nation and local residents to develop two new street names to replace the offensive "sq_" term as required by AB 2022. We're grateful for the beautiful name, 'Tebti,' recommended by the Tribal Council of the Yocha Dehe Wintun Nation, and we look forward to officially re-naming these streets in early 2025.'

The term "sq_" is recognized as a racial, ethnic and gender-based slur, particularly aimed at Native American women. Its removal is a crucial step in recognizing the ongoing trauma and oppression that Native communities have faced.

This action, praised by tribal, local, and state leaders, is seen as a significant step toward a more inclusive California:

YOLO COUNTY, CA (MPG) - Just in time for America Recycles Day, also known as National Recycling Day, on Nov. 15, the Yolo County Landfill announced that food and beverage cartons are now accepted in the recycling stream.

Residents serviced by WM in Woodland, West Sacramento, Winters and unincorporated Yolo County will be able to place cartons in their blue-lidded recycling bin, beginning Nov. 15.

Residential customers of Yolo County serviced by Recology in Davis, El Macero, North Davis Meadows and other rural pockets of Davis and Winters, will have access to drop-off cartons for

You might have noticed the press coverage last year for the Light the World images that filled the large screens of Times Square in New York City. Visitors to Times Square were in for a surprise when its famous billboards became a largerthan-life tribute to the true reason for Christmas: Jesus Christ.

Instead of the usual array of promotional brand logos and marketing graphics to entice viewers to purchase more products, the screens were filled with images of the baby Jesus, lying in a straw-lined manger, with a new star in the heavens luminating his face.

The billboard takeover at Times Square in New York City was part of Light the World initiative, an annual movement from The Church of Jesus Christ of Latter-day Saints to bring people from all over the world together to share the light of Jesus Christ during the Christmas season.

The beautiful nativity scene that emerged from the blackout was a tender reminder of the Savior's birth and why we need His light and love in our lives. The event was truly a Silent Night surprise as thousands of people stood

One of our holiday family favorites is to prepare gift bags for children living in the margins. Our family, including children and grandchildren, numbers 26, and each of us has an assignment to bring something to add to the gift bags.

We set up a couple of large tables near our Christmas tree and have an assembly line to fill the bags, tie with ribbons and deliver to one of the several organizations that support needy children. It is a joy watching our grandchildren delight in filling these gift bags for others.

Another part of Light the World is the Giving Machines, vending machines with a twist. The Giving Machines have become known livestock that charities distribute to families to help them feed themselves or start small businesses. In a single year, givers purchased 41,000 chickens,

25,000 ducks and 3,800 beehives. Chickens, goats, piglets and beehives provided through the Giving Machines have benefited 20,000 families in Kenya and Tanzania over three

internationally for offering

One year a family in Kenya received three chickens. Three years later, those three had grown to a flock of over 7,000 that provided food and income to support not only their family but the entire village. Giving Machines partner each year with both global charities and local nonprofits to allow people to donate items to people in need and have raised more than \$32 million

since 2017.

The Giving Machines will be back in Northern California this year. The big red vending machines will again be at the Westfield Galleria Mall in Roseville and at the Vintage Fair Mall in Modesto as two of the 106 global locations.

Continued from page 1 in bounty while further detail of the future temple

was given. According to Holloway, the new temple will be a striking, three-story octagonal structure designed in the traditional Pagoda style. It will have the capacity to fit up to 2,000 people, offering a space for worship, education and community activities, such as interfaith conferences.

The first floor of the temple will include the dining hall and kitchen, which will fit 911 people. On the second floor will be a Dharma Hall, complete with classrooms and a lecture hall.

On the third floor will be the Buddha Hall, which will feature five Asian-imported Buddha statues facing south. According to Wu, Buddha statues traditionally face south, being the "most proper orientation."

One of the most remarkable features of the design is a sky bridge that will serve as a path from the site's main entrance (or "mountain gate") to the third floor of the temple, offering visitors views of the surrounding area. According to Wu, platforms will be built along the bridge to offer breaks during the climb.

Some of the construction renderings refer to the temple as the "jeweled palace," which is the literal translation of the Chinese word for the structure, said Wu.

"This will be quite the monument for West Sacramento," Holloway said.

He added that residents will be able to see the roof of the temple from across the highway.

When might residents expect to see the temple's construction begin?

"It will be a couple years before the groundbreaking happens," Holloway said. "We're hoping to get approval from the city in early 2025. Then it will take a year to design all the construction, then it will take the city about six months to approve those plans."

According to Wu, the City of Dharma Realm was established in 1992 by the Venerable Master Hsuan Hua. On its

campus is a comprehensive training program for Buddhist nuns as well as classes for individuals to become Buddhist nuns. These nuns live on the campus, as well as a few international students.

Hua also established K-12 schools on the campus, which are called Instilling Goodness Elementary School and Developing Virtues Secondary School. The existing nunnery,

schools and dormitories will remain after the temple's construction.

As the tour continued, Wu gave insight into the nuns' daily lifestyle, which begins with waking up at 3:30 a.m. and eating one meal per day.

Wu also mentioned possible plans to open a

vegan restaurant on the

campus, as Buddhists are vegan, and the kitchen staff on campus "does a great job getting creative."

As the City of Dharma Realm continues to grow, this new temple promises to become a significant spiritual landmark, enriching the community for generations to come. The project represents not

just a physical space but also a deep commitment to promoting mindfulness, compassion and peace in the heart of West Sacramento, according to

"We welcome anyone who wants to come here," Wu said.

Continued from page 1 announce a new milestone in our efforts to reduce waste and promote sustainability in Yolo County," said Marissa Juhler, Yolo County director of Integrated Waste Division. "This initiative reflects our commitment to expanding recycling opportunities, protecting our environment, and supporting our economy. We encourage everyone to take advantage of this

new program and help us keep

Yolo County clean and green for

future generations."

This initiative comes in response to the growing demand for recycling services. Gabletop and aseptic cartons are made from a mix of paper, polyethylene and aluminum (aseptic cartons). These layers provide protection against light, air and harmful bacteria but do not prevent them from being recycled. The estimated quantity of gable top and aseptic cartons generated in California is roughly 70,000 tons each year, of which only 20% is recycled in the state, demonstrating an opportunity for additional recycling growth of

Recycled cartons (milk cartons, soup cartons, juice boxes, etc.) provide the raw materials for building products, as well as paper products such as tissue paper and paper towels. Cities throughout the state, such as Napa, San Diego, San Francisco and Oakland are already participating in carton recycling. Cartons do not belong in trash carts since they are recyclable and are not to be placed in the organics bins to prevent the plastic and aluminum layers from contaminating the finished compost product. Therefore, source separation is necessary to ensure that all three waste streams are utilized correctly.

"The Carton Council is committed to increasing carton recycling so these valuable materials can go on to have a second life," said Jason Pelz, vice-president of recycling for the Carton Council. "We're thrilled to see Yolo County join the growing number of communities adding cartons to their programs."

For many waste service companies, it can be especially

challenging and economically cost prohibitive to add a bunker and optical sorter to their materials recovery facility, and for this reason, there have been delays in implementing such programs. That is why WM and Recology have taken different approaches to carton recycling. The addition of carton materials to the recycling stream reflects WM's \$29 million investment in advanced recycling technology at the Sacramento Recycling and Transfer Station.

With 16 automated optical sorters, the upgraded facility captures and processes a greater percentage of recyclables. This improvement enables a cleaner, high-quality output that can be repurposed in meaningful ways, contributing to natural resource conservation, and reducing greenhouse gas emissions.

Continued from page 1 "The 'sq_' is a word that denigrates Native American women and dehumanizes them. I believe that dehumanization has contributed to the Murdered and Missing Indigenous People crisis that affects all of our people but that strikes women and girls in disproportionate numbers. AB 2022 received broad support around the state from tribes, tribal advocates, civil rights organizations, teachers and many more. Not one of my colleagues in the legislature voted against the bill because so many recognize this word is not a placename that belongs in California. I thank the governor for his signature, all who assisted in passage of AB 2022. CNRA Secretary Crowfoot and his advisory committee also deserve thanks and appreciation for their thoughtful and deliberate process in implementing the measure."

Said Christina Snider-Ashtari, Tribal Affairs Secretary, Governor's Office, "These changes, proposed by local communities in strong partnership with California Native people, allow all Californians to move forward from a past that denigrated Native women and into present that embraces the beauty, diversity and potential that are a hallmark of this state."

Said California Natural Resources Agency Secretary Wade Crowfoot, "The names we give to places in California reflect our shared history and culture. These placenames should never insult communities or perpetuate discrimination. Today's action to remove this harmful term from several locations across our state helps right a historic wrong against California Native American communities and represents an important step toward a more inclusive and positive future."

Said Anthony Roberts, Tribal Chairman, Yocha Dehe Wintun Nation, "The Yocha Dehe Wintun Nation has led the effort to change demeaning mascot imagery of native people, and we support replacing derogatory names locally and across state lands. With continued consultation, tribes can lead initiatives to eliminate such words from California's

public places."

The geographic features and place names will be replaced in 17 counties by Jan. 1 and the new names have been selected in consultation with California Native American tribes. The bill requires replacement names to prioritize honoring tribal cultures and Indigenous languages, ensuring that these places reflect the state's rich cultural history moving forward.

California Advisory Committee on Geographic Names will work closely with public agencies and tribal representatives to implement approved replacement names by January 1, 2025. For more information on the name changes and their impacts, please visit https://cacgn. ca.gov/.

Social Security Matters

Older Veteran Asks about Special Social Security Credit for Military Service

Dear Rusty: I served in the U S Army from January 1958 to Feb 1961. What increase should I receive for those years and who do I call and at what phone number? Signed: Proud Veteran.

Dear Proud Veteran: First, thank you for your military service! I expect you are referring to the "special extra credits for military service" which are available to some who served in in the US Military in earlier years. It is important to note that these "extra credits" take the form of an adjustment to your military pay record while serving and are not an incremental amount added to your monthly Social Security benefit because you served. Military pay has been

benefit because you served.
Military pay has been subject to deductions for Social Security since 1957. Thus, while serving between 1958 and 1961 you paid SS tax on your military earnings. But, for purposes of determining your Social Security benefit, your military earnings record would be increased

by \$300 for each quarter

you served on active duty,

up to a maximum of \$1,200 increase per year of service. That means for 1958 - 1960, when calculating your SS benefit, \$1,200 would be added to your military earnings record for each year you served. FYI, for those who served after 1967, this adjustment was automatically made by Social Security. But for service years prior to 1967 (as in your case) you would need to inform Social Security of your service when you claimed SS and provide a copy of your military form DD-214 (your discharge papers). SS would then make the appropriate adjustment to your military earnings record prior to calculating your benefit amount. And, for clarity, additional credits for military service are not available to those who served after 2001.

A key point to understand is that this adjustment to your military pay may – or may not – affect the amount of your Social Security benefit. Social Security determines your benefit amount based on your highest earning 35 years over your entire lifetime (adjusted for inflation). If, after you served in the military, you had at least 35 years of civilian employment where you earned more than your military pay, it is probable that your military pay is not included when calculating your Social Security bene-

fit. If that is the case, it is

likely that the "special extra

credits for military service" would have no effect on your Social Security payment. If, however, your military pay (including those special extra credits) for any year is more than you earned in civilian life, then you can contact Social Security (1.800.772.1213), provide them with a copy of your DD-214, and ask that they recalculate your Social Security benefit to include the extra credits for your years of military

Local Metal Recycler to Pay \$175,000 in Penalties

Yolo County District Attorney's Office News Release

WOODLAND, CA (MPG) - Yolo County District Attorney Jeff Reisig announced a settlement with Green Zone Recycling, a metal recycler in Woodland, which unlawfully recycled major appliances, including refrigerators and freezers.

Major appliances include materials that can cause serious harm to the environment if improperly managed. To protect our air, water and soil, the law requires that only Certified Appliance Recyclers—businesses with the necessary training and equipment—can accept such appliances.

The District Attorney's investigation, which originated from a complaint submitted by the Yolo County Central Landfill, also received assistance from the Landfill, the Yolo County Environmental Health Division, the California Air Resources Board and

the California Department of Toxic Substances Control. The investigation found Green Zone had a longstanding practice of unlawfully accepting large quantities of major appliances for recycling, and improperly processing those major appliances. This risked causing the release of ozonedepleting chemicals into our atmosphere, among other environmental damage. After the District Attorney's Office contacted Green Zone, the company ceased its illegal practices and cooperated with the investigation.

The Yolo County Superior Court ordered Green Zone to pay \$175,000.00 in civil penalties, partial cost recovery and supplemental environmental projects. The court also issued a statewide injunction to ensure ongoing compliance.

"Major appliances often include air pollutants and other chemicals that can damage our environment," said District Attorney Reisig. "Breaking laws designed to protect our environment, and public health also creates an unfair advantage over businesses that make the investments necessary to follow the law. This office is committed to enforcing the laws that protect our environment and ensure a level-playing field for businesses."

Members of the public can do their part to protect our environment by only disposing of major appliances at the Yolo County Central Landfill, or through a Certified Appliance Recycler.

Contact the landfill at (530) 666-8729 for additional information. A map of Certified Appliance Recyclers in California can also be found on DTSC's website at https://dtsc.ca.gov/certified-appliance-recycler-car-program/#CARmap.

Yolo County residents should also ask whether a company is a Certified Appliance Recycler before using them to dispose of any appliances.












Retirement, Really?

Matsui and Blumenthal Introduce Bicameral **Legislation to Restore Critical Public Health Funding**

WASHINGTON, D.C. (MPG)

Congresswoman Doris Matsui (D-CA) and Senator Richard Blumenthal (D-CT) introduced the Public Health Funding Restoration Act which would restore funding for the Prevention and Public Health Fund (PPHF).

The Prevention and Public Health Fund provides dedicated funding for innovative public health projects, including vaccination programs, chronic disease prevention programs, and health education programs.

"From increases in chronic disease rates to infectious disease outbreaks like the COVID-19 pandemic, the modern public health ecosystem demands continual, robust investments." said Congresswoman Matsui. "Originally meant to reach \$2 billion in 2015, the Prevention and Public Health Fund has been underfunded for years. In addition to supporting existing core public health activities like vaccinations, restoring the Fund to its full amount is critical for developing and expanding innovative programs to prepare for pandemics and other unique public health threats that arise. The Public Health Funding Restoration Act reaffirms the importance of prevention in the United States health care system. It fulfills our promise to support our federal, state and local partners' efforts to improve the health of all Americans."

"This legislation ensures that vital public health programs receive the funding needed to provide affordable and quality care," said Senator Blumenthal. "Without full funding, our public health system is limited in its ability to combat health threats and to develop innovative public health initiatives. With the Public Health Funding Restoration Act, we make a critical investment in lifesaving public health programs and the health of our nation."

The Prevention and Public Health Fund is currently funded at \$1.3 billion. The Public Health Funding Restoration Act would authorize and appropriate \$2 billion in Fiscal Year 2025 and each subsequent fiscal year to fully restore the Prevention and Public Health Fund.

In doing so, the Public Health Funding Restoration Act reaffirms the importance of prevention and public health programs to the Department of Health and Human Services' and local and state health departments' efforts and recognizes that cuts to the Prevention and Public Health Fund undermine both public health and efforts to establish an affordable and accessible health care system.

The legislation is cosponsored in the U.S. House of Representatives by U.S. Representatives Raúl Grijalva (D-AZ), Nanette Barragán (D-CA), Paul Tonko (D-NY), Tony Cárdenas (D-CA) and Ann Kuster (D-NH). It is cosponsored in the U.S. Senate by U.S. Senators Tina Smith (D-MN), Kirsten Gillibrand (D-NY), Patty Murray (D-WA) and Amy Klobuchar (D-MN).

The legislation is supported by over 90 organizations, including Trust for America's Health (TFAH), American Public

Health Association, AIDS Institute, American Heart Association, Association of State and Territorial Health Officials, and Campaign for Tobacco Free Kids.

"The Prevention and Public Health Fund is a vital investment in our nation's health in every state and territory. California's Climate Rules Leave **Working Class Behind**

Commentary by Senator Ted Gaines

The next time Governor Newsom puts on his detective hat and tries to get to the bottom of the "price gouging" that is supposedly driving absurdly high gas prices in California, he should start with the most obvious culprit in the state: himself.

Earlier this month, Newsom's California Air Resources Board (CARB) voted to approve changes to the state's Low Carbon Fuel Standard (LCFS), potentially adding \$.65 cents a gallon to the already punitive cost of gasoline. Although consumers may be recoiling at the thought of even higher prices, political leaders must be relishing the opportunity to make it more difficult to own and operate an internal combustion vehicle.

That's not even counting economic pain caused by the never-ending attacks on the petroleum industry here, which cost jobs and add around \$1.50 in government costs to a gallon of gas, before the LCFS bump earlier this month. Soon, Californians could be paying more in taxes and fees for every gallon of gas than some states pay for an entire

Let The Games Begin: 2026 Campaign for California Governor Now Looms

California has a lengthy — very lengthy — list of critical economic, social and policy issues that are very likely to remain unresolved when Gavin Newsom vacates the governorship 26 months hence.

The nation's highest levels of poverty and homelessness, shortages and rising costs of housing, exploding energy bills, an uncertain water supply, street crime, chronic educational shortcomings, a bullet train project that seems to be going nowhere, and multibillion-dollar budget deficits are merely the most obvious flashpoints.

Most were evident when Newsom was elected governor in 2018, promising vigorous efforts to neutralize them, such as his ridiculous pledge to build 3.5 million units of housing, but most have become even more intractable during his reign.

Given that unfortunate history, why would any sane person volunteer to step into Newsom's shoes? The fact that quite a few Californians are weighing 2026 bids for the governorship testifies to the essentially irrational nature of political ambition.

The next political cycle begins with no clear frontrunners, which is a bit unusual. Rather, we have at least a dozen potential candidates, none of whom can claim more than fractional support, plus one huge unknown factor: Vice President Kamala Harris's career plans after losing her presidential bid.

A new poll by UC Berkeley's Institute of Governmental Studies confirms the lack of a frontrunner and, just for fun, tests the possibility of a Harris comeback run for governor, ala Richard Nixon's vain attempt to become governor in 1962. While nearly half of voters surveyed said they would consider supporting Harris for the governorship, it could be as polarizing as her White House campaign.

"Considerations of Harris as a potential gubernatorial candidate are highly partisan," the poll found, "with 72% of Democrats saying they would be very or somewhat likely to consider supporting her, while 87% of Republicans would not. Among voters not affiliated with either major party, 24% would be very likely and 13% somewhat likely to support a Harris 2026 bid for governor."

Discounting a Harris candidacy, the poll found that another newly defeated Democrat, U.S. Rep. Katie Porter, sits atop the field, with 13% of voters ranking her as their first or second choice, followed closely by Chad Bianco, the Republican sheriff of Riverside County, at 12%.

Porter gave up her Orange County congressional seat this year to run for the U.S. Senate, but lost in the primary to another member of Congress, Adam Schiff, who claimed a Senate seat last

Among Democratic voters, Porter scores 22% support, more than twice what her most likely

Democratic rivals garner. Lt. Governor Eleni Kounalakis, former Los Angeles Mayor Antonio Villaraigosa and U.S. Health and Human Services Secretary Xavier Becerra, the state's former attorney general, all are in the 10-11% range.

Among Republican voters in the survey, Bianco and state Sen. Brian Dahle are virtually tied at about a third each.

The chances for any Republican to become governor are almost nil, given the overwhelming Democratic voter majority, but the state's top-two primary system makes Republican candidates more relevant against a large field of Democrats.

That tactical element was very apparent earlier this year when Porter faced Schiff and a third Democrat, Rep. Barbara Lee. Schiff spent heavily to help Republican Steve Garvey finish in second place in the primary, ensuring a November win.

Counting Porter, there are five reasonably viable Democrats who might run next year — not only Kounalakis, Villaraigosa and Becerra but Attorney General Rob Bonta. A fiveway split of Democratic voters would make it easier for a Republican to finish second in the primary, as Garvey did, and indirectly help the leading Democrat to become governor.

Let the games begin.

Sonoma County Farmers Celebrate Measure J Defeat

The defeat of a Sonoma County ballot measure last week brought relief for farmers in the county. As of Friday, more than 85% of voters had voted against Measure J, which within three years would have banned large dairies and poultry farms in the county. The measure would have capped the number of animals each farm can raise, banning large farms or forcing them to downsize. Doug Beretta, owner of Beretta Family Dairy in Santa Rosa and president of the Sonoma County Farm Bureau, said he was "ecstatic" so many voters had sided with the county's farmers. "The community came together to fight for agriculture," Beretta said. "When those results came in, it really showed."

Brussels Sprouts Nab More Acreage as Demand Grows

As Brussels sprouts have become trendy on social media and restaurant menus during the past several years, California farmers have been able to cash in on the vegetable's popularity. "The market's really grown, especially the fresh market, and a lot of that has to do with the food shows on TV and chefs' artistic abilities," said Monterey Countybased vegetable grower Jeff Hitchcock. "It's really put Brussels sprouts on the map." U.S. per capita consumption of Brussels sprouts increased from 0.33 pounds in 2011 to 0.78 pounds in 2019, according to U.S. Department of Agriculture statistics.



As part of a monthslong investigation known as Operation Tractor Pull, California law enforcement agencies have uncovered an organized agriculture equipment theft ring that targeted San Joaquin Valley farms. After conducting extensive surveillance operations throughout the San Joaquin Valley, authorities said evidence collected accounted for 24 pieces of stolen equipment valued at more than \$2.25 million. Authorities recovered \$1.3 million worth of equipment. "This is a large-scale theft ring impacting our farmers, our ranchers and our agricultural community," said Tulare County Sheriff Mike Boudreaux during an Oct. 29 press conference.

Turkey Supplies Ample Heading into Thanksgiving

The Voice of California Agriculture podcast, produced by the California Farm Bureau, discussed turkey supplies heading into the Thanksgiving holiday season. Bill Mattos, president of the California Poultry Federation, said on the podcast that despite millions of turkeys being lost to bird flu across the country during the past two years, "I think you'll find plenty of turkeys for Thanksgiving," including fresh California turkeys. Mattos said prices may be slightly higher on average this year, but that many grocery stores offer steep discounts on Thanksgiving turkeys to get shoppers into their stores. The episode also covered the efficiency of autonomous sprayers, water flow standards for the Scott and Shasta rivers, and crop damage estimates resulting from hurricanes in Florida and North Carolina.

"RED ONE" HOLIDAY ACTION COMEDY; "ABSOLUTION" FOR A CRIME STORY

"RED ONE" RATED PG-13

What exactly is the holiday cheer to be found in "Red One," a picture that has action and comedy along with a heavy dose of surreal fantasy which seems a lot more like science-fiction drama than a celebration of the Christmas spirit?

Well-known actors take center stage with Dwayne Johnson displaying qualities befitting his physical persona of "The Rock" and Chris Evans shedding his Captain America image for that of a scoundrel with a skewed moral compass.

The titular character for "Red One" is J.K. Simmons' Santa Claus, or known to his family and friends as Nick, who has the code name "Red One" for his security detail, and we thought only U.S. presidents had code names bestowed by the Secret Service.

We first see Chris Evans' Jack O'Malley as a delinquent youth acting like a shakedown artist. In adulthood, Jack is a deadbeat dad completely lacking in scruples when stealing other people's lattes and newspapers before retreating to his job of hacking computers and being a tracker for hire.

With Christmas Eve around the corner, the North Pole comes under attack by evil forces connected to the Christmas witch Gryla (Kiernan Shipka), who wants to punish all the allegedly naughty people in the world and not just children.

The first step in Gryla's misguided plan is the abduction of Santa Claus to be imprisoned in a fortified snow globe, so that Nick won't be able to fulfill his yuletide mission of delivering presents.

Operating under the underground moniker "The Wolf," Jack is surprised as anyone that Santa's head of security, Callum Drift (Dwayne Johnson), has noticed his apparently inadvertent disclosure of the location of Santa's domain to the bad guys.

Considering that the unattached Jack is estranged not only from his son and the boy's mother, one can easily figure that a reconciliation with his offspring, Dylan (Wesley Kimmel), is in the offing since this is a Christmas movie after all.

But first, Jack reluctantly joins Callum in an odd couple buddy team in the hunt for Santa, facing off against an assortment of otherworldly henchmen, including Santa's estranged brother Krampus (Kristofer Hivju) who looks like a cross between a Viking warrior and a horned space demon.

One of Callum's neat tricks is a shape-shifting ability to respond to physical attacks, as well as turning toy cars into real ones for chase scenes and action figures into fighting machines.

Unlike his usual good guy on a virtuous mission, Neeson's character, only fittingly known as Thug, is an aging gangster who attempts to reconnect with his estranged children to rectify his personal failings.

Thug's desire for absolution has much to

do with a terminal illness with the incapacitating neurological malady of CTE, which usually afflicts athletes suffering too many concussions. Too many blows to the head apparently have happened to Thug, a former boxer.

Even though Thug is fading mentally and physically, he's still capable of responding to deadly threats with his own lethality. The mystery centers on who wants to eliminate Thug before irreversible brain damage takes its deadly toll.

Having worked for crime boss Charlie Conner (Ron Perlman) for decades, Thug is tasked with providing tutelage to Conner's lunkhead son Kyle (Daniel Diemer) to learn the ropes to eventually to take over his father's criminal enterprise.

Meanwhile, Thug would like to repair what might be a lifetime of anguish for his alienated daughter Daisy (Frankie Shaw), who really wants nothing to do with her father, even though her young son Dre (Terrence Pulliam) appears curious about the mysterious grandfather.

Reconnecting with family is not helped when Thug can't remember the name of his deceased son or where he's buried. Perhaps he should have family information on the notebook used to keep track of things.

Don't expect this film to be a non-stop action picture. It's about an hour into the story before Thug even throws a punch, and while violence is toned down, the killer instinct of an aging criminal still emerges when the occasion arises.

New Republic FC Stadium Back on Track

SACRAMENTO, CA (MPG) - A project that was on life support had some much-needed life injected into it on Tuesday, Nov. 12, when the Sacramento City Council voted unanimously to approve the framework for a \$321 million downtown railvards soccer stadium and entertainment venue. A long-awaited development needed to provide a permanent home for the Sacramento Republic Football Club (FC).

According to the information provided by council staff in support of the proposal, the projects being approved include a soccer stadium with supporting infrastructure occupying approximately 31 acres, as well as a new 3600-seat live entertainment venue that would occupy existing historic buildings in the railyard.

The agreement, albeit non-binding, does include information regarding project costs, economic impact and anticipated public and private funding sources. The estimated \$321 million price tag breaks down to, \$175 million for the new stadium. \$56 million for the new live entertainment venue and \$90 million for associated

infrastructure. The projects altogether are expected to generate more than 1,500 jobs for the Sacramento region. The agreement includes a provision by which the city would waive reimbursement for municipal services for off-site police, fire, emergency medical services, traffic control and code enforcement for stadium events for up to a maximum of \$300,000 per year for a ten-year period.

The official press release from the city indicates the new stadium will be supported and privately financed by the Wilton Rancheria Tribe which became majority owners of Sacramento Republic FC on Nov. 7. The press release includes a quote from Mayor Darrel Steinberg on the importance of the council's vote.

"We are breaking barriers and making history here in Sacramento," said Mayor Steinberg. "Wilton Rancheria is the first tribe to own a professional men's sports team in North America, and the projects in The Railyards will double the size of the central business district what an incredible opportunity! This is the foundation for something beautiful today that will become even more beautiful in the years and decades to come."

In a Nov. 7 press conference, in advance of the Nov. 12 council vote, city officials joined together with representatives of Sacramento Republic FC, Downtown Railyards Venture LLC and Wilton rancheria Tribe members to celebrate the new energy being pumped into the soccer stadium/railyard development. At the press conference, Wilton Rancheria Chairman Jesus Tarango commented on the importance of the project.

"I am deeply proud to witness this moment, which stands as a profound testament to the resilience and determination of the people of Wilton Rancheria," said Chairman Tarango. "In just over a decade, our Tribe has transformed from landless to becoming a significant economic force in the region. The opportunity to drive a project of such scale and importance, on land where our ancestors once walked, is deeply meaningful. This is not only a chance to honor our history and uplift our community, but also to envision a future where we are not only part of Sacramento's past, but an integral part of its future as well."

According to the city, the stadium project is scheduled for completion by late 2026, and the entertainment venue by 2027. ★

SACRAMENTO, CA (MPG) - The Sacramento State doubles duo of Maddy Ferreros and Irene Riva showed well at last weekend's ITA Conference Masters event in Rome, Ga., reaching the main draw semifinals and falling just one win shy of a berth into the 2024 NCAA Individual Championships.

Facing teams from across the nation, the Hornet tandem opened their run with a straight-set victory over Emilia Valentinsson and Sara Zalukar from Miami University, 7-5, 6-3, then outlasted Bryant's team of Caitlyn Munson and Natalia Vela in three sets, 5-7, 6-4, 10-4.

Ferreros and Riva continued to roll on day two, easing past the Naval Academy's Emily Tannenbaum and Parvathi Shanker, 6-2, 6-0, before suffering their first loss of the tournament in the semifinals to Appalachian State's Savannah Dada-Mascoll and Isabella Romanichen, 6-3, 6-1.

With the top three doubles teams earning a spot in the NCAA Tournament, Ferreros and Riva faced off against Celia-Belle Mohr and Sophia Webster from Vanderbilt for third place, winning the first set in a tiebreaker, 7-6 (5), before falling by the scores of 6-0 and 10-5 to finish fourth.

In singles, sophomore Lou Baudoin fell in her main draw opening round match to Charleston Southern's Marina Skegro, 2-6, 6-4, 6-2, but rebounded in the consolation draw defeating Illinois-Chicago's Mayu Ushio, 4-6, 6-1, 6-2, and advancing to the semifinals with a walkover against South Carolina State's Sofiya Chursina.

In the semis, Baudouin was finally subdued, falling to South Dakota's Beata Havlickova, 6-0, 6-4.

The Hornets have wrapped up the fall portion of the team's schedule and will open the spring championship season on Jan. 26 at home against the University of

Hornet's Goalkeeper Sierra Sonko **Earns Player of the Week Honors**

SACRAMENTO, CA (MPG) - Redshirt freshman goalkeeper Sierra Sonko came up aces not once, not twice, but three times in penalty kicks for the Sacramento State women's soccer team last week during the Big Sky Conference Tournament, stopping a pair of attempts in all three contests to earn National Player of the Week honors from Top Drawer Soccer on Tuesday,

It's another award added to the mantel for the Seattle, Wash., native, who was named the Big Sky Tournament Most Valuable Player for her performance in net as the Hornets claimed their first league tournament championship, and the automatic NCAA berth that goes with it for the first time since 2010.

Having appeared in one match and playing in only five minutes during the regular season, Sonko answered when called upon for No. 5-seeded Sacramento State, stopping a pair of penalties following a 2-2 draw against No. 4-seeded Northern Arizona and repeating the feat against regular season champion, host, and topseeded Montana after the Hornets and the Grizzlies played to a scoreless draw.

Two days later, it took eight rounds of penalties to finally decide a winner, but Sonko stopped defending tournament champion Idaho on its fourth attempt as the Hornets drew even and then denied the Vandals on what turned out to be their final attempt of the day to secure the

Following the match, Sonko became the third Sacramento State women's soccer player to be named the Big Sky Tournament's MVP, joining Katie McCoy (2007) and Elece McBride (2010). She was one of six named to the all-tournament team along with teammates Teysha-Ray Spinney-Kuahuia, Ellie Farber, Sydney Sharts, Dalen Lau, and Izzy Palmatier, matching the most selections in school history along with the 2007
