**ELK GROVE, CA (MPG)** - Hundreds of families will have a hearty Thanksgiving meal after Elk Grove Food Bank Services' annual turkey distribution on Nov. 23.

The rainy weather couldn't dissuade the staff and volunteers, who directed traffic or carried turkeys and other fixings to cars in the Creekside Christian Church parking lot.

Close to 1,600 individuals had signed up to receive food and the food bank hoped to have more than enough for everyone.

Besides a turkey, each recipient got some onions and boxes filled with stuffing, green beans and other foods.

## Planning Commission Favors Climate Plan Amendments

**ELK GROVE, CA (MPG)** - Elk Grove Planning Commission recommended adopting amendments to the city's Climate Action Plan during its Nov. 21 regular meeting. The amendments, which now go before Elk Grove City Council, concerned zero net energy buildings and requirements for electric-vehicle chargers at parking lots.

A provision on zero net energy buildings was altered to reflect a change in state priorities. Originally, the plan defined a zero net energy building as one that produces as much energy through on-site sources as it consumes. However, the state of California has shifted its focus since 2019 to allow off-site projects such as community solar power. Staff recommended changing this language to reduce emissions from power generation at new residential developments, aiming for a 50% reduction from 2019 levels. Another amendment simplifies requirements for electric-vehicle chargers at multiunit buildings, hotels and motels. It says that 40% of spaces must have a low-power charger available and 10% of spaces must have a more advanced Level 2 charger in new construction. Existing parking facilities undergoing alterations must install wiring to support chargers at 10% of spaces. Several other amendments related to electric-vehicle charging were designed to streamline city regulations and bring them in line with changing state codes. Commission Chair Suman Singha was pleased with the amendments, saying that the simplified charger regulations are "critically important as we move forward." Commissioner Juan Fernandez asked about the possibility of maintenance standards for chargers. He recalled trying to use a charger at his office. "I got there and there was a tag on it. It wasn't working properly, so I wasn't able to charge," Fernandez said. "So just Continued on Page 3

**ELK GROVE, CA (MPG) -** For the next year, Elk Grove FFA alumna Abigale Jacobsen will represent the Western United States as a national FFA officer.

Jacobsen was elected at the FFA national convention in October to serve a year as western region vice-president, along with a team of five other officers from across the country.

Jacobsen, a former member of Elk Grove FFA, spoke to the Citizen about what she wants to accomplish during her term.

The officers were elected by national FFA delegates from a pool of 37 candidates. The hopefuls also participated in an extensive interview process.

In an interview, Jacobsen said she was "in shock" when she was named a

national officer but her thoughts remained with the community that made her who she is.

"The joke on my team is that I ran up the stage super, super fast. I don't know if I'll ever be able to run that fast again but I just couldn't believe it. It was a total adrenaline rush," Jacobsen said. "And, one, I was excited to hear my name called but all I could really think about was all the people who had spent countless hours and energy pouring into me and building me into all that I am."

Having graduated from Elk Grove High School in 2022, Jacobsen is studying pre-veterinary medicine at California State University, Chico. She previously served for a year as California state FFA president. When the Citizen spoke to Jacobsen, she was

## Matsui, Carter Applaud Extension of Telemedicine Prescribing Flexibilities

WASHINGTON, D.C. (MPG) - Rep. Doris Matsui, D-Sacramento, and Rep. Earl L. "Buddy" Carter, R-Georgia, applauded the Drug Enforcement Administration (DEA) and Health and Human Services (HHS) decision to extend current flexibilities for telemedicine prescribing of controlled substances for an additional year. The announcement comes after the lawmakers led a group of 18 House colleagues in urging the Drug Enforcement Administration and Health and Human Services to issue such an extension earlier this year.

"The agencies made the right choice by averting a potential cliff for patients relying on telemedicine for their controlled substance prescriptions," said the lawmakers. "While we're relieved that patient

care will not be interrupted at the end of this year, the agencies must continue to work towards a permanent framework for telemedicine prescribing that balances safety with patient access to critical medications. We must ensure no one is slipping through the cracks when it comes to the benefits of telehealth."

A co-chair of the Congressional Telehealth Caucus, Matsui is a longtime champion of

telehealth and improving access to care. She authored the Telemental Health Expansion Act, which permanently added mental health to the definition of Medicare-covered telehealth services, waived the geographic and originating site requirements for mental health provided through telehealth, and allowed Medicare beneficiaries to access these services at home.

Matsui also introduced the Telemental Health Care Access Act, which would repeal the requirement that Medicare patients be seen in person before receiving virtual behavioral health care.

Rep. Doris Matsui has represented the city of Sacramento and its surrounding areas since 2005. She currently serves California's Seventh Congressional District, nestled between the Sierra Nevada Mountains and the Pacific Ocean, which is centered in Sacramento,

and includes the communities of Elk Grove, Galt, West Sacramento, Wilton, Rancho Murieta, Vineyard, Isleton, Walnut Grove, Herald, Clay and the California Delta.

## **D.L. Bliss State Park Remains Closed into Summer 2025**

**SACRAMENTO, CA (MPG)** - California State Parks announced D.L. Bliss State Park will remain closed for camping and partially closed for day use into summer 2025. This extended closure is necessary to complete an ongoing waterline infrastructure replacement.

Campground reservations for the 2025 season at D.L. Bliss State Park will not be available until further notice. (Editor's note: D.L. Bliss State Park is located on the west shore of Lake Tahoe.)

The following day-use areas remain accessible:

Lester Beach and Calawee Cove: These areas will remain open for water access from Lake Tahoe and foot access via the Rubicon Trail from Emerald Bay State Park.

Backcountry Areas: Portions of D.L. Bliss State Park west of Highway 89 will continue to be available for winter backcountry use.

Bouldering/Rock-Climbing Areas: Popular bouldering and rock-climbing sites located just east of Highway 89, closed for the past two seasons, will reopen in 2025 for walk-in access from designated roadside parking areas.

Please note: No restroom or trash services will be available at these locations. Visitors are encouraged to practice "Leave No Trace" principles to minimize environmental impact. Due to construction activities on the park roadways, emergency response vehicle access may be limited, and response times could be delayed.

The public is invited to visit nearby campgrounds and day-use access areas at Emerald Bay State Park and Ed Z'berg Sugar Pine Point State Park, which are expected to be fully open during summer 2025.

California State Parks appreciates the public's understanding and cooperation as it works to improve D.L. Bliss State Park for all visitors.

## **Teen Driver Dies in Collision with Tree**

**ELK GROVE, CA (MPG)** - A teenage driver died in a car crash Nov. 20 on Big Horn Boulevard, Elk Grove Police Department reported.

According to a police statement, officers responded to a report of a single-vehicle crash on Big Horn between Amber Creek and Frye Creek drives at about 1:23 p.m. Police said a Lexus IS heading west on

Big Horn left the roadway east of Frye

Creek Drive and struck a tree. The driver was pronounced dead at the scene. The Sacramento County Coroner's Office identified the driver as Solaimon Hamidi, 17, of Elk Grove.

"The collision is under investigation,

and Traffic Investigators believe speed was a factor," the department said. It encouraged anyone with information relevant to the investigation to contact the Elk Grove Police Department Traffic Bureau at 916-478-8143.

Food bank leaders noted that more and more people are facing hunger in Elk Grove, with Singha saying that the nonprofit served slightly more than 9,000 people in the past month. He added that many of those were older adults and children.

"Food insecurity is a major problem in this country, and when you think we're the richest country in the world, we shouldn't be facing that," Singha said. "So we're hoping that this adds some joy and some happiness to people for the holiday season."

Community Outreach manager Valerie Erwin said the demand for food assistance has not gone down since the coronavirus pandemic.

"I think all of us from several years all thought that if we could get through COVID, things would get better, kind of go back to normal, and things haven't gone back to normal," Erwin said, citing rising prices as a major factor.

One big boost to the food bank's effort to meet the need at Thanksgiving is a yearly donation of turkeys organized by Gil and Kay Albiani.

For this year's donation, their fifth, the couple arranged a delivery of 1,000 turkeys, delivered on Nov. 18. Gil Albiani, a real estate agent and Cosumnes Community Services District board member, told the Herald that everybody should have a turkey on the "universally American" holiday of Thanksgiving. Each year, he appeals to his friends, family and business associates for donations.

The responses are always positive and

generous, Albiani said.

"Wouldn't you expect all the people that provide money for turkeys are thrilled to do that? Nobody objects; they're just really kind," Albiani said, adding that there's "no magic to it all. Just ask and you shall receive."

Located at 9888 Kent St., the food bank is open

from 9 a.m. to 2 p.m., Mondays through Fridays, and 9 a.m. to noon on Saturdays. It is closed on the fourth Wednesday of the month. Starting Jan. 1, 2025, it will be closed on Saturdays.

having equipment installed is great but making sure that it is functional would be even greater."

Carrie Whitlock, the city's strategic planning and innovation program manager, said privately funded chargers don't have maintenance requirements but she added that staff is reviewing the matter.

The five commissioners voted

unanimously to recommend that City Council adopt the amendments.

The commission also signed off on a conditional-use permit for an Elk Grove church to meet at a property on Grant Line Road.

Located south of Grant Line and east of Highway 99, the 3,300-square-foot space is in a multitenant office building. Risen Hope of the Christian and Missionary Alliance asked Planning for authorization to hold assemblies there.

Whitlock said the church would use the space for a 1,200-square-foot sanctuary, along with two offices and storage space. The church proposed no external changes or signage on the building.

Main religious services would be from 9 to 11 a.m. Sundays, attracting about 30 attendees. Smaller religious study gatherings would take place on occasional weekday nights. Standard office operations would be from 8 a.m. to 5 p.m. Mondays through Fridays.

Whitlock said the number of parking spaces needed for the church and the existing uses at the property do not exceed the available spaces.

Risen Hope currently lists a location on Dwight Road on its website.

"We hope to plant a church here where people can come and have spiritual renewal," the Rev. Jerry Lao told the commission.

The Planning Commission voted 5-0 to approve the permit.  $\star$

packing up in preparation to leave Chico for the FFA national headquarters in Indianapolis; she will put her college career on hold for a year to carry out her national officer duties.

"At the end of the day, to me the decision came down to, 'How am I going to be able to live out my life's purpose and give back to the people and community that have done so much for me?"" Jacobsen said.

Jacobsen said that the position will allow her to connect with students and elevate their voices in agriculture.

She said the officer team would start their service with training followed by an international trip to "connect with other segments of the agriculture industry outside the United States."

The officers give motivational speeches and lead workshops, as well as representing students at meetings of the FFA board of directors. Jacobsen said all of this keeps in mind the organization's mission of developing students' potential for career success and personal growth.

Asked what personal experiences inform her approach to the officer role, Jacobsen said the Elk Grove FFA chapter gave her a chance to experience multiple facets of the ag industry, even though she didn't have a "traditional or strong tie to agriculture" before joining.

"That's the story for a lot of students," Jacobsen said. "Not many people within FFA have always grown up from a traditional ag background but we still have opportunities to explore

what agriculture and our future in agriculture can look like for us. And for me, it's led me to pursue a career as a large-animal veterinarian. ... When we're looking at growing the next generation of leaders, not everyone's going to come from the same background."

Jacobsen credited her teachers and teammates at Elk Grove FFA for helping her grow as a person.

"I started out high school as that scared, reserved freshman at the back of the class who seldom raised my hand but fortunately, I had ag educators, like Ms. Sierra Meyers and Mr. Mike Albiani, who saw something in me that I didn't quite see in myself at the time and pushed me to become involved with FFA activities."

Albiani spoke to the Citizen about Jacobsen's drive and the impact of her election for Elk Grove FFA.

"It takes a special student" to achieve what Jacobsen has, because of the large commitment of time and energy, Albiani said. He pointed to a state award for public speaking that Jacobsen earned, calling it the "catalyst" that gave Jacobsen the confidence to pursue a state officer position.

The 26 current Elk Grove FFA students who attended the convention were "very excited" to see Jacobsen named an officer, Albiani said. He noted that she has stayed involved in the chapter and her election has inspired some students to participate in chapter committees and other activities.

"It's meant a lot that the kids believe that, 'Wow, you can do this and be from Elk Grove.' You can be a suburban kid that came into the program not knowing a lot about it," Albiani said.

The national position has already unlocked exciting opportunities for Jacobsen, who joined the officer team in Washington, D.C., for the annual Thanksgiving turkey pardoning on the White House lawn. She is enthusiastic about the move to Indianapolis, although not without trepidation about the winter weather.

"I am a little bit nervous for the Midwest winter. As a California girl in the Sacramento Valley, the snow and weather below about 40 degrees isn't something I'm very used to but I'm very excited to see the snow and live in actual seasons," Jacobsen said.

She also looked forward to checking out a Taylor Swift-themed boutique and spending time at the National FFA Center.





Wow, major media networks have taken to calling the Sacramento Kings an average NBA basketball team. As a fan of nearly 40 years and living through 16 straight seasons of missing the playoffs, that hurts.

I would almost rather you just called them bad, as opposed to the dreaded average.

Who wants to be average? Just an obscure number in a host of other numbers. No one I know, and I have high hopes that this team as it's assembled, will change this narrative and do it quickly.

After the Kings won three games in a row, I was all but certain that DeMar DeRozan had found his niche and was set to do great things for the Sac Town ballers. However, in the Nov. 24 game against the Brooklyn Nets, I witnessed DeRozan pass up 12-15-foot jumpers, only to pass off to other teammates for less desirable shots.

The past week wasn't kind to the Kings, as they had perhaps their worst one week stretch of the season. The week started with a 109-108 loss to the Atlanta Hawks, in a game that the Kings had in hand, and should have won.

Two nights later, in Los Angeles, the Clippers put on a clinic and embarrassed Sacramento, holding the Kings to a season low 88 points. The only good news was that the game was on the road, and the hometown fans didn't have to witness a second quarter that saw Sacramento score a season low 12 points. The game was decided early, and it was hard on the eyes.

Thinking this game had to be an anomaly, Golden One Arena was filled with expectant fans on Sunday Nov. 24 to welcome back former assistant coach Jordi Fernandez, who captured the head coaching job for the Nets in the off season.

Sadly, it was not to be, as the hometown team turned the ball over 16 times, while missing 11 shots from the charity stripe.

Last season saw the Kings finish dead last in the NBA in free throw shooting, but 10 games into the 2024/2025 campaign they were actually leading the



league in free throw percentage. The game against the Nets saw the Kings take a step back, in a game that was entirely winnable.

In today's NBA nine 3-pointers won't win many games, and in particular if your opponent sinks 19. Combine that with 20 made free throws in 31 attempts, and even without regard to the 16 turnovers committed by the Kings, this game was a real stinker.

Stalwart standouts De'Aaron Fox and Domantas Sabonis showed up as they always do, as Fox contributed 31 points, and was the only player for the Kings that could seemingly hit a three. DeAaron sank 3 of 4 3-pointers while Sabonis gathered in 18 rebounds and added 13 points for another solid double-double.

Huerter continues to struggle in spite of the fact that coach Brown has him in the starting five every night. Kevin went 1-5 from 3-point land, bringing his season average to a startling 29%. His 63% 2024/2025 free throw percentage tells me something is off with Huerter, and I'm convinced that either Keon Ellis or Malik Monk when he returns, would be better options in the starting lineup.

I'm just as convinced that Huerter can overcome his slow start but bringing him off the bench would give him a different look at things, and perhaps ease the pressure just a bit.

The game against the Nets saw a return to coach Brown's difficulties as it relates to coach's challenges. I witnessed no less than three occasions that the Kings could have potentially won a challenge, but sadly the game ended, and coach Brown had yet to challenge a single call.

Yes, Kings fans, the hometown boys have some cleaning up to do, and it's difficult to put a happy face on the games of the past week. Still, one game below 500 is not the end of the world, and with over 60 games to play, let's demonstrate a degree of patience. Let's root them on and see if this squad can come together.



If you've been watching the news, then you know that the world is going to end soon.

No, I'm not talking about the recent election. I'm referring to the elusive deep-water oarfish.

Superstitious sailors have long considered the spotting of this rare fish a harbinger of bad news. And this past week, on the shores of Encinitas, California, it's been spotted again. This makes three times this year in California and only 22 times in the past century.

Japanese mythology recounts the doom fish as a precursor to earthquakes and tsunamis. More than a dozen were found on Japan's coastline just before Japan's 2011 Tōhoku earthquake and tsunami, their largest recorded earthquake.

These kinds of scary indicators aren't new. Televangelists have been capitalizing on them for years as they expounded on their version of catastrophic and

world-ending predictions.

If you were born before 1960, you'll likely remember that Hal Lindsey co-authored a 1970 bestseller with Carole C. Carlson titled "The Late, Great Planet Earth." Some of us just laughed

at him while others tried to ignore him. However, when the Yom

Kippur War of 1973 sent

gas prices soaring, we wondered if the Lindsey scenario was creeping into the nonfiction section. Many began taking Lindsey so seriously that they ran scared into the baptismal waters.

Had we been a little smarter, I'm wondering if we might have seen how religious history was on a repeating track with Lindsey's approach. He was using the scare-the-hell-out-of-you technique used by centuries of religious thought.

It's a thought expressed on the old bumper sticker: "The good news is, Jesus is coming back. The bad news is, He's ticked." (OK, the sticker doesn't say "ticked" but this is a family newspaper.)

The real problem with Lindsey and people like him is that they characterize the Christian faith as a war between good

God is all about helping us make it through our times of hurt and pain. He's not about inventing painful situations just so he can play the superhero. and evil. Indeed, they demand that the faithful make a choice between spending eternity in a bottomless pit of eternal fire or going to church three times a week.

The fault in this thinking is that it forces faith into an all-or-nothing proposition. Faith isn't that way at all. Real faith is relationship-based, not

fear-based.

Faith is more like this: When I met my wife at a Southern Baptist Conference Center, I didn't introduce myself by saying, "Marry me or you'll burn." If I had, she might have hit me with a flamethrower.

God doesn't use that approach, either. He doesn't need to scare us into loving him. That's because God is not trying to save us from this world. After all, he created this world for us.

Jesus made the same point quite well, saying, "God didn't go to all the trouble of sending his son merely to point an accusing finger, telling the world how bad it was. He came to help" (John 3:17, The Message Paraphrase).

God is all about helping us make it

through our times of hurt and pain. He's not about inventing painful situations just so he can play the superhero.

I suppose there'll always be fortunes to be made by capitalizing on demise, death and destruction, but I will continue to place my faith in my relationship with our creator.

The Lindsey star eventually faded. The counterculture of the 1960s never became the main culture, and Lindsey's predictions crumbled with the Berlin Wall.

These days, Lindsey is 94 years old, living in Tulsa, Oklahoma. He's still doing video, but now he's predicting the final jihad that will come any day now. Same scared-as-hell program, just a different station.



**SACRAMENTO, CA (MPG)** - The Big Sky Conference Tournament champion Sacramento State women's soccer team made its first appearance in the NCAA Tournament in 14 years on Sunday Nov. 17, but its run through the postseason was cut short at the hands of top-seeded USC, falling to the Trojans by a 5-0 score at the Dignity Health Sports Park Track Stadium in Carson, Calif.

The Hornets, who entered the postseason unbeaten in their previous nine matches, finishing their year at 5-7-9 overall and placed fifth in the Big Sky with a 3-2-3 overall record. Sacramento State's nine-match unbeaten streak was tied for the second-longest in school history while the nine draws set a new school single-season record.

USC, which improved to 16-1-3 overall with the win and moved its unbeaten streak to 14 consecutive contests, advanced to

the second round where it hosts eighth-seeded Saint Louis.

Sunday's appearance in the NCAA postseason was the program's third, but the first since claiming the conference's automatic berth in both 2007 and 2014. The Hornets were fresh off a Big Sky Tournament run that saw them become the first school to advance and claim the title via penalty kicks in all three of their contests, upsetting the No. 4 (Northern Arizona), No. 1 (Montana), and No. 2 (Idaho) seeded teams along the way. Five Sacramento State players were named to the All-Big Sky team while six student-athletes were named to the Big Sky All-Tournament team, including gaining the MVP.

The Trojans opened the scoring just 3:16 into the match when

they were awarded a penalty kick following a tackle in the box that was deemed overly aggressive by the official. USC converted for the 1-0 lead and led 3-0 at the break following scores in the 13th and 17th minutes.

After the break, the Trojans tacked on two more, scoring just 4:26 into the second half and capping the day with a goal with 48 seconds remaining in regulation.

With her seven saves on Sunday, sophomore goalkeeper Izzy Palmatier finished the year with a Big Sky-best 107 stops, a mark that ranks third on the school's single-season list behind only Stacy Himes (123 in 1996) and Amy Seely (108 in 2001). Her seven shutouts this year were also tied for fifth on the single-season list, two of those scoreless draws against the Grizzlies and Vandals in the Big Sky Tournament semifinals and finals, respectively.

In all, 17 players gained NCAA Tournament experience on Nov. 17, with Candace Ching, Ariana Scholten, Ellie Farber, and Ali Fuamatu-Ma'afala, all attempting shots.

- Sacramento Kings guard De'Aaron Fox has been named the Western Conference Player of the Week for games played between Nov. 11 and Nov. 17, the NBA announced on Nov. 18. Fox averaged 40.5 points (57.4 FG%, 57.1 3pt%, 81.0 FT%), 4.5 rebounds, 7.3 assists and 2.0 steals in four games over the course of the week.

Fox has now earned Western Conference Player of the Week honors six times in his career, passing DeMarcus Cousins (5) for the second-most Player of the Week awards in franchise history. He led the league in several categories over the past week, including points per game, total points (162), field goals made (58), free throws made (34), total clutch points (21) and clutch field goals made (7).

franchise scoring record, shooting 22-of-35 from the field, 6-for-10 from 3-point range and 10-of-11 at the free-throw line. Against the Timberwolves, Fox scored 33 second half points, the second-most by a Kings player since the 1996-97 season, including 20 in the fourth quarter alone. He then posted 49 points, going 16-for-30 from the floor, and knocking down 14 free throws, to go with nine assists and a pair of steals in a win vs. Utah on Nov. 16. Per Elias Sports Bureau, Fox is the first player to total 109+ points in consecutive days since Kobe Bryant (110, 3/22-3/23/2007),and just the third player in NBA history, also joining

Wilt Chamberlain. His 109 points set a franchise record for total scoring over a two-game stretch, surpassing Cousins (104, 1/23-1/25/2016).

"Lisann's powerful yet consistent game will add valuable depth to our roster, making her an important asset in Finishing third on three different occasions in the German Youth Championships, Brinkmann has been ranked as high as No. 109 in the women's division (currently ranked No. 139) and is ranked 21st in the Under-18 division.

Fox posted his fourth double-double of the season with 29 points and 10 assists in a win vs. Phoenix on Nov. 13. He followed that up with a 60-point performance vs. Minnesota on Nov. 15, setting the single-game

This season, Fox is posting averages of 28.9 points (50.9 FG%, 84.2 FT%, 61.1 TS%,), 5.0 rebounds, 5.6 assists and 1.8 steals in 14 games. Among league leaders this season, he ranks sixth in scoring average while tied for seventh in steals per game. Fox is one of four players this season averaging 28.0 points, 5.0 rebounds and 5.0 assists per game while shooting 50.0% or better from the floor and holding a true shooting percentage of 60.0% or higher.




