YUBA-SUTTER, CA (MPG) - November is National Homeless Awareness Month, which includes National Hunger and Homeless Awareness Week from Nov. 12 to 23. During this time, the Sutter Yuba Homeless Consortium held its monthly stakeholders meeting and was joined by Sutter-Yuba Behavioral Health for a presentation on Proposition 1.

California's Proposition 1 was voted on and passed by a slim margin this past March, a measure which has been hotly debated. In the ballot text, Prop 1 is said to authorize \$6.38 billion in bonds to build mental health treatment facilities for those with mental health and substance use challenges as well as provide housing for the homeless. By and large, Prop 1 aims to expand access to

mental health and substance abuse treatment programs through the state while also increasing housing support with a focus on veterans. Opponents have argued that the measure would increase the amount of involuntary treatment and divert money from local organizations that serve hard-to-reach populations, such as LGBTQ people and communities of color.

"California is looking for a little more accountability in the funding they're providing so they're doing different things," said Johnny Burke, executive director for the Sutter Yuba Homeless Consortium. "They want to see results because billions of dollars have been spent over the last several years on homeless efforts and homelessness has continued to grow in California. In my opinion, at least for our area, I can say that that money has been spent very well with

great affordable housing projects, lots of people who were rapidly rehoused, our emergency shelters have grown but we have some other financial things going on in our state that are making more people homeless which is a challenge."

How Prop 1 will affect the area's current services is still being navigated. Sutter Yuba Homeless Consortium's meeting on Nov. 14 outlined some of the financial shifting that will take place and gave a snapshot of the region's current homeless demographic.

"Our numbers of folks coming to homelessness for the first time continue to rise," said Burke. "Last week was the second highest week for the entire year for the number of intakes that were done. We're hoping that number will go down but it's been a

Public Health Offers Child Safety Seat Help

Butte County News Release

BUTTE COUNTY, CA (MPG) - Butte County Public Health (BCPH) has been awarded an Office of Traffic Safety Child Passenger Safety grant for \$274,000.

The funding enables Butte County Public Health to provide education on the correct installation of car seats and the distribution of no-cost car seats to eligible Butte County residents. The funding also supports training to certify Child Passenger Safety Technicians (CPSTs) in the region. The grant program runs from Oct. 1 to next Sept. 30.

Motor vehicle-related injuries are preventable, yet motor vehicle crashes remain a leading cause of death and disability for children. Butte County data shows that in 2023, there were 1,529 crashes and about 10 percent of those crashes involved children aged 12 years or younger. Properly using age and weight-appropriate car and booster seats can reduce the risk of injury by 71 to 82 percent (Centers for Disease Control and Prevention). Based on inspections done by Butte County Public Health Child Passenger Safety Technicians, approximately 65 to 70 percent of car and booster seats are used incorrectly in Butte County.

To prevent child passenger injuries, Butte County Public Health grant activities for the 2024-2025 year include one-on-one appointments with certified technicians to inspect car seats, child safety seat inspection events and education classes with certified technicians, distribution of child safety seats at no cost to Butte County residents who qualify, following education classes, regionally, train new Child Passenger Safety Technicians (CPSTs) through certification and recertification courses and collaborate with local organizations to train staff on child passenger safety laws and best practices

Butte County Public Health encourages parents and caregivers to take advantage of the grant-funded services to ensure child passenger safety. Chinese Community Awarded Grant

MARYSVILLE, CA (MPG) - Jon Lim and the Marysville Chinese Community are asking residents to mark their calendars for March 1 and 2.

This will be the return of the annual Bok Kai festival, held in accordance with the lunar calendar, in California's last surviving Chinatown of the Gold Country - Marysville.

This year marks Bok Kai's 145th "birthday," an event long touted as the oldest continuously held parade in California and will also commemorate the year of the Wood Snake.

The snake is the sixth animal in the 12-year cycle of the Chinese zodiac and is said to symbolize wisdom, adaptability and renewal, and is associated with themes of introspection and intuition. Likewise, wood is the most "human" of the elements, according to Chinese culture and is associated with the capacity to look forward, plan and make decisions leading to growth

and expansion.

Already, the Marysville Chinese Community is touting this year's Bok Kai as a year for "elegance, wisdom and transformation." It seems fitting then that Jon Lim, president of the Marysville Chinese Community, recently disclosed to the

Territorial Dispatch that he will receive an Engage Empower and Implement (EEI) grant from the Sacramento Area Council of Governments (SACOG) in the amount of \$500,000.

"This is a pilot program grant and we're very excited for it," said Lim. Lim announced that he

would apply for the grant, when he stood before the Marysville City Council on July 2 seeking both their support and partnership. Without the city's partnership, Lim said, grant funds would have been limited to \$80,000.

A partnership opened

very challenging couple of years and this year has not let up for folks entering homelessness for the first time.”

According to data collected by the Sutter Yuba Homeless Consortium, a total of 70 new intakes were done around the second week of November. Intakes from the past month show that the top three most recent reasons for becoming homeless include breakup and or divorce, loss of job or unemployment, and substance abuse, in that order.

“Typically, the top three are fiscal-related things,” said Burke. “But our number one reason amongst all the people who became homeless for the first time and entered coordinated entry was breakup or divorce and that’s particularly troubling because that is something from an organizational standpoint that we really don’t have a way to have an effect on.”

Burke added that it was uncommon to see substance use make it into the top three categories for the initial cause of homelessness.

The consortium’s monthly coordinated entry report showed a total of 222 clients entering into the system through various intake points throughout Yuba-Sutter. Of that number, 143 were new to homelessness and the rest were returning after previously being released from the coordinated entry system. Self-reported survey responses from the newly registered individuals show that 50% have a behavioral health problem, 27% have a substance use problem, 23% suffered from a disability, 13% had encountered domestic violence, 0% were veterans and only 17% were new to the Yuba-Sutter area. Also noted was a shift in income for households without children who are unsheltered. Approximately 36% of those individuals had an income but the monthly average was only \$478.

“Just a few months ago, we always had at least around 50% without children in the household that had an income and that number was starting to run a little higher,” said Burke. “There’s been some sort of change in the last few months where all of a sudden we’re seeing folks who are coming into homelessness for the first time who don’t have children, don’t have any income at all and for those who do, the average number has dropped.”

According to Burke, one of the fastest growing demographics for those entering homelessness for the first time locally is seniors or those over age 55.

“That’s pretty alarming,” said Burke. “But what’s nice about getting all those numbers is that then we can target where we’re gonna do our next programs and housing programs.”

Housing projects that aim to serve this demographic have already been started or are in the works with Habitat for Humanity taking the lead on a 12-unit project in Linda and another future development in Yuba City.

As for Sutter-Yuba Behavioral Health and funding, Proposition 1 will change the Mental Health Services Act (MHSA) into the Behavioral Health Services Act (BHSA). In aligning itself with the new budgeting categories set forth by the Behavioral Health Services Act,

Sutter-Yuba Behavioral Health will see a projected \$2.2 million reduction or redirection of funds annually. The internal programs that might be at risk include Adult Open Access & Urgent Services, Youth & Family Open Access & Urgent Services, Medication Support Services, Hmong Outreach Center, Latino Outreach Center, Wellness & Recovery Center, and Supportive Housing Services. Likewise, at-risk contracted programs include Sutter County Superintendent of Schools WEX & Adult Education, Telecare Supportive Housing Services and Youth For Change (Peer Mentors). Fiscal support for these programs will need to be redirected, reduced or funded elsewhere for them not to be cut.

“There is new funding coming through to the schools that they may be able to use to support some of the school-based programs that have been funded previously with MHSA,” said Anne Robin, a licensed marriage and family therapist with Capstone Solutions Consulting Group. “And your supportive housing services may be able to go into that housing under the new BHSA categories.”

In other news, both Yuba and Sutter counties have been gearing up to implement CARE Court by the first of December as mandated by the state. CARE, which stands for Community Assistance, Recovery, and Empowerment, is a program implemented in California aimed at

providing a structured support system for individuals with severe mental health challenges. Eligible individuals must be at least 18 years old with a diagnosis of schizophrenia or another psychotic disorder and must be considered unable to participate in traditional treatment due to severity of condition.

“It was really pitched by the governor as a way to reduce homelessness, and his administration estimated that there would be between 7,000 and 12,000 people that would be eligible for CARE Court statewide,” said Rick Bingham, director of Sutter-Yuba Behavioral Health Services. “Just to put that in perspective, the last PIT (Point-in-Time) count showed there were 186,000 homeless people in California, so you’re targeting maybe 4 to 6.5% of the total homeless population - not a huge dent.”

Bingham added that only 1% of the general population had a psychotic disorder and while that percentage might be higher in the homeless population, he said there had been a few misrepresentations when it came to CARE Court. He also stressed that individuals suffering from substance use disorders would be ineligible and that the program did not include housing services.

“There’s a little bit of a hurdle in filing the petition too, the petition must include a statement from a mental health professional verifying that the referred individual has a qualifying diagnosis and is not mentally stable,” said Bingham. “So you could be living with someone who has a significant psychotic disorder and could benefit from CARE Court but somehow you have to also get that person to agree to see a mental health professional and if they’ve not been in treatment or don’t want to go to treatment that might be a hurdle.”

With mental health continuing to be a central focus, Peach Tree Health has developed their own street team and mobile crisis unit. This new implementation has two exam rooms and is capable of both in person and telehealth visits. This unit can be brought to various coordinated entry intake points, helping complete the consortium’s “one stop shop” approach for local homeless outreach services. Burke also said that Sutter-Yuba Behavioral Health will contract with a new group referred to as “psych crisis” that aims to be a 24/7 on-call emergency psych unit open to all residents.

“While access (to mental health programs) is expanding we still have a mental health provider crisis,” said Amira Lindbloom, director of community health for Peach Tree Health. “We’re considered a region that has inadequate behavioral health professionals available... I think just knowing where to go is often a barrier for folks.”

Those looking for ways to get involved with the local unsheltered community might consider volunteering for the upcoming Point in Time count. This event will take place from Jan. 27 to Jan. 31 and involves conducting surveys either in person or over the phone with homeless members throughout Yuba and Sutter counties.

“It’s amazing to hear their stories and I’ve never met a single person who regretted doing it,” said Burke.

the door to more funding that will result in a 70/30 split, with approximately \$150,000 going toward the city for administrative purposes and the remaining \$350,000 going to the Marysville Chinese Community.

“It’s a grant to help come up with a blueprint for what the Marysville Chinese Community would want Chinatown to look like,” said Lim. “It gives us a way to have a voice in government, to do things the government can’t do.”

According to the Sacramento Area Council of Governments, this is the first time that the organization has implemented a funding program that encourages

partnerships between cities, counties and local community-based organizations (CBOs) for the purpose of planning more equitable projects together.

“The goal of EEI is to create a pipeline of equitable, safe, and sustainable projects that are developed with communities,” said Rosie Ramos, project manager for Engage Empower and Implement. “The number of applications and total grant requests shows that there is a strong interest in this new type of community-focused planning and development.”

On Nov. 14, the Sacramento Area Council of Governments’ board of directors approved \$3.8 million in funding for 11 projects

across the region, including \$498,049 for Lim and the City of Marysville’s proposal, and another \$500,000 for an Industry Assessment & Workforce Development Strategy proposed by Yuba and Sutter counties in partnership with the Yuba-Sutter Economic Development Corporation.

Over the next 20 years, goals listed by the Marysville Chinese Community include identifying community stakeholders, determining stakeholders’ needs, defining Chinatown’s physical borders and gathering community input. Lim said the plan also includes developing a land use model and design and identifying public and private investment

funding opportunities.

By setting clear borders on Marysville’s Chinatown district, Marysville Chinatown Community members hope to have more control over the look, function and nature of developments being brought into the area and have their ideas added to the city’s masterplan. The proposed blueprint can also set up the community and city to obtain further grant funding.

As for the upcoming Bok Kai celebrations, Lim and his team are actively seeking volunteers, sponsors, vendors and parade entries, specifically marching bands. The parade is scheduled for March 1, 2025, starting at 10 a.m. and fireworks

will go off near C Street around 8 p.m. Lim plans to find other activities to fill the afternoon such as music, dancers and martial arts demonstrations.

On March 2, the following day, Bomb Day will proceed as usual at 4 p.m. and organizers are looking to bring back both the car show and rib cookoff. The Marysville Chinese Community is still accepting applications for the 2025 Bok Kai hostess; eligible applicants must be age 16 or older, 1/8th Chinese and be from the Yuba-Sutter area.

'Festus Feasts' Shoots Pilot Episode in Yuba-Sutter

YUBA CITY, CA (MPG) - A pilot episode for "Festus Feasts," inspired by the Food Network series "Diners, Drive-Ins, and Dives," was filmed at five local restaurants last week on Nov. 13.

The featured eateries include Pasquini's in Live Oak, Council Oaks Steaks & Seafood in Wheatland, and Sopa Thai, Happy Viking and City Cafe off Plumas Street in Yuba City.

"The idea is to feature food districts as opposed to single restaurants," explained John Cassidy, the show's producer. "It was easier for us to start here obviously since we're all pretty local to Yuba-Sutter, but the goal is to take this on the road and feature food districts across the country that people may or may not be aware of."

Cassidy co-hosts the episode alongside Festus Ezeli, a former Yuba College student and National Basketball Association player.

The two met during Ezeli's time playing for coach Doug Cornelius at Yuba College and when Cassidy was doing sideline radio for the Sacramento Kings.

"I would talk to him at games and we became really good friends after he retired," said Cassidy. "He has become a central figure on the pre, half time, and post-game for the Warriors and ESPN used him a lot in the last year because he is just so talented."

Neither Cassidy nor Ezeli claim to be chefs but the two do appreciate a good meal and atmosphere. In the show, Cassidy takes the lead on introducing Ezeli to the individual owners and gives a bit of history on each establishment. Ezeli is then set free to mingle and feast on whatever is brought before him.

"He's so relatable and so charming and just has this natural ability with people," said Cassidy. "To find people who are that good on camera, it's just one in a million and that's part of why he has been so successful in his broadcasting as well."

Cassidy admits to having a bias for the "Salmon Cassidy," a plate at City Cafe that he helped create 26 years ago. He said that the criteria for choosing which restaurants to feature was tough and came down to time, diversity, longevity and, of course, cinematic composition.

"The Plumas Street corridor is probably the best restaurant distinct of any small town in Northern California," said Cassidy. "What we will do in each episode, and when we finalize this one, we will also highlight other restaurants that we didn't visit in the region, that will be part of each broadcast."

Some of the restaurants Cassidy regrettably had to pass on included Sutter Buttes Brewing, Fernando's, Hooligans, The Brick and the Silver Dollar Saloon just to name a few.

After a full day of filming both Ezeli and Cassidy left with full bellies, excited to see what the next step in this journey may lead to.

"I love how food brings people together and builds a sense of community," said Ezeli. "My dream job would be one where I can travel, share incredible meals, and tell the amazing stories of people from around the

world. If I can use those stories to impact how we see and connect with each other, that would be truly fulfilling."

Being from Nigeria, Ezeli grew up with a fondness for traditional dishes such as fufu, garri, egusi soup and bitter leaf soup. Moving to America shifted his preferences toward Mexican food and he credits San Francisco for introducing him to dim sum, which has quickly gained a top spot on his palette.

"If I had to pick a favorite from that (filming) day, it would be Sopa Thai," said Ezeli. "I just love Thai food, all the flavors, the curry's, the spice,

yum!"

In addition to featuring locals at local restaurants, team members and associates of Tower Media Studios were brought on to round out the film crew. Tower Media, headed by Robert "Bob" Fischetti, is a Marysville based nonprofit media and production company which also houses the community radio station 93Q. The assembled team included Tyler Johnson, Lonnie and Kayla Webb, Kert Baird, David Toledo, Prince, Veronica and director Mike Iachella, who has over 40 years of experience with Cassidy in local television and commercial production.

"Everybody pretty much volunteered to do this pilot, we had a few costs associated with it but for the most part people volunteered their time and effort because they see the potential in the concept," added Cassidy.

Once the pilot episode is complete, a viewing party will be held before pitching it to professional networks. Their target platform is of course Food Network and Guy Fieri, with whom Ezeli has a personal relationship.

"Guy is a big Warriors fan, a big basketball fan," said Ezeli. "He used to watch me play for the Warriors, which led to me going on his show as a guest and then going to spend time with his family, and spending birthdays and holidays with them."

If the show gets picked up by a major network this could be a big boon for Tower Media. Fischetti said he is thrilled to be partnering with Cassidy again and will continue helping in any way he can.

"Guy Fieri is a big deal and 'Diners, Drive-ins and Dives' has got to be one of their best shows," said Fischetti. "They need to keep up with that viewership and so this could be the next big thing for them, and for us!" ★

This Month In Your Garden

December is a bit slower month for gardening but there is still gardening to do. The most important task for this month is the second spraying of dormant spray to keep the fungal infections at bay, and that should be done in late December. As mentioned in November, curl leaf on peaches and nectarines is the main target, and it is useful on a host of other things which can be found on the directions for use. December usually brings cold enough weather that frosty and/or freezing cold nights are a possibility. Be sure to watch for frost or freeze warnings and be ready to protect your plants as needed. All citrus trees are vulnerable to the cold weather because they are evergreen and sub-tropical. A light frost will likely damage the leaves of the plant, whereas a hard freeze will cause much leaf damage and fruit damage as well – best to be ready for it. An old blanket can be placed over a plant as long as it isn't apt to rain causing it to get wet and heavy. A blanket would be best used by putting them on at night and taking them off daily in order to be exposed to the sunlight. Frost cloth is a preferred method which works well and can be held in place by tucking it under a few pots or rocks so wind can't displace it, and it can be saved and re-used – just fold or roll it up and put it with other gardening supplies. It also has the advantage of being permeable so rain will go through it and plants still get watered. Adequate sunlight also reaches the plants. Plastic should not be used directly on a plant. It has no insulation value, in fact it can direct the freezing temperature directly to the leaves. Make a temporary frame work with a few stakes several inches from the foliage of a plant and put the plastic over it as a covering, tee-pee style. Or, three to four stakes can be driven a little way into the ground to create an enclosure over which to put the plastic covering. Essentially making a mini greenhouse/cold frame over the tree. The dead air space within has insulating quality. For containerized plants, be sure that they have been very well watered when especially cold weather has been forecasted. A dry plant will freeze more quickly than a wet one. The moisture in a potted

plant will freeze at 32 degrees and roots won't get colder than that because of their insulating blanket of ice. Dry cold can be much colder and damaging. Of course, any delicate foliage on the plant will need to be covered

Bare root fruit tree season is fast approaching. Bundles of bare root fruit trees will start coming in soon. It takes a bit of time to get them all organized once they arrive, but we are usually ready to offer them for sale by late December. Roses will also be here in early December. If you are interested, we have availability lists to help you make choices at the nursery or on our website. Oregon stock with live Christmas trees and dogwoods and other Oregon stock arrived in late October and are ready for sale. You can see that there are lots of possibilities for the gardeners. Many of them are also good Christmas gift possibilities as well.

Lilacs do well in our area and don't require lots of care, but they are especially happy in very cold climates. The flowers they produce are generally larger clusters than those grown in our more temperate climates. To compensate for the lack of very cold weather, try putting ice cubes around the base of the plants several times during the winter to keep the roots colder, as they would be in snowy climates. Poinsettias are a frequent gift at this time of the year. They seem to bloom and fit right into the season with the festive red flowers. If you are given one or buy one, and the pot has a lovely foil wrapping on it, before you water it cut out a circle of the wrap on the bottom of the container, then place the plant on a saucer with a layer of pebbles to hold it out of any standing water – then water when needed. The wrap won't become a reservoir to waterlog the plant and you will enjoy its beauty longer.

Enjoy the Holiday season and hopefully do some gardening too.

How Three Trump Policy Decrees Could Affect California's Agricultural Industry

Voters in California's farm belt, stretching more than 400 miles from Kern County on the south to Tehama County on the north, delivered solid majorities for Donald Trump in this month's presidential election.

They were obviously outvoted in heavily populated coastal and urban counties, so rival Kamala Harris claimed the state's 54 electoral votes. However, it is Trump who will be moving into the White House, and of all California economic sectors, agriculture arguably has the most to gain or lose during his second presidency.

There are three policy issues particularly important to California's farmers that Trump wants to change. If he does what he has promised, one might benefit the industry and two might damage it.

The beneficial change is what California Farm Bureau President Shannon Douglas, in a post-election statement, calls "securing a sustainable water supply."

For years, state officials have been trying, either through regulatory decrees or negotiations, to reduce the amount of water San Joaquin Valley farmers take from the San Joaquin River and its tributaries to enhance flows through the Sacramento-San Joaquin Delta, thus improving its water quality to support fish and other wildlife.

Farmers are miffed that after two wet winters filled the state's reservoirs, state federal water managers still limited agricultural deliveries.

A few days before the election, the state Water Resources Control Board issued the latest version of its water quality plan, but the supposed compromise is being critiqued by both farmers who want to minimize restrictions and environmentalists who demand a crackdown on water diversions.

Trump stepped into the issue during his first presidency, directing federal water regulators to increase agricultural supplies, and is likely to do so again.

Just before the election, Trump described California water policy, in all caps on his Truth Social website, as "INSANE POLICY DECISIONS," which he defined as "the ridiculously rerouting of MILLIONS OF GALLONS OF WATER A DAY FROM THE NORTH OUT OF THE PACIFIC OCEAN, rather than using it, free of charge, for the towns, cities & farms dotted all throughout California."

The two pending issues that could backfire on farmers who voted for Trump are imposing tariffs on imports from China, which could invite retaliatory tariffs on agricultural exports, and deporting undocumented immigrants, who comprise at least half of the state's agricultural workers.

Despite objections from California's Republican congressional delegation, Trump hit China with tariffs during his first term and "China retaliated with import tariffs that target U.S. agriculture," according to a report from

the University of California's Giannini Foundation of Agricultural Economics.

"For almonds and pistachios, the tariffs did not reduce the volume of U.S. exports to China," the report continued. "However, the trade war diminished California exports of walnuts, wine, oranges, and table grapes."

Cracking down on undocumented immigrants has been a bedrock issue for Trump throughout his political career, and he's promised to make good on his deportation pledge immediately after taking office.

For a variety of reasons, the state's farmers have had difficulty finding enough workers to till and harvest their crops in recent years. Immigration restrictions, California's high living costs and the creation of new factory jobs in Mexico are among the reasons.

California has as many as 2 million undocumented residents, many of whom work in industries ranging from construction to agriculture. The full-blown roundup Trump promises would have an immense economic effect on the state, with agriculture arguably the most vulnerable.

When Central Valley farmers were enthusiastically backing a second term for Trump, they undoubtedly were hoping for relief from water restrictions. Yet that could be the smallest impact Trump 2.0 may have on their industry.

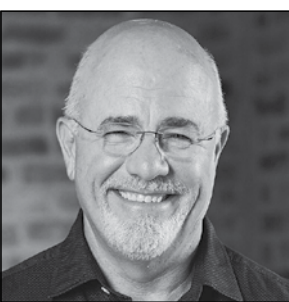

Dave Ramsey Says He Knows What's Best for Us

Dear Dave,

My wife and I are currently on Baby Step 2 of your plan. We attend church regularly, and we've always made sure we tithed 10% to 15% in the past. Do you think it would be okay to lower our tithe while we're getting out of debt and working through our debt snowball?

– Karl

Dear Karl,

When you look up the Hebrew word "tithe," it means tenth. Not 10 to 15 percent—a tenth. I've studied Scripture on this subject for about 25 years and taught in Christian settings. But please keep in mind you shouldn't do this because I gave you a "rule." I'm not the final authority on this. What we're about to get into comes from God.

In Proverbs, it refers to the tithe as first fruits, off the top, before anything else. The book of Deuteronomy says to give a tenth of your net in-

crease. Centuries of protestant Christian teaching has focused on the idea that the tithe goes to the local church, because it's the New Testament representation of the Old Testament storehouse. The storehouse took care of the Levites, which were the priests—or pastors—and the orphans and widows. Today, the New Testament church is supposed to use it for the same kinds of things: pastor's salaries and helping people who are struggling.

Before we go any further, I want you to remember one thing. Tithing isn't a salvation issue. God doesn't love you more just because you tithe a larger amount than the person sitting next to you in church. God loves you. Period. You're His child, and He's going to love you even if you don't tithe. But He knows what tithing does for us. It makes us focus on something other than ourselves. Doing it makes us less selfish, and more selfless. It makes us a little more Christ-like. And he wants us to be

giving and loving to the people around us.

Do you see what I'm saying, Karl? God doesn't need your money. He doesn't need my money. It was my choice decades ago when I hit bottom financially to continue tithing all the way into bankruptcy court and all the way out. But if someone literally can't afford to tithe for some reason—or can't hit 10% and still wants to attend and support a church—I'm pretty sure God understands.

Inflation and It's Causes

Awhile back I suggested that no matter who was elected, the chance of either candidate getting a handle on inflation was slim to none. My opinion of course, but my reasoning is based on 50 years or so of economic study and the subsequent historical events of inflation of a plethora of economies around the world and throughout time.

There are many types of inflation such as demand pull inflation, supply push, scarcity, regulatory and monetary to name but a few. Rather than go off into the weeds on the various causes of all these types of inflation, I will just explain the most insidious and common type of inflation which is monetary inflation.

Monetary means money and money is commonly referred to as currency. Currency is basically a receipt for a good or service obtained from someone else. You buy something, and you get the goods (pun intended) and the seller of whatever it is you received gets a handful of money (currency) that he or she can spend elsewhere whenever and on whatever is it they may desire.

Since currency is always given a specific value, such as one dollar or half a dollar, or whatever, it is essentially a receipt much like you get when you drop off a shirt at a dry cleaners, a car at a repair shop or a chainsaw at a saw shop. The receipt is the proof you have that someone else now has something of yours.

Currency is such a receipt. You furnished something to somebody and the currency replaces that thing with a unit of value that you can then swap later for something else.

Enter the dreaded event of monetary inflation.

Imagine a room full of people and I lock the door and give each person \$1,000 dollars. I then hold up a Rolex watch worth \$5,000 dollars and tell them there is a person outside the room that will give them \$5,000 for the watch as soon as they step outside. I then offer the watch for sale and the only rule is people cannot combine their money with anyone else in the room. The highest bid in the room would be \$1,000 as that is as much as any one person has and they could immediately sell the watch for \$5,000 upon leaving the room, instantly netting a \$4,000 profit.

Now imagine before concluding the sale, I give everyone an extra \$1,000 and restart the bidding. Since they could still sell the watch at a profit, the highest bid would then go to \$2,000 as that is now how much everyone has.

Presto chango.

You have now witnessed monetary inflation. The price for the watch has now climbed from \$1,000 to \$2,000. Keep in mind, the watch has not changed, nor has any other condition in the room. The price for the bidding of the watch has now increased simply because the amount of money in the room has increased.

Now replace the "room" and substitute it with "the economy". Regardless of how many people are in the "economy" (city, state, country or globe as the case may be), the simple economic fact is that if you increase the amount of money in the system, the price for whatever it is for sale increases.

The "increase" in the money supply occurs when an institution who controls the issuance of currency issues *more of it*. Prices of whatever it is for sale in the economic system will increase as well, even though all other conditions remain the same.

In conclusion, the only way to bring prices back down is to reverse the process and *remove money from the system*.

On the grand scale of our economies and our inflation, to decrease the money supply is to first *stop deficit spending*, then remove money from the economy as well. Simply put, that means cutting government expenses, stop government borrowing, and stop creating new money on a grand scale. Unfortunately, that translates, like it or not, to putting the screws down on government spending and its programs, stop governments ability to create (print) new money and kill demand by crushing the consumer's ability to obtain credit.

All that translates into a very unpleasant situation for the majority of those people in it. And considering the amounts of money the global governments have created over many decades, it will be a very long and painful process.

And ain't no one gonna sit still for that.

Like I said, I pity whoever was elected. And please don't shoot the messenger.

Virtual Fencing 'Game-Changer' for Ranchers Grazing Cattle

After the Caldor Fire destroyed 7 miles of fencing on their cattle ranch in 2021, Leisel Finley and her family needed to replace the fence. Finley, a sixth-generation rancher at Mount Echo Ranch in Amador County, learned about a pilot program for virtual fencing that uses GPS enabled collars to monitor each animal's location in near real time. Livestock producers can draw a perimeter on a map of their pasture using a laptop or smartphone application and send those instructions to the collar. The collar then uses audio and tactile cues to contain the animal in the area.

Farm Families Emphasize Importance of Mental Health

The Voice of California Agriculture podcast, produced by the California Farm Bureau, discussed the importance of mental health on farms. Tricia Stever Blattler, executive director of the Tulare County Farm Bureau, spoke with host Gary Sack about losing her husband, Robert, to suicide, and about the need to speak up about mental health in farming communities that face many stressors. "We have to keep normalizing and bringing that conversation forward," Stever Blattler said. The episode also covers efforts in California to combat the oriental fruit fly and a message from the California Farm Bureau

to president-elect Donald Trump and other newly elected leaders.

Port of Oakland Continues to be an Agricultural Export Powerhouse

The Port of Oakland continues to be one of the most important gateways for U.S. agricultural products. As of October, the port has exported nearly \$8.5 billion in agricultural commodities this year, ranking No. 1 in the nation in the volume of international refrigerated exports. "Agricultural exports are especially important commodities for our port's business," said Port of Oakland Maritime Director Bryan Brandes. "In any given year, agricultural products comprise between 37% and 45% of total exports from Oakland." **Probiotics and Prebiotics: Hype or Health?**

Consumers may have noticed a recent trend in food and beverage products labeled probiotic or prebiotic. The products often say they "support a healthy gut" or "boost your immune system" by providing good microbes that are often missing from people's diets. But how can consumers know if these products are really good for them? A new episode of the University of California, Davis, podcast Unfold took a closer look at the proliferation of probiotics and interviewed Maria Marco, a microbiologist and professor in the department of food science and technology at UC Davis. ★

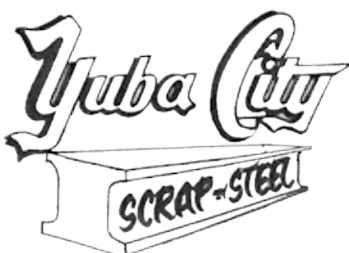

Marysville Man Gets Prison Sentence for Threatening Officer

Yuba County District Attorney's Office News Release

MARYSVILLE, CA (MPG) - Angel Zavala, 27 years old of Marysville, was sentenced Nov. 12 to serve 11 years in prison for threats he made to a female Marysville Police officer on Dec. 26, 2022.

Zavala was convicted in September 2024 after a court trial, in which he was found

guilty of criminal threats, threatening a public official, battery on a peace officer and being drunk in public. Zavala admitted that he had a prior "strike" conviction in 2016 for criminal threats.

This case started on Dec. 26, 2022, with a call about a drunk at the Cortez Room in Marysville. Officers arrived, finding Zavala lying face down outside the bar. Zavala immediately began threatening the

female officer, whom he recognized from prior police contacts. She was initially unfazed but became afraid as his threats became specific.

Zavala told the officer he had been making plans to rape her.

"You don't believe me...? I found your address on Google. I know you live in Auburn in a yellow house. I'm going to" Zavala was reported saying.

The officer, who in fact lived in a yellow house in Auburn,

began to be in fear that Zavala was serious.

Zavala also knew the car she drove. He made graphic threats.

Senior Deputy District Attorney Monique McDevitt prosecuted the case for the People. The officer testified at trial that she was so disturbed by Zavala's threats that she moved. Zavala claimed at trial that he was insane at the time of the offense. Multiple doctors testified and Judge Scrogin ultimately

found Zavala was legally sane when he made the threats.

Judge Scrogin agreed Nov. 12 with the District Attorney's Office that Zavala deserved the maximum punishment and sentenced him to 11 years in prison.

"Officers have to put up with a lot, but they can be victims of crime just like the rest of us," said District Attorney Clint Curry. "I'm thankful for SDDA McDevitt and her zealous advocacy for justice in this case." ★

Wow, major media networks have taken to calling the Sacramento Kings an average NBA basketball team. As a fan of nearly 40 years and living through 16 straight seasons of missing the playoffs, that hurts.

I would almost rather you just called them bad, as opposed to the dreaded average.

Who wants to be average? Just an obscure number in a host of other numbers. No one I know, and I have high hopes that this team as it's assembled, will change this narrative and do it quickly.

After the Kings won three games in a row, I was all but certain that DeMar DeRozan had found his niche and was set to do great things for the Sac Town ballers. However, in the Nov. 24 game against the Brooklyn Nets, I witnessed DeRozan pass up 12-15-foot jumpers, only to pass off to other teammates for less desirable shots.

The past week wasn't kind to the Kings, as they had perhaps their worst one week stretch of the season. The week started with a 109-108 loss to the Atlanta Hawks, in a game that the Kings had in hand, and should have won.

Two nights later, in Los Angeles, the Clippers put on a clinic and embarrassed Sacramento, holding the Kings to a season low 88 points. The only good news was that the game was on the road, and the hometown fans didn't have to witness a second quarter that saw Sacramento score a season low 12 points. The game was decided early, and it was hard on the eyes.

Thinking this game had to be an anomaly, Golden One Arena was filled with expectant fans on Sunday Nov. 24 to welcome back former assistant coach Jordi Fernandez, who captured the head coaching job for the Nets in the off season.

Sadly, it was not to be, as the hometown team turned the ball over 16 times, while missing 11 shots from the charity stripe.

Last season saw the Kings finish dead last in the NBA in free throw shooting, but 10 games into the 2024/2025 campaign they were actually leading the

league in free throw percentage. The game against the Nets saw the Kings take a step back, in a game that was entirely winnable.

In today's NBA nine 3-pointers won't win many games, and in particular if your opponent sinks 19. Combine that with 20 made free throws in 31 attempts, and even without regard to the 16 turnovers committed by the Kings, this game was a real stinker.

Stalwart standouts De'Aaron Fox and Domantas Sabonis showed up as they always do, as Fox contributed 31 points, and was the only player for the Kings that could seemingly hit a three. DeAaron sank 3 of 4 3-pointers while Sabonis gathered in 18 rebounds and added 13 points for another solid double-double.

Huerter continues to struggle in spite of the fact that coach Brown has him in the starting five every night. Kevin went 1-5 from 3-point land, bringing his season average to a startling 29%. His 63% 2024/2025 free throw percentage tells me something is off with Huerter, and I'm convinced that either Keon Ellis or Malik Monk when he returns, would be better options in the starting lineup.

I'm just as convinced that Huerter can overcome his slow start but bringing him off the bench would give him a different look at things, and perhaps ease the pressure just a bit.

The game against the Nets saw a return to coach Brown's difficulties as it relates to coach's challenges. I witnessed no less than three occasions that the Kings could have potentially won a challenge, but sadly the game ended, and coach Brown had yet to challenge a single call.

Yes, Kings fans, the hometown boys have some cleaning up to do, and it's difficult to put a happy face on the games of the past week. Still, one game below 500 is not the end of the world, and with over 60 games to play, let's demonstrate a degree of patience. Let's root them on and see if this squad can come together.

De'Aaron Fox Named Western Conference Player of the Week

SACRAMENTO, CA (MPG)

- Sacramento Kings guard De'Aaron Fox has been named the Western Conference Player of the Week for games played between Nov. 11 and Nov. 17, the NBA announced on Nov. 18. Fox averaged 40.5 points (57.4 FG%, 57.1 3pt%, 81.0 FT%), 4.5 rebounds, 7.3 assists and 2.0 steals in four games over the course of the week.

Fox has now earned Western Conference Player of the Week honors six times in his career, passing DeMarcus Cousins (5) for the second-most Player of the Week awards in franchise history. He led the league in several categories over the past week, including points per game, total points (162), field goals made (58), free throws made (34), total clutch points (21) and clutch field goals made (7).

Fox posted his fourth double-double of the season with 29 points and 10 assists in a win vs. Phoenix on Nov. 13. He followed that up with a 60-point performance vs. Minnesota on Nov. 15, setting the single-game franchise scoring record, shooting 22-of-35 from the field, 6-for-10 from 3-point range and 10-of-11 at the free-throw line. Against the Timberwolves,

Fox scored 33 second half points, the second-most by a Kings player since the 1996-97 season, including 20 in the fourth quarter alone. He then posted 49 points, going 16-for-30 from the floor, and knocking down 14 free throws, to go with nine assists and a pair of steals in a win vs. Utah on Nov. 16. Per Elias Sports Bureau, Fox is the first player to total 109+ points in consecutive days since Kobe Bryant (110, 3/22-3/23/2007), and just the third player in NBA history, also joining Wilt Chamberlain. His 109 points set a franchise record for total scoring

over a two-game stretch, surpassing Cousins (104, 1/23-1/25/2016).

This season, Fox is posting averages of 28.9 points (50.9 FG%, 84.2 FT%, 61.1 TS%), 5.0 rebounds, 5.6 assists and 1.8 steals in 14 games. Among league leaders this season, he ranks sixth in scoring average while tied for seventh in steals per game. Fox is one of four players this season averaging 28.0 points, 5.0 rebounds and 5.0 assists per game while shooting 50.0% or better from the floor and holding a true shooting percentage of 60.0% or higher. ★

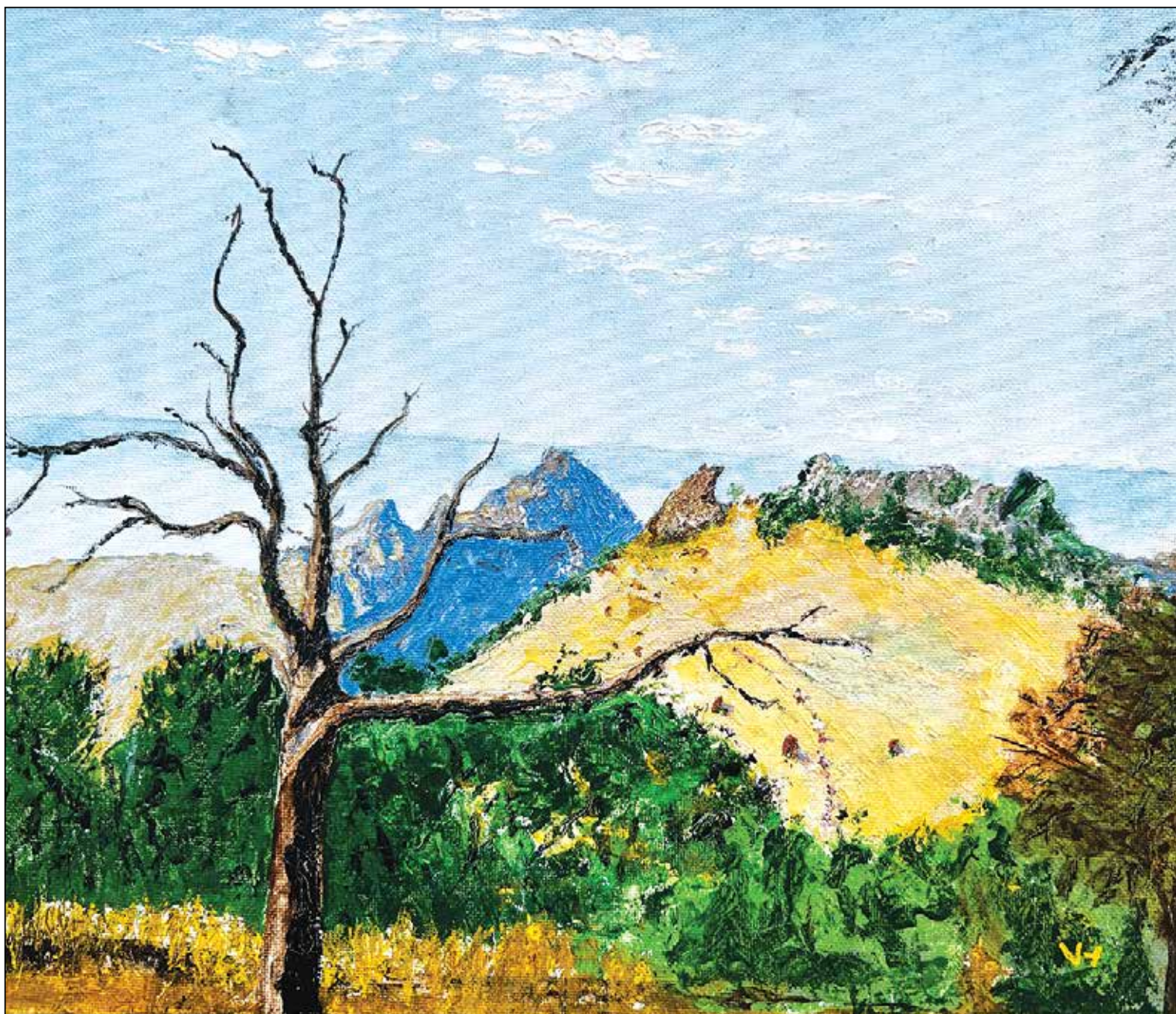
