## Going Mobile Can Be Good Business

GALT, CA (MPG) - Selling food outdoors seems simple: set up a cooktop and a table, put up some shade and a sign, and start cooking.

Following the law and ensuring safety is more involved, though. The location and marketing angles have their twists as

angles have their twists as well.

Keeping the hot food hot and the cold food cold is requirement No. 1,

according to county code

enforcement officials.

Working with clean hands is also a high priority, as are using professional-grade equipment and keeping the food and work area clean and free from flying or crawling critters.

area clean and free from flying or crawling critters.

Home cooks who want to start carving al pastor or making burritos for the public have support from the city of Galt as long as they obtain the proper permits and maintain approved cooking and serving operations. Larger pushcarts and smaller hot dog carts can have a place

in the selling sphere but

these entrepreneurs also

must have permits and inspections to do business in the city.

During a visit by the Herald to Galt's Public Works Department, senior planner Kristyn Bitz showed the Industrial Way/ Pringle Avenue area on a zoning map. This light industrial neighborhood of manufacturing, assembly and auto repair businesses and self-storage facilities is the only zone in Galt that permits itinerant food trucks: those that roll in to feed people and then move on. Other areas of the city parking to three hours.

### Doing the Paperwork

The food trucks that set up regularly in parking lots have done the permit work and made the agreements to cook at these specific spots, and the city regulates the number of trucks per area or intersection.

Some eateries run food trucks in addition to their brick-and-mortar businesses. Those in Galt must get written consent from other restaurants or convenience stores/gas stations

# Future Elections to Be by District

**GALT, CA (MPG)** - After the November election, Galt City Council members will be elected from specific districts rather than from the city as a whole. City Council started the process at its Oct. 1 meeting to avoid a threatened civil-rights lawsuit.

Multiple councilmembers were reluctant to start the change and cited concerns about creating noncompetitive elections. But they agreed that fighting the attorney pushing for the new election system would be a waste of money with little chance of success.

The city of Galt on Aug. 26 received a letter from law firm Shenkman and Hughes. The Malibu-based firm is known for suing or threatening to sue public agencies across the state for alleged violations of the California Voting Rights Act (CVRA), unless they do away with "at-large" elections. The California Voting Rights Act is intended to remedy racial inequalities in voting

Supporters such as Shenkman and Hughes argue that at-large elections, in which candidates can live anywhere in a jurisdiction and are chosen by all voters in a jurisdiction, can allow small majorities of white voters to control all of a city's elected offices, locking out racial minorities, particularly Latinos.

Jurisdictions notified of "vote dilution" affecting a minority must switch to "by-district" elections or face litigation. In a by-district system, a jurisdiction is divided into districts, one for each seat. Only residents of a particular district can run for that district's seat and only other district residents can vote for the seat. This theoretically allows minority groups to elect a candidate of their choice. "There is a low thresh-

old of proof required. Vote dilution occurs when the votes of the protected-class members are outweighed or diluted by the votes of the presumably nonminority voters," interim city attorney Frank Splendorio said. "This can be alleged by a review of voting patterns. You don't have to prove that this is actually occurring."

Continued from page 1 within 350 feet before parking and cooking, Bitz

Edgar Gomez, whose portfolio includes the Tequileros taqueria at Carol Drive and Highway 99, also has full-time food trucks at two convenience store/gas stations in Elk Grove. His mobile businesses follow county code regarding the availability of restrooms to comply with county code for foodtruck personnel. Gomez's rental agreement with the Elk Grove convenience store/gas stations also provides electricity and water, plus refrigeration if needed.

Gomez noted that his trucks also follow county code regarding the use of a commissary to store the trucks, clean them and restock them each day.

#### Galt a Great Draw

Galt is a great draw for food trucks, Bitz said, with the city being on Highway 99. It also has more onand off-ramps than other cities of its size. The code covering mobile food is strict in Galt, although the effort to engage new business is strong.

The city is eager to help food vendors find the right place and time to sell to plentiful customers, Amie Mendes, Galt's economic development director, said

during the Herald's visit. The Saturday Market, Galt Market, and city parades and community events provide more options for local and visiting attendees.

But these events are occasional and mobile vendors are driven to feed more people every day.

Food vendors selling on a public right of way, on private property or without a permit are always on the radar of T.J. Guidotti, who oversees mobile-food operations as part of his role as code compliance supervisor for the city.

Guidotti's method is about education first, compliance next and enforcement after that, if necessary. He counsels small vendors, such as those selling crates of strawberries in parking lots, carts full of frozen fruit bars on sidewalks and one-off snack sellers outside schools. Some individuals are just trying to make a living, Guidotti said, but they must follow code to do business in Galt.

#### **Crossing Jurisdictions**

Monitoring mobile-food compliance crosses jurisdictions, Guidotti said, making it both a challenge and an advantage in his first-responder role. Vendors who set up on a city street or sidewalk can impede vehicle or



mobile-food compliance as part of his duties as code compliance supervisor for the city of Galt.

pedestrian traffic, according to Guidotti. Dealing with trucks or pop-ups on county property sometimes can bring assistance from Sacramento County code officers or Sheriff's personnel. And if a seller is on state property, the California Highway Patrol has helped the Galt code enforcer clear the site.

There is little chance for a quickie setup with an awning, cooktop and cold chests to have the documentation and permits to do business legally, said Sonia Andrusiak, a supervising environmental health specialist for the Sacramento County Environmental Management Department.

Itinerant vendors find business by word of mouth, social media and drive-by curiosity. Their operations do not pay taxes, rent, utilities or employment costs, which is not fair, said Tony Gutierrez, who owns Compadres Bar & Grill in the Raley's shopping center near the Twin Cities Road roundabout. A regular taco pop-up on East Stockton Boulevard north of the circle is set up just outside the city limits, Guidotti said, and under county jurisdiction.

#### **Government Help**

Galt City Councilman Shawn Farmer, a local business owner who advocates for local eateries and their customers, has contacted Sacramento County Supervisor Pat Hume directly on the issue and hears occasionally from constituents who are concerned that non-compliant vendors are harming business for compliant eateries.

"We say to the city that we promote local business, but then we have to do our part to have the city enforce the rules," Farmer

Andrusiak said the county has personnel to respond to reports of noncompliant vendors but not enough people to cover nights and weekends, when pop-ups set up to capture weekend customers at dinnertime or late night.

Andrusiak's team aims to educate the vendors and help them become compliant with the rules of the business. County staff

uses educational storyboards, fliers and postcards to provide the basics. The inspectors also counsel the vendors on-site to correct any violations, including being in the wrong place at the wrong time.

#### **Personal Safety**

Galt planner Bitz said customers who patronize non-permitted food sellers are risking their own safety and health. This goes back to the hot foods/cold foods

The public and other

businesses can report unpermitted vendors by calling 311, Andrusiak said, or by using the GaltConnect app, Mendes

Andrusiak has been in this field for more than 20 years and has seen food trucks evolve from the traditional silvery lunch wagons to the quasi-gourmet food haulers of today.

She patronizes food trucks, Andrusiak said, but only if they have that distinctive, pink permit sticker on the trucks.

San Francisco Chronicle said Shenkman and Hughes has sent at least 175 such letters to agencies throughout California. Most recipients have switched to by-district elections to avoid litigation; no agency that went to court has won its case.

Both Galt school districts have switched away from at-large votes after receiving letters, Galt Joint Union High School District in 2020 and Galt Joint Union Elementary School District in 2022. The city of Elk Grove switched to by-district elections in 2020 after receiving a letter. Cosumnes Community Services District, which provides fire service in Galt, switched on its own initiative in 2019.

Splendorio said Isleton is the only city in Sacramento County that has not received a letter.

City Council adopted a resolution starting the change to by-district votes, and it has 180 days to draw and implement the districts. It will hire a demographer to propose five districts based on the city's population distribution at a cost of about \$30,000. Although the city will prevent a potentially costly court fight, it is required to pay Shenkman and Hughes' attorney fees, up to \$40,000.

In the letter, lawyer Kevin Shenkman cited several past elections as evidence of dilution of the Latino vote. In particular, Shenkman pointed to the unsuccessful City Council

campaigns of Eddy Gomez and Mario Garcia in 2014, who he said received "significant" Latino support but little non-Latino

Councilmember Shawn Farmer voiced concern that switching would result in less competitive elections. He cited the local school districts, which have a total of four seats up for election but just one competitive election, because the other three seats each have one declared candidate.

"As we've seen by the school board elections in our town, which are (by) district, that occurs almost every time in most of the districts, including the race that's going on right now, where only one district is contested." Farmer said.

He noted that residents

might lose representation in City Council votes that pertain to their location, if their councilmember lives too close to the location and must therefore recuse themselves to avoid a conflict of interest.

"It's just going to divide the city," Farmer said.

Mayor Paul Sandhu said the city is doing nothing wrong "but sometimes we have to compromise." He said changing to by-district elections would save the city millions of dollars.

Vice-Mayor Rich Lozano said by-district elections create the possibility of electing a councilmember who only cares about their own area.

"Tell me how you are going to develop policy, being one person, one district, on something that's not in your district?" Lozano said.

During public comment, Galt resident Jerry Sauter said he worried about noncompetitive elections but he acknowledged the potential cost of not switching.

Galt City Council candidates Tim Reed and Bonnie Rodriguez said the switch would have a negative impact. Reed said he and the other current City Council candidates do not live close together, which he said would have resulted in a noncompetitive election under a by-district system.

Rodriguez spoke about the 2014 City Council candidates cited by Shenkman, saying that the two lost because they did not actively campaign. She urged the city to "make (Shenkman) actually work for" the legal fees before complying.

Contacted by the Herald, Shenkman said his law firm identifies voter dilution using a statistical technique that involves taking the number of voters in each precinct with Spanish surnames and comparing that to the vote totals for a given candidate.

Shenkman said by-district elections result in more competition, in aggregate, than at-large votes, because a candidate has to reach fewer voters to win.

"Overall, there are more candidates that run, not less," Shenkman said.

City Council passed the resolution by a 4-1 vote, with Farmer opposed.

The 2024 election is not affected by the resolution; the city's first by-district election will be in 2026, when three seats will be up for votes. The remaining two seats will come up in 2028.


Williams got an enthusiastic cheer from audience members when she was introduced. Williams said she was shocked to be chosen

## Kings Korner By V.G. Harris



The wait is finally over and once again a frenetic group of nearly 20,000 fans will hear the introduction, "and now running the point for the Sacramento Kings from the Kentucky Wildcats, De'Aaron Fox!"

On Wednesday night for the very first time Sacramento fans will hear the introduction of newcomer DeMar DeRozan out of the University of Southern California. DeRozan, like many of his comrade's, chose to bolt to the NBA after just one year in college, and the ninth overall pick in the 2009 draft has been an overwhelming success ever since.

Drafted by the Toronto Raptors, DeRozan spent nine years in Canada before a short stint in San Antonio, and then on to Chicago. Traded for Kawhi Leonard, DeRozan had to watch from San Antonio as the Raptors captured the NBA title in 2019.

Many pundits were wildly surprised that of all the destinations and the high interest in his service, DeRozan chose Sacramento as his next home. Since then, he has said all the right things, and like many NBA fans, I believe he will fit in extremely well alongside De'Aaron Fox and Domantas Sabonis. Great players are replete, but great people and

great players are a scarce commodity. Mr. DeRozan brings both qualities to a team that is replete with team chemistry, and like most Kings fans, I want to see what Monte McNair's standout acquisition can do.

It is entirely possible that amid all the hype, Kings fans may have to be patient while the big three learn to play alongside one another, but I firmly believe that this six-time all-star will make the transition quickly.

Able to play guard or small forward, much has been reported about the uptick we are likely to see with regards to better looks for Fox, Sabonis, and three-point shooter Keegan Murray.

Lost to some degree in all the uproar of the signing of DeRozan, is how third year hoopster Murray will use DeRozan's talents to get better looks, and more opportunities to drive the lane.

I was impressed with Keegan's introduction of a true mid-range game last season, and along with some notable shooting inside the three-point line, like former teammate Harrison Barnes, Murray became a threat driving to the basket.

The combination of Murray's threepoint shooting, mid-range game, and ability to go to the hole, will have a positive impact on DeRozan as well, and I expect to see this career 21 points per game player, potentially pad that number in the upcoming season.

Not to be overshadowed, Domantas Sabonis could elevate his game even more with the myriad of scoring ability around him, and a return to the high octane offense that led the NBA two years ago may well be in the offing.

It remains to be seen what the loss of defensive minded Jordi Fernandez will do to the Kings, and without question assistant head coach Jay Triano will have big

Fitting that Sacramento's first opponent of the preseason will be archrival, The Golden State Warriors, and like the Kings, the Warriors will bring a vaunted offensive into Golden One.

Notably missing Wednesday night will be perennial three-point shooter and other half of the splash brothers, Klay Thompson, who has now donned royal blue colors of the Dallas Mavericks.

Joining all-stars Luka Doncic and Kyrie Irving, Thompson hopes to reignite a career that took a two-and-a-half-year hiatus after suffering back-to-back injuries to his ACL and Achilles.

It's important to note that Thompson helped the Warriors to an NBA title in his comeback season of 2022, but the past two years have seen Klay a step slower, and his offense not as reliable as it once was. At age 34 the 6'6" Thompson may still have more in the tank, but we won't witness that until the Mavericks come to town on Dec. 30.

Hitch up your britches Kings fans. We are in for a different look than perhaps this team has ever presented, and it's going to be a fun ride.



Last Sunday, I admitted to my Nevada City congregation that I sometimes feel like the man who had had enough with life's difficulties, so he went to live in a monasterv.

The abbot restricted the man's spoken words to only two words every year.

After his first year, he reported to the abbot to share his first two words: "Bed

On his second annual opportunity, he pronounced, "Food bad."

Finally, on his third year, he came to the abbot's office to proclaim, "I quit."

"I'm not surprised," said the abbot. "You've done nothing but complain since the day you arrived."

Well, I don't want you to think I complain too much, but I once spent a few days fretting over lost keys, car repairs and my daughter's somewhat risky international travel to Honduras.

On those occasions, "Mrs. Chaplain," (that's what I call her when she's not around) asked, "Have you prayed about

## Don't Talk About God **Behind His Back**

"At this point," I said, "honestly, my prayers would sound more like complaining."

"What's wrong with that?" she asked.

I took a few minutes to think about her challenge when I remembered a guy who did a fair bit of complaining himself:

You remember Moses. He's the one who bugged, literally bugged, the Egyptian Pharoah to free the Jewish people from slavery. Once the people were liberated, Moses ran his egress route through the oppressive heat of the Sinai Desert.

The people quickly forgot their wonderful freedom and started whining about the lack of good Chinese takeout. (OK, maybe they weren't that picky, but they were a bit famished. Read the complete story in Numbers 11.)

So Moses, also resenting his situation, asked God, "Why are you treating me this way? What did I ever to do to deserve this? Where am I supposed to get meat for all these people?"

He continued. "If this is how you intend to treat me, do me a favor and kill me. I've had enough."

Just an observation here: I don't recommend daring God to kill you; it's not a prayer for the faint of heart.

Nevertheless, God threw down a challenge of his own and said to Moses, "Gather together 70 men from among the leaders of Israel, men whom you know to be respected and responsible ... (and) you won't have to carry the whole thing alone."

In the end, Moses wasn't struck dead for his audacious request. Quite the opposite. God answered the prayer - providing a little help from Moses' friends.

Now, I don't pretend to know how prayer works, but I think Moses' prayer was effective for two reasons.

First, the prayer was simple and direct. It wasn't a flowery prayer packed with analogies, metaphors or obtuse tangents.

God likes direct words. (He also dislikes dictionary words like "obtuse.")

Whenever I encounter someone complaining about their raw deal, I've always told them: Stop gossiping about God. Talk to God directly, not behind his back.

Go right up to God (wherever you talk to God) and say, "Hey, God! My life

Then turn it into the prayers Anne Lamott describes in her book, "Traveling Mercies."

"Here are the two best prayers I know:

'Help me, help me, help me' and 'Thank you, thank you, thank you."

Moses' simple prayer worked because

God heard the heart of the prayer: honesty. In the midst of the griping, God heard a confession known by anyone in a 12-step recovery process.

It's a prayer that has various wordings, but the gist is, "I'm powerless to do anything by myself. I need help."

It was the same kind of prayer my wife was challenging me to pray.

A little later, she asked, "Find your keys

"No, but I think God's given me a plan to find them."

"Really?"

"Yeah. How do you feel about having 70 readers come over and help me look for my keys?"

"Really? After 23 years of column writing, do you still claim to have at least 70 readers?'

I think I'll start calling her "Mrs. Moses "

Just not to her face.



### **CSD Saw Surplus of \$9 Mil in FY 2023-24**

ELK GROVE, CA (MPG) - The Cosumnes Community Services District (CSD) netted a General Fund surplus of nearly \$9 million in the previous fiscal year, the board of directors heard at its Oct. 2 regular meeting.

Cosumnes Community Services District Budget Manager Jillian Chavez presented the preliminary report on the budget performance in fiscal year 2023-24, saying the results were boosted in large part by strong investment returns. The unaudited results cover the period from July 2023 through June 2024.

Chavez highlighted several bright spots in the report, including roughly 5% growth in property tax revenue, and annexations to its community facilities districts to support the Mello-Roos tax base. High interest rates caused a short-term boost in the district's investment gains, and income from the Measure E sales tax is beating expectations.

The district faces various challenges as well, Chavez said. Despite having some benefits, the high interest rates have discouraged people from selling their houses, and the reduced housing market churn limited the rise in property tax income. Chavez said Elk Grove Unified School District has begun providing free preschool, which outcompetes the district's offerings. Administrative requirements, supply chain delays and employee retention also pose problems.

Higher-than-expected revenue and lower-than-expected expenses meant that the General Fund balance after quarter 4 was \$8.8 million higher than predicted. The majority of the extra revenue is due to historically high interest rates, which Chavez emphasized is a volatile fund source.

Expenditures were \$5 million lower than expected. This was largely because the district had a lower retirement liability payment because of good investment returns, and it saw the results of a cost-saving program in the Recreation Division.

Funds from Measure E, received from the city of Elk Grove, exceeded expectations by \$1.9 million, reaching a total of \$10.3 million. Spending from the fund was below projections by about \$3.3 million, which Chavez said was due to previously approved purchases being delayed by supply chain issues. The district is setting that savings aside to eventually complete the purchases.

Director Gil Albiani asked whether the district could reach an agreement to receive reimbursement from EGUSD for the preschool students that Cosumnes serves.

"We already have a symbiotic relationship. Just seems like this is another area that somebody ought to explore," Albiani said. Chavez said district staff had a meeting planned with the school district to discuss options.

Albiani also praised the district's financial footing and quality of its services.

Director Peter Sakaris asked whether the district could allocate some funds to the CORE recreation center under construction, something Chavez called possible. The board did not act on the suggestion.

The board approved the report by a 3-0 vote. Board President Jim Luttrell and Sakaris abstained.

Assistant Fire Chief Robert Kasparian spoke about the launch of an emergency medical services unit, EMS 71.

Implemented on Oct. 1, the program converted day-shift EMS personnel to a 24-hour schedule that will allow round-the-clock service.

A staff member on this schedule serves two 24-hour shifts followed by four days off.

With the new schedule, the unit will respond more quickly to EMS equipment needs and provide additional support during emergency responses, Kasparian said.

The unit will be able to visit any hospital in the county to assist crews waiting for a patient to be admitted, such as by bringing food and helping with the admission process.

Kasparian said the unit would allow the department to provide EMS education at fire stations, rather than bringing crews to a central training center, and the unit may eventually help with transporting patients to destinations besides hospitals, such as mental-health facilities.

The board voted to cancel its Oct. 16 regular meeting. The next meeting is scheduled for Nov. 6. ★
