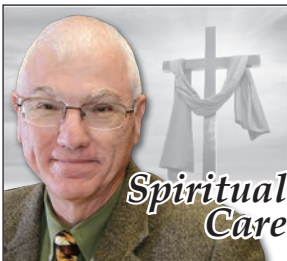

Influencer's Car Show Drives Toy Giving



Local car enthusiasts combined their love of cars with a desire to give back to the community by donating toys at the Toxic World Toy Drive at the Elk Grove Dodge dealership on Dec. 22.

ELK GROVE, CA (MPG) - For the second year in a row, the Toxic World car club spread holiday cheer by holding its annual car show toy drive on Sunday at Elk Grove Dodge.

Elk Grove resident

Baldeep Singh, founder of Toxic World, said when the group was formed in November 2023, the word “toxic” in the name was a reference to the amount of toxicity the members perceived in everyday society. Their goal then morphed into using the club to help ease that toxicity by

bringing together their passion for cars, motor-sports, bikes and local communities.

It then spun into charity events and toy drives for children.

Singh said that in the previous year’s event, he based it off his personal brand, ToxicHawkk, and

had gained over 250,000 followers all over social media which helped support the formation of the event.

“The growth from last year’s event to this year has been exponential,” Singh said. “We have a lot of supporters in the Elk

Menorah Lighting Celebrates Hanukkah

ELK GROVE, CA (MPG) - Just a few days before the start of the Hanukkah festival, Jewish families and others from the community gathered at the Old Town Plaza on Sunday, to remember one of the most important events in the faith’s history.

The third annual event was hosted by the Chabad of Elk Grove, and co-sponsored by the City of Elk Grove and was intended to help celebrate and commemorate one of the Jewish faith’s most important stories: the lighting of the menorah and the rededication of the second Jewish temple.

“This is a prayer or blessing for the candles,” Erica Cassman said.

The story behind this occasion harkens back to when Antiochus IV, the Seleucid Greek ruler, wanted the Jews to stop practicing their religion and worship the Greek god Zeus. Jewish warriors called Maccabees revolted against Greeks during the second century BCE and were able to rededicate their temple.

They wanted to relight the menorah, the multibranched Jewish candelabra, in the temple for the eight-day celebration, however, it was believed that there was only enough pure oil for one day. As the story goes, it miraculously lasted the entire eight days.

The tradition was again honored in Elk Grove with the lighting of a nine-foot LED menorah and attendees singing “Ma’oz Tzur,” a Hebrew poem from the 12th or early 13th century. Translated from Hebrew, it means, “Rock of Ages.”

Hanukkah started on Wednesday and runs through the upcoming Thursday.

“This is a time to be kinder to each other,” Elk Grove resident and event organizer Rabbi Chaim Groner said. “To be better.”

Before the official menorah lighting, attendees danced to lively Hanukkah music. Children were also able to select a balloon

Cleaning Up at the Special Waste Center

ELK GROVE, CA (MPG) - What is blue, green, black and all over Elk Grove? Answer: Carts for recycling, organics and garbage.

Good for you, Elk Grove residents. You have used these bins from Republic Services for separating household and yard waste. You are getting accustomed to depositing food scraps in the kitchen pail

provided.

“Changing our behavioral habits isn’t always easy but the extra effort has had a direct impact on our environment,” said Kimberly Taylor, the city of Elk Grove’s recycling and waste manager.

How has this program been doing? “To evaluate if it is working, periodically 1,000 pounds of recycling and organic material is dumped out and analyzed to see if customers

are separating according to the new rules,” Taylor said. “Though the sorting rate is not where we want it to be yet, it has improved considerably since its institution.”

In addition to curbside collection, Elk Grove residents can also reduce, reuse, recycle and safely dispose of materials at the Special Waste Collection Center.

Family Hits Jackpot for Charities at Giving Machine

SACRAMENTO REGION, CA (MPG) - Seven is a special number for Kelvin and Leslie Moss of Granite Bay. They have seven children, and their last child was nicknamed “Seven.” And, on the night they went to the Sacramento area’s charitable vending machines, there were seven members of their family present.

And sevens are especially lucky for struggling individuals and families in the greater Sacramento region who are suffering financially or emotionally, and the gifts are designed to provide food, comfort, counseling and other services to help them on their path toward self-reliance. The Moss family knows a bit about suffering emotionally, as they lost three of their sons to accidental deaths in the past four years.

“We didn’t know we’d do this until we got there that night. We had seven children, and seven of us were at the Giving Machines that night. It just felt right to choose 777,” mother and grandmother Leslie Moss said. “We really felt we hit the jackpot for our community. It was a great night.”

Light the World Giving Machines, sponsored and financed by The Church of Jesus Christ of Latter-day Saints, are at the Westfield Galleria at Roseville for a third year and are filled with cards detailing charitable gifts.

When one item is purchased, the card falls to the bottom, just like a candy bar drops when purchased at a vending machine. Joining Kelvin and Leslie at the Giving

Machine were son-in-law Eric Stratton and four grandchildren.

“It was really fun to see every single card drop to the bottom one by one,” said Leslie. “The kids would shout as they dropped: ‘Someone is getting new underwear!’ ‘Someone is getting diapers for their baby!’” And so on, she says, until all 30 cards dropped.

Twenty-five of the 30 gifts are for individuals or families in the greater Sacramento region who are suffering financially or emotionally, and the gifts are designed to provide food, comfort, counseling and other services to help them on their path toward self-reliance. The Moss family knows a bit about suffering emotionally, as they lost three of their sons to accidental deaths in the past four years.

“Our grandchildren were really on board with this, in giving to others who are less-fortunate and suffering at this time,” Leslie said. “They wanted to make sure that heaven could be involved, that their uncles could be there, too.”

Before heading to the Giving Machines, Grandma and Grandpa talked to the children about what the Giving Machines are all about and to think about the specific gift they wanted to choose for a needy person or family.

“We talked about how usually with a vending machine you get something for yourself, but with the Giving Machine, this time you are getting something to help someone else,” Leslie said. “They were so thoughtful about why they chose that specific gift.”

Bennett, 14, chose suicide prevention therapy from Lighthouse Counseling & Family Resource Center because “it’s the gift that will keep giving,” Leslie said. Lighthouse, based throughout Placer County, provides counseling, educational classes and programs and assists clients in obtaining resources to help them through a challenging time. The other gifts in the Giving Machine for Lighthouse that the Moss family also purchased are child abuse and domestic violence prevention counseling sessions, one week worth of diapers for a single mother with a newborn, and a three-day supply of emergency food.

Winston, who goes by Win, is 8 years old, and he chose three days of safe shelter for a family or individual in need, provided by Catholic Charities throughout the Sacramento region. Win chose that, Leslie says, “because whenever he sees a homeless person, he feels so sad for them and wants to help take care of them.” Other gifts for Catholic Charities are an infant care kit for a new mother, a “dress for success” gift that provides a job seeker a new outfit, one week of food for a senior experiencing food insecurity, and job training for someone entering the workforce.

Daisy, 5, “couldn’t bear to think about someone going to bed without a blanket and a pillow,” so she wanted to give the “Pillow & Bedding” provided by Al-Misbaah Charitable Aid, Leslie said. The Sacramento-based charity has helped

numerous refugees and vulnerable families get established in Northern California. The other gifts for Al-Misbaah are socks and hat for someone who needs the extra warmth, a hygiene kit to help a community member stay clean, a backpack filled with school supplies for a student, and a bicycle for a child for exercise, adventure and to ride to and from school.

Daisy’s twin brother, Freddy, “loves to play soccer, and he couldn’t figure out how any child could go without a soccer ball,” Leslie said. So, he chose the gift of four soccer balls for a school to help teach students teamwork and promote fitness. That gift is offered by Right to Play, a global charity that helps children in impoverished nations thrive by promoting the “power of play.” The other gifts in the Giving Machine purchased are 20 storybooks for primary schoolchildren and menstrual hygiene kits to help female students stay

in school.

The Moss family purchased all those gifts, along with others from three other charities. They are:

First Step Communities in Sacramento and Roseville, which provides interim housing and emergency shelter in the Sacramento area and Roseville.

Their gifts in the Giving Machines are a kit of hygiene essentials, new underwear, a warm blanket and pillow, a winter coat and 100 laundry vouchers.

Rancho Cordova Food Locker’s Community Food Hub, whose gifts in the Giving Machines are two gallons of milk for children, an emergency weekend food pack for students, a one-month supply of fresh produce for a family, a kit of essentials to feed 10 senior citizens, and a group cooking class to teach 25 families cooking techniques and nutrition principles.

The global charity Academy for Creating

Enterprise, which provides business opportunities for individuals and families in impoverished countries. The two gifts in the Roseville Giving Machines are a basket as a way to carry goods for a new business owner and, probably the most unique gift in the machines, two piglets to help a family start a business.

“It was just an awesome experience for us to give to so many people at the same time,” Leslie said. “We hope to do again next year and make it a family tradition.”

The Light the World Giving Machines are located on the first floor of Westfield Galleria at Roseville, near the giant Christmas tree. The Giving Machines will keep giving through New Year’s Day.

such as batteries, which can start fires; paint; small or large electronics, or aerosol cans to get rid of? How about tires? Hypodermic needles? Medications? Fat, oil and grease? Fire extinguishers? Fertilizers?

There are specific instructions for disposing of these items and sometimes special days for bringing them in. For a list of acceptable and unacceptable items, go to elkgrovecity.org/recycle.

As of Dec. 1, Styrofoam is not accepted at the Special Waste Collection Center.

In the Recycling Area that is open to the public are large, labeled dumpsters for cardboard (in 2023, 120 tons of cardboard was recycled by the facility) metals and green waste that doesn’t fit in your home container. There is also a covered area for donating clothes and shoes.

Carlos Duque, the Waste Program coordinator who oversees the Special Waste Collection Center

Operations, is especially proud of their new aerosol can crusher.

“This machine extracts the remaining liquid and then can safely smash the cans into small units,” Duque said.

Clean and green definitely applies at this recycling facility.

The site has LEED (Leadership in Energy and Environmental Design) Gold Metal certification for sustainable design using green power, water and energy savings, and air quality.

Full protective gear is worn by employees who handle dangerous materials, and exhaust fans over workstations vent out fumes. A training course

and medical evaluation precedes staff hiring. Anti-fatigue mats help workers with standing for extended periods.

Sam Iverson, site manager, runs the day-to-day operation, and he manages seven employees and interactions with the public. Iverson and other employees identify and sort the recyclables and package materials for shipment. If a substance comes in without identifying information, it is thoroughly tested to decide what it is and what category it should be placed in for proper disposal.

One perk for Elk Grove residents is a “store” of safe salvaged items. Residents can choose up to

10 products or objects per month free of charge.

It is surprising what residents throw away. The office has a collection of old items, such as a lineup of antiquated cell phones

from the first model made in 1985.

Take recyclables to 9255 Disposal Lane, Elk Grove, from 9 a.m. to 4 p.m. Saturdays through Wednesdays.

City Provides Options for Recycling Holiday Trees, Lights

City of Elk Grove News Release

ELK GROVE, CA (MPG) - Choose a method to dispose of your tree from these options:

1. Curbside Collection

On your green waste collection day, leave your holiday tree curbside next to your gray green-waste cart by 6 a.m. the weeks of Dec. 31, (excluding Jan. 1), Jan. 14 and Jan. 28. If your tree is taller than six feet, cut it into 3-foot or shorter pieces.

2. Green Waste Cart

After cutting your tree into 3-foot or shorter pieces, place those pieces in your gray green-waste cart. Make sure the trimmed pieces fit completely into the cart with the lid closed.

3. Self-Haul to Elder Creek

Take your holiday tree, free of charge, to the Elder Creek Transfer and Recovery Station at 8642 Elder Creek Road, Sacramento, between Florin-Perkins Road

and Watt Avenue.

4. Self-Haul to SWCC

Take your holiday tree, free of charge, to the Special Waste Collection Center at 9255 Disposal Lane, Elk Grove 95624. Open Saturday to Wednesday 9 a.m. to 4 p.m.

Holiday String Lights

Recycle indoor/outdoor string lights at Elk Grove City Hall, 8401 Laguna

Palms Way, from 8 a.m. to 5 p.m. Monday through Friday.

Or take them to the Special Waste Collection Center, 9255 Disposal Lane, from 9 a.m. to 4 p.m. Saturday through Wednesday.

Lights from holiday decorations such as inflatables must be removed before they can be recycled.

Other materials from items including metal, plastic, fabric etc. should be thrown away or recycled separately.

Grove area, and it only gets better because it helps give back to the community.”

Singh added that the car club also participates in other events throughout the year, but the toy drive is their biggest one. The club also plans to do an event that is geared towards teen mental health, Singh said.

Several vehicles were on display. One motorcycle had a stuffed animal of Knuckles the Echidna from the “Sonic the Hedgehog” game series on display. A few exotic cars were also there, such as a Lotus, two Lamborghini cars and a McLaren 720S.

The number of toys increased as time passed, with many beginning to pile up inside the dealership. Inside, a Jeep Grand Cherokee displayed the ToxicHawkk logo. The cars in the lot exhibited were decked out in Christmas revelry, decorated to correlate with the holiday season, including antlers and red noses, and cars with Christmas lights on the decor.

Henderson Known as an Electrifying Legend of the Game

National Baseball Hall of Fame News Release

SACRAMENTO REGION, CA (MPG) - Rickey Henderson used the ultimate combination of power and speed to break numerous major league baseball records during his career.

But what solidified his place in baseball history was his love for the game.

Henderson died on Dec. 20, at the age of 65. His enthusiasm for the game manifested itself in 1,406 stolen bases – by far the best total in history.

“Rickey Henderson was not only the greatest base stealer of all-time, but one of the most memorable personalities of his generation,” said Jane Forbes Clark, Chairman of the Board of the National Baseball Hall of Fame and Museum. “The enthusiasm and energy he brought to Cooperstown each year will truly be missed. Our thoughts are with his wife, Pamela, and their family.”

Born on Dec. 25, 1958, in Chicago, Ill., Henderson spent most of his childhood in Oakland, Calif. An All-American running back in high school, Henderson turned down multiple football scholarships to sign with the Oakland Athletics in 1976.

In his first full major league season 1980, Henderson broke Hall of Famer Ty Cobb’s 65-year-old American League stolen base record of 96 with 100 swipes. In 1982, he stole 130 bases, breaking Hall of Famer Lou Brock’s modern era major league single-season record of 118.

“He’s the greatest leadoff hitter of all time, and I’m not sure there’s a close second,” said Billy Beane, senior advisor to the Athletics and the team’s former long-time general manager.

He played for nine teams over his 25-year career including the Athletics, Yankees, Padres, Mets, Red Sox, Dodgers, Angels, Mariners and Blue Jays. He led the American League in steals 12 times and went on to be the all-time record holder with 1,406 thefts, earning him the nickname “Man of Steal.”

“It wasn’t until I saw Rickey that I



understood what baseball was about. Rickey Henderson is a run, man,” said Athletics teammate Mitchell Page. “That’s it. When you see Rickey Henderson, I don’t care when, the score’s already 1-0. If he’s with you, that’s great. If he’s not, you won’t like it.”

His speed wasn’t his only skill. Henderson set all-time records for runs scored (2,295), unintentional walks (2,129) and leadoff home runs (81). The 10-time All-Star won the MVP Award in 1990, leading the American League in runs scored, stolen bases and on-base percentage. He finished in the top 10 in MVP voting five other times.

“He was one of the best players that I ever played with and obviously the best leadoff hitter in baseball,” said Hall of Famer Dave Winfield.

Henderson won two World Series during his career, in 1989 with Oakland and in 1993 with Toronto. He spent most of his career in left field and won a Gold Glove Award in 1981. He finished with a .279 batting average, 3,055 hits and 297 home runs. He electrified crowds with his flair and enthusiasm for the game.

Henderson was elected to the Baseball Hall of Fame in 2009 on his first appearance on the Baseball Writers’ Association of America ballot.

“If my uniform doesn’t get dirty, I haven’t done anything in the baseball game,” said Henderson. ★

Stay Safe in the Cold

Sacramento County News Release

SACRAMENTO COUNTY, CA (MPG) - With temperatures staying cool this week, it's a great time to review cold weather tips.

Check on elderly family members, friends and neighbors. Seniors and those with serious medical conditions are at risk. Check on community members who might be vulnerable to ensure they are safely keeping warm.

Bring your pets inside when temperatures start to dip near freezing. A dog or cat left outside in severe cold weather can quickly die from exposure. Except for exercise and walks, all dogs and cats are safer indoors during the winter.

Make sure your pets have a warm, draft-free place indoors with a dry mat or blanket that they can lie on. For additional winter weather tips for animals, check out the Bradshaw Animal Shelter's website at animalcare.sac-county.gov.

Heat your home safely; carbon monoxide is a silent killer. It is not OK to heat the inside of your home with any kind of barbecue, propane heater or any other fuel-fired equipment, due to the risk of carbon monoxide poisoning. Only use heaters installed with your home and those designed to be used indoors. Make sure that your natural gas furnaces and other appliances are in good, clean working order.

Insulate outdoor pipes that lead into your home to prevent freezing. Seal with caulk around the pipes that lead into and out of your home. Inside your home, leave the bathroom and under-sink cabinets open

to help warm the water. If your pipes freeze, leave your tap on and call a plumber. You can defrost your pipes using a hair-dryer on a low setting, working your way slowly from the faucet to where your pipe enters the wall. County residents who need to have their water turned off in order to make repairs to their lines can go online or call 311 (or 916-875-4311 if calling from out of the area).

Ensure proper drainage by scooping up leaves and debris. Keeping storm drains clear can prevent street flooding and black ice from forming.

When it is raining, reduce your vehicle speed. Wet roads increase the distance and time needed to stop your vehicle. Be extra cautious on roads, bridges and overpasses when temperatures are 32 degrees or below because of black ice; slow down and give yourself extra spacing between vehicles in front of you.

Watch for tree limbs. As temperatures dip, trees become vulnerable to limbs snapping. For downed trees or branches in the roadway, county residents can go online or call 311 (or 916-875-4311 from out of the area).

Prepare for wind. Secure yard items that could blow around and be prepared for the possibility of loss of power. For downed power lines, stay away and immediately call 9-1-1.

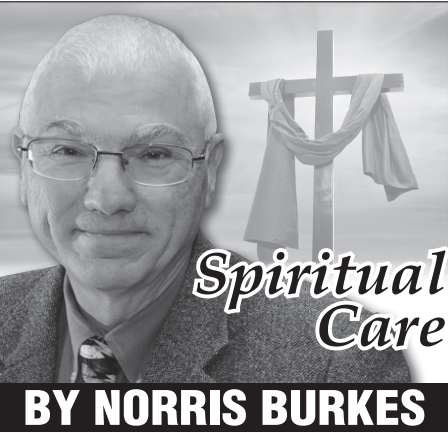

California Implements Key New Laws in 2025

SACRAMENTO, CA (MPG) - Starting Jan. 1, many significant new laws will go into effect across California, impacting everything in daily life from traffic regulations to employment, housing to healthcare.

Traffic Laws

Senate Bill 1107 will raise the minimum auto liability insurance requirements for California motorists. Currently, drivers must carry liability coverage of \$15,000 for injury or death of one person, \$30,000 for injury or death of multiple people, and \$5,000 for property damage. Beginning Jan. 1, these requirements will increase to \$30,000 for bodily injury or death of one person, \$60,000 for multiple persons and \$15,000 for property damage.

Assembly Bill 413, commonly known as the

"Daylighting Law," will take effect in 2025, banning drivers from parking within 20 feet of a crosswalk. This law aims to improve pedestrian safety by providing clearer visibility at intersections. The law applies to both marked and unmarked crosswalks, and while cities are working to implement signage and curb markings, not all areas will have red-painted curbs in time for the new rule.

Senate Bill 905 closes the "locked door loophole" in California’s auto burglary laws. Under the new law, prosecutors no longer need to prove that a vehicle was locked in order to charge someone with burglary. Instead, they only need to show that forcible entry occurred. The change is expected to make it easier for victims of car break-ins to pursue legal action, with felony convictions carrying penalties ranging from 16 months to three years.

Employment Laws

A statewide minimum wage increase will take effect on Jan. 1, raising the rate to \$16.50 per hour for all employees, regardless of company size. This adjustment is based on a cost-of-living provision built into California’s minimum wage law.

Senate Bill 1100 prohibits employers from requiring a valid driver’s license for job applicants unless driving is a core function of the role. Employers must also demonstrate that using alternative transportation would not be comparable in travel time or cost.

Housing Laws

Assembly Bill 2347 introduces stronger protections for renters by extending the timeline for tenants to respond to eviction notices. Under the new law, tenants will have 10 business days, up from the previous five-day deadline, to contest an eviction.

Starting in April, Senate Bill 611 will provide additional protections for renters in California by prohibiting landlords from charging tenants a fee for paying their rent or security deposit by check. In addition, landlords will be required to provide a written statement to tenants if they charge a security deposit that exceeds the standard amount.

Crime

Senate Bill 1414 introduces stricter penalties for individuals convicted of soliciting a minor for sex. The law raises the crime of soliciting or buying sex from minors under 16 from a misdemeanor to a felony, carrying more severe legal consequences. If the person solicited is under 16, or under 18 and a victim of human trafficking, the offense could be punishable by jail time of up to a year and a fine of up to \$10,000 or a prison sentence ranging from 16

months to three years. For repeat offenders, the penalties are harsher, with mandatory felony charges and a prison sentence of 16 months to three years.

Education

In the education sector, Assembly Bill 1780 prohibits private nonprofit universities in California from considering legacy status in admissions. The ban, effective in September, means that ties to donors or alumni will no longer play a role in college admissions decisions

Consumer Protection

In a move aimed at consumer protection, Assembly Bill 2863 will require companies offering auto-renewal services to provide customers with an easy option to cancel subscriptions.

Starting July 1, consumers will be able to cancel their subscriptions by the same method they used to sign up.


Health

A major update in health-care comes with Senate Bill 729, which mandates that health insurance plans cover the diagnosis and treatment of infertility, including in vitro fertilization (IVF), starting July 1.

Senate Bill 1061 will protect consumers by prohibiting credit reporting agencies from including medical debt on their credit reports, ensuring that such debt cannot negatively impact individuals’ credit scores.

Assembly Bills 1817 and 2771 will ban the use of harmful chemicals known as PFAS (perfluoroalkyl and polyfluoroalkyl substances) in clothing, textiles and cosmetics sold in California.

These chemicals, which have been linked to serious health issues such as liver damage, thyroid disease, reproductive problems and cancer, will no longer be allowed in products. ★

ARC Volleyball Closes Out Season in State Semifinals

SACRAMENTO, CA (MPG) - After twice being swept by American River College (ARC) in the regular season, a hungry Feather River College team fully savored a third opportunity versus the Beavers in performing a sweep in the 3C2A Women's Volleyball Championship semifinals on Saturday, Dec. 7, at Mt. San Antonio College in Walnut, Calif. Feather River (30-7) defeated American River (28-5), 3-0: 25-19, 25-22, 25-23.

There was no coincidence why American River College was making a sixth straight appearance at the 3C2A State Women's Volleyball Championship. The Beavers have height and that was a factor in a heavy block that was too much for LA Mission's attack in a 4-set quarterfinals victory for the Beavers on Friday, Dec. 6.

In their quarterfinal matchup, American River received another sterling performance by 5-foot-11 Morgan Castaneda, who rifled 21 kills (hit .292) with 10 digs and three blocks, but the Beavers also relied on the blocking and net talents of 6-1 Celestine Hayes (three kills, five blocks), 6-foot Mallory Kuehl (five kills in only six attacks and six blocks), 5-11 Kyla Powell, who chipped in seven kills and two blocks, and 5-10 Amiah Cornejo, who contributed five kills and served

three aces off the ARC bench.

The Dec. 7 semifinal matchup featured American River College versus Feather River College. The Battle of the rivers began with Feather River's Tiare Faupula scoring four kills and making three blocks in a 6-point opening set triumph. Feather River led 15-7 and ran away with the game and a 1-0 lead.

In the semifinal second set, American River jumped out

to a 9-3 lead only to see the Golden Eagles go on a 5-0 run to slice it to one. The Beavers would then lead 14-11 and 17-14 before Feather River went on an 8-2 run capped by a block by Faupula and Ledua Koi for a 22-19 advantage. Two kills by Ane Tuinauvai and another stuff by Lucy Ryan and Mia Rivera captured the 3-point win and a commanding 2-0 sets lead.

In the third set, the Beavers

tried to rally as 6-foot-2 Jayda Moran came off the bench to record a pair of blocks with teammate Malloy Kuehl and built a 14-6 lead. An Amiah Cornejo/ Celestine Hayes block doubled the score at 16-8 and a kill by Kuehl later made it 18-11.

Tuinauvai, who missed both of the first two encounters with American River due to injury, buried three kills in a momentous 11-2 run to give Feather

River a 22-20 lead. A push kill by Kaylynn Whitt, an ace by Sofia McPherson, and an attack error by Feather River regained the lead for American River at 23-22.

The Beavers though couldn't finish off the set as a solo block by Mia Rivera was sandwiched by two rifle kills by Ryan to complete the surprising Feather River sweep.

Overall for Feather River, quarterfinals hero Chloe Albiez powered 10 kills, Tuinauvai eight kills with 12 digs, Faupula seven kills (.313) and five blocks, and Rivera three kills and six blocks. Teya Gibbs was a setting/defensive stalwart on 13 assists and 12 digs while the team's starting setter Maya Cann dished out 24 assists.

For American River, All-American Morgan Castaneda was limited to 10 kills with 10 digs, Kuehl had four kills, five blocks, and two aces, and Cornejo scored six kills.

"Feather River swung aggressively with a nothing to lose, underdog mentality," said American River College head coach Carson Lowden, who brought her team to the state tourney for the sixth straight season. "I thought we served and passed well. We didn't put enough offensive pressure on them. The difference was that they just did a great job in transition."

The loss snapped American River College's 13-match win streak. ★

This is the second time that the River Cats have earned the accolade, first receiving the distinction following the 2004 season.

Named after longtime MiLB ambassador Bob Freitas, the annual award is given to one team from each of the MiLB's three classification levels (Triple-A, Double-A, and Single-A), recognizing the franchise's overall excellence, community engagement, and long-term success as a business operation through marketing, on-field operation, and fan service.

"This award is a testament to the passion, dedication, and hard work of our entire team," said Sacramento River Cats President and COO Chip Maxson. "Every member of our staff plays a vital role in creating unforgettable experiences for our fans and we are proud to share this honor with our community."

Ahead of celebrating their 25th season, the team sold out the third exhibition game in the shared history between the River Cats and their parent affiliate, the San Francisco Giants. In addition, Sacramento sold their most new season tickets in a single year since their inaugural season in 2000. The team also sold out its newly renovated Diamond View Dugout and all remaining premium memberships reaching capacity for access to the Jackson Rancheria Casino Resort Legacy Club.

Including Sacramento's best single-game turnstile

since the 2019 season on Sept. 21, Sutter Health Park and the River Cats saw an 8.8 percent total increase in per-game turnstile. This feat was buoyed by a continued growth of new fans with over 40,000 "first known attendees" visiting this season, four percent more than in 2023, in addition to a 16 percent increase in group tickets sold.

Significant to those successes was the introduction of the Sutter Health Park Summer Pass, a ticket pack that included a lawn ticket to more than 40 home games from the end of May to early September. The Summer Pass sold over 500 packs in a three-week timeframe, outperforming the sales of all other MiLB products of its kind during the year. The Pass is slated for a return in 2025.

Also aiding in fan growth this season was an enhanced focus on producing special game takeovers, drawing

audiences to honor their diverse communities including Hispanic Heritage Night, Pride Night and a Juneteenth celebration. As a result of the DEI efforts, the Consulate General of Mexico recognized the organization for their outstanding work in enhancing visibility and representation.

Giveaways and fan engagement have also played a role for Sacramento, as the River Cats' lead generation database, Fan Compass, grew by 36 percent to become the largest of its kind in MiLB.

The River Cats continued to establish their brand as a trusted marketing platform for regional companies looking to connect with fans, growing their portfolio of corporate partners by 24 percent, including new additions Poppy Bank and Jamba, among others.

Among numerous volunteer and community efforts were a pair of baseball clinics

hosted by the River Cats including Baseball for All at Independence Field, an opportunity for River Cats players and coaches to come together with children of all ages and abilities to play ball. The River Cats generated nearly \$20,000 in donations in partnership with River Cats sponsors to charitable organizations including Sacramento Food Bank, Sutter Gould Medical, Courage House and Foundation Diabetes Program.

The 2024 season is the second time that the River Cats have been Bob Freitas Award recipients, first achieving the honor during their fifth season in Sacramento exactly 20 years ago following the 2004 campaign, making the organization one of only eight multi-time winners. Sacramento is the second consecutive Pacific Coast League team and seventh in the past eight seasons (excluding 2020) to earn the

award, following in the footsteps of the Albuquerque Isotopes who captured the honor for a Triple-A leading third time in 2023.

To celebrate the award, the River Cats have partnered with Drake's Brewing Co, to produce a River Cats Celebration Ale. The limited-edition beer will be available exclusively at Drake's: The Barn located across from Sutter Health Park in West Sacramento.

Sacramento kicks off its season at home with Opening Night on Friday, March 28 against the Albuquerque Isotopes at 6:45 p.m. Tickets to the home opener and the entire first half of the season through July 3 are now available. 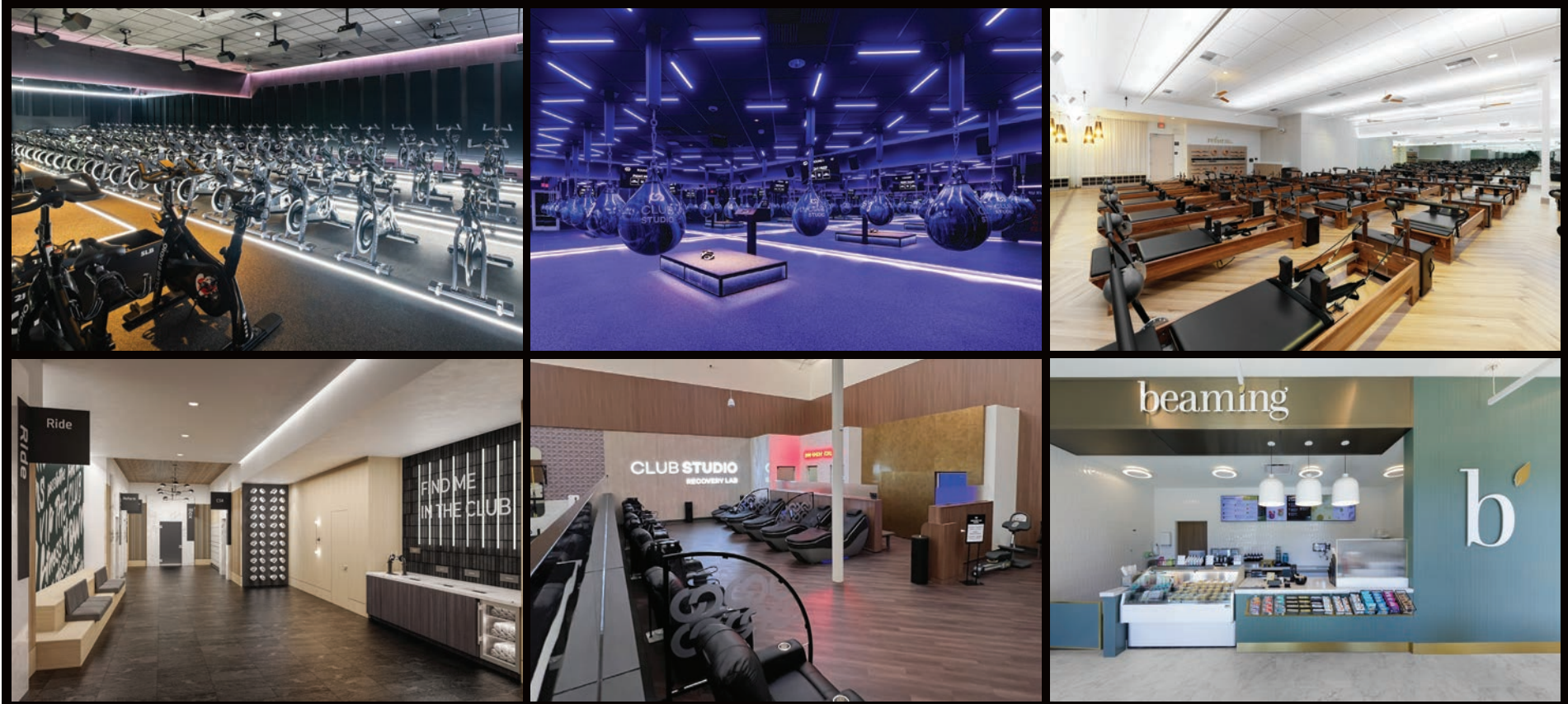
