# Laws are Changing in 2025



Starting Jan. 1, 2025, many significant new laws will go into effect across California, impacting everything in daily life from traffic regulations, employment, housing to healthcare. Image from Pixabay

SACRAMENTO REGION, CA (MPG) - Starting Jan. 1, 2025, many significant new laws will go into effect across California, impacting everything in daily life from traffic regulations, employment, housing to healthcare.

#### TRAFFIC LAWS

Senate Bill 1107 will raise the minimum auto liability insurance requirements for California motor ists. Currently, drivers must carry liability coverage of \$15,000 for injury or death of one person, \$30,000 for injury or death of multiple people, and \$5,000 for property damage. Beginning Jan. 1, these requirements will increase to \$30,000 for bodily injury or death of one person, \$60,000 for multiple persons and \$15,000 for property damage.

Assembly Bill 413, commonly known as the "Daylighting Law," will take effect in 2025, banning drivers from parking within 20 feet of a crosswalk. This law aims to improve pedestrian safety by providing clearer visibility at intersections. The law applies to both marked and unmarked crosswalks, and while cities are working to implement signage and curb markings, not all areas will have red-painted curbs in time for the new rule.

Senate Bill 905 closes the "locked door loophole" in California's auto burglary laws. Under the new law, prosecutors no longer need to prove that a vehicle was locked in order to charge someone with burglary. Instead, they only need to show that forcible entry occurred. The change is expected to make it easier for victims of car break-ins to pursue legal action, with felony convictions carrying penalties ranging from 16 months to three years.

#### **EMPLOYMENT LAWS**

A statewide minimum wage increase will take effect on Jan. 1, raising the rate to \$16.50 per hour for all employees, regardless of company size. This adjustment is based on a cost-of-living provision built into California's minimum wage law.

Senate Bill 1100 prohibits employers from requiring a valid driver's license for job applicants unless driving is a core function of the role. Employers must also demonstrate that using alternative transportation would not be comparable in travel

#### **HOUSING LAWS**

Assembly Bill 2347 introduces stronger protections for renters by extending the timeline for tenants to respond to eviction notices. Under the new law, tenants will have 10 business days, up from the previous five-day deadline, to contest an

#### Requirements

Trees must have all tinsel, lights, decorations, nails and stands removed. Flocked trees are not accepted for recycling. Please ensure transported holiday trees are properly secured during transport.

#### Saturday, Jan. 4, **Free Mulching Event**

From 8 a.m. to 3:30 p.m., residents can bring holiday trees to be mulched for free to the SMUD Corporation Yard, located at 6100 Folsom Blvd. (just off Highway 50). Mulched tree is offered free to customers.

#### **Sacramento County** Locations

On both Saturday, Jan. 4 and Sunday, Jan. 5, rain or shine, residents can recycle holiday trees for free at two locations.

From 8:30 a.m. to 4:30 p.m. both days, residents can drop trees off at Kiefer Landfill, located at 12701 Kiefer Blvd. (Jackson Highway, north on Grant Line Road, right on Kiefer Boulevard).

Trees can also be dropped off between 8 a.m. and 6 p.m. at North Area Recovery Station, located at 4450 Roseville Road (Highway 80, north on Watt Avenue, left on Roseville Road).

Loads in excess of five trees must be issued a voucher for the trees to be accepted at no charge. Nonprofit civic groups and community organizations can obtain vouchers by submitting the Annual Holiday Tree Recycling Program Application Form. 

# Stay Safe in the Cold

SACRAMENTO COUNTY, CA (MPG) - With temperatures staying cool this week, it's a great time to review cold weather tips.

Check on elderly family members, friends and neighbors. Seniors and those with serious medical conditions are at risk. Check on community members who might be vulnerable to ensure they are safely keeping warm.

Bring your pets inside when temperatures start to dip near freezing. A dog or cat left outside in severe cold weather can quickly die from exposure. Except for exercise and walks, all dogs and cats are safer indoors during the winter.

Make sure your pets have a warm, draft-free place indoors with a dry mat or blanket that they can lie on. For additional winter weather tips for animals, check out the Bradshaw Animal Shelter's website at animalcare.saccounty.gov.

Heat your home safely; carbon monoxide is a silent killer. It is not OK to heat the inside of your home with any kind of barbecue, propane heater or any other fuel-fired equipment, due to the risk of carbon monoxide poisoning. Only use heaters installed with your home and those designed to be used indoors. Make sure that your natural gas furnaces and other appliances are in good, clean working order.

Insulate outdoor pipes that lead into your home to prevent freezing. Seal with caulk around the pipes that lead into and out of your home. Inside your home, leave the bathroom and under-sink cabinets open to help warm the water. If your

way slowly from the faucet to where your pipe enters the wall. County residents who need to have their water turned off in order to make repairs to their lines can go online or call 311 (or 916-875-4311 if calling from out of the area).

Ensure proper drainage by scooping up leaves and debris. Keeping storm drains clear can prevent street flooding and black ice from forming.

When it is raining, reduce your vehicle speed. Wet roads increase the distance and time needed to stop your vehicle. Be extra cautious on roads, bridges and overpasses when temperatures are 32 degrees or below because of black ice: slow down and give yourself extra spacing between vehicles in front of you.

Watch for tree limbs. As temperatures dip, trees become vulnerable to limbs snapping. For downed trees or branches in the roadway, county residents can go online or call 311 (or 916-875-4311 if calling from out of the area). Prepare for wind. Secure yard items that

could blow around and be prepared for the possibility of loss of power. For downed power lines, stay away and immediately call 9-1-1.

Sign-up for Emergency Alerts. This system alerts residents about emergency events and other important public safety information quickly in a variety of situations, such as severe weather, unexpected road closures, missing persons and evacuations of buildings or neighborhoods.

CITRUS HEIGHTS, CA (MPG) - On Dec. 17, the Citrus Heights Chamber of Commerce hosted a highly anticipated luncheon at the Citrus Heights Community Center, featuring newly-elected Sacramento County Supervisor Rosario Rodriguez.

The event, which ran from 11:30 a.m. to 1 p.m., provided attendees with an opportunity to meet Rodriguez, hear her vision for the future, and learn about the impact of her leadership on the Citrus Heights community and Sacramento County as a whole.

Sheri Merrick, the Citrus Heights Chamber of Commerce executive director, praised Rodriguez's rise to leadership. emphasizing her journey.

"She has grown from the daughter of an immigrant to become a community leader, a business owner, a former

mayor of Folsom and now the Supervisor-elect for Sacramento County Board of Supervisors District 4," Merrick said. "Her story is one of hard work, dedication and a commitment to making meaningful change in the community."

Rodriguez, a San Francisco native, shared her personal and professional journey with the crowd, detailing her 20 years in healthcare, her experience as a business owner and her path to becoming an elected official.

"I wanted to work for myself, I love food, and I'm a big foodie, so I decided to open a taqueria," Rodriguez said. "We found a location, gutted it, and I started working full time at the restaurant. That was my first introduction to policymaking: there are so many decisions made by the city that directly affect businesses and that's when I started getting involved with City Council meetings."

Rodriguez's commitment to public service deepened after she was elected to the Folsom City Council in 2020. Reflecting on her time in office, Rodriguez noted her passion for policymaking and her drive to improve the community.

"I realized how much I love making decisions that positively impact the city and its residents. The last four years have been truly amazing," Rodriguez said. "As a Latina, I wanted to bring diversity to the table. At that time, the City Council was predominantly all Caucasian for a city that was about 30% people of color."

When former Supervisor Sue Frost announced her retirement in 2023, Rodriguez saw an opportunity to address larger issues facing the county, particularly the challenges of city mandates and regional growth. She ran for the Sacramento County Board of Supervisors, winning her seat outright in the primary election with more than 51% of the vote.

Now, Rodriguez is eager to tackle some of the region's most pressing issues and to support community growth.

"I'm really excited about working more closely with the chambers and other organizations to make improvements," Rodriguez said. "Our communities have so much potential to invest in themselves and I want to help enhance that growth, promote beautification and ensure a safe environment for everyone."

Rodriguez also discussed the most urgent issues facing the county. Homelessness, transportation and public safety topped the list.

"We need more accountability in the organizations receiving county funds. If they're not delivering results,

we need to hold them accountable," Rodriguez said.

On transportation, she noted the limitations of Measure A funding and expressed the need for alternative solutions.

Public safety, Rodriguez added, is a critical priority for

"Government's number one priority is to make sure our community feels safe," Rodriguez said. "We also need to focus on getting young people into public safety careers. It's essential to build a bridge between high school programs and these fields."

With a housing crisis impacting the region, Rodriguez is committed to supporting growth and development to meet the community's demands.

"I want to see accountability and improvements," Rodriguez said. "I have the energy, the time and the drive."



The amendment proposal, submitted by Ethan Conrad Properties, details adjustments to the plan approved by the City Council in 2021 that would affect the redevelopment of the Sunrise Mall area.

Proposed changes include the allowance of eight quick-service restaurant and drive-thru businesses, building and landscape materials sales, light industrial and storage uses, and automotive uses, as well as the removal of requirements for open

### **Henderson Remembered as Electrifying Legend of the Game**

SACRAMENTO REGION, CA (MPG) - Rickey Henderson used the ultimate combination of power and speed to break numerous major league baseball records during his

But what solidified his place in baseball history was his love for the game.

Henderson died on Dec. 20, at the age of 65. His enthusiasm for the game manifested itself in

1,406 stolen bases – by far the best total in history.

"Rickey

Henderson was not only the greatest base stealer of all-time, but one of the most memorable personalities of his generation,"

said Jane Forbes Clark, Chairman of the Board of the National Baseball Hall of Fame and Museum. "The enthusiasm and energy he brought to

Cooperstown each year will truly be missed. Our thoughts are with his wife, Pamela, and their family." Born on Dec. 25, 1958, in Chicago, Ill.,

Henderson spent most of his childhood in Oakland, Calif. An All-American running back in high school, Henderson turned down multiple football scholarships to sign with the Oakland Athletics in 1976. In his first full major league season

1980, Henderson broke Hall of Famer Ty Cobb's 65-year-old American League stolen base record of 96 with 100 swipes. In 1982, he stole 130 bases, breaking Hall of Famer Lou Brock's modern era major league single-season record of 118.

"He's the greatest leadoff hitter of all time, and I'm not sure there's a close second," said Billy Beane, senior advisor to the Athletics and the team's former longtime general manager.

He played for nine teams over his

25-year career including the Athletics, Yankees, Padres, Mets, Red Sox, Dodgers, Angels, Mariners and Blue Jays. He led the American League in steals 12 times and went on to be the all-time record holder with 1,406 thefts, earning him the nickname "Man of Steal."

"It wasn't until I saw Rickey that I understood what baseball was about. Rickey Henderson is a run, man," said Athletics teammate Mitchell Page. "That's it. When you see Rickey

speed Ηis wasn't his only skill. Henderson all-time records for runs scored (2,295), unintentional

walks (2,129) and leadoff home runs (81). The 10-time All-Star won the MVP Award in 1990, leading the

American League in runs scored, stolen bases and on-base percentage. He finished in the top ten in MVP voting five

"He was one of the best players that I ever played with and obviously the best leadoff hitter in baseball," said Hall of Famer Dave Winfield. Henderson won two World Series

during his career, in 1989 with Oakland and in 1993 with Toronto. He spent most of his career in left field and won a Gold Glove Award in 1981. He finished with a .279 batting average, 3,055 hits and 297 home runs. He electrified crowds with his flair and enthusiasm for the game. Henderson was elected to the Baseball

Hall of Fame in 2009 on his first appearance on the Baseball Writers' Association of America ballot.

"If my uniform doesn't get dirty, I haven't done anything in the baseball game," said Henderson.

### Can New State Regulations Resolve **California's Existential Insurance Crisis?**

There's no law requiring California property owners to carry insurance, but the vast majority buy it to protect themselves from fire and other perils, or are required to do so by their mortgage lenders.

There's also no law requiring insurance companies to offer coverage in California, but most would prefer to do so in the nation's most immense concentration of property needing protection.

For decades, insuring California's homes, farms and commercial properties was a hum-drum business of willing sellers and willing buyers. However, the former have become less willing as the state experiences an ever-increasing number of wildfires — even during winter months — that devastate homes and businesses in fireprone areas.

Last Friday, as the latest of those fires was driving people from their homes in the quaint seaside village of Malibu, Ricardo Lara, the state's elected insurance commissioner, formally unveiled a large chunk of his plan to stem the exodus of insurers from California.

It would allow insurers to use computer modeling of future exposure to set premiums, while requiring them to offer coverage in risky communities roughly in line with

their shares of the market. Until now, insurers set rates based on past losses.

"Giving people more choices to protect themselves is how we will solve California's insurance crisis," Lara said in a statement as he released details of the modeling plan. "For the first time in history we are requiring insurance companies to expand where people need help the most. With our changing climate we can no longer look to the past. We are being innovative and forward-looking to protect Californians' access to insurance."

He also noted that in setting rates, insurers will be required to consider hardening efforts by threatened communities and property owners to reduce potential

Lara claims support from environmental groups, farmers and other stakeholders, in addition to insurers. But he's drawing sharp criticism from Consumer Watchdog, an organization that has sponsored landmark changes in insurance regulation. The group has also received millions of dollars in fees from intervening in insurance rates cases, and has been a harsh critic of Lara throughout his time in office.

"Full transparency is what keeps insurance rates honest but Commissioner Lara's rule does away with that protection," Consumer Watchdog executive director Carmen Balber said in a statement. "The rule will let insurance companies raise rates based on secret algorithms but not expand coverage as promised."

The new rules take effect in January. Farmers Insurance, California's second-largest property insurer, has already pledged to expand its coverage in response to Lara's actions. The American Property Casualty Association, a trade group, also reacted positively.

"California will continue to have a robust regulatory and rate approval process that guarantees that rates reflect the actual cost of covering claims," the association said.

While the rules unveiled last week are central to Lara's plans, there are other elements that remain: shoring up the FAIR Plan, California's last ditch insurer for property owners who cannot obtain coverage elsewhere, speeding up insurance rate case approvals, and allowing insurers to include costs of reinsurance — coverage of their potential losses — in setting rates.

Adoption of Lara's plans may result in premium increases, but maintaining a viable insurance market is a vital factor in the state's economy. The inability to buy insurance would devastate the residential and commercial real estate market and require property owners to pay for fire losses out of their own pockets.

Lara's plans may not be perfect, but nobody — including Consumer Watchdog — has offered a better alternative. He should be credited with at least attempting to deal with one of California's existential

real reason for the objection. It could very well be that she doesn't want to be further away from her family, and that's natural-to an extent. But like you said, there could be other factors involved.

There might be something in your past that bothers her, or something she doesn't want you to revisit. There may even be feelings of discomfort with your family for things that have happened or been said. It could also be the insecurity that goes along with a move, a new home and a new job. I don't know how far away you're talking about moving, but it could also be she's worried about leaving her job.

From a relationship standpoint, you two each need to lay your cards on the table and be honest with each other. Open up, and really talk about it. Otherwise, it's going to become a sore spot and cause even more problems. Part of marriage is making compromises. Sometimes compromises must be made by one, or both, people in order to do what's best for the re-

lationship in the present and in the long run.

It could be that you just need an impartial referee. Would you both be willing to attend a few sessions with a good pastor or marriage counselor togeth-

er? Talking to either one doesn't mean your marriage is on the rocks, but sometimes a compassionate and objective third party can help dig down below the surface to uncover issues and help find a reasonable solution to problems.

I hope this helps. God bless you both, Freddie.

### **Social Security Matters** Have I Saved Social Security Money by Claiming at 62?

Dear Rusty: I had to start collecting Social Security at 62, and I am 75 now. I believe that in the last 13 years I have saved Social Security money, so I do not know why I cannot draw my full benefits now.

If I had started drawing at 65 at \$1,200 per month, then I would have drawn \$16,400 per year. Instead, I got \$680 per month from 62 to 75, or \$8,160 per year, or about \$106,000 over 13 years. Compare that to the age 65 amount of \$14,400 per year for 10 years, which is \$144,000. So, by claiming at 62, at age 75 I have saved the government over \$38,000. It would make seniors lives so much easier if they could draw full Social Security at 75 years old, after getting only part of their SS. Signed:

Second-guessing Dear Second-guessing: The difference between benefits claimed at various ages causes many to reflect, as you have done, about what might have been had you waited longer to claim. But there is an error in your calculations. If your age 62 monthly benefit is \$680, your age 65 monthly benefit would have been about \$845, not \$1,200. Thus, at 75 you would have collected about \$101,400 by claiming at 65, vs. the \$106,000 you have received

by claiming at age 62. In other words, you still would not have broken even had you claimed at age 65.

Social Security says that it doesn't matter when you claim - they say that if you claim early your payments will be less, but you'll get more of them. Where SSA's argument falls apart is when life expectancy is longer. Our experience is that if you wait until your full retirement age (FRA) to claim (which is age 66 in your case), vs. claiming at age 62, you will collect the same amount of total money at about age 78. In other words, the "breakeven age" for waiting until FRA to claim is about 78. So, you will reach your personal "breakeven age" in about 2 ½ years (at age 78). And this is precisely why we encourage everyone to understand their life expectancy when deciding when to claim Social Security – those who expect to live longer will, indeed, get more SS money if they delay claiming.

Your benefit is determined by your age when you claim, and if you claim before your FRA your monthly amount is permanently reduced. If you claimed at age 62 and your monthly amount was \$680, then in the four years until you reached age 66 (your FRA) you would have received about \$32,640. If you had, instead, waited until your FRA to claim, your benefit at age 66 would have been about \$906/month. Collecting \$906/month (at 66) vs. \$680/month (at 62) would make your breakeven age about 78. If you claimed at age 65 instead of 62, your breakeven age would have


been about a year earlier (77). So, have you saved Social Security money? Up to this

point, you have not. Since you claimed at age 62, you have collected about \$680/ month for 13 years until you were 75 (or about \$106,000). If you had waited until age 65 to claim you would have, instead, collected about 101,400 - in other wordsyou have received more, so far, by claiming at age 62. But that will change when you reach 77 (your breakeven age, had you claimed at 65). Starting at age 77, you will have received less in cumulative lifetime benefits because vou claimed at age 62. Which, again, is why - at the AMAC Foundation's Social Security Advisory Service - we encourage everyone to consider life expectancy when deciding when to take Social Security. Of course there are other factors too, not the least of which is financial need, but life expectancy is key. And since the benefit you get when you claim is permanent (except for annual Cost of Living Adjustments), deciding when to claim Social Security is a decision

# Celtic Cross Church Welcomes a New Pastor

CITRUS HEIGHTS, CA (MPG) - Yule be Missed. And there's no doubt that he will.

Celtic Cross Presbyterian Church celebrated the 28 years of service of retiring pastor Bob Yule with a farewell potluck on Nov. 16, recognizing that his ministry accounts for almost one third of the church's overall history in Citrus Heights.

Celtic Cross was organized as a Presbyterian church on Feb. 25, 1962, within the bounds of the Presbytery of Sacramento, and celebrated its 60th anniversary in Citrus Heights last November.

The church has since welcomed a new pastor, Rev. Dr. Sam Sungsoo Jun, (who prefers to be called Pastor Sam) who will now carry the church forward in faith and service to the community.

Yule and his wife, Patty, and their son, Josh, will continue to make their home in Fair Oaks. Looking back, Yule describes the 28 years as Celtic Cross Church pastor as being especially fulfilling for he and his family.

"I credit the people of Celtic Cross with incredible resilience. That is a long time to listen to anyone," said Yule, smiling during a recent interview.

"Our goal at Celtic Cross is to be a church that raises up entire families in discipleship and empowers people to be messengers of Christ in their community," Yule said.

Celtic Cross is a "continually growing community of people committed to following Jesus Christ," Yule said.

"When Patty and I arrived (at Celtic Cross) in late 1996, we were warmly welcomed," he said. "This community (Celtic Cross) has become my home, not only because it is the longest time I have ever lived anywhere but especially because of the encouragement and support we have both experienced here."

Yule had kind words about Pastor Sam.

"Pastor Sam will bring the same great energy, creativity and a Christ-like love to Celtic Cross which he has demonstrated in his past ministry experience," Yule said. "I am glad to hand over the baton of leadership to you, Pastor Sam, and I am praying that God provides with wisdom and direction as you lead the people of God for years to come."

Pastor Sam was previously senior pastor at the Northern Lakes Community Church in Traverse City, Michigan since 2019. He's now taking time to settle in before relocating his

family from Michigan to a new home here.

The new pastor of Celtic Cross is the son of a pastor and has been married to his wife, Annie, for 26 years. He's the father of two college-aged daughters, Hannah and Amy, who are attending interstate collegiate rivals, the University of Michigan and Michigan State University.

Pastor Sam provided a guest sermon on Sunday, Sept. 29 at the 10 a.m. combined service at Celtic Cross and was then approved by vote at a congregational meeting that followed.

Born in Korea, Pastor Sam has six sisters and is the only son. His father pastored a large Presbyterian Church in Inchon, Korea for 42 years. Pastor Sam arrived in the United States to attend college in 1991.

"My father's pastoral visits were the most important times for guiding people to faith," he said. "It's in a 'ministry of presence' where God is met and encountered in a very real way, that God's love and grace can fully be felt and experienced."

Today, I still draw and prac tice his ministry of presence in my own ministry settings," Pastor Sam said.

Pastor Sam said he looks forward to the congregation of Celtic Cross getting to know a little more about him. He once considered pursuing a much different career than the ministry

during his high school and college years. He moved to the United States in 1991.

"For my first three years in high school in South Korea, I was dreaming about becoming an opera singer, as I took some vocal trainings and also led men's quartet and choir in my high school," he said.

"In my senior year in high school, I then dreamt about being a language (English) professor but ended up with going to college to become a religion professor," he said. "Then, after the first year in college, I was given an opportunity to study abroad in the United States to further my study in religion and liberal arts in Texas. While studying at the University of Texas at Austin, my religion, music and Greek professors all encouraged me to go to seminary to have an in-depth study about Christianity."

Pastor Sam earned his mas ter's in divinity from Princeton Theological Seminary in Princeton, New Jersey, and his Doctor of Ministry degree from Fuller Theological Seminary in Pasadena, California. He most recently served as associate pastor at Pines Presbyterian Church in Houston, Texas,

where he focused on Youth and Family, Congregational Care, and Mission. Prior to that, he was a Lilly Resident in Pastoral Ministry at the First Presbyterian Church in Ann Arbor, Michigan.

"I'm also a musician (a trained tenor), and sometimes I sing while playing piano but these days, I enjoy much more listening to all kinds of music from classical opera to contemporary Christian jazz and much more watching plays and musical performances in theaters," he said.

Pastor Bob Yule intends to keep busy in his spiritual life and wherever his retirement might lead him.

"There's a need for part-time transitional pastors in our region and in early 2025, I will preach a few times a month at the Auburn Presbyterian Church," Yule said.

"The church is looking to call a new pastor in the next year. I believe I can help the congregation get prepared for the future," Yule said. "I'm also looking forward to having a few more days off to ride my bike on the American River Parkway and have more time to enjoy with my wife, Patty."

CITRUS HEIGHTS, CA (MPG) - The Citrus Heights Community Center at 6300 Fountain Square Drive officially has a new name.







# A California Child Tested Positive for Bird Flu

An Alameda County child with mild upper respiratory symptoms tested positive for bird flu, state public health officials announced on Nov. 19. The potential infection is the first known case in California that does not appear to have originated from contact with infected cattle.

State health officials are waiting for the Centers for Disease Control and Prevention to confirm the test result, as of

Public health investigators suspect the infection may have originated from wild birds, which are the main carriers of bird flu, according to a statement from the California Department of Public Health. The agency did not disclose information describing the child's interactions with wildlife.

The child displayed mild respiratory symptoms and tested positive for multiple viruses, according to Austin Wingate, a spokesperson for the Alameda County health department.

Doctors did not initially suspect bird flu. Officials detected it through routine influenza subtyping, Wingate said. Family members tested negative for bird flu, but they had other viruses.

Officials are working to notify and test close contacts of the child, which include individuals at a daycare the child attended.

"We want to reinforce for parents, caregivers and families that based on the information and data we have, we don't think the child was infectious - and no human-to-human spread of bird flu has been documented in any country for more than 15 years," said state Public Health Officer Dr. Tomás Aragón.

Aragón emphasized the risk to the general public remains low. People can become infected through close contact with infected animals, according to the Centers for Disease Control. Dairy and poultry workers and people who work with wildlife face the greatest risk of contracting the virus.

Some infectious disease experts are concerned about what this case could signal about the wider bird flu outbreak sweeping the country, which started in

products.

"We're seeing the numbers go up, the number of infected farms, the number of farm workers, we now have this child. All of these signs to me suggest that things are going in the wrong direction, not the right direction," said Sam Scarpino, an epidemiologist with Northeastern University in Boston who is not involved in the California disease investigation.

#### Cases spreading in Central Valley dairies

The case comes as California grapples with the country's largest bird flu outbreak among cattle and farmworkers. There are 26 confirmed human cases of bird flu primarily in the Central Valley where the virus has swept through 335 herds, according to state health and agriculture officials. Workers in the dairy industry have contracted the virus through close contact with

infected cows. The state health department has distributed more than 3 million pieces of personal protective equipment to farmworkers. It has also secured 5,000 doses of the seasonal flu vaccine for farmworkers from the Centers for Disease Control and Prevention.

The federal government has a small stockpile of bird flu vaccines, but they have not been distributed. Instead, health officials encourage people to get vaccinated for influenza, COVID-19 and respiratory syncytial virus to help prevent co-infections like the child had.

"We want to make sure in general that we promote people getting up to date on vaccines and protecting themselves from seasonal illness, from seasonal flu," said Dr. Erica Pan, the state's top epidemiologist, in a previous interview with CalMatters.

Scarpino said California has done a good job of testing farmworkers compared to other states where sick cattle have infected humans, contributing to its relatively high number of confirmed cases, but surveillance efforts across the board need to be increased.

As seasonal flu rates increase, it will become harder for public health laboratories to detect rare viruses, such as H5N1, the bird flu, Scarpino said.

> **Bird Flu Present** in California Sewage

The bird flu virus has appeared in 17 wastewater systems in California, according to the Centers for Disease Control and Prevention. Positive detections appear primarily in Northern California, including in Alameda, San Francisco, Sonoma, Contra Costa and Sacramento. Wastewater surveillance cannot determine the source of the virus, but infections among wild waterfowl can contribute to its presence.

Maurice Pitesky, a researcher at UC Davis who studies bird flu in waterfowl, said it's rare for the virus to jump from birds to humans but it has happened before. The virus is endemic among wild birds, Pitesky said, and has also been detected in other mammals in California, including bobcats, skunks and mountain lions.

"As the virus further evolves within a mammalian host whether it's dairy cows or felines or all the species that it has affected — it will continue to adapt," Pitesky said. "As it adapts more and more, it has more potential to cause even more problems."

Sacramento County Public Health is actively monitoring the bird flu situation locally and coordinating with state and federal agencies. Residents are encouraged to stay informed and follow precautions to protect themselves and their families.

#### **Prevention Tips**

Avoid contact with wild birds: Even if birds appear healthy, they can carry the bird flu virus.

Use protective equipment: If you work with animals potentially exposed to bird flu, wear N95 masks, gloves and eye protection.

Get the flu vaccine: While the seasonal flu vaccine doesn't protect against bird flu, it can reduce the risk of severe illness and coinfection.

Stick to pasteurized dairy products: Do not consume

or handle raw milk or milk products from animals suspected to be infected. Do not feed pets raw milk

#### **How Bird Flu Spreads**

Human cases of bird flu are rare but can occur when someone has close contact with infected animals or contaminated surfaces. Farmworkers and others who work closely with poultry or dairy cattle are at higher risk. No person-to-person spread of bird flu has been detected in California.

#### Watch for Symptoms

If you've been in close contact with infected animals, monitor yourself for symptoms for 10 days. Symptoms include:

Fever, fatigue or body aches Cough, sore throat or runny nose Trouble breathing or chest discomfort Nausea, vomiting or diarrhea

Red or irritated eyes (conjunctivitis).

If you develop symptoms, isolate yourself immediately, contact Sacramento County Public Health to report the illness and work, and ask Sacramento County Public Health and your healthcare provider for guidance.

#### Bird Flu in California

Bird flu is spreading globally through wild bird populations, with outbreaks reported in poultry and dairy herds in the U.S. While human cases remain extremely rare, California health officials continue to work with local agencies to monitor and control the spread.

Sacramento County Public Health will provide updates as new information becomes available.

Continued from page 1 by prohibiting landlords from charging tenants a fee for paying their rent or security deposit by check. In addition, landlords will be required to provide a written statement to tenants if they charge a security deposit that exceeds the standard amount. **CRIME** 

Senate Bill 1414 introduces stricter penalties for individuals convicted of soliciting a minor for sex. The law raises the crime of soliciting or buying sex from minors under 16 from a misdemeanor to a felony, carrying more severe legal consequences. If the person solicited is under 16, or under 18 and a victim of human trafficking, the offense could be punishable by jail time of up to a year and a fine of up to \$10,000 or a prison sentence ranging from 16 months to three years. For repeat offenders, the penalties are harsher, with mandatory felony charges and a prison sentence of 16 months to three years.

#### **EDUCATION**

In the education sector, Assembly Bill 1780 prohibits private nonprofit universities in California from considering legacy status in admissions. # ARC Volleyball Closes Out Season in State Semifinals

SACRAMENTO, CA (MPG) - After twice being swept by American River College (ARC) in the regular season, a hungry Feather River College team fully savored a third opportunity versus the Beavers in performing a sweep in the 3C2A Women's Volleyball Championship semifinals on Saturday, Dec. 7, at Mt. San Antonio College in Walnut, Calif. Feather River (30-7) defeated American River (28-5), 3-0: 25-19, 25-22, 25-23.

There was no coincidence why American River College was making a sixth straight appearance at the 3C2A State Women's Volleyball Championship. The Beavers have height and that was a factor in a heavy block that was too much for LA Mission's attack in a 4-set quarterfinals victory for the Beavers on Friday, Dec. 6.

In their quarterfinal matchup, American River received another sterling performance by 5-foot-11 Morgan Castaneda, who rifled 21 kills (hit .292) with 10 digs and three blocks, but the Beavers also relied on the blocking and net talents of 6-1 Celestine Haves (three kills, five blocks), 6-foot Mallory Kuehl (five kills in only six attacks and six blocks), 5-11 Kyla Powell, who chipped in seven kills and two blocks, and 5-10 Amiah Cornejo, who contributed five kills and served

three aces off the ARC bench.

The Dec. 7 semifinal matchup featured American River College versus Feather River College. The Battle of the rivers began with Feather River's Tiare Faupula scoring four kills and making three blocks in a 6-point opening set triumph. Feather River led 15-7 and ran away with the game and a 1-0 lead.

In the semifinal second set, American River jumped out

to a 9-3 lead only to see the Golden Eagles go on a 5-0 run to slice it to one. The Beavers would then lead 14-11 and 17-14 before Feather River went on an 8-2 run capped by a block by Faupula and Ledua Koi for a 22-19 advantage. Two kills by Ane Tuinauvai and another stuff by Lucy Ryan and Mia Rivera captured the 3-point win and a commanding 2-0 sets lead.

In the third set, the Beavers

tried to rally as 6-foot-2 Jayda Moran came off the bench to record a pair of blocks with teammate Malloy Kuehl and built a 14-6 lead. An Amiah Cornejo/ Celestine Hayes block doubled the score at 16-8 and a kill by Kuehl later made it 18-11.

Tuinauvai, who missed both of the first two encounters with American River due to injury, buried three kills in a momentous 11-2 run to give Feather River a 22-20 lead. A push kill by Kaylynn Whitt, an ace by Sofia McPherson, and an attack error by Feather River regained the lead for American River at 23-22.

The Beavers though couldn't finish off the set as a solo block by Mia Rivera was sandwiched by two rifle kills by Ryan to complete the surprising Feather River

Overall for Feather River, quarterfinals hero Chloe Albiez powered 10 kills, Tuinauvai eight kills with 12 digs, Faupula seven kills (.313) and five blocks, and Rivera three kills and six blocks. Teya Gibbs was a setting/defensive stalwart on 13 assists and 12 digs while the team's starting setter Maya Cann dished out 24 assists.

For American River, All-American Morgan Castaneda was limited to 10 kills with 10 digs, Kuehl had four kills, five blocks, and two aces, and Cornejo scored six kills.

"Feather River swung aggressively with a nothing to lose, underdog mentality," said American River College head coach Carson Lowden, who brought her team to the state tournev for the sixth straight season. "I thought we served and passed well. We didn't put enough offensive pressure on them. The difference was that they just did a great job in transition."
