Hoops Legend Cartwright Pens Bio

ELK GROVE, CA (MPG) - In the world

of basketball, former NBA star Bill Cartwright has done it all.

As a prep star for the Elk Grove Thundering Herd, Cartwright earned two California Mr. Basketball distinctions and in 1975 led his squad to a Northern California high school boys' basketball title under coach Dan Risley.


He then went on to play basketball at the University of San Francisco, where he was a three-time All-American and twice named Northern California Player of the Year, ending his career as the Dons' all-time leading in points, field goals and free throws.

In the NBA, Cartwright continued that tradition of excellence, winning three NBA Championships as one of the defensive anchors of the 1991-93 Chicago Bulls three-peat dynasty before earning another two rings as an assistant coach under Phil Jackson in 1996 and 1997.

Now, Cartwright is taking on a different challenge: an autobiography.

In "Living Life at the Center," the 7-foot Cartwright explores his childhood, his transition into sports and his collegiate and professional basketball career, as well as his stint

Report Released

California Department of Justice News Release

SACRAMENTO REGION, CA (MPG) - The California Racial and Identity Profiling Advisory Board on Dec. 31 announced the release of its annual report on police stops across California. The report analyzes 4.7 million vehicle and pedestrian stops conducted in 2023 by 539 law enforcement agencies in California under the Racial and Identity Profiling Act (RIPA). Overall, the report shows disparities consistent with those observed in prior years' data with respect to perceived race, age, and disability status. The report finds, for example, that the disparity between the proportion of stops and the proportion of residential population was greatest for individuals perceived to be Black, who were stopped 126% more frequently than expected, followed by individuals perceived to be Latino, who were stopped 44% more frequently than expected. In addition to providing an in-depth look into policing in 2023, the report contains a wide array of best practice recommendations related to policing, with a particular focus this year on the policing of youth and its impacts.

Winter Bird Festival Puts out the Call for Photographers

GALT, CA (MPG) - The organizers behind Galt's upcoming 18th annual Winter Bird Festival are putting out the call for local photographers with an eye for ornithology.

Photographers can try their hand at showcasing their unique perspectives and eye for their avian subjects by taking part in an art exhibition at the annual event. The organizers are looking for photos of birds across Northern California as well as scenes of nature across the Sacramento Valley region.

The photos must be framed to display, and each applicant is allowed up to four entries. An application can be found on the city's website and the deadline is Ian 20

The art exhibition is just one part of the larger festival, which has drawn bird enthusiasts to Galt for nearly two decades.

The festival will begin on Friday, Jan. 31 at McCaffery Middle School and provides an opportunity for local bird enthusiasts to share their interests with others while taking part in workshops and bird watching events.

Nine tours are scheduled for Saturday, Feb. 1, including a botany walk, paddling tours and a tour of restoration work in the Cosumnes River Preserve.

On Sunday, Feb. 2, the San Francisco Bay Area Nature Journal Club is hosting a free field trip to the Sacramento Valley to explore the active bird

life and wetlands of the Cosumnes River Preserve. The tour will meet at 10 a.m. at the preserve's visitor center and will explore the wetlands throughout the morning. The event will wrap up at 4 p.m. following a potluck lunch and journaling discussion.

The event also gives the opportunity to catch the migration of Sandhill Cranes that call the area home for the winter.

David Lee, a world-renowned birder who currently owns the distinction as one of the top birders in the Central Valley, is the event's keynote speaker. Lee has authored books on the subject, including "Annotated Checklist of the Birds of San Joaquin County." He also has served as the editor of "North American Birds, Northern California Region."

The festival includes plenty of events for children, including a live animal show, an opportunity to create a bird feeder and an art contest. The entries in the latter event will have their work showcased on the city's website.

On Jan. 31, the Marion O. Lawrence Library is hosting a reading of "Honk, Honkl! A story of Migration" for children. Kids can also participate in an art contest through local school district; entries will be showcased on the city's website.

Shoplifting Leads to Felony Arrest Under New Prop. 36

GALT, CA (MPG) - Alleged repeat offenders will face stiffer penalties after being arrested for allegedly shoplifting at a Galt store due to a law passed by California voters last year.

The Galt Police Department announced the arrest of a 54-yearold Sacramento man for allegedly shoplifting from Save Mart at 1059 C St. on Saturday. According to the department, the man, alongside a 42-yearold North Highlands woman, was arrested as they attempted to load the reportedly stolen goods into their vehicle.

Galt Police reported that after a criminal history check it was determined that the man had multiple prior convictions for property-related crime, making him eligible for felony charges following the approval of Proposition 36: the Homelessness, Drug Addiction and Theft Reduction Act. The law went into effect on Dec. 18.

He was charged with

shoplifting conspiracy and the newly implemented charge of petty theft with priors. The woman was arrested for shoplifting and conspiracy and was released at the scene.

The arrest followed another incident on New Year's Eve where an individual was arrested for allegedly attempting to break into an ATM. That person also faces increased felony charges.

Galt Police Lt. Brian Azevedo described the law change as "another tool in our toolbox."

"It gives us a little more authority and ability to book someone and instead of just issuing a citation, which is how we have had to do it for about the last 10 years," Azevedo said. "We are now able to book people and keep people in jail for theft if it qualifies for that charge."

Prop. 36 reversed some of the punishment reduction requirements approved by voters under Proposition 47, according to an analysis from the nonpartisan Legislative Analyst's Office.

It was widely supported by Galt voters in the 2024 election. The measure received overwhelming statewide support from voters, with 68% in favor of the change.

Prop. 47, approved in 2014, downgraded thefts worth \$950 or less and some drug-related charges into misdemeanors. Some critics argued the change in sentencing guidelines led to a spike in petty crime and drug use.

Under Prop. 36, offenders who have had two prior theft or drug convictions can now be charged with a felony for thefts under \$950 and the possession of certain drugs.

"It helps us out by being able to protect the public more and be able to be out there and get people who are legitimately are committing crimes and should not be able to be out there on the streets," Azevedo added.

The man was booked and transferred to Sacramento County's Jail on I Street in Downtown Sacramento.

Participants should bring their chili pre-cooked and ready to be judged.


First place will take home \$100, in addition to bragging rights; second place will earn \$50 and third place will take home a \$25 River Rock Brewery gift card.

Burglars Hit Four Galt Restaurants

GALT, CA (MPG) - The Galt Police Department is still looking for four individuals who hit four Galt businesses last week in a brazen string of burglaries.

The burglars struck Compadres Bar & Grill, Papas & Wings, Y2 Yan Chinese Food and Santa Cruz Taqueria during the early hours of Dec. 30. Each of the businesses had boarded up windows shortly following the break-ins.

Galt Police Lt. Brian Azevedo said the cases are still under investigation.

Jose "Tony" Gutierrez owns Compadres Bar & Grill and said the burglars damaged his restaurant's front door to enter the premises but couldn't get through. They then were able to smash in a window behind the restaurant before rummaging through the premises.

Gutierrez also owns Compadres Market on C Street and said while his restaurant has never experienced a break-in before, it's not an uncommon story for other businesses in the

"It has been going on every single year," Gutierrez said. "Last year they broke into a lot of businesses over here."

Gutierrez said the burglars broke into the space by smashing the back doors and windows before rummaging through the space. He said they couldn't grab anything of real value in the break-in, but the damage to the door could have exceeded \$2,000.

"They only took some

change from the cashier machine, and like two bottles of tequila," he said.

He said he previously took precautions at Compadres Market by placing wrought iron bars behind his windows to prevent burglars from being able to climb into the business if someone breaks out his windows.

"We are the ones who have to protect our businesses," he said.

The owners or managers of the other afflicted restaurants, Papas & Wings, Y2 Yan Chinese Food

and Santa Cruz Taqueria could not be reached for comment.

Gutierrez said he is unsure of the status of the investigation into the break-ins.

According to the Galt Police Department's Facebook page, the suspects, who were caught on surveillance video wearing hooded baggy clothing, arrived in a silver-colored SUV, believed to be a 2016-2018 model Acura RDX. No visible license plates were shown.

Galt Police Lt. John

Rocha told KCRA 3 that events like last week's string of burglaries were "never a good thing."

"I mean, it affects our local business owners and the community," he told KCRA 3. "It costs money to repair the locations and at the same time any losses incurred: They have to deal with that."

as a coach, both stateside and overseas in Japan and Mexico.

"My story is not one of tragedy, drugs and alcohol," Cartwright said. "It's not like that. It's just a reflection of my family, friends, coaches and what you are able to accomplish. The trophies and all that stuff, that is nice, but it is more about my coaches, my teams and my teammates, because that would not have been possible if not for them."

Cartwright, who is now the director of university initiatives at his alma mater, sat down with the Elk Grove Citizen on Jan. 2 to discuss the book, his life and what he hopes younger athletes might pull from the 5-time NBA Champions life, both on and off the hardwood.

Sean P. Thomas: What drove you to write your autobiography? What was that moment that spoke to you and said, 'Hey, I should sit down and get this on paper?' Was that something that you always wanted to do?

Bill Cartwright: "It was interesting because without the pandemic it would not have happened. It is something that I had been thinking about, and it's really interesting because

I am such a reflection of the people I grew up with, parents and coaches. So, I thought it was a great opportunity to do this reflection of my journey. I've really been all over the place, so it really made you start questioning a lot of things. It made me question my parents, and how well I knew them. You really find out that, 'Hmm, I have known them my whole life, but I didn't know a whole lot about them."

ST: With this being your first step into writing, did you look to any other sports autobiographies for guidance?

BC: We had no clue. That was the hardest part because we had to start over about three times to kind of format this and how we wanted to start and finish. As you know, every single person has their opinion, so it was kind of nightmarish.

ST: As you are reflecting on your upbringing, you kind of noted the hard work that was instilled in you from a young age. Is that something that you had reflected on prior to starting this autobiographical journey? Or something that became apparent as you worked through your past growing up and working in

Lodi, Sacramento and playing in Elk Grove?

BC: That is who the Cartwrights are, but that is also who Elk Grove was. We are a working community. A lot of farmers, but you worked. There were not a lot of affluent people around. Everyone was kind of in the same boat: white, black, Hispanic, Filipino, Portuguese, Asian, we were all kind of in the same boat, but you know one thing, is that you could work.

That was the time, too. Elk Grove High School was not the reflection of Ivy League education; it reflected work.

During the summer, the whole family picked tomatoes. If you could imagine a bunch of kids running around picking tomatoes for eight hours a day. People go, 'Hoeing sugar beet fields?' Oh yeah..."

ST: I'm sure basketball practice couldn't really compare to that.

BC: Oh yeah, after we moved to South Sac, probably a year after that that all stopped because of school. But that transfer of work went into sports.

ST: What other lessons did you pull from your time as a player?

BC: In college and the NBA, you learn to be able to adapt, to be able to adapt

to different coaches and listen to them. Everybody has a different vision for you. I'm like, 'But I'm a shooter.' 'Well, not now you are not.'"

ST: Which is interesting because now in basketball it's positionless almost.


BC: You said that perfectly; I mean, there is (the Sacramento Kings' Domantas) Sabonis bringing the ball up.

ST: To piggyback on that discussion about evolution, what was that transition from player to coach like as you wrapped up your career and how did you approach covering it in your autobiography?

BC: I had never intended to coach. Period. It's genius that my next career worked out. For all my brilliance, I was going to be a McDonald's operator. Throughout my 16-year (career), I thought what could I do so that I could be successful?

Then I got a phone call from Jerry Krause, and he asked me to coach. I was coaching an eighth-grade girls' team up in El Dorado Hills; it was really fun. But then Jerry calls me up and says, 'Do you want to coach?' And I'm thinking ... no."

I knew there were a few

guys up there who wanted to coach, and I didn't want to step over them, and I told him that. That was kind of my way out.

He called me back later and told me, 'Man that shows a lot of character,' Oh great, now he thinks I have character. I was trying to get out of this thing.

So, I thought, that is where I was being led and I talk about this in the book as well. The decisions you make in your life, you think you are making them, but they are kind of making them themselves.

ST: Is there a lesson that you hope younger players take from your experience?

BC: If you are a kid, a high school kid, or a college kid and you have ambition, just do more.

Do more; more is always better. If that is what you want to do. I didn't shoot more because I was ordered to. I shot more because that is what I liked.

It just becomes a part of you and what you like. If you don't want to play, that is all right as long as you are doing something.

What a difference a week makes! Yes, a lot can happen in a week, and the Sacramento Kings are living proof.

Gone is former coach of the year, Mike Brown, and interim head coach Doug Christie not only is riding a season high 4-game winning streak, he's riding a basketball juggernaut as well.

Wins over injury depleted Dallas Mavericks and Philadelphia 76ers were welcome wins, but to handily defeat the Memphis Grizzlies and archrival Golden State Warriors back-to-back was a sign that the Kings were truly on the road to recovery.

A horrid 6-game losing streak was the undoing of Mike Brown, and every pundit, newscaster and fan had a different opinion. The general consensus was that coach Brown had lost the locker room, and after a meltdown loss to the Detroit Pistons in which collectively the Kings and in particular DeAaron Fox guarded no one, the Pistons came away with an improbable 1-point win. 4-point plays to win a game are a rarity, and it's no fun to be on the losing end, but that's precisely where the Kings found themselves.

Whether coach Brown had truly lost his voice with the team is still open to conjecture, but from this writer's perspective, his lack of any consistency as it relates to playing time for players off the bench, led to overall sub-par productivity. Players from Keon Ellis, Alex Len, to Trey Lyles never knew from one game to the next if they would see significant minutes or no minutes at all.

Doug Christie was tapped on the shoulder and asked to take over the head coaching reigns, and so far, he's been a welcome addition to the head seat.

Some players have commented that Christie brings the mindset of a former player to the table, and thus far his voice is being heard. In particular the defensive end of the court has seen significant improvement, and the past four games have featured some of the best defensive basketball that fans have seen

A wire-to-wire victory over the Golden State Warriors in which Sacramento never allowed the Warriors any breathing room, was a glimpse of what the Sactown boys are capable of, and Malik Monk had perhaps his finest game of the season. Malik matched Steph Curry with 26 points and added a season high 12 assists, but his defense was equally impressive. Domantas Sabonis had his usual stellar performance, adding 22 points and 13 rebounds while playing only three quarters.

Does coaching make a difference? You bet it does. Does that mean that winning four of five games since Mike Brown's departure, the Kings are headed to the playoffs.

Too early to tell Kings fans but take solace in seeing what your hometown boys are capable of doing. Not just playing tough teams and winning, but actually accomplishing blow-out wins.

Keon Ellis has returned to form and did a yeoman's job in filling in for an injured DeAaron Fox in the win over the Warriors. Keon has a big upside, as does Trey Lyles who is also showing signs of looking like his former self, playing solid basketball on both ends of

Say hello to Devin Carter Kings fans, and this young rookie has game! Playing in just his 2nd NBA game, Devin broke into the scoring column with 13 points while adding an impressive seven rebounds. This youngster has been on the sidelines all season recovering from off-season shoulder surgery, and he looks eager to impress his fans and teammates alike. I like what I see in Devin, and his defense in particular on Stephon Curry was impressive to see. His debut has been a long time coming, and it could not have come at a more auspicious time. I look for coach Christie to give him all the playing time he can handle, and with the unfortunate departure of Davion Mitchell, another guard that can play ferocious defense is a welcome sight.

Stay tuned Kings fans and stay away from ugly trade rumors. Trades will invariably come, but let's just hope it doesn't involve the core members we've come to love!

Services-Screening Coordination Call Center simplifies access to mental health and substance use treatment services by combining multiple phone numbers into one centralized line at 916-875-1055. This new service integrates the Mental Health Access Team and the Substance Use Prevention and Treatment System of Care under one number. By doing so, Sacramento County ensures that individuals in need can receive timely coordination among providers and improve health outcomes for those struggling with mental health and

substance use challenges.

"The BHS-SAC Call Center is a game-changer for our community," said Dr. Ryan Quist, the Behavioral Health director. "By centralizing these essential services, we're breaking down barriers to care and simplifying how our community can receive mental health and substance use resources."

Implementation of Senate Bill 43 (SB 43)

Sacramento County will implement the state's modernized law for involuntary psychiatric holds, which expands the definition of

"gravely disabled." This new definition includes individuals unable to care for their basic needs for health and safety due to a severe substance use disorder or a co-occurring mental health disorder and severe substance use disorder.

Senate Bill 43 also broadens the definition of "basic needs" to include a person's ability to obtain necessary medical care, personal

safety, food, weather-appropriate clothing and/or shelter. The updated law will expand access to acute and long-term care


for our most vulnerable community

members who meet the definition

of gravely disabled and are suffering from a severe substance use disorder.

These efforts are part of a broader initiative in California to address homelessness, mental health crises and substance abuse treatment. Chispa has a simple mission: Sponsor children's libraries and equip them with quality books in Spanish by working side by side with Honduran community leaders and educators.

In the 80 schools where Chispa works, they build alliances with communities to design, fund and manage their own libraries. Community members also volunteer in the library project and raise a symbolic portion of the funding that ensures sustainability and ownership.

"What will we do during the volunteer week?" asked another.

"We begin the day after arrival by decorating library spaces that will make children proud of their school. We paint the walls with colorful murals, assemble bookshelves, and stock and catalog an entire library.

"Imagine us working together, rolling two coats of white paint on crumbling walls. The paint provides a bright pallet for those murals intended to inspire future readers.

The children will surround us, chattering the few English words they know. Their smiles go for miles as they read the picture books we bring."

from a young age. In this report, the Board makes a number of recommendations that we encourage policy makers, law enforcement agencies, and community advocates to consider to eliminate bias in policing and enhance public safety.'

"The annual collection of RIPA stop data is one part of our broader effort to increase public safety for all Californians. Through the analysis of stop data and recommendations for thoughtful reforms, we're continuing to strengthen trust between local law enforcement and the communities they serve," said Attorney General Rob

"This year's report takes a close look at the policing of youth and the lasting impact interactions with police can have

at a young age. I'm grateful to the board and staff at the California Department of Justice for continuing to shine a light on disparities in police stops at every age and provide recommendations for targeted data-driven reforms."

The information collected under the act includes data on peace officers' perceptions of the demographics of stopped individuals, such as race or ethnicity, gender identity, sexual orientation, age, and disability. The board uses several well-established methodologies to analyze the data and determine whether disparities can be found across demographic groups and whether bias exists.

The board's report also contains a wide array of policy recommendations related to policing, with a particular focus interactions with youth, civilian complaint processes, accountability, officer decertification, and training, on racial and identity profiling.

Through this data analysis and these recommendations, the board reaffirms its commitment to improving public safety and achieving the legal mandate to eliminate the racial and identity profiling

of all Californians.



Got a Green Thumb for Houseplants?

According to the National Day website, one of the best ways to enhance a space is by adding house plants.



When Losing is Still Winning

SACRAMENTO REGION, CA (MPG) - Rio Linda High School alumnus and former Sacramento State Hornet Cam Skattebo gave 110% in the Sun Devils' 39-31 College Football Playoff loss to the Texas Longhorns in the Peach Bowl on New Year's Eve. Skattebo transferred from Sacramento State University to Arizona State University following the 2022 season and just completed his senior year, culminating with the thrilling overtime loss to the Longhorns.

Skattebo's frenetic "never say quit" playing style, he was famous for from his time as a Hornet, carried over to his time as an Arizona State Wildcat and was exemplified by his Peach Bowl performance.


Over four quarters and overtime of the 2024-25 Peach Bowl, the 22-yearold racked up 284 total yards, 143 rushing, 99 receiving, and 42 passing. Skattebo's Peach Bowl

performance included two rushing touchdowns, a passing touchdown, and a two-point conversion. A herculean effort from the 5-foot, 11-inch, 215-pound senior running back.

Skattebo's performance was so great that despite being on the losing end of the game, he was named the Offensive Most Valuable Player of the Peach Bowl. It's the first time in 26 years that a member of the losing team has won the game's Offensive Most Valuable Player award.

Prior to the Peach Bowl, Skattebo had foreshadowed his game performance in his media day comments on Dec. 30. "There's nobody out

there that can stop me." Skattebo said. "If they're studying hard, there's a reason. I have full respect for them, because they understand what they're playing against, and that's why I love playing in games like this, because they constantly look at me as a

threat, and that's something I've always wanted to be. And if I'm a threat on the football field against an SEC team that was the runner-up to win their conference, then I think I'm in a pretty good position."

In 2024, Skattebo had a

breakthrough senior season, rushing for 1,568 yards and 19 touchdowns while catching 37 passes for 506 yards and three touchdowns. Making him the first Big 12 player ever to have at least 1500 rushing yards and 500 receiving yards in the same season and the first FBS player to do it since Christian McCaffrey in 2015. The star running back finished fifth in Heisman Trophy voting.

While Skattebo and the Arizona State University Wildcats would have preferred to beat the Longhorns in the Peach Bowl and advance in the College Football Playoff, the Offensive MVP award is an admirable accomplishment for one of the nation's top running

SACRAMENTO REGION, CA (MPG) - A spectacular sophomore season has translated into a ticket to the next level for Sacramento State sophomore forward Donovan Sessoms, who was selected with the first pick of the third round (No. 61 overall) by expansion side San Diego FC in the 2025 Major League Soccer (MLS) SuperDraft on Dec. 20.

Sessoms is the first Hornet to be taken in the MLS SuperDraft since Chimdum Mez was taken in the fourth round (66th overall) by the San Jose Earthquakes, and the fifth Sacramento State student-athlete to be drafted by an MLS club in school history along with Brandon Cavitt (1996 College Draft, Dallas Burn), Ernesto Carranza (2011 Supplemental Draft, Chivas USA), and Fernando Cabadas (2011 Supplemental Draft, New England Revolution).

San Diego FC had five selections in the draft, building a roster as the newest of Major League Soccer's 30 clubs that will compete in 2025. The city was awarded a franchise in May of 2023 and will play its first match on Feb. 23 against defending MLS Cup champion LA Galaxy.

An All-Big West first-team selection in 2024. Sessoms put together one of the finest offensive seasons in school history, finishing with a team-high 10 goals and 20 points for the year, both ranking among the top 10 in single-season history. Half of those 10 scored went for game-winning goals, ranking tied for fifth in the nation.

Among his Big West Conference brethren, Sessoms ranked third in the Big West in shot attempts (48) and led the league with 2.67 shots per match. He also finished fifth in the league in points, fourth in points per match (1.11), fourth in goals, and third in goals per match (0.56).

The 33-year-old right-handed hitter combined for a .250 batting average in 128 games overall, making 102 starts at third base and 15 at first base. Urshela is a .273 career hitter with 73 home runs, 332 RBI and a .729 OPS in 792 games over nine seasons in the majors with Cleveland (2015, 17), Toronto (2018), New York-AL (2019-21), Minnesota (2022), Los Angeles-AL (2023), Detroit (2024) and Atlanta (2024). He batted .299 in 62 games with the Angels in 2023 before a fractured pelvis ended his season in mid-June. The native of Colombia had

quarter, Galt dropped 19 points compared to Rosemont's nine. Joseph Gomez swished in three 3-pointers to help close the


In the fourth quarter the Warriors scored nine points while the Wolverines dropped 11 and it just wasn't enough to finish Rosemont off.

Nothing but net as Joseph Gomez scores from 3-point line.




