PTP Youth **Basketball Announces New Award Program**

YUBA CITY, CA (MPG) - The Prince Training Players (PTP) Youth Basketball Program in Yuba City recently announced a new "Player of the Month" award series starting in December.

Javeyon Brown from Marysville High School and Torrence Harter from Sutter Union High School were named Prince Training Players' first Players of the Month. Both have maintained an average GPA of 3.5 and received high accolades from their respective coaches.

"We're looking at not just the athlete on the floor but also into their academics: the student-athlete," said Gerrard Prince, Prince Training Players' founder and head coach. "It's about

their all-around character."

Prince has led Prince Training Players for about six years now and said he is always looking for ways to inspire young athletes. His love for basketball developed in Los Angeles while growing up in what he called a particularly rough neighborhood.

"Basketball was an outlet that I felt kept me on a straight and narrow path," said Prince. "As the son of a single mom, it was everything to me."

Through basketball, Prince received the opportunity to play for Yuba College between 1987 and 1989, but at age 23, was diagnosed with a severe case of Rheumatoid arthritis. No longer able to play, Prince said, he was consumed with depressive thoughts and wasn't sure what to do next. He again focused on basketball, this time focusing his efforts on coaching.

"I had a son and I decided I wanted to start training him," explained Prince. "He went on to become two-time Player of the Year in this area and also Player of the Year in MaxPreps his senior year."

Prince's son is Keenan Prince, a local basketball legend who, after many accolades, now is an educator in Sacramento. His "Player of the Year" titles inspired Gerrard Prince in part to start up his own

"It's about building better players and better people," said Prince. "The impact I make on a child's life far beyond when they stop playing for me means far more than the wins and losses.'

Timeline of Events

February 2006

The City of Marysville issues its first "Notice to Correct" to the owners of the State Theater, citing code violations. Necessary improvements include repairs to the marquee, roof,

Yuba County Awarded \$35 Million Federal Grant

YUBA COUNTY, CA (MPG) - Yuba County Public Works was awarded its largest federal transportation grant, a major milestone for improved safety, access, and future development of south Yuba County.

The \$35.5 million grant, awarded on Tuesday, will help extend Plumas Lake Boulevard, connecting it to Plumas-Arboga Road via two new bridges. This project will make travel safer and easier, especially for residents and visitors in the area. Yuba County was just one of two California jurisdictions to be awarded funding through the Rural Surface Transportation Grant Program from Department of Transportation.

"This is a vital project for the future of south Yuba County and will increase safety and improve access between Plumas Lake on Highway 70 and Beale Air Force Base, Wheatland, Hard Rock, Toyota Amphitheater and future development in the Sports and Entertainment Zone on Highway 65," Yuba County District 4 Supervisor Gary Bradford said. "I'm excited that we received this grant, as it will ensure the project has the necessary funding to move forward."

This interchange will offer direct access from Highway 70 to our Sports and Entertainment Zone, eliminating the need

to cross the railroad tracks at Algodon. This safer route will also provide a way out of Plumas Lake without having to cross the tracks, which is important for potential emergency situations. The project is also key for the proposed North Valley Rail Stop in the area.

"Overall, this project is a multi-modal jumping-off point," said Dan Peterson, former Yuba County Public Works Director who applied for this grant for the County. "One challenge faced by potential developers and residents alike is being able to get to and from this area safely."

The timeline includes completing design and land acquisition by summer/fall 2025, starting construction in 2026, and completing the project in late 2028/early 2029.

This project is part of a long-term plan that started back in 2005, when Yuba County began working on an interchange at Plumas Lake Boulevard and Highway 70. The grant will help fund the second phase of this project.

Yuba County's Sports and Entertainment Zone, established in 1998, spans 1,000 acres at Highway 65 and Forty Mile Road in Wheatland and is home to Hard Rock Hotel and Casino and the Toyota Amphitheater. This project aims to improve safety concerns and access challenges and support future development in the region.

WASHINGTON, D.C. (MPG) - On Jan. 14, Congressman Doug LaMalfa (R-Richvale) released the following statement after the House passed H.R. 28, the Protection of Women and Girls in Sports Act. This bill allows women and girls a fair playing field in sports by ensuring that school athletics

comply with the Title IX recognition of a person's actual chromosomes and sex at

'This passage is significant win for fairness and integrity in women's sports. This bill ensures that female athletes can compete on an even playing field, staying true to the original purpose of the Title IX. Women and girls deserve the chance to succeed in sports based on their own hard work and talent, without facing the unfair challenge of competing against biological males. This legislation stands up for the rights of female athletes, protecting their right to privacy and safety in places like bathrooms and locker rooms, and preserving the principles of competition and fair play that are at the heart of sports. It's a straightforward matter and we're pleased to be taking action to protect the future of women's athletics," said Rep. LaMalfa.

Representative Kiley to Introduce Legislation to Rein in Coastal Commission Abuses

WASHINGTON, D.C. (MPG) - Representative Kevin Kiley (R-CA) will introduce legislation to amend the Coastal Zone Management Act (CZMA) to limit the scope of state authority to review certain activities, including national security-related activities, critical infrastructure projects and activities with high economic impact, including post-disaster recovery and rebuilding.

This initiative will ensure that vital aerospace and defense initiatives can move forward without undue delays and that rebuilding efforts are not unduly impeded following the catastrophic fires in Los Angeles.

"The Coastal Zone Management Act was never intended to allow state agencies to prioritize partisan considerations over national security and economic progress," said Rep. Kiley. "The Commission's vote to block additional launches at Vandenberg undermines our national defense readiness and threatens California's leadership in aerospace innovation, and its history of irrational decision-making could threaten rebuilding efforts in the Los Angeles area. My legislation will ensure that critical projects are not held hostage by unnecessary red tape or political bias."

The Coastal Zone Management Act (CZMA) allows coastal states to review federal activities for consistency with state coastal management policies. However, recent objections from the California Coastal Commission (CCC) to SpaceX's request to expand Falcon 9 launches at Vandenberg Space Force Base demonstrate how the politicization of the state agency decisions can delay projects critical to national security. The Commission's 6-4 vote against granting concurrence hinders both defense operations and California's leadership in aerospace innovation. The debate prior to the vote included criticism of SpaceX CEO Elon Musk's political views and labor practices, highlighting concerns about political bias influencing the decision.

Kevin is proud to have been born and raised in California's third district and educated within its local public schools. He resides in Rocklin, CA. California's 3rd Congressional District is the most geographically diverse in California, spanning most of the California-Nevada border and includes Plumas, Sierra, Nevada, Placer, Alpine, Mono, and Inyo, and parts of Yuba, *El Dorado, and Sacramento counties.* ★

Sutter County Sheriff's Office Cites Clerk for Selling Alcohol to Minor

SUTTER COUNTY, CA (MPG) - Sutter County Sheriff's Office along with agents of the California Department of Alcoholic Beverage Control (ABC) have cited one clerk for selling alcohol to a minor on Jan.

The actions were the result of a Minor Decoy operation in which minors, under the direct supervision of department agents, attempted to purchase alcohol from eight retail licensees in Sutter County.

Clerks who sold to a minor face a minimum fine of \$250, and 24 to 32 hours of community service for a first violation. In addition, the California Department of Alcoholic Beverage Control may take administrative action against the alcoholic beverage license of the business where alcohol was sold to a minor. That may include a fine, suspension, or the permanent revocation of the license.

under the age of 21 have a much higher risk of being involved in a crash than older drivers. About 25 percent of fatal crashes involve underage drinking according to the National Highway Traffic Safety Administration (NHTSA).

Minor Decoy operations have been conducted by local law enforcement throughout the state since the 1980s. When the program first began, the violation rate of retail establishments selling to minors was as high as 40 to 50 percent.

When conducted on a routine basis, the rate has dropped to below 10 percent in some cities. In 1994, the California Supreme Court ruled unanimously that use of minor decoys is a valid legal tool of law enforcement to make sure that licensees are complying with the law.

Funding for this program was provided by a grant from the California Department of Alcoholic Beverage Control through the department's Alcohol Policing Partnership (APP) program.

Repairs are partially completed but progress stalls. The marquee remains unrepaired and owners fall out of compliance. The city imposes fines, which the own-

ers unsuccessfully appeal four times.

May, 2008

The owners accuse city officials of mail fraud and ethnic discrimination, claiming notices were sent to the wrong address.

They allege federal agents have advised them not to speak to city officials, asserting that the FBI is investigating the city.

City officials deny any knowledge of an FBI investigation.

At this point, the owners owe \$18,000 in fines.

August 2008

The city undertakes repairs to the marquee, billing the owners \$6,300.

January, 2009

The Marysville City Council votes to file a lien against the State Theater to recover \$47,031.65 in fines and administrative costs.

Don Melvin requests an extension, citing George Benny's health issues. The council denies the request.

1998-2016 City records show that the State Theater

was last inspected by the fire department in 1998. During this time, conflicts between the city and the owners persist.

November 2016

theater but are denied access. A warrant is obtained to conduct the inspection. revealing numerous fire code violations, including vehicles in the lobby, cushions and other debris.

May, 2017

The owners appeal a \$100 fine for failing to correct fire code violations, arguing that stacking cushions as required is impossible in the space.

The City Council denies the appeal, declaring the property a public nuisance.

Fire Inspector Julie Gibbs sets a compliance deadline of May 20, 2017. Noncompliance will result in escalating fines of \$200 and \$300 per day.

Next Steps

Typically, if fines and liens on a building remain unpaid, a city can take action such as placing a lien on the property, initiating foreclosure proceedings to sell the property, demolishing the building if deemed a public nuisance or taking the property owner to court to recover the outstanding debt, including legal fees.

The Territorial Dispatch reached out to both Jim Schaad, Marysville city manager, and Dan Flores, Marysville Community Development director but did not receive a response other than that there were "no updates at this time" from Schaad. Whether the city or its fire department ever successfully collected the fines imposed on the theater's owners has yet to be confirmed. Attempts to contact the property's owners were also fruitless, as of

Kern County Immigration Sweep Halts Citrus Harvest

Scores of farmworkers stayed home last week amid an immigration enforcement operation conducted in Kern County by U.S. Border Patrol. "The crew didn't show up," said Peter Belluomini, who grows and packs lemons, mandarins and navel oranges east of Bakersfield, and is in the middle of harvesting all three crops. "Instead of 30 people, there were like five," said Belluomini, referring to workers hired through a farm labor contractor for his citrus harvest. "The rest were hiding at home."

State Water Board Readopts Drought Flows for Siskiyou County

Even though hydrologic conditions point to a more positive water outlook for the Scott River and Shasta River in Siskiyou County, state water officials last week readopted drought emergency regulations that curtail water rights in the region, affecting farmers and ranchers. The regulation first took effect in 2021. Readopted for the Scott River and Shasta River watersheds every year since, the order limits surface-water diversions and groundwater pumping.

California Bountiful TV tours San Diego County

In its latest episode, California Bountiful TV explores agricultural and culinary landmarks in San Diego County. Host Aubrey Aguino visits the nation's only producer of avocado oil, a family-owned and -operated egg ranch and a mushroom farm that's tucked into the hills of Escondido. Disaster-Prone California Should Adopt a Preventive Approach, Rather Than a Reactive One

As horrific as they may be, the wildfires sweeping through Los Angeles neighborhoods, destroying homes and businesses and killing dozens of people, are certainly not unprecedented.

Rather, they join a California continuum of natural and human-caused disasters that have afflicted the state throughout its history — fires most recently, but also earthquakes, floods, dam collapses and deadly riots. It's as if Californians must endure periodic calamities as the cosmic cost of enjoying unmatched attributes of weather, scenic beauty, mineral wealth and enormous amounts of arable land.

Precisely 60 years ago, for example, the ruggedly beautiful northwestern corner of California coped with immensely destructive flooding from epic storms. The Eel River basin received 22 inches of rain in just two days.

Several small towns along the Eel and Klamath rivers were destroyed, drowned in as much as 50 feet of water, and dozens of state and local bridges were demolished, isolating the region. The federal government even sent naval ships, including an aircraft carrier, to bring relief supplies and assist in search and rescue efforts.

Less than a year earlier,

Crescent City, a Del Norte County town afflicted by the floods, had been clobbered by a tsunami touched off by a massive earthquake in Alaska.

The persistence of disasters befalling California is underscored by just one data point: During Pete Wilson's governorship in the 1990s, every California county was declared a disaster area at least once, and several times in some counties.

Wilson's emergencies included the 1994 Northridge Earthquake, the 1992 Rodney King riots and heavy flooding in 1997 that sparked disaster declarations in 48 of the state's 58 counties.

Simultaneously during his time in office, California experienced the worst recession since the Great Depression, a severe drought and was just beginning to recover from the 1989 Loma Prieta earthquake in the San Francisco Bay Area that destroyed a section of the Bay Bridge, among other

It was as if the four horsemen of the apocalypse were galloping across California, dragging Wilson behind

To his credit, Wilson figuratively shrugged his shoulders and assumed the role of crisis manager, even though, ironically, the disasters undermined his plans for "preventive government" that would deal with issues before they became crises.

If disasters of one kind or another are baked into California's existence, what could be done to mitigate their impacts?

When it comes to floods and wildfires, we could — if we had the political will either stop building homes in areas prone to flood or fire, or at least impose strict standards on construction to make buildings less vulnerable, as we do for earthquakes.

There is some anecdotal evidence that homes built with fire-resistant materials, including non-flammable roofs, have fared better in the Los Angeles fires. We could start by imposing tough new building standards when neighborhoods scorched by current fires are rebuilt.

We also need to plan for better escape routes and install better systems for warning people to evacuate. The narrow winding streets in Southern California's upscale communities became death traps for some.

Finally, we need a new approach to insurance coverage. Insurance Commissioner Ricardo Lara is finalizing a new regulatory system that would let insurers include estimates of future losses and costs of reinsurance in their premiums, hoping that it would prop up a very unstable

Maybe we should go beyond that. Maybe we need the state to provide basic casualty coverage in a master statewide policy financed by mandatory fees on property, with the option for property owners to purchase supplemental coverage.

If disasters are unavoidable in California, we need to accept that fact and adopt Pete Wilson's preventive approach, rather than merely reacting after the fact.

Wild Fires and Cal Fair

With wildfires once again in the news, the first thing I thought was "Its wintertime, who has massive wildfires in winter?!"

What I found out it had been quite some time since the Pacific Palisades had any significant rainfall. Hence the wood fuel was very dry. I also saw the rows of houses right on the beach front had been obliterated. That I would never had expected. After all, if I had a home on the beach, I would be thinking wave erosion, tsunami, storm surge and flooding, but never wildfire.

But what they do have are the occasional high winds, often referred to as the Santa Ana winds. They can occur all through many southern California areas and they can reach very high velocities.

If anyone has ever fanned a burn pile with a blower, you know how high winds can fan a fire like no other. Add high velocity air to a fuel source and you get an entirely different type of burn. Think jet engines, metal forging or supercharged cars. High velocity wind does the same thing. High winds cause fires to burn faster and at higher temperatures as more air is forced into the flames.

With 60 mph winds at times, there is no stopping it. Embers go sideways. Fires burn white hot. Containment is only possible at the side of the fire, if that. Getting in front of it is impossible. Think flaming freight train and you get an idea how fast and how devastating these wind driven fires can be.

Impossible to stop, moving at lighting spend with incredible temperatures, they incinerate everything in their path into

As a Cal Fair authorized agent, I often get calls from homeowners saving they have cleared the bushes around their property, sometime up into the hundreds of feet. They basically have a house on a football field like landscape. There is nothing within hundreds of feet in any direction to burn. The homeowners complain that there should be no reason to pay sky high rates for fire coverage or perhaps be cancelled all together. They claim they are being redlined by insurance companies who look at a zip code and carte blanche cancel every house in it. Many homeowners think they are being unfairly treated or singled out because of a negligent neighbor who refuses to clear his land but they fail to understand the insurer's point of view and the nature of these windblown monsters.

I did a film covering the CAMP FIRE that occurred near Paradise, California, three years after it happened. What used to look like Yosemite looked more like Lodi. Entire blocks were obliterated, sometimes leaving a moon type landscape. Oddly, in the middle of it might be one house that was spared for whatever

Speaking with a retired firefighter whose house was one of the first ones hit, he said "you just don't know how fires will move. One house might be left standing while all the houses around it are gone".

I revisited the area just last week and spent the day with the same firefighter who gave me a tour around the city now 6 years later. Much of the devastation has been cleared away but there is much work to be done. Entire areas are still bare, many lots are still vacant and contractor vehicles still permeate the city roads buzzing to and fro to various work sites. City and utility crews are still found everywhere and the town still looks somewhat empty mid-day.

Wildfires such as the Camp Fire in Paradise and the Pacific Palisades fire are horrific events, leaving landscapes similar to an atomic bomb blast without the radiation. Entire areas are wiped clean. And the fire themselves, when happening, can be unstoppable.

Insurance companies know all too well how devastating these fires can be and the damage they can cause.

In conclusion and in my opinion, homeowners in high risk fire areas are not being picked on by greedy insurance companies. The reality is the risks are real and the costs can be immense.

The biggest wild fires themselves can be horrific, incinerating monsters, traveling at incredible rates of speed, virtually unstoppable and destroying everything in their path

In other words, treat it almost like a professional sales call. And don't be afraid to have a little fun with it. If you're still under consideration, that means they like you and you have a shot at the position. You might even hint at the fact they don't want to hire a sales manager who doesn't know how to follow up.

You obviously have sales skills if you worked your way up to a manager's position. So, put those skills to work. If you're on a sales call, and the customer needs to perform some due diligence before deciding,

a smart salesperson will request to schedule a follow-up. In your email, ask if checking back on a certain day in the next couple of weeks will work. You don't want to be obnoxious, but you're looking for an appointment of sorts—a time frame—so you'll know when to follow up without seeming pushy or desperate.



Kings Korner By V.G. Harris



Who's the hottest team in the NBA right now?! Well, if you're Steve Kerr, he's telling his Golden State Warriors it's the Sacramento Kings, as the former world champs embark on their short journey from the bay area to Golden One Arena on Wednesday night.

Winners of 9 out of the last 10 games. only the Milwaukee Bucks kept the Kings from riding a 10-game win streak.

Solid playoff bound teams like the Celtics, Bulls, and Rockets met with the defensive minded Sactown boys, and each came away wondering what just hit them.

Is there reason for optimism in Sacramento? You bet there is, and if there's one thing the Kings need to be caution of, it's making an ill-advised trade.

You find many fans or commentators that will argue that the Kings need to strengthen their front court, and the reason is that the current alignment is not living up to their billing.

Third year player, and much lauded Keegan Murray is having a subpar season, and if he doesn't watch out, fans will stop looking at him as a 3-point shooter. As of late, Keegan has made more impact on the boards and on defense than he has as a shooter. Sadly, in a 23-point blow-out of the Wizards, Keegan contributed only 4 points and failed to connect on all 5 of his 3-point attempts.

Not to be left out, Trey Lyles, who has been playing abysmal basketball as of late, scored only 4 points as well, while taking up 20 minutes of play on the hardwood.

Once considered the Kings 3-point assassin, Kevin Huerter took a total of six 3-point shots, connecting on just one. So, Murray, Lyles, and Huerter made exactly one 3-point field goal while putting in a combined 61 minutes of play on the hardwood.

Why do I point out the negatives with the Kings winning 9 out of 10 games and climbing above the 500 mark? Sadly, none of the three just mentioned are likely to bring anything of value on the trade

While Keegan Murray held significant value on the trade market just one year ago, his interest and value has dropped to an all-time low, and many teams are likely not interested in Keegan at all.

Similarly, Kevin Huerter is fortunate to make a basket from 3-point land at all, and the former starter for the Kings and 3-point specialist is likely to fall into the same disinterest category as Keegan Murray.

As for Lyles, like Keegan, he's having a subpar performance in 2024/2025, and his lack of offensive productivity will likely garnish him little interest from other teams.

Unfortunately, while teams turn away from trade offers for Murray, Lyles, and Huerter, they will be coming strong for players like Fox, Monk, and possibly even

Of all the players the Kings have currently, it's possible that Keon Ellis has the most prolific upside. Ellis remarkably is supplanting other players on the team, as a Bonafide 3-point shooter. In Sunday night's win over the Washington Wizards, all Keon did was score 18 points in 18 minutes, while connecting on six 3-point shots to lead all players from beyond the arc.

Pay attention Sacramento, and I'm talking to you Monte McNair. Keon Ellis brings game on both ends of the court.

Sabonis remains untouchable if there is such a term in NBA circles today, but the gossip surrounding DeAaron Fox needs to die down, as any trade involving Fox from this writer's perspective is a bad idea.

The Kings need to hold the fort, pay little attention to trades involving Fox and Monk, and hope that Murray, Lyles, and Huerter will return to some form on shooting acumen. Slumps don't last forever, and the fact that the Kings have played with such assiduous vigor and success over the past 3 weeks gives Sactown some muchneeded breathing room.

Tdap Vaccination Urged as Whooping Cough Increases

California Department of Public Health News Release

SACRAMENTO REGION, CA (MPG) - California is experiencing an increase in cases of whooping cough (also known as pertussis), a highly contagious bacterial disease that can be spread though coughing and can cause severe illness, especially in infants. California Department of Public Health is urging all Californians, especially those who are pregnant and those who provide care to infants, to be up to date on their Tdap (tetanus, diphtheria, pertussis) vaccine to help prevent whooping cough.

Individuals vaccinated against whooping cough are protected against severe illness and complications due to whooping cough. These complications can be most severe in infants, causing apnea (dangerous pauses in breathing) and can be fatal.

More than 2,000 cases of whooping cough were reported statewide between January and October 2024. 62 of those cases were infants less than four months of age who were hospitalized, including one infant who tragically died. During the same time range in 2023, there were less than 400 whooping cough cases reported in the state.

"Since the COVID-19 pandemic has subsided, many practices that had lowered instances of whooping cough are no longer in place, and we're seeing the disease return to pre-pandemic levels," said Dr. Tomás J. Aragón, California Department of Public Health Director and State Public Health Officer. "Infants are particularly vulnerable and that's why California Department of Public Health especially encourages people who are pregnant to receive the Tdap vaccine in their third

trimester which will pass along protective antibodies to the baby."

With whooping cough cases rising, ensure you are up to date on your whooping cough vaccine. Vaccination is recommended for all:

Pregnant people between 27 and 36 weeks of pregnancy, even if they have received Tdap in the past.

Adults, every 10 years.

Adolescents aged 11 or 12 years (Tdap vaccine is also required for 7th grade advancement in California).

Infants and young children receive their own whooping cough (DTaP) vaccines starting at 2 months through 4-6 years of age. Babies and children who haven't had all recommended doses are more likely to have serious complications.

Talk to your doctor or pharmacist about which vaccines are right for you and your family. People with whooping

cough have severe coughing attacks that can last for months. Infants too young for vaccination are at greatest risk for hospitalization and death. Early signs of whooping cough are similar to symptoms of the common cold such as a runny or stuffy nose and low-grade fever. Babies with whooping cough may have trouble breathing, turn blue or stop breathing.

To protect infants from whooping cough, California Department of Public Health strongly urges maternal immunization with Tdap (tetanus, diphtheria, pertussis) vaccine in the last trimester (between 27 and 36 weeks) of every pregnancy. When given during pregnancy, Tdap is approximately 90% effective in preventing infant hospitalizations due to whooping cough. It is also beneficial for all family members and caregivers of newborns to receive either the Tdap (for adults and children older than seven) or DTaP (for those seven years of age or younger) vaccines to prevent spreading whooping cough to infants.

These vaccines are safe and effective and can be received at the same time as flu, COVID, or RSV

Tdap vaccines are widely available at many doctor offices and pharmacies. Schedule a vaccine appointment by visiting MyTurn.ca.gov or contacting your local pharmacy or health care provider.

Most health insurance plans, including Medi-Cal, cover Tdap vaccines. Individuals experiencing difficulty finding a place to get immunized may contact their health care provider or local health department for help.

The Vaccines For Children (VFC) program is a federally funded program that provides vaccines at no cost to children (18 and younger) who might not otherwise be vaccinated because of an inability to pay. Contact your doctor to learn if they are enrolled in Vaccines For Childrenor visit MyTurn to find a location based on your eligibility.

Get more information about whooping cough or pertussis by visiting California Department of Public Health's Pertussis (Whooping Cough) webpage or CDC's Whooping Cough Vaccination webpage.

Whooping cough (pertussis) activity in California is on the rise, with more than 2,000 reported cases and one infant death between the months of January and October of 2024. Everyone who is between 27 and 36 weeks pregnant and family members or caregivers of infants should get the Tdap/DTaP vaccination to help protect infants and young children against serious illness and hospitalization.






What's Up at Lake Oroville

Salmon Spawning Operations

Annual Chinook salmon spawning activities at the Feather River Fish Hatchery in Oroville have been completed. The Hatchery collected enough eggs to meet its normal production goal of 2 million spring-run fingerlings and 6 million fall-run fingerlings, with additional eggs collected to increase production this year. Another 1 million springrun and 6 million fall-run Chinook salmon will be produced to address declines in Central Valley Chinook salmon populations during recent years.

The hatchery's spawning process collects eggs from returning adult females and milt (sperm) from returning adult male Chinook salmon to fertilize the eggs. After fertilization, the eggs are placed in incubators to develop for approximately 85 days. Once they reach the fry stage and can consume food, they will either be released into the Feather River or transferred to long ponds called raceways at the facility to grow into fingerlings. Chinook salmon fingerlings raised at the Hatchery will be released in the Feather River and San Francisco Bay between March and June to support inland and ocean populations. In addition, California Department of Water Resources and California Department of Fish and Wildlife continued thiamine treatments to combat B1 vitamin deficiencies. This treatment improves the health of the fish, increasing the survival of Chinook salmon

from egg to juvenile. The Feather River Fish Hatchery is a California State Water Project (SWP) facility built in the late 1960s by the California Department of Water Resources to mitigate impacts on fish migration resulting from the construction of Oroville Dam. Department of Water Resources owns and maintains the facility and provides funding to the California Department of Fish and Wildlife to perform spawning, rearing, and stocking operations.

few weeks throughout the various branches of Lake Oroville to capture floating woody debris before it reaches the main body of the lake. With the rainy season underway, inflows into Lake Oroville are expected to increase with strong storms from atmospheric rivers. These higher inflows wash woody debris into the reservoir, which can impact water infrastructure and present a hazard to boaters. Over the next few months, Department of Water crews will be collecting, containing, and pulling larger pieces of wood out of the lake and away from shoreline areas using boom

collected. Floating debris removal ensures continued infrastructure operations and the safety of the recreating public on Lake Oroville. However, boaters and other water recreationists should take precautions when operating watercrafts on Lake Oroville and should remain alert for floating debris.

Snow-Cember at the Visitor Center

Visit the Lake Oroville Visitor Center.

Staffed by knowledgeable guides, the Lake Oroville Visitor Center features interpretive displays on Oroville Dam, area geology, wildlife and habitat, hydroelectric power, and cultural and historical artifacts. View videos in the theater about the construction of Oroville Dam, walk or hike along nearby trails, and visit the 47-foot-tall observation tower that provides unsurpassed

panoramic views of surrounding areas. Free guided tours for school and community groups are available by reservation. Parking and admission to the Visitor Center are free.

Lakeside Access Road Closed

Rising reservoir levels at Lake Oroville from recent storms have required the closure of Lakeside Access Road at Oroville Dam. While Lakeside Access Road is closed, vehicle access to the Spillway Boat Ramp and Day Use Area is available daily between 6 a.m. and 8 p.m., with all vehicles and trailers subject to inspection by the California Highway Patrol (CHP) for security purposes. There are three other boat ramps at Lake Oroville that are open 24 hours per day and do not entail CHP inspections: Bidwell Canyon, Loafer Point, and Lime Saddle.

Oroville Recreation Lake Oroville is one of the State Water Project's premier recreational destinations and one of California's best fishing spots. The lake provides both warm-water and cold-water fisheries, with excellent bass fishing opportunities during the fall and winter months. Be sure to check California Department of Fish and Wildlife (CDFW) fishing regulations before fishing. The marinas at Bidwell Canyon and Lime Saddle are open daily and provide a variety of services including a convenience store, gas, boat rentals, and more.

Department of Water Resources, the California Department of Parks and Recreation (State Parks), and California Department of Fish and Wildlife maintain over 92 miles of trails in the Oroville area. An interactive map of recreation facilities, including open trails and their permitted uses (hike, bike, horse, multi), is available on Department of Water's Lake Oroville Recreation webpage. A paper trail map is available at various locations, including most entrance kiosks and the Lake Oroville Visitor Center.

Current Lake Operations

Lake Oroville is at 785 feet elevation and storage is approximately 1.94 million acre-feet (MAF), which is 57 percent of its total capacity and 108 percent of the historical average.

Feather River flows are at 800 cubic feet per second (cfs) through the City of Oroville with 950 cfs being released from the Thermalito Afterbay River Outlet (Outlet) for a total Feather River release of 1,750 cfs downstream. The Department of Water Resources continues to assess Feather River releases daily.

In November a series

of atmospheric rivers brought heavy rainfall to Northern California, with Lake Oroville experiencing an approximate 26-foot rise in elevation between Nov. 19 and Nov. 30 due to runoff. Incoming weekend storms are expected to further raise water levels at Lake Oroville, but with the reservoir currently at 56 percent of its total capacity, there is still ample storage to capture storm runoff while providing flood control protection for the Feather River and downstream communities. Water inflows to the reservoir during November storms were as high as 64,000 cubic feet per second (cfs) while outflows in the Feather River through Oroville remained at a minimum of 800 cfs. Department of Water Resources took advantage of the recent storm systems to capture as much water as possible in Lake Oroville, while continuing to support environmental and water delivery needs

to 27 million Californians.

The public can track precipitation, snow, reservoir levels, and more at the California Data Exchange Center. The Lake Oroville gage station is identified as "ORO.
