Butte County Announces First Flu Death, Urges **Vaccination**

Butte County Public Health News Release

BUTTE COUNTY, CA (MPG)

- Butte County Public Health (BCPH) is reporting the first flu-related death for the 2024-25 flu season, underscoring the severe impact of seasonal viruses. The individual, who was in their 60s and unvaccinated, passed away due to complications from influenza.

Residents, especially those at increased risk for complications, are urged to get vaccinated against the flu and take other actions to prevent respiratory illnesses.

"Our hearts go out to the family and friends affected by this tragic loss," said Dr. Jarett Beaudoin, Butte County Health Officer. "These deaths are a heartbreaking reminder of the seriousness of respiratory illnesses, particularly for those most vulnerable, including young children, older adults, and individuals with underlying health conditions."

Vaccination remains one of the most effective ways to prevent severe illness, hospitalization, and death. BCPH strongly encourages everyone 6 months and older to get vaccinated against flu and COVID-19 to protect themselves and those around them. Vaccination of pregnant women also helps to protect infants too young to be vaccinated.

Flu and COVID-19 vaccines are available at local healthcare providers and pharmacies throughout Butte County. Residents are encouraged to talk with their healthcare provider for more information on vaccine availability and eligibility. The RSV vaccination is available for older adults, pregnant people, infants, and caregivers of children younger than 19 months. Contact your healthcare provider to determine if RSV vaccination is recommended for you. In addition to vaccina-

tion, community members are urged to take everyday precautions to reduce the spread of respiratory illnesses, including:

Washing hands frequently with soap and water for 20 seconds Avoid touching your

nose, eyes and mouth Staying home when sick

Keeping sick children home from school according to the school's sick child policy (typically symptom-improving and no fever


OROVILLE, CA (MPG) - The Department of Water Resources (DWR) continues federally required flood control releases from Lake Oroville to maintain flood protection for downstream communities. Water is being released through the Hyatt Powerplant for energy production and from Oroville Dam's main spillway. With lessening storms and reduced inflows into Lake Oroville, Department of Water Resources has decreased total Feather River flood control releases to 17,000 cubic feet per second (cfs). Releases are subject to change based on ongoing weather conditions.

Between October and June, the Department of Water Resources is required to operate Lake Oroville for flood control under federal Water Control Manual guidelines set by the U.S. Army Corps of Engineers. These federal regulations establish a set storage space that is reserved to capture inflows from rain and future snowmelt, while

I had the opportunity to speak on a policy panel at the California Forestry Association Innovation Conference in Sacramento last week. The rate and intensity of wildfires in California are finally causing those who run the state to take perhaps a different view of the environmental policies that have gotten us to this place. There is a lot of talk about global warming or climate change and catastrophic fires. Make no mistake. What's happening with our forests and wildfires in urban areas is caused by lousy policy more than it is

mate. Mother Nature does her thing; it is the politicians that do not add water storage capacity as the population doubles; they don't make laws that require clearing foliage under power poles until after the fires; they don't make major changes to the State Forestry Practices Act even though they claim "everything has changed." It's not just the politicians and the system; I have heard neighbors fight the removal of trees from under the power lines because they like where the trees make shade on their patio. How we as a people think about the environment, especially trees, needs a huge change. There are examples of policy course corrections; U.S. mining companies abandoned critical mineral production in the 1990s mainly due to low profit margins, increased competition, and rising production costs, leading to reduced domestic capacity.

This decline created a dependency on foreign sources, particularly China, which now dominates the global supply of critical minerals essential for advanced technologies and defense systems. Efforts to resolve this issue include federal strategies to boost domestic exploration, production, and processing of essential minerals. America will be mineral-independent again, just as changes in energy policy will make America energy-independent. Mistakes in public policy can be fixed. Forest policy should be a priority for the next adjustment.

One way to know it's time to put out your garbage cans is when all your neighbors have put out their garbage cans. Go with the herd on simple issues.

Biggs City Council Replaces Water Meters

BIGGS, CA (MPG) - Items of business at Biggs City Council meeting on Feb. 11 included the unanimous approval of a contract with Regional Government Services (RGS) for city accounting services. Two other firms were considered but the review committee said that Regional Government Services showed greater competency and was the clear choice.

Approval was also granted for the purchase of 40 new replacement water meters to comply with Assembly Bill 2572. The meters will cost \$12,027.32, which required approval because the amount exceeds the \$10,000 limit on the city administrator's authorization. The amount is within the city budget and does not include installation costs.

Interim City Administrator Cliff Wagner gave an update on various city-owned properties under lease, such as the two in the Industrial Park, one for agriculture and the other the Fiber Optics center. The agriculture lease is current but other leases have expired. proved, pre-permitted Accessory

Wagner recommended that the leases be renewed or canceled. Some upgrades will be needed, according to councilmembers. Discussion involved the profit that the properties bring in, justifying the cost of upgrades. The councilmembers voted unanimously to update the leases.

Department reports began with the Fire Department. Fire Chief Chip Fowler said that the equipment on loan to Southern California has been returned and some firefighters are still there. Volunteer firefighters are being tested and 34 new recruits have been outfitted countywide. County firefighters rescued 23 people and nine dogs from flooding in Butte and Tehama counties in January. Councilmember Anita Wilks asked about the fire hydrant seals and Fowler said that the hydrants are inspected annually.

City planner Bob Summerville enorted that three pre-anDwelling Unit (ADU) plans are now available on the city website at cityofcolusa.com. The Accessory Dwelling Unit plans should eliminate about 30% of

the permitting time and costs. Anyone who wants to take advantage of these plans can contact Summerville at his office at 530-868-6008

authorization was approved for Wagner to execute a contract with Gannett Fleming in the amount of \$138,961 for the construction management of the long-awaited Second Street Bicycle and Pedestrian Improvements Project. The

> contractor had communicated possibly beginning in the spring or summer to avoid school traf-

fic. Councilmember Wilks indicated that she would favor "to get right on it" rather than waiting until the summer.

Public Works superintendent Paul Pratt gave a report on department actions to mitigate the increase of wastewater due to recent

heavy rainfall. Wagner expressed his appreciation for the long hours of "hard, dirty, gritty work" that Pratt and his team have done to maintain the system. During committee reports, Councilmember Wilks said that she attended the Small Cities Organized Risk Efforts (SCORE) Board of Directors meeting. Thanks were extended by Small Cities Organized Risk Efforts to City Clerk Roben Benish for getting invoices submitted on time. A new service available to the city at no cost would be the Employer Pool Notice Program, to be discussed at a future City Council meeting.

Wagner reported that about 3,000 legislative bills are introduced in California each year, with a good portion impacting electric utility regulation. As administrator for a Publicly Owned Utility (POU), Wagner and his staff track and comply with all the new regulations. Wagner was also successful in gaining access to the ARV Compliance Service tracking system.

Wilks commented that she recently attended the Northern California Power Agency (NCPA) meeting and observed that the Northern California Power Agency is working very hard to reduce utility costs.


On Feb. 11 the Bulldogs traveled to Orland to face the Trojans. After a tightly-contested first quarter that had the Bulldogs leading 17-13, the Bulldogs took off and never looked back. A 4-point lead turned into an 11-point lead at halftime and then it only grew from there.

The Bulldogs won the game 67-39 and this win secured the Butte View League Championship. Junior Jacob Boyan led the team in scoring with 15 points and eight rebounds. Luis Murillo, Bikram Kullar and Gus Stogsdill all added 10 points

On Feb. 13, the Bulldogs traveled to Oroville to take on the Tigers. This was a game completely dominated by the Bulldogs. In each of the first three quarters, the Bulldogs did not allow more than eight points and scored 12 or more in every quarter (22 in the second). The

Parks Supports Off-Highway Vehicle Recreation



California State Parks' Off-Highway Motor Vehicle Recreation Division has recommended \$3.45 million in grant awards aimed at enhancing safe, responsible and sustainable off-highway

SACRAMETNO, CA (MPG) - California State Parks' Off-Highway Motor Vehicle Recreation Division has recommended \$3.45 million in grant awards aimed at enhancing safe, responsible and sustainable off-highway vehicle recreation across the state.

The funding, part of the U.S. Department of Transportation's Federal Highway Administration's Recreational Trails Program, will support nine projects led by cities, federal agencies and nonprofit organizations in California.

The recommended projects prioritize off-highway vehicle recreation safety education, trail maintenance, habitat restoration and resource protection.

Some of the highlighted grant recipients include, Sierra Buttes Trail

Stewardship awarded \$164,405 to maintain approximately 48 miles of motorized trails in the Plumas National Forest, and Tahoe National Forest awarded \$103,270 to complete the remaining mile of the Big Boulder single-track trail re-route as part of the Downieville Trail Network.

State Parks will forward the applications to the Department of Transportation's Federal Highway Administration for final approval once the recommended agencies fulfill specific federal requirements.

Grant programs such as the Recreational Trails Program help advance California's Outdoors for All Initiative, by providing funds to local, state, federal and nonprofit organizations to develop motorized and non-motorized recreation trails (paved, non-paved and backcountry) and trail-related facilities projects as well as acquire trail corridors.

State to Revisit Ban on Driverless Tractors

During the past half-century, the emergence of new agricultural technology such as aerial drones, autonomous tractors and other equipment has changed the way crops around the world are planted, cared for and harvested. But in California, a regulation from the state's Division of Occupational Safety and Health, or Cal/ OSHA, dating to 1977, has prohibited the use of autonomous agricultural equipment without a driver at the helm. After years of advocacy from farm groups, the agency's standards board has empaneled an advisory committee to examine the regulation, signaling it may consider revising it. 'Frustrated' and 'Confused':

Army Corps Dam Releases Sent Farmers Scrambling

An unscheduled order by the U.S. Army Corps of Engineers to release water at maximum capacity from dams at Lake Kaweah and Lake Success in Tulare County late last month prompted fears of flooding from local farmers and water managers. Alexandra Biering, a water policy expert and director of policy advocacy for the California Farm Bureau, said she had never seen anything like it. "There is a huge danger to the downstream public," Biering said of making unscheduled releases of that magnitude. Local water managers suc-

ceeded in getting the releases dialed back

to less than a third of full capacity.

Delegates Adopt Labor, Trade, Crop Insurance Policies

At the American Farm Bureau Federation's 106th convention, held last month in San Antonio, voting delegates representing every state and nearly every agricultural commodity deliberated on policies affecting agricultural productivity and profitability. The policies approved at the meeting will guide the nation's largest general farm organization in its legislative and regulatory efforts throughout 2025. California Farm Bureau successfully authored changes that were approved by the delegate body. This included added language to support broadening federal crop insurance for tree and vine losses and discouraging regional limitations.

Valdez Nabs Pitcher of the Week Award





Now, let's talk about the mortgage. I would absolutely recommend she go ahead a pay it off. If she can do that at age 76 and still have \$540,000 left, that's the way to go. Let's pay off the house, and then she can start taking her income off a percentage of the remainder. She won't need much with the house payment out of the way, because she won't be sending money to the bank to pay the anymore.

Continued from page 1 of Water Resources continues to monitor lake levels, weather forecasts, and mountain snow levels to optimize water storage while allowing for carryover storage into next year.

Within the Oroville-Thermalito Complex, the Department of Water Resources maintains several areas that preserve and enhance wildlife habitat. Encompassed within the Thermalito Afterbay's 17 miles of shoreline and 4,300 surface acres of water are numerous brood ponds that provide prime habitat and breeding areas for waterfowl and giant garter snakes, a protected species. While water levels at the Afterbay may fluctuate based on agriculture and hydropower operations, the Department of Water Resources ensures brood pond habitats remain stable. A flap gate outlet system permits water to flow into brood pond areas, raising water levels while preventing water from being released and maintaining a stable elevation for waterfowl nests and giant garter snakes. These measures ensure these species continue to thrive, upholding DWR's commitment to protect, restore, and enhance the natural and

Lake Oroville is one of the State Water Project's premier recreational destinations and one of California's best fishing spots. The lake provides both warm-water and cold-water fisheries, with excellent bass fishing

human environments.

opportunities during the fall levels with over 19,000 and winter months.

To improve fish habitats at Lake Oroville and the Thermalito Afterbay, the Department of Water Resources works with members of the California Conservation Corps (CCC) to bundle recycled Christmas trees and anchor them in various locations around the lakebed. Anchoring the trees allows them to remain submerged, providing juvenile fish safe refuge, and improving fisheries and recreational fishing opportunities. Installation of the Christmas tree habitats will occur in the coming weeks.

Driftwood Abatement at Lake Oroville

With a significant increase in runoff into Lake Oroville from recent storm systems, Department of Water Resource's civil maintenance crews have been patrolling the branches of Lake Oroville to capture floating woody debris before it reaches the main body of the lake. Higher inflows wash woody debris into the reservoir, which can impact water infrastructure and present a hazard to boaters. Over the next few months, Department of Water Resources crews will collect, contain and pull larger pieces of wood out of the lake and away from shore-

line areas using boom lines. Department of Water Resources crews spent a significant amount of time collecting woody debris in Lake Oroville in 2023 and 2024 following heavy storms and high reservoir

cubic yards of woody vegetation collected. Floating debris removal ensures continued infrastructure operations and the safety of the recreating public on Lake Oroville. However, boaters and other water recreationists should take precautions when operating watercraft on Lake Oroville and should remain alert for floating debris.

Staffed by knowledgeable guides, the Lake Oroville Visitor Center features interpretive displays on Oroville Dam, area geology, wildlife and habitat, hydroelectric power, and cultural and historical artifacts. View videos in the theater about the construction of Oroville Dam, walk or hike along nearby trails, and visit the 47-foottall observation tower that provides unsurpassed panoramic views of surrounding areas. Free guided tours for school and community groups are available by reservation. Parking and admission to the Visitor Center are free.

The Department of Water Resources, the California Department of Parks and Recreation (State Parks), and the California Department of Fish and Wildlife (CDFW) maintain over 92 miles of trails in the Oroville area. An interactive map of recreation facilities, including open trails and their permitted uses (hike, bike, horse, multi), is available on Department of Water Resource's Lake Oroville Recreation webpage. A paper trail map is available

at various locations, including most entrance kiosks and the Lake Oroville Visitor Center.

Fall-run Chinook salmon: 23

Steelhead: 63

Ahead of anticipated increased river flows at the fish monitoring station, monitoring equipment has been removed, which will impact count estimates.

Current Lake Operations

Lake Oroville is at 857 feet elevation and storage is approximately 2.8 million acre-feet (MAF), which is 82 percent of its total capacity and 131 percent of the historical average.

Feather River flows are at 7,000 cfs through the City of Oroville with 10,000 cfs being released from the Thermalito Afterbay River Outlet (Outlet) for a total Feather River release of 17,000 cfs downstream. Total Feather River releases will decrease to 15,000 cfs on Feb. 17 and 14,000 cfs on Feb. 18, with flows from the Outlet remaining at 10,000 cfs. Department of Water Resources continues to assess Feather River releases daily.

The public can track precipitation, snow, reservoir levels, and more at the California Data Exchange Center. The Lake Oroville gage station is identified as

Social Security Matters

About Claiming Social Security when I have a Health Savings Account (HSA)

Dear Rusty: I have reached my full retirement age (66 plus 8 months) and plan to apply for Social Security this month, but I've seen articles which say that when I apply, I must also take Medicare Part A. This, even though I am continuing to work and am covered by my employer's health insurance (a high deductible plan). I contribute bi-weekly into an HSA (Heath Savings Account). I've read that Medicare back dates Part A coverage by 6 months, which suggests I would have had to stop contributing to my HSA six months ago. If this is true, will I need to pay penalties and such to the IRS? I'm not able to find anything else about this topic, and I'm wondering what you might have to say. I have my wife and two children on my employer's HDHP. We contribute \$6,000 annually to our HSA and my employer contributes \$1,250 on January 1st each year. We can live without the HSA, but the taxes and IRS penalties concern me. Signed: Wanting to Claim SS (but concerned)

Dear Wanting to Claim: I'm afraid that what you've read is correct - it is mandatory for you to take Medicare Part A (inpatient hospitalization coverage) when receiving Social Security benefits after age 65. Medicare Part A is free to you, and even though you are still covered under your employer's creditable high deductible healthcare plan and can delay taking Medicare Part B, you must take Medicare Part A to collect Social Security after 65. Medicare and your employer's plan will coordinate healthcare benefit payments.

That does, however, also mean your Health Savings Account (HSA) will be affected because, as you have found, Medicare will backdate your Part A coverage by 6 months. And because Part A is not a high deductible plan (a requirement for HSA), any contributions you make after the effective date of Part A will be subject to an IRS penalty, and your HSA contributions won't be considered tax-exempt. This will mean the IRS will likely assess a 6% excise tax on any contributions made after your Part A effective date, and you'll need to pay income tax on those contributions.

What you may wish to consider is stopping your HSA contributions now and waiting an additional six months or so to claim your Social Security benefits (to get beyond the HSA penalty phase). This would have the advantage of avoiding the IRS penalty on your HSA contributions and would also increase your Social Security benefit due to Delayed Retirement Credits (DRCs). You earn DRCs at the rate of .677% for each month beyond your FRA that you wait to claim, which means an SS benefit about 4% higher if you wait six months longer to claim

A 1995 California Court Ruling That Restored **Immigrant Rights Could Backfire Now**

California has the nation's largest population of undocumented immigrants with roughly 1.8 million people. Over the last three decades, Californians' attitudes about that fact have undergone an astonishing swing.

Hostility reached a peak in the early 1990s, demonstrated by passage of Proposition 187 in 1994 by a 3-2 margin. The measure would have required police to check the legal status of people they encountered and barred public services, including education, to those who could not prove

citizenship or legal residency. It was the centerpiece of Republican Gov. Pete Wilson's campaign for a second term, contending that undocumented people were overwhelming the state's budget.

However, support for a crackdown was not confined to GOP voters. Not only did many Democrats — then as now the largest bloc of voters — vote for the measure, but a Legislature dominated by Democrats passed anti-immigrant laws, such banning driver's licenses.

Soon, however, public sentiment and the political atmosphere began to change. Undocumented immigrants and their advocates scored a big win a year after Prop. 187's passage when federal Judge Marianna Pfaelzer

lated the federal government's exclusive power to regulate immigration.

'The California voters' overwhelming approval of Proposition 187 reflects their justifiable frustration with the federal government's inability to enforce the immigration laws effectively," she wrote at the time. "No matter how serious the problem may be, however, the authority to regulate immigration belongs exclusively to the federal government and state agencies are not permitted to assume that authority. The state is powerless to enact its own scheme to regulate immigration or to devise immigration regulations which run parallel to or purport to supplement the fed-

eral immigration laws." A few years later, after Democrat Gray Davis succeeded Wilson, the state abandoned an appeal of Pfaelzer's ruling. In subsequent years the Legislature repealed other laws, such as the one on driver's licenses, and has done whatever it could to treat undocumented immigrants as if they were legal residents, such as expanding health care benefits.

When Donald Trump was elected president in 2016 and promised a crackdown on illegal immigration, California reacted with legislation to make it more difficult for federal immigration authorities to capture and deport undocumented Californians.

The most important was Senate Bill 54, introduced a month after Trump won the election. Dubbed the California Values Act, it essentially bars California police from aiding in any way federal efforts to identify and deport undocumented

immigrants.

ruled that the measure vio- SB 54 survived one court challenge but Trump is once again in the White House, declaring his intention to rid the nation of undocumented immigrants, and is taking aim at California and other states with sanctuary laws.

The U.S. Department of Justice has filed suit to overturn Illinois laws quite similar to California's SB 54, and its contention in the Illinois suit could — with great irony - convert the federal court decision against Prop. 187 three decades ago ago into a hammer to smash SB 54. If California was illegally interfering with the federal government's exclusive power over immigration in Prop. 187, the suit implies, sanctuary laws also interfere

with that power. The 23-page complaint, filed in federal court in Chicago, alleges that Illinois laws "have the purpose and effect of making it more difficult for, and deliberately impeding, federal immigration officers' ability to carry out their responsibilities in those jurisdictions."

California officials are aware that the Illinois suit will not be the only challenge to local and state laws meant to protect undocumented immigrants.

Were the Illinois suit's argument to prevail, the situation in California could come full circle. A legal principle that protected California's immigrants from Prop. 187 in 1995 might make identifying and deporting them easier in 2025.



Biggs Boys Seeded Second in D6 Playoffs

BIGGS, CA (MPG) - Sandwiching wins over Mid-Valley League rivals Maxwell and Williams around a loss to non-conference opponent Durham, the Biggs Wolverines now head into the Northern Section Division VI playoffs after being awarded the No. 2 seed.

Making the trip to Maxwell on Feb. 11, Biggs got off to a somewhat sluggish start, but following a timeout and a pep talk from Coach Roscoe Deel, put the pedal to the metal and never looked back as they cruised to a 61-31 victory over the Panthers.

Brady Smith and Hunter Seipert led the way with 12 points apiece, Hudson Brewer pitched in with an 11-point effort, while David Ibarra-Carmona collected 10 rebounds.

In Durham on Feb. 13, Skyler Long registered a 15-point, 13-rebound double-double and

Ibarra-Carmona grabbed another 10 boards, but it wasn't enough as the Wolverines fell 40-58 to the Trojans.

Rounding out the regular season at home against Williams last Friday night, Biggs proved an ungracious host as it downed the Yellowjackets 57-34.

Smith ended the night with 15 points and seven assists, Long doubled up for the second straight game with 10 points, 11 rebounds and then dished out seven assists to spark the Wolverines.

Seipert added 10 more points to the total, Johnny Conn pulled down 11 rebounds, while Ibarra-Carmona finished with another 10-rebound game.

Biggs (16-8) finished second to Portola in the MVL and began its playoff run on Feb. 20 at home against No. 7 Los Molinos with the winner advancing to a second-round game on Feb. 25 against the winner between No. 3 Plumas Charter and No. 6 Loyalton.

'Ninja' Assault Defendant Sentenced

BUTTE COUNTY, CA (MPG) - After emotional victim statements heard Jan. 22 in Butte County Superior Court, a judge sentenced the so-called "ninja" attacker to 16 years and four months in prison.

Samuel Dickenson, 31, of Chico was sentenced by Judge Corie Caraway to the maximum term after having previously pleaded guilty to attempted rape of a child under 10 years old, attempted murder and assault with a deadly weapon.

The charges related to an August 2024 attack where Dickenson, disguised in an all-black ninja outfit, armed himself with knives and duct tape, and entered the home of a Magalia family at about 10:40 p.m. with the intent to kidnap and rape an 8-year-old girl he knew lived there.

The child and her mother were not home at the time but the child's grandparents were

Ramsev said Dickenson stabbed the grandmother, 70, twice in the chest, while she was in the living room. When the grandfather, 72, came into the living room to rescue his wife, Dickenson repeatedly beat him in the head with a large

roll of duct tape. The grandfather was also stabbed in the ribs during the altercation.

The child's 13-yearold brother heard the commotion, locked himself in the residence's bathroom, and called 911. Sheriff's deputies immediately responded but Dickenson had fled. The next day, Dickenson turned himself in to law

The grandmother was taken to the hospital, where she was treated and eventually released. The grandfather sought medical treatment for his injuries the next

day. Both are recovering.

The victims and their family members addressed Judge Caraway during the sentencing hearing. The eight-year-old's mother told the judge: "Since the brutal attack, I have had nightmares and flash-

> backs during the day that leave me in tears in public. My trust in people is gone. If someone I thought was family could attempt to kill my parents and kidnap and rape my child, surely anyone is capable of doing it as well... I must make sure my kids do not see or feel the fear that I

> > have. I need to make sure

they feel safe, even when I do not think we are."

The grandmother said: "My stab wounds took about two months to heal and the pain disappeared but the emotional wounds will never go away. Samuel Dickenson is the individual responsible for taking away any sense of security in our own home."

The case prosecutor, Jessica F. Miller, told the judge that Dickenson took advantage of a position of trust when planning and carrying out this attack. The eightyear-old and her family had previously lived with Dickenson's family in Chico for a few months shortly after being displaced by the Camp Fire in 2018. Dickenson became enamored with the child and then rekindled his acquaintance with the child's family to locate her in Magalia to plan his kidnapping and rape.

The prosecutor noted it was only through serendipity that the 8-year-old was not home at the time of the attack. She had broken her foot earlier that day at a fair and was at urgent care at the time.

Given the charges, Ramsey said, Dickenson will be subject to a Department of State Hospitals screening at the end of his prison sentence to determine his status as a sexually violent predator, which could result in his commitment to a secure state hospital for life.
