

SagamoreHill Broadcasting, LLC Contest Rules

Enter for "YAGODY + JIGJAM Ticket Giveaway" until 4/23/25 12:00:00 PM.

Prizes can be picked up during regular business hours (excluding holidays) within 30 days of winning a prize. All prizes must be picked up in person. Prizes will not be mailed unless specifically stated. Prizes can be picked up at 129. W Prien Lake Road, Lake Charles, Louisiana, 70601.

No purchase necessary. Void where prohibited by law. All federal, state, and local law regulations apply.

Qualifications: Limit one entry per person, per day during on-air giveaway, on-site remote contests, online contest, or text contest unless contest rules state otherwise.
