## Yuba River Endowment Awards \$100,000 in Scholarships

MARYSVILLE, CA (MPG) - The Yuba River Endowment's 2025 scholarship fund has been increased again to a total of \$100,000, including two special awards named after leaders pivotal to Yuba County's water infrastructure history.

Last year, the endowment ended up increasing the total award to \$100,000 due to the number of top caliber applicants. This year, the initial award was set at \$75,000 and was again increased to \$100,000 once interviews were complete. More than 140 applications were received, and 52 students were selected for interviews, all of whom will receive an award.

The awards range from \$500 to \$5,000. This year's recipients include 26 college students continuing their studies and 26 current high school seniors. The high school students are from Lindhurst, Wheatland High, Marysville High, and the Marysville Charter Academy for the Arts.

"We just had so many amazing applicants again overall, so the one's chosen to interview were all really great students," said Yuba River Endowment Board Member Steve Waltz. "We are also excited to create and award the Merle Collins and Roger Murray special scholarships, honoring two gentlemen who had a profound impact on agriculture in Yuba County."

The Merle Collins Scholarship of

\$5,000 is awarded to Elizabeth Silva of Lindhurst High who will be pursuing an ag education with the hopes of being an FFA advisor one day. Merle Collins moved to the West Coast in 1918, becoming the state 4-H club specialist for the University of Nevada, then relocating to Susan County in 1922 to become Lassen County's farm advisor where he helped eradicate tuberculosis in beef and dairy cattle.

In 1929, Collins moved to Marysville and became Yuba County's Farm Advisor. Collins specialized in developing new products for Yuba County farmers and was also responsible for early water rights filings for irrigation. He envisioned a plan that involved the development of surface water within the county and worked with local districts on the possible expansion of surface water into their areas and enabled them to see the potential benefits. Collins was instrumental in convincing Browns Valley Irrigation District landowners that construction of the Virginia Ranch Dam was needed for storage and water reliability. After completion of Virginia Ranch Dam in 1963, Browns Valley Irrigation District held a dedication ceremony in July 1964 to honor Collins by naming the reservoir Collins Lake.

The Roger Murray Scholarship of \$5,000 is awarded to Logan Beach, a Marysville High alumni, currently attending Chico State pursuing a civil engineering degree. Roger Murray grew up during the Great

Depression, moving to Wheatland in 1948. Murray farmed rice and wheat, then built a dairy called The Marysville Milk Farm, selling milk to Crystal Creamery and hand delivering bottled milk to Wheatland residents and schools. Murray helped start the Plumias Brophy Fire House where local 4-H meetings were held. Murray invented a Cage Wheel Tractor and spent almost two years in Central America teaching farmers how to use it in their rice fields. Upon returning to Wheatland, Murray started a heavy equipment business, building dairies, barns and shops.

Throughout the 1980s and 1990s, Murray was instrumental in building the South Yuba, Brophy Water and Dry Creek Mutual Water Company districts; and completed many projects for the Yuba Water Agency.

Murray was on the Wheatland High School Board of Trustees for 43 years, tying him in fourth-place for all time longevity in California school board history. A huge supporter of 4-H and FFA, Murray convinced the Wheatland school board to start the agriculture department in 1988. He served as chairman of the Wheatland High Ag Advisory Committee and for the rest of his life volunteered time mentoring hundreds of students. Murray left us in 2016 at the age of 87.

Yuba River Endowment scholarships were open to any Yuba County resident or any high school senior attending a Yuba County high school,

## Council Holds Moment of Silence for Fallen Officer

MARYSVILLE, CA (MPG) - The Marysville City Council opened its April 1 meeting with a moment of silence for Osmar Rodarte, a 27-year-old Marysville Police officer who lost his life in the line of duty on March 26.

Councilmember Brad Hudson thanked everyone in the community for coming together and supporting "our blue-line family."

Councilmember Marjorie Rollins said there was an incredible outpouring of support for Officer Rodarte's family and the "prayers and thoughts quickly transformed into action, showcasing the profound impact he had on our community."

Councilmember Stuart Gilchrist was too overcome with emotions to comment on the tragedy at this time and Vice-Mayor Bruce Buttacavoli said donations for the officer's family are being collected by Back the Badge.

Mayor Chris Branscum said he had "the privilege of participating in the procession that took (Rodarte's) mortal remains from Marysville to Placer County."

"It was one of the most moving experiences of my life," Branscum said, and there were many moments that brought him to tears.

In other council news, the Marysville City Council issued a proclamation recognizing April as Sexual Assault Prevention Month. Mayor Branscum read the proclamation, stating, "It is essential that we raise awareness about the prevalence of sexual assault and its devastating impact on individuals and communities."

According to Branscum, the City of Marysville is committed to providing a safe environment for everyone. It supports the collaboration of local agencies, law enforcement and healthcare professionals to prevent sexual assault, support survivors and advocate for change.

The City Council also recognized April as Child Abuse Prevention Month. Mayor Branscum read the proclamation: "Child abuse remains a significant concern in our society, affecting thousands of children, the most helpless among us... Every child has the right to grow up in a safe, supportive and nurturing environment."

The city is dedicated to protecting children from abuse and neglect by "fostering healthy families, promoting

**MARYSVILLE, CA (MPG)** - The Rotary Club of Marysville delivered nine automated external defibrillators (AEDs) to Yuba County schools, as part of a regional Rotary initiative to ensure the life-saving devices are accessible when needed to save a child in cardiac arrest.

The Rotary clubs of Marysville, Elk Grove and Arden Arcade teamed up to broadly distribute AEDs throughout the greater Sacramento area and received supplementary funding from Rotary International to support their cause. "This is the kind of gift that you hope is absolutely never needed and never used," said DeDe Cordell, president of the Rotary

Club of Marysville. "But if they ever do need it, we want to make sure they have it or the consequences could be devastating." The Marysville club worked with the local school districts to determine the need, and distributed three AEDs to Marysville High School, and one each to Lindhurst, Yuba County Career Preparatory Carter School, TE Mathews,

# Yuba City Doctor Placed on Six-Year Probation

**YUBA CITY, CA (MPG)** - Dr. Dung Minh Tran, an internal medicine physician based in Yuba City, has been placed on a six-year probation by the Medical Board of California following a series of workplace misconduct allegations and an admitted inappropriate relationship with a subordinate nurse. The decision, part of a stipulated settlement approved March 7, will take effect at 5 p.m. April 4. Although Tran did not formally contest the

charges at hearing, he stipulated to the facts of the case, agreed that the Medical Board could establish a prima facie case and waived his rights to a hearing. The board adopted the settlement, which includes a stayed license revocation and a 90-day actual suspension from practice beginning 16 days after the effective date. The following summary is based on the stipulated disciplinary order issued by the Medical Board of California (Case No. 800-2021-084593), which includes the formal

accusation and detailed terms of Tran's probation. Pattern of Disrespect and Intimidation Multiple complaints were filed against Tran stemming from his conduct at Adventist Health-Rideout Hospital in Marysville, where he held clinical privileges. In one incident from April 2021, Tran allegedly publicly berated a registered nurse ("Nurse A") in front of Chico State nursing students, yelling, "So you don't know anything about your patient? Why don't you know anything

about your patient?" When the nurse attempted to explain that the patient had brought up a new issue, Tran allegedly turned to a student and said loudly, "Don't be like that nurse! Don't be like that nurse!" while laughing and continuing to repeat the phrase. Nurse A later filed an internal complaint, describing the encounter as "completely inappropriate" and emotionally distressing. Another staff member, a licensed respiratory therapist ("R.T. B"), said that Tran told her she needed to "be reeled in" and that "the patient's blood would be on (her)" after she requested clarification on a treatment order in August 2021. She said that Tran had a reputation for "not providing clear and concise orders" and often called staff questions "stupid." Later that day, she said that Tran confronted her in front of colleagues, saying, "Who do you think you are? I am a doctor. RTs act like they have authority in this hospital. You have no authority, and I'm here to reel you in." His alleged failure to provide proper orders reportedly delayed treatment for two patients.

environment for the staff." "You appeared to acknowledge the issues of your perceived behavior and demonstrated some insight into the impact of your behavior on the staff as well as on patient care," the letter said. "Such behavior cannot, and will not, be tolerated." **Coercive Sexual Relationship with Subordinate Nurse** The most serious findings involve Tran's admitted romantic and sexual relationship with "Nurse D," a subordinate he supervised from April 2020 through December 2021. According to the documents, the relationship began with unwanted physical contact and escalated to sexual coercion, emotional threats and stalking. Nurse D stated she initially complied with Tran's requests out of fear of retaliation and felt she had to continue a sexual relationship with Tran after he refused to return a necklace bearing her and her fiancé's initials. In January 2021, when Nurse D sought help for her mother's cancer diagnosis, Tran allegedly arranged expedited care and then requested she meet him at his office. There, she said he touched and kissed her and asked if he could take photos of her naked body. She complied, the nurse said, because it was the only way to ensure continued care for her mother. In December 2021,

Tran's behavior reportedly escalated, she said, and he began threatening to confront her husband and ruin her life. In one message, she said, he texted: "You will never have a clear conscience until I forgive you... This will haunt you for life." He also sent messages asserting dominance, the nurse said: "I am your God. You must obey me." On Dec. 8, 2021, Tran allegedly drove to her residence, texting her photos of her house and threatening to confront her husband. Nurse D reported the situation to Rideout's Human Resources the following week. **Probation Terms and Restrictions** As part of the disciplinary order, Tran must serve a 90-day suspension from medical practice, complete professionalism and boundaries courses, undergo regular psychotherapy, be monitored by an approved physician during practice and refrain from supervising physician assistants or advanced practice nurses. Also, Tran has to notify hospitals and insurers of his probation and pay \$57,455 in investigation and enforcement costs. Additionally, the Medical Board of California ordered that all allegations in the original accusation be treated as admitted facts if Tran ever petitions to reinstate or alter the terms of his license in the future. ★

## Beale Airmen Return from Leading Expeditionary Operations

**BEALE AIR FORCE BASE, CA (MPG)** - Family, friends and teammates gathered April 7 on the tarmac at Beale Air Force Base to welcome their loved ones after months deployed.

Ninth Reconnaissance Wing (9 RW) Airmen supported the 378th Air Expeditionary Wing (378 AEW) for six months, providing critical command and control, operational and administrative capabilities. They returned to Beale Air Force Base following the successful completion of their deployment.

The deployment follows the 24-month cycle of the Air Force Force Generation (AFFORGEN) model that commits units at the wing-level, allowing faster spin-up of the complex, modern systems required on today's battlefield. By deploying a team, that team can more effectively work together down-range.

Chief Creek, Command Chief Sergeant at Beale Air Force Base and of the 378th for the last six

months said one of the advantages is "being able to go out and have command elements together."

Still, the ability of airmen from disparate bases to effectively fill mission requirements down range was highlighted.

"We saw airmen come together from across well over 40 bases to perform record levels of combat ops over there," said Col. Charles Hansen, 9th Mission Support Group Commander (9th MSG).

After months away from home, this large chunk from Team Beale returned April 7, completing the "deployment" phase of

AFFORGEN and entering the "reset" phase of recovery and training.

"When they left, it was definitely something where we had to put a lot of processes in place and brainstorm how to fill the gap while all these people were gone," said 1st Lt. Zachary Sims, officer in charge of requirements and optimization within the operations section of the 9th Civil Engineer Squadron at Beale Air Force Base.

Some of those processes included carrying more weight and branching out into roles: "I enjoyed more responsibilities

pushed down to me but grateful they will be back with us," said Sims.

Along with loved ones on the flightline, returning Airmen were greeted with refreshments provided by the Beale Military Liaison Council, along with resource information at the Military and Family Readiness Center.

The following day, deployers returned to the Community Activity Center for in-processing and to start the reconstitution phase of the deployment cycle. This included briefing, medical and financial breakouts, and collecting luggage from the deployment during the "bag-drag."

Chief Sgt. DeCarlos Harrison, senior enlisted leader, 9th MSG, said that "reintegration is about the support here on base and it helps get back to normalcy. The support we are getting here is reinvigorating."

Echoing Harrison's feelings of support, Col. Hansen said, "The return was no doubt a very unique experience. After 20-plus years of deployments, it is a great point of pride in how the 9th Reconnaissance Wing and team greeted chock one."

With their return, the Airmen of Team Beale rejoin their units, ready to continue supporting the mission and contributing to the Air Force's operational capabilities. ★

who plans to attend or continue at a trade school, junior college or college in fall 2025. The application window closed Jan. 31. Interviews were held in late March. Students who were chosen for awards were notified this week and will receive their funds once they submit proof of enrollment for their fall classes.

The Yuba River Endowment is a nonprofit organization created by Yuba County farmers to benefit the residents of Yuba County. The endowment is comprised of farmers who have a right to water that flows on the Yuba River. In some years, these farmers are able to both farm their own land and transfer a

portion of their water to drought-stricken areas of the state. A portion of the proceeds from these water transfers goes to the endowment. Since forming in late 2019, the endowment has donated more than \$1,000,000 to support Yuba County ag education, provide food resources, veteran's support, and much more. ★

# Nevada County Designates New Landmark

**NEVADA COUNTY, CA (MPG)** - Nevada County Board of Supervisors approved the Resolution to Landmark the Grant Schoolhouse, located at 135 Winchester St, in Grass Valley, on March 11.

The landmark is to be designated as Nevada County Historical Landmark NEV 25-02. This is another step in the Commission's effort to obtain historical designation of the remaining 19th century schoolhouses that played such an important part in the history of Nevada County.

Located on the corner of Winchester and Marshall Streets in Grass Valley, the second oldest school in Grass Valley, the Winchester School was built on the site in 1864 at a cost of \$1500. An adjacent school, the Grant School, was built in 1895. Both schoolhouses burned down in 1898. The present Grant Schoolhouse was built on the site and opened in 1900. The school closed in 1968, and the building became a private residence. It underwent a number of careful renovations and is considered one of the best-preserved buildings in Grass Valley.

The landmark will be featured in the next update to the Commission's

# Congressman LaMalfa Statement on the Passage of the SAVE Act

**Office of Congressman Doug LaMalfa News Release**

**WASHINGTON, D.C. (MPG)** - On April 10, Congressman Doug LaMalfa (R-Richvale) released the following statement after the House of Representatives passed H.R. 22, the Safeguard American Voter Eligibility (SAVE) Act, a bill that ensures only U.S. citizens can vote in federal elections by requiring proof of citizenship for voter registration.

"The right to vote was always intended to be reserved for United States citizens. Allowing non-citizens that right would undermine the very principles upon which our nation was founded and diminish the value of votes cast by actual American citizens," said Congressman LaMalfa. "For years, blue states have exploited weak laws, creating loopholes that put our elections at risk. The SAVE Act is a commonsense solution that closes these gaps and ensures that only U.S. citizens can vote in federal elections, restoring trust and integrity to the process. I am pleased to see the House take this important step towards protecting the sanctity of our elections and

the will of the American people."

The Safeguard American Voter Eligibility Act reinforces election security by:

Requiring proof of U.S. citizenship to register to vote in federal elections, whether at the DMV, a government office or by mail.

Ensuring voter rolls are accurate by mandating that states remove non-citizens from their databases.

Holding election officials accountable by allowing private citizens to sue if officials register voters without proper proof of citizenship.

Providing states access to federal databases at no cost to verify citizenship status.

Creating a process for legitimate voters who lack standard documentation, ensuring no eligible citizen is wrongly turned away.

# Social Security Matters

## When Should My Wife Claim Social Security?

**Dear Rusty:** My wife was born in July 1959, and her recent SS benefit estimate is \$3,337 at her full retirement age, or \$4,397 at age 70. She is presently employed full-time and intends to continue working until she is aged 70. She is wondering when the most financially advantageous time would be to draw her SS retirement. **Signed: Planning Ahead**

**Dear Planning Ahead:** Obviously, the best time for your wife to get the highest possible monthly Social Security benefit would be age 70. Provided your wife's life expectancy is at least average (about age 87 for a woman her current age), she will likely receive the most in cumulative lifetime Social Security benefits by waiting until age 70 to claim.

For clarity, if your wife were to choose to claim before her full retirement age (FRA), her monthly amount would be less and she would be subject to Social Security's Annual Earnings Test (AET), which limits how much she can earn before her FRA. If the AET is exceeded, SS will take away \$1 for every \$2 her earnings are over the limit (they take away by

withholding future benefits until the penalty is satisfied). The AET (\$23,400 for 2025 but changes yearly) is in effect until your wife reaches her full retirement age of 66 years and 10 months, after which she can earn as much as she likes without penalty. Since she plans to work full time until age 70, your wife should likely not claim Social Security before her FRA. As mentioned, claiming at age 70 is probably a more prudent financial option.

Since your wife expects to continue working, she should also know that her estimated benefit will likely increase assuming her more recent earnings are among the highest over her lifetime. Social Security will review current year earnings annually to see if her current earnings warrant a benefit increase (SS benefits are always based on the highest 35 years of work earnings, and that includes earnings even after SS benefit are started). Also, the estimates provided by SS do not include Cost of Living Adjustments (COLA) which typically occur annually. FYI, the average annual COLA increase over the past two decades has been about 2.5%.

Based on her estimated FRA benefit, it is also evident that your wife will not get additional benefits as your spouse. For that to occur, your benefit at your FRA would need to be more than twice your wife's FRA amount, which it likely is not. Thus, your wife should make her claiming decision based

only on her own benefit opportunity, considering her personal financial needs and her life expectancy.

FYI, your wife's "breakeven age" – the age at which she will have collected the same amount of SS money by claiming at age 70 vs. claiming at her full retirement age (FRA), is about 82 years of age. Thus, assuming her life expectancy is more than 82, it would be prudent to wait until age 70 to claim Social Security.

In the end, the "best" time to claim Social Security depends on a few factors – most notably, life expectancy, and financial need. If the SS money isn't urgently needed now, and your wife's life expectancy is at least "average," then it appears from what you've shared that her best choice would be to wait until age 70 to claim Social Security. If life circumstances change over the years, your wife can take comfort knowing that she can also claim her Social Security at any time before age 70 and she will get benefits right up to the month she claims. Note that by waiting until after her FRA to claim, she will earn Delayed Retirement Credits (DRCs) of .667% more benefit for each month of delay (about 8% more for each year of delay).

# Salmon Fishing Shutdown Marks a Grim Milestone

This week, a public federal process determined there will be no commercial salmon fishing off California's coast for the third year in a row. It's a grim milestone for our state.

While we will see some recreational ocean fishing, we're at the low-water mark. With so few fish available, we know this won't be enough to meet the demand of our state. That's hard news in hard times.

Thirty years ago, the idea we would be implementing, yet alone discussing, these restrictions would have been unthinkable. Back then, millions of salmon swam through the rivers of California every year. It was a bountiful, thriving species.

But last year, the number of adult salmon in the Sacramento Index, a critical measure of the Sacramento River salmon population and an indicator of the overall health of California's salmon, shrank to roughly 100,000 fish. It's a tiny fraction of salmon's former might.

The reasons for the decline are numerous and complicated. Decades of severe drought, climate disruption, water management challenges and habitat loss threaten the future of salmon in California. The loss of salmon would wound California deeply.

Salmon are the basis of a multibillion-dollar fishing economy that creates jobs across the state. They support thriving forests, rivers and floodplains and serve as one of the most popular seafood choices across the country. Salmon provide vital subsistence to numerous California tribes. Recreational salmon fishing trips form the basis of family legend and lore.

For the salmon lovers among us, these are dark times. But I see glimmers of hope.

Two weeks ago, the California Department of Fish and Wildlife revealed the progress on California's "Salmon Strategy for a Hotter, Drier Future." It was an update on the strategy Gov. Gavin Newsom released last year, which outlined dozens of key action items the state must take to better support healthy salmon populations.

In the last year alone, state fish and wildlife and its partner agencies have made critical headway on nearly 70% of the action items set by Governor Gavin Newsom. Another 26% are already done.

California finished removing the

outdated and obsolete Klamath River dams, allowing for a free-flowing river and access to cold-water habitats blocked for more than a century.

California's initiative to fast-track approvals for salmon restoration projects led to the streamlining of more than 60 important projects to support salmon populations over the past year.

Fish and wildlife has also worked with the State Water Resources Control Board to develop flow recommendations in drought-prone watersheds like the Scott and Shasta rivers and Mill and Deer creeks. This ensures salmon populations have enough cold water to survive during dry periods.

Investments to expand and modernize the state's fish hatcheries, ensuring California is supporting the production of a resilient salmon population, have increased fall run production from state-operated hatcheries in the Central Valley by over 9.7 million fish.

The state's salmon strategy was designed for long-term salmon support. But we're already seeing early benefits, some that even surprised fish and wildlife officials. Ten days after the final Klamath dam came down, state scientists spotted salmon swimming north of the dam sites into Oregon.

Experts originally estimated that would take 10 years.

Data shows that, while salmon numbers from 2024 are down, California saw the highest number of jacks (2-year-old fish) returning to the Central Valley since 2019. Jacks are an important predictor of the number of adult salmon that will return to spawn the following year.

In Lagunitas Creek, there's been a 60% increase in spawning of endangered Coho salmon. In Mendocino County, adult salmon returns have almost quadrupled their 15-year average.

To be clear, these wins are just the beginning. The road to reviving California salmon will be long. But these successes give me hope and the drive to keep fighting for salmon.

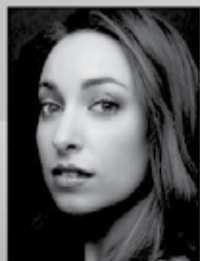

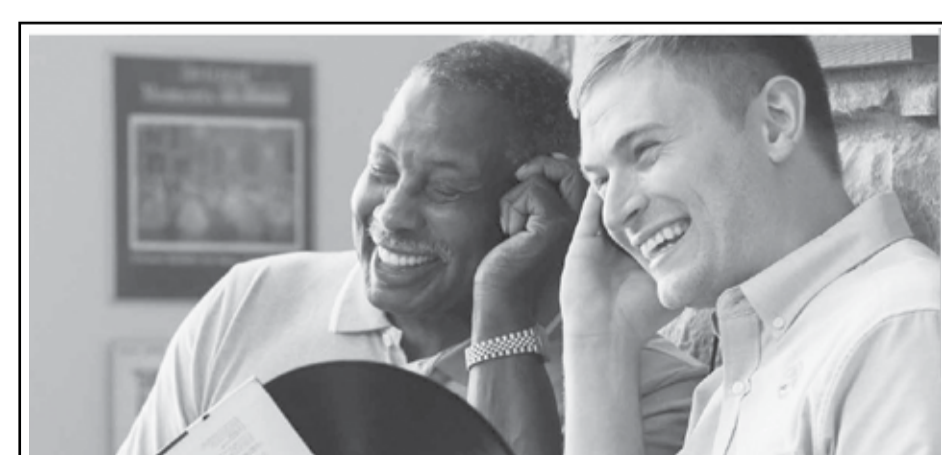

## Food & Farm NEWS

### Rising Wages Test Ranchers Who Provide Vegetation Management

Sheep and goats, increasingly used to eat flammable vegetation in targeted areas, have become a key part of California's wildfire prevention efforts. But ranchers who provide targeted grazing services depend on a viable sheep and goat ranching industry. Their business may be in jeopardy due to a steep rise in the minimum wage ranchers must pay the herders who look after their animals around the clock. Since 2019, that wage has more than doubled, soaring this year to \$4,820 a month. "It's just become untenable," said sheep rancher Andréa Soares, who operates Star Creek Land Stewards in Merced County.

### Researcher Develops Tool to Deter Spread of Bird Flu on Farms

Maurice Pitesky, University of California Cooperative Extension poultry specialist, has developed a Waterfowl Alert Network to provide data to farmers and agricultural agency staff about the locations of waterfowl roosting and feeding. Pitesky developed the tool to help poultry and dairy farmers limit contact with the migrating birds, as they can carry the virus that causes bird flu. The network uses data from satellites, weather radar and land-based environmental sensors. "One thing we need to consider in the medium- to long-term is the concept of waterfowl habitat shifting away from food animal production," he said.

### New Study Finds Sauerkraut Benefits Gut Health

A new study published in the journal Applied and Environmental Microbiology found that sauerkraut, which is fermented cabbage, may provide substantial benefits to gut health, supporting digestion and helping protect against illness. "Some of the metabolites we find in the sauerkraut are the same kind of metabolites we're finding to be made by the gut microbiome, so that gives us a little more confidence that this connection we found between the metabolites in sauerkraut and good gut health makes sense," said Maria Marco, professor in the Department of Food Science and Technology at the University of California, Davis, who co-authored the study.

### Research Says Overtime Law Has Cost Farmworkers \$100 a Week

In 2023, University of California, Berkeley, assistant professor Alexandra Hill published research showing California's 2016 agricultural overtime law had not achieved its goal of increasing earnings for farmworkers. She found that Assembly Bill 1066 caused workers to lose hours and pay as farmers shortened the workweek to balance their wage bills. Hill said her continued analysis of farmworker employment data shows farmworkers have earned roughly \$100 less per week on average than they would have without AB 1066. "There is really convincing evidence that work hours for individual farmworkers fell after the law went into effect," she said. ★

## Buy and Hold or Sell and Fold

In times like these, the stock market mantra of "buy and hold" just doesn't seem to cut it. I know they also say "hold for the long term" but I, like the rest of you, don't know how much "long" I have in my term. This especially applies to those of us who are a bit older. I use the word "bit" with the proverbial tongue in cheek.

In any case, those that have attended one of my investing seminars (there is one coming up in the fall at Placer College for Adults in Auburn), I always tell the story of when I was a young trader and in 1987, in one day (called Black Monday) I lost a cool 45% of my account, roughly 180 grand.

Let me tell you, that is not a pleasant feeling. It stayed with me for months. I still get a stomach ache when I think about it.

They say something good comes out of all things that happen to us. I know that's debatable, but one thing it taught me is to swear I would never have a "gave it all back" stock moment again.

It was then and there I came up with the slot machine theory of investing. It means for the many of us that have played the "one armed bandit", when people play a slot machine, most people exercise good money management. Which is to say when they lose a certain amount they just walk away and go to the bar.

On the contrary, many investors and advisors don't follow that advice and instead adopt "the market always goes up over time" mantra.

It goes something like this: You make some money, or start out opening an account, and the market then drops 5%, and your advisor says (or your brain says), "I'm only down 5%, don't worry about it". Then the market drops 10% and you rinse and repeat that thought. Ditto down 15%, down 20% down 25%. Somewhere around down 30% or more, you call your advisor in a panic and say "Hey Ed, I am now down a lot of money and I want to sell out".

Basically you have reached your "get up and walk away" slot machine moment. The advisor (or your brain) then chimes in and says "You're down too far, you don't want to sell out now".

Hummm...

So if you use this strategy in Vegas sitting in front of some slot, you don't walk away, but instead go back to the ATM and get more money. That's because "you're down too far" and don't want to quit now.

Although some investors have the CAJONES to hold through thick and thin and watch their life savings evaporate, I am not one of them, and maybe you aren't either.

It is true, the market has a continually upward slope to it over the decades but there are a few issues with using that as

an excuse to never sell your stocks.

Case in point: the recent months of this market rout may have wiped out a year's gains or more. Indeed some stocks have lost 10, 20 or 30 percent. Another reason to get up and walk out of the casino of stocks is that it may take a very long time to recover losses or regain previous profits. After the 1929 crash, it took 25 years for the Dow Jones Industrial Average to eclipse its previous high. The NASDAQ took 15 years to recover after the dot.com crash. There are many more examples of long wait times to recover from a previous hammering.

True, all those markets did eventually recover, but had an investor sold and just put those monies in the bank instead of hanging out in those floundering markets for all that time, the compounding interest on savings accounts or CD may have returned incredible gains compared to someone who just sat and "held for the long term."

In conclusion, there is a time to be in an asset and a time not to. Had an investor at least taken some money off the table at market highs, and/or acted when markets began to sell off, and then bought back in closer to, or at a market bottom, the gains may have been many multiples higher than those who just "rode it out".

Knowing when to sell and buy is the trick, and having a clue as to what might precede or at least hint at turning points in the markets can take years of training and experience. I know the recommendations to "hold for the long term" are many, but in my opinion, come from those that simply follow the crowd and may not take the time to really study what is going on in the lobbies of American business and the ivory halls of both Wall Street and Washington.

Knowing what to do could be as simple as setting a limit of your losses when markets correct. Simply use the slot machine theory of "I have lost enough money and am getting up and leaving the casino for now."

Either that or buy and hold for the long term and just keep holding through thick or thin.

And how's that working out for you?

# Hurleton Man Charged with Domestic Violence Murder

**Butte County District Attorney News Released**

**BUTTE COUNTY, CA (MPG)**

- A Hurleton man was charged on April 16 in Butte County Superior Court for the shotgun death of an ex-girlfriend this past weekend.

Curtis Ector Morales, 43, of Hurleton, was charged with felony counts of murder with the use of a firearm and possession of a short-barreled shotgun for the shooting of Dakota Morningstar, 32. The shooting occurred at

Morales' property in the 600 block of Black Bart Road in the rural Hurleton area east of Oroville.

According to Butte County District Attorney Mike Ramsey, at approximately 11:55 p.m. April 13, the Butte County Sheriff's Dispatch Center received a call reporting a woman with a gunshot wound on Black Bart Road.

Upon arrival, deputies located the female victim with an apparent shotgun wound to her lower left side. She was pronounced dead at the scene.

Sheriff's detectives

determined Morningstar was the ex-girlfriend of Morales and had lived on the Black Bart Road property until recently. Shortly before being shot, Morningstar had arrived on the property to pick up her dog and personal possessions she left behind when she vacated the property.

After arriving at the property, witnesses in the area described that Morningstar and Morales engaged in a verbal argument that ended with Morningstar being shot. During a subsequent search of the property,

sheriff's detectives located a short-barreled shotgun hidden in a manzanita bush on the property.

Morales was arrested and booked into the Butte County Jail on suspicion of murder the morning of April 13.

Morales was arraigned in court on April 16 with his private attorney in attendance. He will next appear in Butte County Superior Court on April 24, after press time, for entry of plea and setting of a preliminary hearing. He is being held in custody in lieu of \$2,015,000 bail. ★

Oswald Road will be temporarily closed to through traffic in both directions for the next few months during construction as crews work on a new signal to improve safety at the intersection. Detour signs are posted to direct traffic to alternate routes. Access for emergency services will be maintained. The project will construct a new traffic signal

at the intersection of State Route 99 and Oswald Road to reduce collisions, improve traffic flow and accommodate future growth in the area. Work is projected to be complete by December, weather permitting. This project is funded through Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017, the State Highway Operation and Protection

Program (SHOPP) and a \$1.7 million contribution from Sutter County. Senate Bill 1 provides \$5 billion in transportation funding annually, shared equally between state and local agencies. Road projects progress through construction phases more quickly based on the availability of Senate Bill 1 funds, including projects partially funded by Senate Bill 1.
