ELK GROVE, CA (MPG) - The Elk Grove Historical Society's garden grounds was filled with festive Victorian-era garb for the annual Spring Tea fundraiser event on Saturday, May 10.

Dozens of attendees in vintage-inspired attire

sampled tea blends, scones, finger sandwiches and petit fours beneath hand-lettered table numbers and fresh floral centerpieces.

The event doubles as Mother's Day event where families can celebrate mom over a nice cup of tea.

"I think it's great. The turnout is better, and the ladies love it," said volunteer coordinator and historical society Second Vice President Barbara Claire.

The tradition began at the Blue Victoria Tea Room in early 2002 before being moved to the museum grounds on the northeast corner of Elk Grove Regional Park. The venue provides an immersive backdrop where guests can "step back into early

Elk Grove life," Claire explained.

Sixteen members of the Elk Grove Girl Scout Service Unit assisted with serving and hospitality duties, earning community-service

hours and historic-skills badges. Troop leader Kara Joseph said the experience helps scouts practice

**ELK GROVE, CA (MPG)** - The third annual RAD Games at the Wackford Community and Aquatic Complex in Elk Grove brought together hundreds of participants and families Saturday, May 10 for a free, inclusive event designed for individuals with disabilities.

Organized by the Cosumnes

Community Services District's therapeutic recreation staff, the RAD Games featured over a dozen activity stations including sports, arts and crafts, vendor booths, inflatables and even a silent disco.

The event was created to provide an accessible, welcoming environment for individuals of all ages and abilities.

More than 150 people registered in advance, but organizers expected up to 500 attendees throughout the day.

Participants received a color-coded map designed like a Monopoly board to guide them through stations tailored to various physical and cognitive abilities. Each area included adaptations to ensure accessibility.

"We kind of came up with the idea for the first year to make it like a Monopoly board and put our own twist on it," said Ciera Dulgar, the therapeutic recreation supervisor who launched the event in 2022.

# Newsom Wants Cities to Get Tougher on Homeless Encampments

State Releases \$3.3B in Funding

SACRAMENTO, CA (MPG)

- Gov. Gavin Newsom on Monday announced a model ordinance designed to help cities and counties manage homeless encampments, while also releasing \$3.3 billion in Proposition 1 funds to expand behavioral health housing and treatment options across California.

The announcement, detailed in a news release from the Governor's Office, outlines a hypothetical framework for local governments to establish rules and enforcement procedures that prioritize notice, shelter and support services. The model ordinance includes requirements such as a 48-hour notice before encampment clearance, coordination with service providers and storage of displaced belongings.

"There's nothing compassionate about letting people die on the streets," Newsom said in a statement "Now, we're giving [local leaders] a model they can put to work immediately — with urgency and with humanity — to resolve encampments and connect people to shelter, housing and care."

The ordinance would ban sleeping, including in a sleeping bag, in one space for more than three consecutive nights in a row. Based off the ordinance, people would be forced to pick up and move at least 200 feet every night.

The ordinance follows Newsom's 2024 executive order urging jurisdictions to act swiftly using existing state and local resources. It also builds on legal precedent affirmed by the U.S. Supreme Court, which clarified local authority to regulate public camping.

According to the Governor's Office, the model ordinance includes provisions to prohibit long-term camping in a single location and blockages of public sidewalks, while also ensuring reasonable

# Hmong American Day to Celebrate 50th Anniversary at Elk Grove Park

**ELK GROVE, CA (MPG)** - The 50th anniversary of Hmong American Day will be celebrated with a free, family-friendly festival at Elk Grove Park from 10 a.m. to 5 p.m. Saturday, May 17.

The event will honor the resilience and contributions of the Hmong community in the United States, particularly in Sacramento County, which is home to more than 30,000 Hmong Americans. Activities will include a car show, cultural performances, food vendors and entertainment for all ages.

Hmong American Day commemorates the arrival of Hmong refugees to the United States after the Vietnam War. Many Hmong people were recruited by the CIA to fight in the "Secret War" in Laos, aiding

U.S. forces during the conflict. After the fall of Saigon in 1975, tens of thousands of Hmong families fled persecution in Southeast Asia and resettled in the United States as refugees.

Elk Grove has since become home to one of the largest Hmong populations in the region, contributing significantly to the city's cultural and economic landscape. The annual celebration highlights the importance of preserving Hmong history and heritage for future generations.

The 2025 celebration is hosted in partnership with Sacramento City Councilmember Mai Vang, Elk Grove Unified School Board Trustee Sean Yang and other community organizations.

# **Planet Fitness Gym Expands its Footprint** Tougher on Homeless Encampments to Elk Grove Center

Planet Fitness, which operates six gyms in the Sacramento region, is moving into the Laguna 99 shopping center on Elk Grove Boulevard.

According to the Phillips Edison and Co. Inc. website, Planet Fitness will operate a 20,257-squarefoot location. The space was previously operated by outdoor patio equipment retailer California Backyard. The space is expected to open by the end of the year.

Planet Fitness has

carved out a space in the fitness industry as a lowcost, no-judgment fitness location.

The Sacramento Business Journal first reported the news.

The location will be operated by Taymax Group, which touts itself as the "leading Planet Fitness franchisee group," with over 150 locations nationwide.

#### SF Supermarket to Take Over Former **Big Lots Building**

SF Supermarket is taking over the former Big Lots space on Elk Grove Boulevard, according to the Sacramento Business Journal.

The Journal reported that the Asian supermarket chain has closed escrow for the 40,000-square-foot building at 8539 Elk Grove Blvd. for \$10 million.

Big Lots closed the location in 2024 after the chain went bankrupt. The space was advertised for a lease, but SF Supermarket pushed to purchase the building, according to the Journal.

#### Sal's Kabob and **Gyro Opens New Location**

in Downtown A former pizzeria space on K Street will soon house the latest location for Sal's Kabob and Gyro Grill, an eatery that has roots in Elk Grove.

The newest 4.400-square-foot location is within the confines of the Hardin building and within walking distance of the Golden 1 Center. It will replace MidiCi pizzeria, which closed in July of last year.

Sutter Properties Group announced the news in a Facebook post.

Sal's Kabob and Gyro has operated in Elk Grove for over a decade, serving up kabobs, gyros, combo plates and other Mediterranean and Greek fare, as well as burgers, salads and wraps.

The governor often voices his frustration over the lack of progress at the local level, casting homelessness as a humanitarian crisis and a health and safety issue.

Newsom suggested that cities do not prohibit encampments if there are no available shelter beds.

While the Governor's Office cannot force local municipalities to act, can

statewide. The state has

also created a transparency platform — accountability. ca.gov — that tracks local governments' progress on homelessness response, housing and behavioral health efforts.

According to the website, Sacramento County constructed 22,311 housing units between 2019-2023 and has tamped down people living without shelter by 40.8% since 2023.

While homelessness has risen nationwide by more than 18% in 2024, California has limited its increase to 3%, according to the news release. The state has also seen reductions in veteran and youth homelessness, bucking national trends.

"There are no more excuses," Newsom said in the news release. "The tools are here. The time for inaction is over."

"They get a map and have a variety of stations, from physical fitness and arts and crafts to different vendors and sponsors. They can try things they haven't before."

Dulgar said she had long envisioned a free event for people with disabilities and recognized the Wackford Center as the perfect venue.

This year's additions included a silent disco. expanded obstacle course and inflatables, based on feedback collected through post-event surveys.

"We gather surveys, and we just listen to what the community wants," said recreation coordinator Lexi to implement them every

Participants were grouped into scheduled sessions, with youth in the morning, followed by teens and then adults. After completing activities, they received medals and had the opportunity to swim during open pool hours.

"The facility's closed down just for our event today," Dulgar said. "They get their map when they show up, and their goal is to try and finish as many stations as they can."

More than 30 volunteers and 15 to 20 staff helped to manage the day.

According to Dulgar, recruiting volunteers is

Cobb. "We try our best rarely a challenge due to the strong support from the local community.

"We don't really have to try that hard to get volunteers," she said. "We do get a pretty good turnout from high school age, all ages, actually, that come and

help support this event." The event also offered a quiet room for those needing sensory breaks and included adaptations for both cognitive and physi-

cal disabilities. "Each activity area, we do an orientation with our volunteers, and our staff have all gone through adaptive training," Dulgar said. "We have different adaptations at every station."

Popular stations included arts and crafts, basketball and an interactive fire sta-

tion setup. "They love the fire station because they get to use the fire hose on the truck," Dulgar said.

Cobb, who took the lead on the event for the first time this year, said the continued growth has been rewarding.

"It's been awesome to see it grow," she said. "I think every year, getting the feedback and trying to implement those changes, the community sees them."

As the RAD Games continue to expand, organizers hope to keep improving and providing new experiences for participants.



Do you ever wonder what people think about you? I do and, most especially, I wonder what my readers think of me.

My speaking events often give me multiple opportunities to discover what my readers think of me.

For instance, last week, I spoke to a Rotary group, where a few readers made some surprising conclusions about me based solely on my column mugshot.

"You have a lot more hair than your picture shows," pbserved a friendly bald man.

Thank you, I guess. Honestly, I wish I had more.

A woman in earshot observed that I seemed taller than my column portrait suggests.

Really? I thought. She deduced this from a thumbnail photo?

Following her, another woman gathered her gumption to tell me, "You aren't as fat as you seem in the newspaper."

For the record, I'm 185 pounds, standing 6 feet, 1 inch. Add an extra half inch if all my hair is mussed by the wind.

As I was testing my microphone at another event, two men approached me. The first one inquired if I was a "good speaker, not boring." While the other quite impatiently demanded that I start my presentation early, before our meal was finished.

Answered in the order asked, "Yes" and "No."

But after the talks I was happy to hear the audience move out of superficial observations.

"I appreciate your humility," said one gentleman.

However, while I signed books, another reader added, "This is like meeting a rock star."

I'm not making any of this up. They really said these things. But I do realize that my "celeb" status never really matters to my audiences.

What mattered to people wasn't my height, hair or eloquence. Above the trivial observations, the thing that mattered most to them was how well I listened.

I listened as a man and wife spoke of their son returning from a combat deployment in Iraq, only to lose him to a cancer likely caused by his exposure to the burn pit (the open-air combustion of trash in military deployment sites.)

One man put a lot of trust in me as he unloaded his helplessness in dealing with his wife's third cancer treatment.

Another man told me of his failing marriage while another expressed his powerlessness to find effective treatment for a schizophrenic son.

The whole thing got me thinking about the manner in which Jesus rolled into his community speaking gigs.

He was certainly a crowd favorite wherever he spoke. On a hillside, he outlined some very coherent thoughts in his Sermon on the Mount. He was the banquet speaker for a hungry crowd of five thousand.

But where he really wowed the crowd were the moments he listened to individuals. For example, he shielded a woman about to be stoned for adultery. He befriended a polygamous woman shunned by a gossipy town. He spoke forgiveness to a follower who denied him.

You don't have to wonder what people thought about a guy like that. Jesus heard the pain in their lives. He didn't use his personal comparison to bring his pain into their story. He didn't dismiss their pain or discount it. He listened and made it a part of his own pain.

Given a choice between being a better speaker or a better listener, I'm thinking I want to be more like the Jesus, the listener guy. How about you?





# California Leaders Introduce 'Safe Homes Act' for Wildfire, Insurance Solutions

Office of Assemblymember Lisa Calderon News Release

SACRAMENTO, CA (MPG) - On April 30, state and community leaders supported a bold new initiative to confront California's worsening wildfire and insurance crises: the California Safe Homes Act (Assembly Bill 888). Driven by years of extensive community outreach and unprecedented stakeholder engagement, the act represents a transformative step toward wildfire resilience and insurance affordability. The California Safe Homes Act passed the Assembly Insurance Committee on a 16 to 0 vote.

"Investing in mitigation is crucial to overcoming this insurance crisis. We are not powerless in this fight. We need to equip consumers with the resources to undertake necessary work," stated Insurance Commissioner

Ricardo Lara, the sponsor of the California Safe Homes Act. "We have traveled across every region of the state, listened to thousands of Californians, collaborated with local communities and firefighters, and consulted with insurance leaders from other states and countries. One thing is clear: wildfire safety works, and we must scale it like never before."

"Investing in proven safety measures to make California safer from wildfires is essential to protecting lives, homes, and access to insurance,' said Assemblymember Lisa Calderon, author of the California Safe Homes Act. "Assembly Bill 888 is a step in the right direction to assist California residents and create more resilient communities throughout our state.

The California Safe Homes Act is designed to make homes safer from wildfires while increasing access to insurance. The act will fund critical

mitigation efforts, including fire-safe roofing, defensible space within the first five feet of a home, also known as "zone zero," and community-level wildfire protection strategies.

These are some of the most impactful and costly measures, and homeowners have consistently told the Department of Insurance they want to do this work but simply cannot afford it. California Safe Homes puts money back in people's hands to pay for these essential projects.

The initiative builds on Safer from Wildfires, developed by the Department of Insurance, which lavs out ten proven. achievable wildfire safety actions. It is the first plan of its kind in the nation, created proactively to reduce wildfire risk before disaster strikes.

"Protecting homes before a hurricane ever happens has helped bring affordable insurance back to Alabama. Natural disasters like windstorms,

earthquakes, or wildfires will come no matter what we do. That means you must find ways to build stronger before the event so you will have less damage after the event," said Alabama Insurance Commissioner Mark Fowler, who told the committee about the success of the Strengthen Alabama Homes grant program. "It's actually a pretty simple concept. Assembly Bill 888 will help you pave that

"Through my leadership in the National Association of **Insurance Commissioners** and visits to other states, I have observed successful strategies in action. Disaster mitigation programs are the cornerstone of our National Climate Resilience Strategy, effectively protecting homes against perils, stabilizing markets, and providing consumers with

"Through our work with our own defensible space grant program, we have witnessed homeowners who invest in these safety improvements not only better protect their homes but also gain access to more affordable insurance options, a lifeline in communities where coverage is increasingly difficult to secure," said Jen Goodlin, Executive Director of the Rebuild Paradise Foundation which has worked directly with hundreds of homeowners rebuilding in wildfire-prone areas. "Families who participated in our program and created a non-combustible zone zero, the critical first five feet of defensible space around their

homes, have received the reward of insurability and peace of mind. This bill would greatly benefit not just Paradise, but our Upper Ridge community of Magalia, this area has limited resources and significant wildfire fuel, by providing the support needed to make critical safety improvements. Assembly Bill 888 offers hope for communities like ours, helping ensure a safer, more resilient future."

"We have worked with thousands of people in California and across the country to be prepared before a disaster ever happens. Home hardening and defensible space are proven ways to reduce wildfire risk and keep homes insured, and homeowners need help making these improvements," said Amy Bach, Executive Director of United Policyholders, whose Wildfire Risk Reduction and Asset Protection program (WRAP) is a national model for community education.

AB888 will be heard next in the Assembly Appropriations Committee.

# **Matsui Condemns GOP Effort** to Repeal Clean Air Waivers

WASHINGTON, D.C. This is a blatant, unlawful attempt to undermine decades of progress and double down on dirty fossil fuels. We must stop wasting everyone's time and start working for the American people."

Last month, t h e Government Accountability Office reiterated a 2023 decision that California's Clean Air Act waivers were not subject to the Congressional Review Act (CRA). The Senate Parliamentarian has affirmed this determination, ruling that the Congressional Review Act cannot be used to overturn California's waivers.

Congresswoman Matsui has spearheaded efforts in Congress calling for stronger emissions standards for cars and trucks. Under the first Trump Administration, the congresswoman led opposition to President Trump's attempts to revoke California's pollution standards, and the Congresswoman successfully fought for the reinstatement of California's authority under the Biden Administration.

In March of 2021, she led a letter with 70 of her colleagues urging the Biden Administration to take action to reinstate California's Clean Air Act waiver and restore the Obama-Biden tailpipe emission and fuel economy standards.

In July of 2021, she led a follow up letter with then Energy and Commerce Chairman Frank Pallone and 139 of her colleagues to reiterate the importance of reinstating the California Clean Air Act waiver. \*

# Salmon Releases Adjusted to Support Sacramento River Populations

California Department of Fish and Wildlife News Release

SACRAMENTO, CA (MPG) - In a significant shift of California's salmon strategy, the California Department of Fish and Wildlife (CDFW) has begun releasing juvenile fall-run Chinook salmon from CDFW-operated hatcheries into the main stem of the Sacramento River for the first time.

The release of approximately 3.5 million fall-run Chinook salmon smolts into the main stem of the Sacramento River occurred in mid-April near Redding and Butte City. The fish originated from increased production at CDFW's hatchery operations at the Feather River Fish Hatchery and the Mokelumne River Fish Hatchery. CDFW-operated salmon hatcheries historically have supported populations on their home rivers elsewhere in the Central Valley.

"We strongly support the California Department of Fish and Wildlife's bold decision to release salmon smolts directly into the main stem of the Sacramento River a historic first that gives

juvenile fish a fighting chance at survival," said Scott Artis, executive director at Golden State Salmon Association. "With Sacramento fall-run Chinook returns at crisis levels, and fishing families and businesses having been impacted since 2023, this innovative move is exactly the kind of action we need. We applaud the tireless hatchery staff who made this possible and stand with them in the effort to rebuild our salmon runs and revive California's commercial and recreational fisheries."

Last month, for the third year in a row, the federal Pacific Fishery Management Council recommended the closure of all commercial salmon fishing in California while also recommending an extremely limited ocean sport fishing season due to continued low abundance of salmon populations.

While fisheries managers are seeing some positive signs for fall-run Chinook salmon in other parts of the Central Valley due in part to increased hatchery production from

state-operated hatcheries and better in-river conditions with wetter years, returns to the main stem of the Sacramento River remain at concerningly low

"The naturally spawning Sacramento River salmon populations have been the primary driver of California's commercial and recreational salmon fisheries for decades," said Jay Rowan, CDFW Fisheries Branch Chief. "Poor spawning and migration conditions for fall-run Chinook during the past

two droughts have resulted in low returning adult numbers the last three years. These low adult returns not only affected fishing seasons but also reduced the number of spawning adults and, consequently, the number of juvenile salmon available to take advantage of the good river conditions to rebound this part of the run. The extra effort by our hatchery staff to maximize production has allowed us to take measures this year to speed up the rebuilding of these critical Sacramento River natural spawning areas. This significant shift in strategy speaks to CDFW's long-term commitment to boosting these important

salmon populations." The 3.5 million fish being released into the main stem of the Sacramento River are part of an additional 9.7 million salmon produced in 2025 above normal production goals, funded in partnership with ocean and inland fishing groups. CDFW's hatchery operations, in coordination with the state Department of Water Resources, East Bay Municipal Utility District, and the federal Bureau of Reclamation, will raise and release more than 28

million fall-run Chinook salmon in total in 2025.

CDFW's Sacramento River salmon releases are being timed with increases in water flows that have been shown to improve survival in their journey to the Pacific Ocean and also with salmon releases from the U.S. Fish and Wildlife Service's Coleman National Fish Hatchery in Shasta County to overwhelm predators with a massive volume of released fish.

Additionally, CDFW has provided the Coleman National Fish Hatchery with 10 million salmon eggs to help meet its production goals and offset low adult salmon returns to the federal fish hatchery located on Battle Creek about 3 miles east of the Sacramento River in Anderson.

The juvenile salmon released into the Sacramento River are expected to imprint on the main stem during their migration to the ocean, which in three years upon their return to freshwater is expected to increase the number of adults utilizing important natural spawning areas within the main stem.

# Life-Saving Device Installed at Parks

SACRAMENTO REGION, CA (MPG) - Thanks to three Rotary clubs, 18 automated external defibrillator (AED) units have recently been installed at public facilities in Sacramento, Carmichael, Elk Grove and

The devices can revive heart function in case of cardiac arrest. In compliance with state legislation, similar units must be provided for all youth sport locations in California by 2027. Proven effective in saving lives, an automated external defibrillator costs between \$900 and

One such device was installed recently near Howe Park's tennis courts. The donor, Arden Arcade Rotarians, gathered to view demonstrations of its use by a representative of an organization dedicated to preventing cardiac deaths in young people.

"Every minute that passes without oxygen being pumped to the brain diminishes a patient's chance of recovery," said Project Adam coordinator Rebecca McCormac. "Surveys show one in 300 American children has a heart condition. These often go undiagnosed and can pose risks, especially during athletic activity. That's why it's important to have automated external defibrillators where young

people gather."

Designed to be employed without medical training, automated external defibrillators apply electric shock stimulation to the heart after cardiac arrest.

"When available for bystanders to use, these AEDs save lives," said McCormac. "Days after training in the use of the defibrillator and CPR, Davis High School staff revived a teacher who'd collapsed. They managed to get his heart beating before an ambulance reached the school."

Assisted by the Rotary Club of Arden Arcade, Fulton-El Camino and Mission Oaks Park districts have mounted defibrillators at park sports facilities.

Fundraising by Arden Arcade, Elk Grove and Marysville Rotary clubs provided a \$42,000 grant for the project. The volunteers hope to continue unit donations

"We're glad to do this for children and the community," said Arden Arcade Rotary Club President Christine Jensen. "As Rotarians, service above self is central to everything we do."

The Cosumnes Community Services District announced a ribbon cutting on Tuesday, May 20 at 10 a.m. at Rotary Grove in Elk Grove Park for the

installation of the new AEDs that were installed in CCSD parks.

The event will also commemorate the two-year anniversary of the sudden cardiac arrest of Sacramento native Joe Ellis, who will also speak at the event.

"It's surreal to mark this two-year anniversary knowing these AEDs could be what helps save another life," said Ellis. "Quick action and the right tools saved my life, and I'm grateful others in this community will now have that same chance."

Cosumnes CSD has installed a heated AED cabinet along with a Stop the Bleed rapid response kit at Rotary Grove in Elk Grove Park. Additional AEDs are being installed at Bartholomew Sports Park and Laguna Community Park, two of the District's busiest parks that host numerous sporting events and activities year-round.

"Rotary is all about serving our community," said Steve Jones, president of the Rotary Club of Elk Grove. "Helping fund AEDs in parks is an investment in public safety and in every person who visits these spaces. We're proud to be part of something that could save lives.'







# Aggies Make Statement at Lubbock Regionals

DAVIS, CA (MPG) - University of California Davis women's golf put the nation on notice at the National Collegiate Athletic Association (NCAA) Lubbock Regionals, finishing better than number 18 Arizona and just one stroke off the final cut line with an impressive seventh-place finish to wrap up a historic season.

In the clubhouse: The final cut line ended up being +25, and the final spot was decided by a onehole playoff between Purdue and Texas A&M, showcasing how competitive the week was in Lubbock, Texas.

Skyler May set the tone for the Aggies, shooting -3 for the fourth-best round on the day, and her +2 overall placed her eighth in the final standings. May recorded four birdies, including back-to-back on 16

Vani Karimanal put on a show, shooting -2 with three birdies, climbing 15 spots to finish


National Basketball Association (NBA) Hall of Famer Dr. Shaquille O'Neal will serve as the general manager of Sacramento State University men's basketball starting in the 2025-2026 season.

O'Neal joins the program shortly after the appointment of former Sacramento Kings star Mike Bibby as head coach and the recruitment of his son, Shaqir O'Neal, who was signed to the team in early April.

Shaquille O'Neal, famously known as Shaq, will focus on recruitment, marketing and holistic player development both on and off the basketball court. He has waived a salary and will serve in a volunteer capacity, according to Sacramento State Athletics. The staff page for Shaquille

O'Neal for Sacramento State Men's Basketballs states that he was born in Newark, New Jersey, on March 6, 1972. He is considered to be one of the most dominant basketball players in National Basketball Association's history. Standing at sevenfoot-one inches, weighing 325 pounds, Shaq's larger-than-

He played his junior season (2024 to 2025) at Florida Agricultural and Mechanical University of the Southwestern Athletic Conference, after spending his first three seasons (redshirt in 2021 to 2022) with Texas Southern of the Southwestern Athletic Conference.
