

### FOR SAFETY'S SAKE, LIVE YOUR LIFE





Firefighters lined the intersection of Laguna Boulevard and Bruceville Road on Saturday, May 17 for the 20th annual Fill the Boot for Burns event.

ELK GROVE, CA, (MPG) -Firefighters, interns and volunteers stood at all four corners of the intersection at Laguna Boulevard and Bruceville Road this past weekend, shaking boots and calling on passing drivers to donate to a cause that hits close to home: the Firefighters Burn Institute. Boot in hand, Cosumnes Fire Chief Felipe Rodriguez joined his team on the pavement, leading the charge in the department's long-running, community-driven fundraising effort. The money raised will support survivors of burn injuries and programs that help families recover and rebuild.

"It shows the selflessness that exists within our community, where people are willing to give for a greater cause," Rodriguez said. "Very altruistic, to donate for something that's going to help many who have been severely affected by a burn."

Founded in 1973, the Firefighters Burn Institute (FFBI) provides support to burn victims of all ages, with services ranging from medical care assistance to prevention education. A significant portion of the funds raised also goes toward programs like burn survivor camps for children, where young victims can connect with others who share similar experiences.

"We raise funds for burn victims to raise awareness

on preventing burn injuries," said Rodriguez. "We have a burn camp that we support ... for children who've been burned, many of them with very severe injuries, and they can spend a week with other kids who have also been burned and just be themselves."

The entire event is run on a volunteer basis by off-duty firefighters, fire interns and support from community members. Despite being limited

### Police Release Video from In-N-Out Shooting

**ELK GROVE, CA (MPG)** -The Elk Grove Police Department last Thursday released body-worn camera footage showing the April 12 police shooting of Jerry Tolliver Jr., 50, outside an In-N-Out Burger on East Stockton Boulevard.

The eight-minute video, compiled by the department, shows officers confronting Tolliver after receiving reports of a man acting erratically and possibly carrying a weapon in the parking lot.

A customer inside the restaurant had called 911 around 11:13 p.m., saying an individual was inside the In-N-Out harassing juveniles and "acting erratically," according to the video. "It looks like it might be the butt of a gun, like, in his pocket," the caller said. Four officers responded to the scene, three approaching from Bond Road and one already in the parking lot. Video shows officers shouting commands at Tolliver, who was seated outside the restaurant at a table. "Hands up. Hands up. Get your hands out of your f----- pockets!" one officer can be heard velling. Moments later, another officer fired multiple shots. Police said Tolliver had a .38-caliber revolver in his right hand as he ran between parked vehicles while officers arrived to the scene. Body-cam and dashcam footage shows him raising what police identified as the firearm toward officers before police fired at Tolliver. According to the video, a camera on a parked vehicle recorded Tolliver exiting the restaurant, at one point waiving the firearm about his head. The revolver recovered at the scene was loaded with six rounds, police said. Tolliver was seriously injured and remains hospitalized. Police said he faces charges of assault with a deadly weapon on a peace officer and being a felon in possession of a firearm once he is released from care. None of the officers were injured during the

## **Neil Nayyar Now Plays 130 Instruments**

ELK GROVE, CA (MPG) - Few musicians can claim to have mastered more instruments than most can name, but Neil Nayyar is no ordinary artist.

Born and raised in Elk Grove, Nayyar has achieved widespread recognition for his rare and extraordinary talent: By the age of 13, he had already set a world record for playing 107 musical instruments, a number that has since grown to an astonishing 130.

His journey began long before he could walk, inspired by a simple line in a book his father read during Nayyar's time in the womb. Today, Navyar is not only a multi-instrumentalist, but also a singer in multiple languages, an author and a live performer who blends genres.

In this conversation with Elk Grove Citizen City Editor Sean P. Thomas, Nayyar opens up about the origins of his musical abilities, the challenges of picking up unusual instruments like the theremin, the vision behind his album "Breaking Barriers" and what continues to drive his creative exploration.

ST: You play an incredible number of instruments, most than I'm sure most can name. How did that all begin?

Neil Nayyar: It actually started when I was in

the womb. My dad randomly picked a book from the library, and it mentioned that if you played Mozart's music to a baby in the womb, the child might become a musician. My parents tried it. Then when I was 6, they took me to a free drum class. After just one lesson, I was playing fluidly like a pro. Then after that my parents decided to challenge me and gave me another instrument, which was the guitar, and after learning the guitar, I went to the piano, to the flute, to the saxophone, on and on and on. Then at the age of 12, I set my first world record playing 44 musical instruments in 2017. I later broke my own record by playing 107 instruments in 2019. Now, I can play 130.

Q: Most people can't even name 50 instruments. How do you find all these different ones?

A: Many came from local music stores in Sacramento and Elk Grove like Music Go Round, Tim's Music and Klein Music. Some rarer instruments I've had to order online, sometimes from international shops.

Q: Your latest album, "Breaking Barriers," uses a wide variety of instruments. How did you approach putting it together?

A: My mentor, Mr. Prasanna, who is actually a world-renowned guitarist, said, "Hey, Neil, how

about you make an album with all your instruments?" I decided to create each song from each genre, across different genres and cultures. We decided, for example, to have like an Arabic song with Arabic instruments, a Chinese song with Chinese instruments, Indian song with Indian instruments, and so forth.

The hardest part when recording in the studio was that I had to bring 10 instruments at a time to the studio. Record all 10 instruments, go back to my home, bring another 10 instruments, go back to this studio, record them. Go back and forth. That was the crazy part. recording, going home, and repeating the process.

One track, "Exploring Worlds," now that song it has all 107 instruments in one track and that is the longest track on this album just under 10 minutes. It has three genres, starting with a pop and rock feel, going into Irish and going into another different genre.

Q: You also sing in multiple languages. How did that come about?

A: I said I wanted to try something different; I wanted to see how I would sound if I were singing different languages. I tried singing, I think a little bit of Spanish, that worked out; I tried reading Chinese. I tried doing Hindi, or Ukrainian or Neil Nayyar will perform at the Sacramento County Fair on May 24. Photo courtesy of Neil Nayyar other types of languages. And I said, "Wow, I guess it's possible" and people kind of liked it, too. It's a rare thing to see: someone singing in that language even though they are not

from that country. Q: Do you have a favorite instrument?

A: It would have to be the sitar. It's a string instrument from India, famously played by this popular guru in India called Ravi Shankar. The sound is very different.

It has its own different frequencies or vibrations. It has this kind of twangy sound. It has also been used by many bands, actually, for instance the Beatles, The Who, the Rolling Stones and Metallica.

O: Was there an instrument that really challenged you?

A: The theremin. It's an electric instrument with two antennas. That was a tough one. So, you have, on the right, you have one antenna for changing the note, and on the left, you have another antenna, which is changing, like, the volume of the note. The hard part is standing still because if you move one inch here or there, then the sound will change and then you have to return the whole thing. You can only move your wrist up and down.

**Q: You were born and** raised in Elk Grove; what's the music scene like there?

A: Yes, both born and raised. My singing teacher, Raquela Burt, is based here and also produced my album. She has really inspired me and has been really helpful on my musical journey. I took my first drum class through Cosumnes Community Services District, which led me to New Songs Music School in Elk Grove. That's where things really took off.

Q: Is there an instrument you haven't been able to get your hands on yet?

A: The Bandura, a Ukrainian string instrument

similar to a harp. It's quite large and hard to find, especially because of the ongoing war. I've been searching for it for two years now.

Q: What's next for you?

A: I've got several upcoming performances: May 24 - Sacramento

County Fair at 12 p.m. May 29 - AARP vir-

tual event for API Heritage Month

July 12 - California State Fair at 5 p.m.

Sept. 5 - National anthem performance at Sacramento River Cats game.

On top of that, I published a book titled "Passion to Exploration of 107 Sound Machines." It showcases each instrument I play, with illustrations, history and how to play them. I wrote it because so many people-sometimes from countries these instruments originate from-had never even seen them.

That surprised me and inspired me to share their stories.  $\star$

# **Angelman Walk Helps Bring Awareness**

**ELK GROVE, CA (MPG)** - Several people walked around the Elk Grove Park pond on May 17 to help support those who have Angelman Syndrome.

More than 500 people came out to participate in the walk. The event was set adjacent to Strauss Island with many tents of sponsors set up. With the walk's route being the loop around the pond, many signs were on display alongside the pond of some "angels" with mini-bios and factoids about the children who have Angelman Syndrome.

According to the Mayo Clinic, Angelman Syndrome is a condition caused by a genetic change. It is mostly caused by genetic changes on chromosome 15 called the ubiquitin protein ligase E3A gene. The disorder causes delayed development, speech and balance problems, mental disability and sometimes seizures.

Although the event was to bring support and awareness for the disorder, the event provided entertainment such as music, raffles and a mini-playground for toddlers.

Amanda Moore, the chief executive officer of the Angelman Syndrome Foundation, who is also from Indianapolis, Ind., said that not a lot of people know about Angelman Syndrome, but the disorder affects 1 in 15,000 people in the United States. She noted that the event has been going on for 26 years and that the goal is to raise money to help families with a member that has the disorder, as well as clinical research and transformative research to help find a treatment for Angelman.

Moore said she has a child who has Angelman Syndrome, and getting the diagnosis is quite devastating for families. There are times when some families wait years to get the diagnosis, and getting an answer is important.

"It's a lifelong journey that's filled with a lot of ups and downs," Moore said. "Our kids deal with a lot of seizures, are hospitalized often and can't tell us what's going on. So it's hard for us to know how to help them."

Jake Tuttle, co-coordinator of the Sacramento Angelman Strong, said he became aware of the disorder because his daughter was diagnosed with Angelman when she was 11 months old.

Tuttle noted that the walk was the main fundraiser for the Sacramento area. Because this was the third event in Elk Grove, Sacramento Angelman Strong raised \$50,000 in the previous two events. Although the event has existed for 26 years, the Sacramento walk was moved to Elk Grove in 2023.

"Our organization took on the event because it's so vital to link members of this rare community," Tuttle said. "Because it's one in 15,000 births with this condition, it's very rare to find people who are going through the same difficult journey, but this event lets all of those individuals be recognized and connects all of the families."

Teresa Richardson, a Modesto resident and mother of 17-year-old Jaden Richardson, who has Angelman Syndrome, said the walk was a good way for families to gain support from those who also have relatives with diagnoses of the disorder.

Being from Modesto, it didn't bother her to have to come up to Elk Grove and meet other people.

"If Modesto had a walk like this, I would participate, but because Angelman is so rare, it's difficult to get people in your area to do an event like this," Richardson said. "The Elk Grove event feels good that I was willing to drive an hour to meet other Angelman families. When you're isolated in little towns, it's harder to get people together." ★



## For Safety's Sake, Live Your Life



I often felt that if I hadn't become a chaplain, I'd have become a safety officer.

For example, whenever I volunteer with Chispa Project in Honduras, I'm the guy who steadies the ladder, double checks that the lunch produce is washed correctly and then I police the perimeter for bad guys. (Bad guys don't mess with Chaplain Safety Officer.)

The irony is that my interest in this subject comes from the tragedies I've witnessed in my chaplain career. In death's aftermath I've offered comfort to those whose loved ones were accidentally struck, shot, suffocated, burned, poisoned, fallen or electrocuted.

From those tragic encounters, I've developed a preoccupation with safety that my children say has cost them some of their freedoms. I've always made them wear hats in the sun, helmets on the bike trail and seat belts in the car. For safety's sake, I've made them chew slowly, run quickly and sleep adequately.

They learned pretty well, but never did I realize just how much their training might come back to benefit me.

In 2011, my wife and I flew to Denver to spend a few days with our daughter, Sara. We had no agenda. Just a little rest and relaxation.

Following our late-night arrival, we were ushered into our accommodations, a garage conversion with an open-flame furnace. Playing the fastidious safety inspector, I checked to make sure that Sara had vented the heater properly through a nearby window. She had. Then, I tested the smoke and CO2 detector. Everything worked properly.

Becky and I said our good nights and settled in for a cozy winter sleep, snug under blankets, basking in a glowing heat.

About 2 a.m., we were jolted from bliss with a high-pitched alarm. I saw no smoke, so I focused my squinting eves on the CO2 detector. Carbon monoxide levels were pushing high enough to send us singing in the celestial choir with Jesus himself.

We immediately turned off the heater, opened all the windows, and retreated to the living room, shutting the garage door behind us. After 20 minutes, levels returned to normal, and we re-retired to bed — sans heater but with a double scoop of blankets.

If you're anticipating my point here, you're probably looking for me to quote the Christian Scripture, "It is appointed unto a man once to die and after that the judgment."

Those familiar with this Scripture often use stories such as these to admonish people to live full throttle, seize the day and live every day as if it were their last.

There is some wisdom in those truisms, but honestly, I don't want to live every day like it's my last.

I also need some days to be "regular." I need days that start with a decent breakfast, some time in my pastor's office and a drive home with takeout pizza to watch "Amazing Race" with my amazing wife.

Nothing wrong with that. We all need some routine days where we hold those whom we love, exhale gratitude for the life we are granted and refuel our needs for the next day.

Perhaps today wasn't your best day. If today was only average, then I say, be content that you had no close calls with death to throw you into an existential funk. You don't need to always be prompting yourself with the morbid thought that this day might be your last.

But more than anything, I say, "Stay safe. For safety's sake, live your life. There will likely be a tomorrow.'

## **USA Properties Fund Starts Construction on Terracina at Wildhawk**

An Affordable Apartment Community in The Vineyard Area of Sacramento County

**SACRAMENTO, CA (MPG)** - USA Properties Fund has started construction on Terracina at Wildhawk, an affordable apartment community that will provide much-needed housing for residents at a wide range of income levels in the fast-growing Vineyard area just southeast of Sacramento.

Terracina at Wildhawk, located at 9750 Gerber Road, just east of Bradshaw Road, will become the latest, and one of the few, affordable apartment communities in the Vineyard neighborhood, joining new homes and shopping centers in an area with about 45,000 residents.

"Terracina at Wildhawk will provide much-needed housing for Sacramento County residents," said Sacramento County Supervisor Patrick Kennedy, whose district includes the Vineyard area. "As a partner in the project, this illustrates the county's growing commitment to more housing in the region. Terracina at Wildhawk will help lower-income residents find housing but will also have a ripple effect in the surrounding neighborhoods and the community as a whole."

The 145-apartment community will allow moderate-income residents, from early-in-their career professionals to those in lower-paying jobs, to live and work in the Sacramento region. Terracina at Wildhawk is halfway between Elk Grove and Rancho Cordova, and about 20 miles from downtown Sacramento, offering a good mix of job opportunities for residents.

"The Vineyard area is booming because of the incredible demand and the fast-rising cost for housing in the Sacramento region," said Geoff Brown, President of

USA Properties Fund. "We are committed to addressing the critical shortage of quality affordable housing and helping residents who have few options."

Terracina at Wildhawk will feature one- to three-bedroom apartments, with some units possibly available as early as spring 2026. The apartment community should be completed in summer 2026.

The \$67.9 million development is possible thanks to a public-private partnership that includes the Sacramento Housing and Redevelopment Agency (SHRA), Sacramento County, JPMorgan Chase and WNC Inc.

Sacramento County contributed \$1.475 million to offset impact fees for the project. The "vital development" is one of the first projects approved through a pilot program, said Claudia Wade, Chief of the Sacramento County Engineering Division.

Sacramento Housing and Redevelopment Agency is another major partner on the project, with a \$9.2-million loan and bond issuance.

"Sacramento continues to face a shortage of housing for seniors and families who struggle under the burden of rent they can barely afford," said La Shelle Dozier, executive director of the Sacramento Housing and Redevelopment Agency. "Through the financial assistance that SHRA is able to provide, Terracina at Wildhawk will lift that burden and provide over 140 families with the relief they deserve in an affordable, safe place to call home."

Almost three of every five renters in the Sacramento region spend at least 30% of their income on housing, one of the highest percentages of cost-burdened households in California, according to the Joint Center for Housing Studies of Harvard University. Renters in the Bay Area and Southern California have higher rents but so are their wages.

"With the demand for housing at an all-time high, we are incredibly proud to support USA Properties Fund as they continue to be a driving force in the creation of affordable housing across California," said Justin Chen, executive director of Community Development Banking at JPMorgan Chase. "Ensuring access to affordable housing with community spaces and essential amenities is vital for the well-being and success of residents."

'All The Right Elements

for Success' Terracina at Wildhawk will have significantly lower rents compared to nearby market-rate properties, allowing residents the opportunity to pay off debt and save money.

Residents must meet income requirements, earning 30% to 70% of the median income for Sacramento County, about \$35,370 to \$82,530 per year for a four-person household, such as a couple with two children.

Rents will range from \$634 for a one-bedroom apartment at the 30% income level and increase to \$2,120 for a three-bedroom unit at the 70% income level. However, the range in rents will likely change slightly before the first apartments become available.

"The cost-savings in rent can have a life-changing impact on residents, from helping them pay down debt with some enrolling or returning to college," said Brown of USA Properties Fund.

Terracina at Wildhawk will offer lower rent for residents, but also a long list of amenities, including a community room, a fitness center, swimming pool, a dog park and EV charging stations. The apartment community also features a massive \$3.275-million photovoltaic solar system that will help offset electrical use for residents.

Apartments will feature

energy-efficient appliances and light fixtures, ceiling fans and low-flow faucets, showers and toilets.

Terracina at Wildhawk will include LifeSTEPS, a social-services provider that offers a range of services for residents, from healthy living and financial planning classes to programs for children.

# Pony Express Rides from Sacramento to St. Joseph

**SACRAMENTO, CA (MPG)** - The Annual Re-Ride of the historic Pony Express mail service will be conducted from June 11 through June 21 by the National Pony Express Association (NPEA).

The event, celebrating the 165th year anniversary of "the Pony", will start in Sacramento and end in the city of St. Joseph in Missouri, traveling west to east this year.

Personal and commemorative letters will be carried in a mochila (a leather square that is placed over the saddle with four locked cantinas to hold the mail) by horse and rider relays from the Sacramento River to the Missouri River.

The first rider will depart Old Sacramento at 2 p.m. (Pacific Time Zone) on June 11, and the last rider is scheduled to arrive at the Patee House in St. Joseph, Missouri, at 7:30 p.m. (Central Daylight Time) on June 21.

The route will follow the Pony Express National Historic Trail, a component of the National Trails System. The mail will travel 1966 miles across California, Nevada, Utah, Wyoming, Colorado, Nebraska, and Kansas to Missouri.

Approximately 600 member riders from the National Pony Express Association's eight state divisions will ride relay-style, 24 hours a day, until the mochila is delivered in St. Joseph, Missouri. Each rider will take the Pony Express Oath prior to riding with the mochila, just as the riders did in 1860.

The annual Re-Ride is a 10-day, 24 hours-a-day event honoring the Central Overland California and Pikes Peak Express Company. The company carried letters and telegrams from April 1860 to November 1861, between St. Joseph and Sacramento, proving the central route through Salt Lake City was passable year-round. Their intent was to win a federal mail contract, which unfortunately never materialized.





If owners of one-half or more of the area of land in the existing CFD and not exempt from the Special Tax, or if the owners of one-half or more of the area of land in the territory proposed to be annexed and not exempt from the Special Tax, file written protests against the proposed annexation, and protests are not withdrawn so as to reduce the protests to less than a majority, no further proceedings to annex the same territory shall be undertaken for a period of one year from the date of the decision of the District Board on the issues discussed at the hearing.

**SECTION 2**. The Authority's special tax consultant, currently David Taussig & Associates, Inc., doing business as DTA, 18201 Von Karman Avenue, Suite 220, Irvine, CA 92612, telephone (800) 969-4382, is authorized and directed, with the aid of the appropriate officers and agents of the Authority, to determine each year, without further action of the Commission, the appropriate amount of the Special Tax (pursuant to, and as that term is defined in, the Resolution of Annexation) to be levied for Improvement Area No. 2, to prepare the annual Special Tax roll in accordance with the RMA.

**SECTION 3.** Upon approval by the Commission, whether as submitted or as modified by the Commission, the special tax consultant is authorized and directed, without further action of the Commission, to provide all necessary and appropriate information to the Sacramento County Auditor in proper form, and in proper time, necessary to effect the correct and timely billing and collection of the Special Tax on the secured property tax roll of the County; **provided**, that as stated in the Resolution of Annexation and in Section 53340 of the California Government Code, the Commission has reserved the right to utilize any method of collecting the Special Tax which it shall, from time to time, determine to be in the best interests of the Authority, including but not limited to, direct billing by the Authority to the property owners, supplemental billing and, under the circumstances provided by law, judicial foreclosure, all or any of which the Commission may implement in its discretion by resolution.

**SECTION 4**. The appropriate officers and agents of the Authority are authorized to make adjustments to the Special Tax roll prior to the final posting of the Special Tax to the Sacramento County tax roll each fiscal year, as may be necessary to achieve a correct match of the Special Tax levy with the assessor's parcel numbers finally utilized by the Sacramento County Auditor in sending out property tax bills.

**SECTION 5**. The Authority agrees that, in the event the Special Tax is collected on the secured tax roll of Sacramento County, the County may charge its reasonable and agreed charges for collecting the Special Tax as allowed by law, prior to remitting the Special Tax collections to the Authority.

**SECTION 6**. Taxpayers claiming that the amount of the Special Tax on their property is not correct are referred to Section F of the RMA for the proper claims procedure.

**SECTION 7.** If for any cause any portion of this Ordinance is found to be invalid, or if the Special Tax is found inapplicable to any particular parcel by a court of competent jurisdiction, the balance of this Ordinance, and the application of the Special Tax to all other parcels, shall not be affected.

**SECTION 8**. This Ordinance shall take effect and be in force thirty (30) days after its final passage; and before the expiration of fifteen (15) days after its passage the same shall be published, with the names of the members voting for and against the same, at least once in a newspaper of general circulation published and circulated in the area of the Community Facilities District.



#### **ORDINANCE NO. 250RD-12**

#### **CALIFORNIA STATEWIDE COMMUNITIES DEVELOPMENT AUTHORITY**

#### **ORDINANCE LEVYING A SPECIAL TAX WITHIN IMPROVEMENT AREA NO. 3 OF** COMMUNITY FACILITIES DISTRICT NO. 2023-02 (ELLIOTT SPRINGS)

BE IT ENACTED BY THE COMMISSION OF THE CALIFORNIA STATEWIDE COMMUNITIES DEVELOPMENT AUTHORITY:

SECTION 1. Pursuant to California Government Code Sections 53316 and 53340, and in accordance with the Rate and Method of Apportionment (the "RMA"), as set forth in Exhibit B of Resolution No. 25SCIP-035 (the "Resolution of Intent to Annex") adopted March 6, 2025 as incorporated into Resolution No. 25SCIP-063 (the "Resolution of Annexation") adopted Apri 17, 2025, with respect to Improvement Area No. 3 ("Improvement Area No. 3") of the California Statewide Communities Development Authority Statewide Community Infrastructure Program Community Facilities District No. 2023-02 (Elliott Springs) City of Elk Grove, County of Sacramento State of California (the "Community Facilities District"), without the need for further action by this Commission, a special tax is hereby levied on all taxable parcels within Improvement Area No. 3 for the 2025-2026 fiscal year and for each and every subsequent fiscal year in the amount determined in accordance with the RMA necessary to satisfy the Special Tax Requirement (as defined in the RMA), until collection of the Special Tax by the Commission ceases and a Notice of Cessation of Special Tax is recorded in accordance with Section 53330.5 of the Mello-Roos Community Facilities Act of 1982, being Chapter 2.5, Part 1, Division 2, Title 5 (beginning with Section 53311) of the Government Code of the State of California, provided that this amount may in any fiscal year be levied at a lesser amount by resolution of the Commission.

SECTION 2. The Authority's special tax consultant, currently David Taussig & Associates, Inc., doing business as DTA, 18201 Von Karman Avenue, Suite 220, Irvine, CA 92612, telephone (800) 969-4382, is authorized and directed, with the aid of the appropriate officers and agents of the Authority, to determine each year, without further action of the Commission, the appropriate amount of the Special Tax (pursuant to, and as that term is defined in, the Resolution of Annexation) to be levied for Improvement Area No. 3, to prepare the annual Special Tax roll in accordance with the **RMA** 

SECTION 3. Upon approval by the Commission, whether as submitted or as modified by the Commission, the special tax consultant is authorized and directed, without further action of the Commission, to provide all necessary and appropriate information to the Sacramento County Auditor in proper form, and in proper time, necessary to effect the correct and timely billing and collection of the Special Tax on the secured property tax roll of the County; provided, that as stated in the Resolution of Annexation and in Section 53340 of the California Government Code, the Commission has reserved the right to utilize any method of collecting the Special Tax which it shall, from time to time, determine to be in the best interests of the Authority, including but not limited to, direct billing by the Authority to the property owners, supplemental billing and, under the circumstances provided by law, judicial foreclosure, all or any of which the Commission may implement in its discretion by resolution.

SECTION 4. The appropriate officers and agents of the Authority are authorized to make adjustments to the Special Tax roll prior to the final posting of the Special Tax to the Sacramento County tax roll each fiscal year, as may be necessary to achieve a correct match of the Special Tax levy with the assessor's parcel numbers finally utilized by the Sacramento County Auditor in sending out property tax bills.

SECTION 5. The Authority agrees that, in the event the Special Tax is collected on the secured tax roll of Sacramento County, the County may charge its reasonable and agreed charges for collecting the Special Tax as allowed by law, prior to remitting the Special Tax collections to the Authority.

SECTION 6. Taxpayers claiming that the amount of the Special Tax on their property is not correct are referred to Section F of the RMA for the proper claims procedure.

SECTION 7. If for any cause any portion of this Ordinance is found to be invalid, or if the Special Tax is found inapplicable to any particular parcel by a court of competent jurisdiction, the balance of this Ordinance, and the application of the Special Tax to all other parcels, shall not be affected

SECTION 8. This Ordinance shall take effect and be in force thirty (30) days after its final passage; and before the expiration of fifteen (15) days after its passage the same shall be published, with the names of the members voting for and against the same, at least once in a newspaper of general circulation published and circulated in the area of the Community Facilities District.

I, the undersigned, the duly appointed and qualified representative of the Commission of the California Statewide Communities Development Authority, DO HEREBY CERTIFY that the foregoing ordinance was first read at a regular meeting of the Commission on April 17, 2025, and was duly passed and adopted by the Commission of the Authority at a duly called meeting of the Commission of the Authority held in accordance with law on May 1, 2025.



## Four Dead in Three Fatal Collisions in Elk Grove Over the Past Week

**ELK GROVE, CA (MPG)** -The Elk Grove Police Department is investigating three separate fatal collisions that occurred over the past seven days, resulting in the deaths of four individuals.

The most recent crash happened late Saturday night, May 17. Officers responded to reports of a motorcyclist down on northbound Waterman Road, just south of Sheldon Road, shortly before 11:30 p.m. According to police, a 42-year-old man was found in the center median and was pronounced dead at the scene.

Preliminary investigation indicated that the motorcyclist had been traveling northbound when he lost control and struck the median. It is currently unknown if impairment played a role in the crash.

Earlier in the week, on Tuesday, May 13, officers responded to another fatal collision in the same area, northbound Waterman Road near Sheldon Road, at approximately 5:03 a.m. Police said a vehicle traveling northbound left the roadway and struck a light pole on the east side. Both the 21-year-old male driver and a 21-year-old female passenger died at the scene. Investigators believe speed was a factor.

The Sacramento County Coroner's Office will identify the victims.

On Saturday, May 10, officers were dispatched at approximately 5:32 a.m. to a single-vehicle crash on Elk Grove Boulevard, between McKenna Drive and Backer Ranch Road. According to police, a Lexus traveling eastbound left the road just west of Backer Ranch Road and struck a tree.

The driver, a 23-yearold man and sole occupant, was pronounced dead at the scene.

Minutes earlier, the same vehicle had been involved in a minor hit-and-run at the intersection of Elk Grove Boulevard and Fire Poppy Road around 5:27 a.m.

Investigators believe speed and alcohol were contributing factors in the fatal crash.

All three collisions remain under investigation. The Elk Grove Police Department is asking anyone with information to contact the Traffic Bureau at (916) 478-8143. ★

to a single intersection, the turnout and energy were high, with firefighters hoping to exceed their usual range of \$25,000 to \$28,000 — aiming this year for a potential \$40,000 to \$50,000 in just eight hours.

"Hopefully, we're in the \$40,000 to \$50,000 mark," said firefighter-paramedic Eric Jackson, who helped organize the event with colleague Manuel Carter. "It kind of goes up and down. Depends on the economy and the time of year. I feel like we're in a good spot right now in the city of Elk Grove and the state of California."

Jackson emphasized the broader impact of the burn institute, which supports firefighters and civilians alike across Central and Northern California.

"There's kids camps. There's a burn unit at UC Davis that was started with FFBI help," he said. "We have all sorts of resources Fire Chief Felipe Rodriguez grabbed a boot and helped traverse the intersection, picking up donations to help support the Firefighters Burn Institute.

that are throughout the region, and that's what all the money goes towards."

Even though the entire event was confined to one busy intersection, the team made it count.

"We have people on every corner," Jackson said. "You'll see people going in and out of the cars as the light turns red. It's the same intersection we've used for the past 20 vears."

Roughly 40 to 50 people were on-site throughout



the day, all volunteering their time. Some helped for an hour; others stayed the entire day. Support also came from neighboring fire agencies in Courtland, Walnut Grove and Wilton. And while volunteers worked the lanes of traffic, local businesses helped behind the scenes.

"All the food we have here ... is donated from the community," Jackson noted. "Pizza, coffee, Crumbl Cookie, Starbucks, they all provide food for our event to feed everybody. So, you come out here, shake a boot for a couple hours, get some free food, hang out with your friends, and it's a good time."

For firefighter Milo Griffin, the event is a tradition he's proud to continue, ever since his intern days in 2006.

"It's a great opportunity to raise funds for some people who really need the help and who receive care," Griffin said. "If this

wasn't an option, they might not be able to either afford that care or be able to get that care."

Intern Charley Magee, who comes from a family of firefighters, said she's participated since childhood and still finds it meaningful.

"I just love giving back to my community, especially the fire department and this specific profit that we're doing," she said. "Everyone is always super supportive, super nice, super respectful ... and if they're not donating, they're honking their horns or waving."

For Cosumnes Community Services District Board President Angela Spease, the community's response reflects the trust and respect they have for the department.

"They love it, because our firefighters are who we trust to come into our homes and they do so much for us," said Spease. "So, the least they can do is donate to those that unfortunately got burned in the line of duty."

Fire Chief Rodriguez is expected to present the total donation amount at an upcoming district board meeting.



## State Controller Cohen Responds to May Budget Revision

**SACRAMENTO, CA (MPG)** - On May 14, Controller Malia M. Cohen issued the following statement on Governor Gavin Newsom's May Revision:

"When I released my April Cash Report on Friday, I cautioned that although current revenues are exceeding projections and the state has enough reserves to cover expenses this fiscal year, budget forecasts show significant deficits in the years ahead. Addressing these shortfalls will require the governor and legislature to establish clear spending priorities in this budget and upcoming budget cycles.

As the state's chief fiscal officer, with a clear view of what comes in and out of California's checking, savings and credit accounts, I know, just like every Californian does, that we must be extremely cautious about new commitments. Proposals for longterm funding of new programs and services must be weighed carefully. The financial uncertainty ahead is too great to make promises we may not be able to keep. Like all Californians who check their bank accounts to decide whether they can afford gas, groceries, or the commute to work, I see you, and I understand those daily decisions. That's why I urge all of us to be fiscally prudent. With growing uncertainty around federal funding and other state revenue sources, we must prepare for the possibility of tougher financial times ahead.

I look forward to working with the governor and all members of the legislature to ensure that we have the appropriate cash and reserves to get us through this financially turbulent time so that we can continue to move California forward so that families, individuals, vulnerable populations and businesses can continue to thrive."

"In 2021, Governor Newsom stood before Californians announcing a \$75 billion budget surplus. Four years later, the state faces a \$12 billion deficit. The governor attributes this downturn to the so-called 'Trump Slump,' but the reality is that the state's spending problem was created in California and must be solved in California. In his revised May budget proposal, the governor has simply shifted spending. Proposed cuts to the state's general fund are nearly equal to increased spending in the state's special funds. This accounting maneuver does nothing to solve the underlying deficit.

We also believe that it is critically important to fund the implementation of Proposition 36 in order to protect communities and businesses.

Importantly, the governor has not proposed new taxes as Californians struggle with the highest cost of living in the country. It is critically important for the governor and the legislature to pass policies that stimulate private sector investment and job creation to ensure the State of California can generate the revenues needed to fund all priority programs and ensure long-term economic stability."

## Newsom Continues Freefall in 2028 Presidential Candidate Polls

Latest polls give Newsom only 5% support

Governor Gavin Newsom continued to fall in nationwide 2020 Presidential candidate polling last week, with the most recent Echelon poll giving him only 5% of the vote.

Originally the favorite candidate for the 2028 Presidential Election, Newson has dramatically fallen in polls in the ensuing months. Issues over Newsom's response to the January wildfires in L.A., making Democrats angry over the reversal of positions like transgender athletes, federal reversals of pet state projects, and many more have cratered support since the beginning of the year. In January he was second only to Harris. Now he sits at a distant fifth with only 5% support. Currently, the former Vice President sits at 28% support, 13 points ahead of the next closest candidate, former Secretary of Transportation Pete Buttigieg. Without Harris in the race, Newsom jumps up to third in polling, but only climbs up to 10 percent, well behind Buttigieg and Senator Cory Booker (D-NJ).

32%, followed by Buttigieg with 10%, Congresswoman Alexandria Ocasio-Cortez (D-NY) with 8% and Booker with 6%. Newsom is tied for fifth with 5%, along with Governor Tim Walz (D-MN) and Governor JB Pritzker (D-IL). By contrast, for the GOP side of the poll, Vice President JD Vance sits at 44%, with former South Carolina Governor garnering 8% and Florida Governor Ron DeSantis leveling at 7%.

While polling this early is by no means an indicator who the candidate will be, they do give a good baseline on how Americans, and especially people within their respective parties feel about them. Harris is high right now coming off the 2024 election and constant media attention over speculation that she might run for Governor in 2026. Buttigieg has the same air of mystery around his political future after declining to not run for the Senate in Michigan. Booker has been very outspoken against Trump policies, and thus has seen his star rise amongst Dems since Trump was inaugurated. AOC has been AOC. Newsom though has seemingly done everything possible to sabotage himself this early on, and thus giving other candidates more ammunition against him should he bounce back up.

This is by no means the end for Newsom. He has plenty of time to get back up. If Harris opts to be Governor instead and a few other candidates fall into a tailspin, Newsom could be right back up there. What happens in the 2026 midterms could also influence what Newsom does, or what happens to the other candidates.

But right now, viewing it all at a metric standpoint, Newsom needs to shake things up fast if he wants to get the Democratic slot in 2028. He is rapidly running out of things to tout in California. His electric car policies are swiftly fading, homelessness he is currently taking more drastic measures on, and that's not even counting all things from his past that would come up in a debate. All candidates would have to likely defend what they did during the COVID pandemic, and as soon as someone mentions the French Laundry incident, Newsom will have to be on the defensive. There are numerous reasons why Newsom is down right now. And even though primaries are two and a half years away, polling shows that he needs to start doing all he can now. It kind of explains that new homeless ordinance.

## Rep. Kiley Responds to Medicaid for Illegal Immigrants Proposal

**WASHINGTON (MPG)** - Rep. Kevin Kiley (R-CA), author of the No Medicaid for Illegal Immigrants Act, responded to the Energy & Commerce Committee's decision to include a provision in the budget reconciliation text reducing the Affordable Care Act (ACA) Federal Medical Assistance Percentage (FMAP) for states that provide Medicaid to illegal immigrants.

"I have spent the last several months meeting with healthcare providers throughout my district, along with nonprofits, with patient advocates, and many other stakeholders. All of these groups have conveyed to me the importance of protecting Medi-Cal. That is why I have opposed cutting benefits for eligible beneficiaries. But now, thanks to Governor Newsom and the Legislature's reckless actions, we could lose billions in federal funding, harming the very vulnerable populations I have fought to protect," Rep. Kiley said. Kiley also responded to Governor Newsom's recent proposal to freeze

his policy of providing free Medi-Cal to income-eligible undocumented immigrants.

"Gov. Newsom is ending his reckless policy of giving free Medi-Cal to undocumented immigrants. The Governor is finally acknowledging what has long been obvious: this policy is misguided, unsustainable, and should never have been enacted. However, Gov. Newsom has only partially repealed his disastrous policy. It needs to be reversed entirely, or Californians will continue to spend billions on coverage for illegal immigrants and our state will lose an even larger amount in federal Medicaid funding," Rep. Kiley said.

As Governor Gavin Newsom unveiled a revised 2025 to 2026 budget on May 14, he blamed a "Trump slump" from President Donald Trump's tariffs and other economic moves as the major factor in increasing the state's deficit by another \$12 billion.

"California is under assault," Newsom told reporters at a budget briefing, declaring that Trump's actions had created "a climate of deep uncertainty."

The initial budget Newsom proposed in January already had at least an \$11 billion gap between income and outgo that he filled with reserves, loans, deferrals, raids on special funds and accounting maneuvers.

State tax receipts were running ahead of expectations during the early part of the year, but after Trump imposed tariffs on imported goods, saying it would spur domestic production, Newsom and his budget staff revised revenue estimates downward, particularly personal income taxes.

"Washington's imposition of tariffs has driven a downgrade in both the economic and revenue forecasts," the revised budget declares. "Combined with increased expenditure growth above the governor's (January) budget, most notably in Medi-Cal, the state must now close an estimated shortfall of \$12 get and provide for a prudent discretionary reserve. This will require difficult but necessary decisions to reduce ongoing expenditure growth to maintain budget resilience and stability for critical state programs."

The revised budget maintains overall spending at virtually the same level of the January version, \$322 billion, but drops general fund expenditures by \$2 billion to \$226 billion.

As noted, the state also experienced a multibillion-dollar spike in costs for Medi-Cal, the state's health care system for the poor, which contributed to the \$12 billion deficit estimate. Newsom proposed a series of maneuvers to close the new deficit, primarily reductions in Medi-Cal, including a freeze on adult enrollments and \$100 per month premiums for Medi-Cal enrollees.

By singling out Medi-Cal as a major driver of state spending and urging reductions, Newsom was doing a 180-degree political pirouette from a year ago, when he was boasting about achieving nearly 100% medical care coverage for Californians with the addition of thousands of undocumented immigrants to the programs rolls.

The latest expansion of California's chronic budget gap, what fiscal experts deem a "structural deficit," makes it virtually certain that Newsom's governorship will end 19 months hence with the state's finances still unbalanced. The governor's own budget staff and the Legislature's nonpartisan budget advisor, Gabe Petek, have both projected multibillion-dollar deficits well into the future. It doesn't appear will provide fiscal salvation.

The revised budget projects that California's economy faces a sluggish future, with little overall job growth and unemployment rates, which are now among the nation's highest, virtually unchanged. Accordingly, state revenues are projected to increase slowly.

The forecasts don't assume that the national economy will drift into recession, as some economists are predicting due to Trump's tariffs. If one occurred, it would depress revenues even more.

The budget also does not assess the potential reductions in federal aid to states, particularly in health care, that Trump and Republicans in Congress have proposed. Medi-Cal and other social and medical programs are targets in both Washington and Sacramento because they are among the largest items in both federal and state budgets.

As services are trimmed to close budget gaps, advocates for the poor, public employee labor unions and progressive groups are increasing pressure for tax increases to balance the state's books.

Newsom has resisted those calls, but if the projected multi-year deficits become reality, the tax increase drumbeat will grow louder. He can and probably will continue to shun tax increases but if he does, the pressure will hit his successor, whomever that is, immediately upon inauguration.
