## From the Stratosphere to the Streets

*Merryl Tengesdal's Mission to Inspire*

**SACRAMENTO, CA (MPG)** - At 70,000 feet above Earth, the sky fades to black and the stars shine uninterrupted. For Col. Merryl Tengesdal, the first and only African American woman to fly the U-2 “Dragon Lady,” that silence became a place of peace and purpose.

“It’s just me up there,” Tengesdal said. “No light pollution. The only thing I hear is my own breathing and the hum of the engine. It’s where I confront myself, judge myself and love myself.”


A Bronx-born “Star Trek” fan who once dreamed of meeting aliens, Tengesdal charted a real-life journey that defied not only gravity but also history. Perhaps it’s all that time hovering in the stratosphere that has helped keep “T” looking so fresh and youthful. But her glow is more than physical; it radiates from someone who has boldly gone further than most. Now 54 and living in Roseville, Tengesdal is among a select few, just 11 women and 12 African Americans, who have piloted the Air Force’s high-altitude reconnaissance plane.

“I had no idea I would be making history,” said Tengesdal. “I just wanted to fly the aircraft and do the mission; that was the furthest thing from my mind. For me, it was all about being with a group, a brotherhood and sisterhood that flew a great mission and a bunch of professionals that were great at what they did.”

Her inspiration took root at age 7 in front of a television screen. Tengesdal watched “Star Trek” intensely determined to meet aliens, explore new worlds and boldly go

## High Wheelers Ride Strong on Road and Home Turf

**MARYSVILLE, CA (MPG)** - After dazzling hometown fans in their Marysville debut, the Yuba-Sutter High Wheelers hit the highway for a 13-game trek that produced dramatic wins, growth-moment losses and a headline-grabbing call-up.

They opened in Ogden with back-to-back victories over the Raptors (14–10 on May 27, 11–6 on May 28), stumbled briefly, but closed strong

with a 9–8 win (May 31) and a 10–5 clincher (June 1).

Colorado Springs brought more late-inning drama. The High Wheelers dropped the first two to the Rocky Mountain Vibes (9–8 and 11–10 on June 3–4), but responded with a 9–8 knockout-round win on June 5, regrouped after losses on June 6 and 7, then closed the series with a 13–6 win on June 8.

Back at Bryant Field, the team swept the Glacier Range Riders in a thrilling three-game set: a 7–6 knockout win on

June 10, a 3–2 knockout win on June 11, and a tight 2–1 victory on June 12, powered by two solo home runs from slugger Gio Brusa.

They stayed hot heading into the weekend. On Friday, June 13, the High Wheelers outpaced the Northern Colorado Owlz 13–9 in a lively slugfest. Saturday’s momentum slipped away in an 8–3 loss, and Sunday’s Father’s Day matchup came down to the wire, ultimately ending in a tough 11–10 knockout round defeat.

## LaMalfa Statement on House Passage of Rescissions Act

**WASHINGTON, D.C. (MPG)** - Congressman Doug LaMalfa (R-Richvale) released the following statement on June 12 after the House passed H.R. 4, the Rescissions Act of 2025. Passage of this bill codifies President Trump’s rescissions package, cutting \$9.4 billion in wasteful federal spending.

“This is exactly the kind of action voters sent us here to take. We’re cutting nearly \$10 billion in junk spending, foreign aid giveaways, woke public broadcasting, and other bloated programs that do nothing for the average American,” said Rep. LaMalfa. “The federal government has a spending problem, and this bill is a strong step toward restoring fiscal sanity, holding agencies accountable, and stopping the inflationary madness that’s been driving prices through the roof.”

The Congressional Budget and Impoundment Control Act of 1974 was enacted after President Nixon refused to spend congressionally approved funds. The law allows a president to propose rescinding funds already appropriated by Congress. Once submitted, the funds can be withheld for up to 45 legislative days. If Congress passes a rescissions bill, the funds are permanently canceled; if not, the money must be spent. The law also sets expedited procedures for Senate consideration, including a simple majority vote threshold and limited debate, meaning rescissions bills cannot be filibustered.

President Trump submitted a \$9.4 billion rescissions package targeting programs deemed wasteful, politically biased or unnecessary to taxpayers. The proposal includes cuts to foreign aid, global health spending and public broadcasting. H.R. 4 will now make its way to the Senate for consideration.

where no one had before.  
“To do that, I knew I was going to do well in math and science and I was going to go to college,” said Tengesdal. “I didn’t know what I was going to fly but I was going to fly.”  
Tengesdal joined the Navy in 1994, flew helicopters, returned as an instructor and eventually transitioned to the Air Force. That’s when she stumbled across the U-2 program.  
“The mission was very similar to what I did in the Navy, as well as going and flying in a pressure suit and flying above 70,000 feet,” explained Tengesdal. “It was everything that I wanted. It was the next step for me so I said, ‘Let’s go.’”  
For many pilots, the experience of flying the U-2 is more than technical; it’s spiritual.  
“I got to be above 70,000 for a long time. A lot of people will never see the Earth from that

perspective,” Tengesdal said. “When you come back to Earth, there has to be a level of humility you should take things with. What you’ve seen is spectacular. I realized that everything in life is so small, so infinitesimal, compared to the universe. So let’s not take life so seriously. Let’s be kind to one another. Let’s try and have different perspectives to understand each other.”  
Although she officially retired in 2017, Tengesdal admits she misses the solitude and clarity that the stratosphere offered.  
“Oh yeah, I miss it,” said Tengesdal. “For me, that is a peaceful place, where I can think and it’s just me. I think a lot of people have a hard time being alone in their own thoughts, I love it. I love being able to confront myself for who I am and be able to evaluate myself, judge myself and love myself.”  
When asked what it

means to be a symbol for women, for Black women, for people of color, Tengesdal doesn’t flinch.  
“It feels amazing. I’m glad I have the opportunity to do something positive,” Tengesdal said. “Contrary to what a lot of people think, and I used to think like this, representation does matter. With women and people of color, if they see someone in my position, wearing my rank, doing what I’ve done, it inspires them. In the past, we have had a lot of people who have accomplished amazing things with totally different pressures and they still succeeded anyway. We have some opportunities right now that other people may be trying to take away. We need to fight for that and just be unstoppable at what we do because we are amazing people.”  
That same fire shapes how she views today’s culture and what it needs.  
“Right now, the way

things are, number one, I’m seeing a lot of mediocre things on social media and I’m tired of it, I’m exhausted,” Tengesdal said. “If we’re truly about excellence, let’s be excellent. And for the mediocre people out there, stop gaslighting us, ’cause we’re doing some good things. Let us cook. Go over there in the corner.”  
Today, Tengesdal splits her time between mentoring youth, training others through martial arts and weightlifting, and sharing her story nationwide.  
“When I retired, I became a personal trainer because I wanted to be able to train youth to become better versions of themselves,” Tengesdal said. “You can talk to a teenager when they’re most tired. And when they lift weights with me or do martial arts with me, they’re tired, so that’s when I can feed in some good nuggets for life lessons.”

Tengesdal’s decision to retire was heavily influenced by her two children and a desire to be more present.  
“My son was four years old and I wanted to walk him to school. I wanted to be able to do things that my mom wished she could have done, but as a single parent she couldn’t,” said Tengesdal.  
As Juneteenth approaches, Tengesdal’s story is especially resonant. Tengesdal’s career, and her presence, are a reminder of the progress that’s possible when paired with a positive mindset and supportive mentorship. Her memoir, “Shatter the Sky,” is now available on Amazon and she continues to speak around the country on leadership, diversity and personal excellence. ## MOSQUITOES ACCUMULATING IN TOWN AREAS

### TOWN SPRAYING SET TO BEGIN

When mosquitoes move into town areas, it is important to reduce their numbers and lower mosquito-borne disease risk. Public health insecticides formulated for application in urban and residential environments undergo rigorous safety testing before they are approved for use. For the 2025 season, the District will be using a permethrin product applied at a rate of 0.29 ounces per acre. All applications are predicated on mosquito abundance, disease activity and favorable weather conditions. Although these materials pose a low risk to human health, some people may prefer to minimize exposure by staying indoors, keeping windows closed and turning off window mounted air conditioners, evaporative coolers and whole house fans when spraying is taking place in the immediate area. ### SCHEDULE

On Tuesday morning, July 1, 2025, weekly fogging routes will begin in Live Oak, Tierra Buena, Yuba City, and Sutter. On Thursday morning, July 3, 2025, weekly fogging routes will take place in Olivehurst, Linda, Plumas Lake, Wheatland, and Marysville. Routes begin as early as 3:30 am and continue until 6:30 am. Meridian and Robbins will be included in Ag routes on Thursday evenings. The program will continue weekly, and additional town areas and mornings may be added if mosquito-borne disease activity becomes elevated. The program ends in mid-September when mosquito abundance declines.

# Mother-Daughter Duo Shine in “Steel Magnolias”

**YUBA CITY, CA (MPG)** - For local mother-daughter duo Janine and Paige Clements, “Steel Magnolias” isn’t just a show, it’s a rare and heartfelt milestone. The pair share the stage in Convergence Theatre Company’s latest production at the Sutter Theater Center for the Arts in Yuba City, marking their first time performing together in over five years, and their first time doing so in such emotionally demanding roles.

Paige Clements, a recent graduate of Wheatland Union High School, stars as the vibrant and headstrong Shelby Eatenton. Her mother, Janine Clements, plays M'Lynn, Shelby's fiercely devoted and emotionally complex mother.

“I felt like we had big shoes to fill,” said Janine Clements. “I can almost quote the entire movie, and these characters are so iconic that I had to do them right, I had to give them the respect they deserve.”

Despite being seasoned performers, the Clements said the emotional layers of the play felt different this time around.

“It’s weird because I just graduated high school like a week ago and will be going to college soon,” said Paige Clements. “There’s been a lot of big feelings of ‘growing up,’ and this just kind of cemented all of that. We’re not going to get an opportunity like this again.”

Janine Clements added that the poignancy of an empty nest has influenced her performance each night.

“The tears just flow,” she said. “It hits close to home.”

“Steel Magnolias,” written by Robert Harling in 1987, is a character-driven drama set in a small Louisiana town. The story unfolds entirely within a beauty salon where six women gather regularly to share stories, gossip, laughter and grief. At its heart is the bond between Shelby and M'Lynn, anchoring the narrative in themes of maternal love, angst and the quiet strength of women supporting one another.

“I sat down and looked at the script and I was like, ‘Oh, this is different from the movie,’” said Janine Clements. “We’ve taken out the element of men, they’re no longer involved. So, all those funny lines that the character Drum had in the movie are now dispersed among all of us. It’s just such a cool female empowerment story.”

Harling’s original stage script, unlike the film adaptation, features no male characters onstage. Instead, male presence is reduced to off-stage sounds, gunshots, phone calls and explosions, that jar the women’s world

without ever fully entering it. It’s a deliberate and, perhaps, tongue-in-cheek inversion of the old adage that women and children should be “seen and not heard.” Here, the “man child” is heard but never seen, present in sound but absent in substance.

This choice strips male characters of visual power, forcing the audience to sit solely with the complex emotional lives of the women. This narrative reclamation quietly comments on both traditional Southern gender roles and the emotional absenteeism often expected of men.

In many ways Harling’s work is reminiscent of his esteemed predecessor Tennessee Williams. Both playwrights, openly gay Southern men, demonstrated extraordinary sensitivity in writing female characters. Their works are rooted in regionalism, family dynamics, grief and resilience, but where Williams often used lyrical metaphor and psychological tension, Harling finds his power in intimate realism and quiet sisterhood.

“We always try to think about what our plays are saying,” said Matt DeMeritt, one of Convergence Theater Company’s founders. “What I love about these women as I’ve been watching this is that they do not at all have the same belief systems and yet they’re all able to coexist peacefully and not hate each other.”

For director Cassie Fifield, this production marked her directorial debut with an adult cast and her first non-musical project. More recently Fifield has worked as a musical director for Center Stage Productions “Frozen Jr.” and as Lucy in “Jekyll & Hyde” for Convergence Theater Company.

“When there’s a musical, I usually want to be in it,” said Fifield with a laugh. “So, I told myself if I’m going to direct, it should be a straight show. When we were pitching ideas last year, ‘Steel Magnolias’ just felt like a good fit. It’s

a small cast, and it has that CTC vibe where we want to make people feel something.”

That “vibe” shines through thanks to a talented ensemble of veteran performers and drama educators, including Crystal DeMeritt, Lydia Crist, and Janine Clements.

Another standout is Tanda Phelps, who plays salon owner Truvy. In real life, Phelps is a hairdresser herself at Primped & Polished in Linda, adding a layer of authenticity to the role.

“I do feel sometimes things are exaggerated for entertainment,” said Phelps. "But the truth is we do have our clients that become friends and chosen family. The gossip, the laughs, the tears, the frustration are all real. I have the absolute best people in my life, and they started as a client first.”

While the show runs long, nearly three hours, Fifield keeps the pace brisk, perhaps due to her musical background and choreographic instincts. The emotional arc flows naturally, broken up with humor thanks to Crist and local crowd-favorite Wendi Jellsey in the role of Ouiser, the cantankerous but lovable curmudgeon.


The only critique lies in the regional accents. While the southern drawls are effective, some veer into nasally or exaggerated tones. A deeper exploration of vocal resonance might have elevated the performances further. That said, the Clements’ accent work stood out for its subtlety and support.

Those brave enough to face a good cry can catch a performance of “Steel Magnolias” at the Sutter Theater Center for the Arts, located at 754 Plumas Street in Yuba City. Shows will run through June 29 with evening performances taking place Fridays and Saturdays at 7 p.m. and Sundays at 2 p.m. Tickets are available online at yubasutterarts.org, by phone at 530-742-2787 or in person at the theater box office. ★

## Decent Almond Crop Projected Despite Early Alarm about Bee Losses

Despite concerns earlier this year that there would not be enough bees to pollinate the 2025 almond crop, the shortage does not appear to have affected production, according to a forecast by the U.S. Department of Agriculture. The department projected California farmers will harvest 2.8 billion pounds of almonds, which is less than average but slightly more than last year. “That’s not an excellent crop, but it’s a nice crop,” Mel Machado, chief agricultural officer of Blue Diamond Growers, a cooperative of almond growers, told host Gary Sack on a recent episode of the Voice of California Agriculture podcast, which is produced by the California Farm Bureau. Growers are “cautiously optimistic,” Machado said.

## Lemon Growers Struggle with Supply and Market Challenges

With peak lemon season winding down in Ventura County—the state’s top producer of the citrus fruit—growers say ongoing challenges with low prices make it hard to earn a profit. While Central Valley growers have been able to produce quality lemons, those in coastal areas have struggled with unfavorable weather. “We haven’t been making anything on lemons since the pandemic,” said Craig Colton, a Ventura County grower. “Because of the age of our trees, wind damage and size issues, we can’t get the fruit quality the packinghouse is asking for.”

## California Agriculture Official Highlights Priorities

In an exclusive interview with Ag Alert®, California Department of Food and Agriculture Secretary Karen Ross spoke about challenges farmers face and her priorities for agriculture in the Golden State. “It is crucial that we understand where we can help provide relief or more efficient, effective ways of doing things,” Ross said. “It’s hugely important for our landscape and our climate goals to keep people on the land and for families in rural communities to have a thriving agricultural sector.”

## Legislation Allowing Schools to Serve Whole Milk Advances

A bill being considered by U.S. lawmakers would give schools the option of serving whole and 2% milk. Dairy groups applauded passage last week of the Whole Milk for Healthy Kids Act out of the U.S. Senate Committee on Agriculture, Nutrition and Forestry. The bipartisan legislation was already approved by a House committee. Since 2012, federal school meal rules have allowed only 1% and fat-free milk to be served in schools, despite those varieties being less popular in people’s homes. The bill “is about making informed, science-backed decisions that prioritize the health and future of our children,” National Milk Producers Federation President and CEO Gregg Doud said. ★

# Social Security Matters

## Can My Husband Work Part Time and Collect Social Security?

**Dear Rusty:** I am writing to you on behalf of my husband. His intentions are to go part time as of January 1, 2026, working 30 hours a week and take Social Security benefits as supplemental income. How can we determine what his Social Security benefit would be with him still working part time? He will be 63 and 7 months old next January and has not yet applied for benefits. We look forward to hearing from someone very soon. **Signed: Anxious for Information**

**Dear Anxious:** If he claims Social Security at age 63 and 7 months, your husband's benefit will be about 78% of what it would be if he waited until age 67 to claim. And, since your husband will not yet have reached his SS full retirement age (FRA), he will be subject to Social Security's Annual Earning Test (AET), which limits how much he can earn while working and collecting early Social Security retirement benefits. The amount he can earn without paying a penalty changes yearly but, for reference, the earnings limit for 2025 is \$23,400 per year. If his work earnings exceed the annual limit, Social Security will take away some of his benefits. Using the 2025 limit as an example, if your husband's annual 2025 earnings were

\$40,000, then he would owe about \$8,300 (half of the amount he exceeded the limit by). Social Security would withhold his monthly benefits for enough months to recover what he owes for exceeding the earnings limit (how many months they withhold would be determined by his monthly SS benefit amount).

FYI, the earnings test lasts until your husband reaches his full retirement age (his FRA is age 67), but in the year he attains his FRA the penalty for exceeding the limit is less - \$1 for every \$3 over the limit - and the limit is much higher. The annual earnings test no longer applies once your husband reaches his FRA.

When your husband applies for his SS retirement benefit, Social Security will ask about his work plans and how much he expects to earn each year. Based upon that information, if he expects to exceed the annual limit they will pay his benefits for some months of the year (depending on his projected earnings) and withhold his benefits for the remaining months. They will also monitor his annual earnings as reported to the IRS and make any appropriate benefit adjustment afterwards.

If SS benefits are withheld because your husband exceeded the annual earnings limit, when he reaches his full retirement age (67), Social Security will give him time-credit for all month's that benefits were withheld. Essentially, they will advance his actual claim date by the number of months benefits were withheld, which will make his monthly benefit higher at his FRA. The higher amount he receives after reaching his FRA will help

him recover some of the money withheld as a result of exceeding the earnings limit before his FRA.

Please note that it is always best to inform Social Security up front if your husband plans to work and earn (even part time) prior to reaching his FRA. The IRS will provide the SSA with your husband's earnings information, and SSA will (if his projected earnings weren't disclosed when he applied) issue an Overpayment Notice if he earns more than allowed. He will then be required to repay SS everything owed, or have his benefits withheld until Social Security recovers what he owes.

One final point: by claiming his benefits in January 2026, your husband's monthly amount will be reduced by about 22% (from the amount he would get at his FRA of 67). Claiming early (before FRA) always results in a benefit reduction, whereas waiting longer than FRA to claim always results in a higher monthly amount (maximum benefit is reached at age 70).

# Newsom Wanted to Fast-Track, the Legislature Slowed

Repeatedly Gavin Newsom has sought legislative approval of his high-priority policy proposals within the annual state budget process, even though they often have nothing to do with the budget.

The unique rules governing the budget and its accompanying "trailer bills" allow them to be enacted quickly, bypassing many parliamentary hurdles and vote thresholds that other legislation must endure.

The Legislature, controlled by Newsom's fellow Democrats, generally allows him to use the budget process, in part because legislators often employ the same shortcuts for their own priorities.

Their underlying motive for the sneaky use — or misuse — of the budget process is to avoid prolonged analysis and debate that might, if the bills' contents are fully vetted, make them more difficult to enact. The trailer bills often contain favors for interest groups that would be difficult to justify in a

more transparent process.

Last month, while unveiling a revised state budget, Newsom asked the Legislature to attach legislation that would fast-track the highly controversial project to move Sacramento River water to the California Aqueduct without it flowing through the Sacramento-San Joaquin Delta — renewing a tactic that failed two years ago.

First proposed as a "peripheral canal" more than a half-century ago, it morphed into twin tunnels and, after Newsom's election, a single tunnel. Its purpose has also evolved, from a mechanism to increase water deliveries to Southern California, to one that would, Newsom and others argue, improve the reliability of deliveries.

"For too long, attempts to modernize our critical water infrastructure have stalled in endless red tape, burdened with unnecessary delay," Newsom said. "We're done with barriers. Our state needs to complete this project as soon as possible, so that we can better store and manage water to prepare for a hotter, drier future. Let's get this built."

It would take a book — a big book — to fully explain all of the project's environmental, financial and political aspects. Briefly, however, while advocates say that isolating water conveyance from the Delta would

improve habitat for fish and other wildlife, opponents contend that less water flowing through the estuary would further degrade its water quality.

While Newsom and other supporters often depict the tunnel as a stand-alone project, it is inexorably related to other aspects of California's very complex water picture.

For instance, as it touts a tunnel that would doubtless reduce Delta flows, the state also is pressuring farmers to reduce diversions from the San Joaquin River and its tributaries, to increase flows through the Delta. Those two efforts are not officially linked, but the connection is obvious.

The long-stalled Delta Conveyance Project — the latest of several official names — has slowly approached the final pre-construction phase, which is why Newsom wanted a trailer bill to finally get a green light.

### The Future of Warfare is Here

Ukraine may not have "the cards," as President Trump put it, but it does have drones. They were used to great effect over the weekend in an audacious attack within Russia that has focused the world's attention on a revolution in warfare.

A badly outmanned and outgunned country just reached far inside its adversary's territory to destroy or damage hugely expensive, nuclear-capable strategic aircraft with low-cost drones basically indistinguishable from ones available on Amazon.

It's not quite David versus Goliath, because the Russian giant is not going to be felled by the blow, but the diplomatic and psychological impact of the raid could be profound, as Ukraine seeks to demonstrate to the West its staying power.

For creativity and outsized effect with widely available devices, the Ukrainian attack is in the same league as Israel's beeper attack on Hezbollah operatives in Lebanon last year. Both operations also carry a message about new vulnerabilities -- to a compromised supply chain and to a surprise drone attack -- that should make us take notice.

We've just watched the equivalent of aviation legend Billy Mitchell's demonstration in 1921 when he had U.S. planes

sink a former German battleship, in a display of the emerging potency of air power.

Ukraine's Operation Spider Web combined Mission Impossible-style intrigue -- the drones were secreted within Russia and some of them launched from containers attached to trucks, unbeknownst to the drivers -- with clever innovation.

The attacks spanned several time zones and hit 41 Russian aircraft, according to the Ukrainians. The operation was the latest iteration of a cat-and-mouse drone war between Ukraine and Russia. The Ukraine conflict is essentially a war of attrition, yet it is anything but static, as the means of waging it change almost by the week. Offensive innovation is met with defensive countermove, triggering another change on offense.

Drones are vulnerable to electronic jamming? Then, they'll be controlled by massive spools of fiber optic cable. Drones threaten supply routes? Then, the roads will be covered with netting. And drones will be attacked by other drones. What the siren of the Stuka dive-bomber was to the Blitzkrieg -- an unmistakable herald of a new way of waging war -- the high-pitched whirr of the drone is to the Ukraine war.

Estimates are that drones now inflict about 70% of casualties on both sides, and there are literally millions of them. Russia deployed roughly 4 million drones last year, and Ukraine about 1.5 million. We have much to learn from all this. After last weekend, every commander of a U.S. base should be thinking anew about potential vulnerability to drone attack, and it's

not hard to imagine the Chinese utilizing drones to execute a wide-ranging strike in the Western Pacific if Beijing goes after Taiwan.

Once a leader in drone technology when its Predators were taking out targets in the War on Terror, the U.S. hasn't kept up with the adaptations happening in the Ukraine war. Inevitably, our own bureaucratic processes are our worst enemy.

As head of the U.S. National Drone Association, Nathan Ecelbarger, writes, the system for acquiring drones "remains deeply flawed, overly bureaucratic and resistant to innovation."

We'll have to focus more on defenses, too, from early detection to counter-drone capabilities. The problem with using missiles to defeat drones is the asymmetry in expense -- an SM-2 missile costs millions, whereas a Houthi drone costs thousands. And drone swarms could overcome a battery of missiles.

This is the reason why the work of next-generation defense firms like Epirus, which has developed a scalable, high-power microwave technology platform that can knock a swarm of drones from the sky, is so important.

What's happening in the Ukraine war is the norm in human conflict. It's adapt or watch your castle get reduced to rubble, your fleet get sent to the bottom of the ocean or a leg of your nuclear triad get assaulted by, essentially, a plaything of hobbyists.

# Value is How we Perceive It Stock PE

When investors hear about how expensive stocks are, some might think it refers to a high stock price. For example, if someone compares a stock that costs a buck a share, and then looks at a stock that has a \$900 price tag, they may think the \$900 stock is more expensive.

On one hand, they would be right if it pertained to how we shop for most things.

After all, if we see a dress priced at \$20 bucks and one priced at \$2,000, in a certain sense, the \$2,000 dress is indeed more expensive.

But what if the \$20 dress is made from cotton and the \$2,000 dress is made from gold thread and has \$5,000 worth of diamonds on it?

The \$2,000 dress with \$5,000 worth of diamonds and woven in gold thread certainly is a better value as for \$2000 you are getting over \$5,000 worth of diamonds plus the gold thread and hence, could be said to be a better value than the \$20 dress.

The same can be said about the comparative price of stocks.

Many investors may only look at the price of a stock when deciding what to buy instead of looking for the better "value".

Although there are many intangibles and ways to evaluate the value of a stock, the most basic method that almost any investor can use is what is called the "Price to earnings ratio" (PE).

The PE is a common published figure on almost all stock screeners and it represents how much you are paying in company earnings per each share of stock you buy.

The PE is calculated by dividing the price of a share of the stock by the earnings per share.

For example, if a stock is priced at ten dollars and the company annually earns one dollar per share, then \$10 (price per share) divided by \$1 (earnings per share), the PE ratio for this stock is 10.

If the company earned \$2 per share, then \$10 divided by \$2 is 5.

Now suppose you were looking at buying a grocery store and between the two stores you were looking at, grocery store A had two owners and earned two bucks a year. Each owner would get one buck a year in earnings. Its PE would be 5. (10 divided by 2).

Grocery store B also had two owners but earned only one buck a year. Each owner would get .50 cents a year. Its PE

is 10. (10 divided by 1)

If both stores were priced for sale at the same price, Grocery store A, having a lower PE, would be the better value as each owner gets more money per year than grocery store B, which subsequently has a higher PE.

The PE therefore tells you what company is costing you more as it pertains to earnings. The higher the PE, the more expensive the stock relative to another with a lower PE.

This simplistic mindset can be one of many considerations an investor can look at when deciding what stock might be a better value.

Seasoned investors know that there are many more metrics one can look at when considering what stock to buy

Of course, a knowledgeable financial professional can always assist you when wading through a company's financial vitals, but understanding even a small amount of how to evaluate a stock can begin to open the eyes of even the most beginning of investors.

After all, what is more simplistic in deciding what company to invest in then just seeing which company makes more money?

Although comparing PE is only one of many metrics that should be used, and its best to only consider companies in the same industry when using the PE comparison methodology, this common sense approach can start the mom and pop investor down the road of knowing a little bit more about the world of investing.

Education is the cornerstone of progress, and when it comes to your money, the more knowledge you have, the better you and your money will be.

### Tiddlywinks

Tiddlywinks has been played by most of us as children. Most have never thought about the game’s origin. It has just always been with us. The following may not really be the true origin story, but it could be.

Chadwick Tiddly married Morgana Pead-Winks on June 10, 1843, in the small village of Chipping-on-Firth, Cumbria County, England. This day, Saturday, was a beautiful day and foretold good fortune for the Tiddly/Pead-Winks union. Chadwick was an inventive chap but had met with little success. However, Morgana, bedazzled by his powers of persuasion and his perfectly smashing set of muttonchops, agreed to marry him anyway. After all, he did bear a striking resemblance to Prince Albert of Saxe-Coburg and Gotha, Queen Victoria’s squeeze.

Chadwick and Morgana Tiddly set up housekeeping in a small second floor flat in Chipping-on-Firth two blocks away from the substantial residence of Morgana’s brother, Egbert, and his lovely wife, Edwina. The Tiddlys and the Pead-Winks began spending Saturday evenings at the Pead-Winks home

playing whist. Edwina was not overly interested in the game, would forget trump, and not follow suit. Consequently, after dealing with this inattention for a time, Egbert would suggest that they break for a spot of tea, small cakes, and some nuts. As the conversation would continue and the tea drunk, Edwina would amuse herself, flipping nuts into her empty cup by setting the nut on her thumbnail and flicking her thumb against her index finger. After a couple of weeks of enduring this, Egbert couldn’t take it anymore.

“Edwina, must you persist in flippin’ nuts,” Egbert asked one evening.

“Are calling me a flippin’ nut?”

“No, of course not, my snooky lumps, I am referring to your nut flippin’.”

“Do not fret, Egbert. It is but a harmless habit. It amuses me to see if I can flip the nut into the cup.”

“But it is a bit, shall we say, distracting, wouldn’t you agree?”

“I suppose you are correct. But it is amusing, nevertheless.”

The next day, Chadwick kept thinking about the nut flipping. It did appear to be interesting. The inventive wheels were slowly grind-

ing away in his head. He tried flipping nuts into a cup for several days as time permitted. Accuracy was a big problem, and Morgana became upset with the stray nuts lying around on the floor. He tried flipping coins, but they were too heavy and were in danger of breaking the cup.

When Chadwick began discussing nut flipping with Edwina during one of their Saturday whist tournaments, Egbert blew his cork and banned the subject and the activity forever. Morgana sided with Egbert and nut flipping passed into a distant memory along with the development of any flipping activity.

Several months passed and Chadwick couldn’t get the flipping activity out of his mind. He borrowed a few flat buttons from Morgana’s sewing basket and tried to flip those. This seemed to work much better, and the accuracy was measurably improved. As he continued to practice, he got pretty good. He demonstrated his prowess to the Pead-Winks the next Saturday to their amazement, and Egbert had a change of heart.

“We must develop and market this as a parlor game, don’t you agree?” ex-

claimed Egbert. “What shall we call it?”

Chadwick, not too sure he liked this “we” stuff, agreed the activity might have some merit. Reasserting his ownership of the idea, he said, “I thought that I would conduct some additional research at home. Flippin’ as a name has a nice ring, don’t you think?”

Egbert, now sensing his involvement in this endeavor was being thrown under the hansom cab, tactfully reminded Chadwick that Edwina had been the inspiration. Chadwick was forced to agree and assured Egbert he would be involved. The game was officially registered as Flippin’.


Eight months later, interest in the game was spreading through England with great success. By the 1860s, the game had spread throughout Britain and Western Europe. With this success came family discussions concerning the name. The game’s patent was due to run out in a couple of years, and the inventors thought the game’s name should include their names. All sorts of name combinations were tried and Tiddly/Winks was chosen.

The Irish brought the game to the U.S. during the 1880s immigrations.



However, the game was still known as Flippin’ in Ireland, and the disks were called birds. Decades later, when flippin’ the bird became an obscene hand gesture that was used in anger when an opponent won, birds were renamed winks. Tiddlywinks, minus the slash and the capital W, gradually took over as the official title.

By the 1940s, the disks were made of plastic and were much lighter and springier. Consequently, the game evolved into flipping one into a small bowl by pressing the edge with another creating the children’s game that we know today. ★

"Last year, we had a similar exhibit, 'Potter the Otter,' that was really popular, so we are very excited to bring something like that back," said Molly Bloom, the museum's director and curator. "Whenever we can get hand-on stuff like this for

families to enjoy, we're all for it."

Admission is free and the museum is air-conditioned. It is a perfect way to beat the heat while learning something new.



# PCW Returns Home

**MARYSVILLE, CA (MPG)** - Professional wrestling might not be the first thing that comes to mind when one thinks of a community fundraiser, but in Marysville, that narrative is being flipped on its head.

On Friday, June 27, Pro Championship Wrestling (PCW) will host a live "Primetime" wrestling event at the Tri-Counties Community Center in downtown Marysville. The event is part of a new partnership between Pro Championship Wrestling and the center, designed to both support up-and-coming wrestlers and raise funds for the community space itself. Proceeds from ticket sales will be split 50/50 between Pro Championship Wrestling and the center, while the community center will retain 100 percent of snack bar earnings.

For Pro Championship Wrestling founder and longtime Marysville resident Zack Reeb, the event marks more than just a return, it's a full circle moment nearly three decades in the making.

"PCW is my baby and my life's work," said Reeb. "I gave up traveling the world with bigger companies just to come home and work towards my dream, making a regional promotion known across the globe."

Reeb founded Pro Championship Wrestling in 1999 as a senior project while attending Marysville High School, just across the street from the current venue. The Project consisted of a 10-page essay on the history of Pro Wrestling in the World Wrestling Entertainment (WWE), a 10-minute speech in front of a panel of judges and the most important part, the product.

With the support of his civics teacher Steve White, Reeb rented a ring trucked up from Los Angeles and staged his very first show in the school gym. The event was so successful that Reeb's parents decided to help their then 17-year-old son transform his project into a full-fledged business and that's how Pro Championship Wrestling was born.

"Primetime University is what keeps me grounded and fills my life with purpose," said Reeb. "Helping young men and women to realize their dream is the most rewarding thing I have ever done in my life."

Today, Pro Championship Wrestling's presence continues to grow, drawing in talent and fans from across the state. Its newest flagship YouTube show "LIMELIGHT" offers a showcase for the region's top talent, while also giving newer wrestlers hands-on experience in both performance and production. The show airs Saturdays at noon and Reeb now intends to film these matches live, potentially on a monthly basis, at the Tri-Counties Community Center.

"Limelight is the vision finally coming together," said Reeb. "We're teaching

young wrestlers about interviews, production, everything that will help them further their careers at a higher level."

The June 27 event will feature local up-and-coming athletes including recent River Valley High School graduate Ethan "All Pro" Reyno, alongside seasoned professionals like "Darkfox" Olumide Coker and Nathan Brick, both of whom recently helped raise funds for Wheatland Union High School's special needs program.

"Helping and giving back to the community I've been a lifelong resident of is very surreal," said Reeb. "I never thought I'd have the opportunity to be a role model and give back like this."

The event also dovetails with Pro Championship Wrestling's training initiative, "Primetime University", which Reeb describes as his true passion.

"Primetime University is what keeps me grounded and fills my life with purpose," Reeb said. "Helping young men and women realize their dream is the most rewarding thing I've ever done."

Two days after the Marysville event, Pro Championship Wrestling will host a talent contest on Sunday, June 29 at their training facility in Yuba City (1242 Hassett Ave., Building 9). Beginning at 11 a.m., male and female contestants of all experience levels will compete in physical fitness, wrestling drills and live promotional speaking for a chance to win free training and become the "Next PCW Superstar."

General admission tickets for the Limelight show at the Tri-Counties Community Center start at \$15 and are available online at pcwnorcal.com, or in person at the center located at 1830 B St. in Marysville. On the day of the show, June 27, doors will open at 6:30 p.m. and the first bell will sound at 7 p.m. For more information or assistance, contact Pro Championship Wrestling at 530-315-4020. ★
